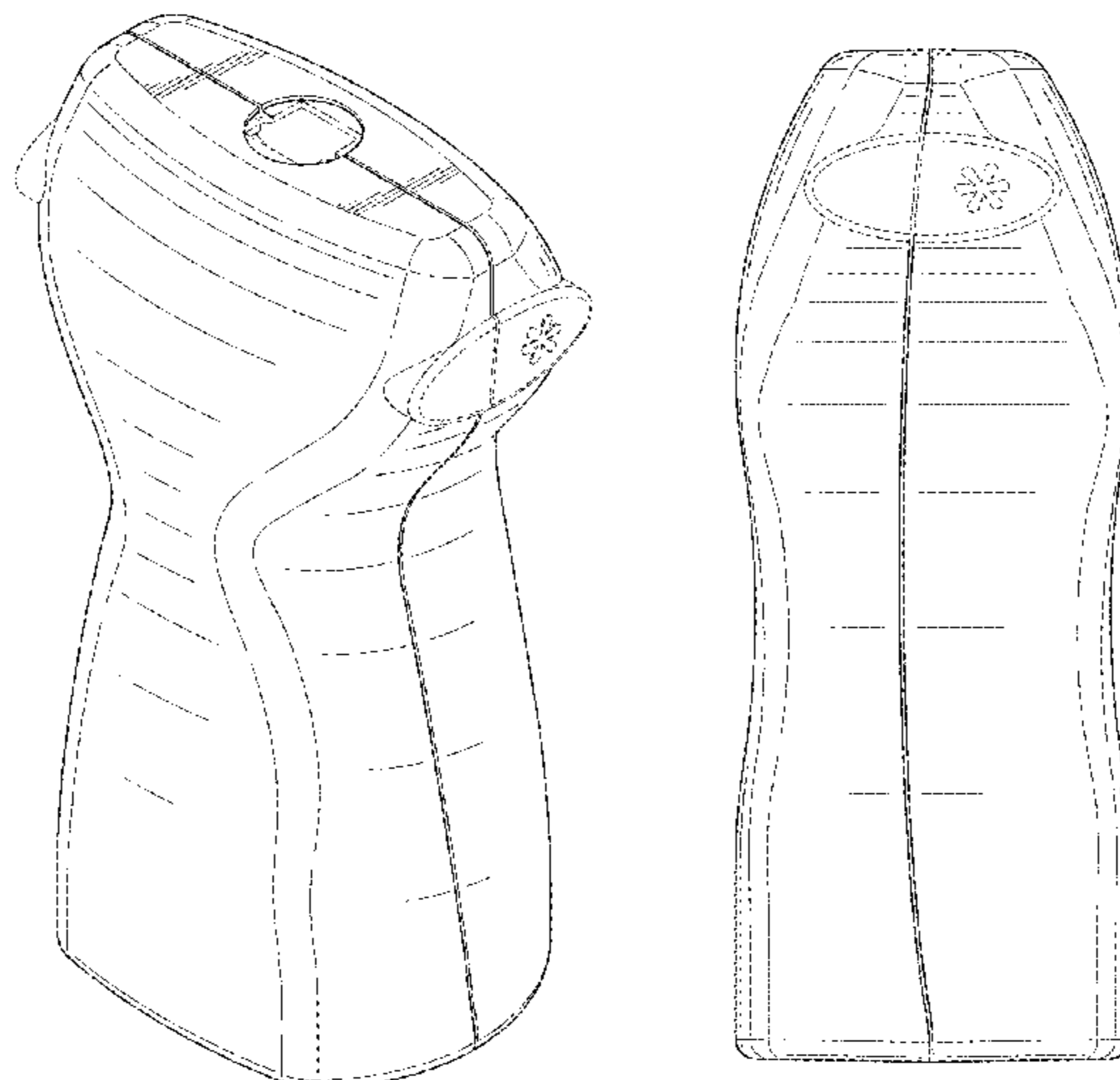

FIG. 1 is a perspective view of the food pouch container.
FIG. 2 is a front view thereof, the rear view being a mirror
image.
FIG. 3 is a right side elevation view thereof, the left side
elevation view being a mirror image.
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The broken lines shown in FIGS. 1-5 represent portions of
the food pouch container that form no part of the claimed
design.

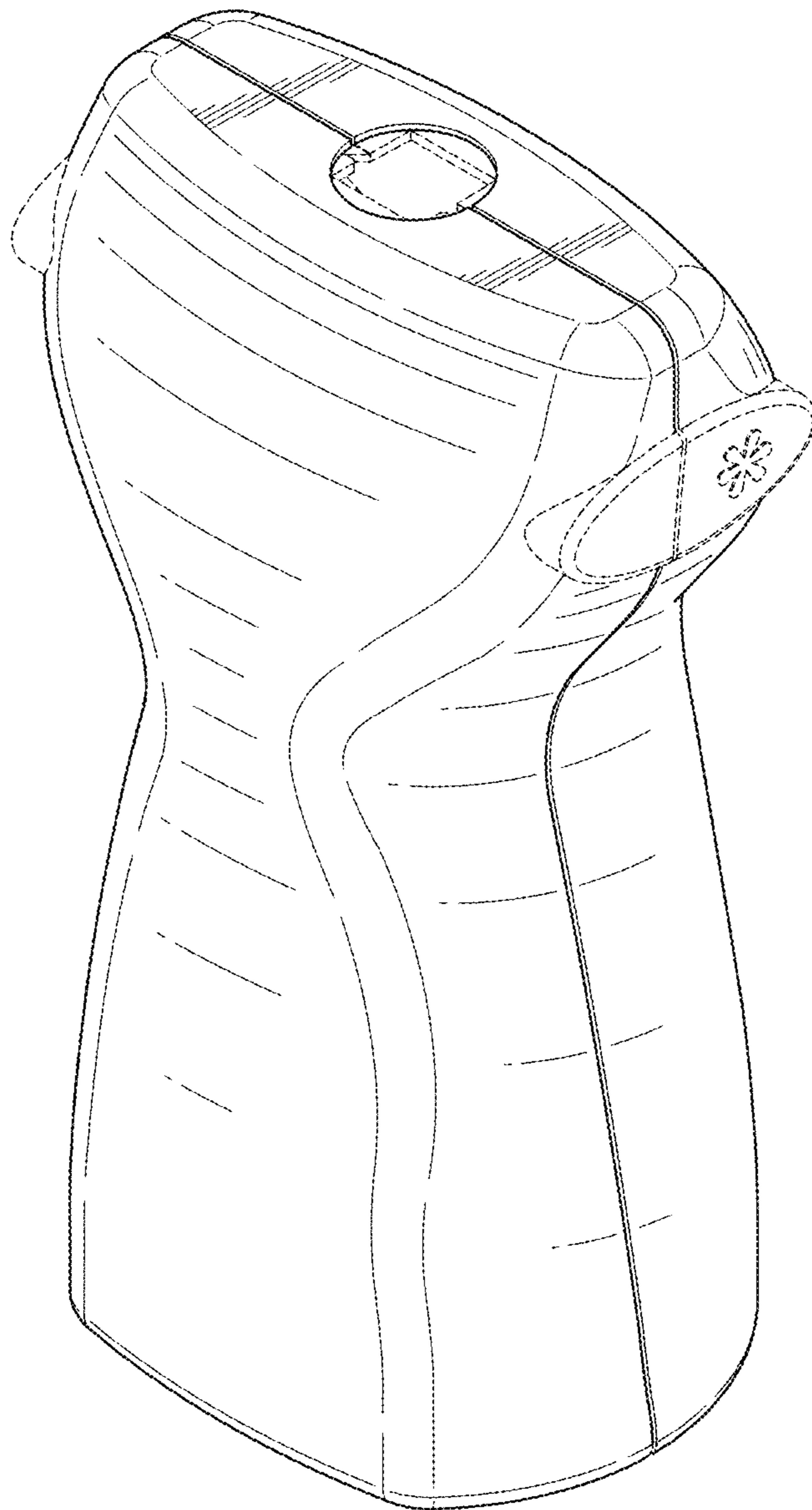

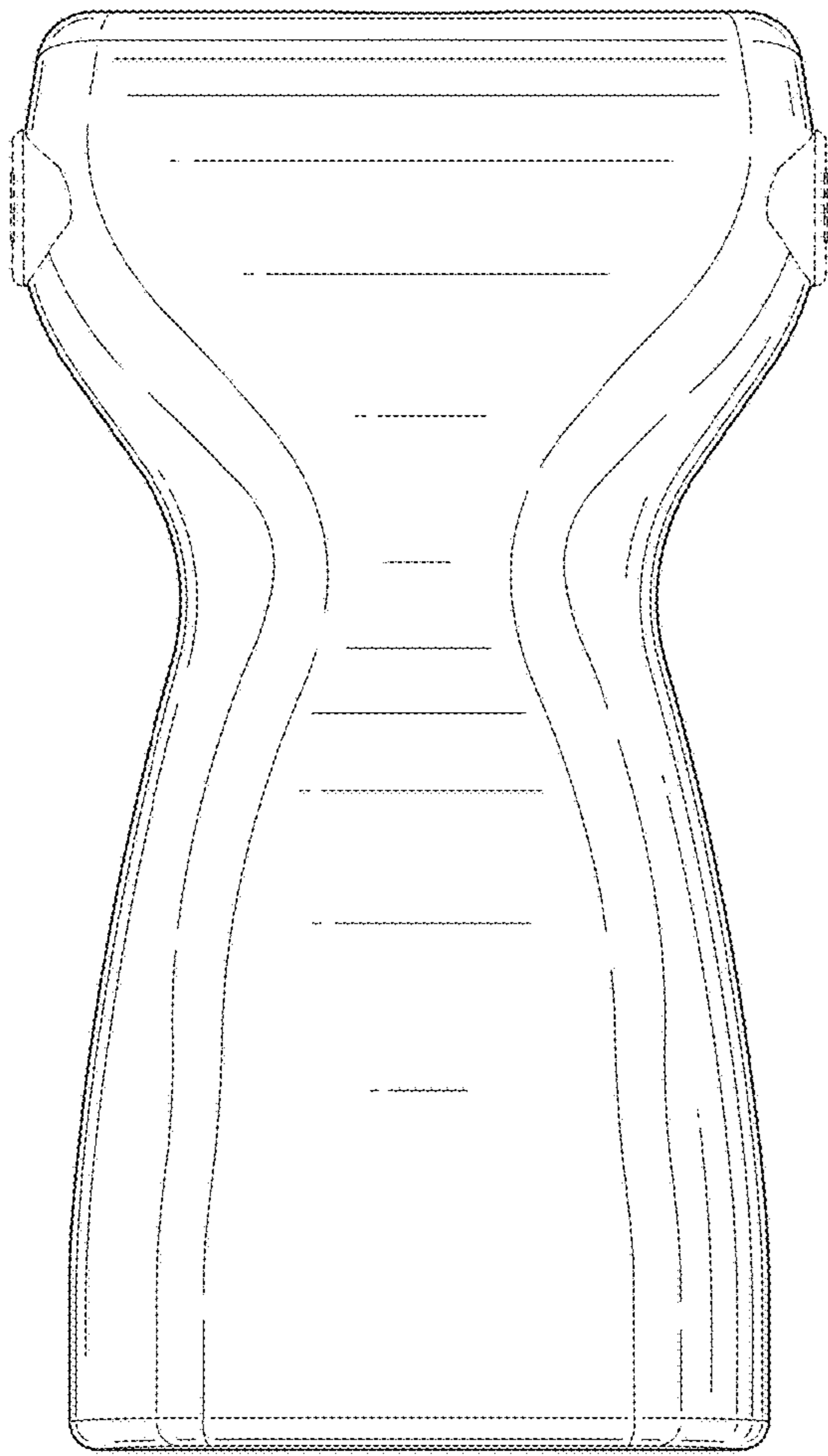

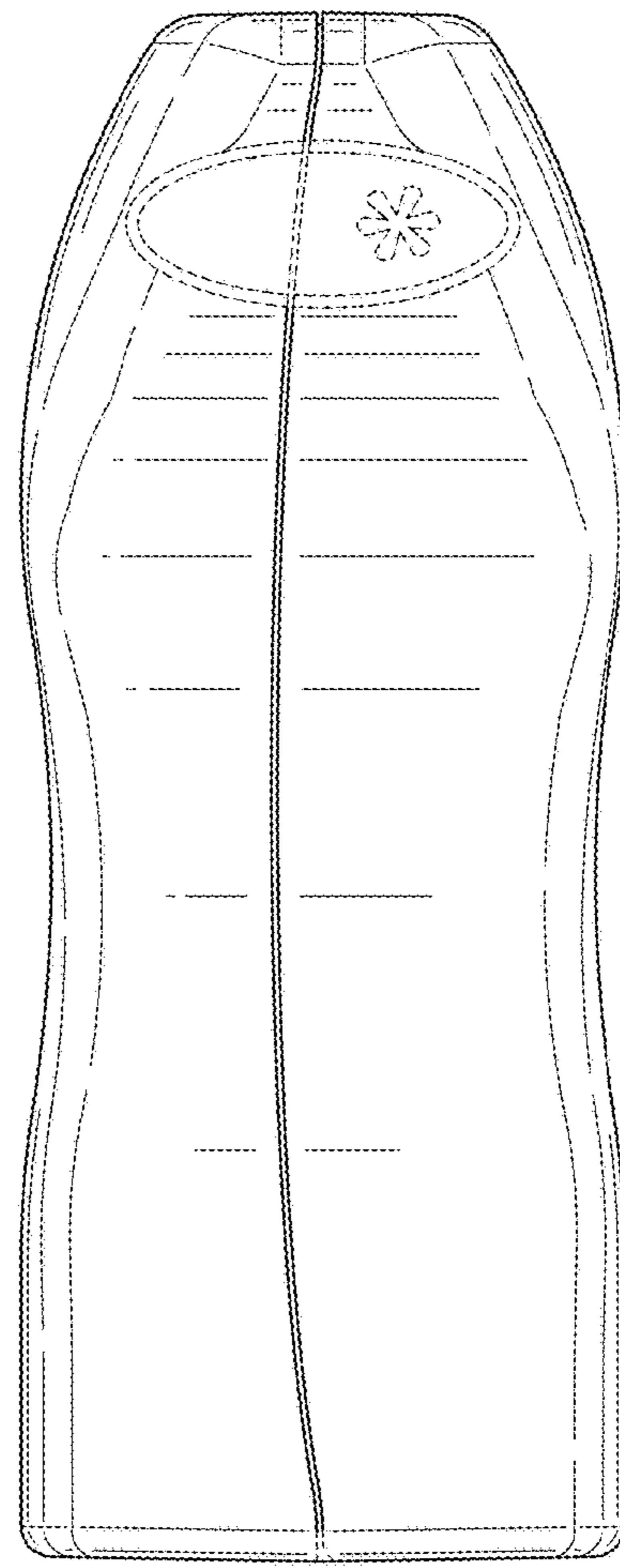

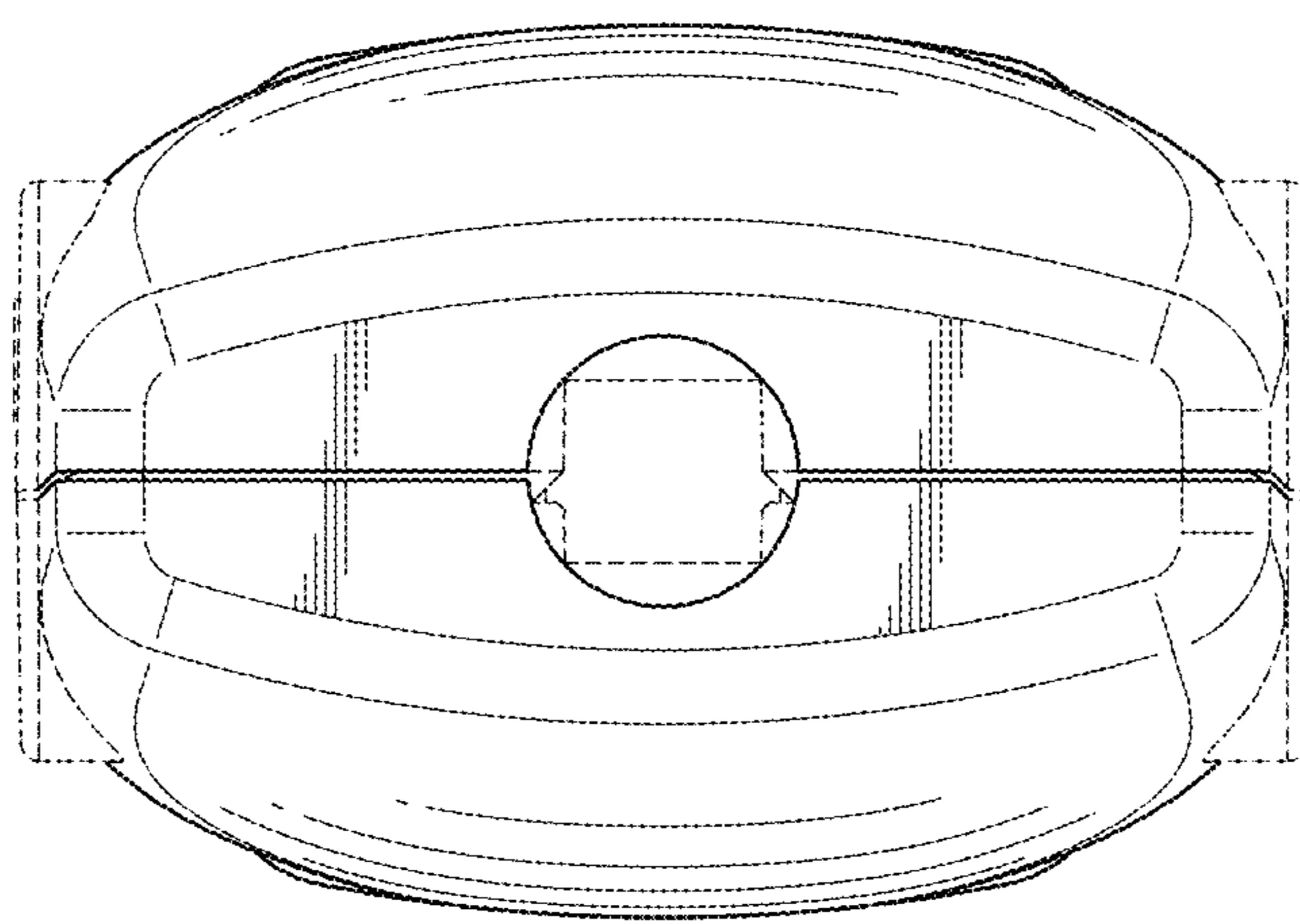

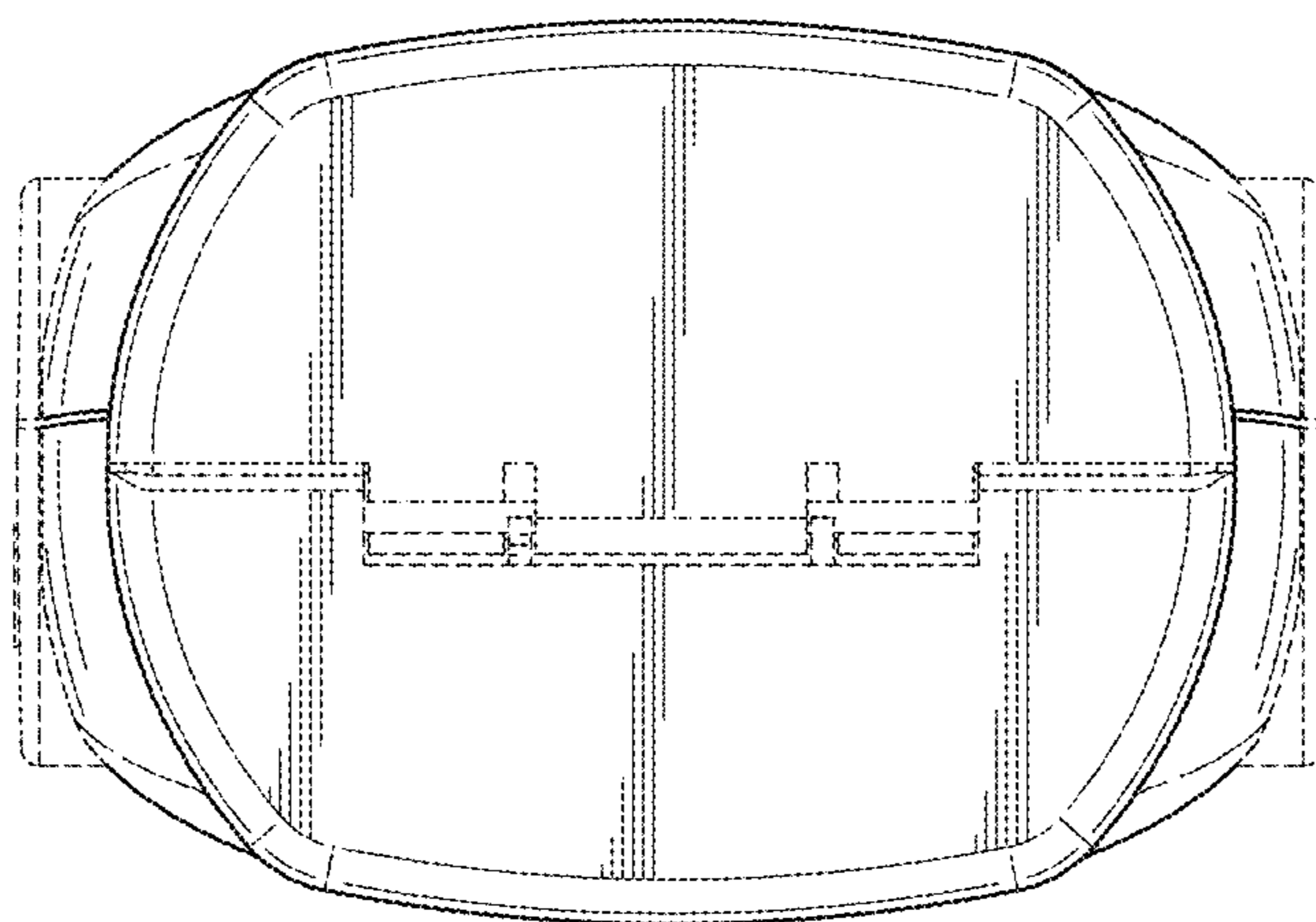
