DESCRIPTION

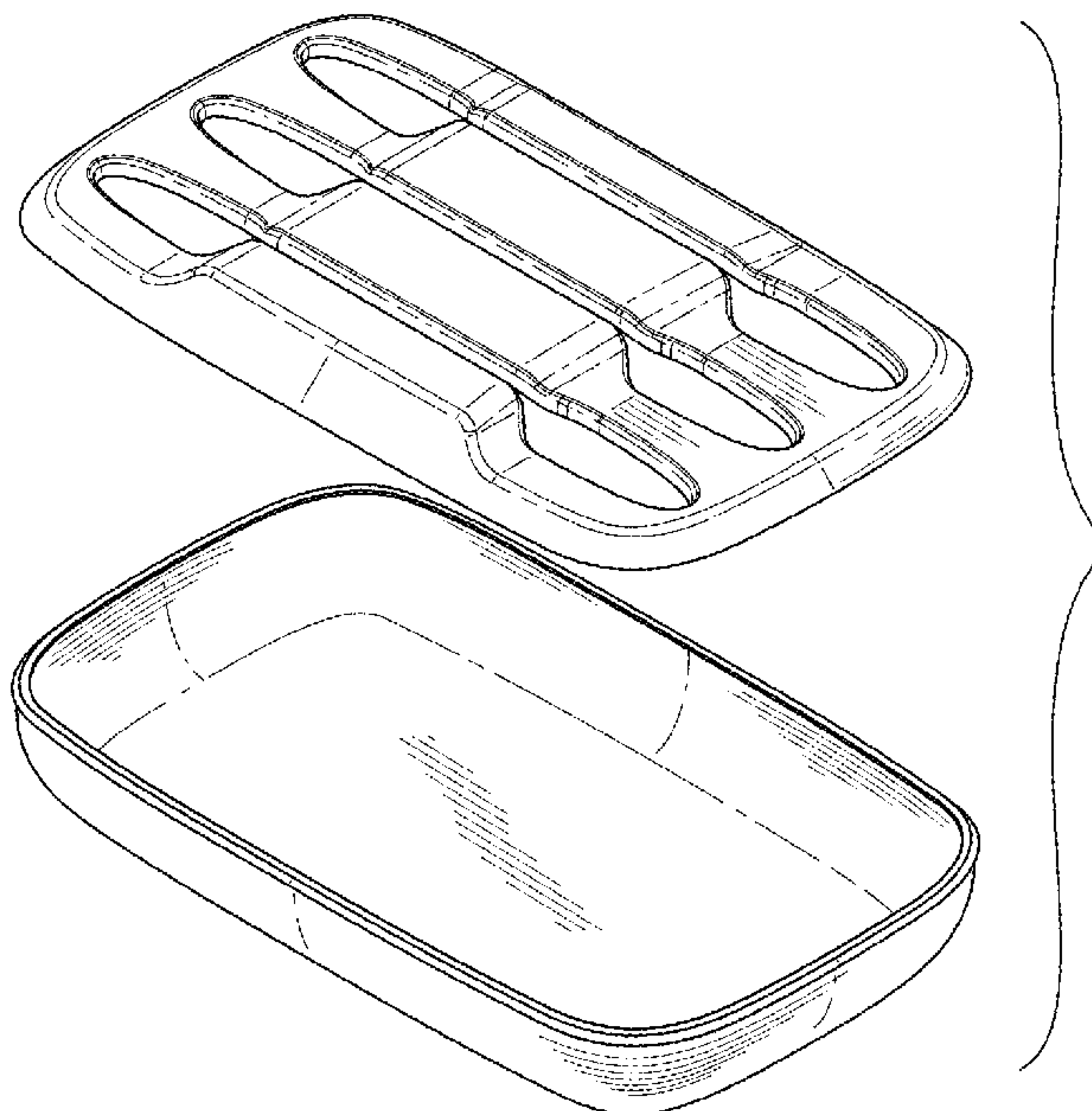
FIG. 1 is a top perspective view of a knife holder, shown in environmental use, showing my new design;
FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;
FIG. 3 is a left-side elevational view thereof;

FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is an exploded top perspective view thereof; and,

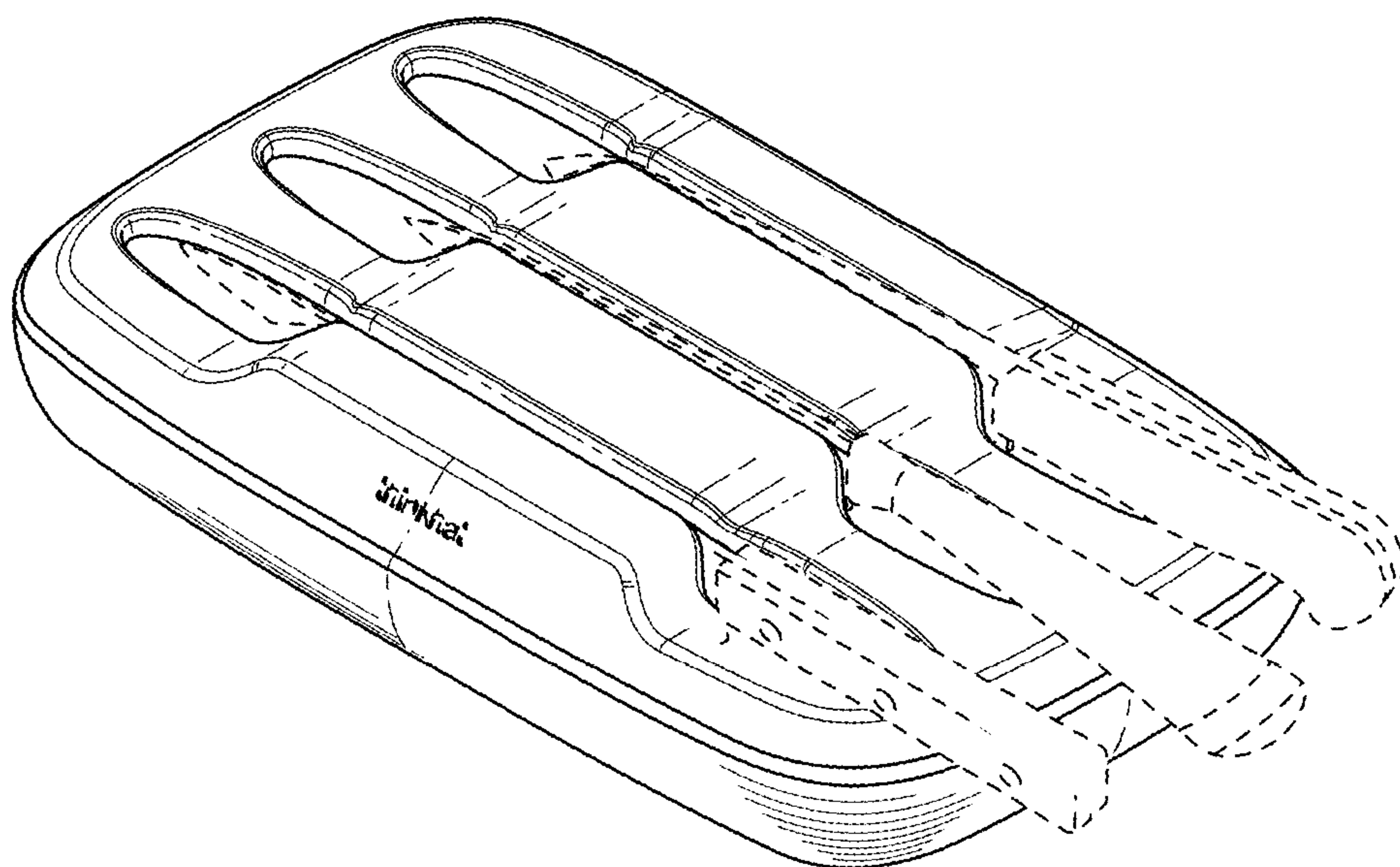

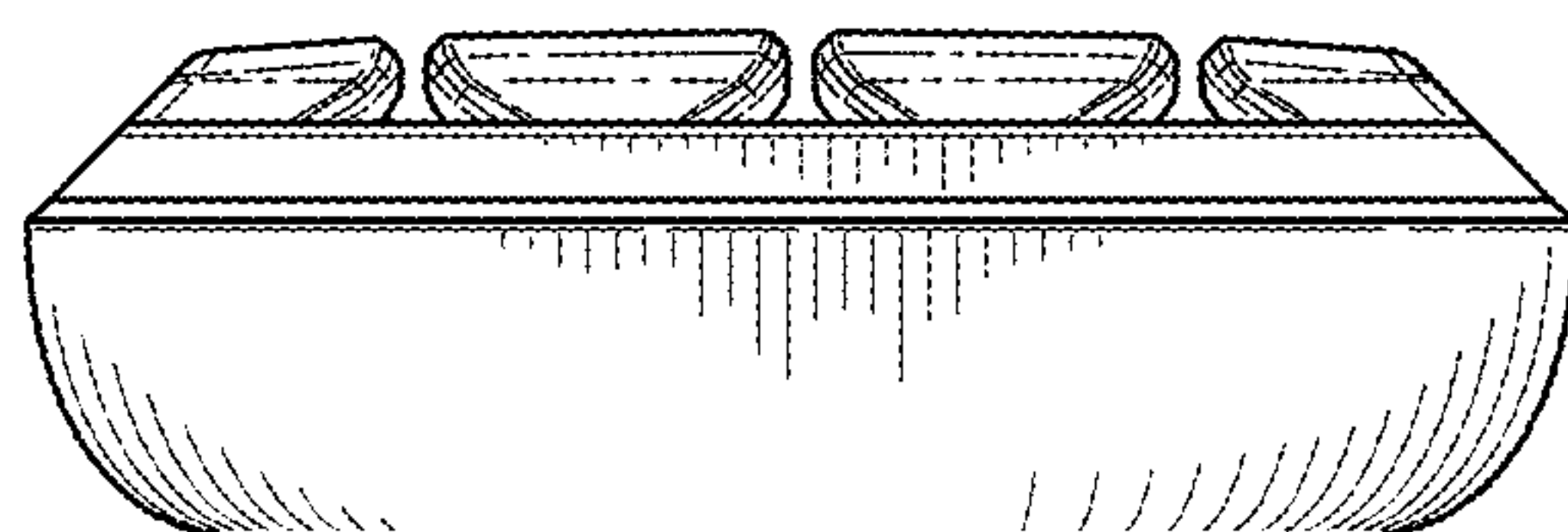

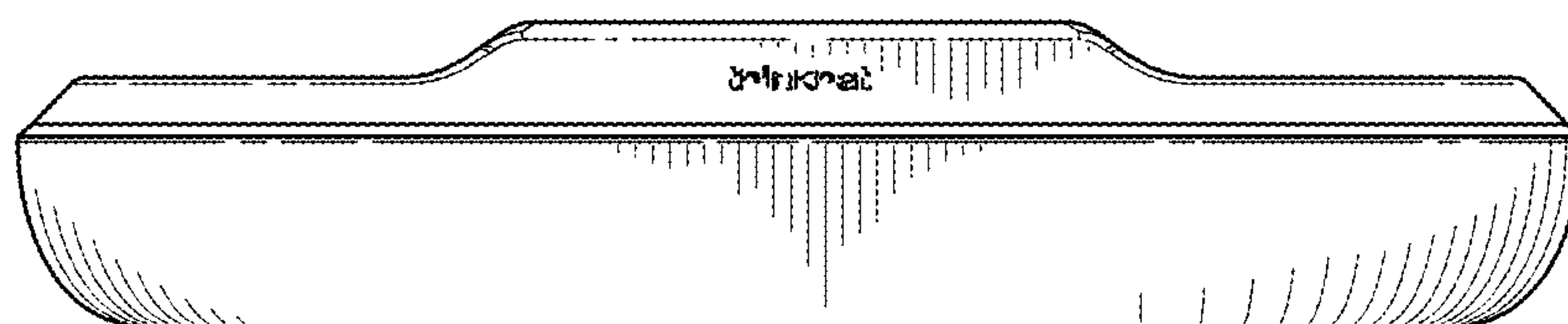

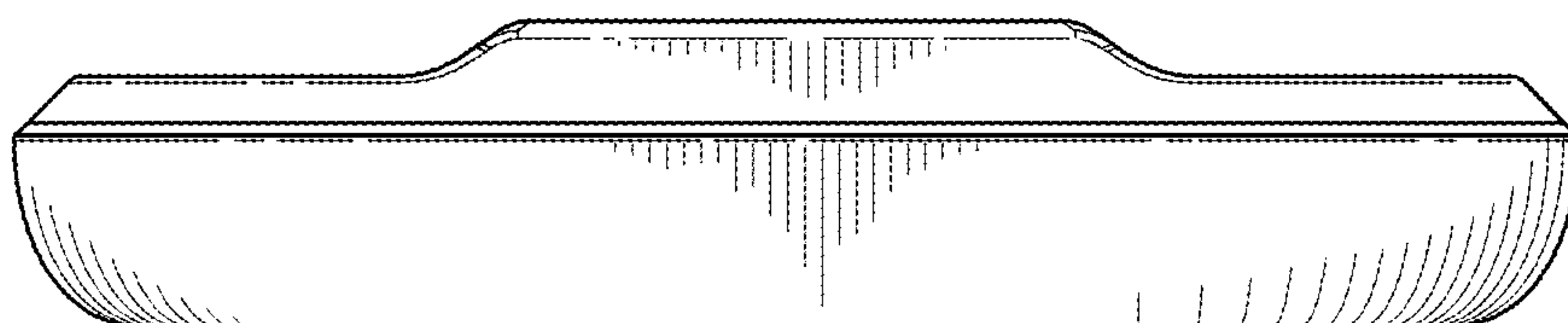

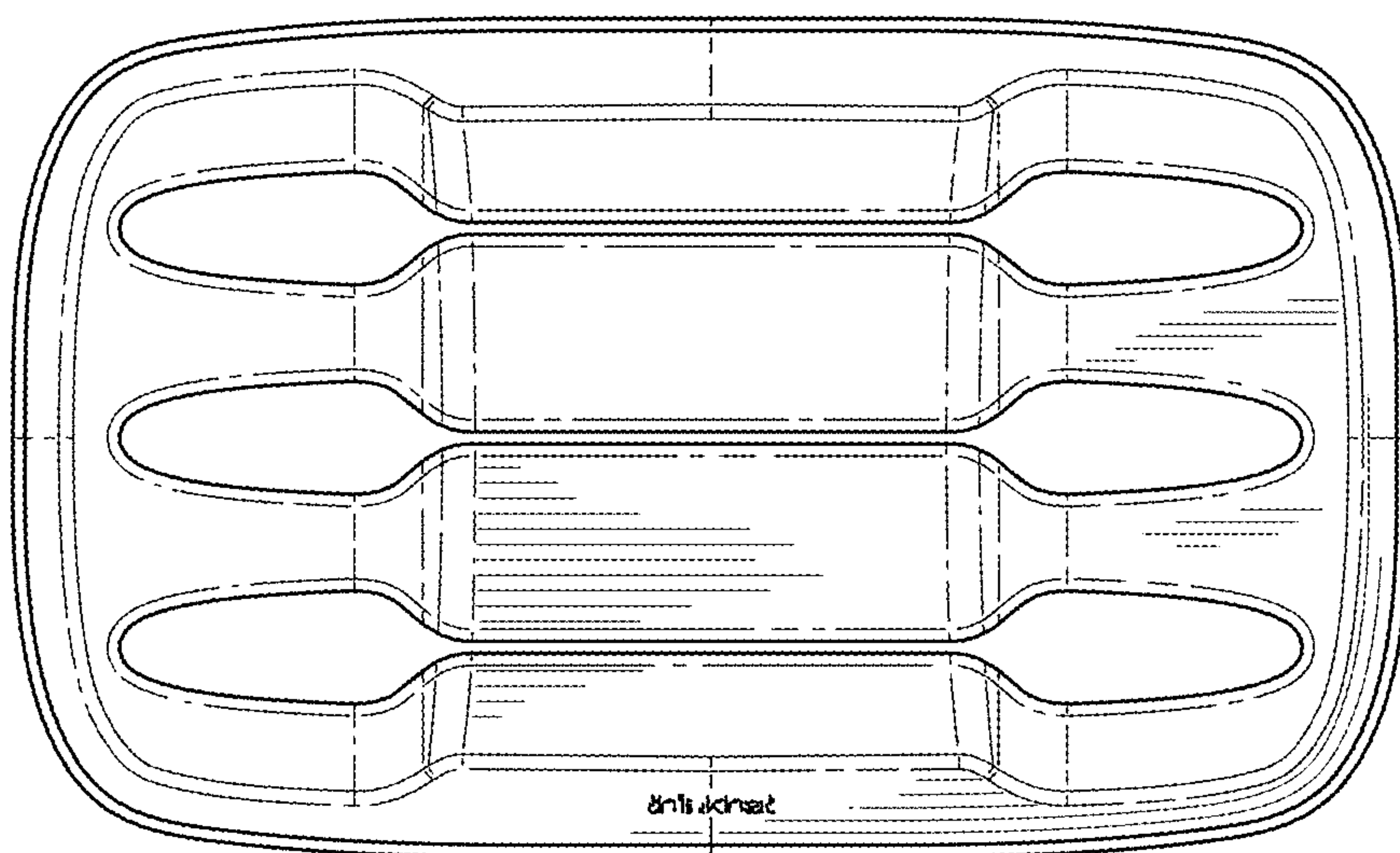

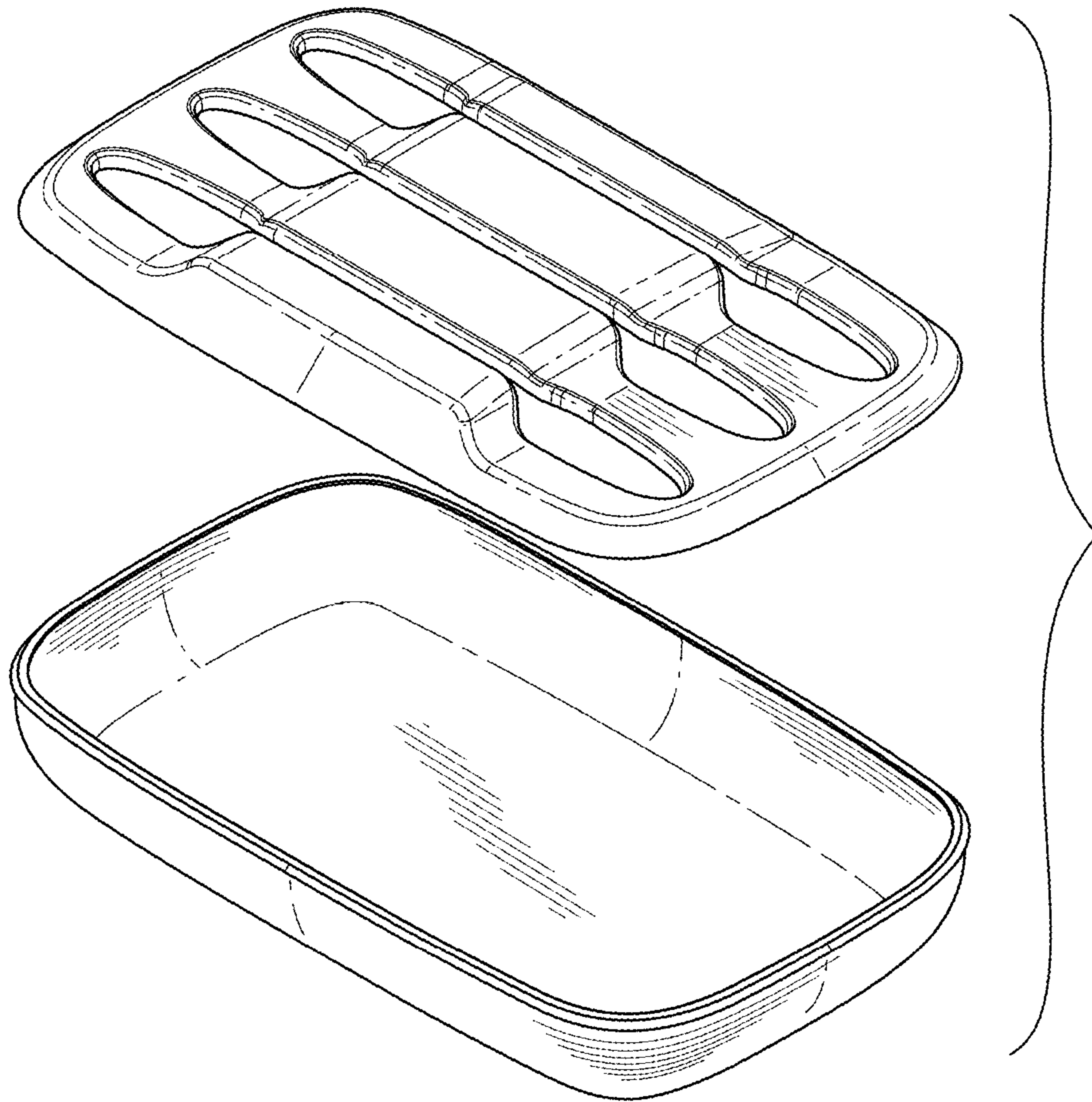

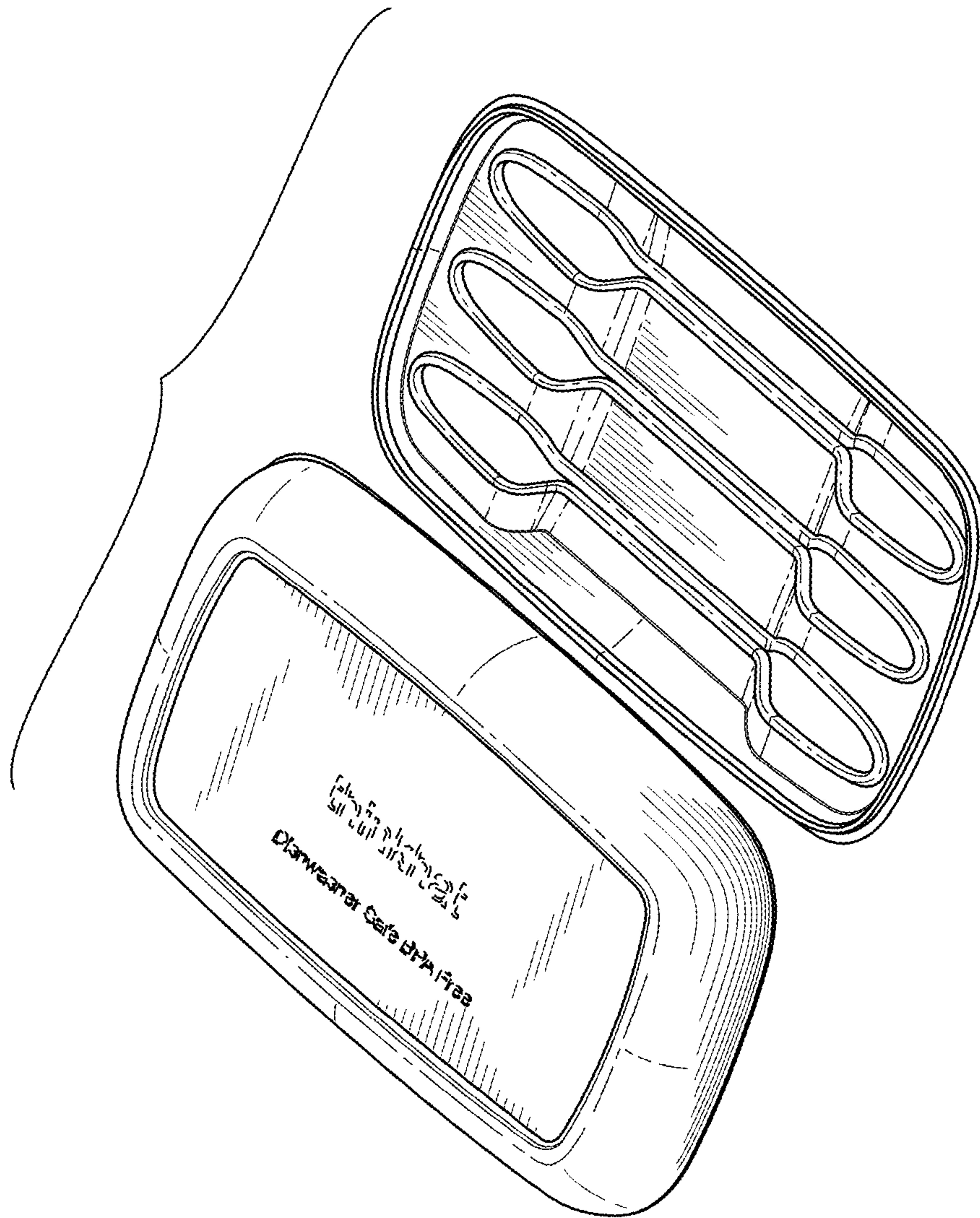
