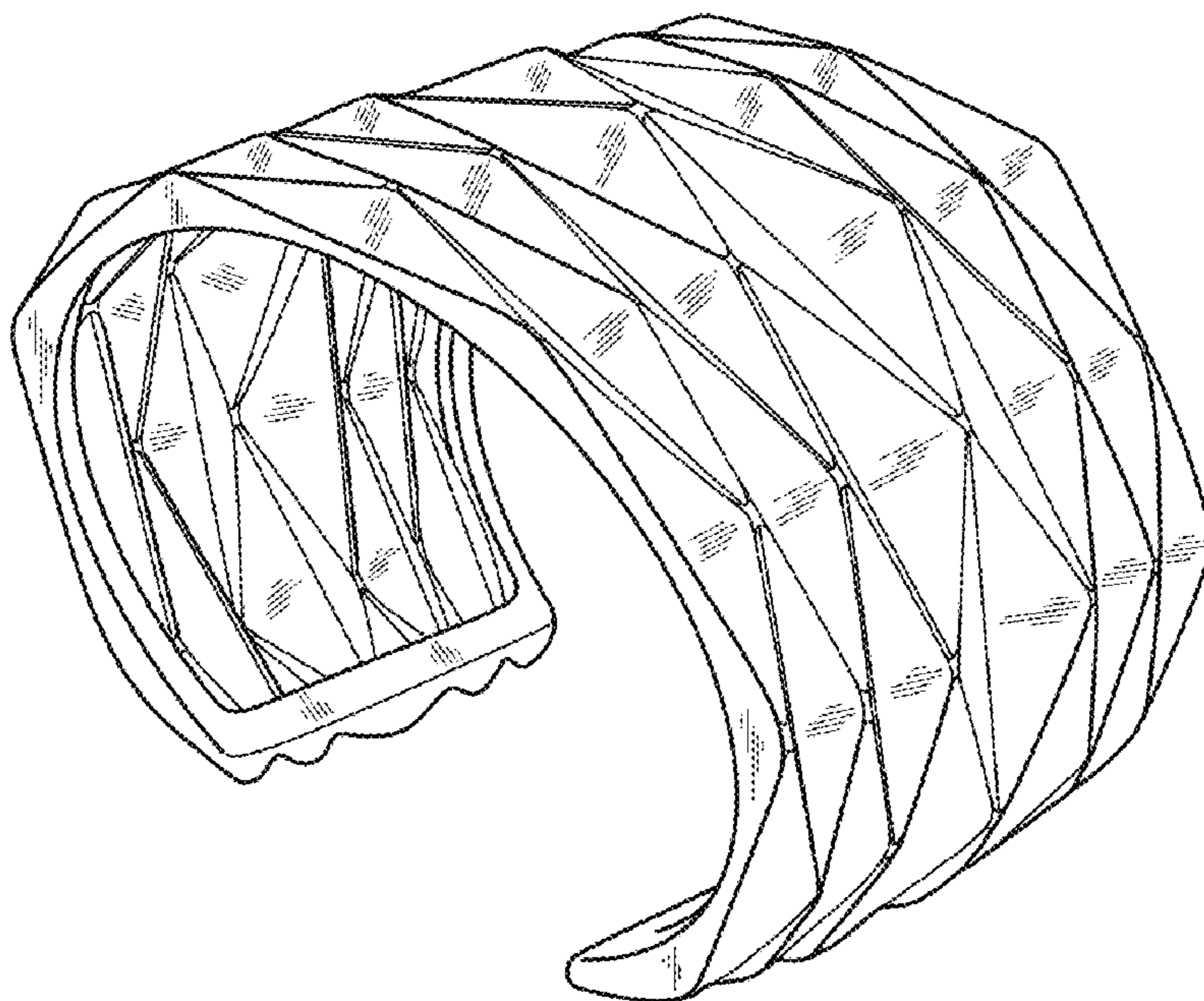
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a bracelet showing my new design;
FIG. 2 is a front view of the bracelet, the rear view being the same;

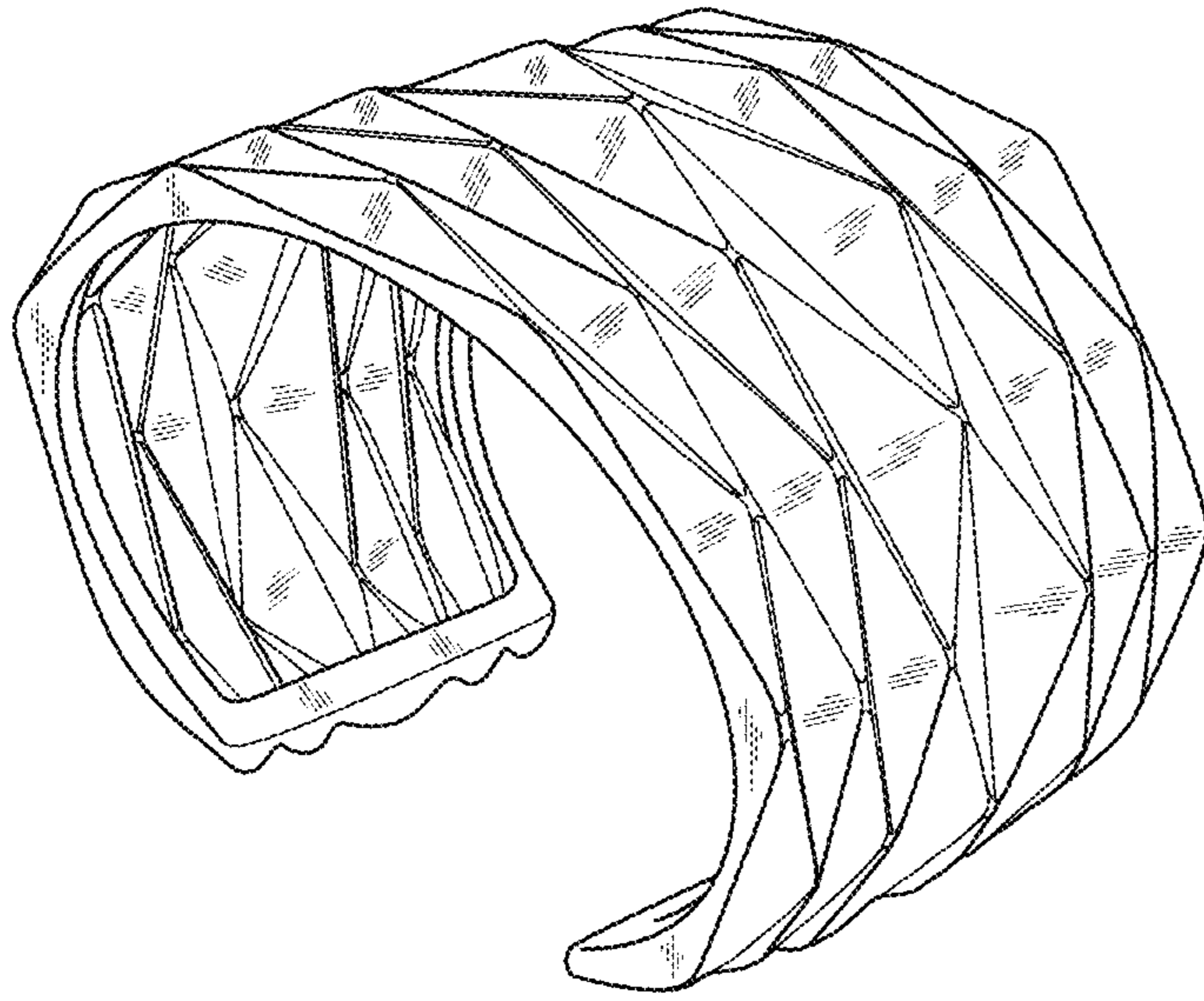

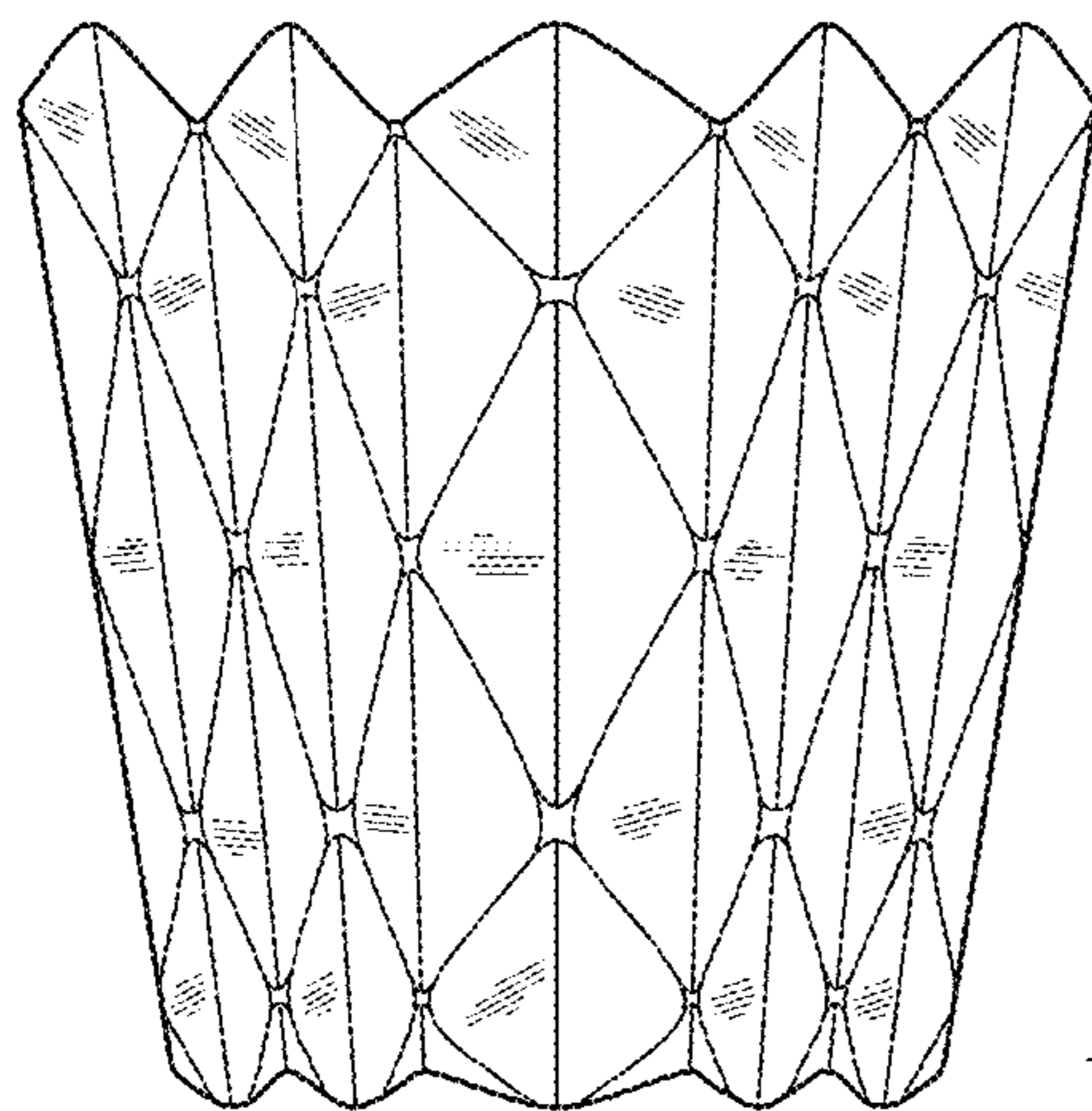
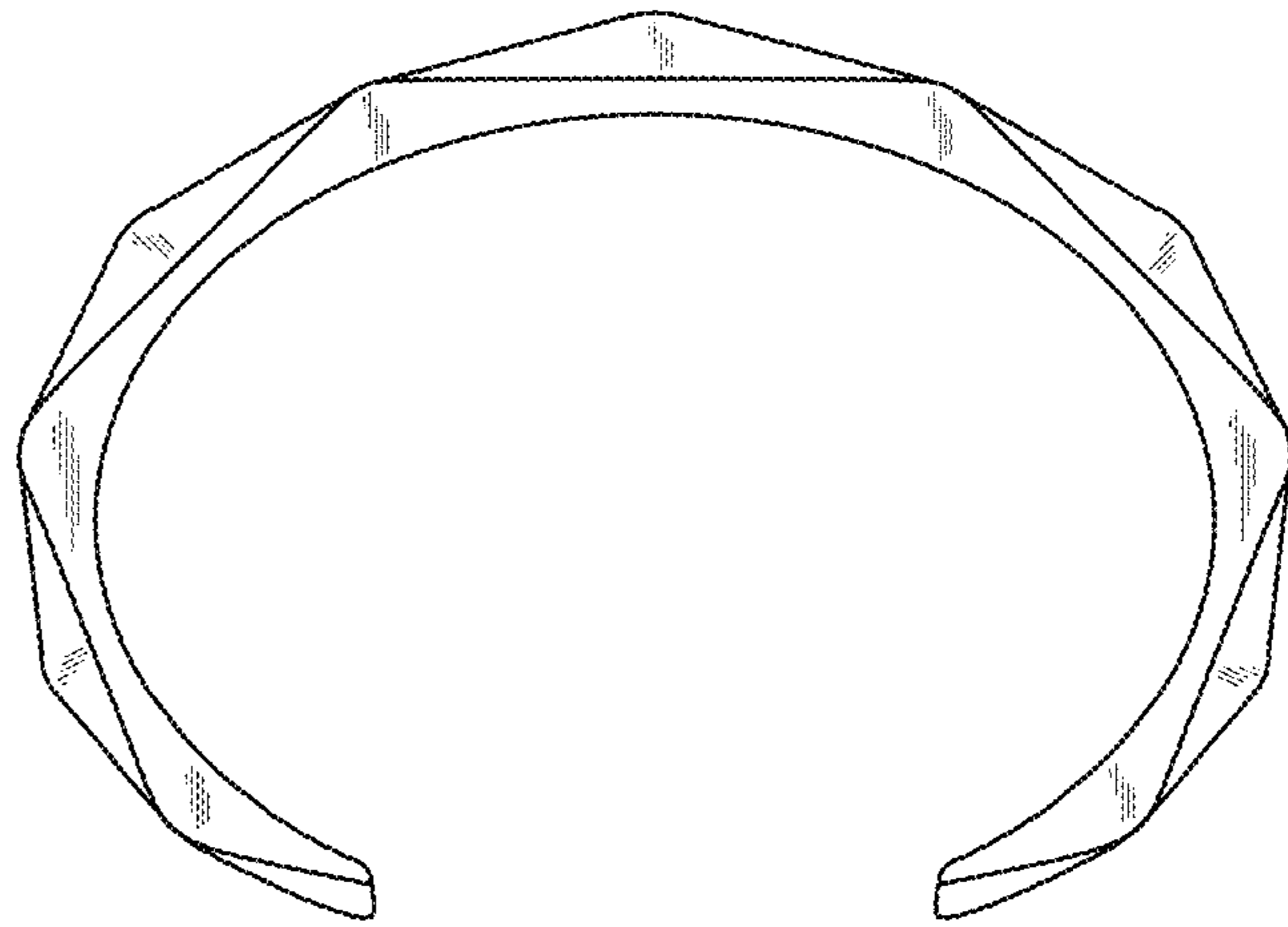

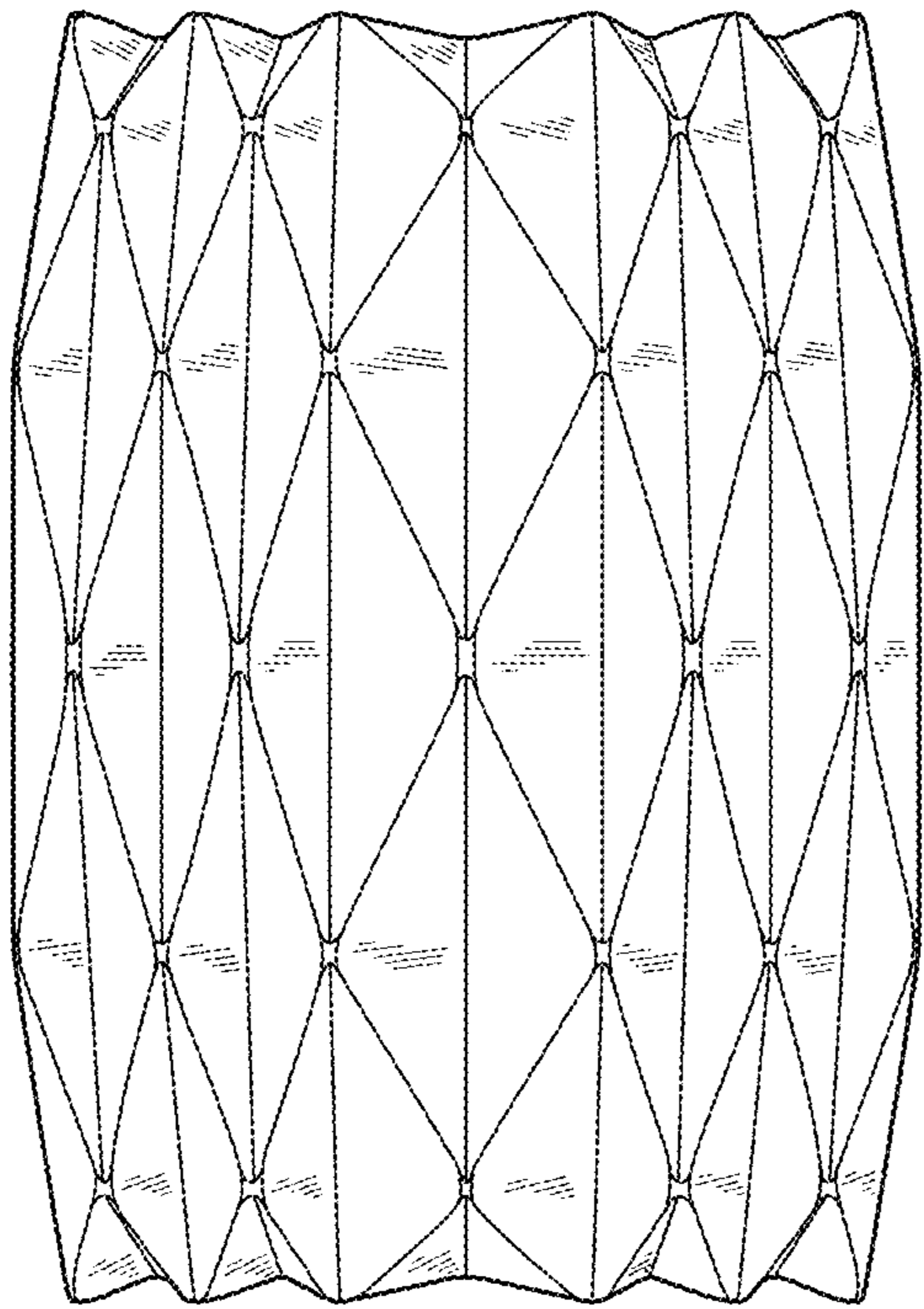

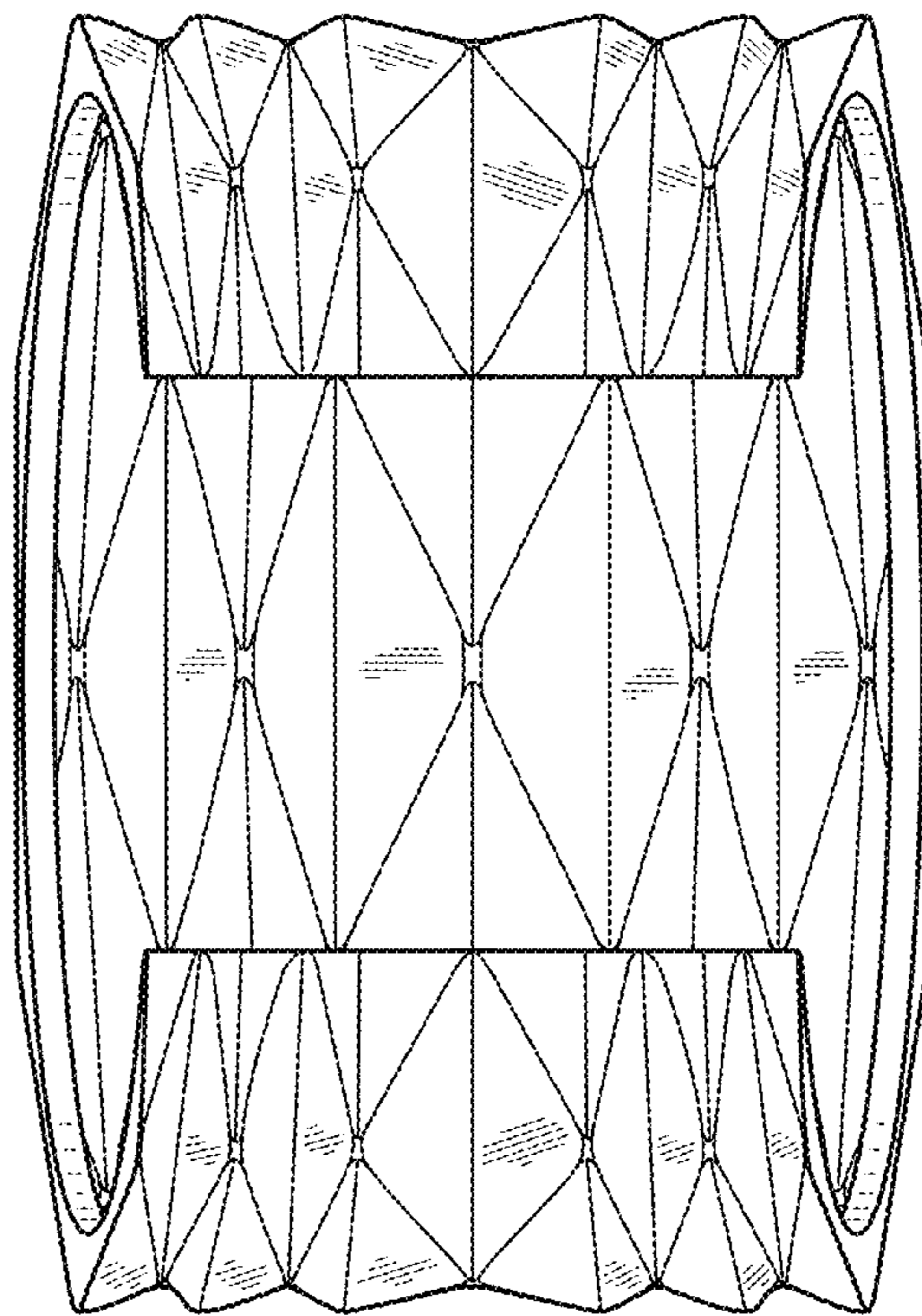
