(57) **CLAIM**

The ornamental design for a hand stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hand stand, shown with environment;
FIG. 2 is a front view thereof, shown without environment;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
Surface markings are provided to illustrate the shape of the design with greater clarity but do not indicate the use of any specific type of surface material. The broken lines showing a sphere in FIG. 1 illustrate environmental structure while all other broken lines illustrate portions of the hand stand; the broken lines form no part of the claimed design.

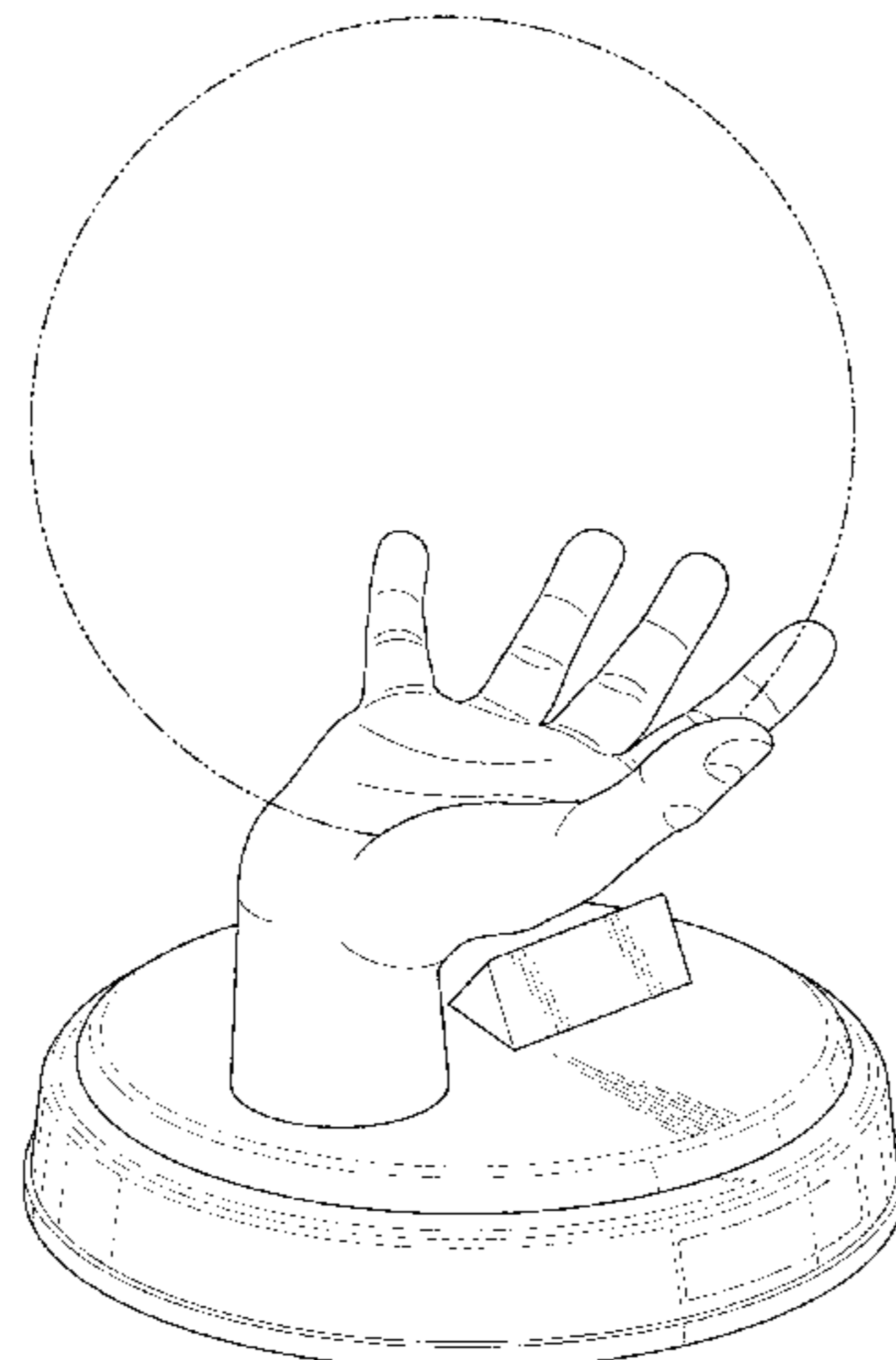
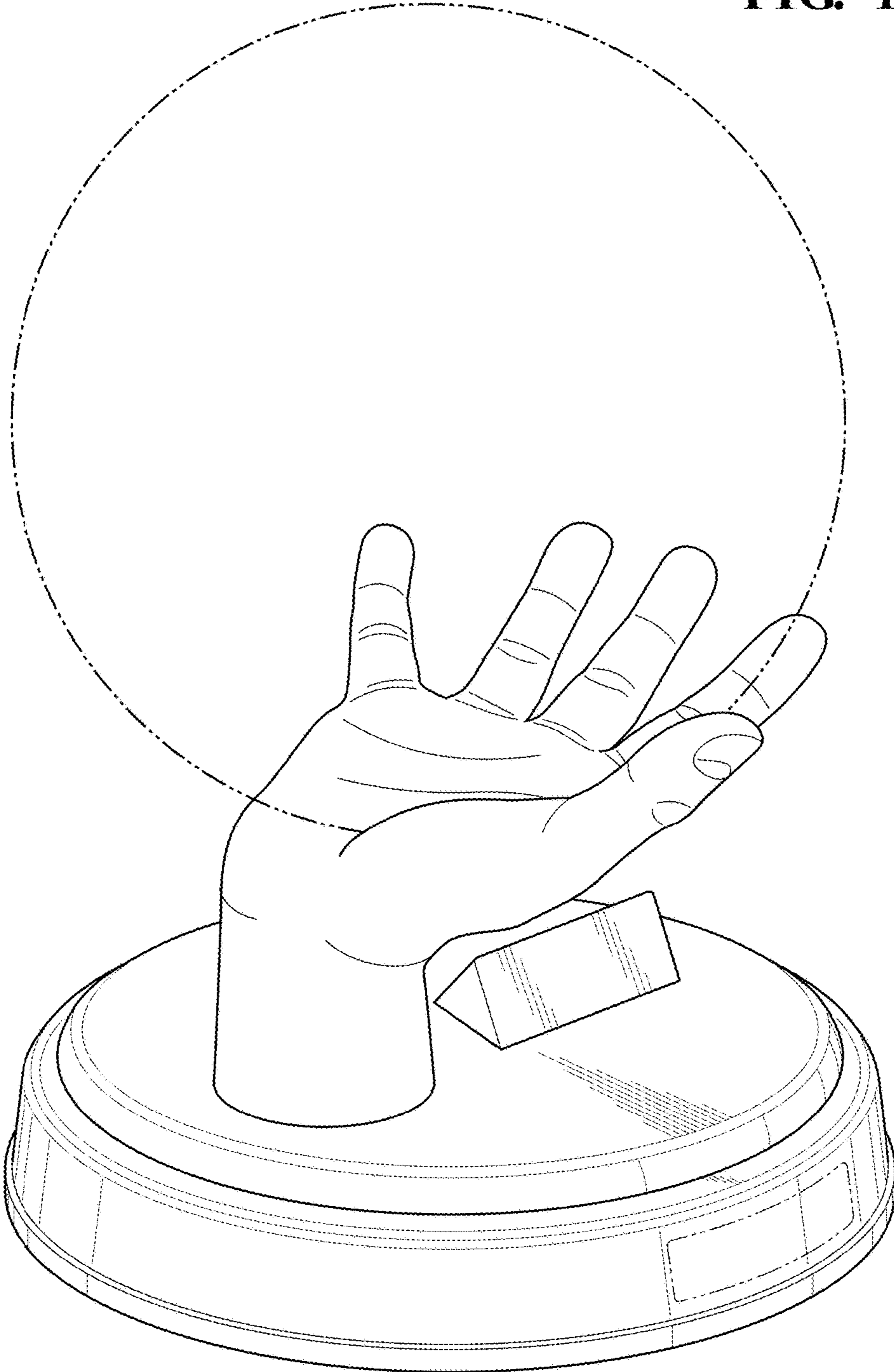

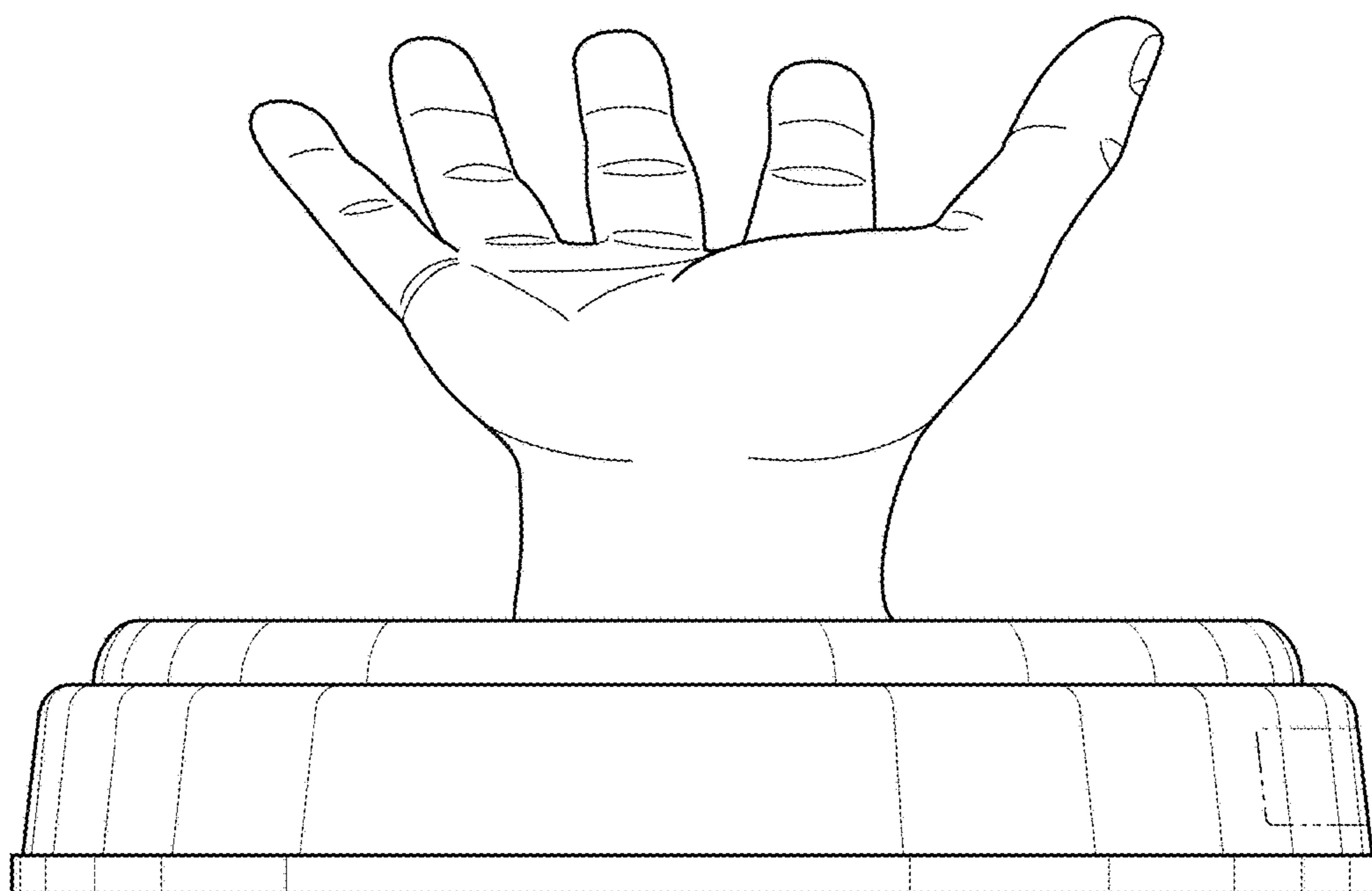

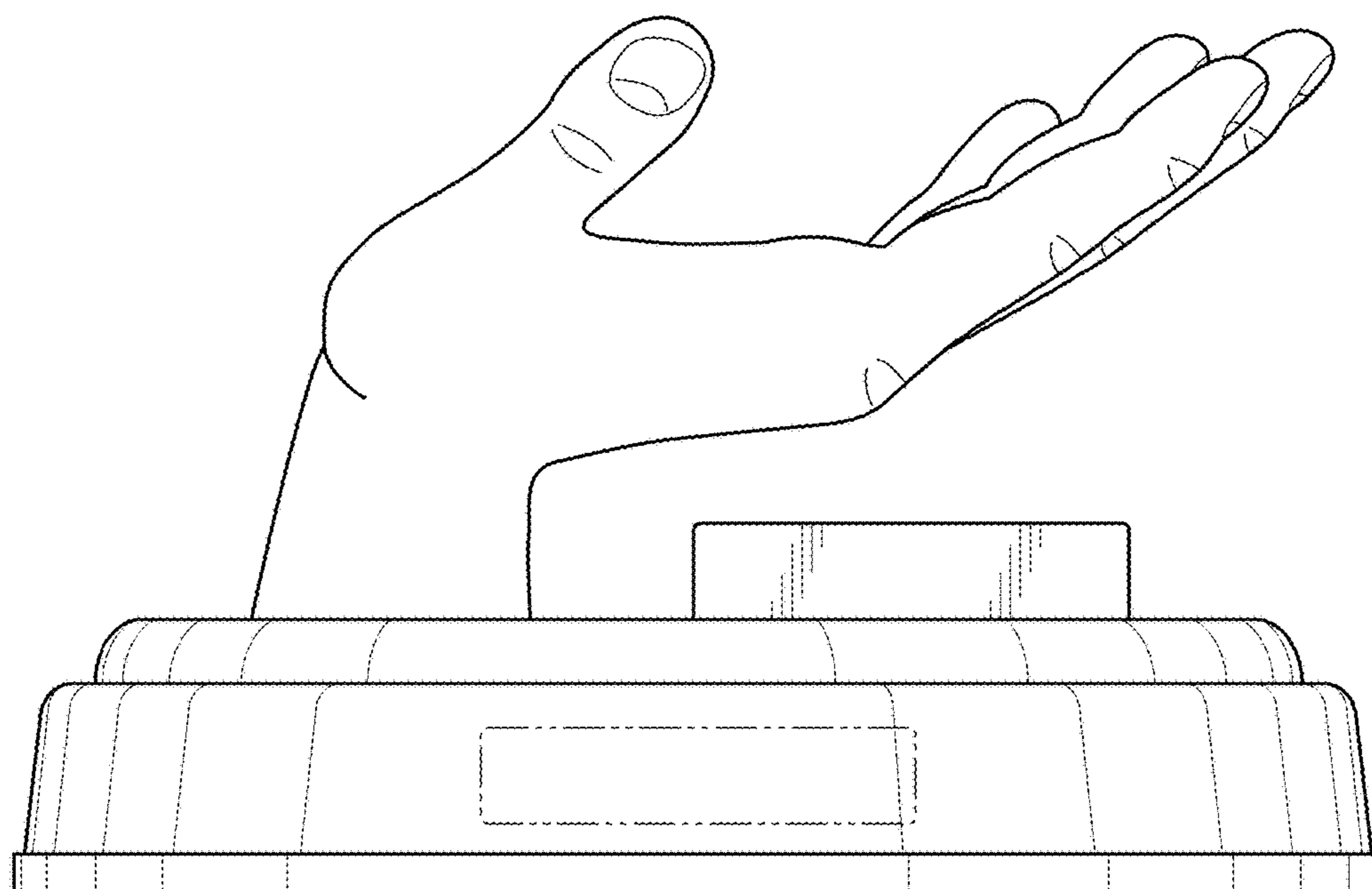

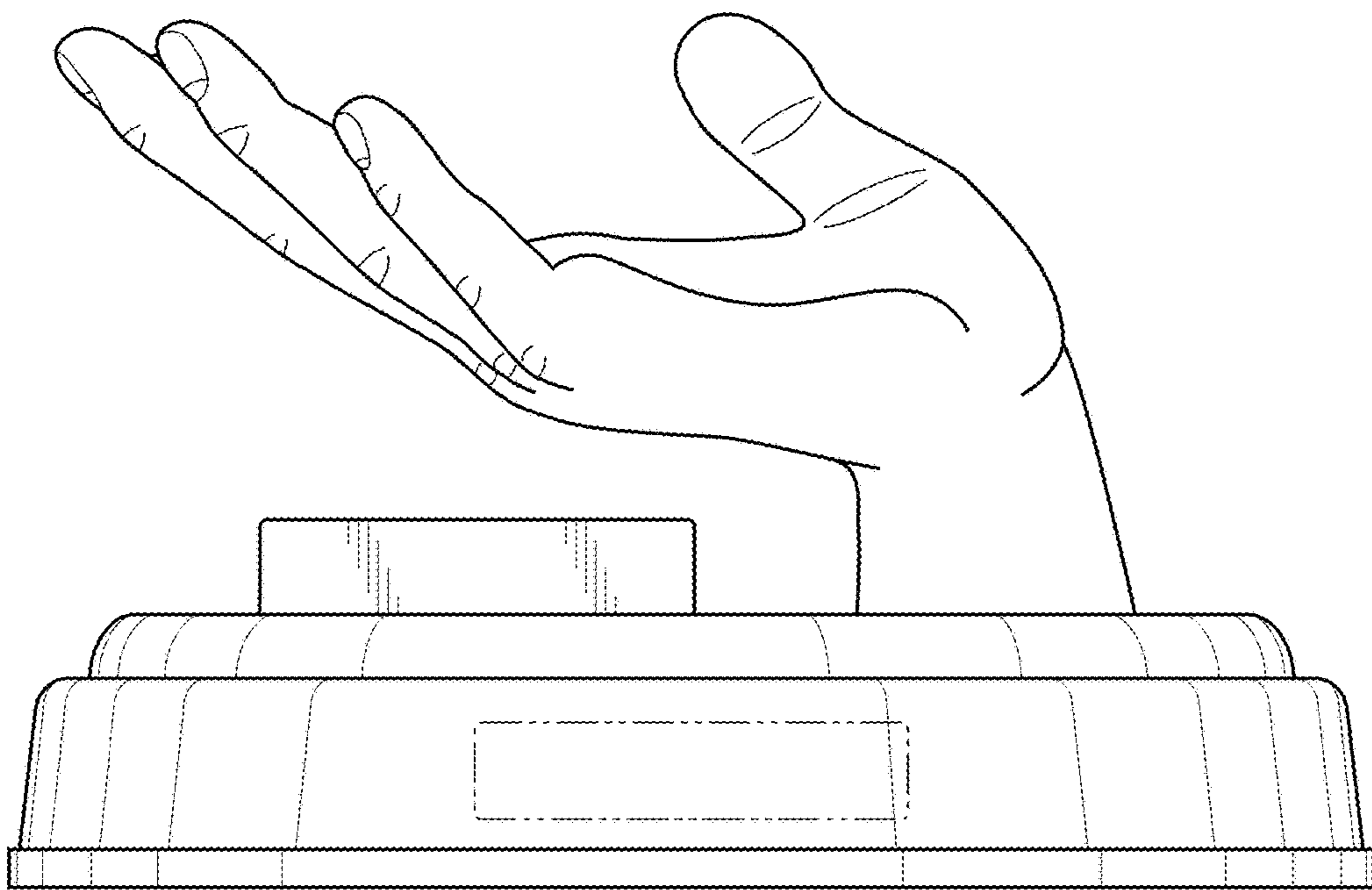

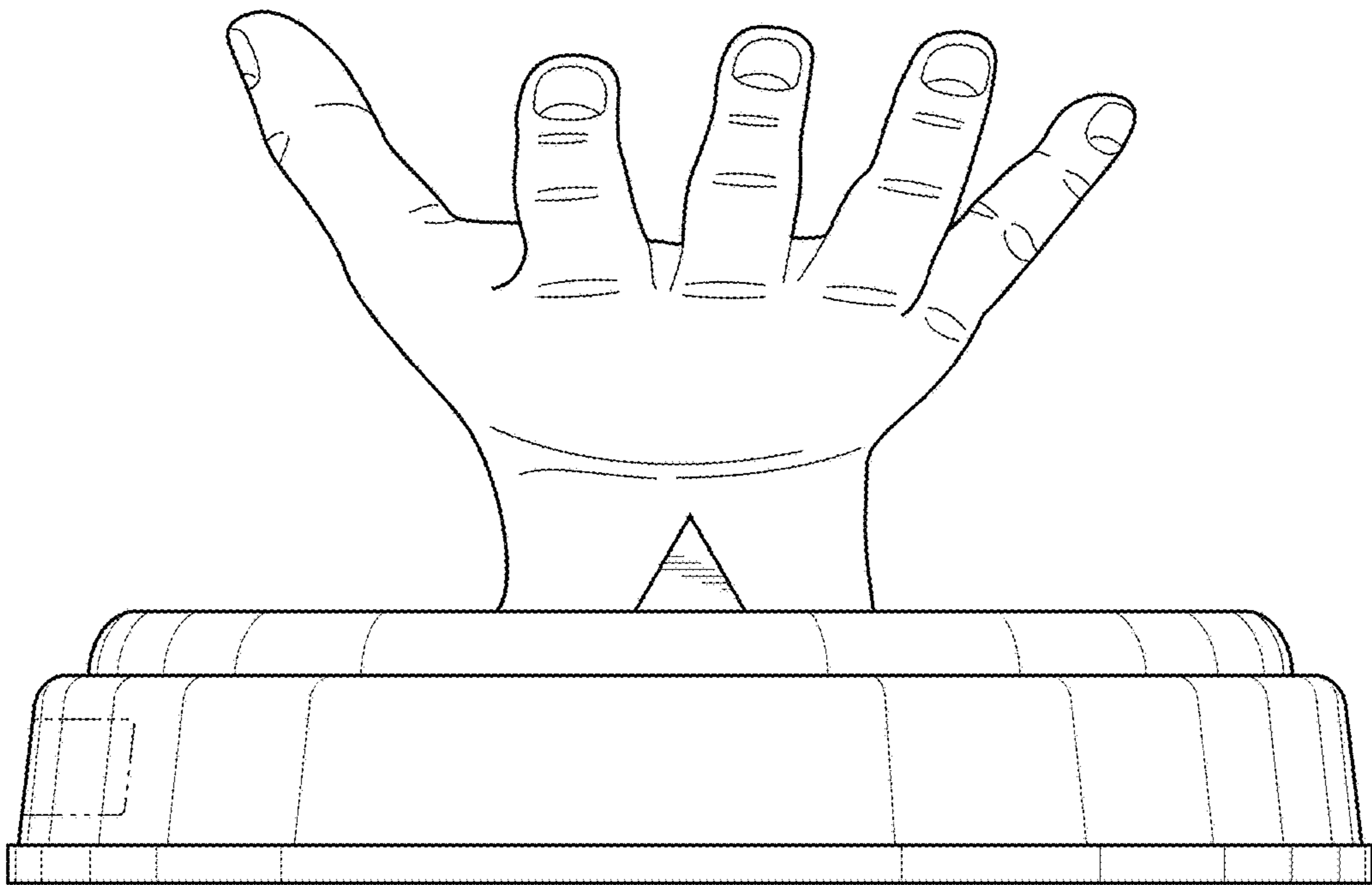

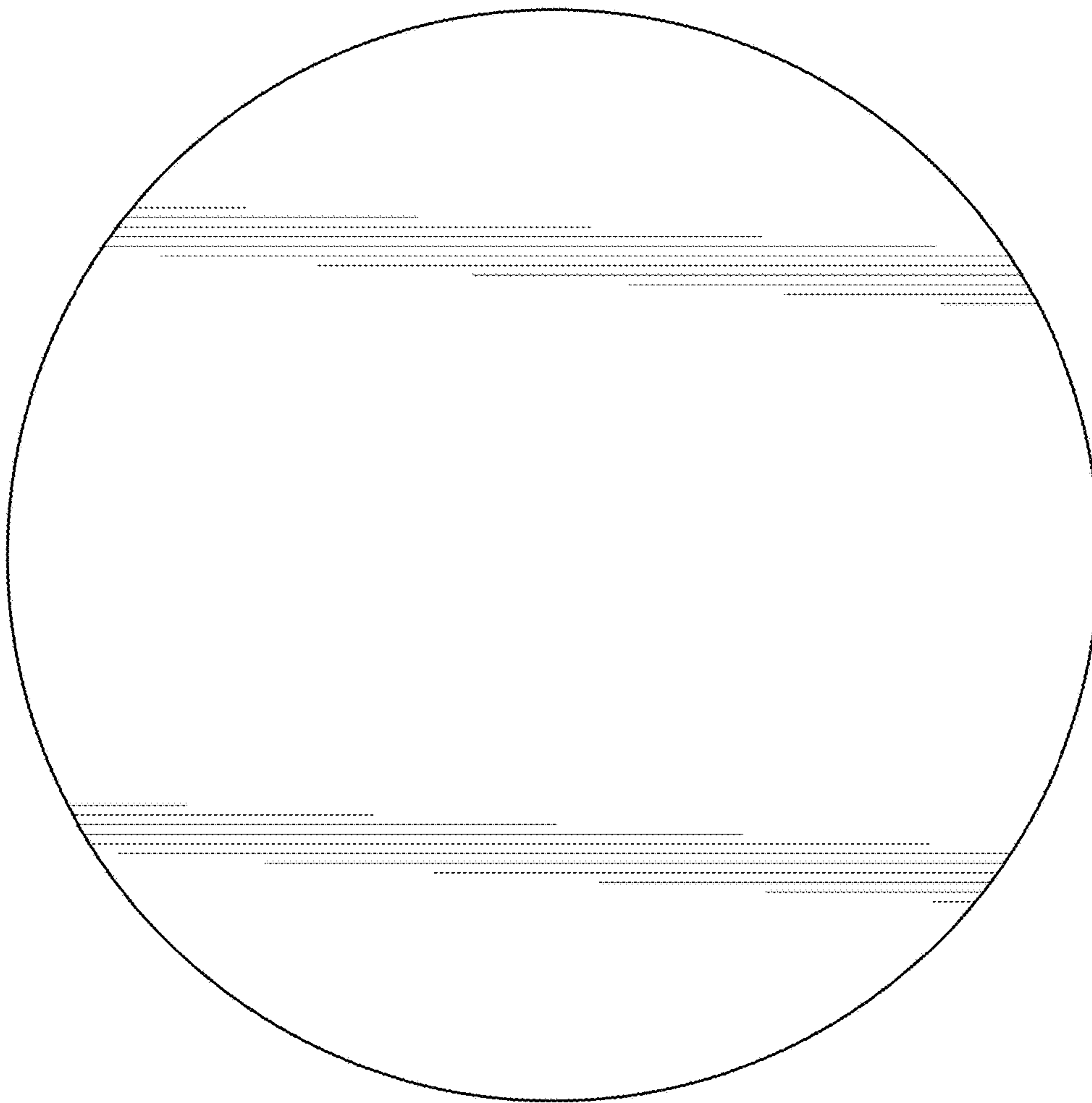
