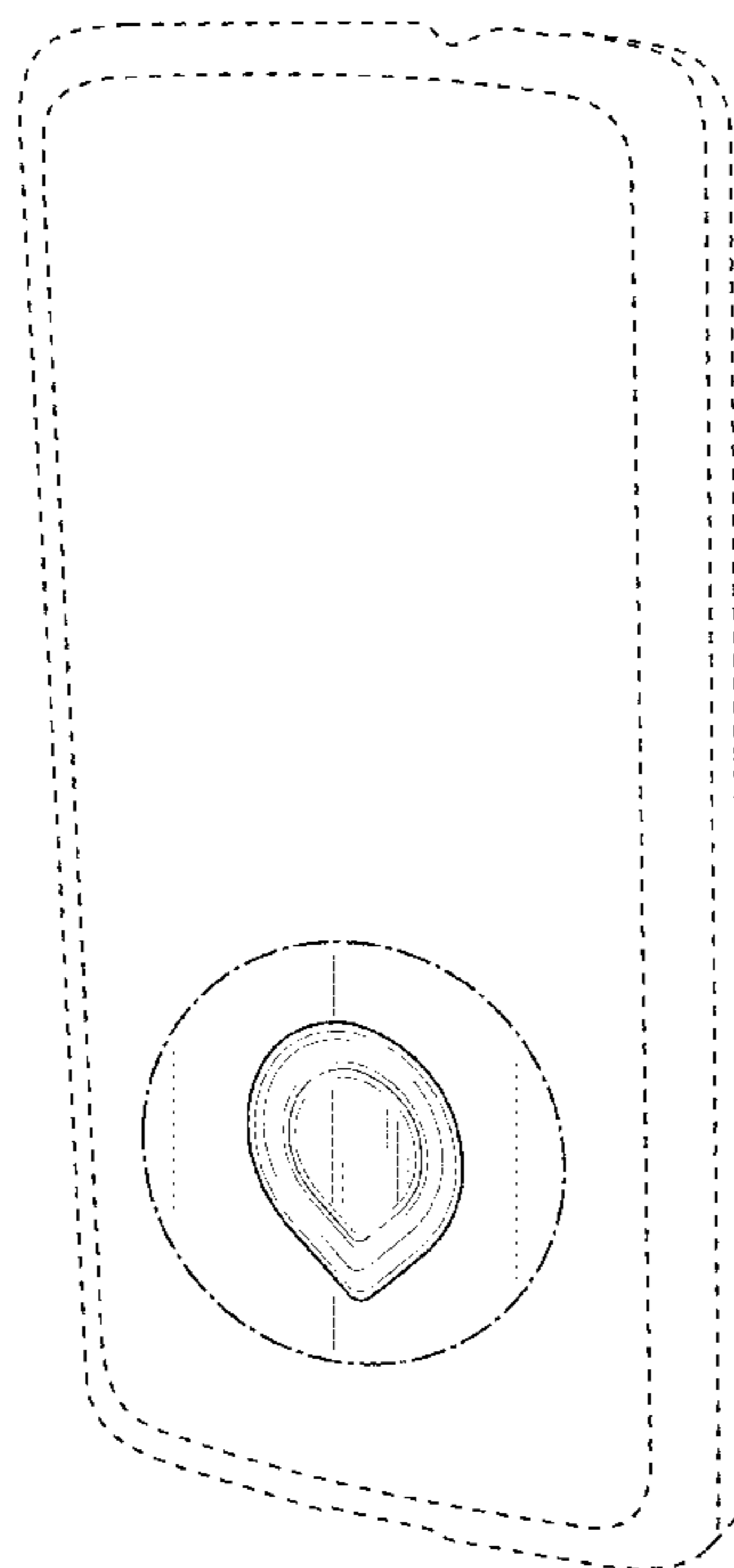
FIG. 1 is a front top perspective view of an enclosure for a communication device showing our new design;

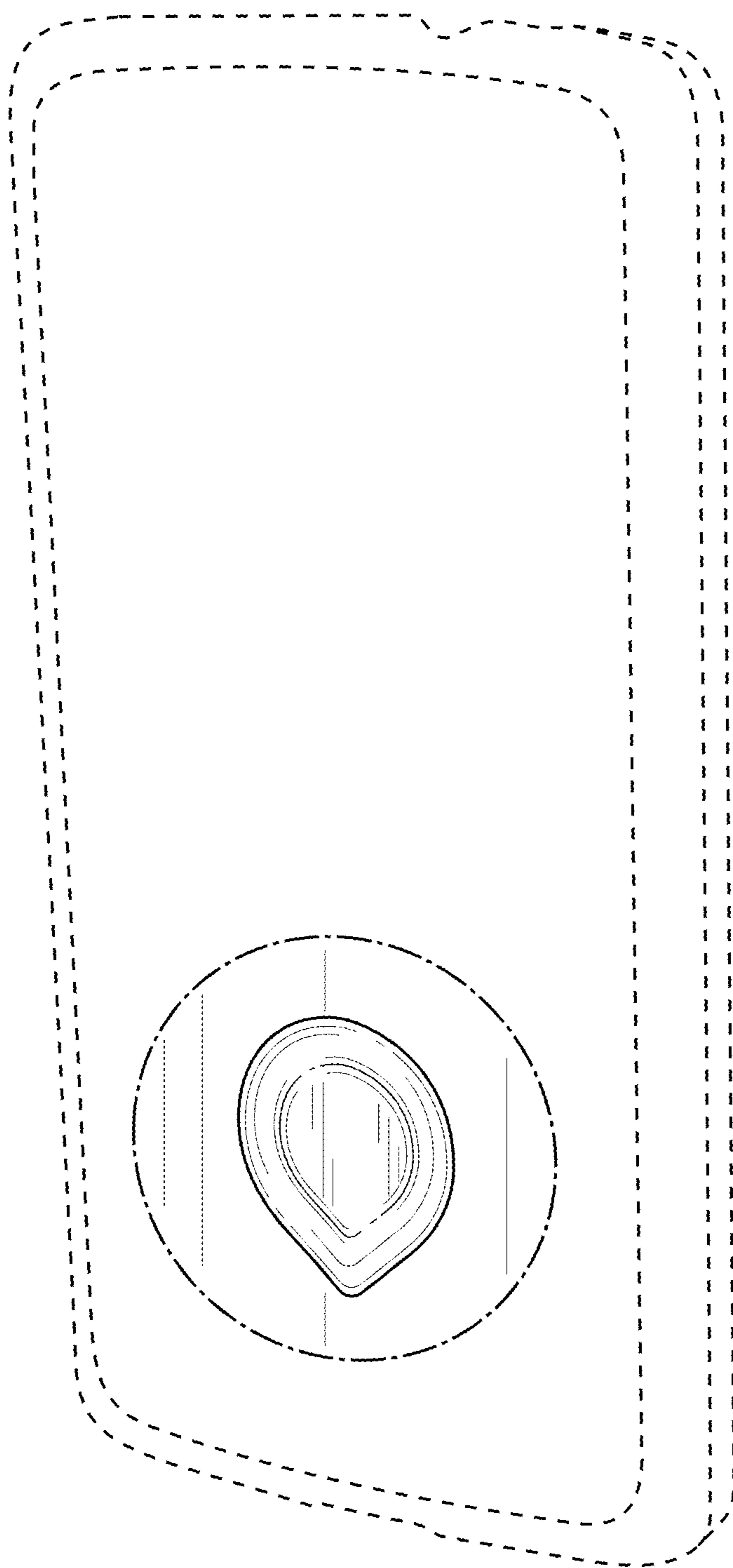

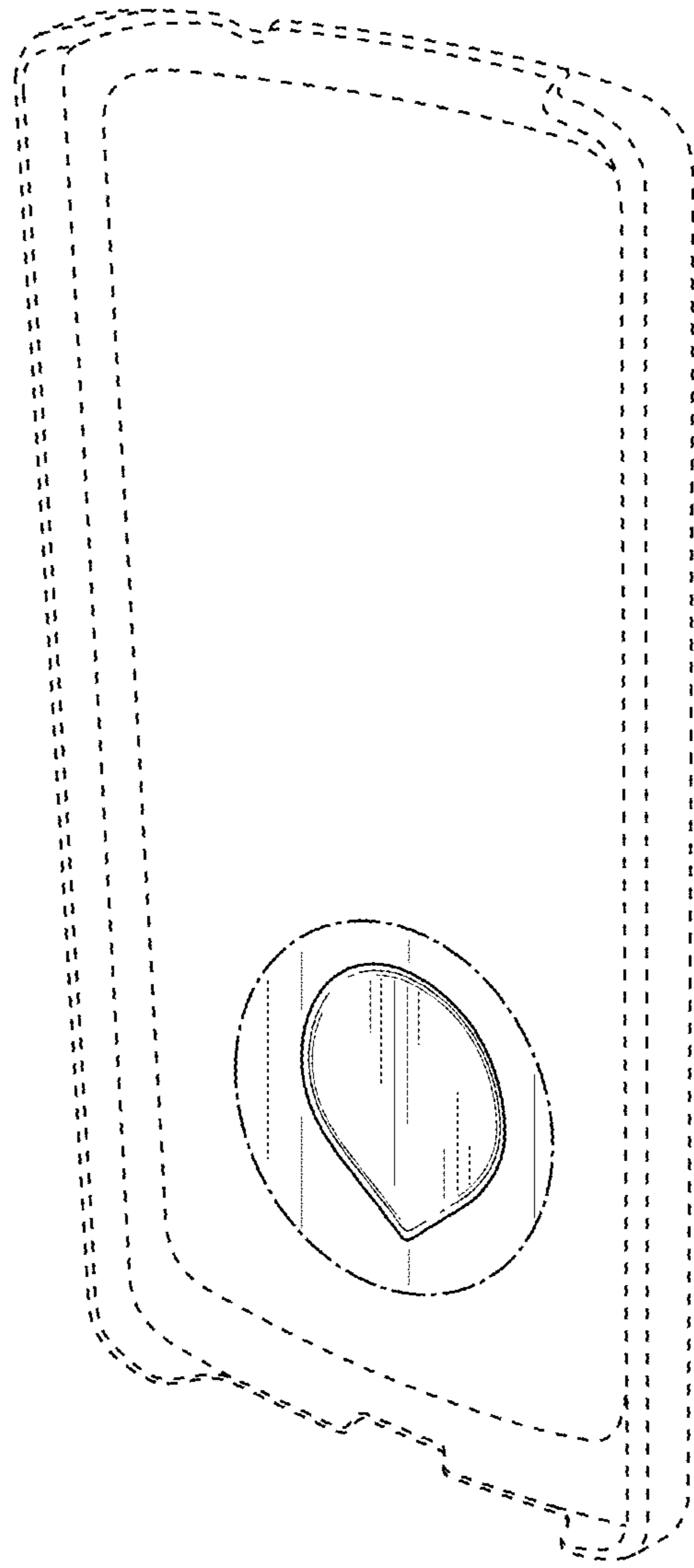

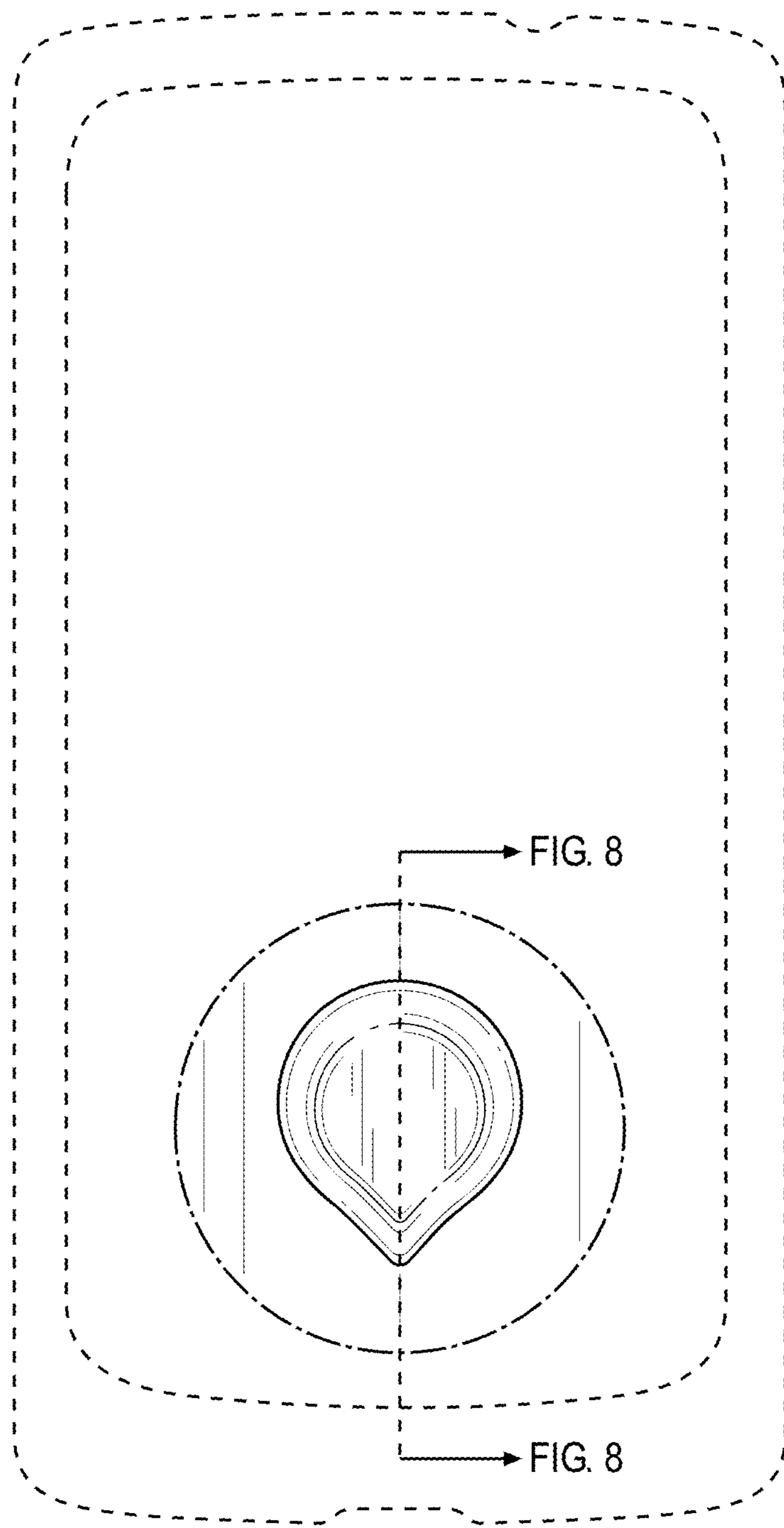

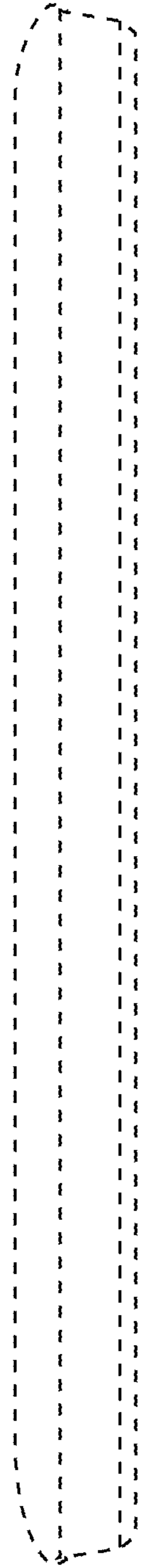

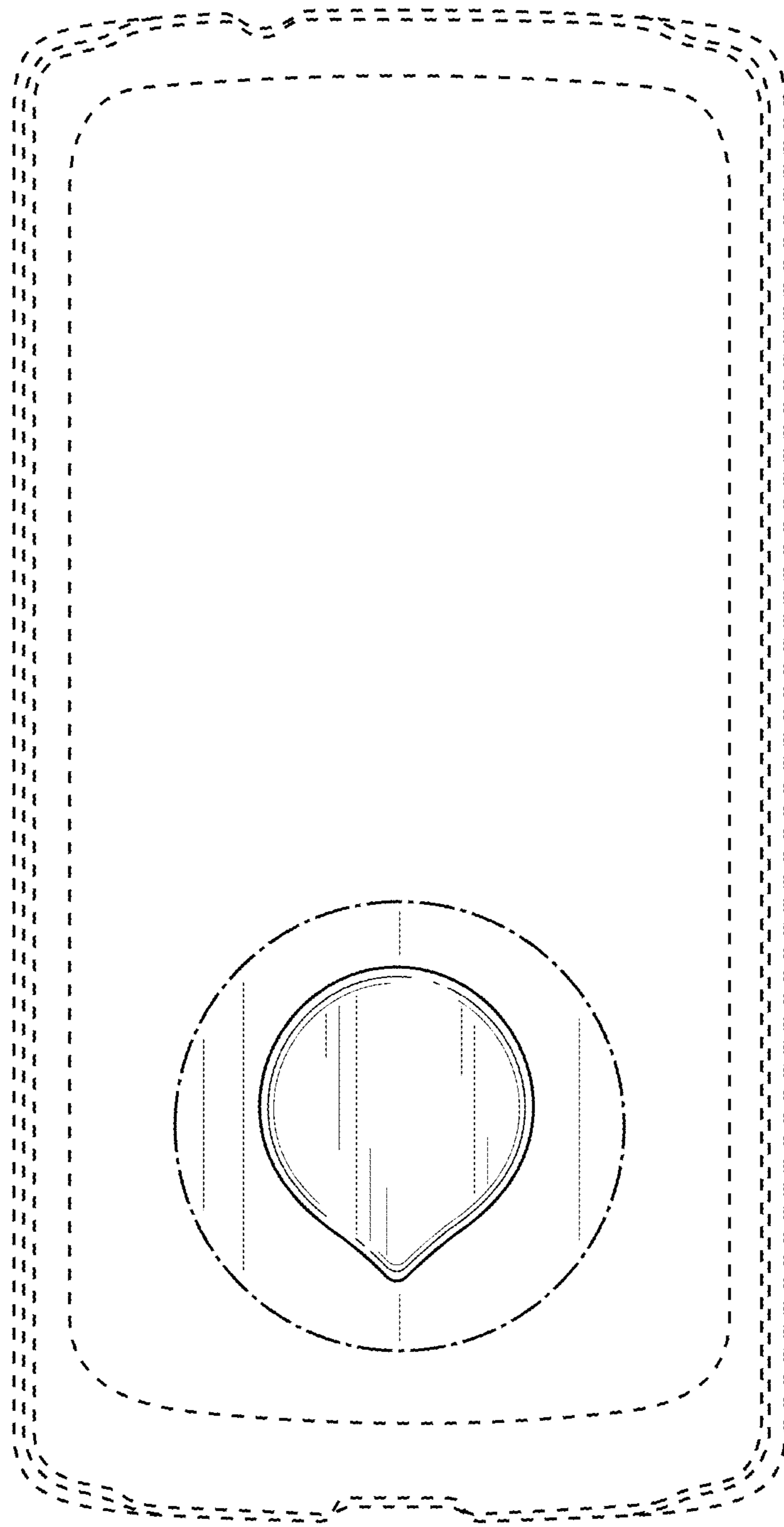

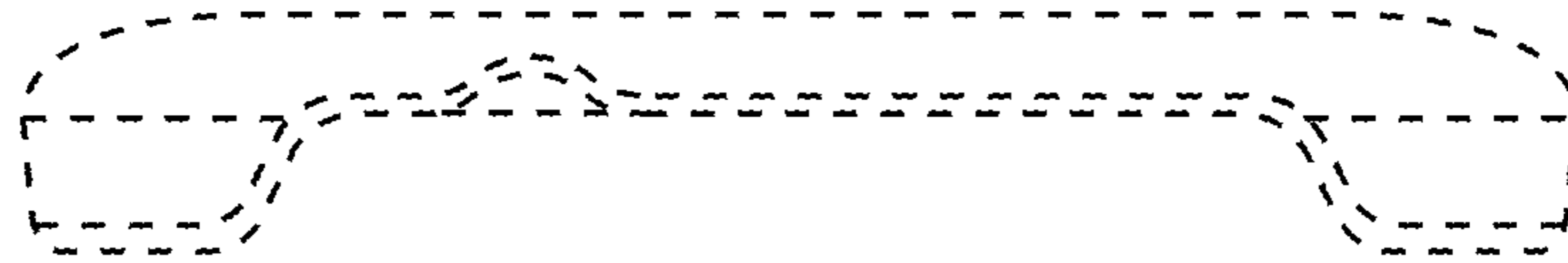

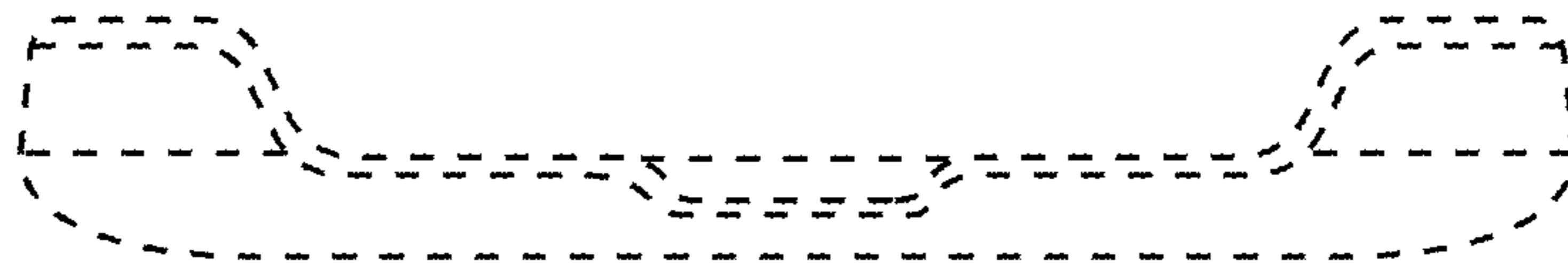
