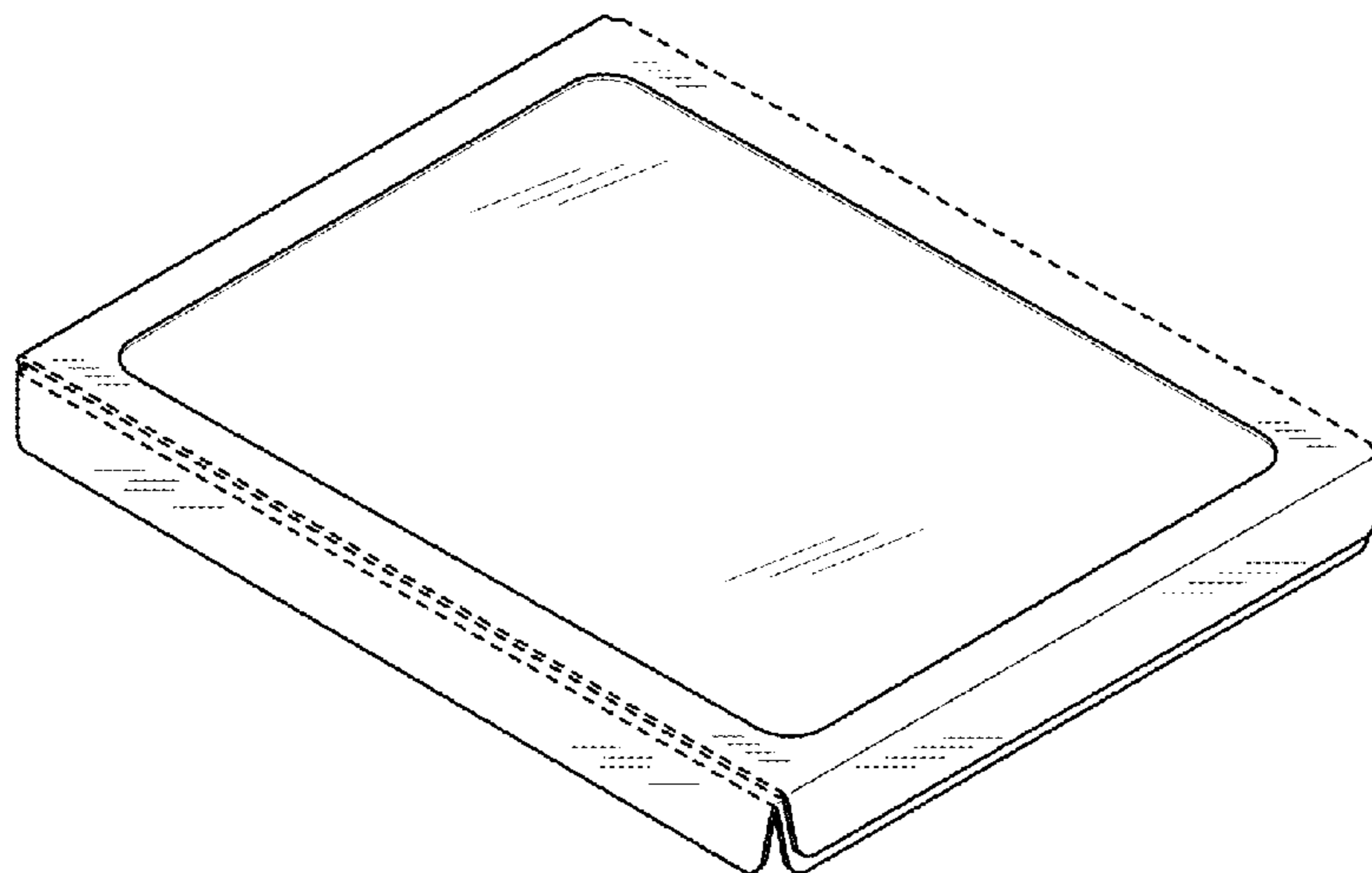
(57) **CLAIM**

The ornamental design for universal tablet packaging, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of universal tablet packaging in accordance with the design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a right plan view thereof; FIG. 6 is a left plan view thereof; FIG. 7 is a rear plan view thereof; FIG. 8 is a front plan view thereof; FIG. 9 is a bottom plan view thereof prior to folding; and, FIG. 10 is a top plan view thereof prior to folding. The broken lines represent portions of the structure that form no part of the claim.

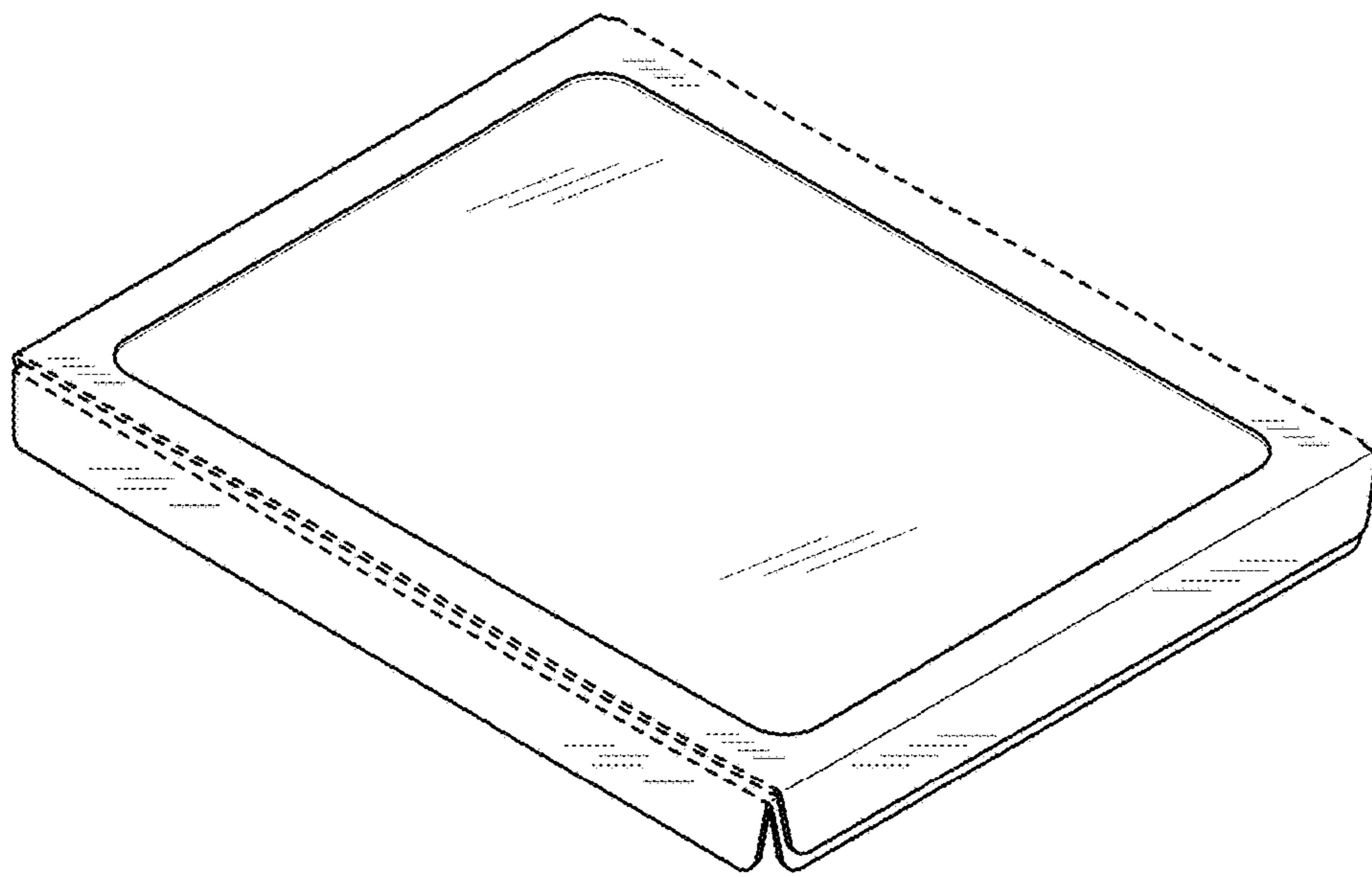

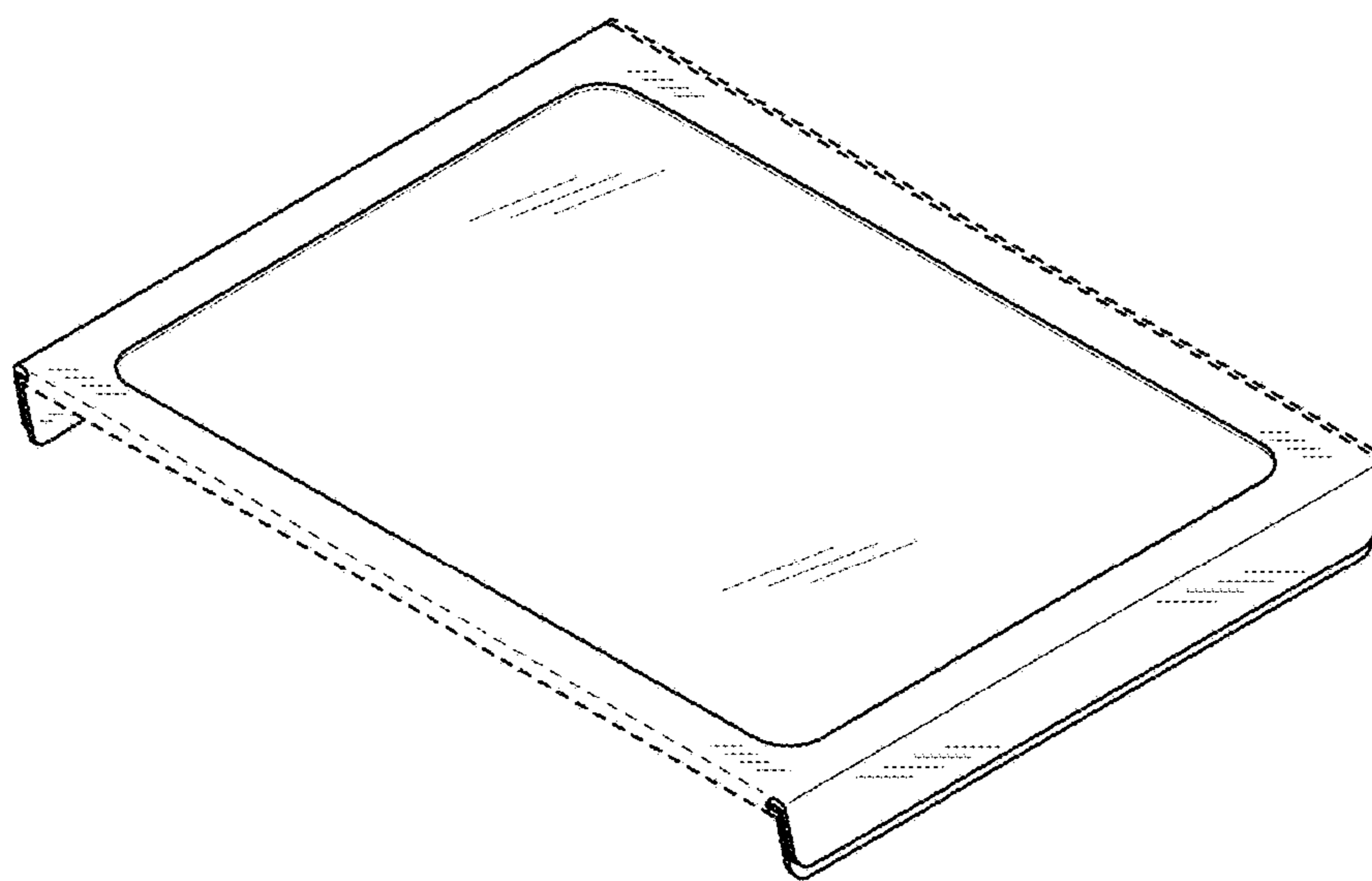

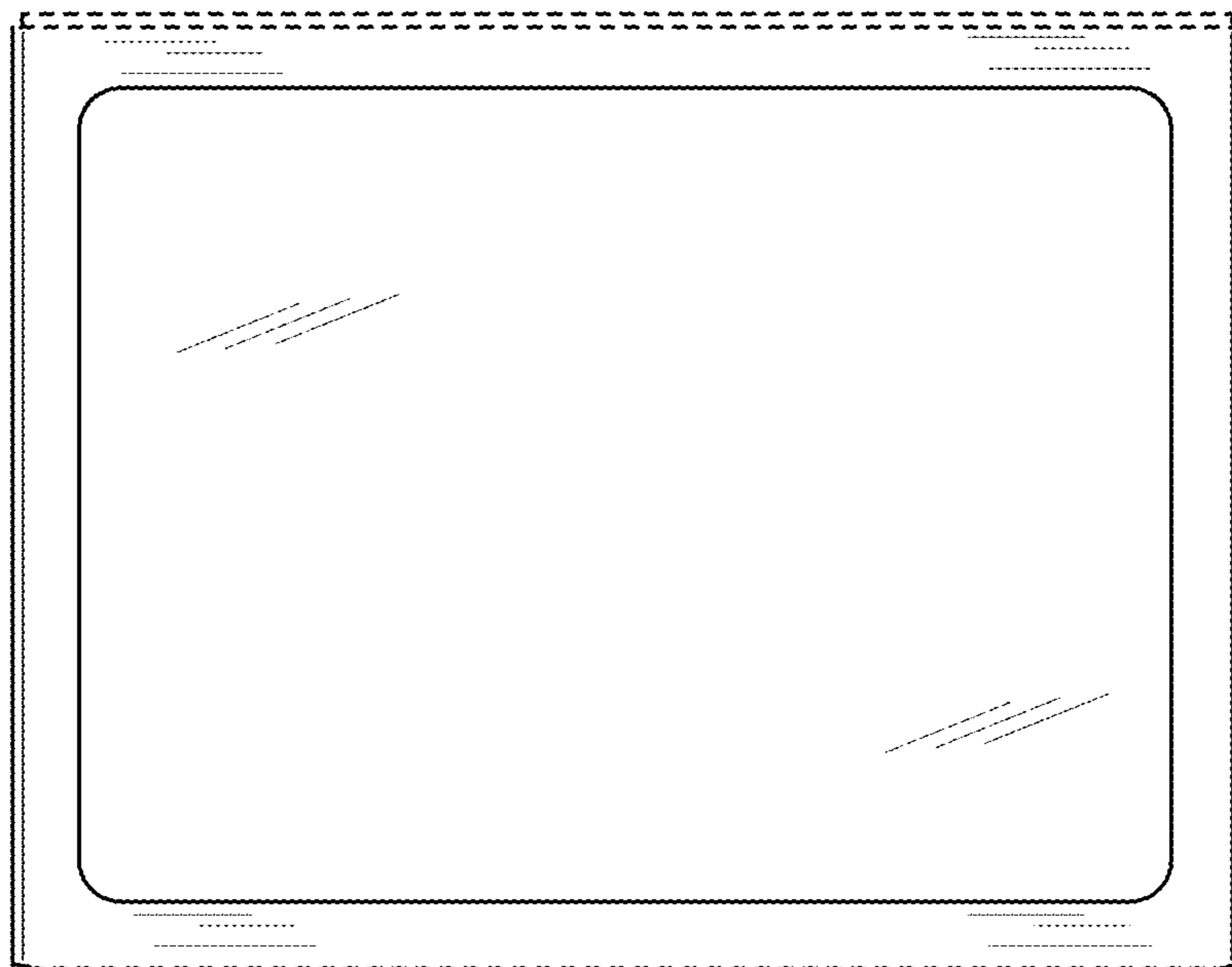

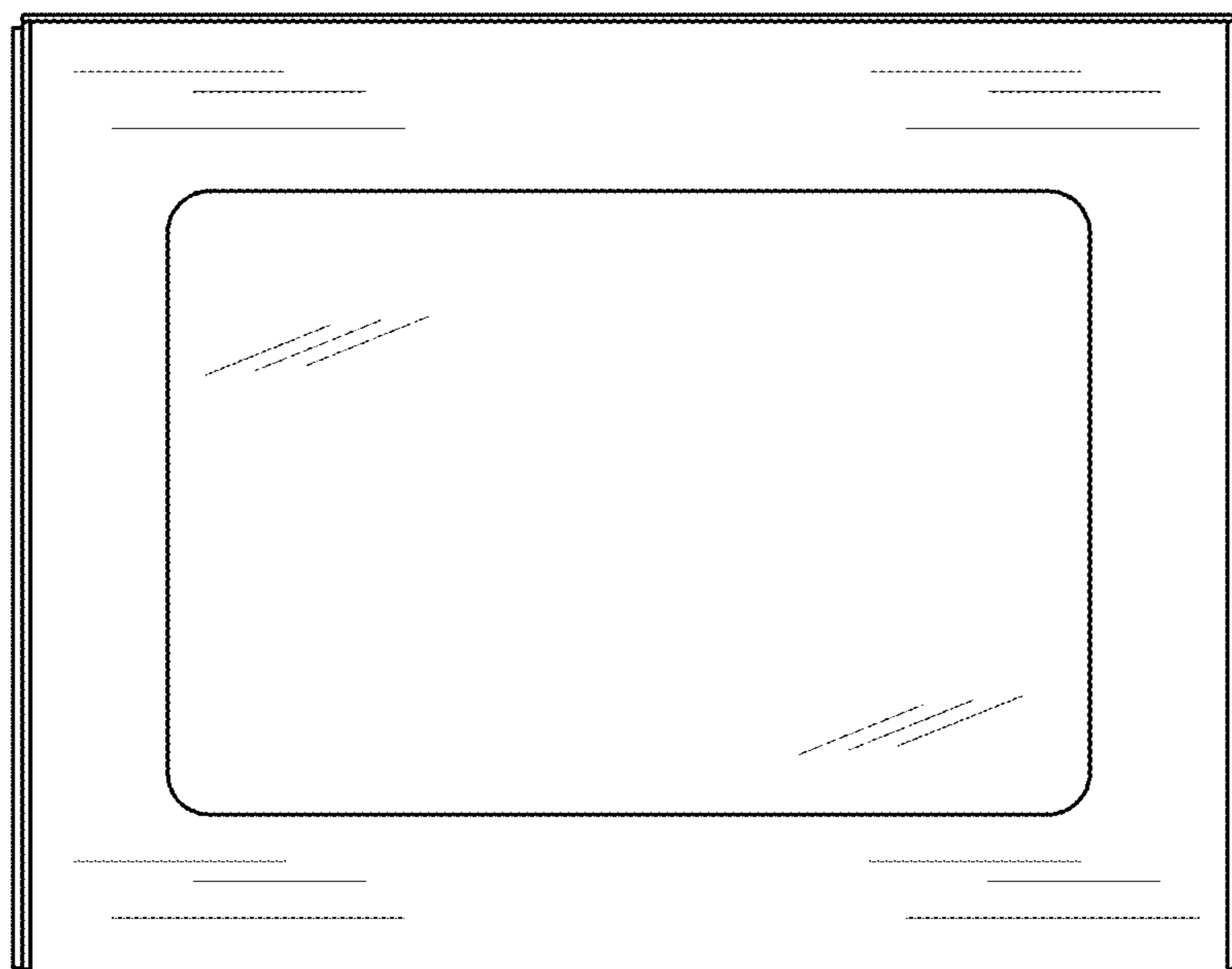

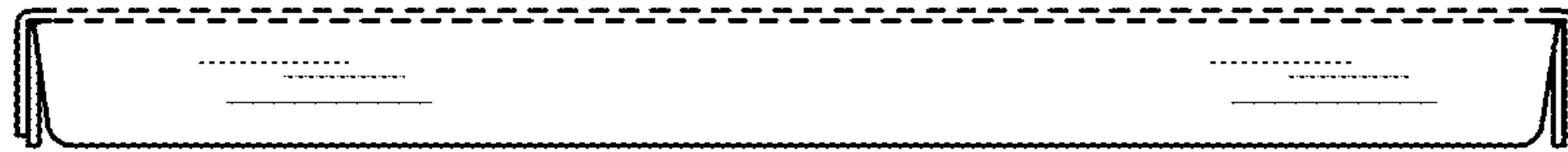

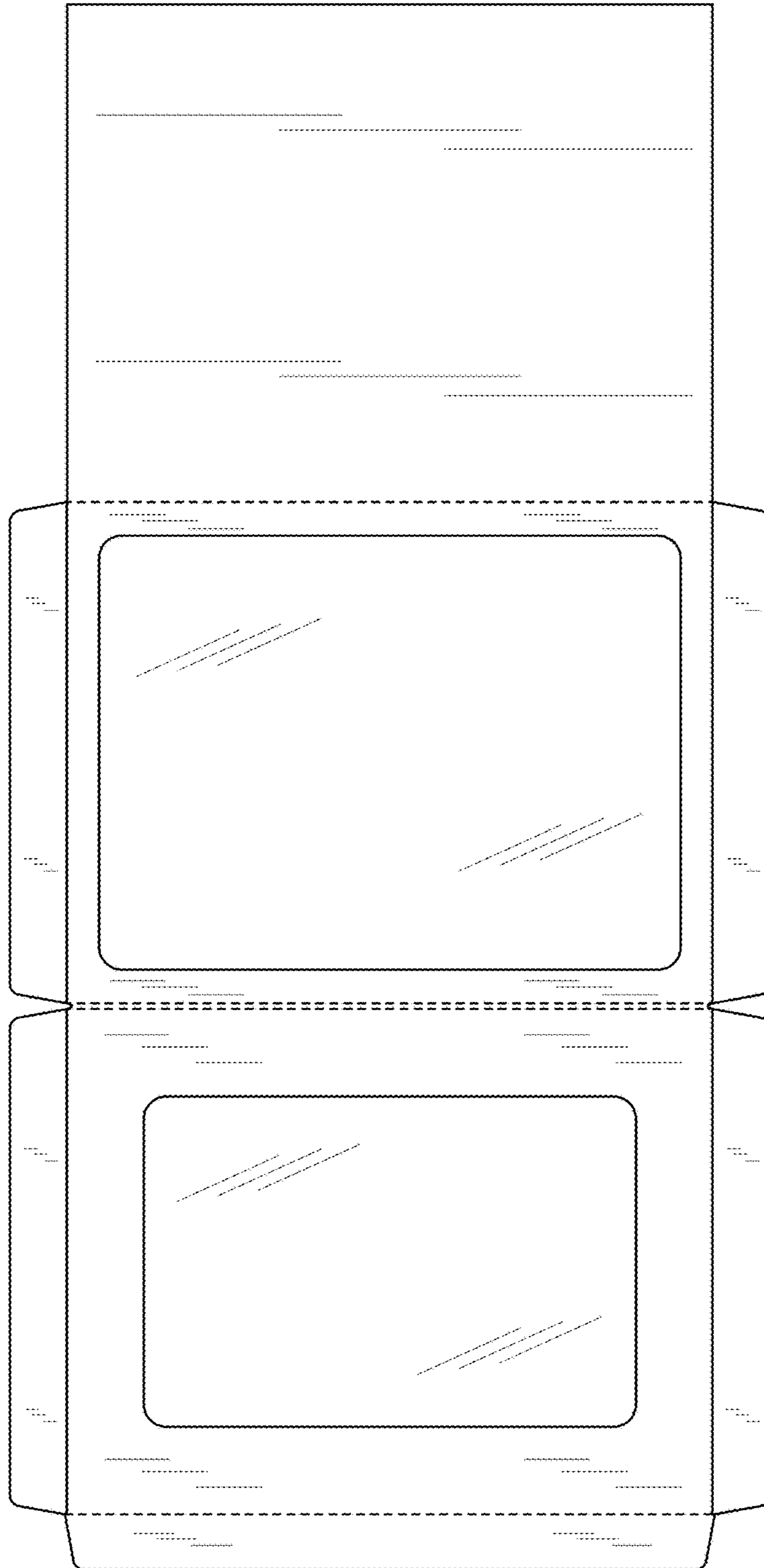

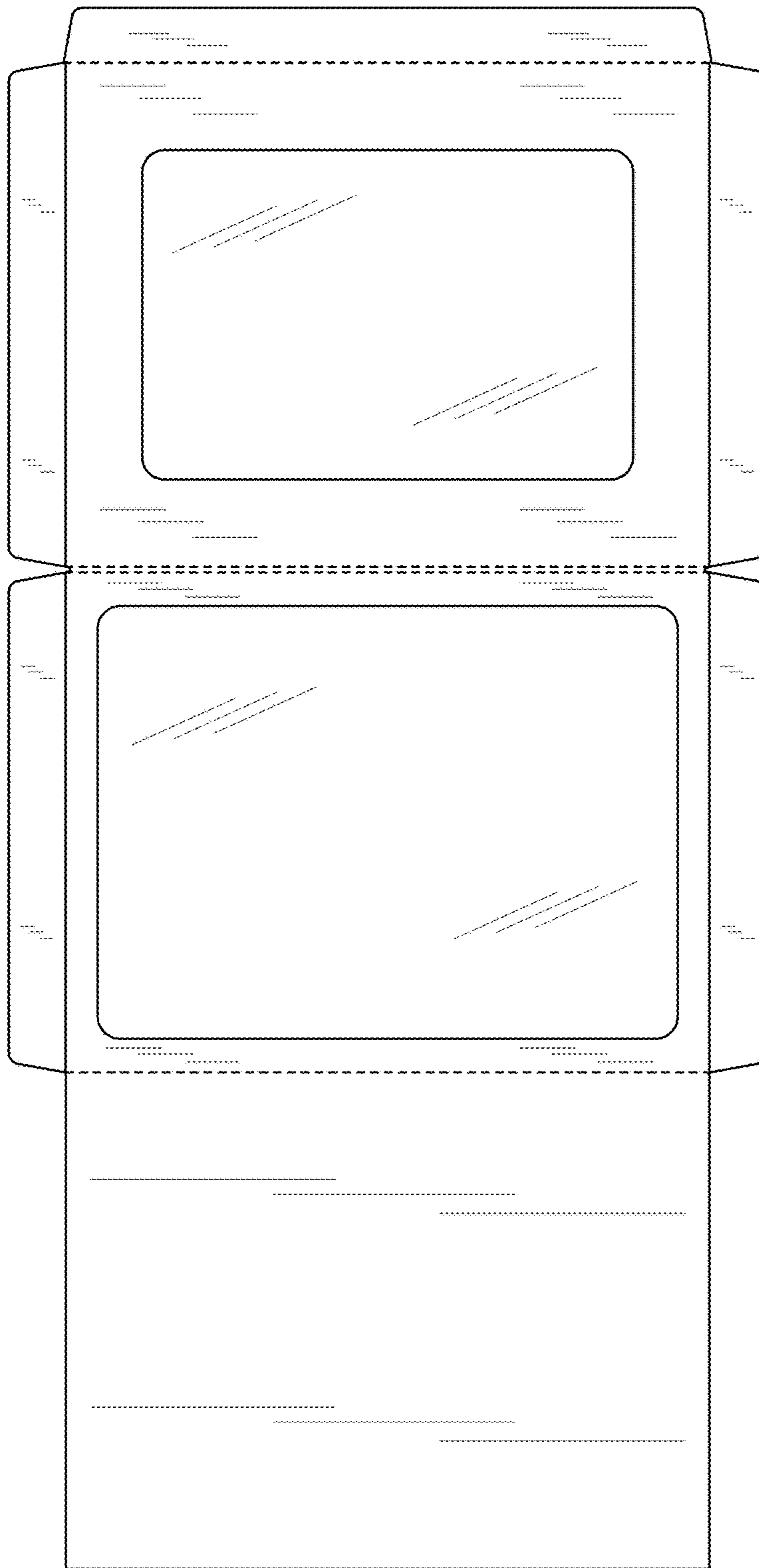
