(57) **CLAIM**

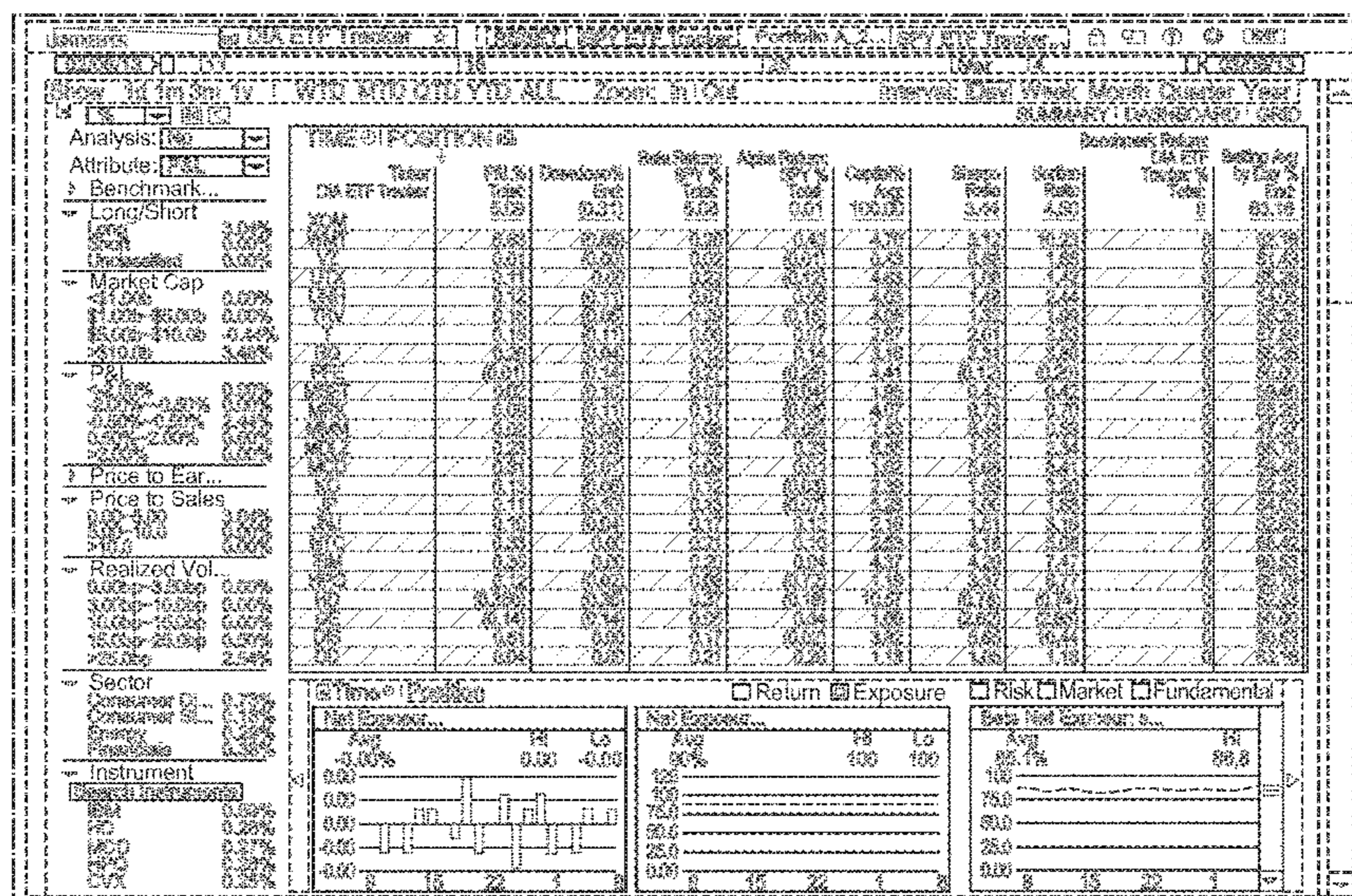
The ornamental design for a computer display with graphical user interface, as shown and described.
