(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen with animated graphical user interface showing our new design; FIG. 2 is a front view of a second image thereof; FIG. 3 is a front view of a third image thereof; FIG. 4 is a front view of a fourth image thereof; FIG. 5 is a front view of a fifth image thereof; and, FIG. 6 is a front view of a sixth image thereof.

The broken lines in the drawings illustrate the display screen and portions of the graphical user interface and for no part of the claimed design.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-6. The process or period in which one image transitions to another image forms no part of the claimed design.

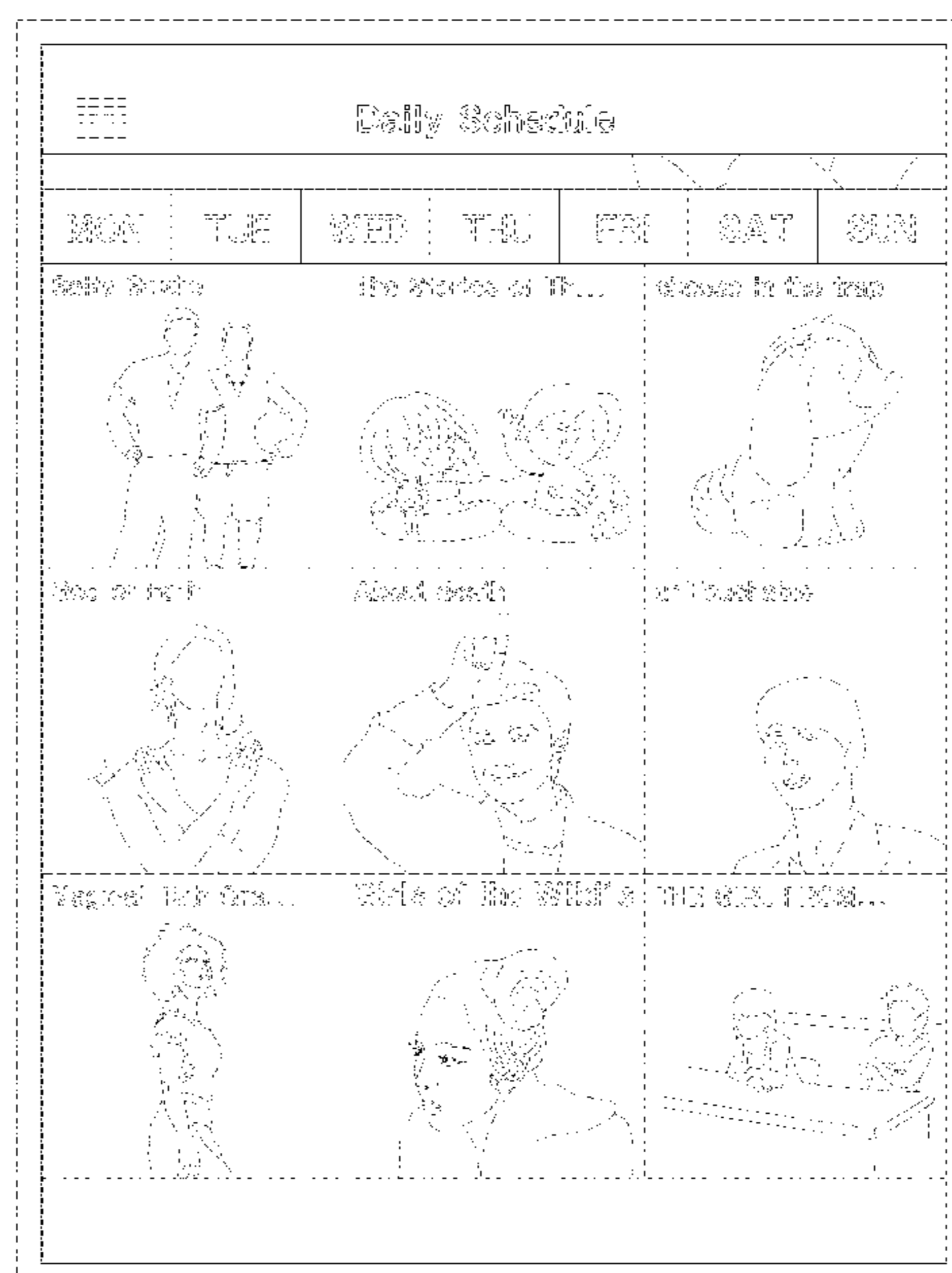
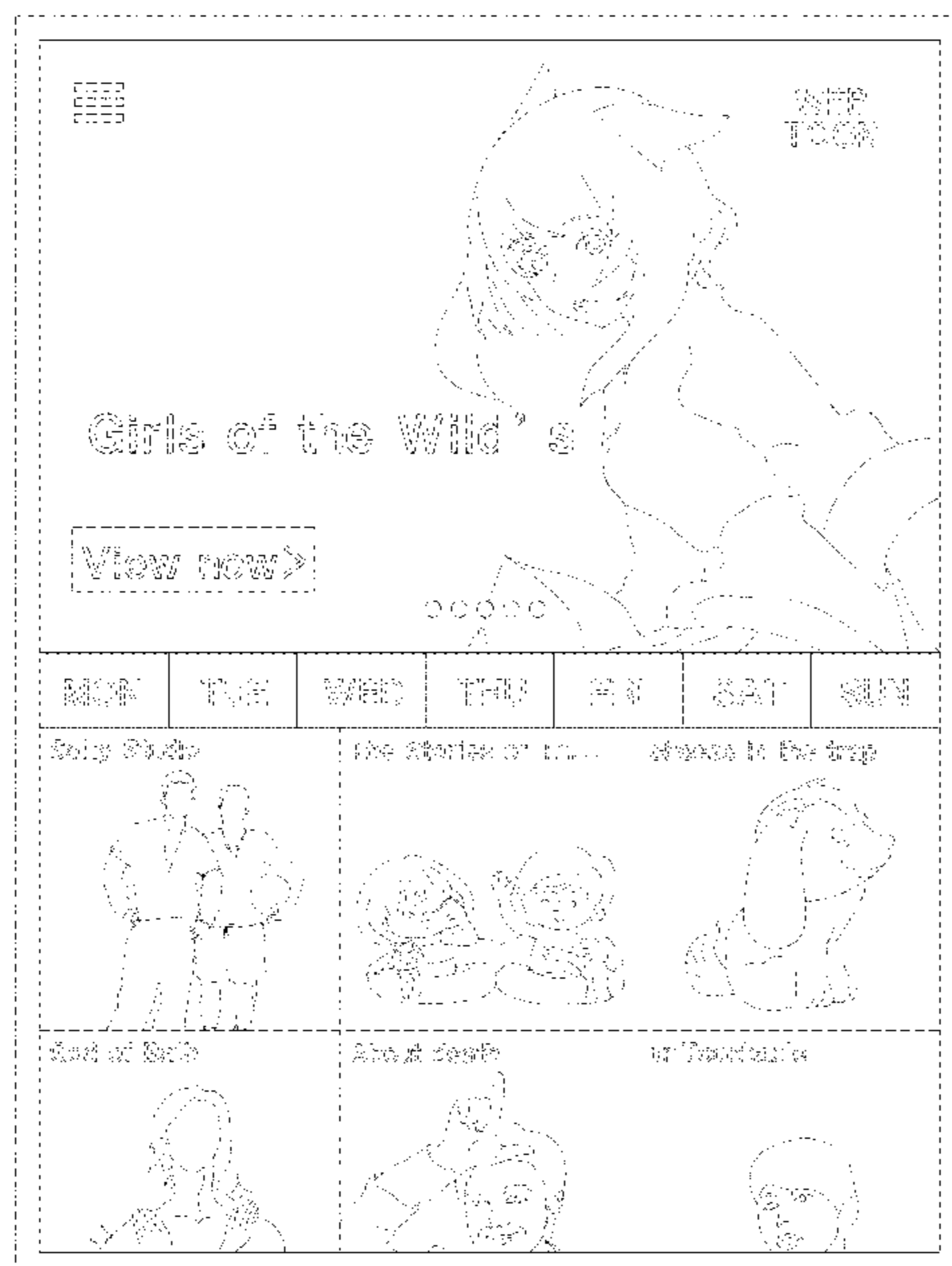

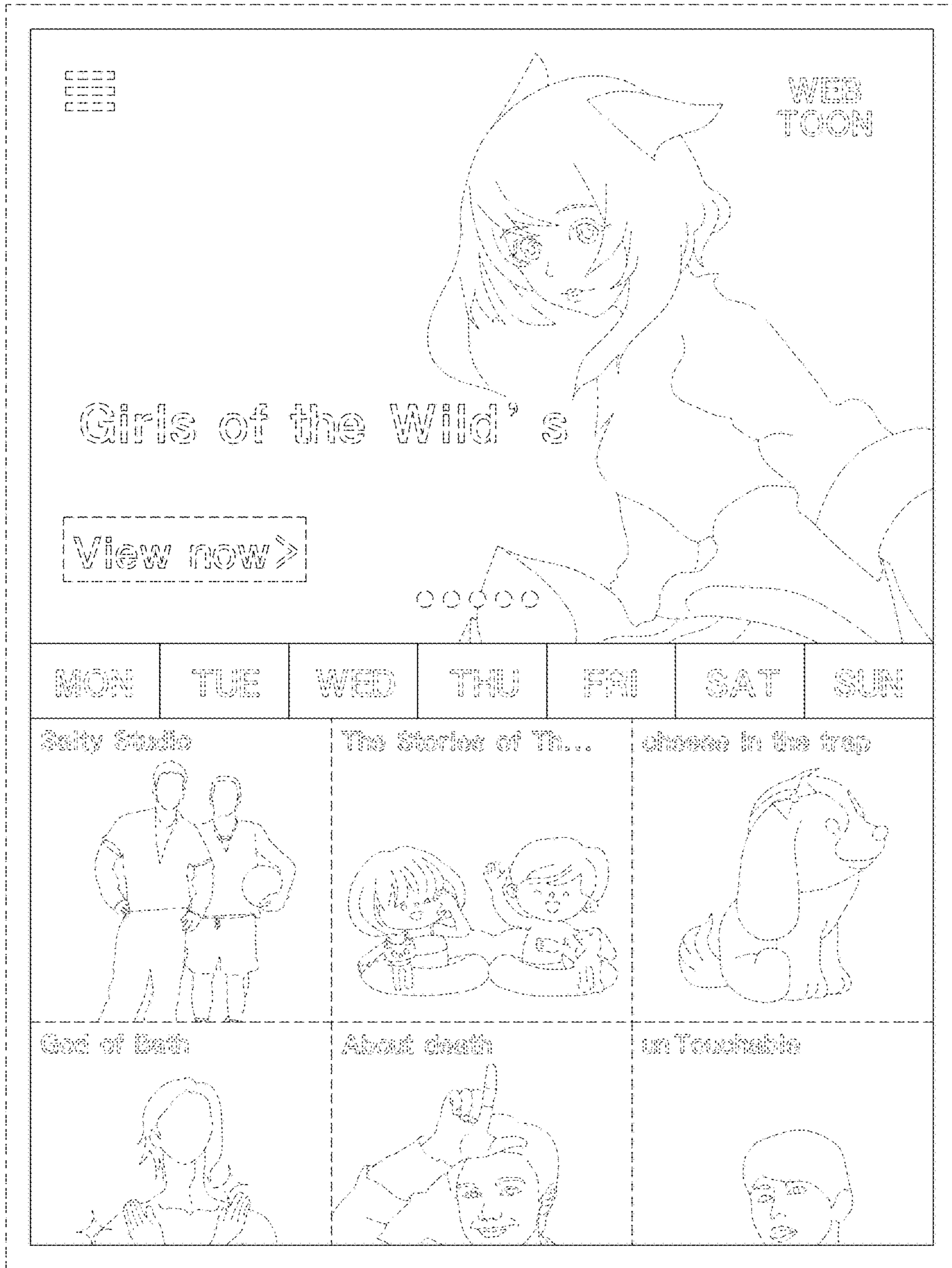

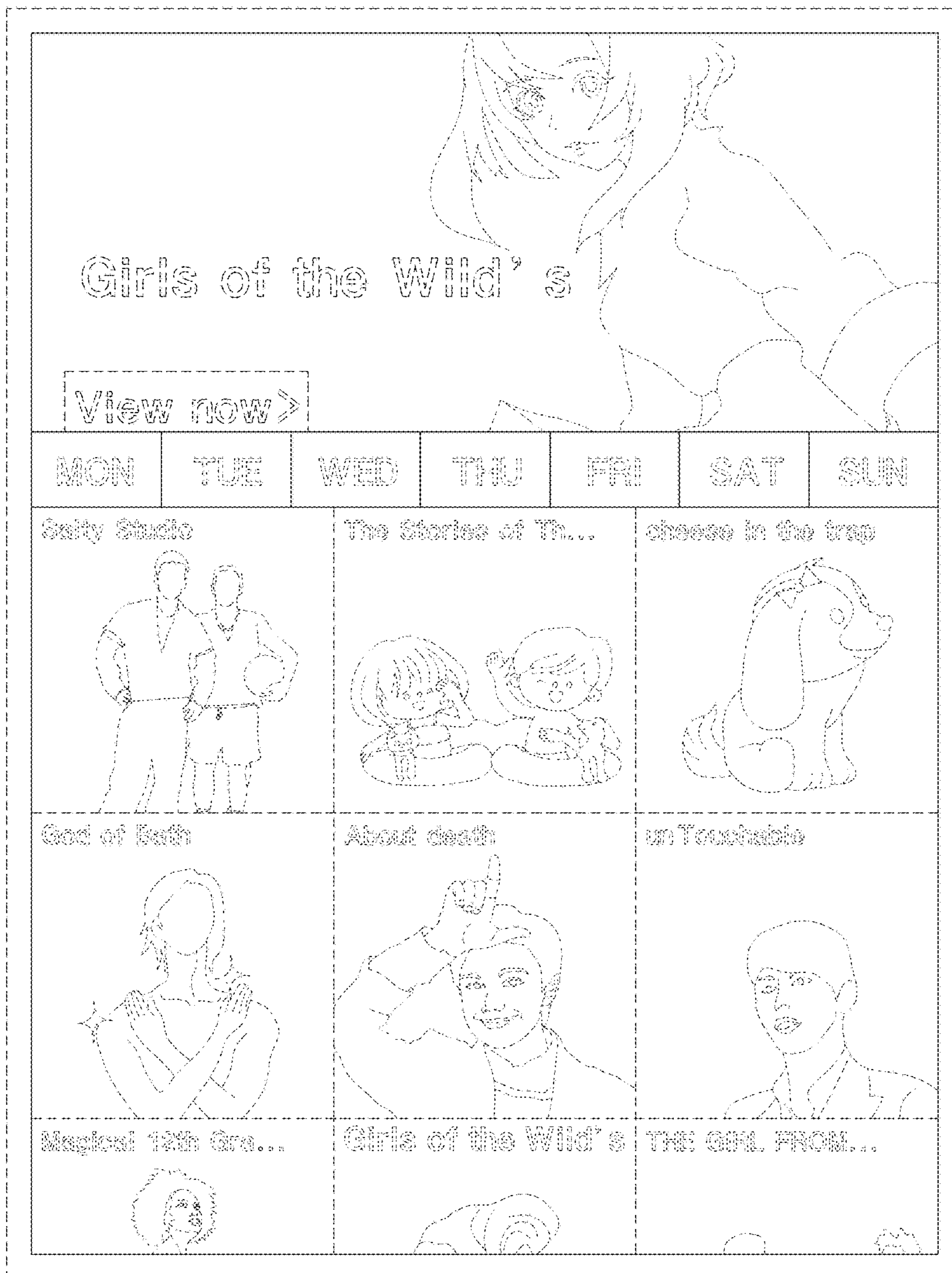

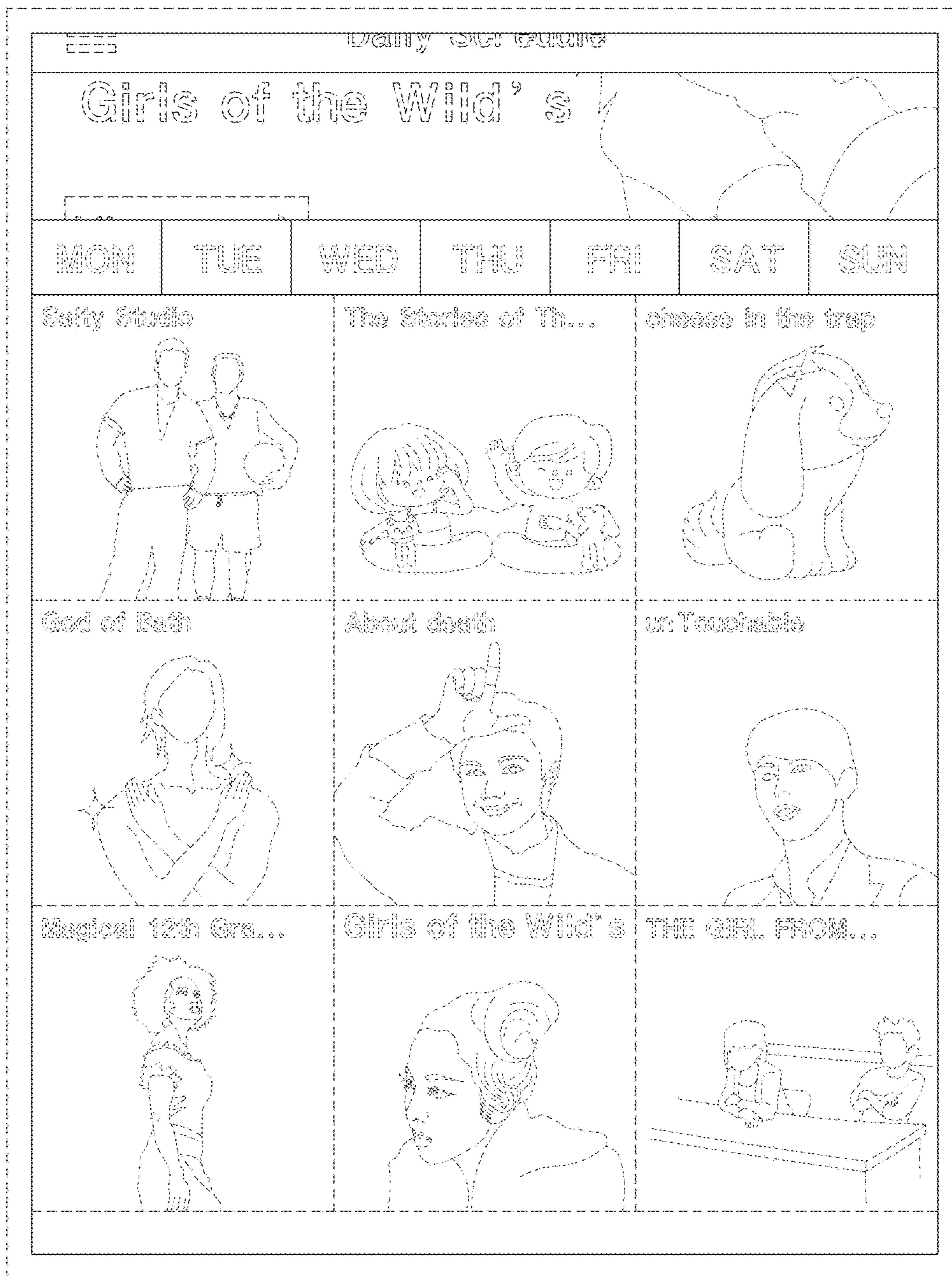
























