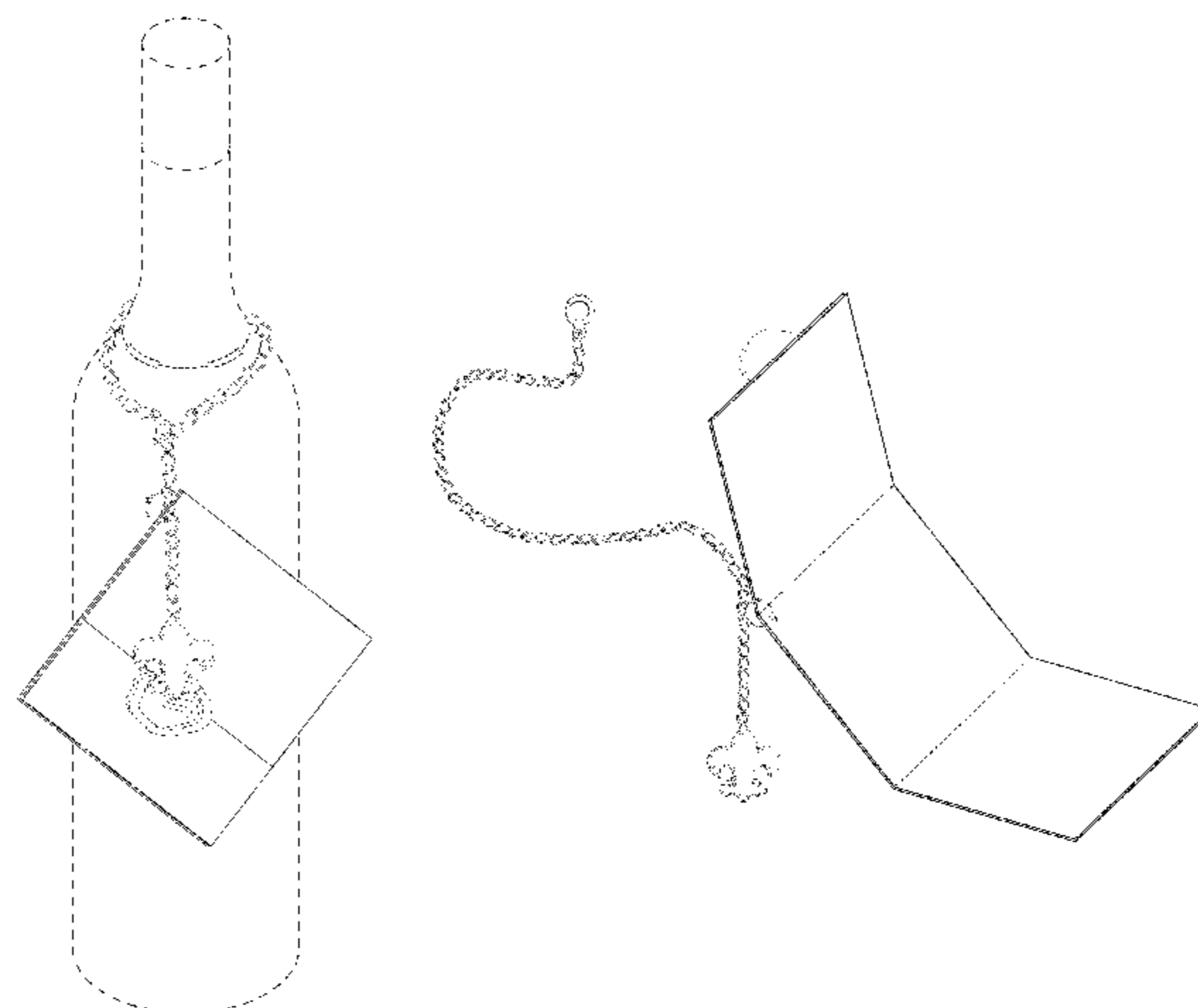
(57) **CLAIM**

The ornamental design for a card with a decorative chain, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a card with a decorative chain, showing my new design in use condition; FIG. 2 is a perspective view of the card with a decorative chain with the card in a closed position; FIG. 3 is a front elevation view of the decorative chain shown separately for ease of illustration; FIG. 4 is a perspective view of the card with a decorative chain with the card in an open position; FIG. 5 is a perspective view of the card with a decorative chain with the card in a closed position; FIG. 6 is a perspective view of the card with a decorative chain with the card in an open position; FIG. 7 is a perspective view of the card with a decorative chain with card in use condition; and, FIG. 8 is a perspective view of the card with a decorative chain with card in use condition. In FIG. 3, the broken away portions show the chain has no specific length. The charm feature shown in broken lines in FIGS. 1-8 illustrates a feature of the decorative chain with card and forms no part of the claimed design. The wine bottle in FIG. 1, the basket in FIG. 7, and the vase in FIG. 8, all shown in broken lines, illustrate the claimed design while in use, and form no part of the claim.

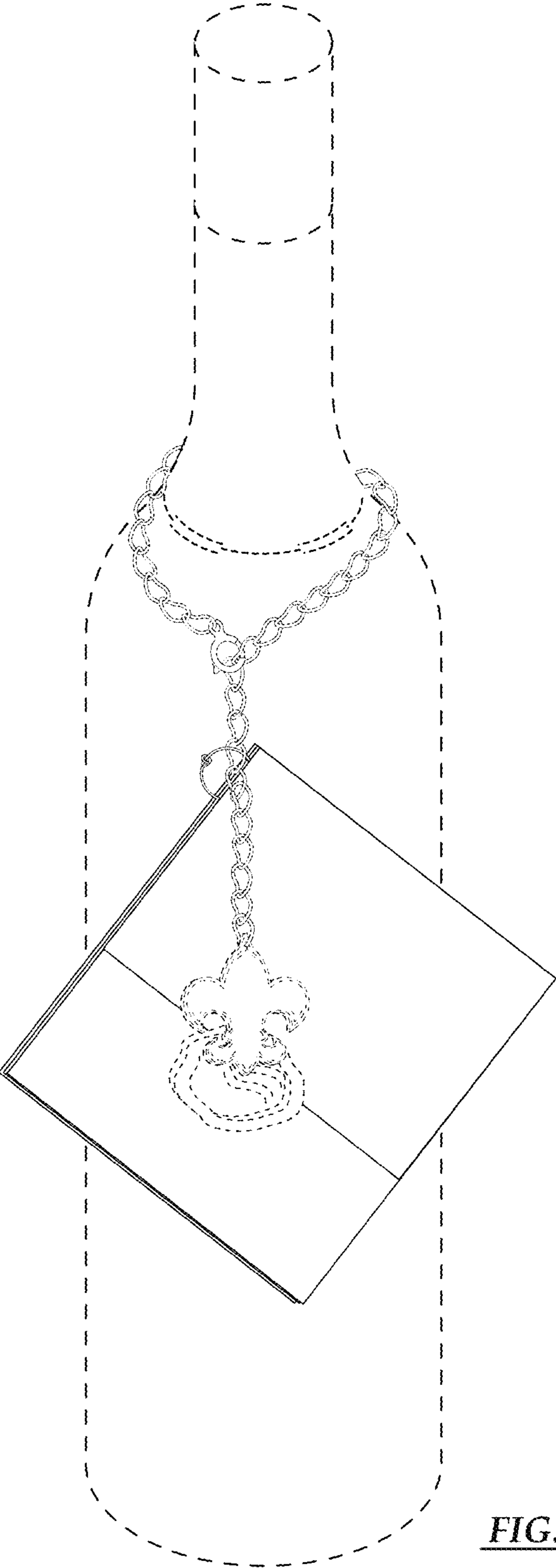

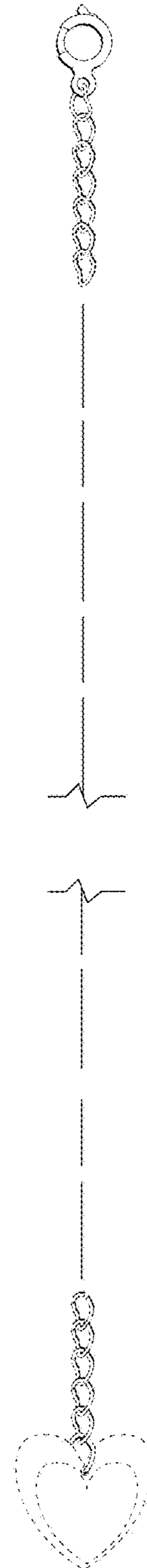

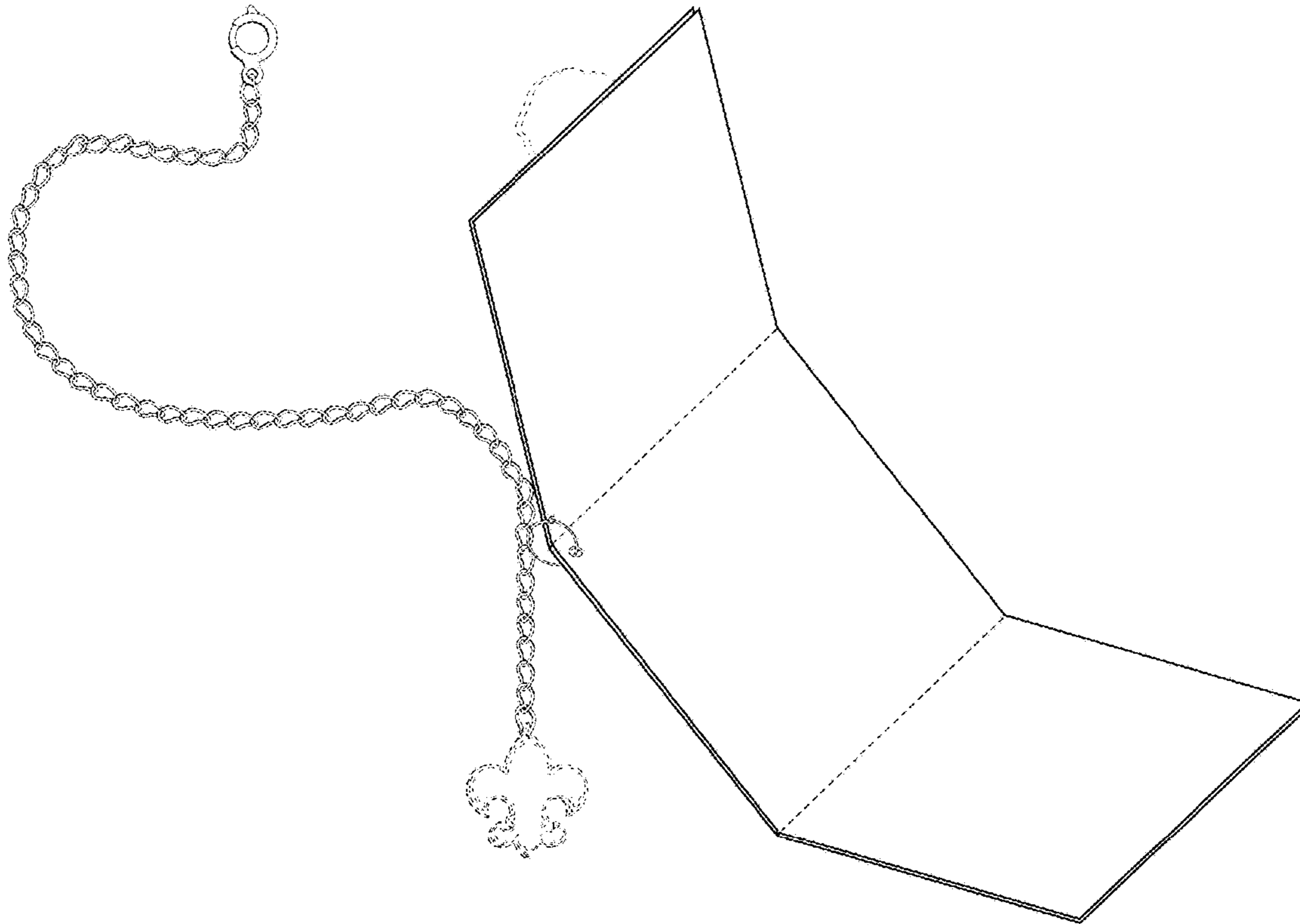

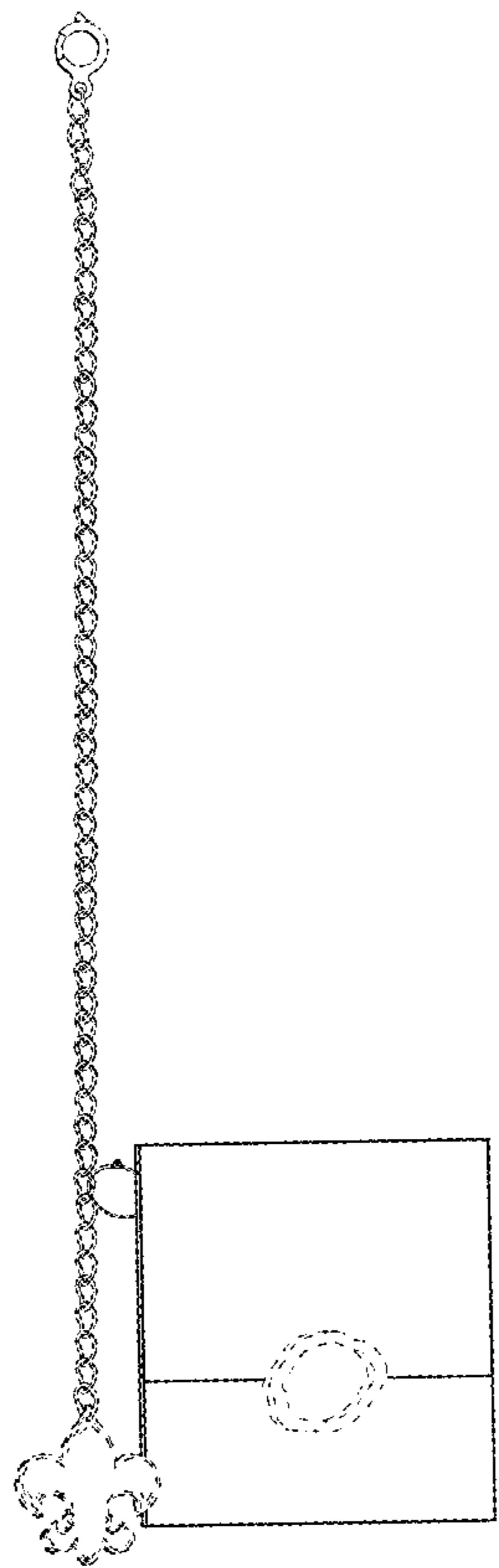

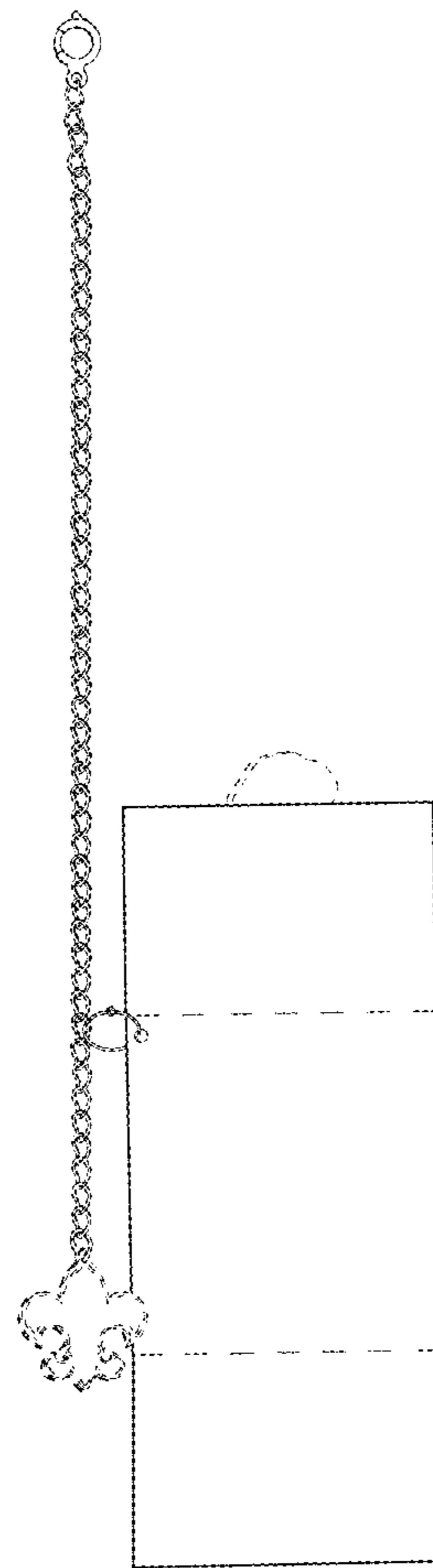

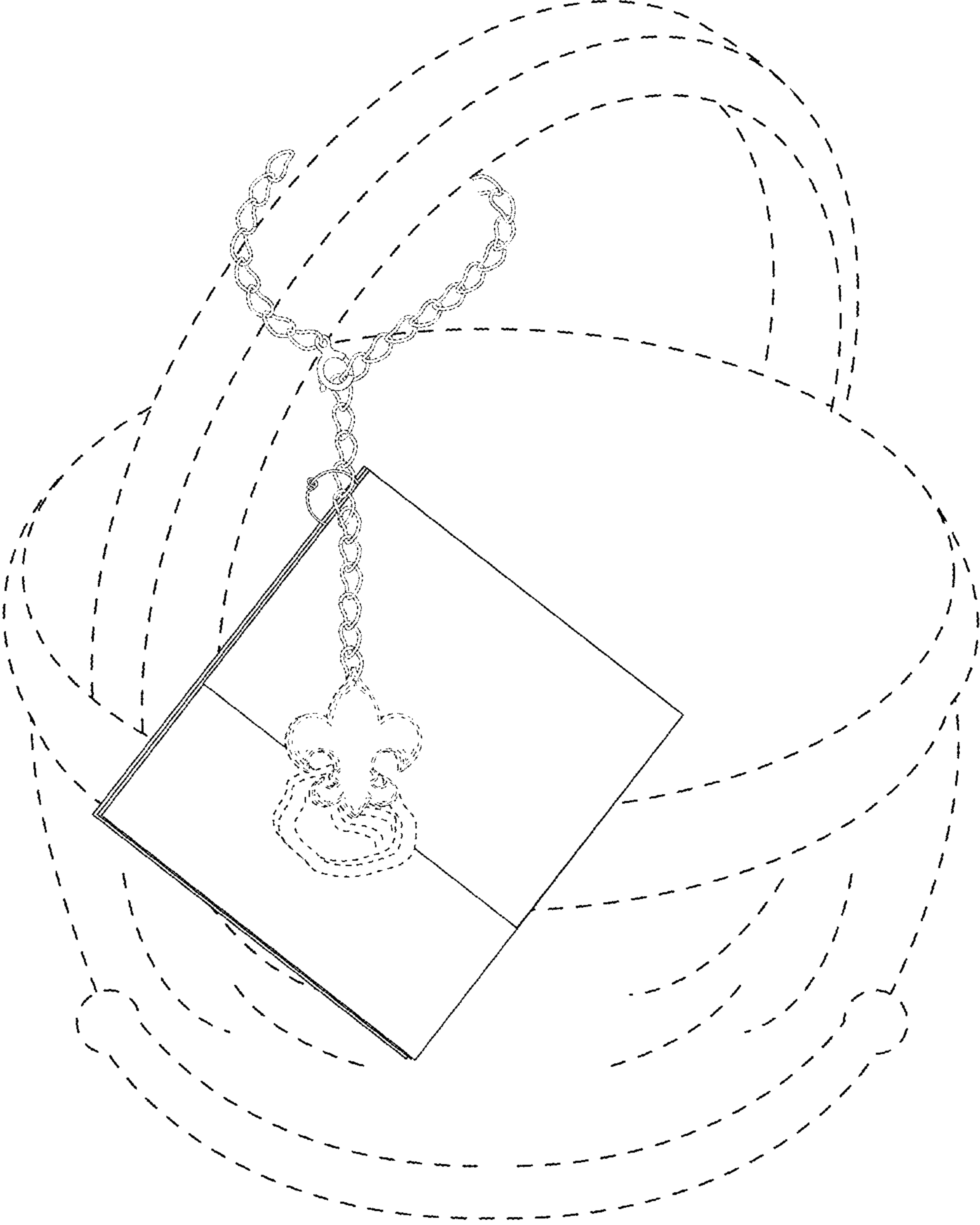

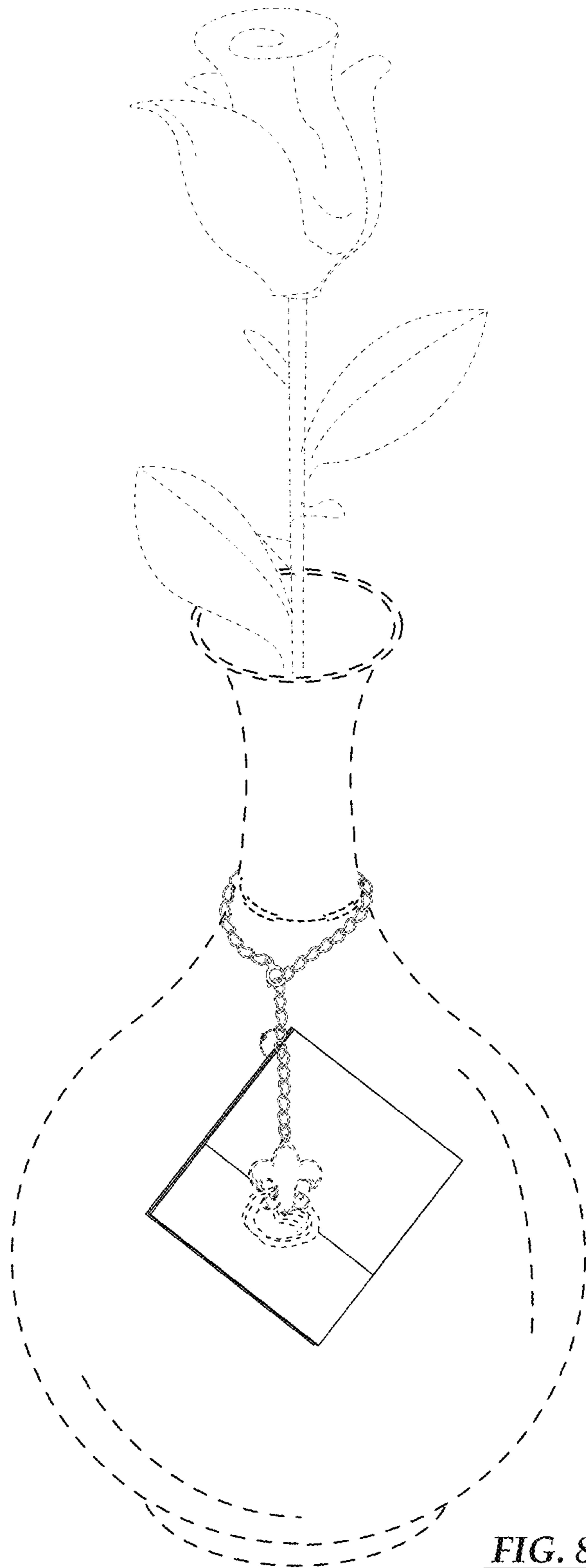
