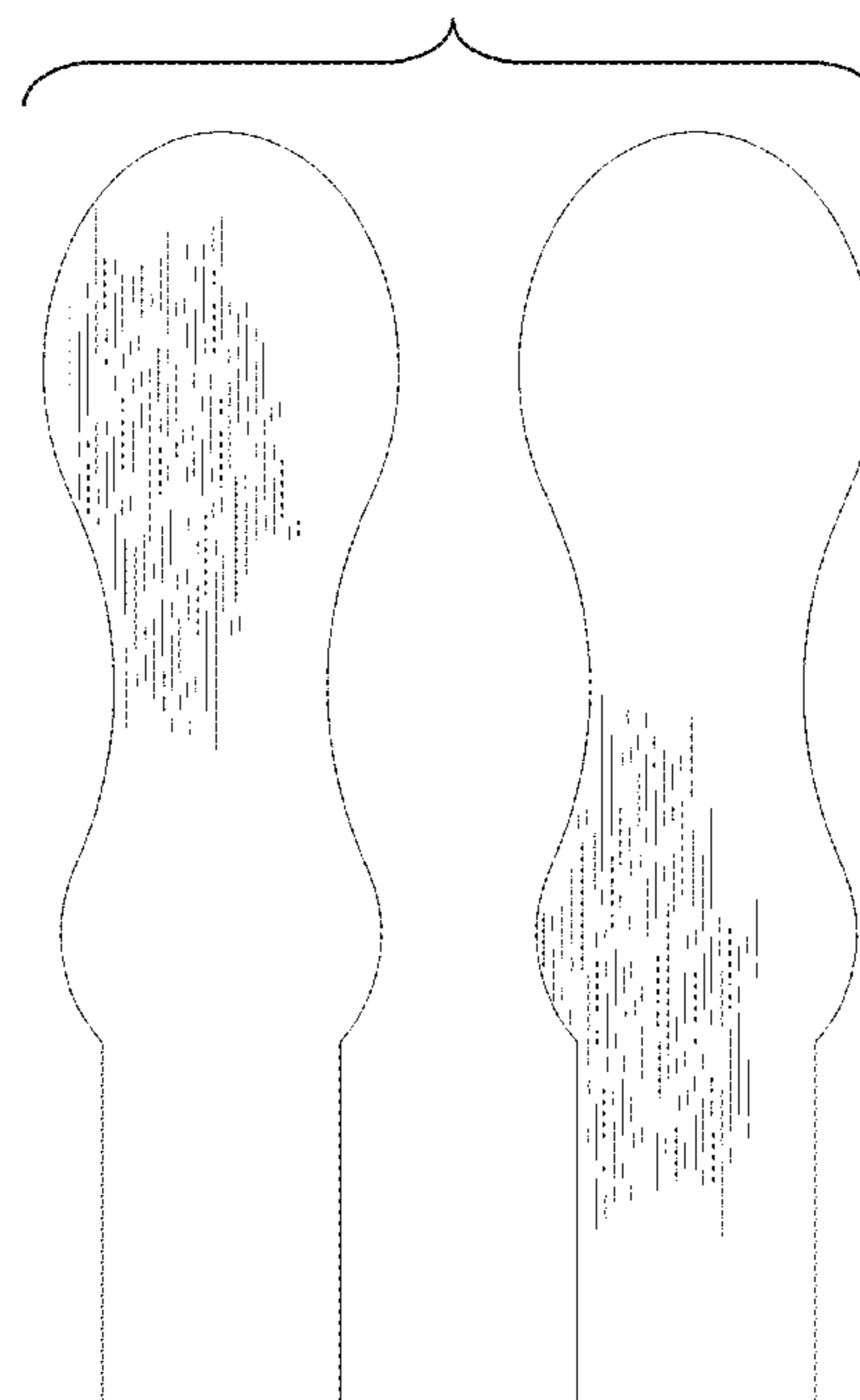
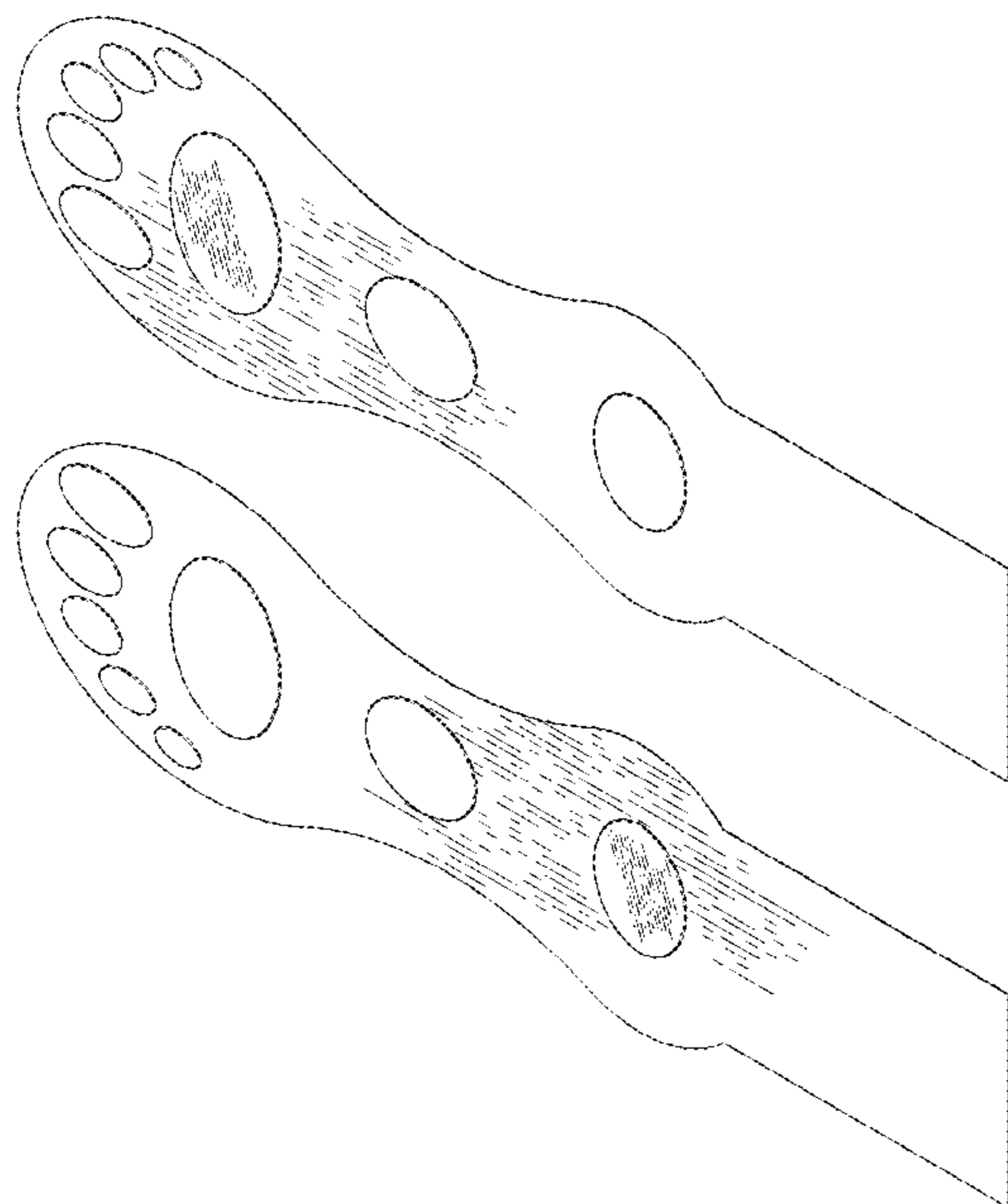
(57) **CLAIM**

The ornamental design for a pair of disposable sanitary foot pads, as shown and described.

**DESCRIPTION**

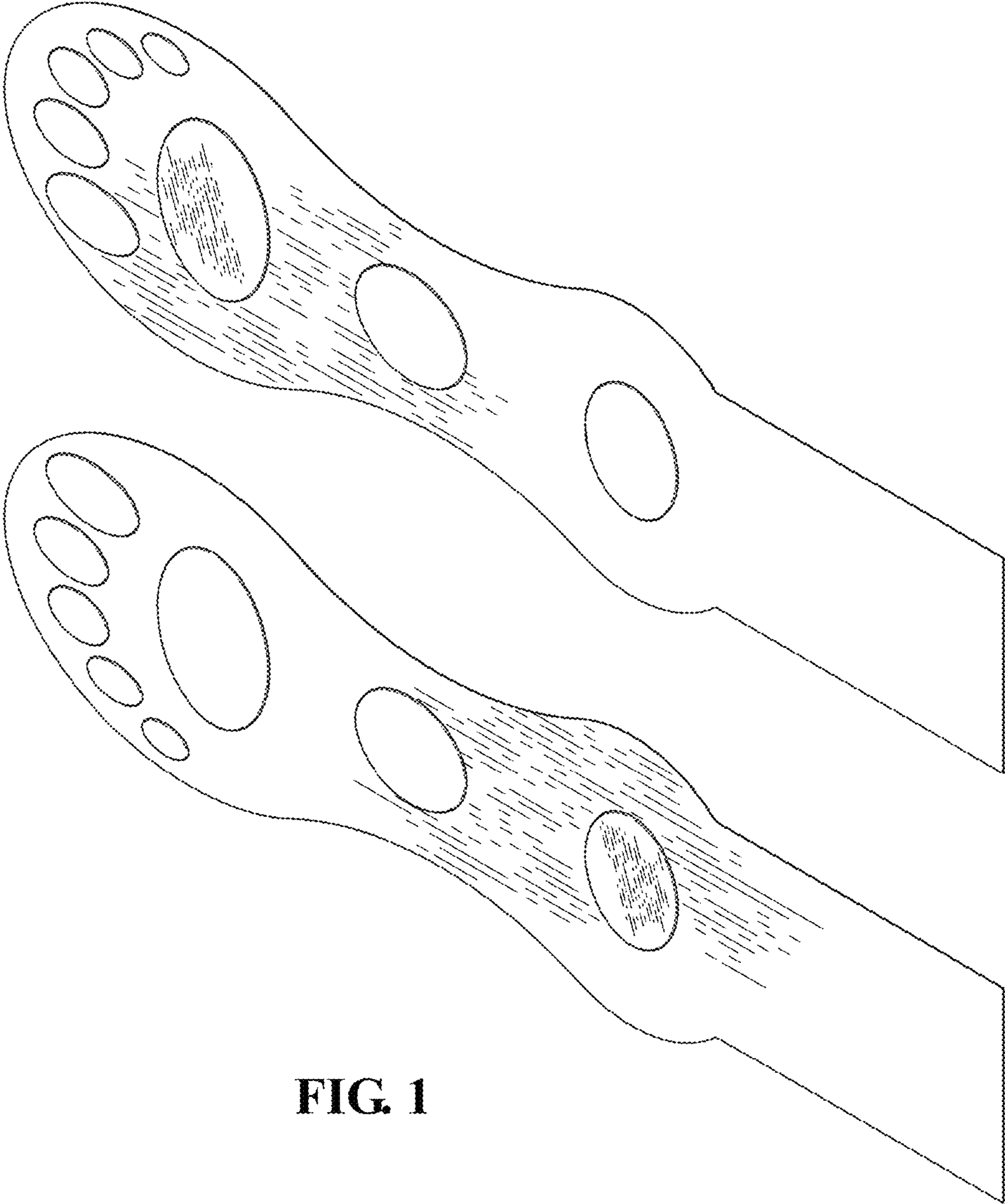
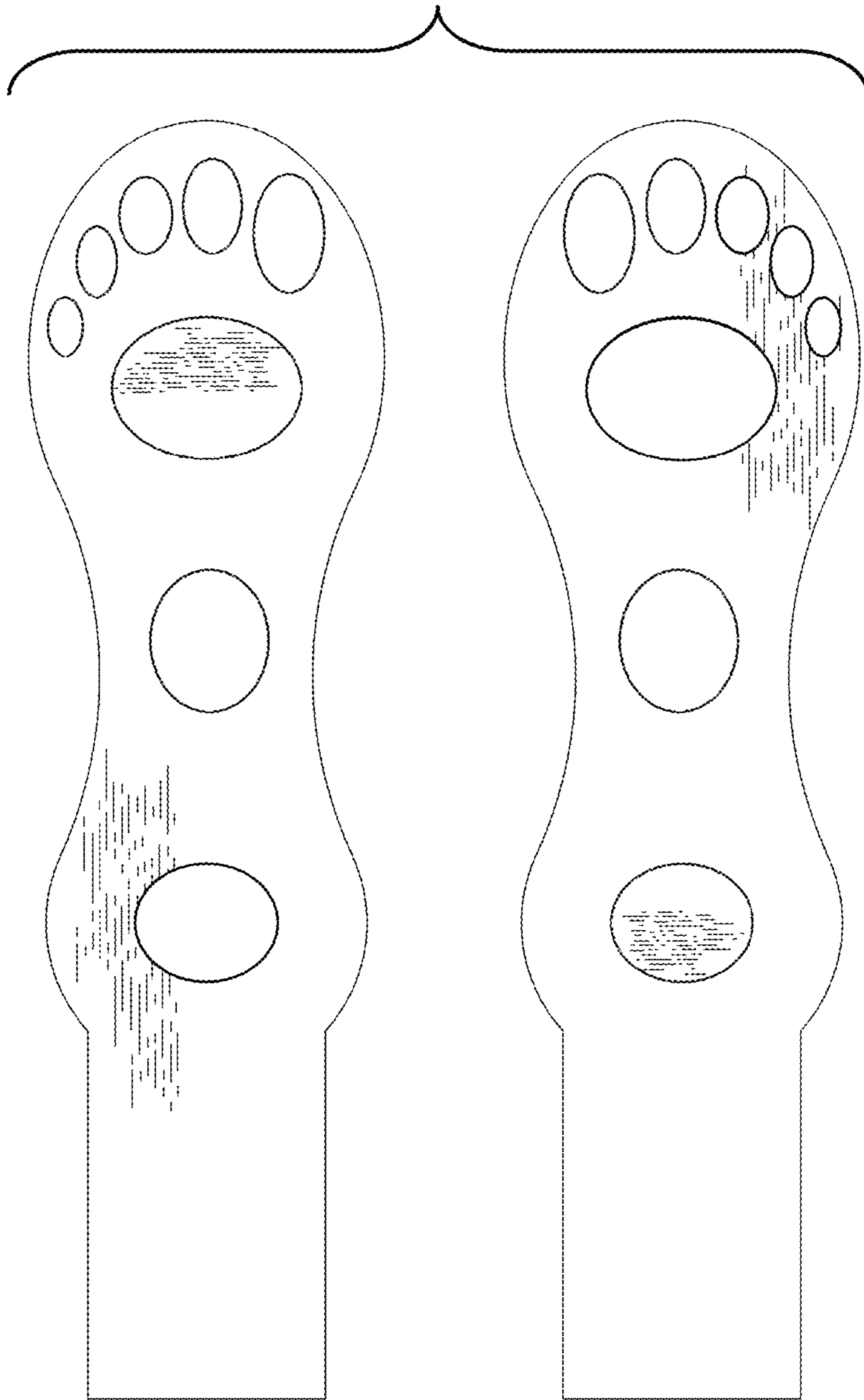
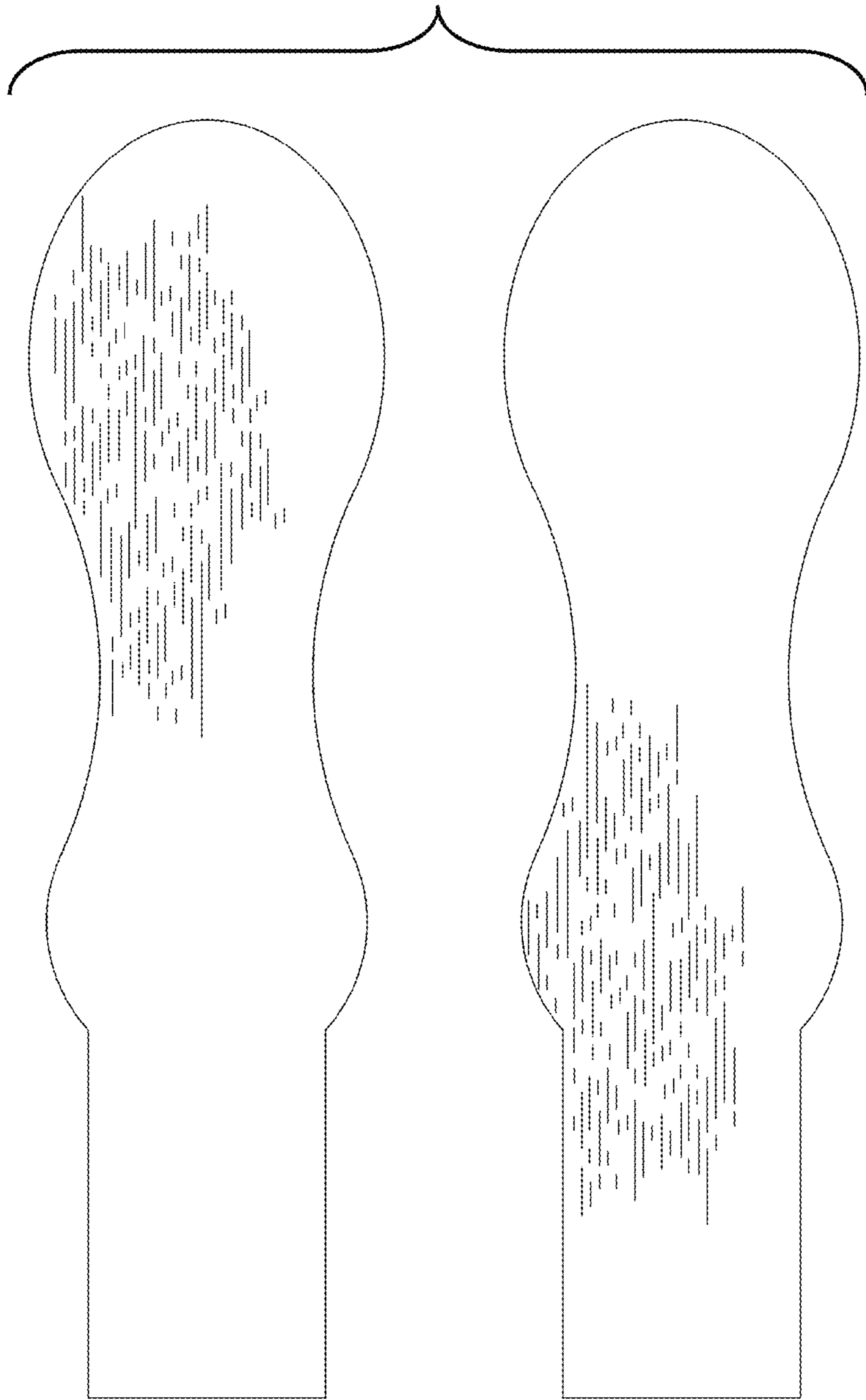

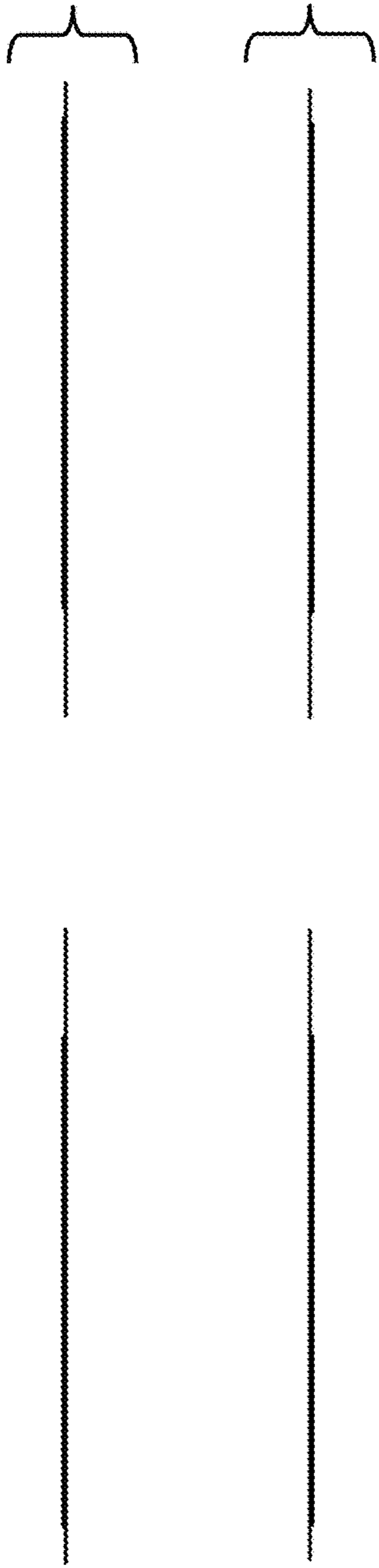

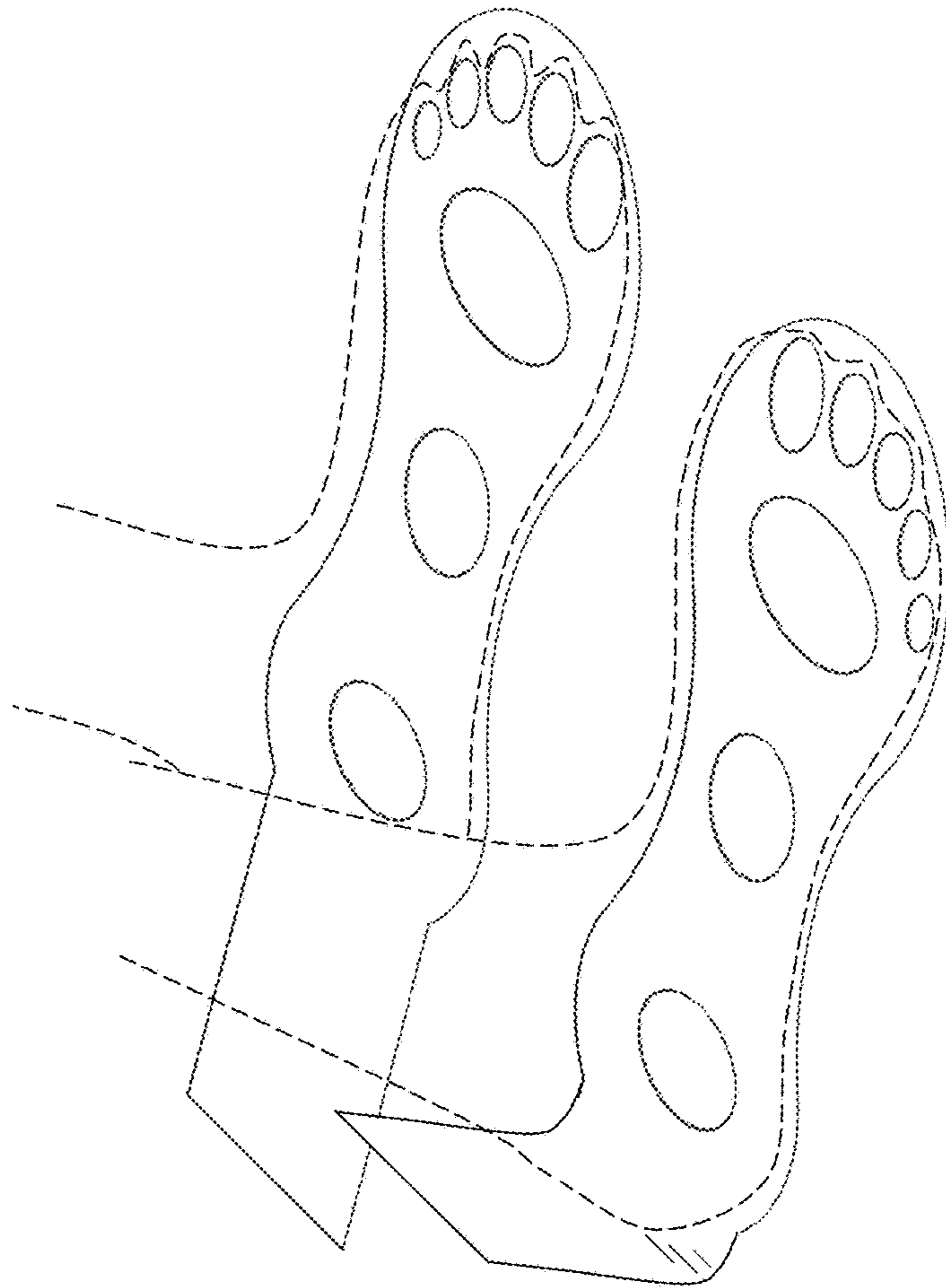
