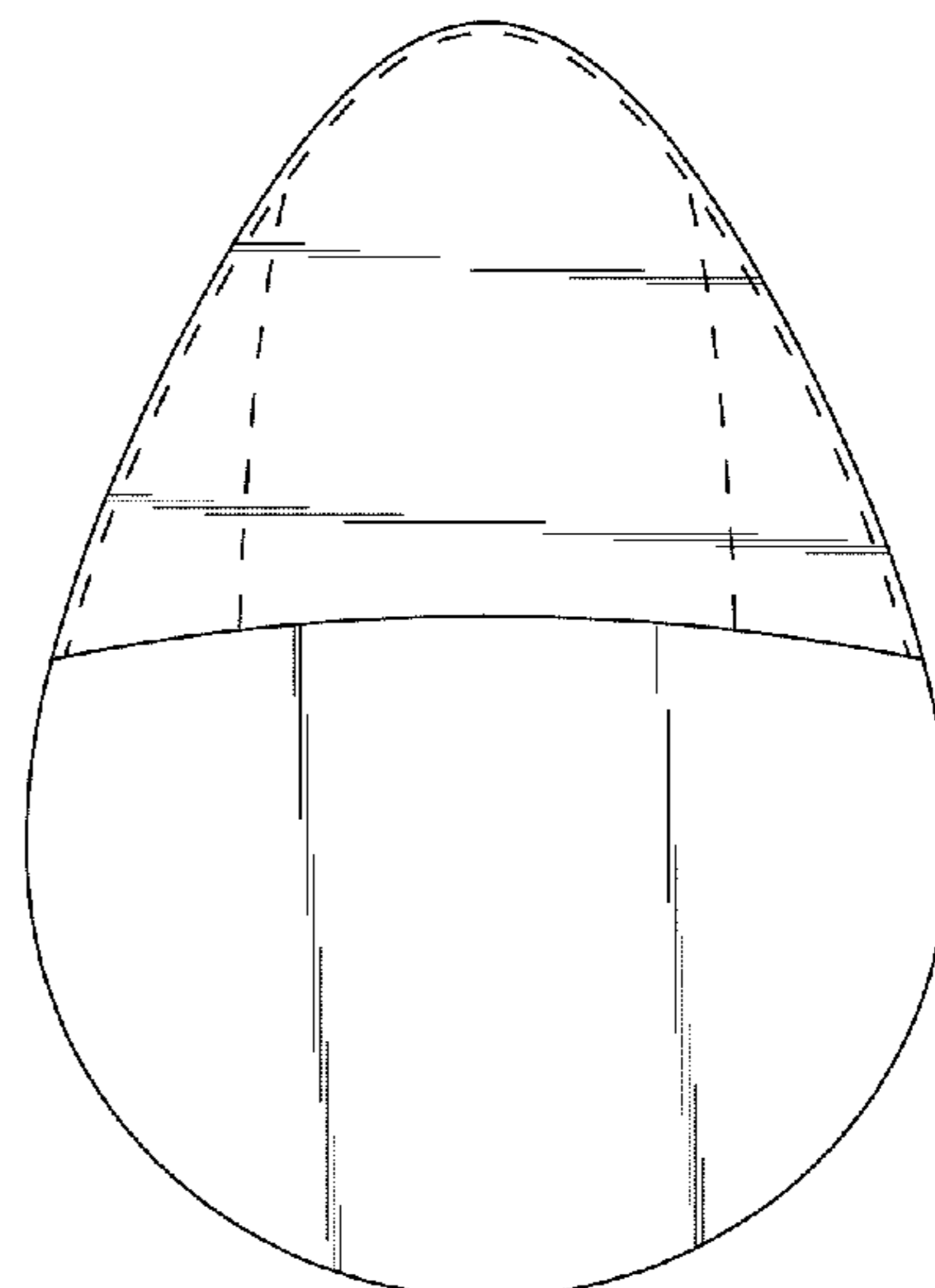
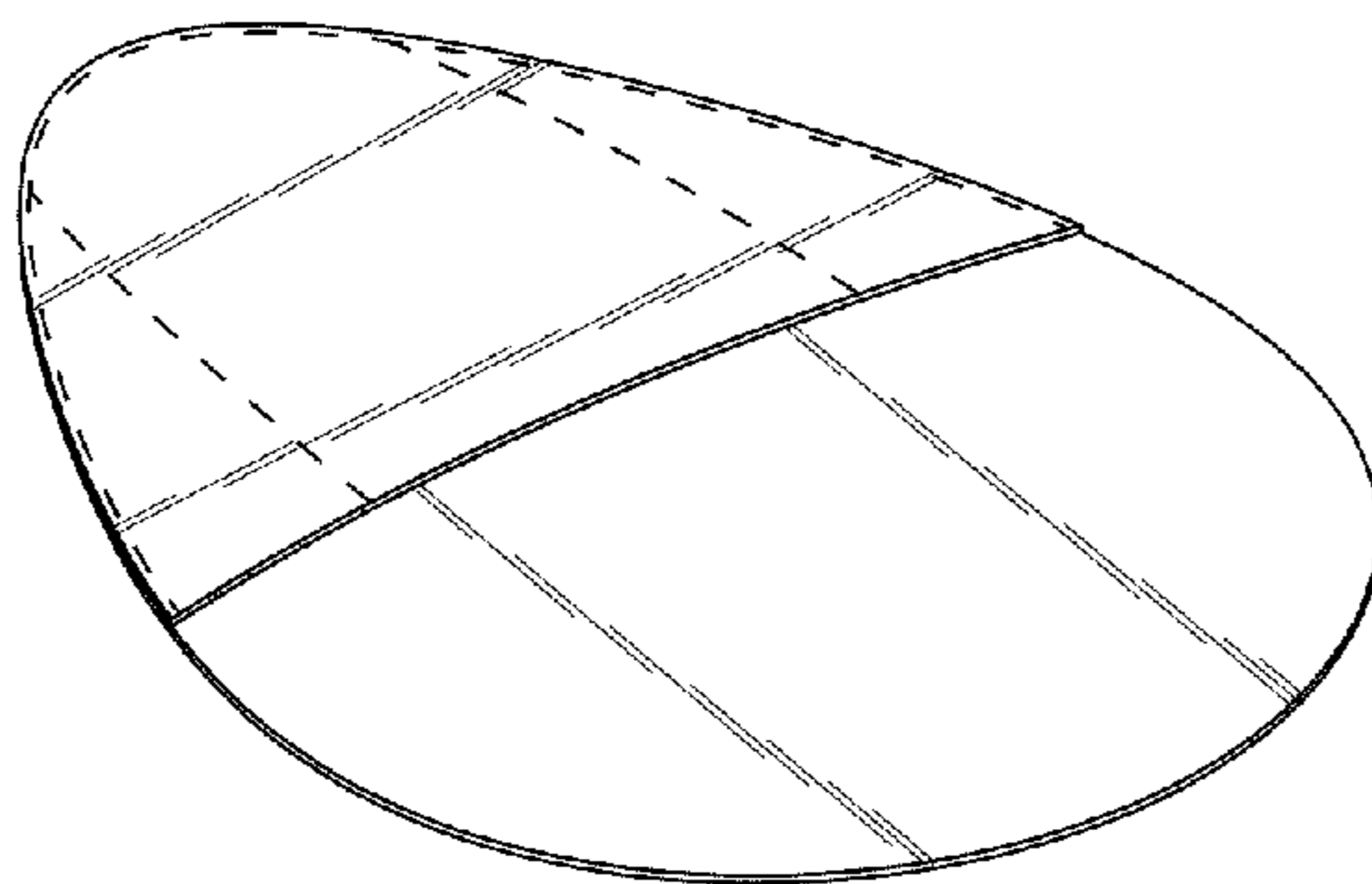
(57) **CLAIM**

The ornamental design for a cleaning cloth, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the new design for a cleaning cloth;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof, a left side view being a mirror image thereof;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.
The portions of the cleaning cloth in FIGS. 1, 2, and 3 shown in broken lines are included to show features that form no part of the claimed design.

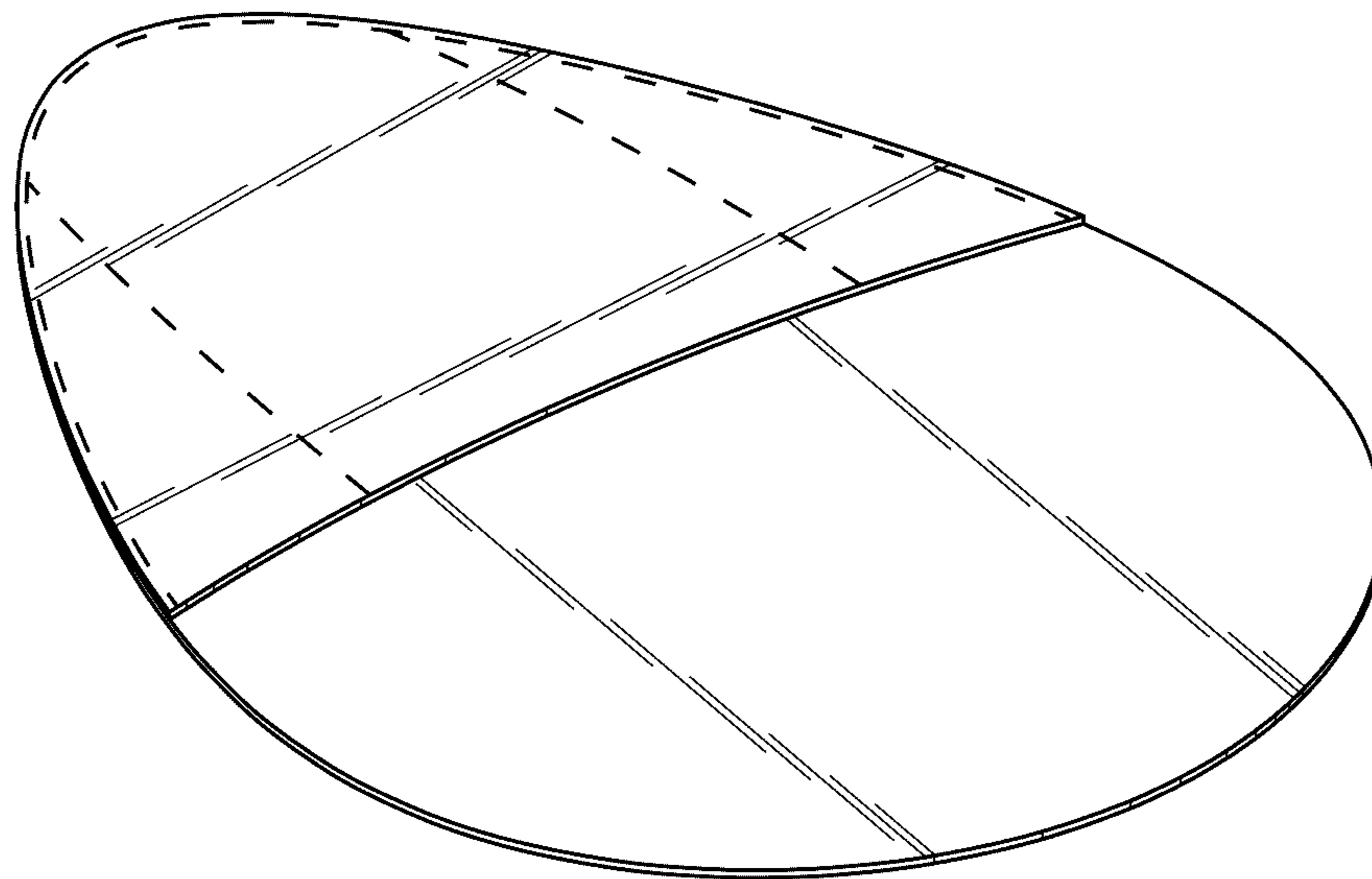

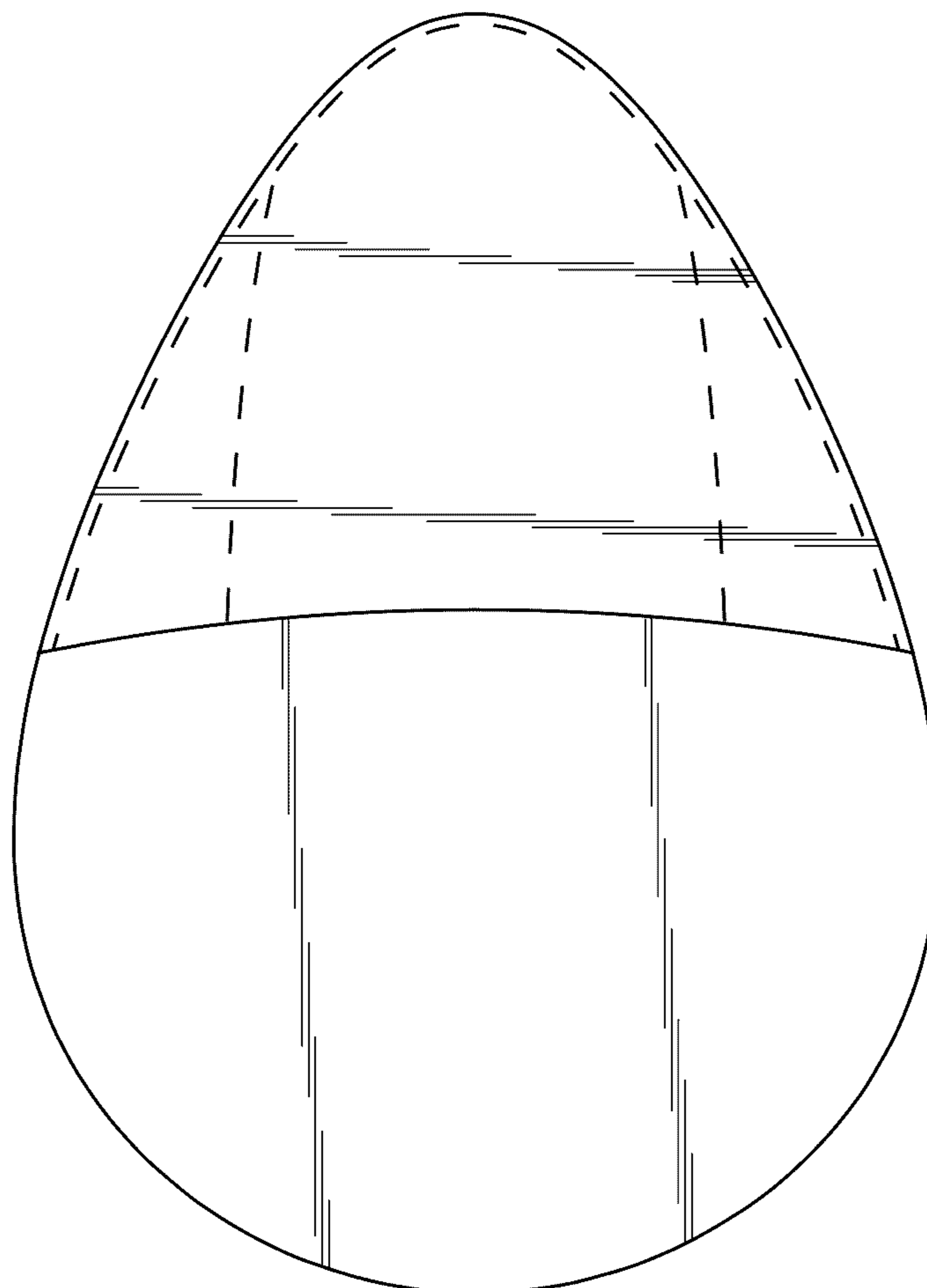

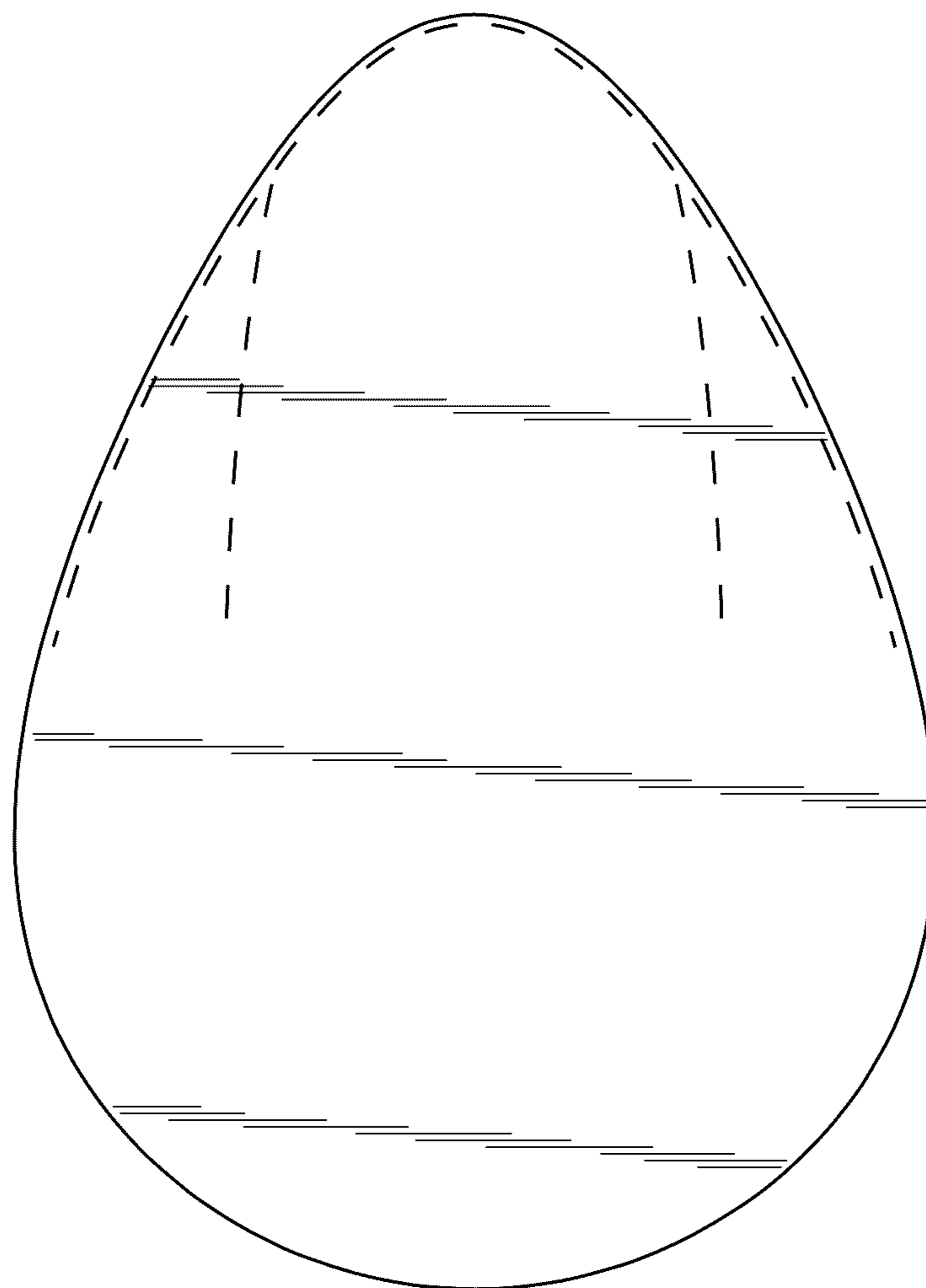
