**DESCRIPTION**

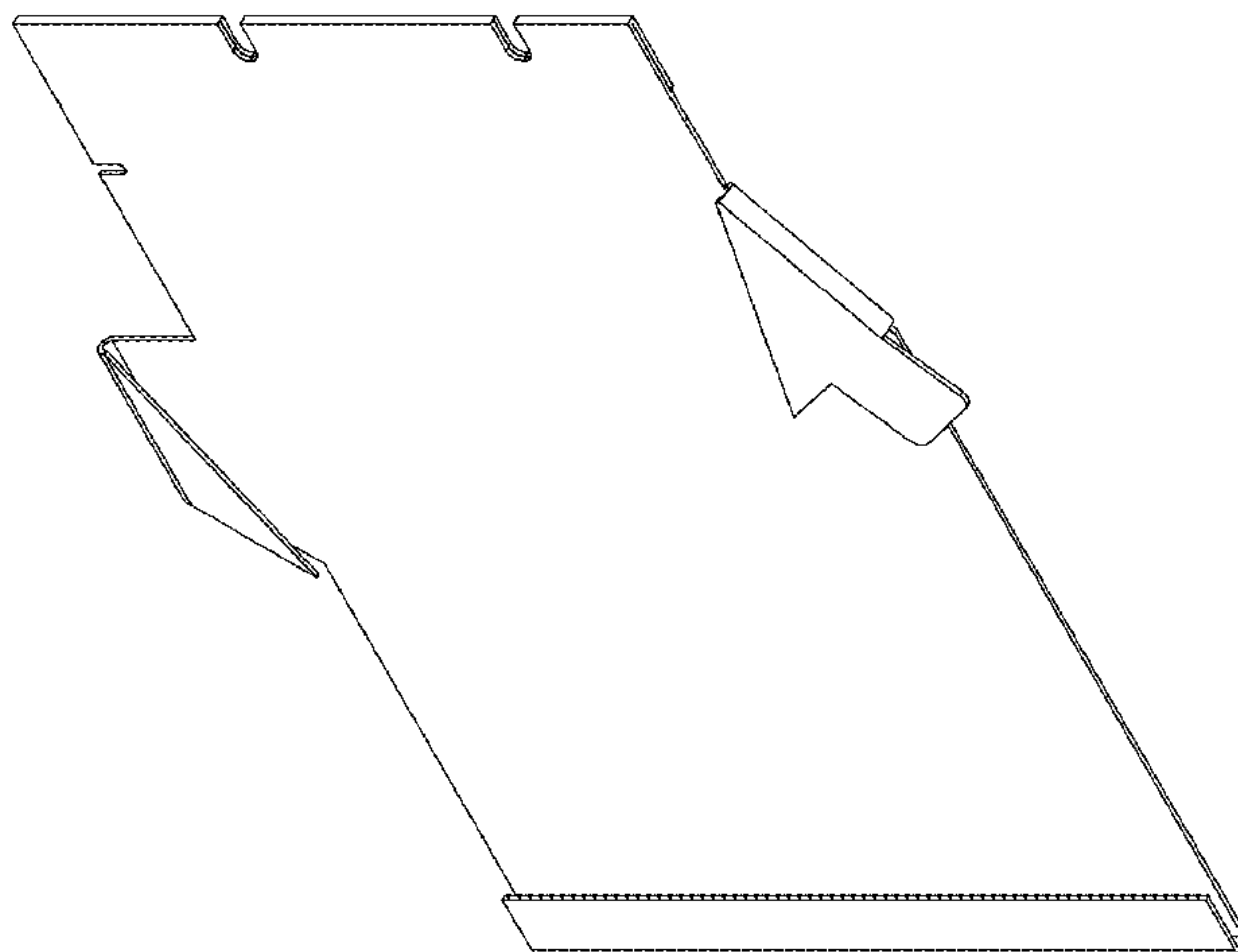
FIG. 1 is a perspective view of a first embodiment of a glove support with a glove.

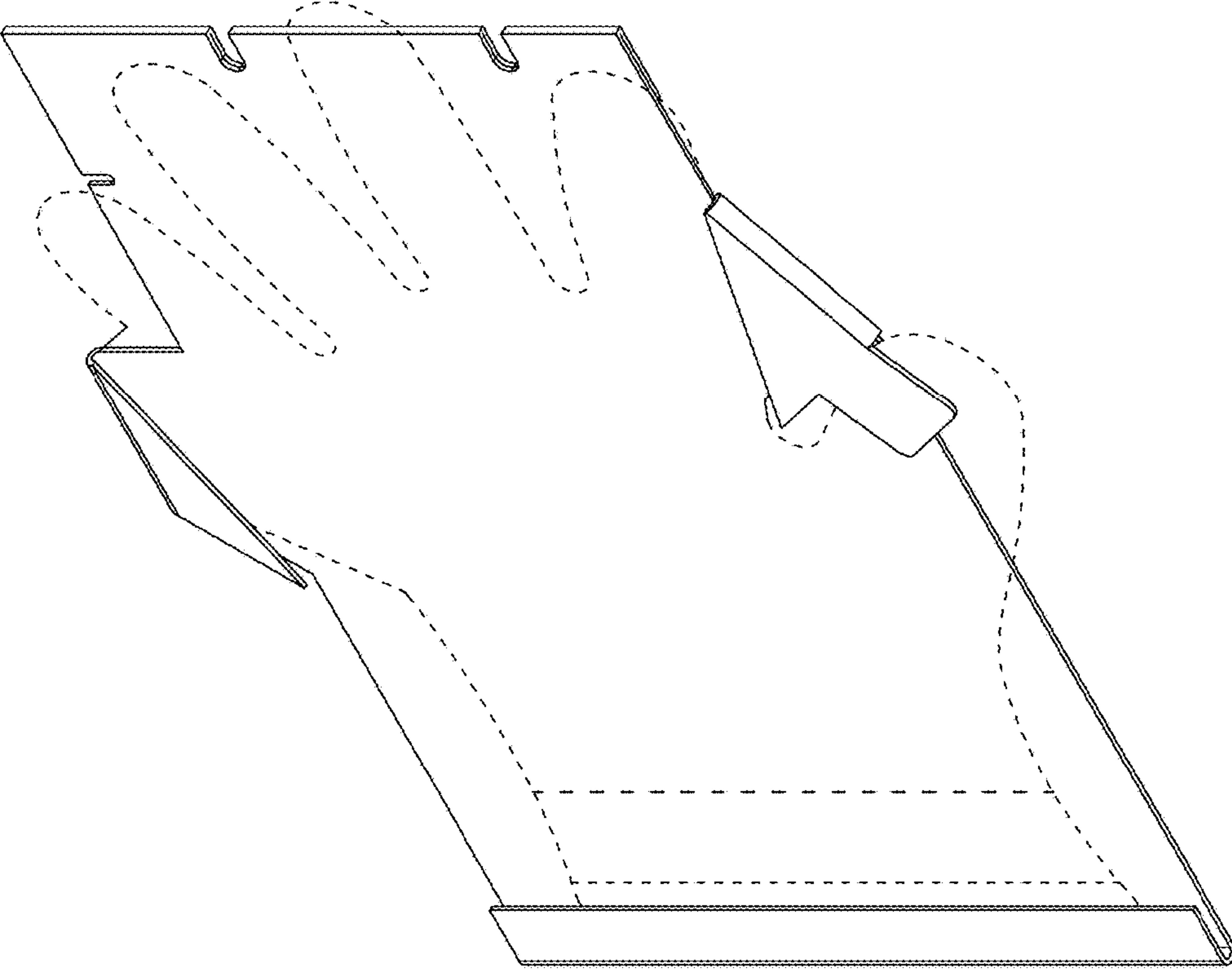

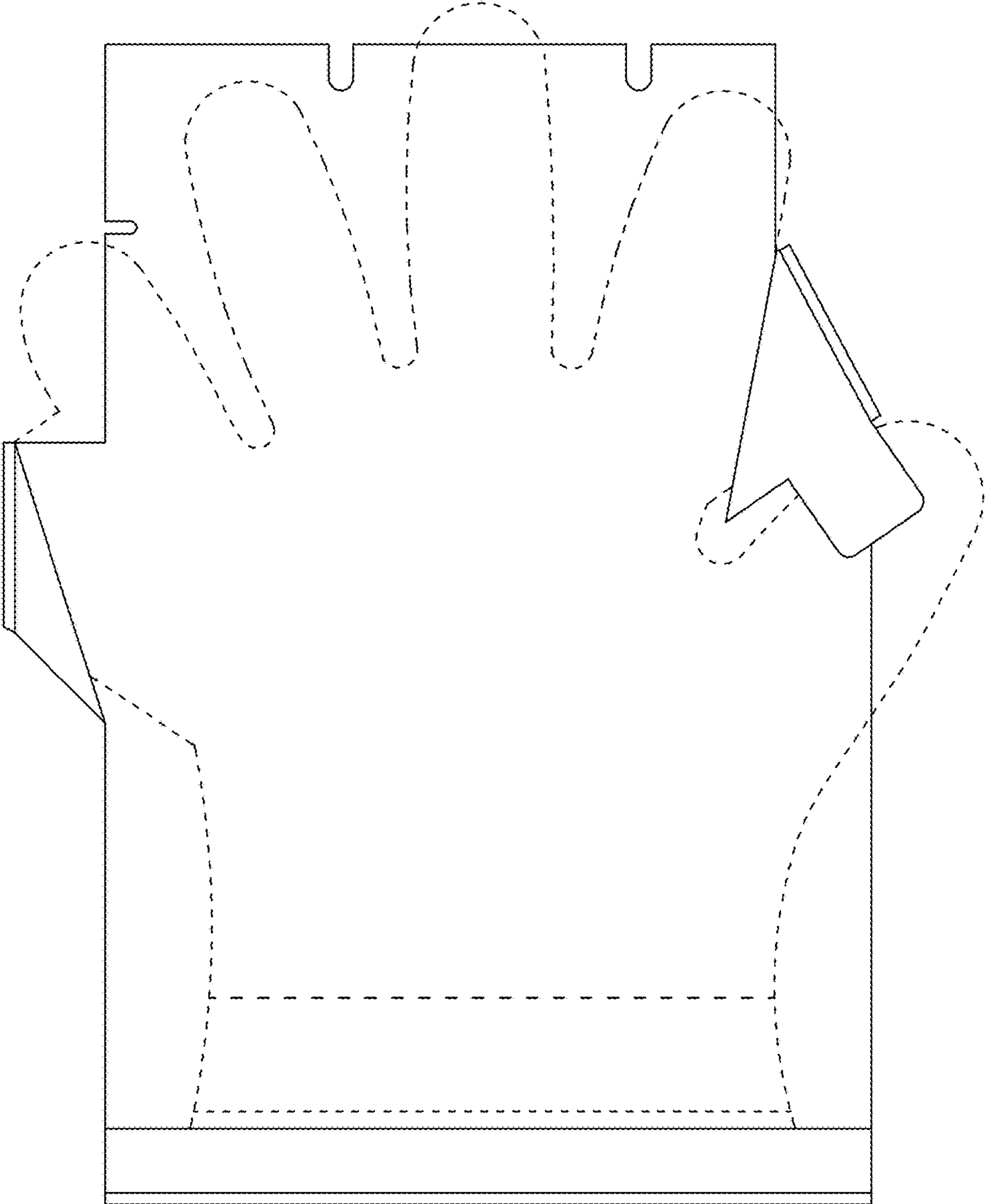

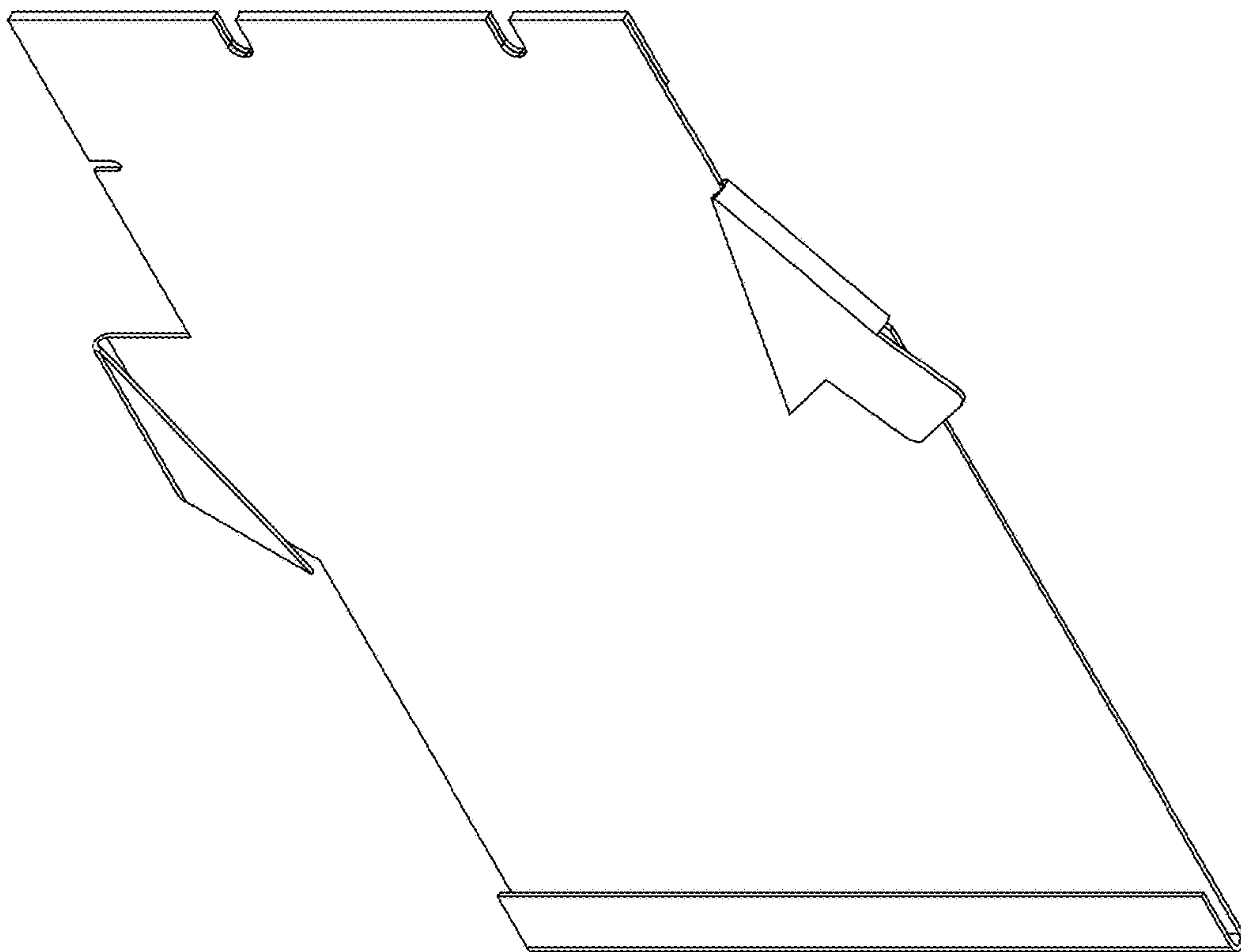

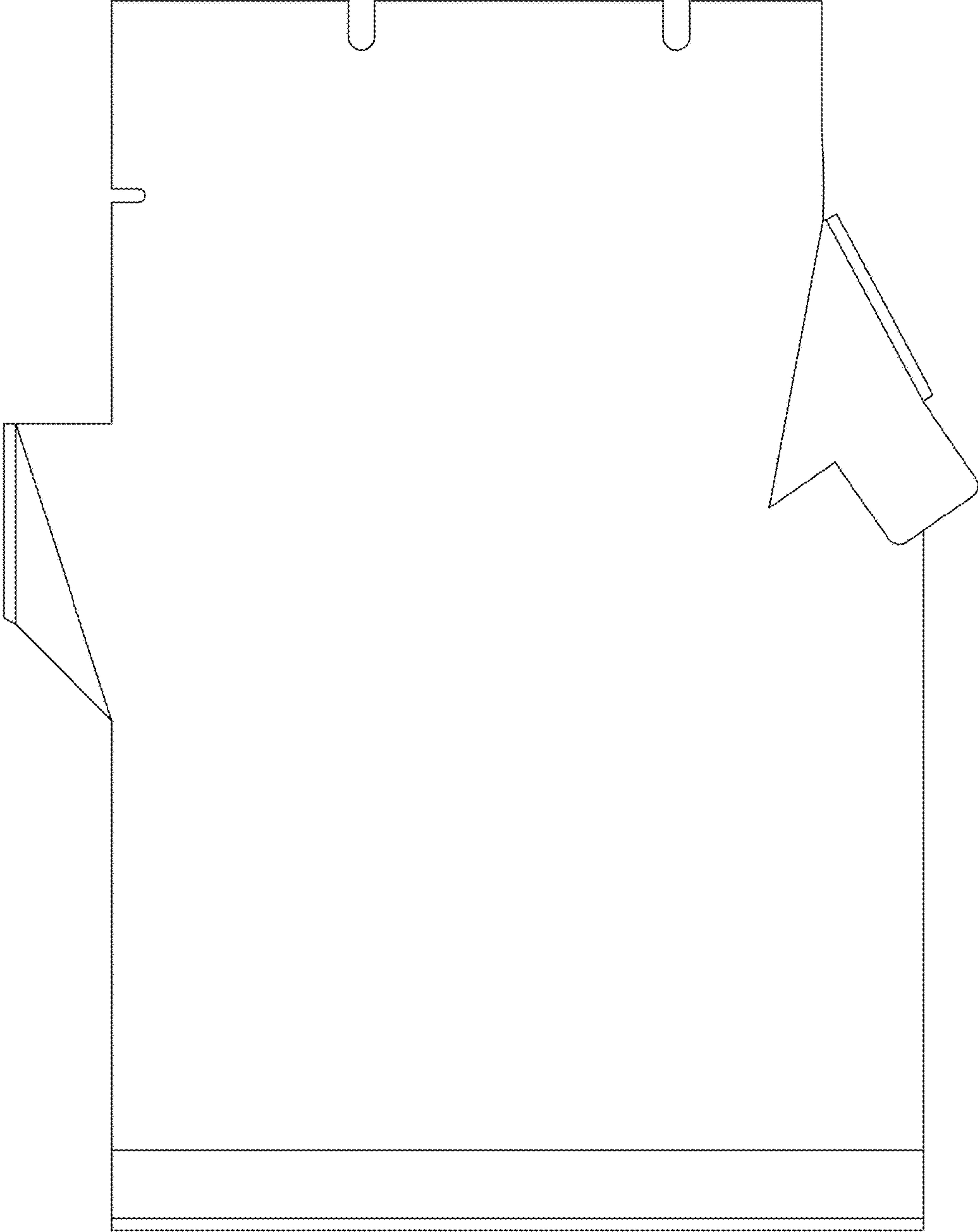

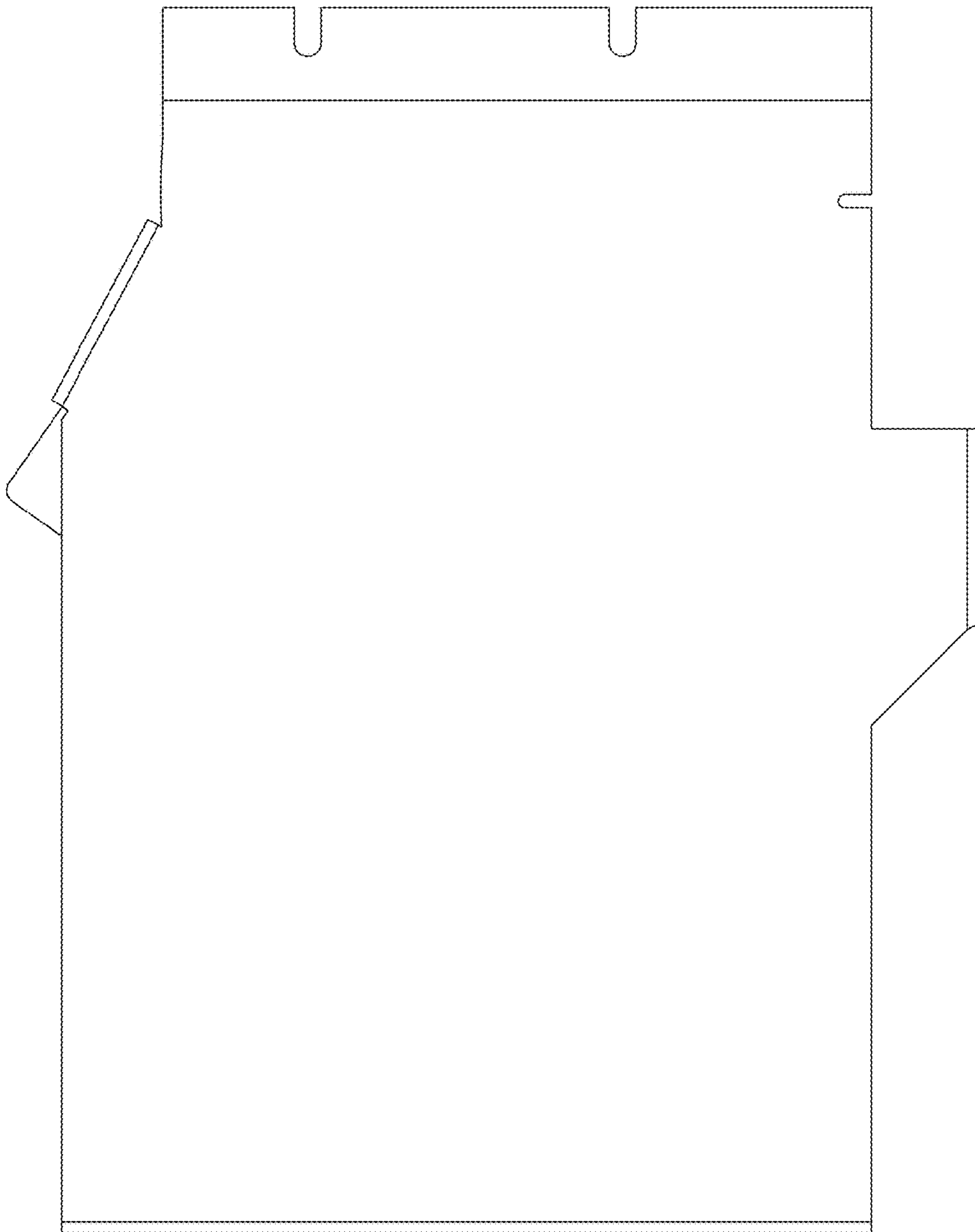

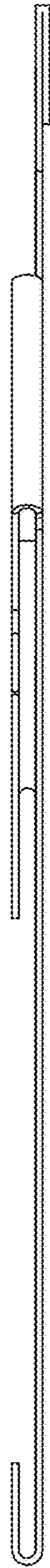

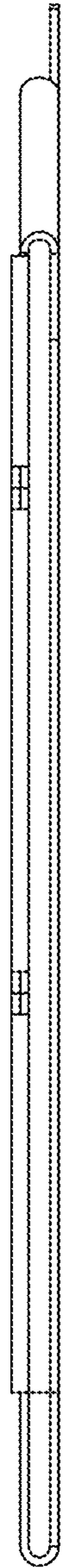

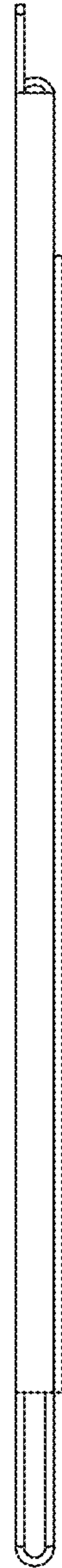
