The ornamental design for a hooded top, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hooded top illustrated as worn by a woman according to the present invention;

FIG. 2 is a front view of a hooded top according to the present invention;

FIG. 3 is a rear view of a hooded top according to the present invention;

FIG. 4 is a profile view of a hooded top according to the present invention;

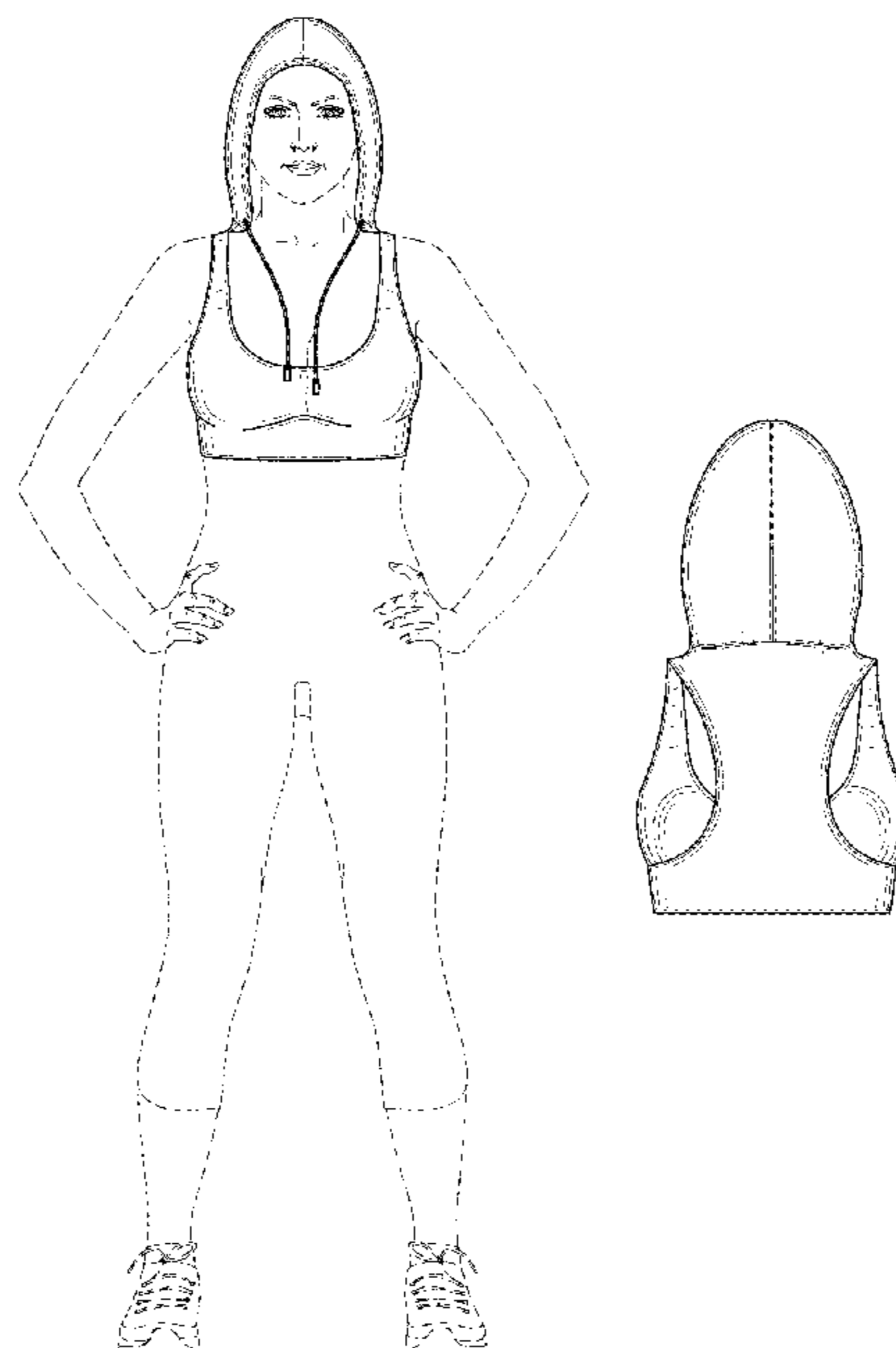
FIG. 5 is a second profile view of a hooded top according to the present invention;

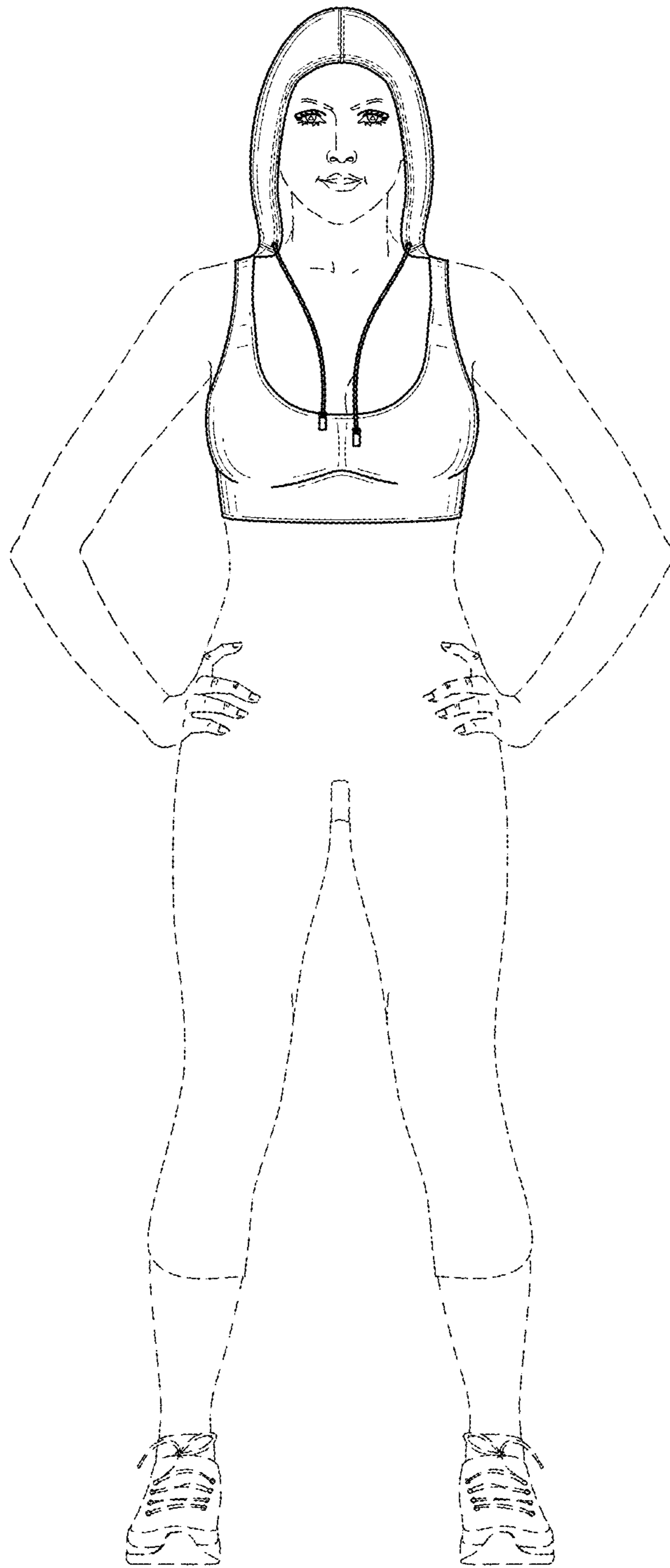

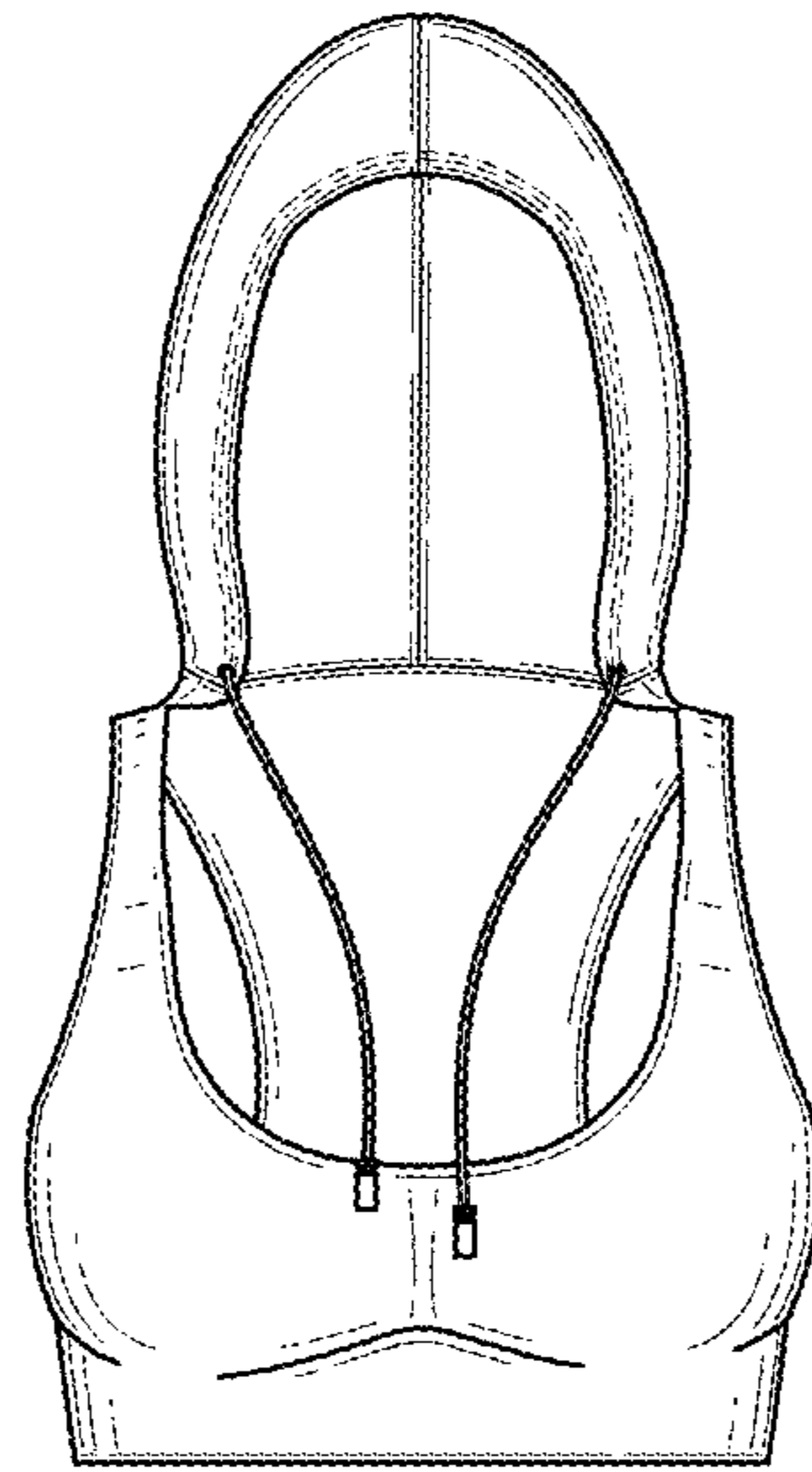

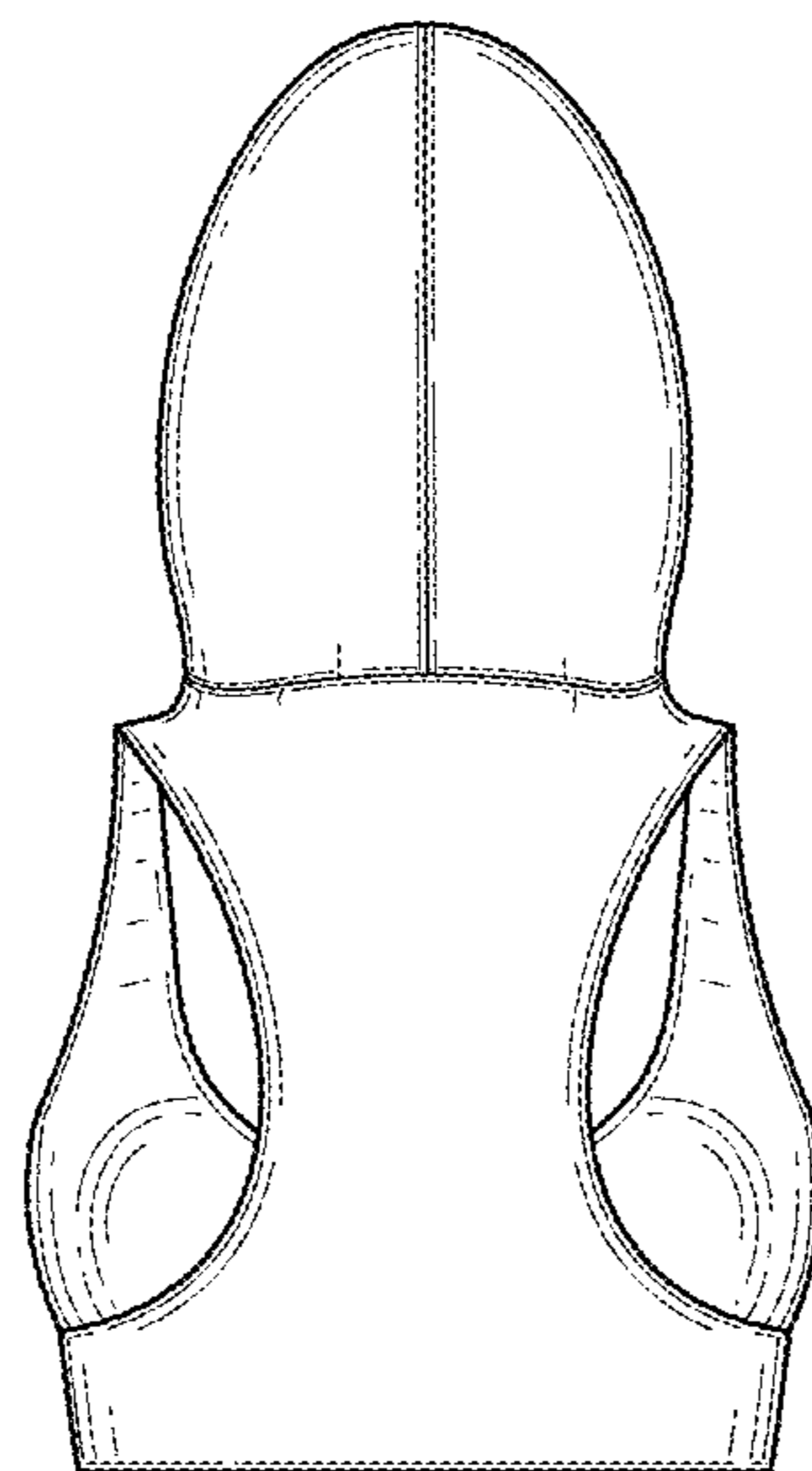

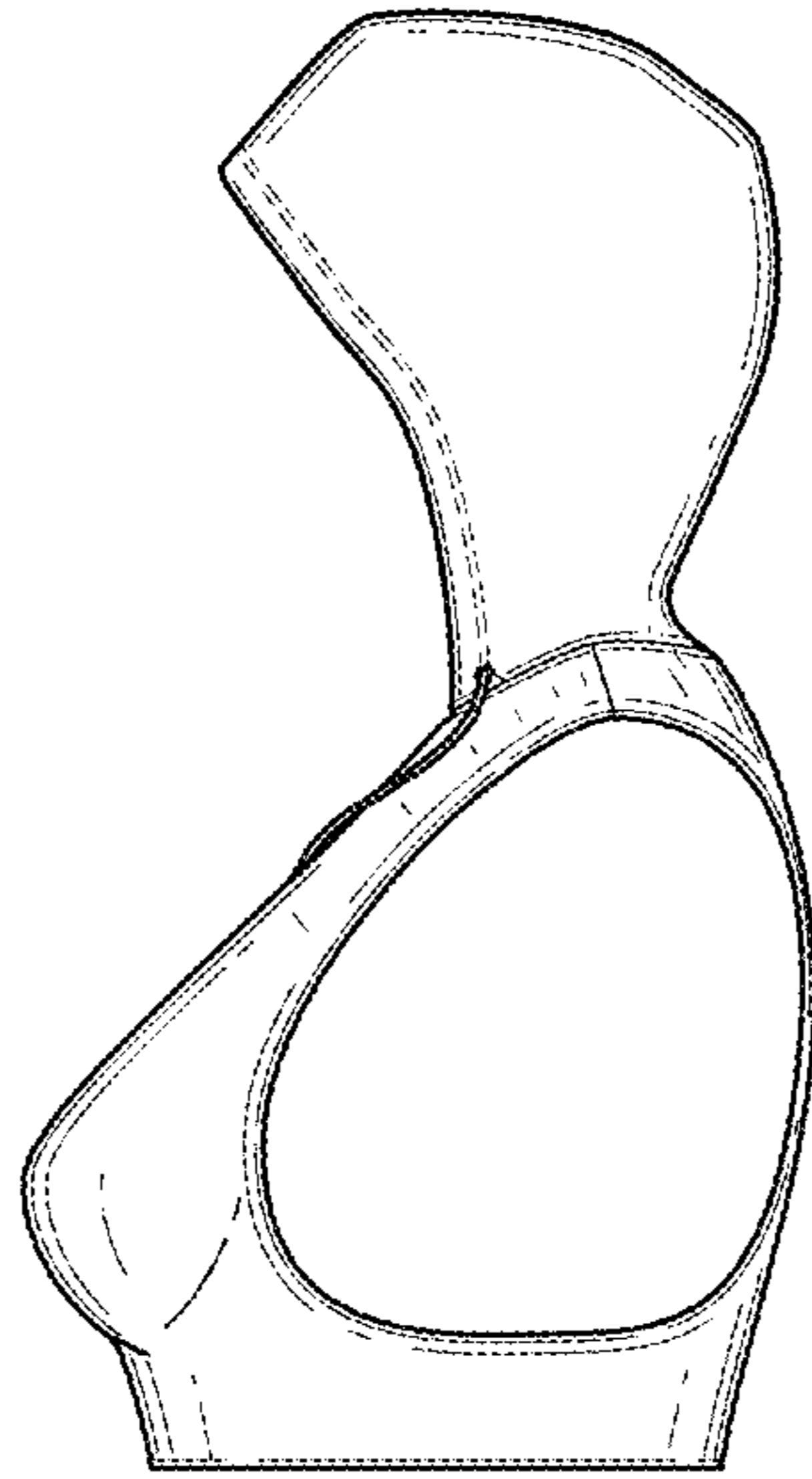

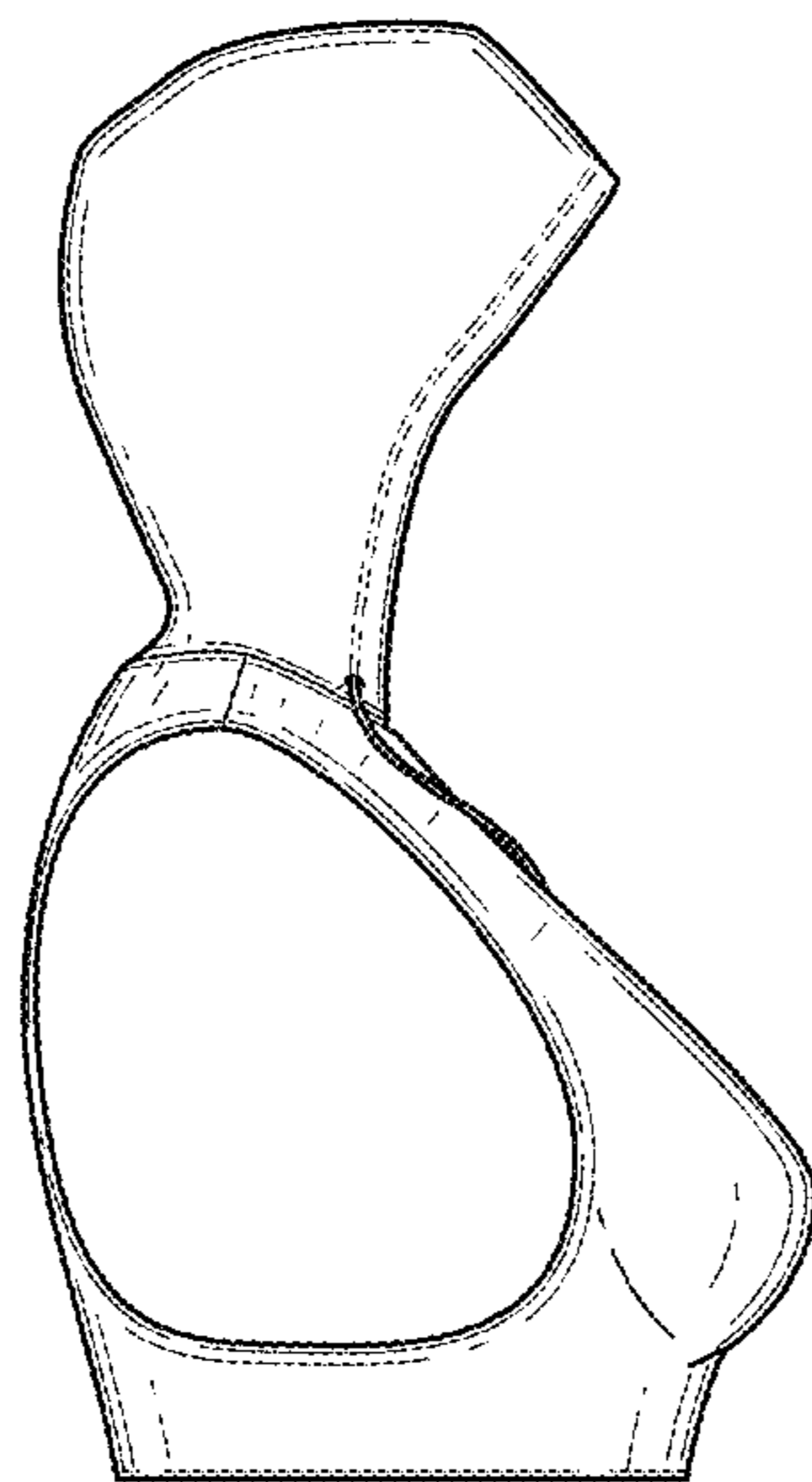

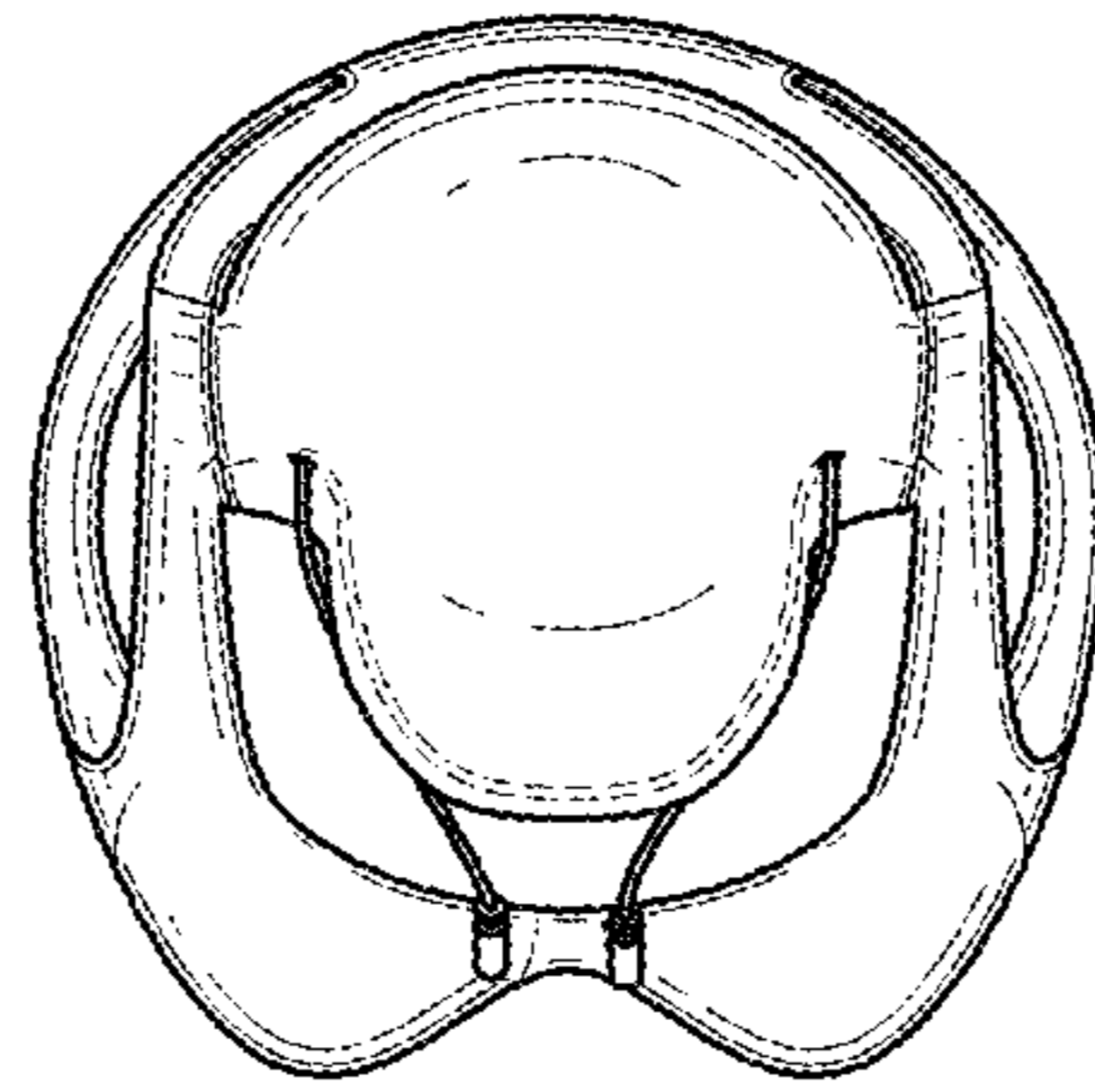

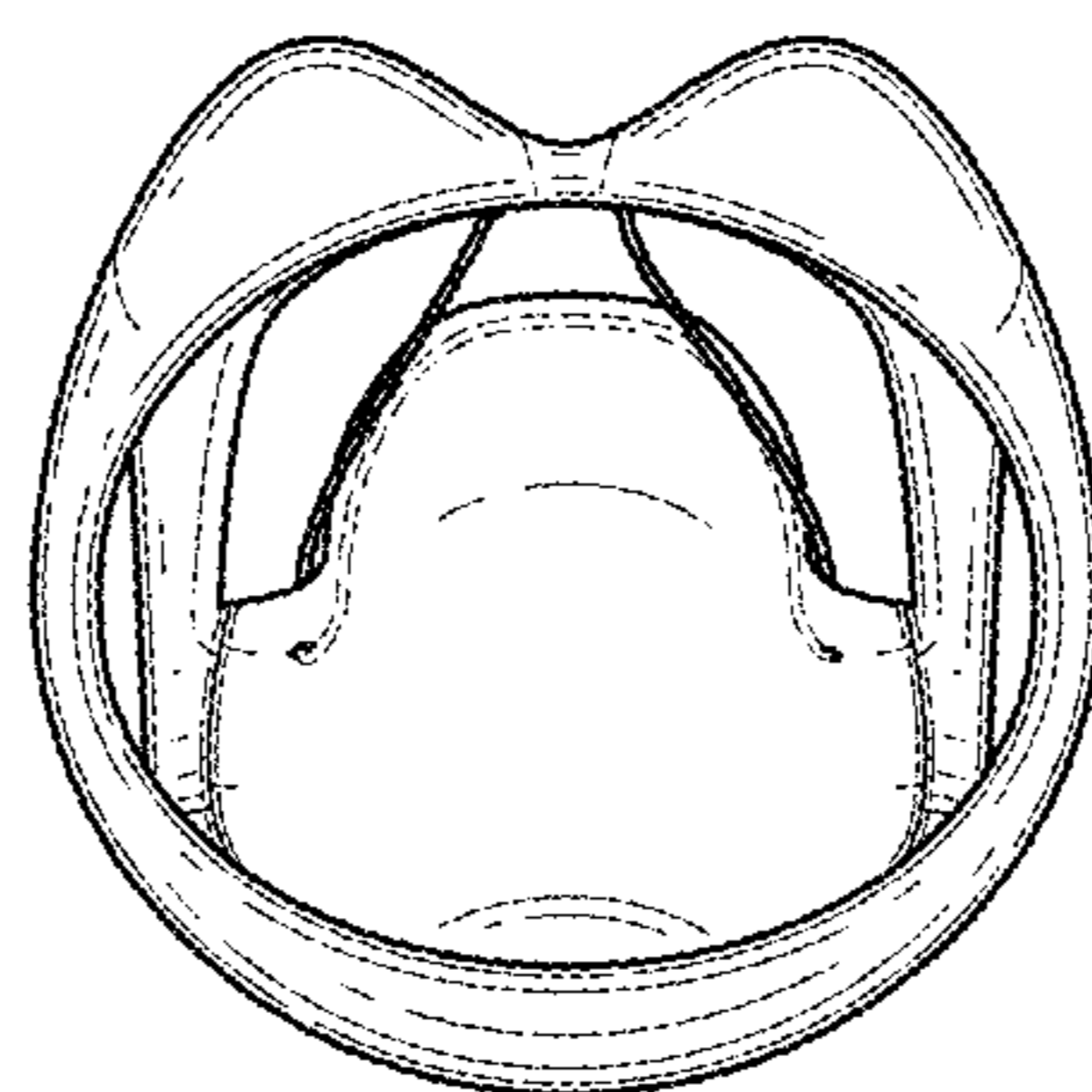
