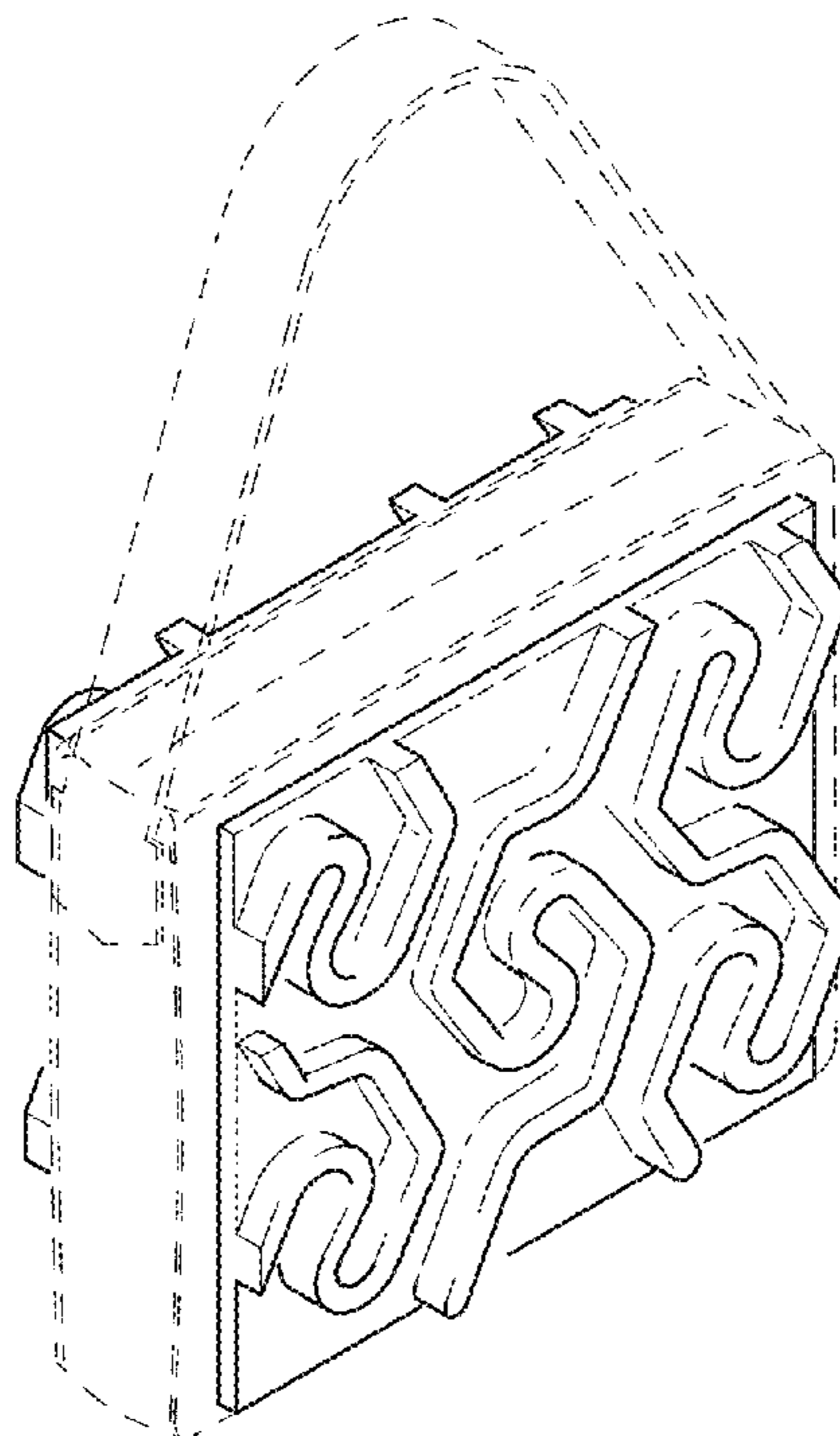
(57) **CLAIM**

The ornamental design for a purse decoration, as shown and described.

DESCRIPTION

FIG. 1 is a right, top, perspective view of a purse decoration in accordance with the present invention;
 FIG. 2 is an elevational right-side view of the purse decoration of FIG. 1 in accordance with the present invention;
 FIG. 3 is an upward-looking planar bottom view of the purse decoration of FIG. 1 in accordance with the present invention;
 FIG. 4 is an elevational left-side view of the purse decoration of FIG. 1 in accordance with the present invention;
 FIG. 5 is a downward-looking planar top view of the purse decoration of FIG. 1 in accordance with the present invention;
 FIG. 6 is an elevational front-edge view of the purse decoration of FIG. 1 in accordance with the present invention; and,
 FIG. 7 is an elevational back-edge view of the purse decoration of FIG. 1 in accordance with the present invention.
 The broken lines showing a purse between the decoration depict environment only and forms no part of the claimed design.

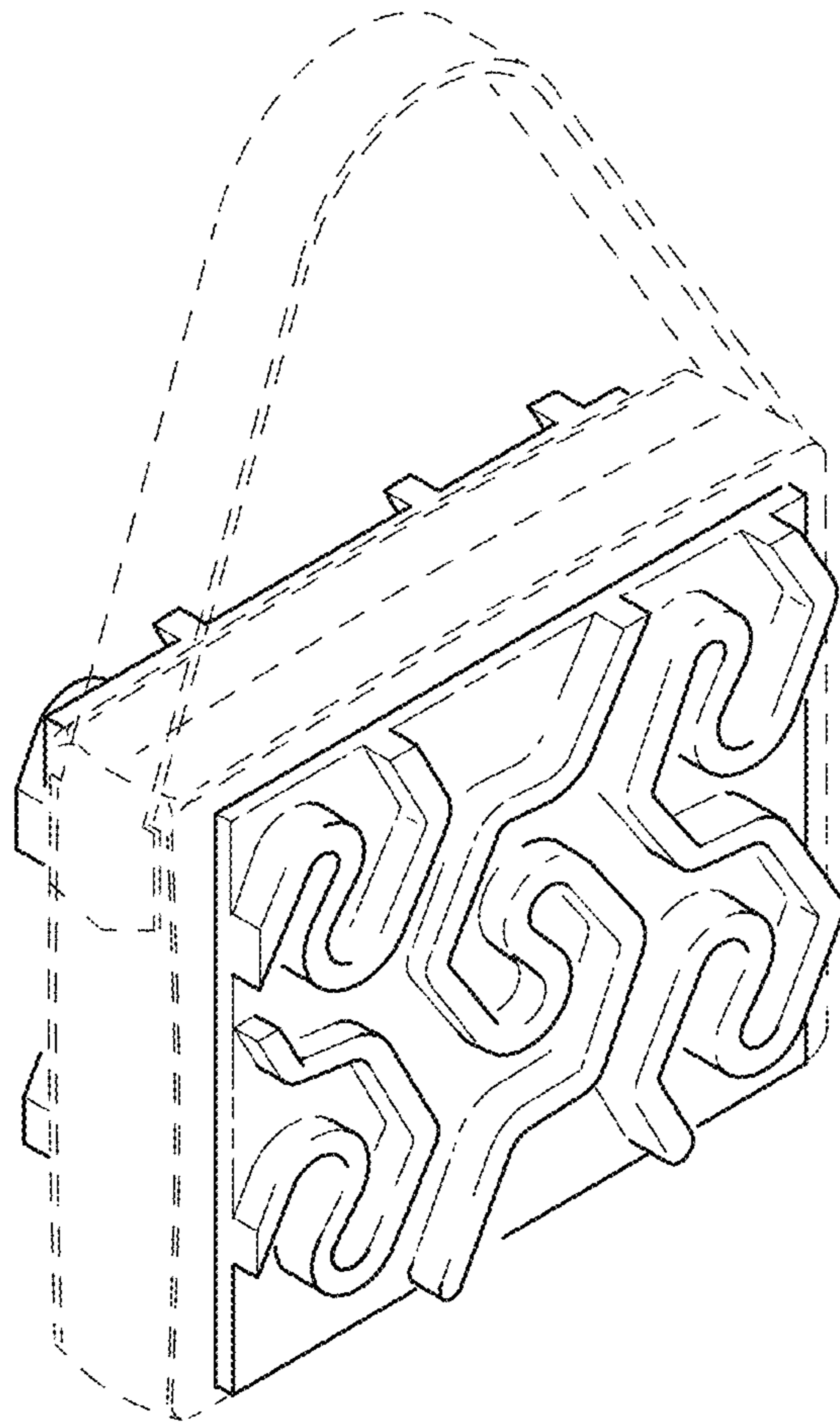

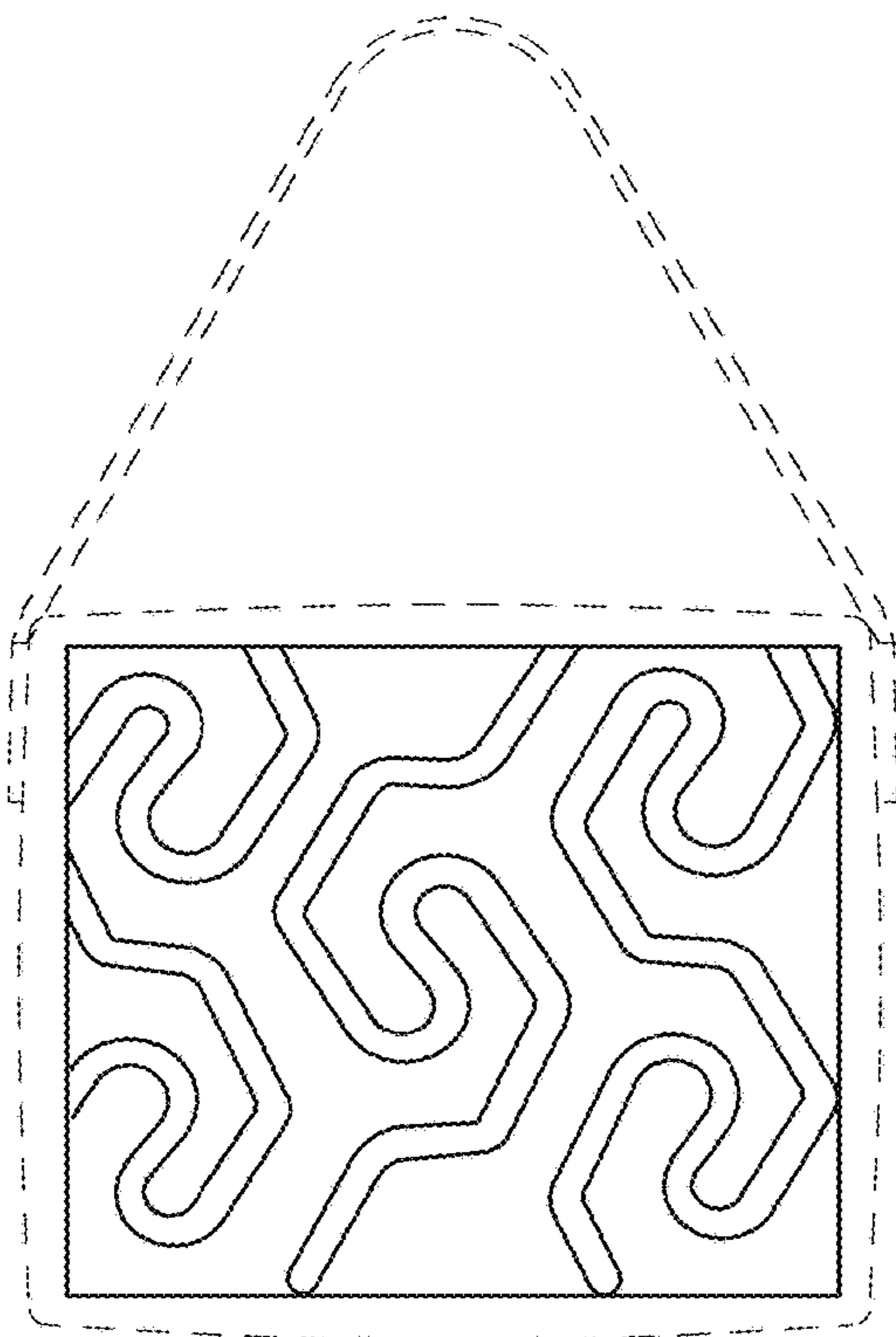
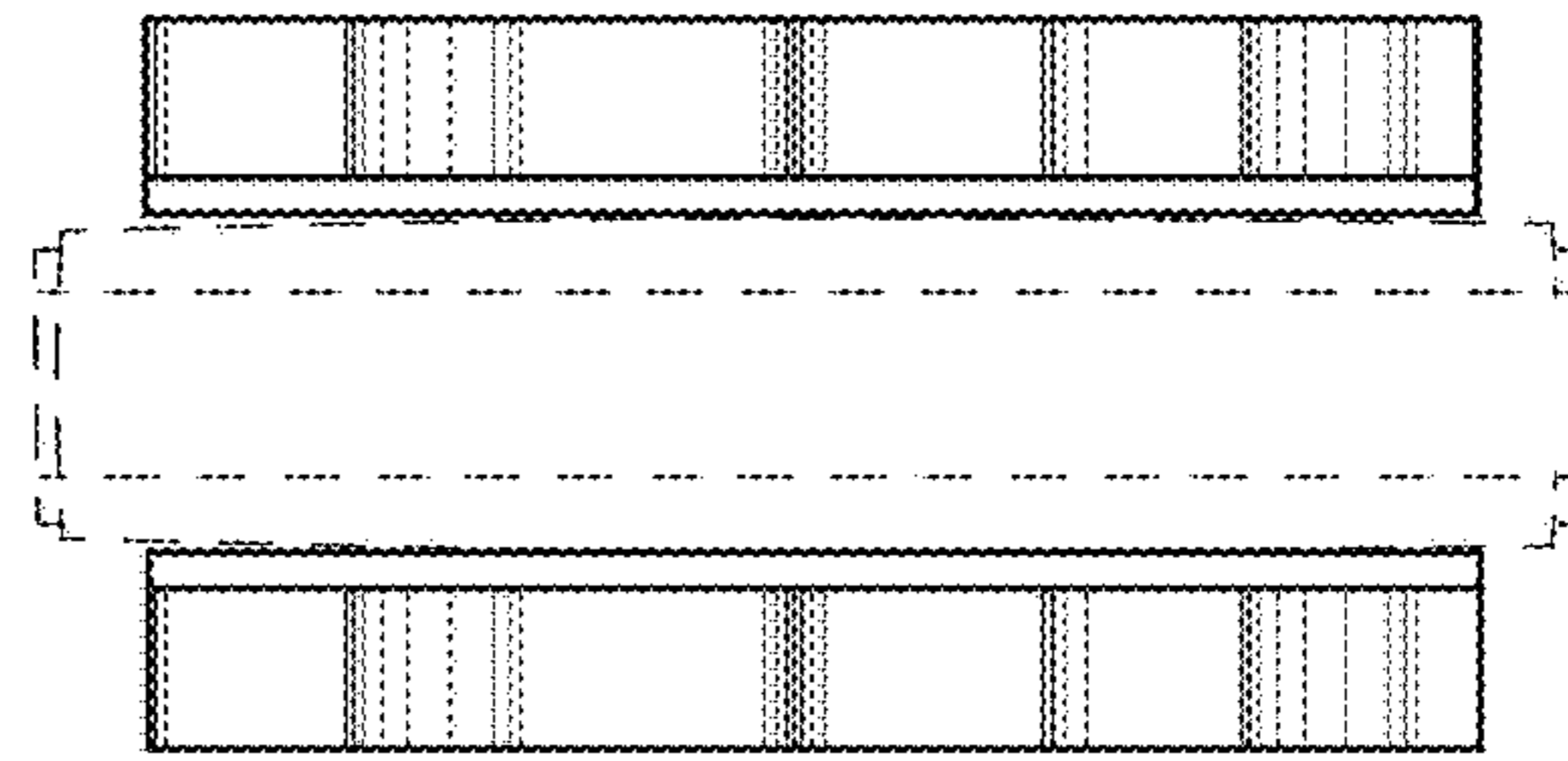

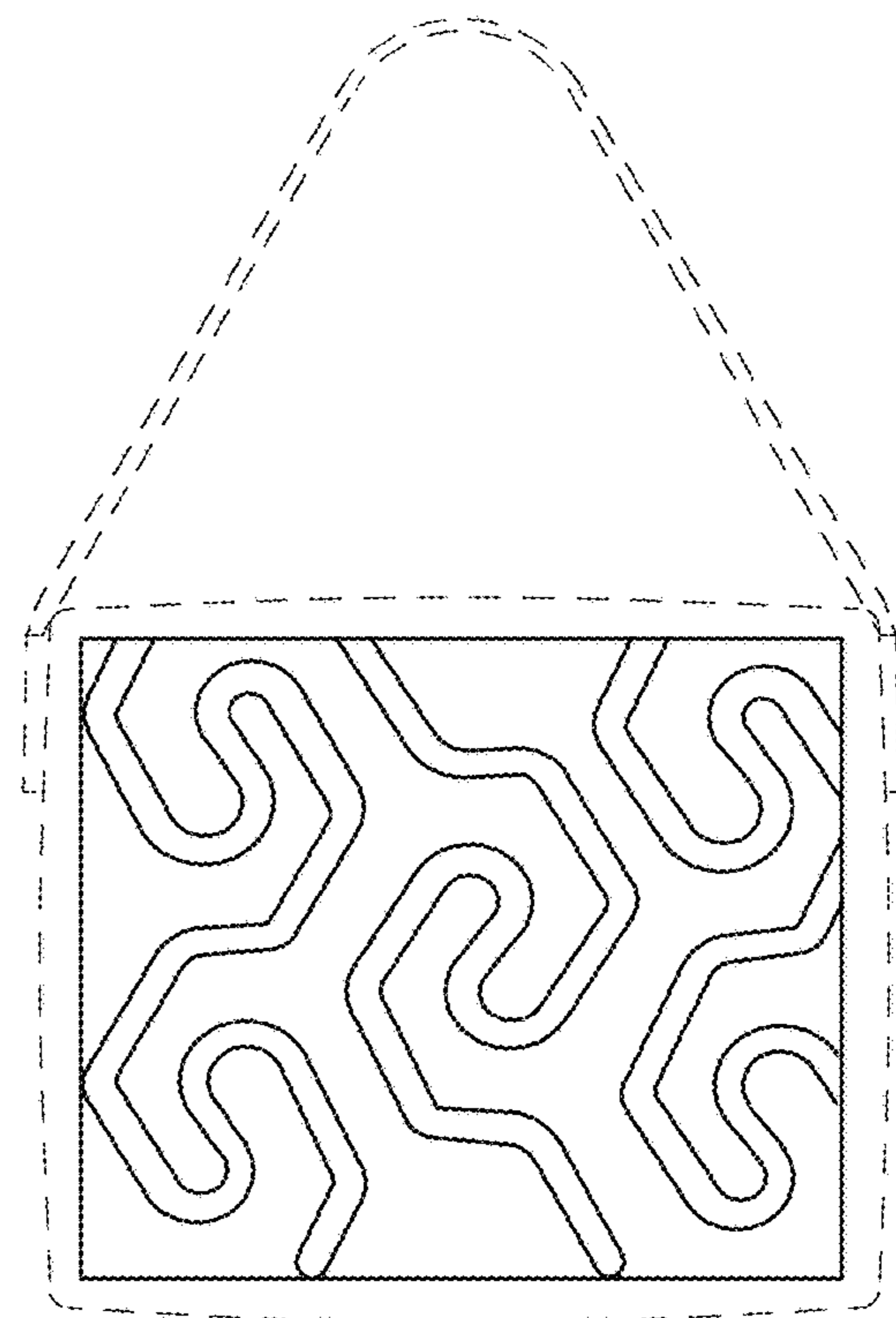

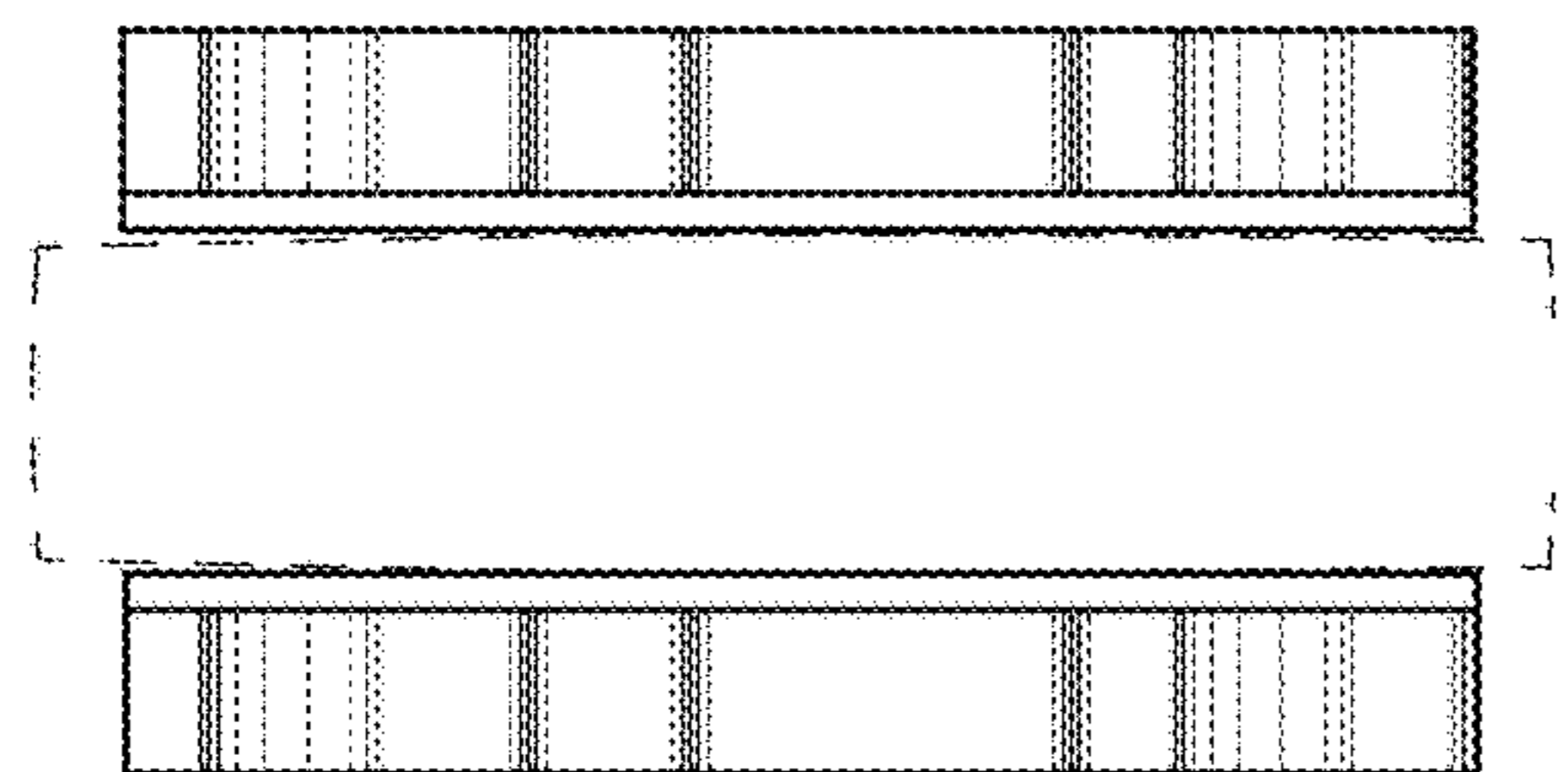

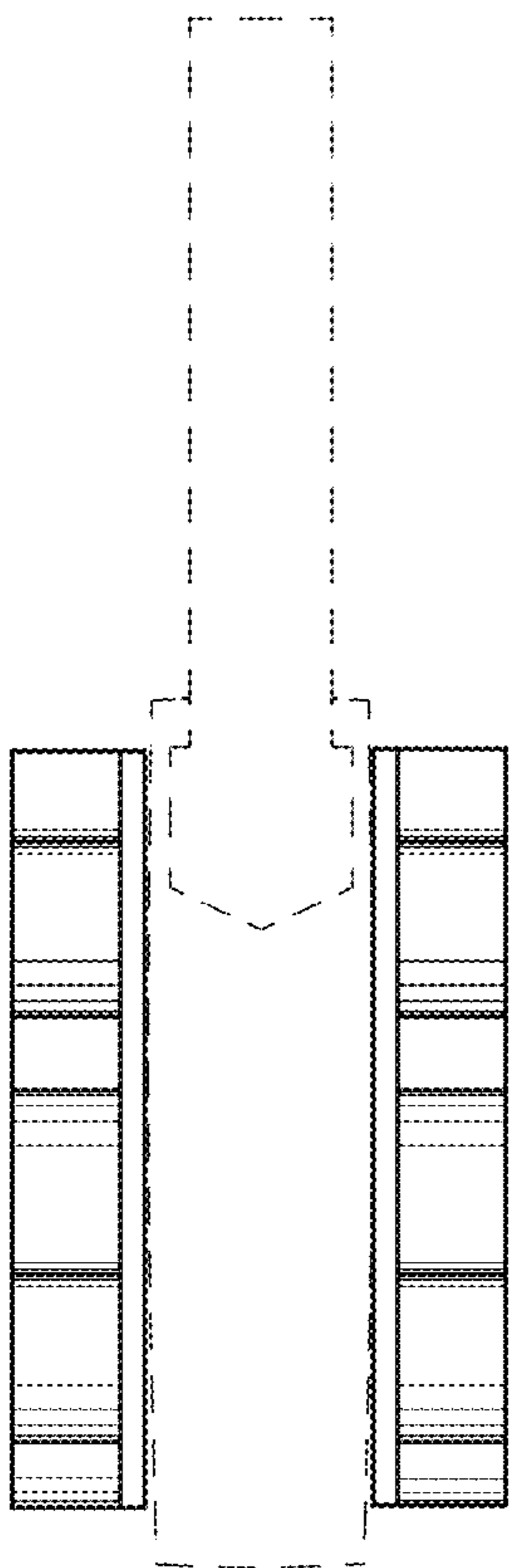

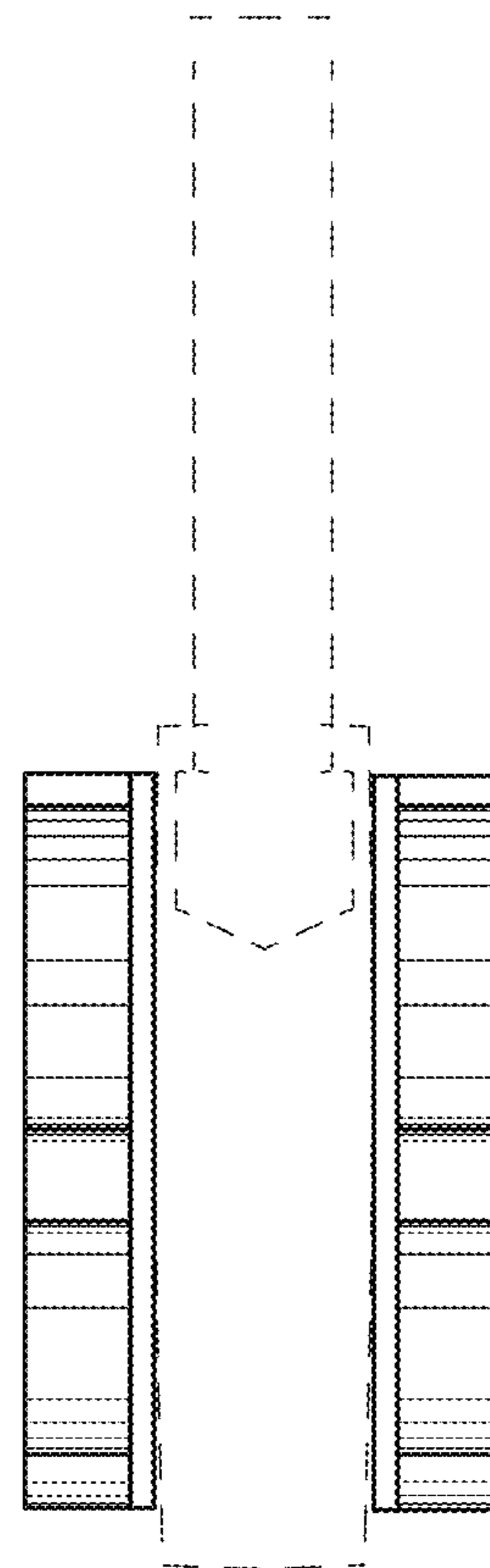
