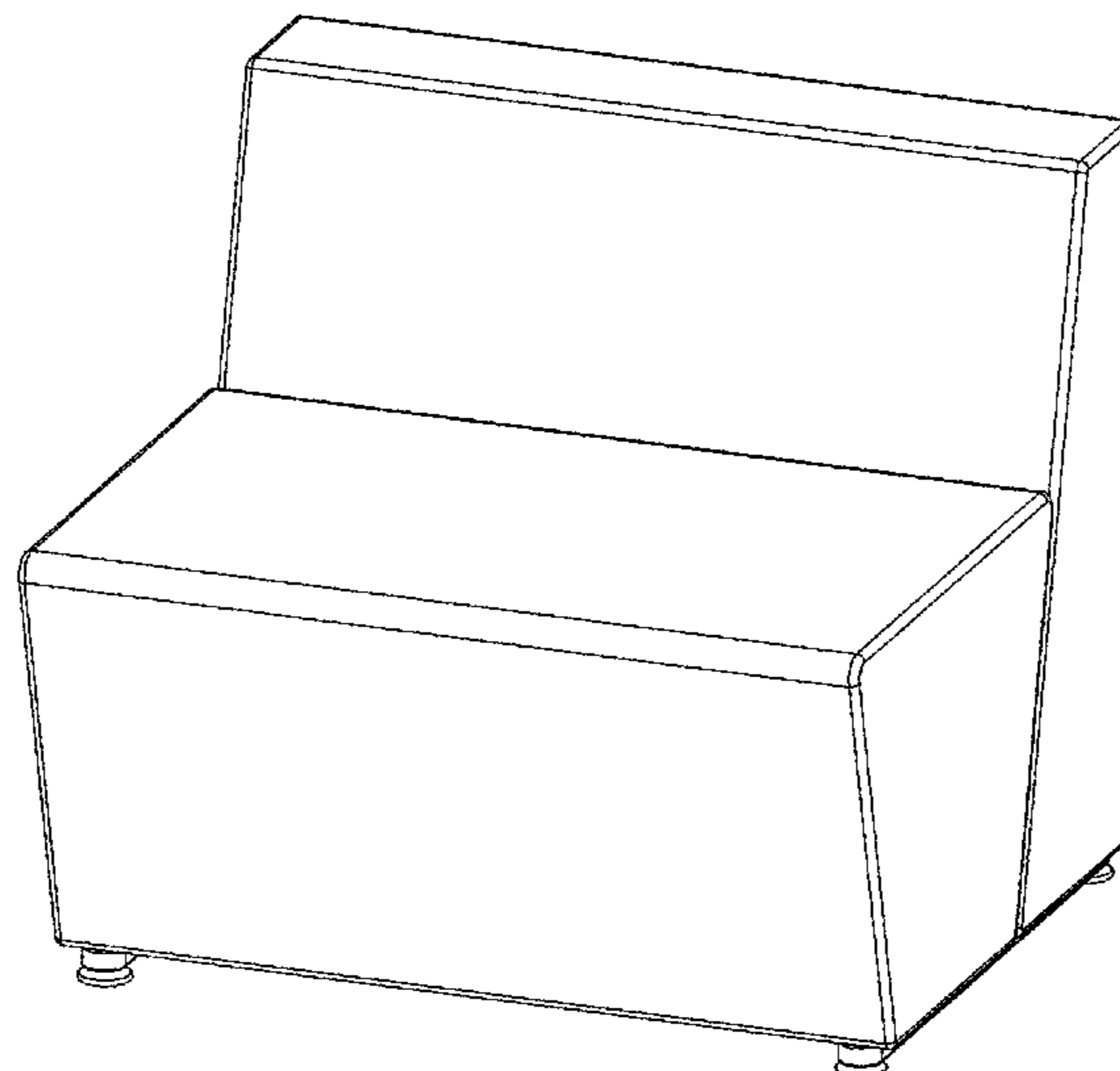
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevation view of furniture module showing my new design,
FIG. 2 is a left side elevation thereof, the right side elevation view is a mirror image of the left side elevation view,
FIG. 3 is a rear elevation view thereof,
FIG. 4 is a top plan view thereof,
FIG. 5 is a top, front, and right side perspective view thereof,
FIG. 6 is a top, rear, and left side perspective view thereof,
FIG. 7 is a front elevation view of furniture module, according to another embodiment of the present invention,
FIG. 8 is a left side elevation view thereof, the right side elevation view is a mirror image thereof,
FIG. 9 is a rear elevation view thereof,
FIG. 10 is a top plan view thereof,
FIG. 11 is a top, front, and right side perspective view thereof,
FIG. 12 is a top, front, and left side perspective view thereof,
FIG. 13 is a front elevation view of furniture modules, according to another embodiment of the present invention,

FIG. 16 is a top plan view thereof,

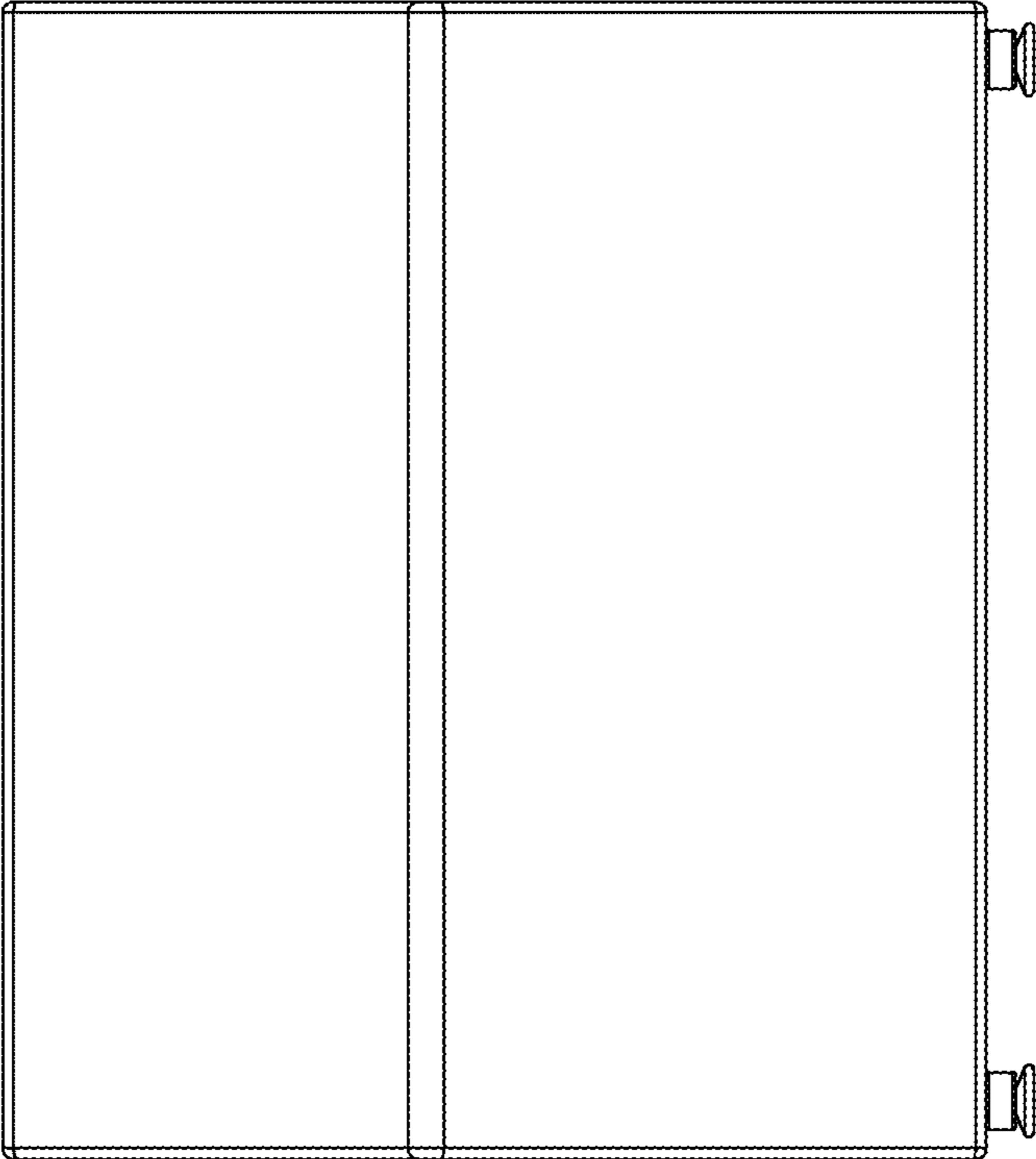

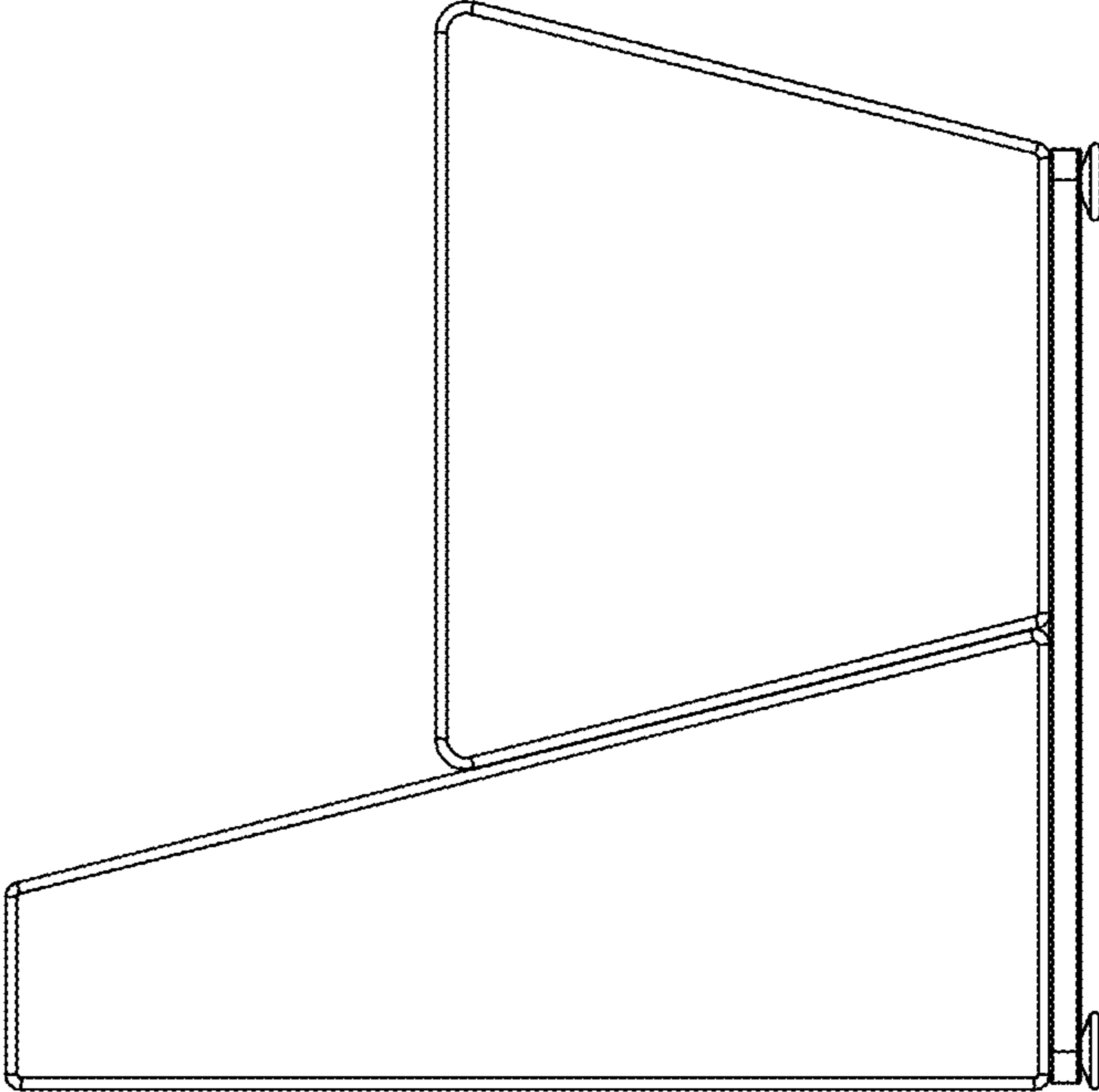

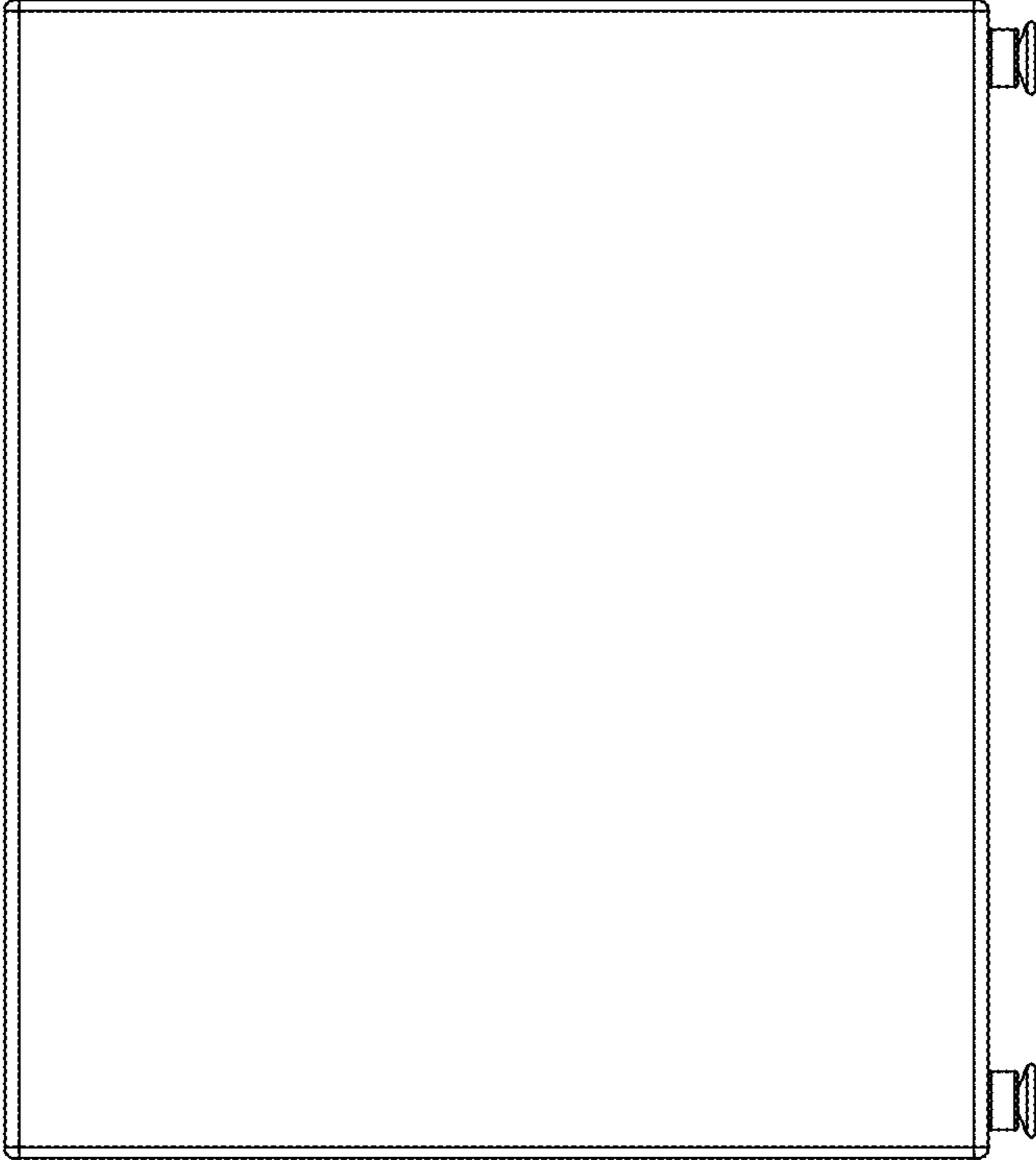

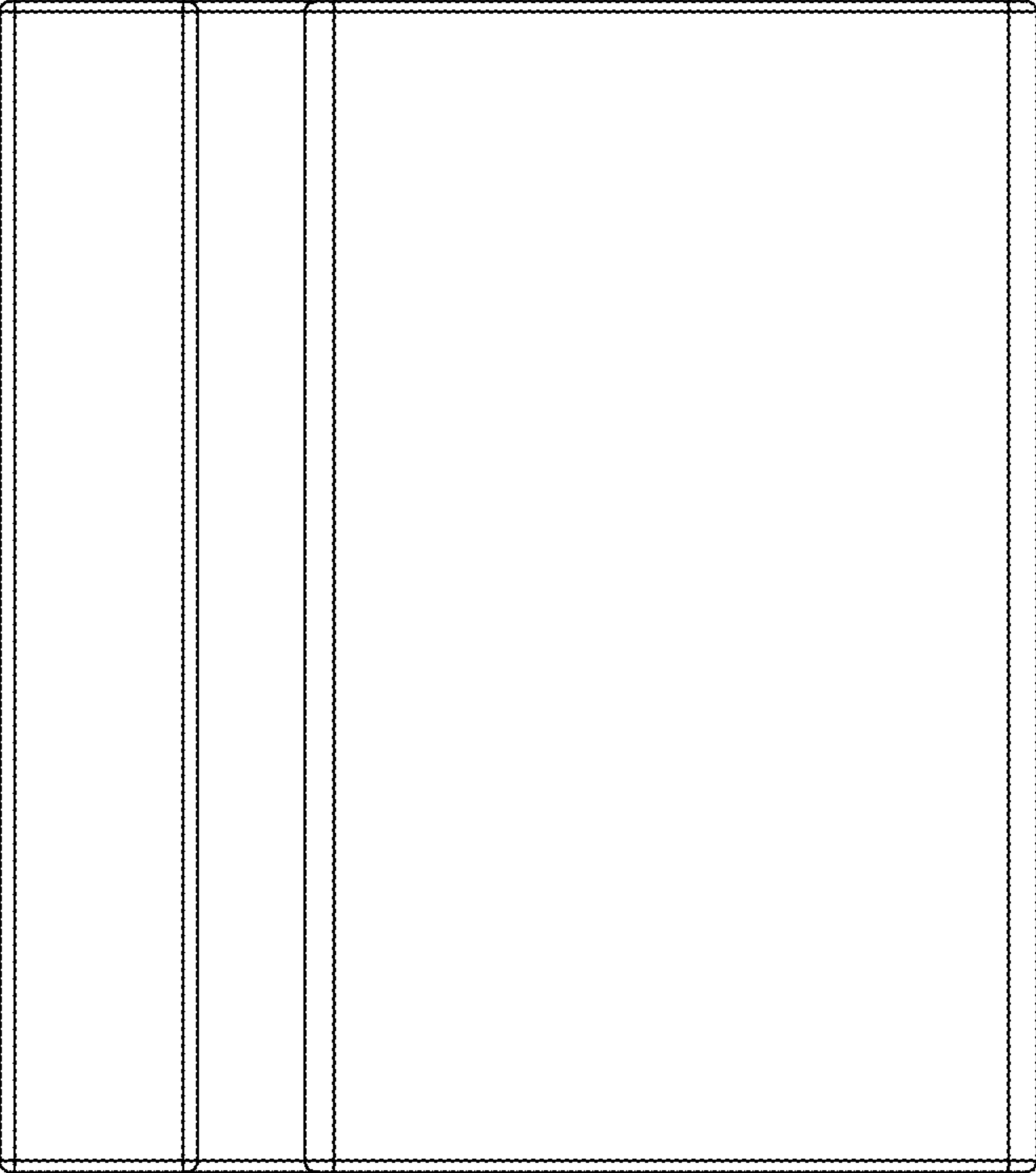

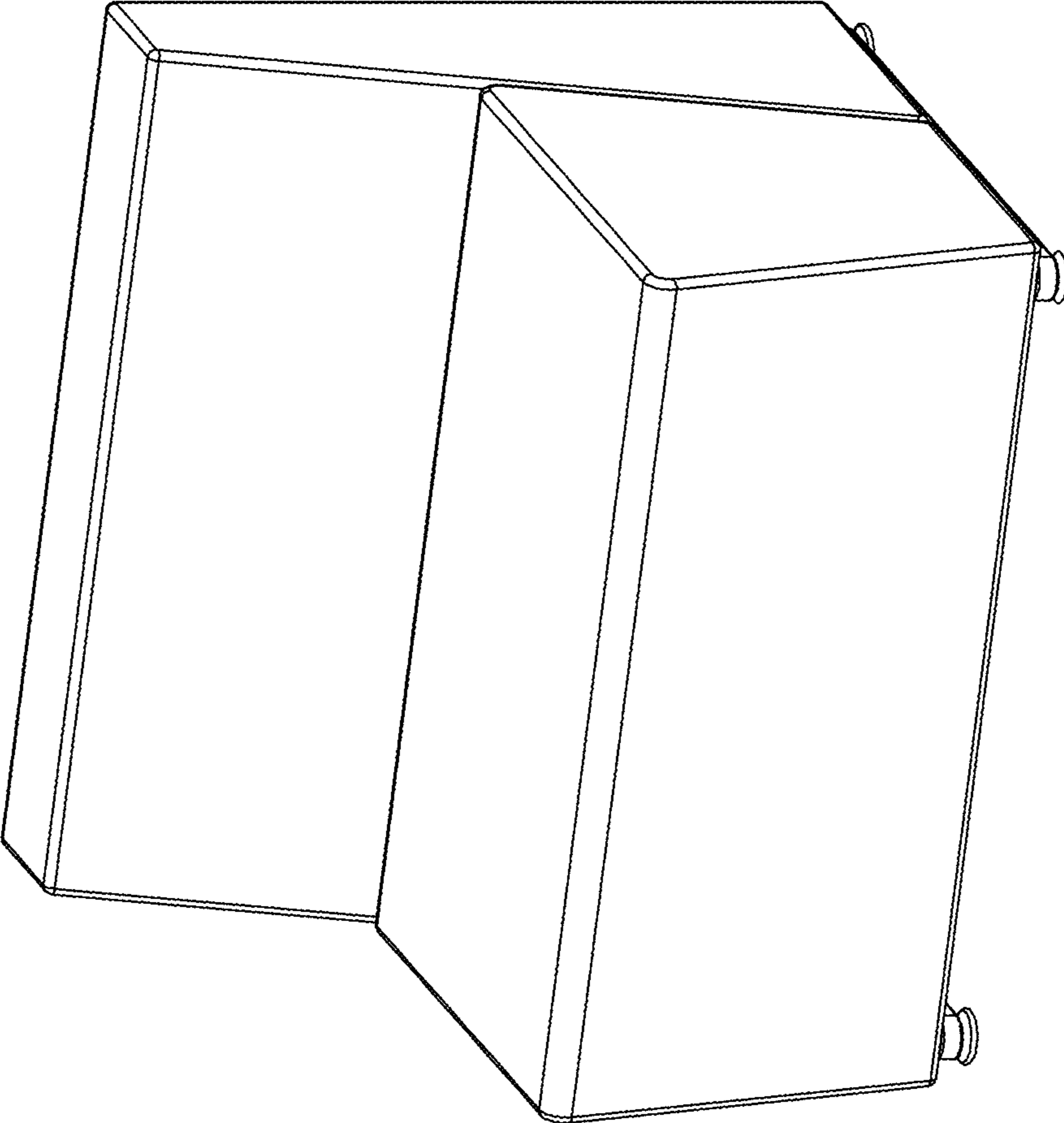

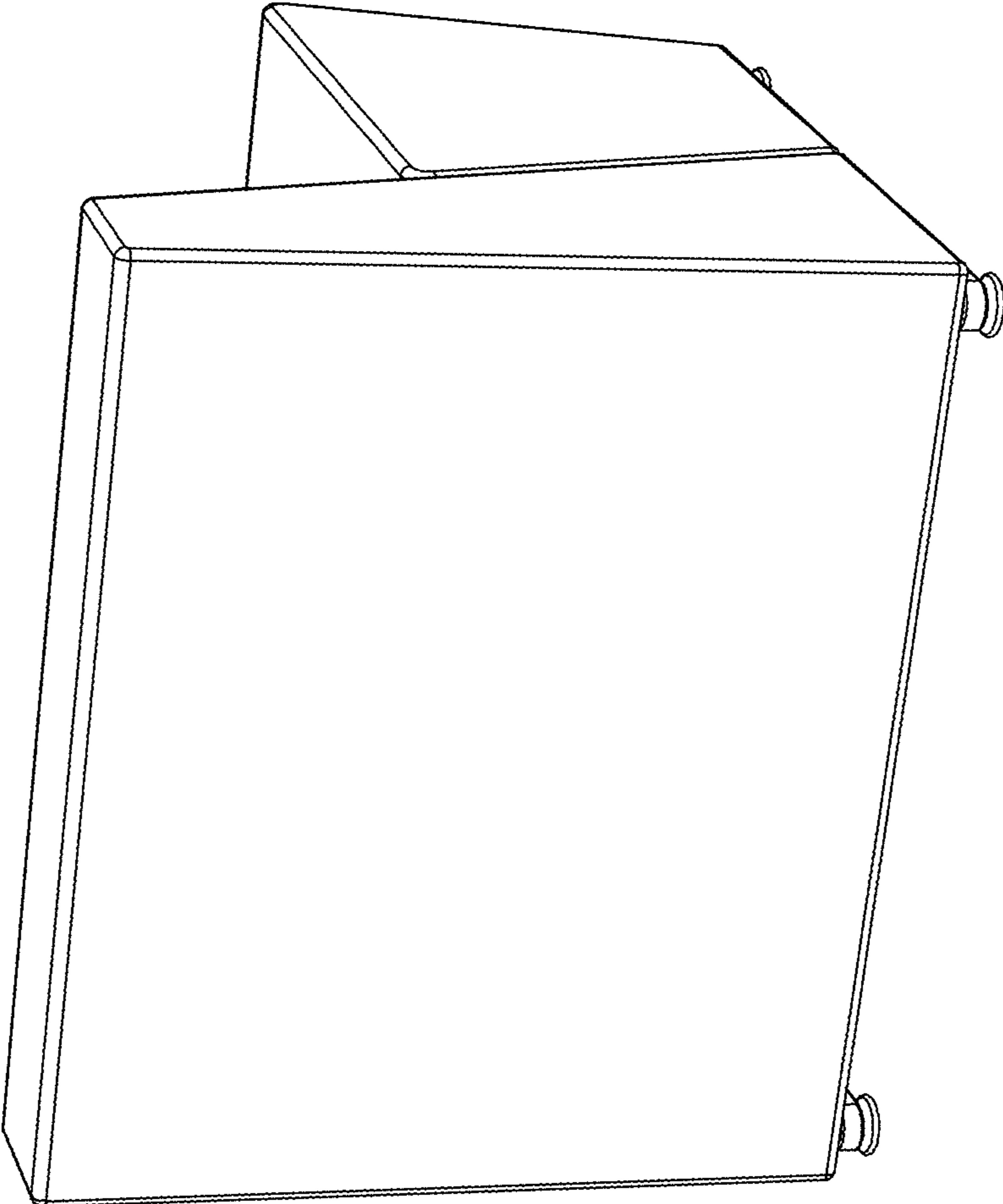

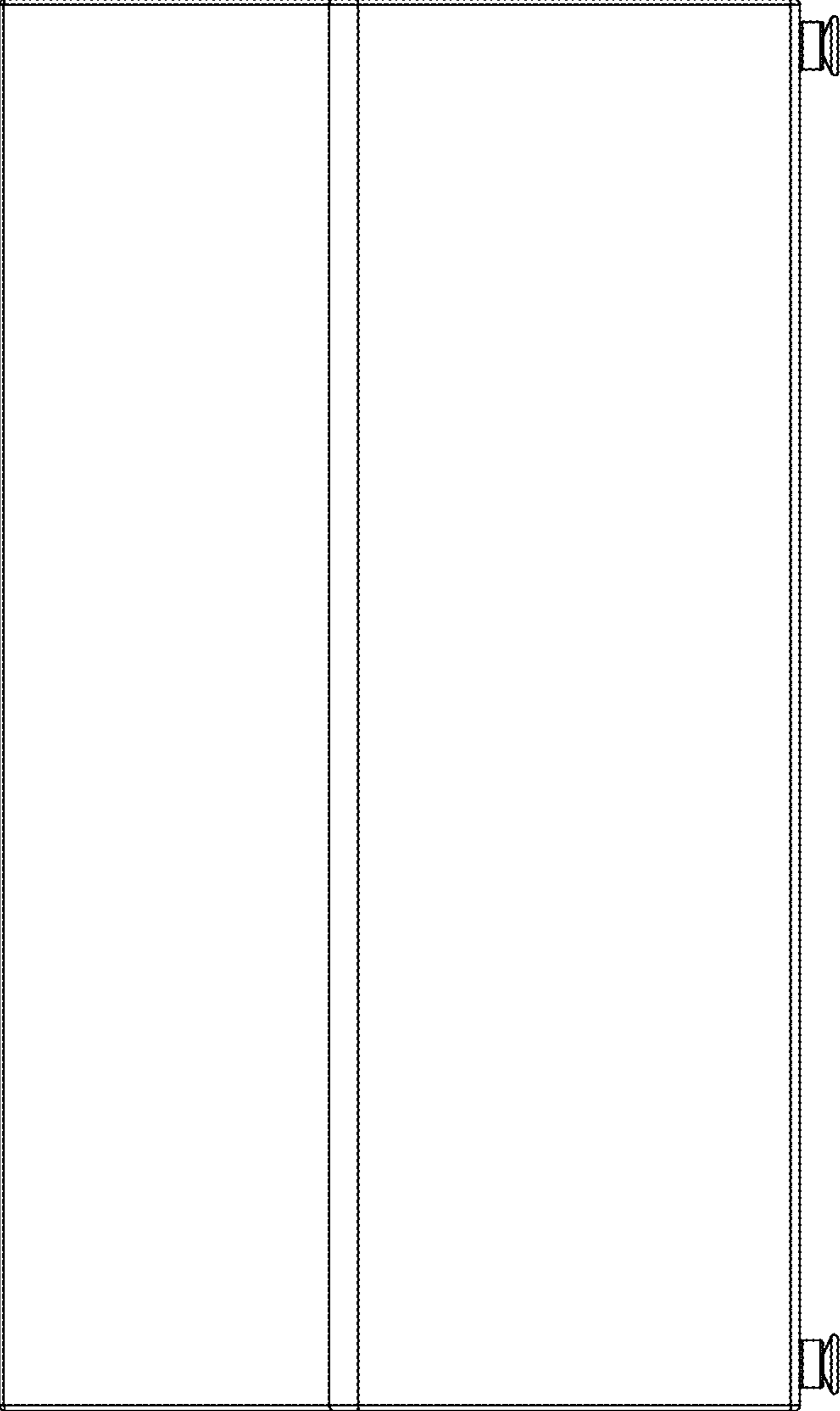

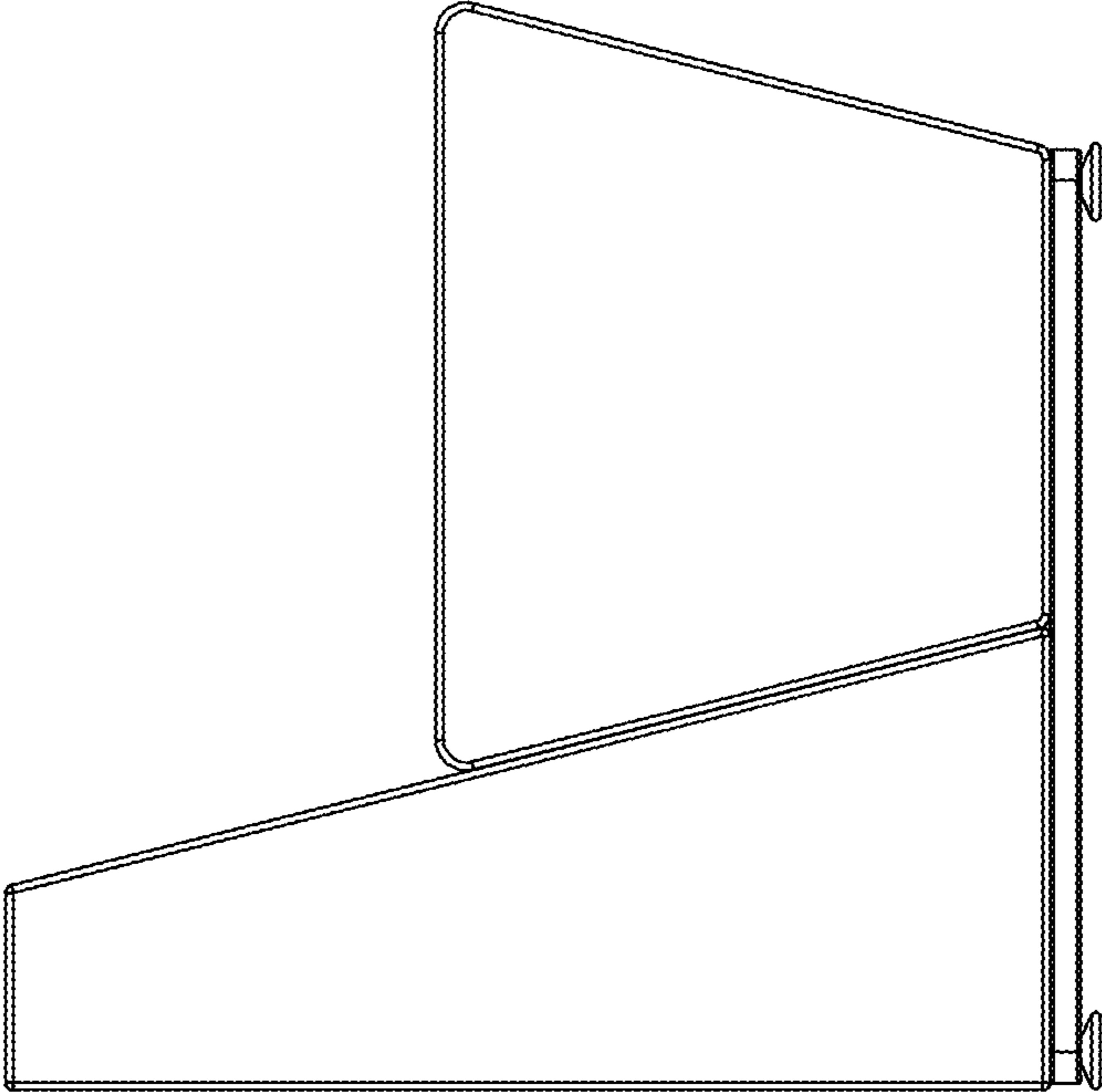

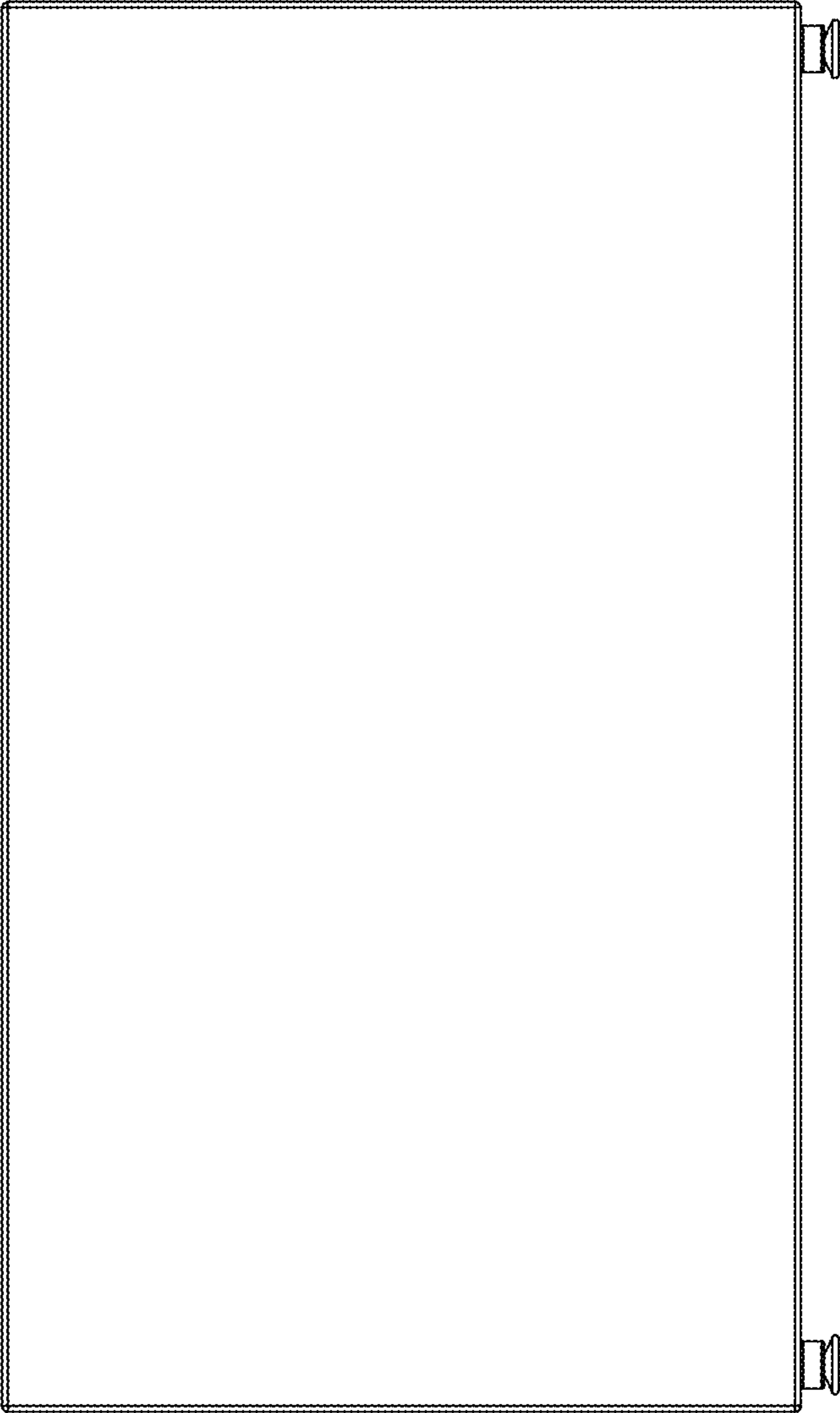

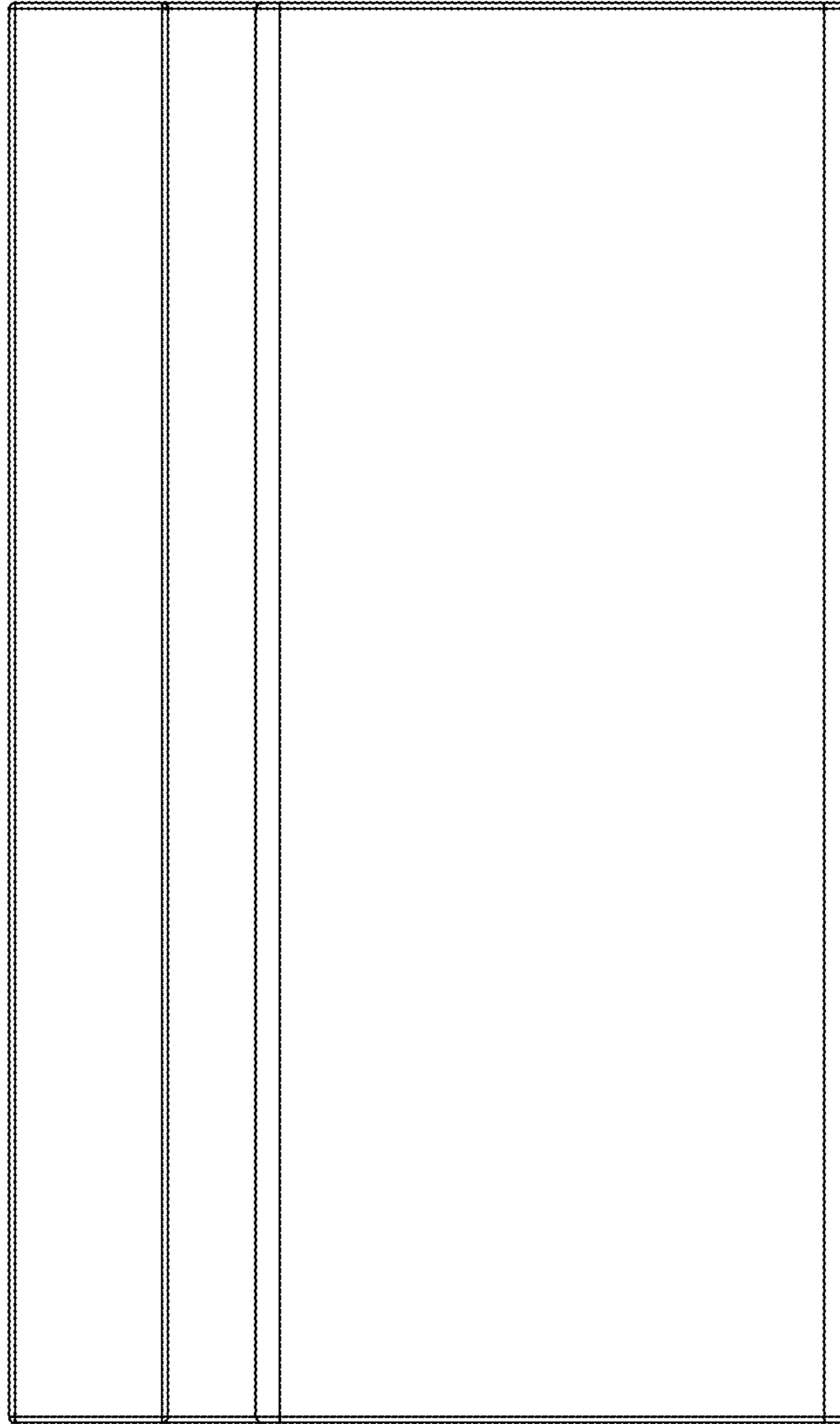
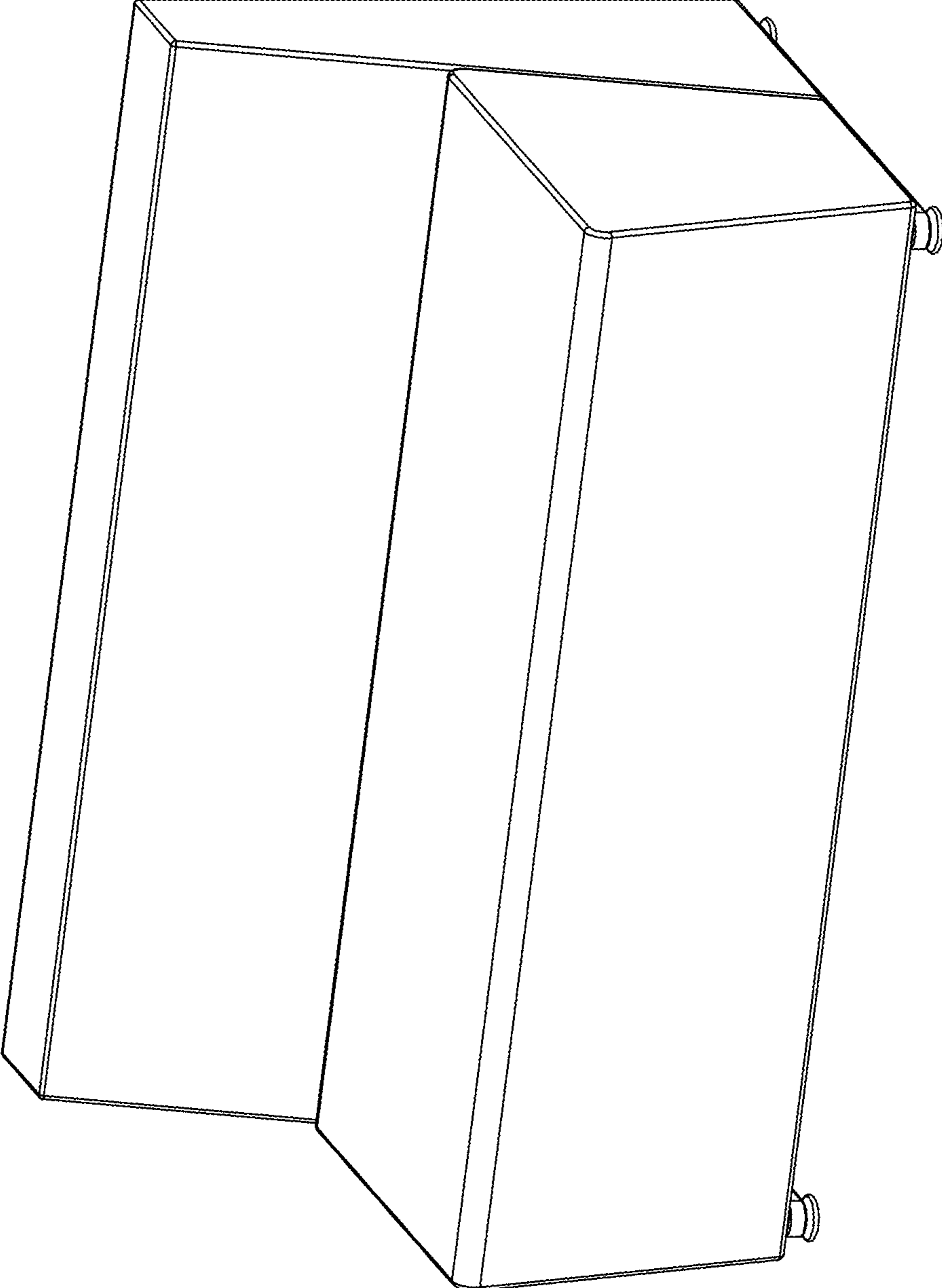

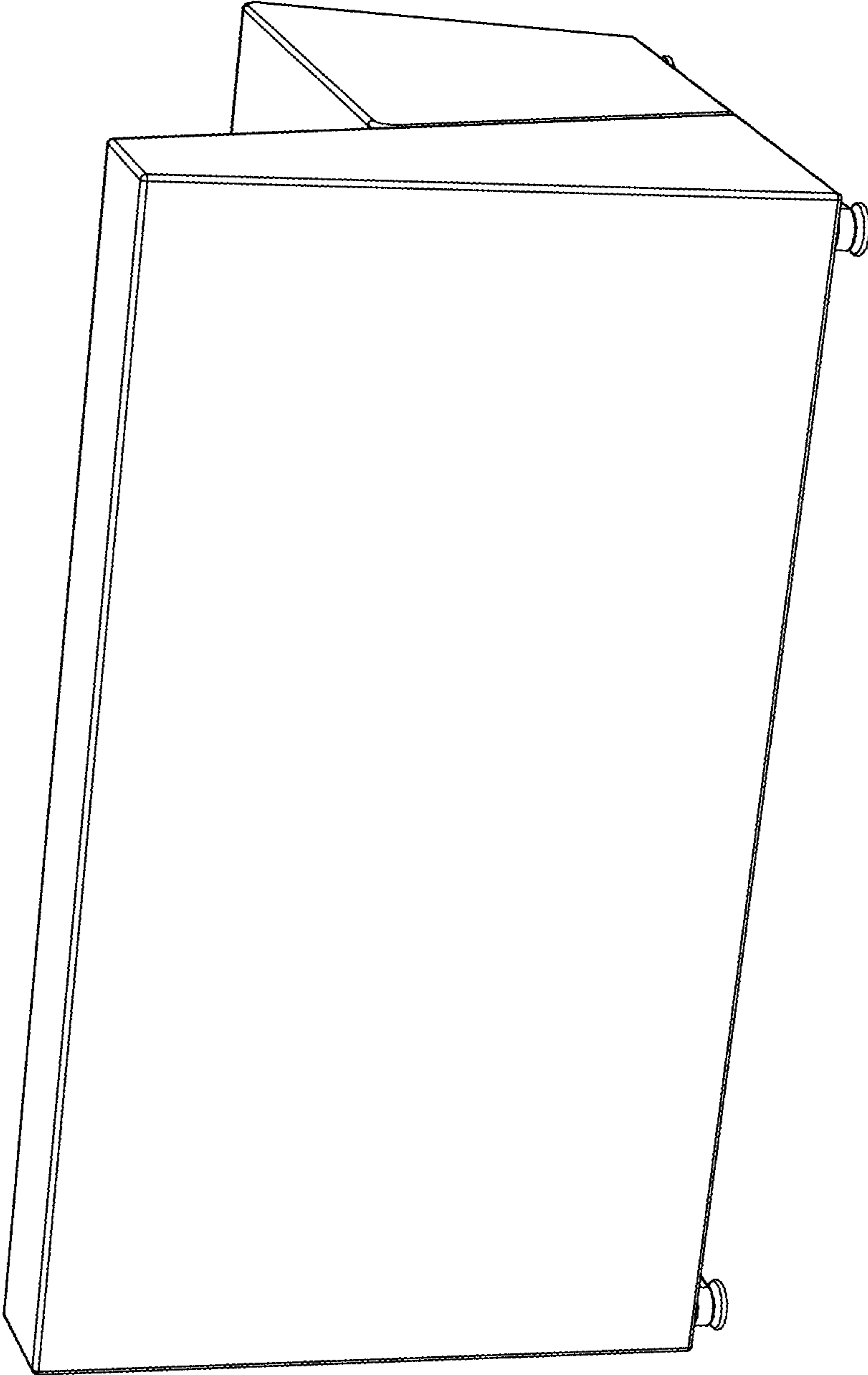

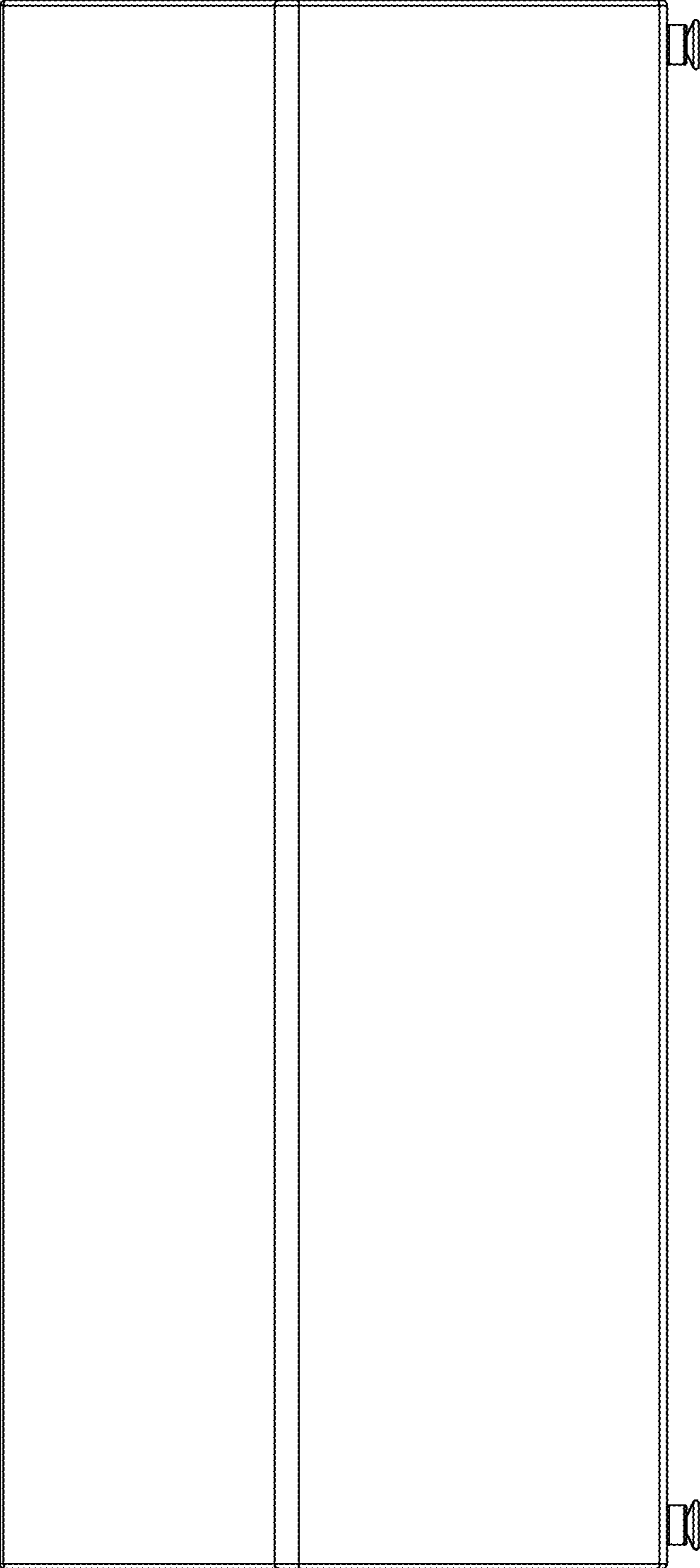

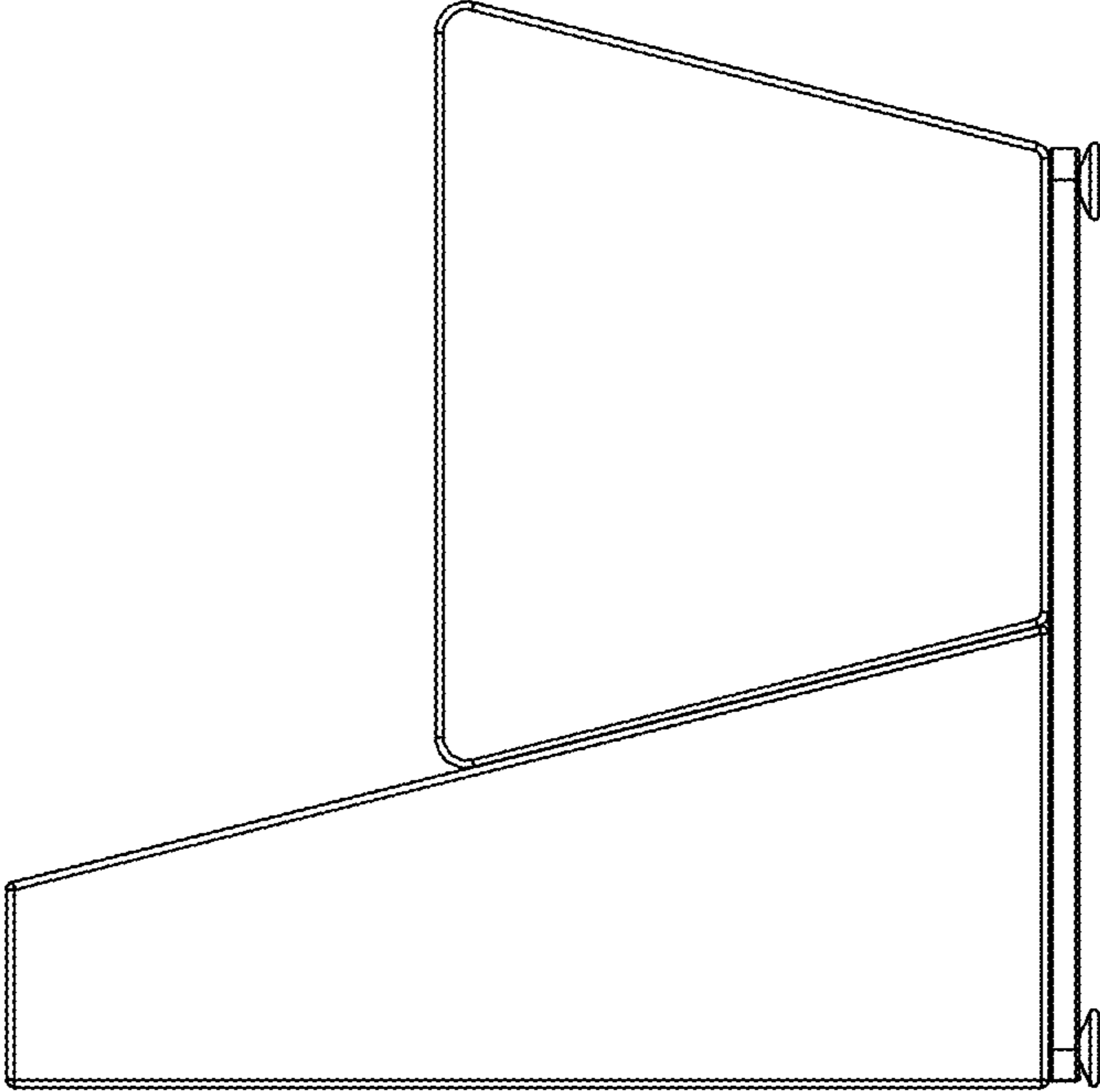

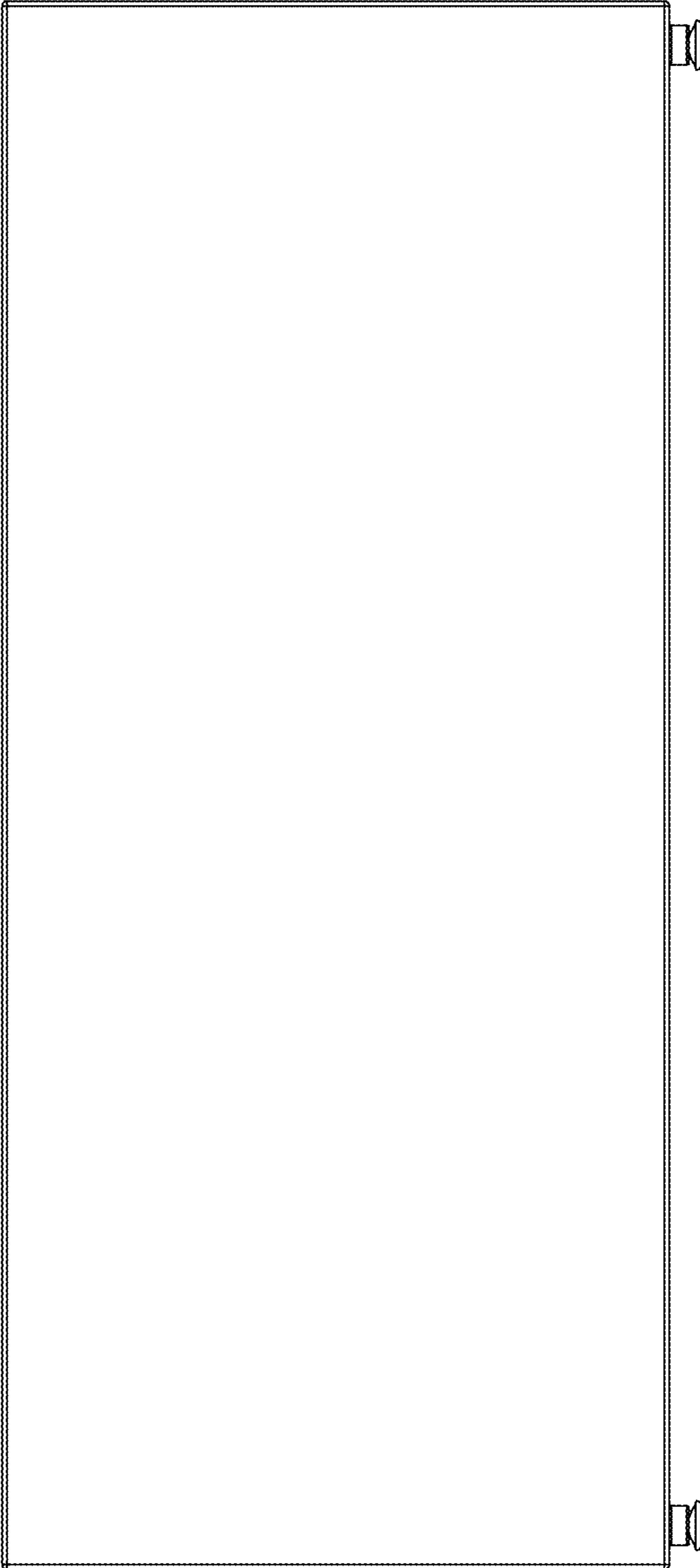
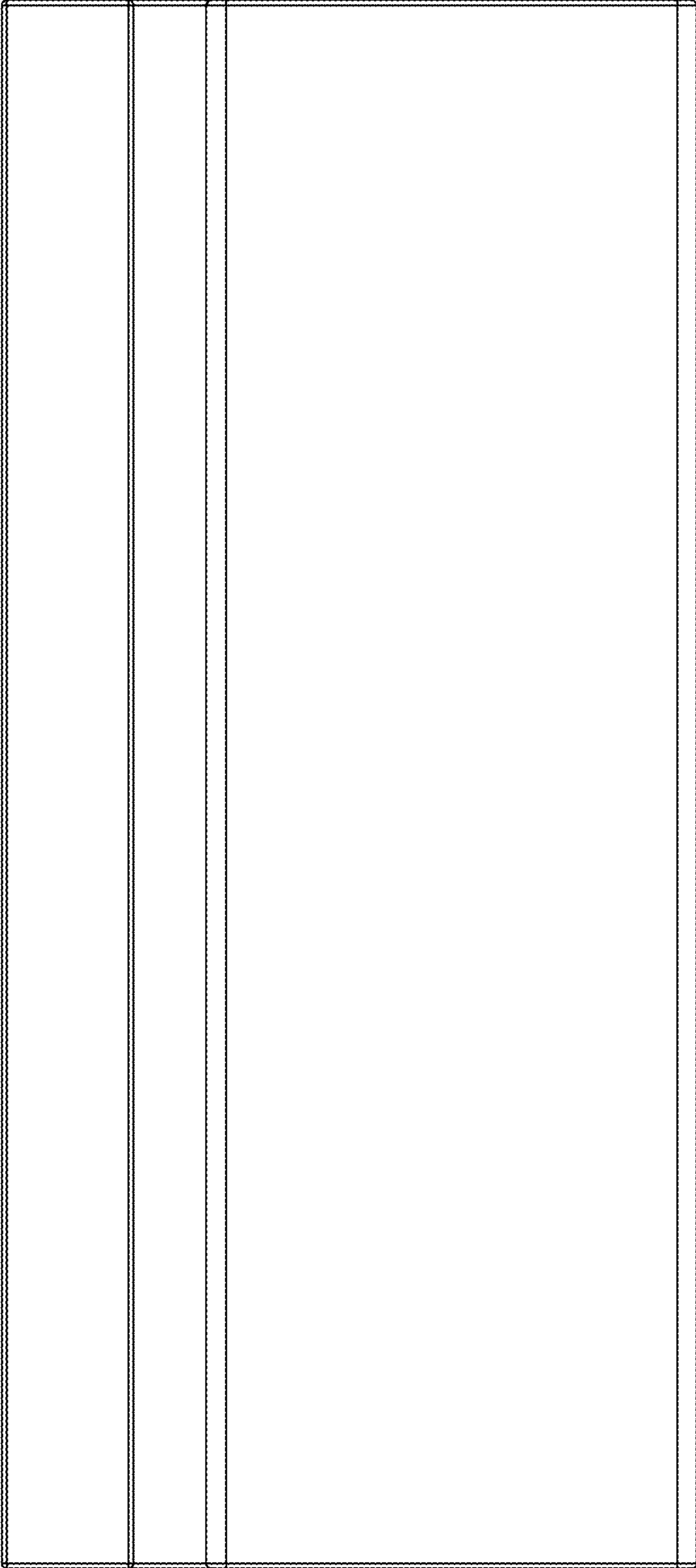

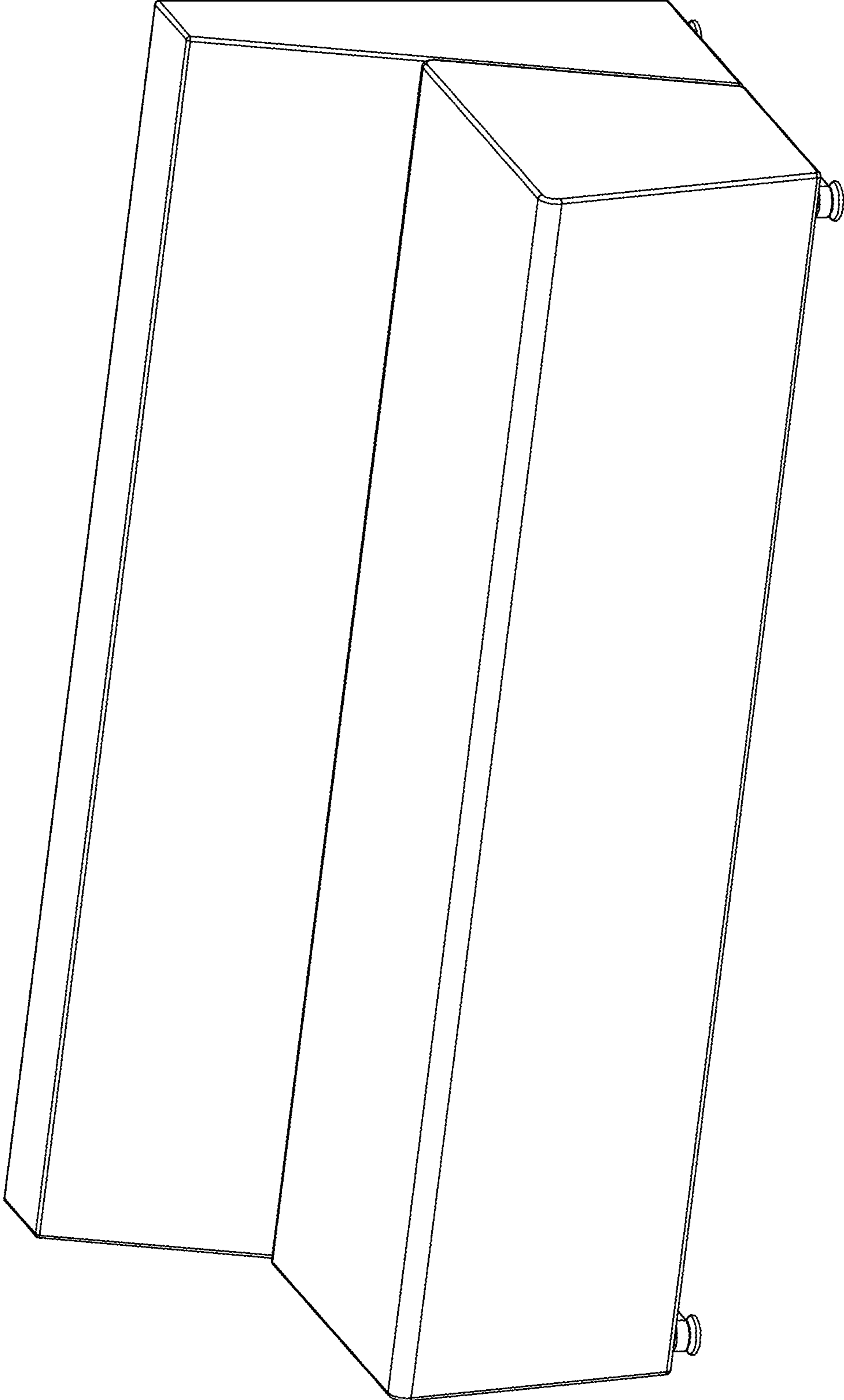

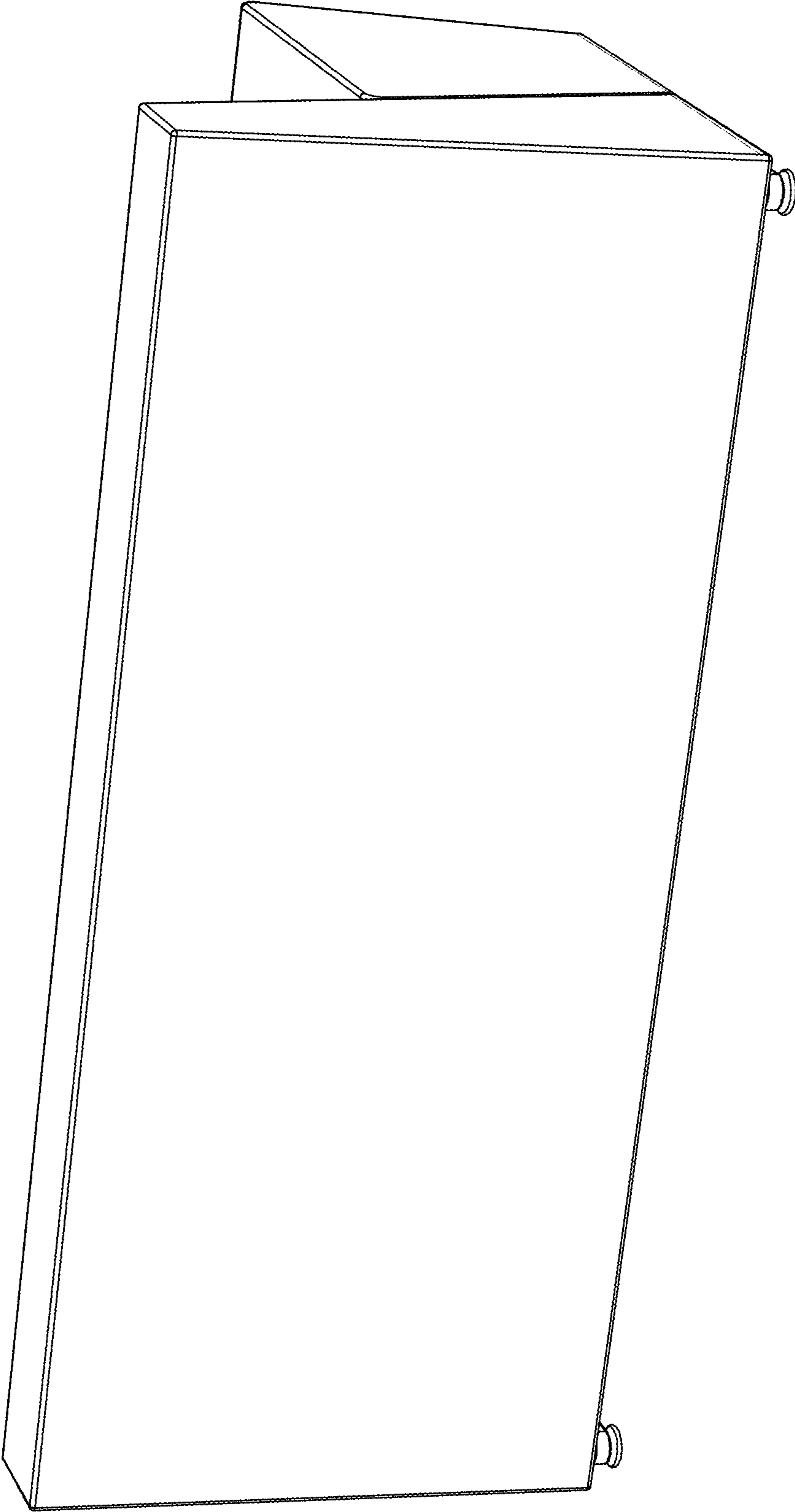
