DESCRIPTION

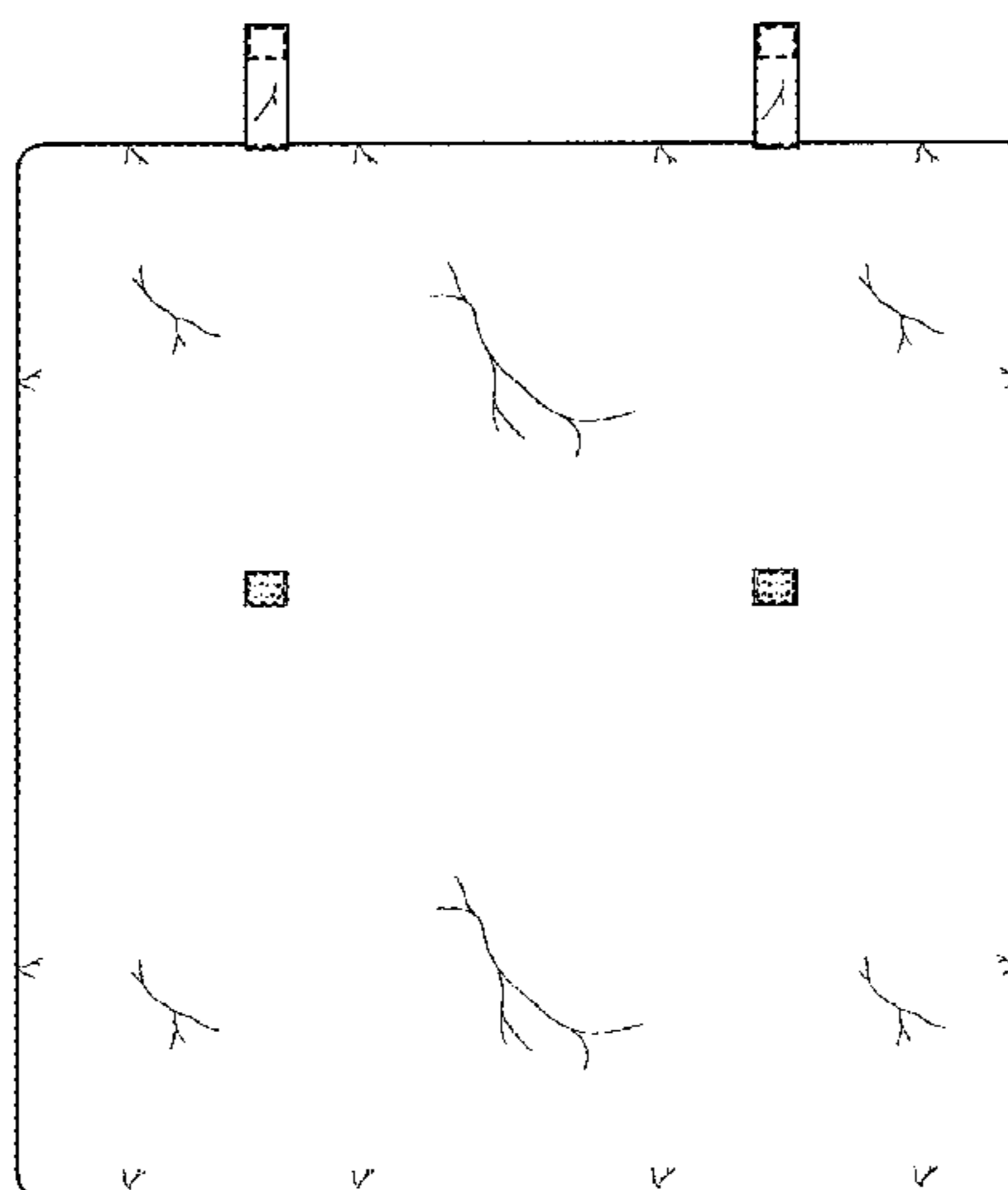
FIG. 1 is a folded perspective view thereof;

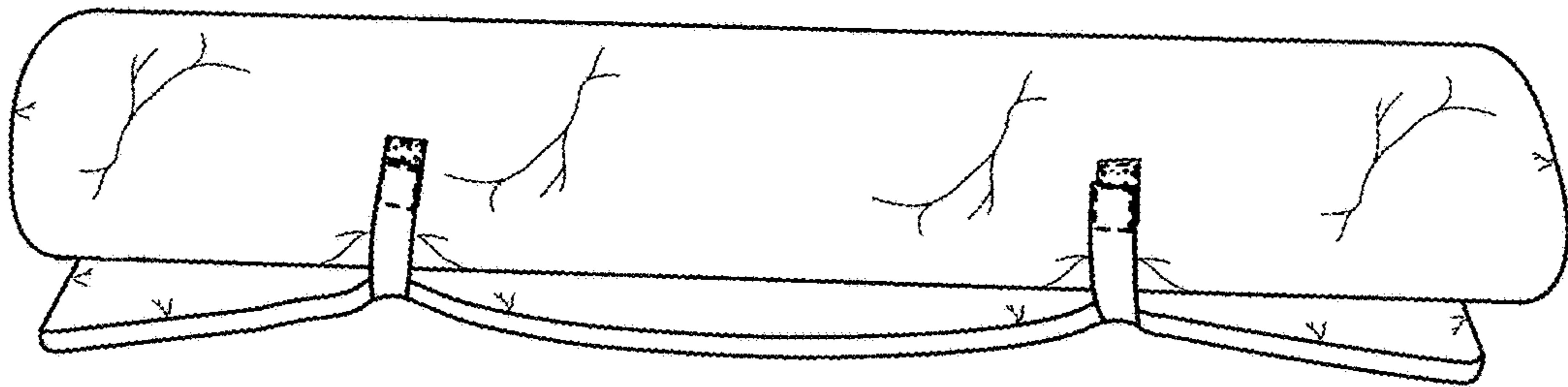

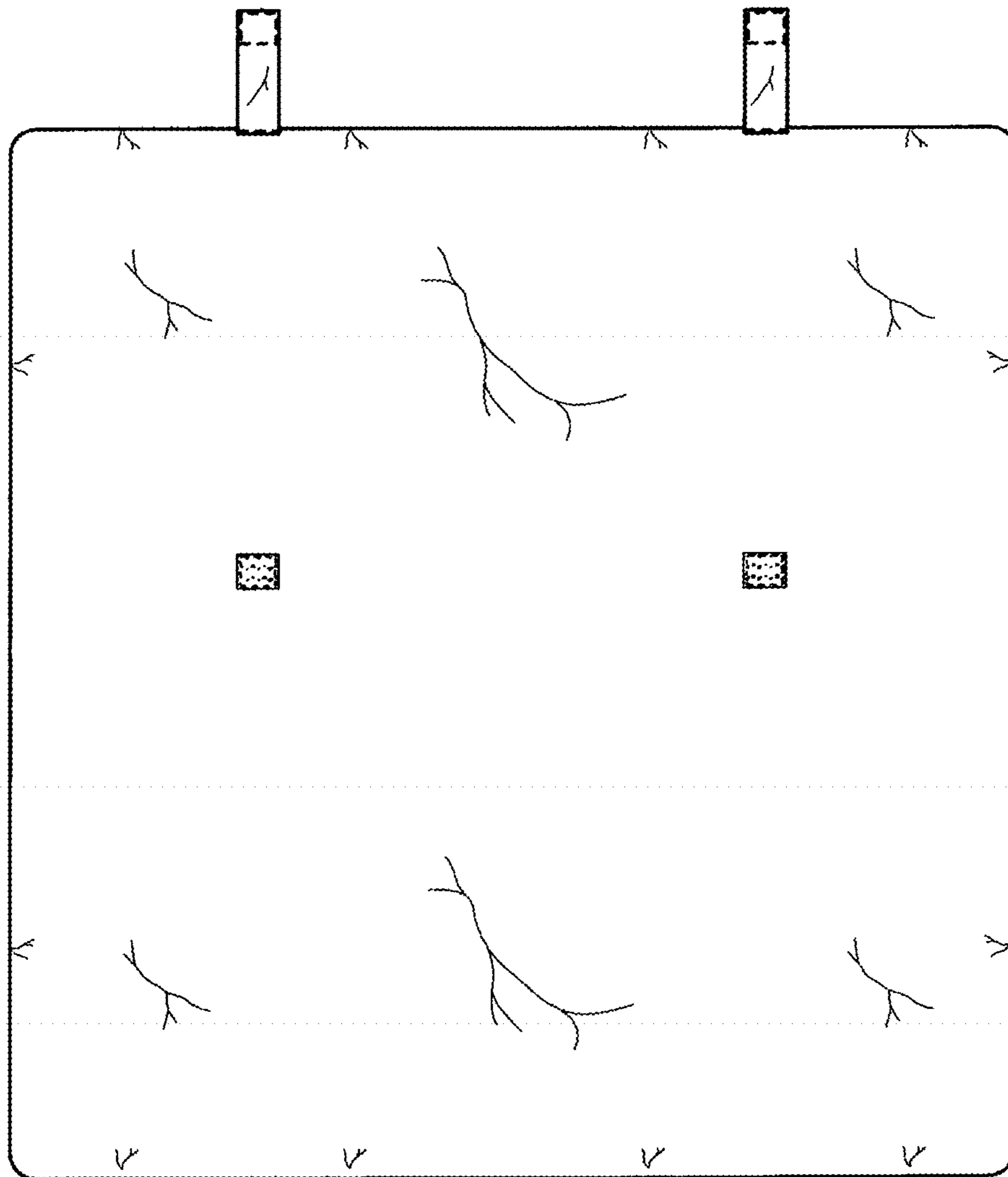

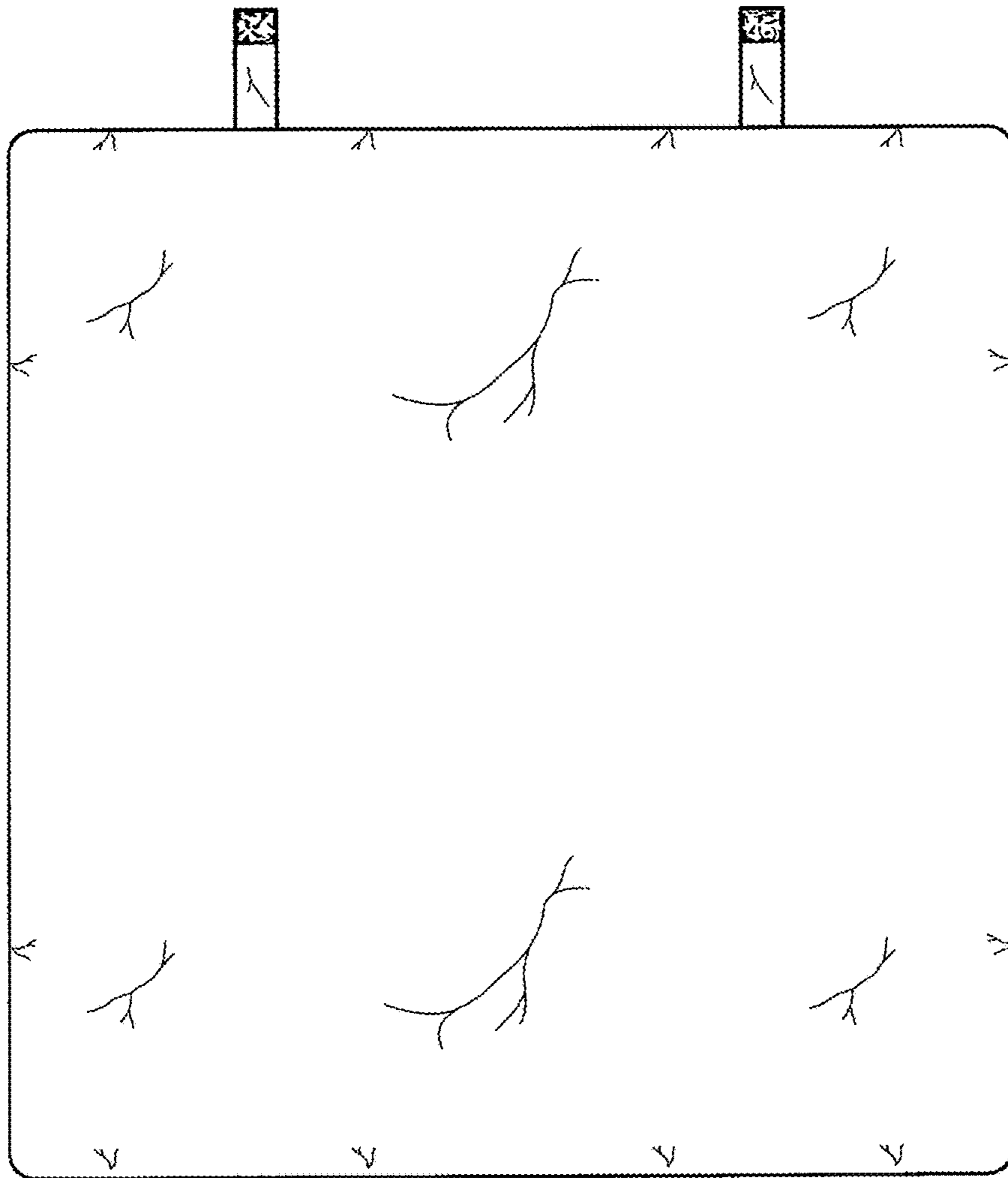

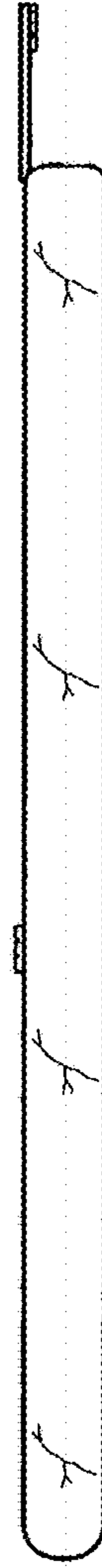

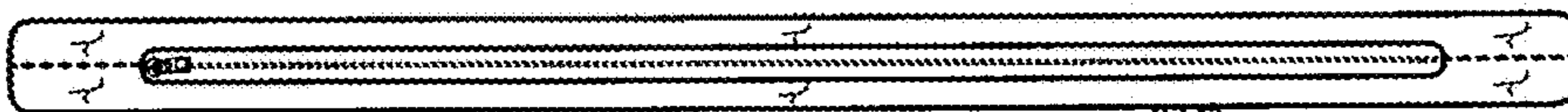
