(57) **CLAIM**

The ornamental design for a multi-tier heart shaped display case with a bite taken out of it, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a multi-tier heart shaped display case with a bite taken out of it, showing my new design with heart and circular shaped features forming no part of the claimed design;

FIG. 2 is a perspective view of the design of FIG. 1, with circular shaped features as well as a curved elongated feature forming no part of the claimed design; and,

FIG. 3 is a side view of the design of FIG. 1, showing raised heart shaped features which form no part of the claimed design.

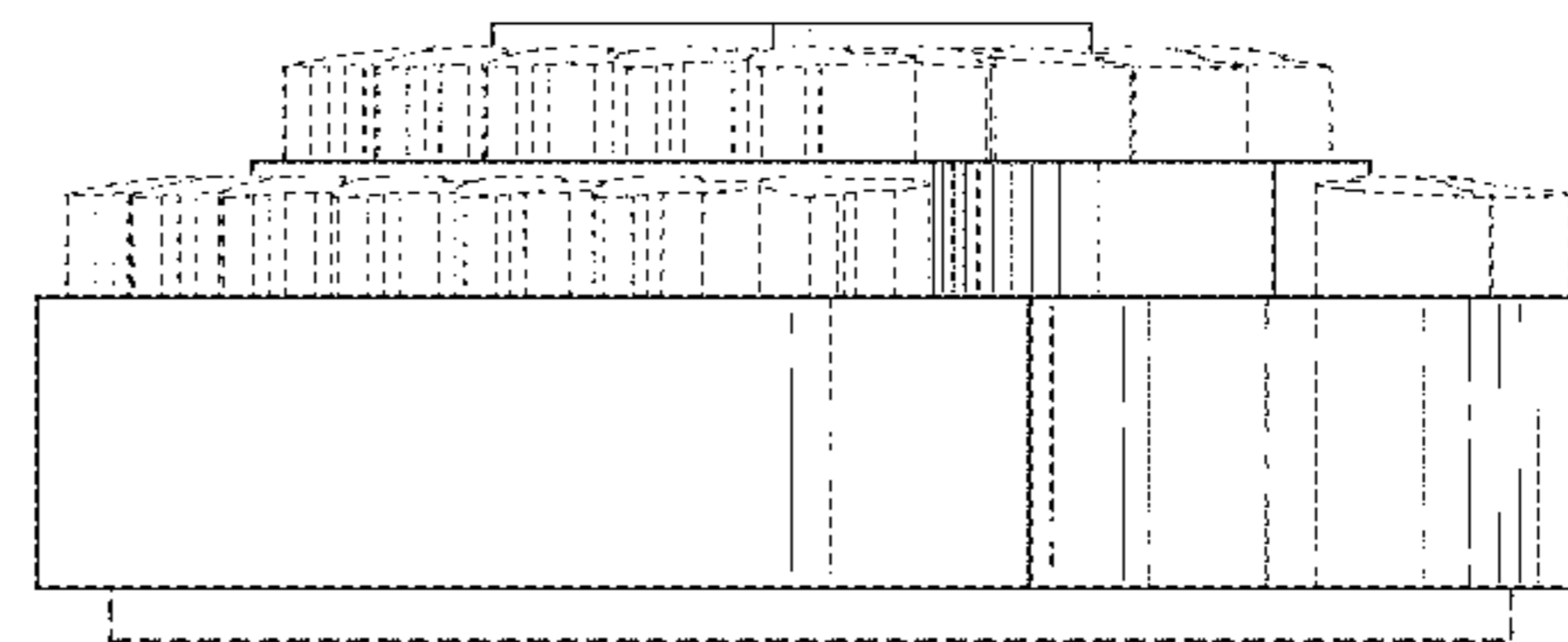
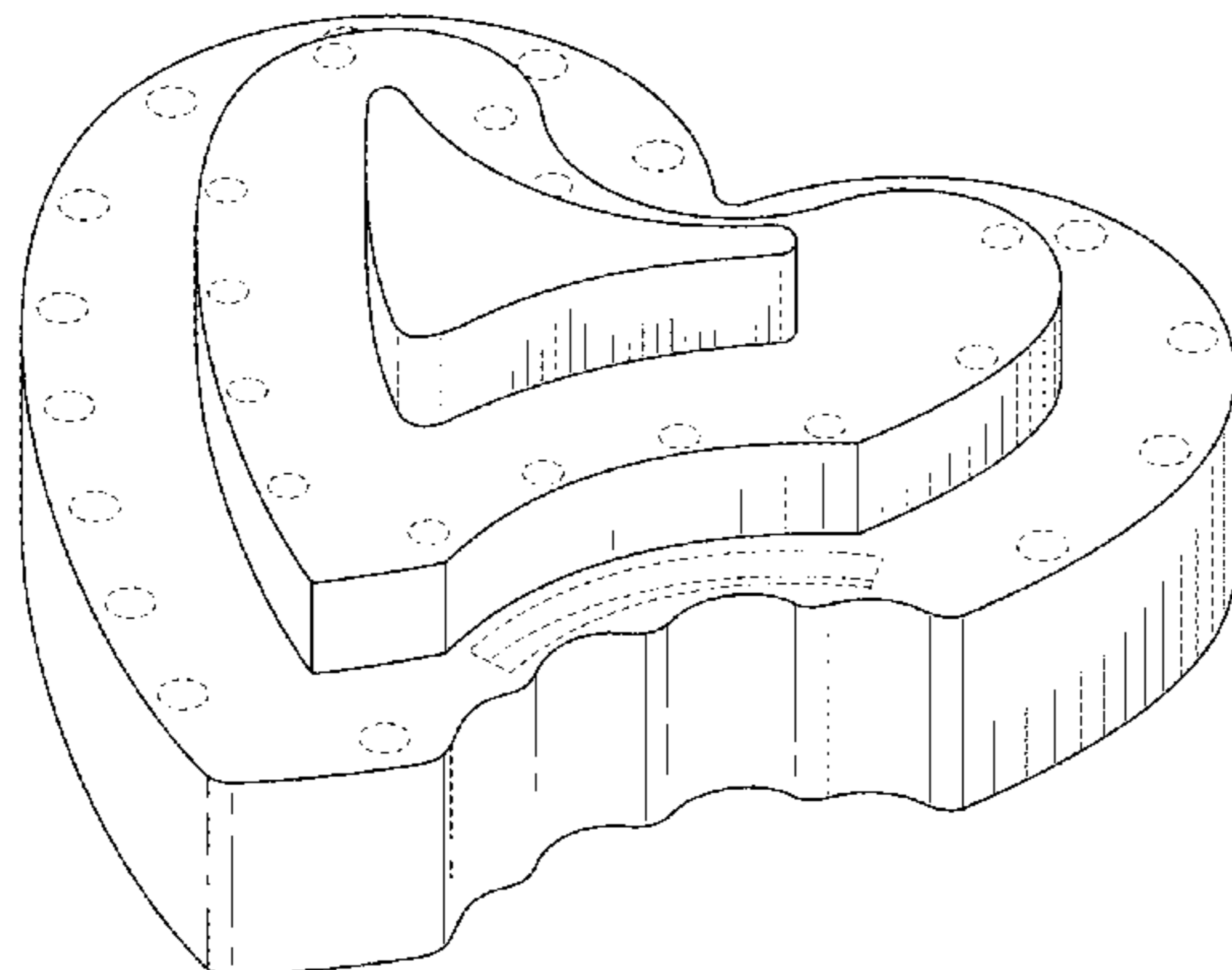

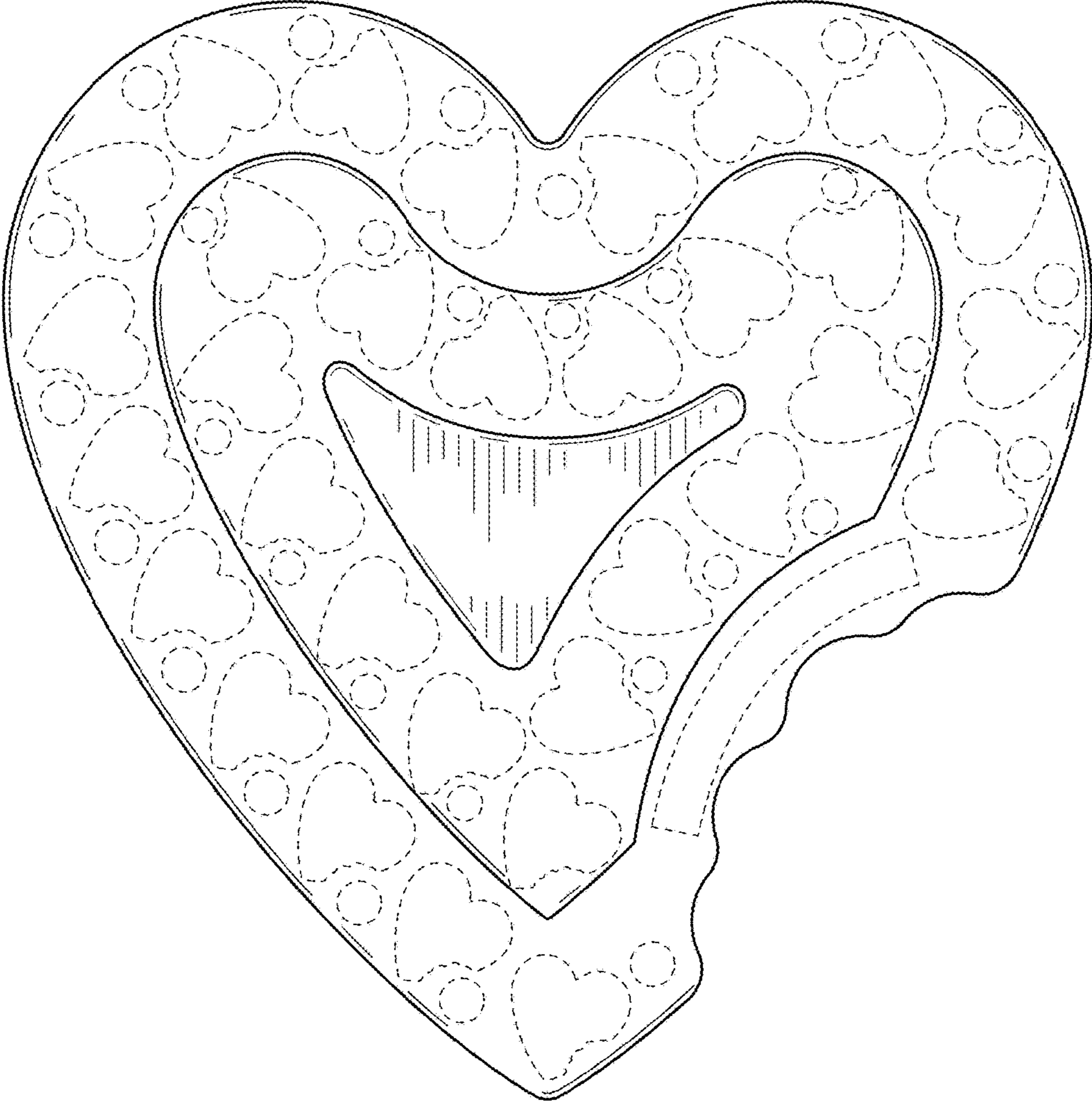

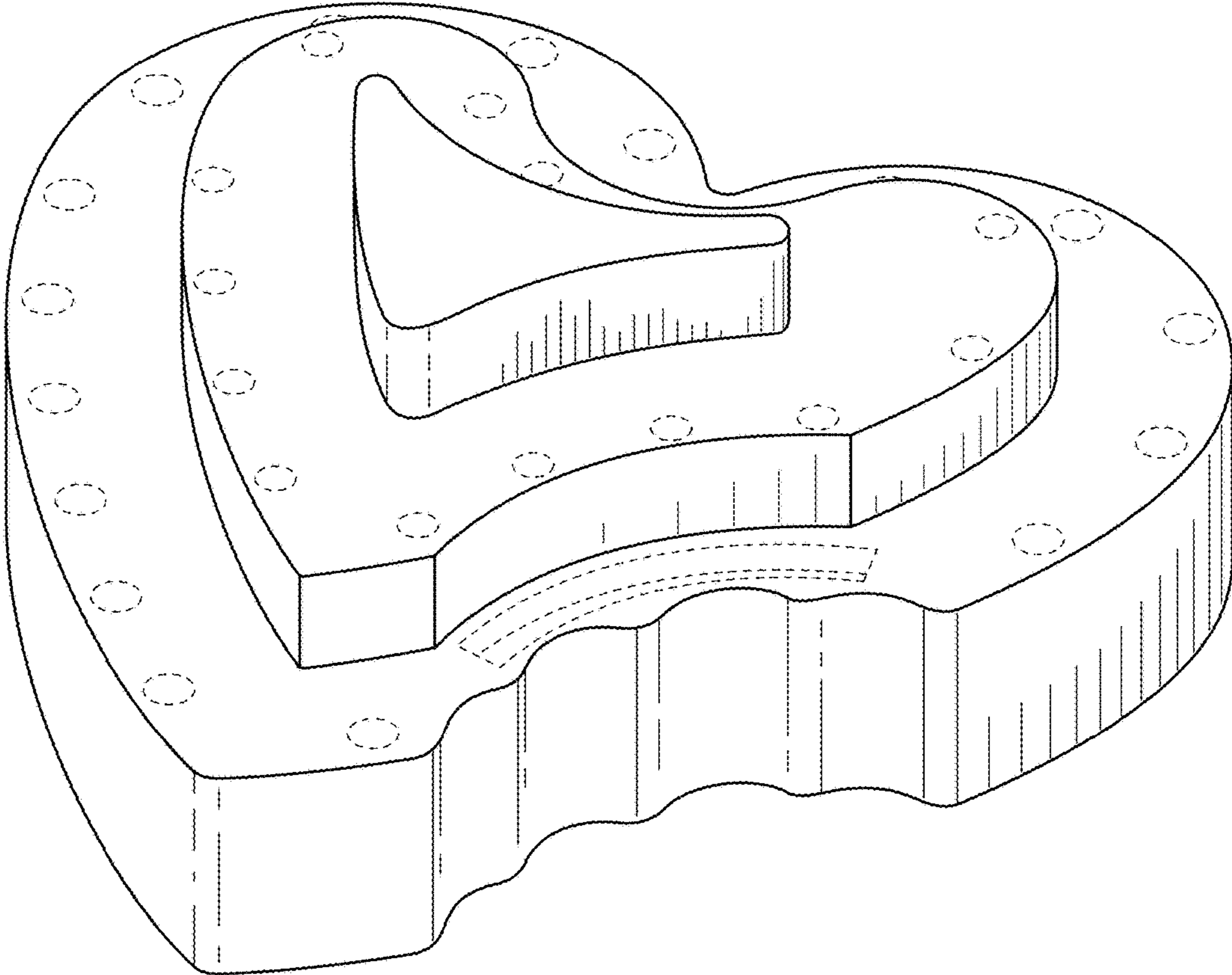

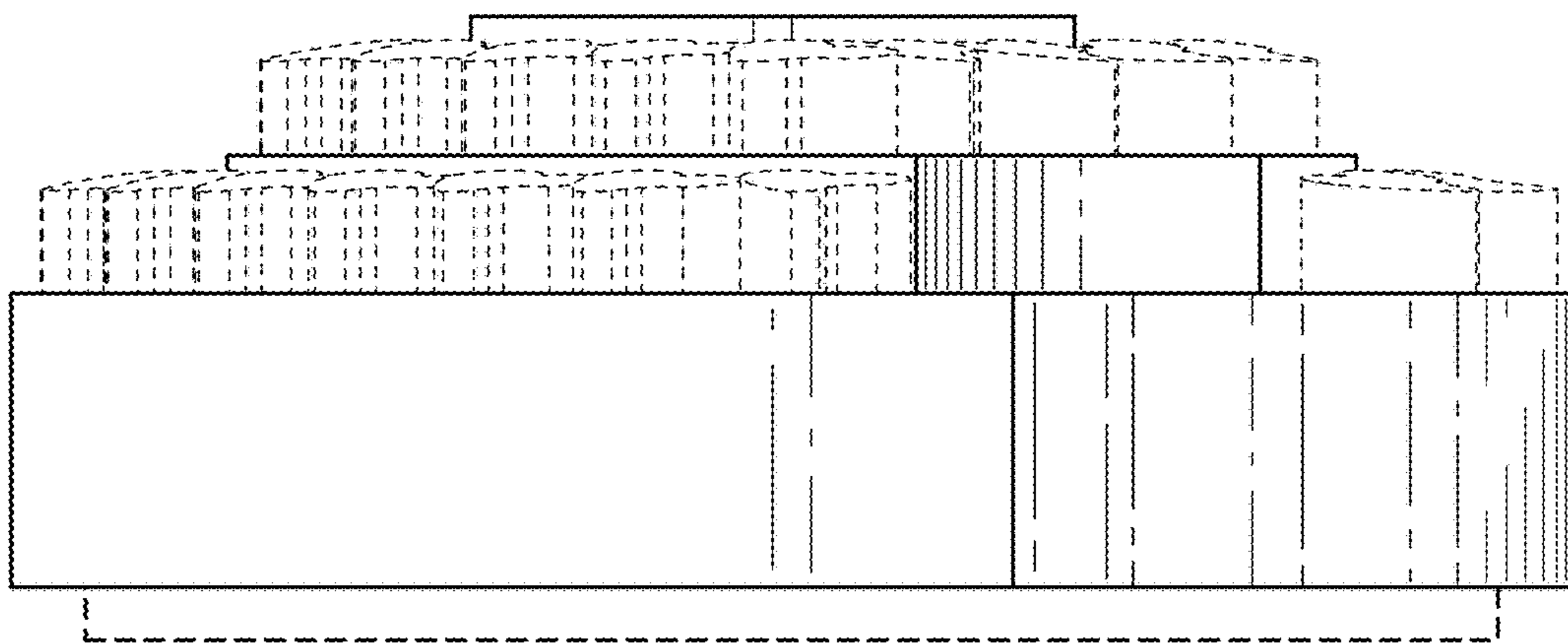
