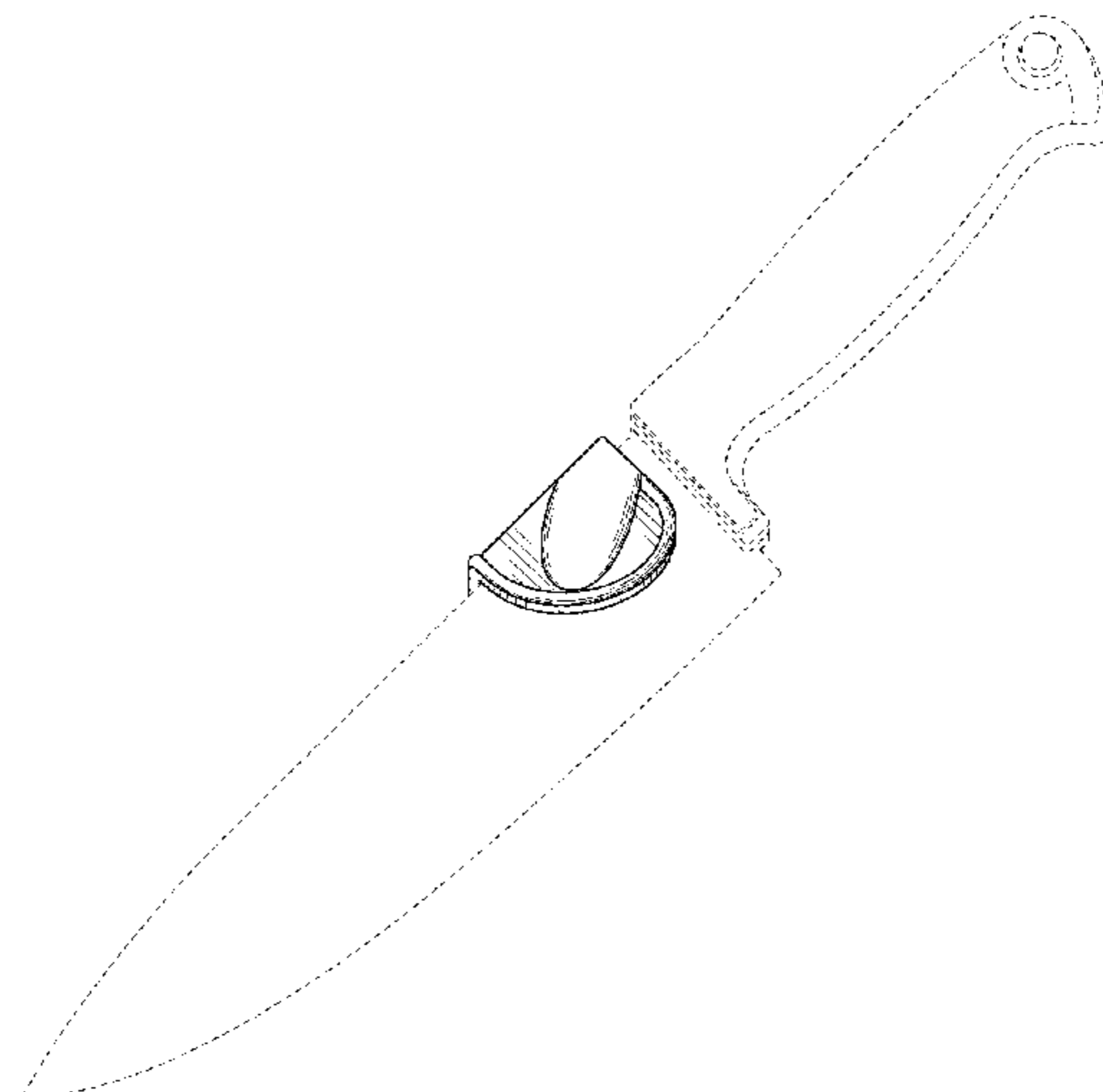
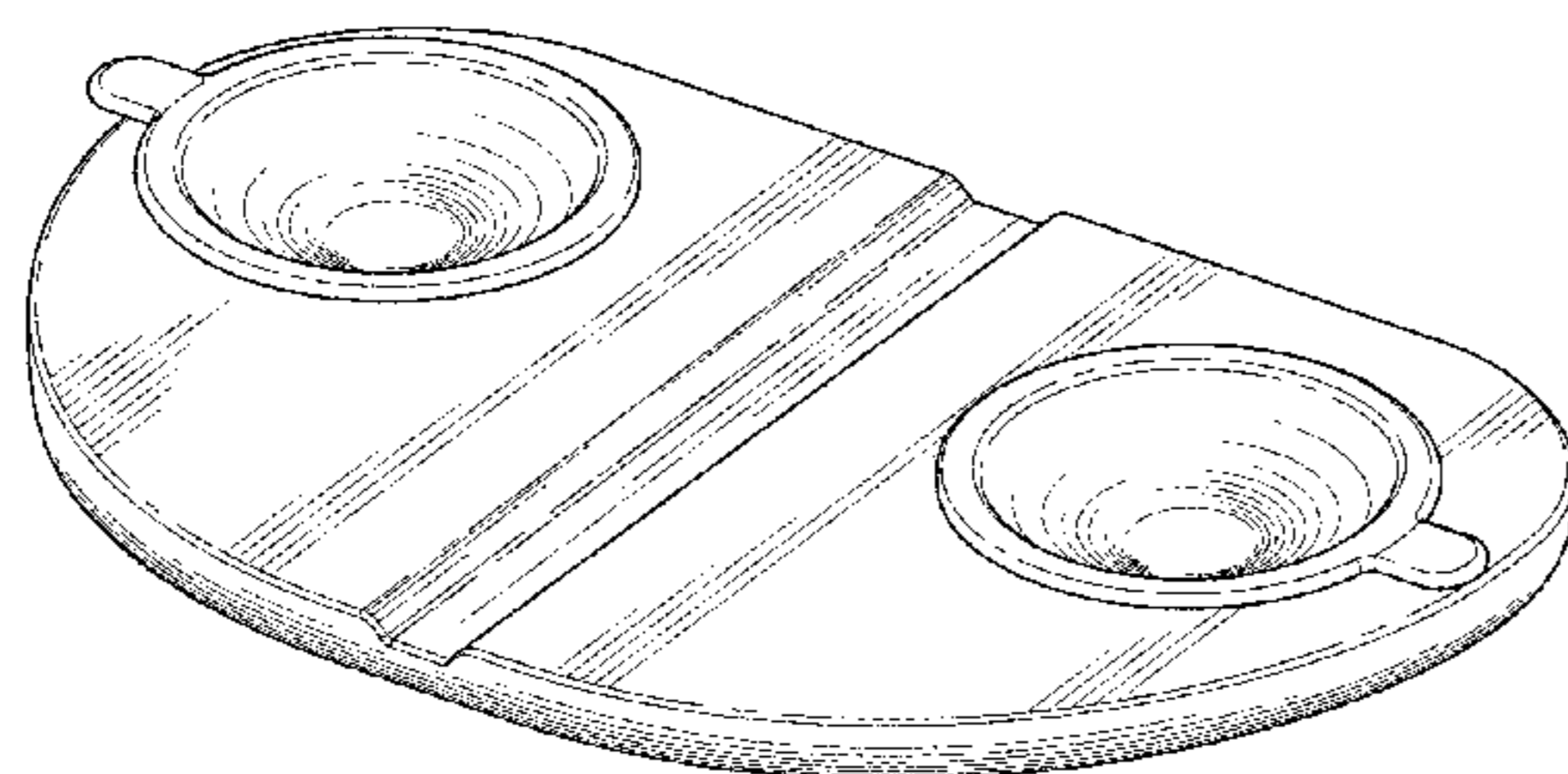
The ornamental design for a knife comfort grip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a knife comfort grip in accordance with the invention;

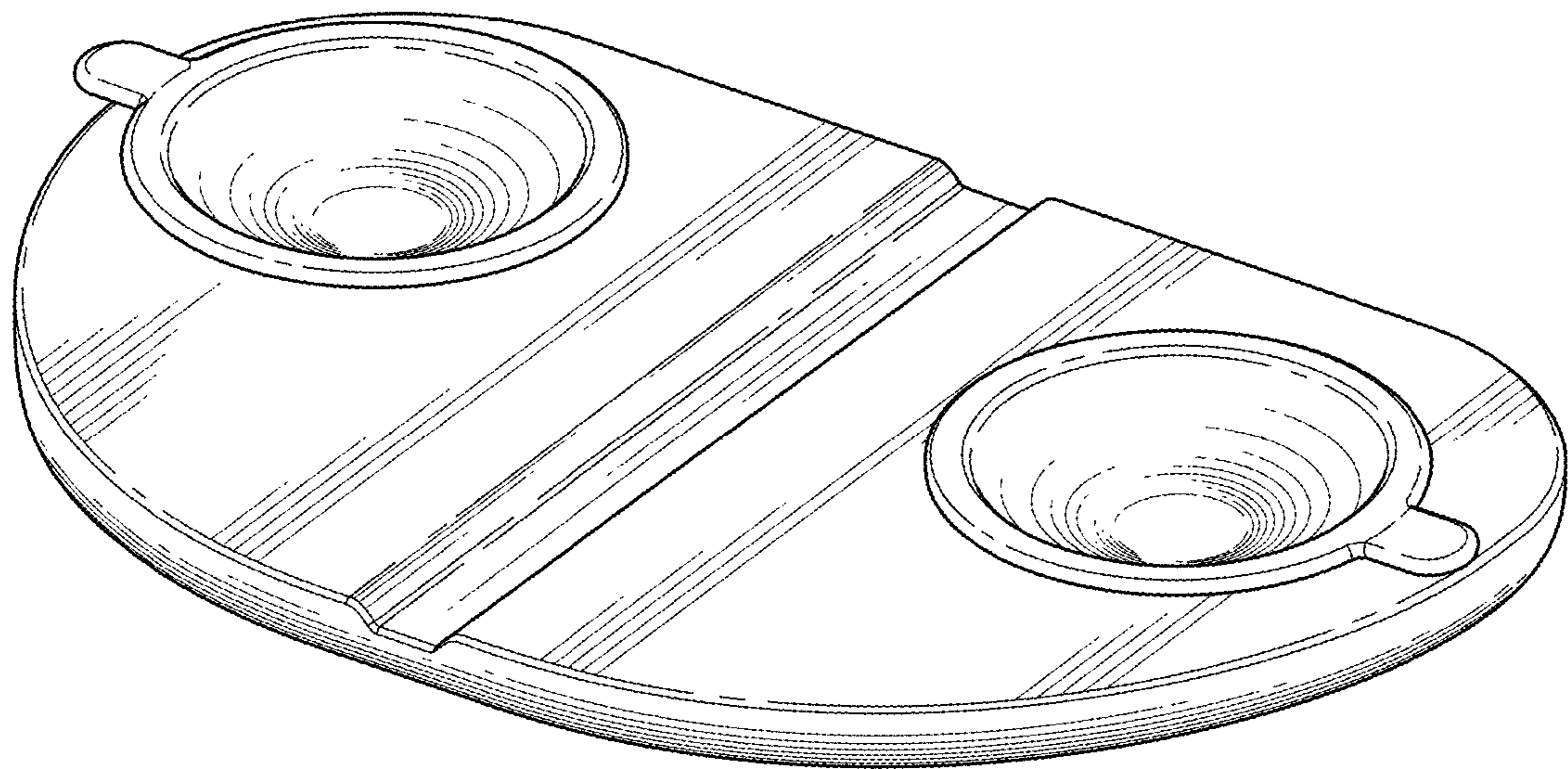

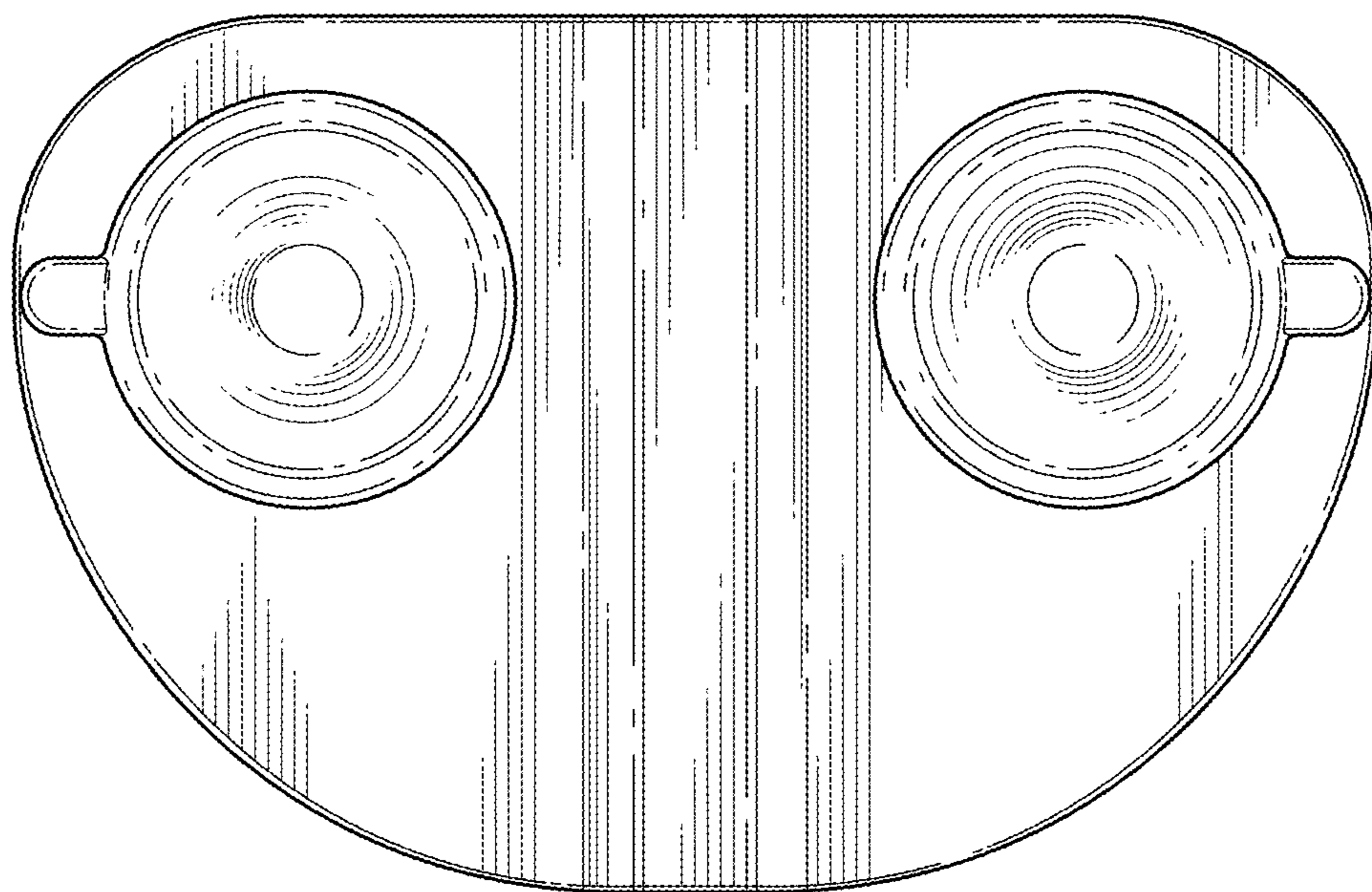

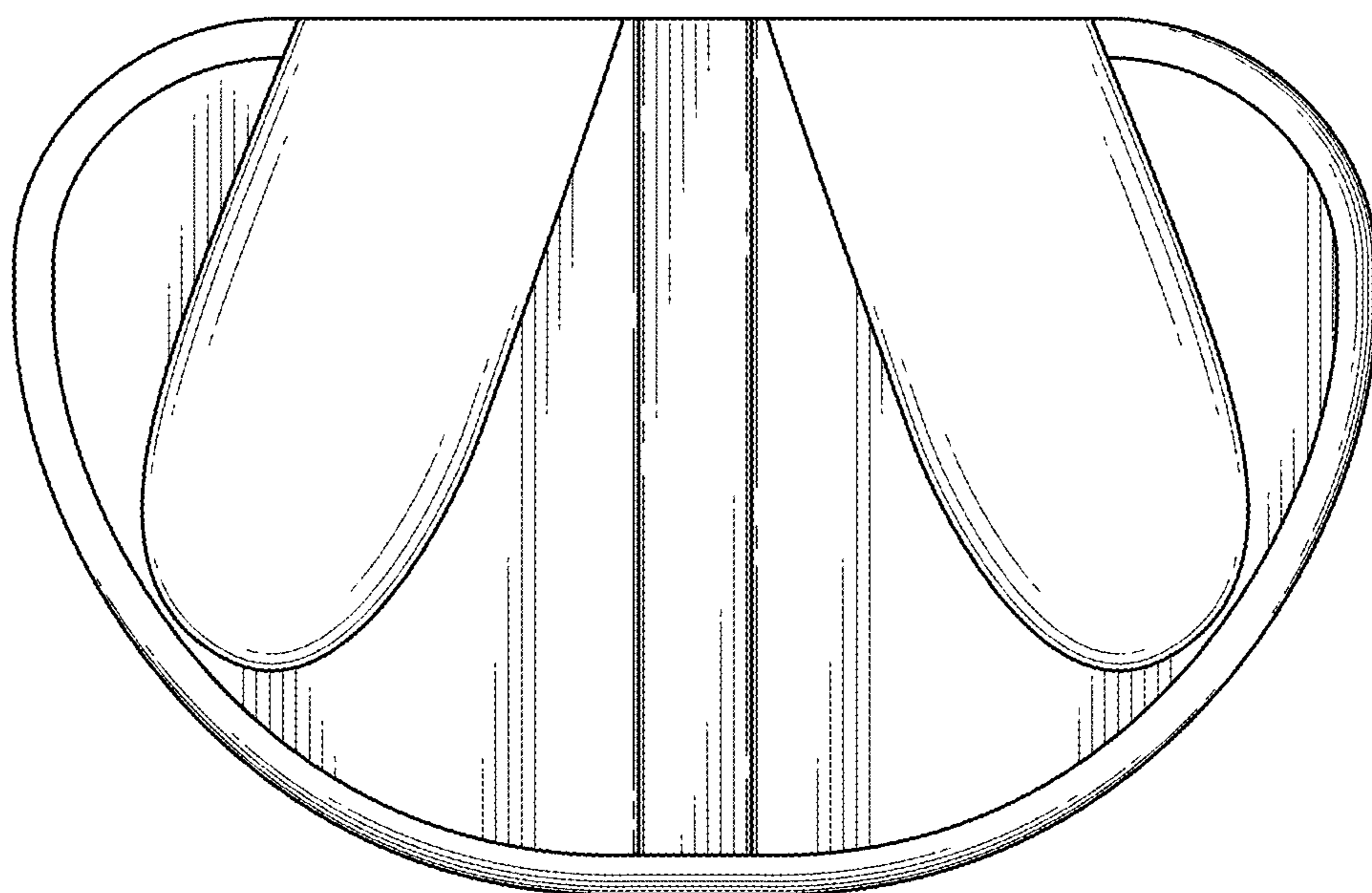

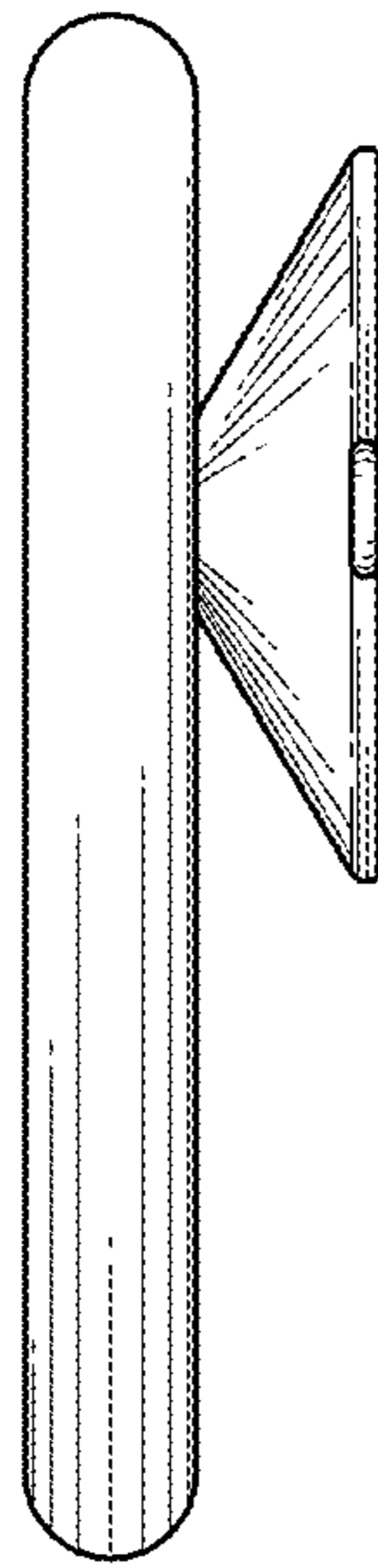

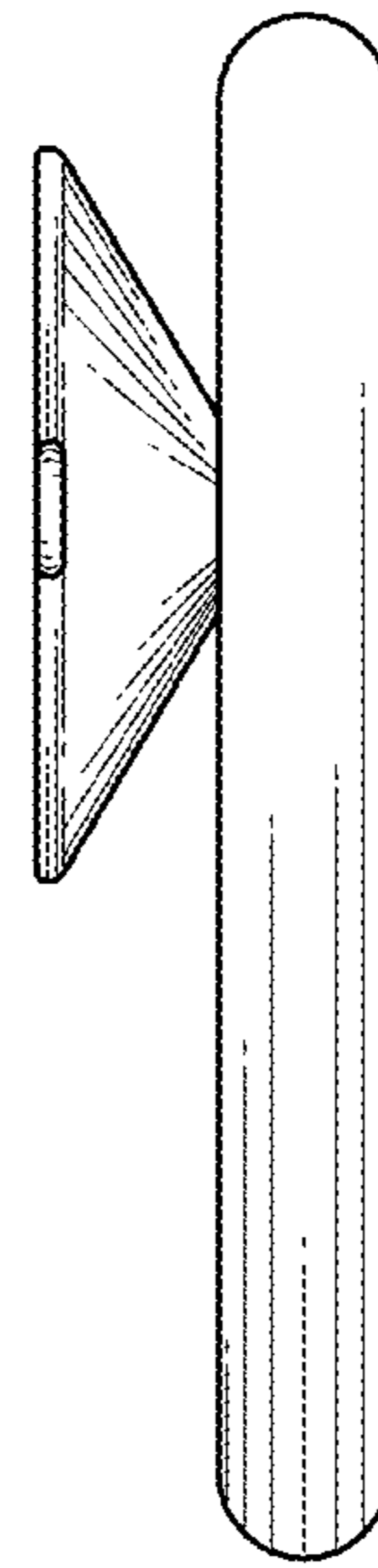

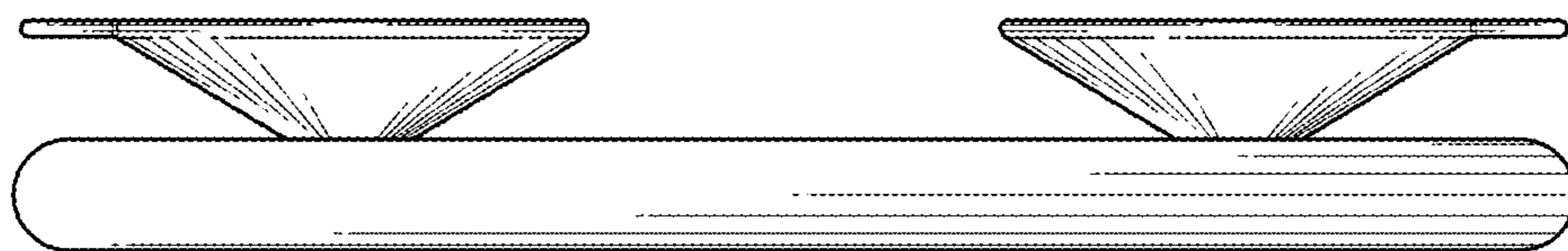

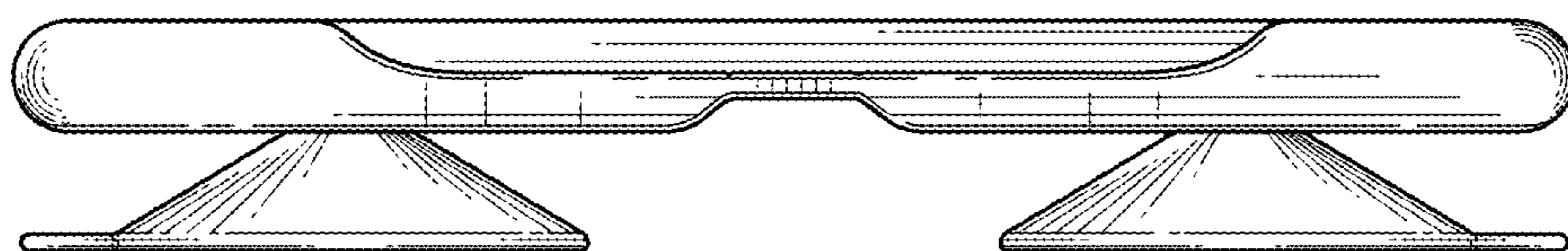

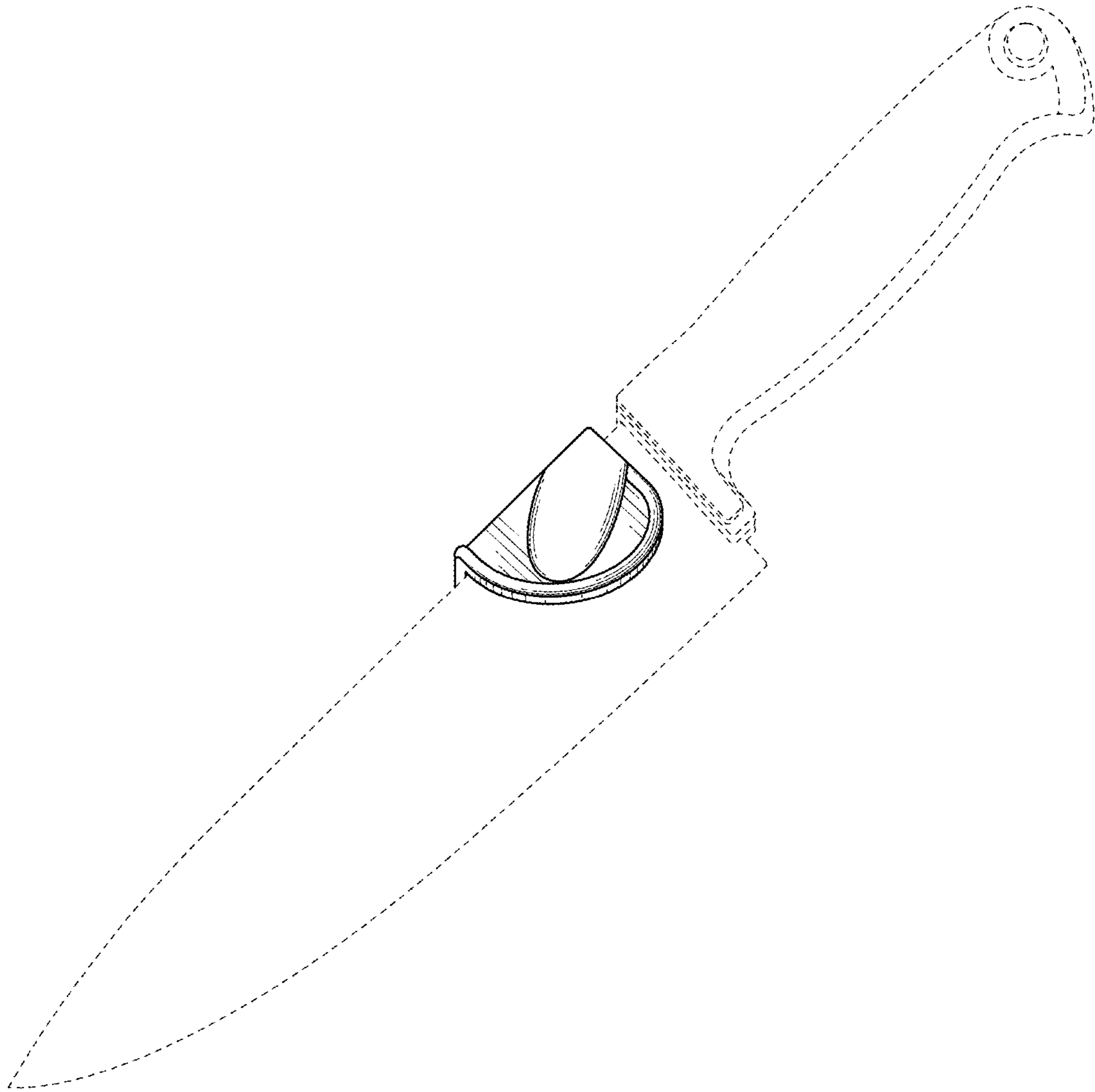
