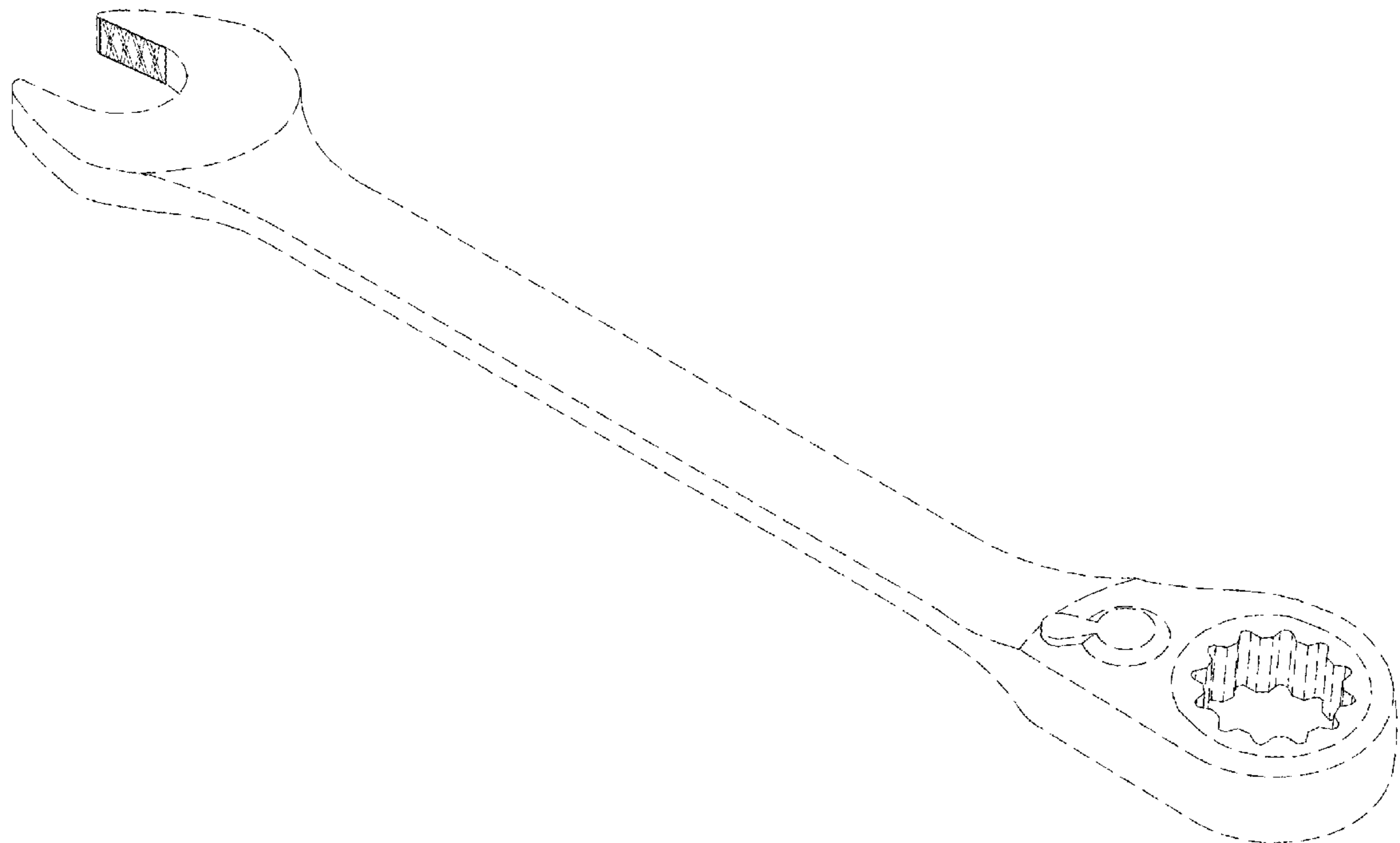

The ornamental design for a wrench, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a wrench;
 FIG. 2 is a front view of FIG. 1;
 FIG. 3 is a partially sectional view taken along line 3-3 of FIG. 2 showing the design for the wrench of FIG. 1;
 FIG. 4 is a partially sectional view taken along line 4-4 of FIG. 2 showing the design for the wrench of FIG. 1;
 FIG. 5 is a partially enlarged perspective view showing the design for the wrench of FIG. 1;
 FIG. 6 is a perspective view of a second embodiment of a wrench;
 FIG. 7 is a front view of FIG. 6;
 FIG. 8 is a partially sectional view taken along line 8-8 of FIG. 7 showing the design for the wrench of FIG. 6;
 FIG. 9 is a partially sectional view taken along line 9-9 of FIG. 7 showing the design for the wrench of FIG. 6; and,
 FIG. 10 is a partially enlarged perspective view showing the design for the wrench of FIG. 6.
 The broken lines depict portions of the wrench that form no part of the claimed design.

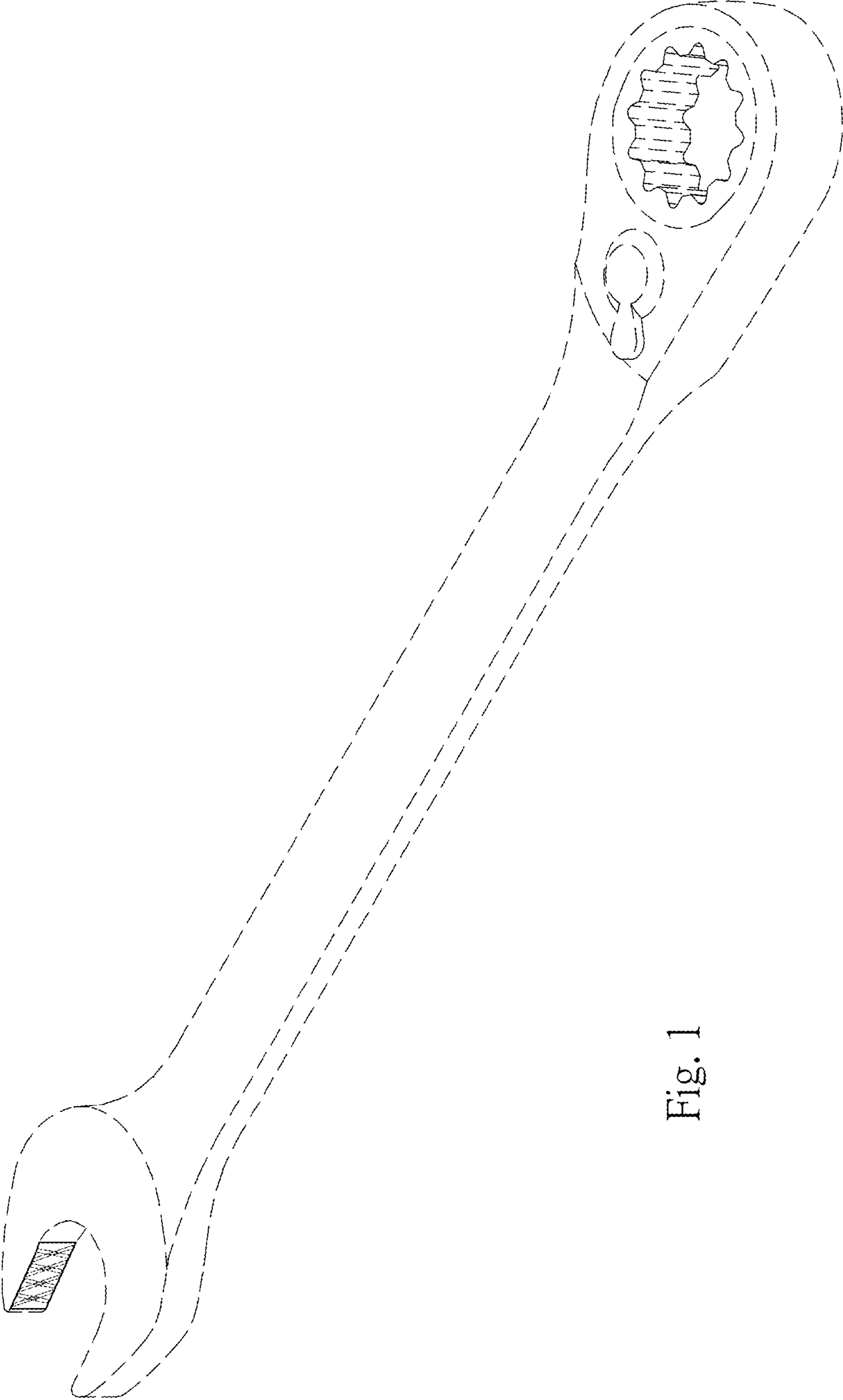

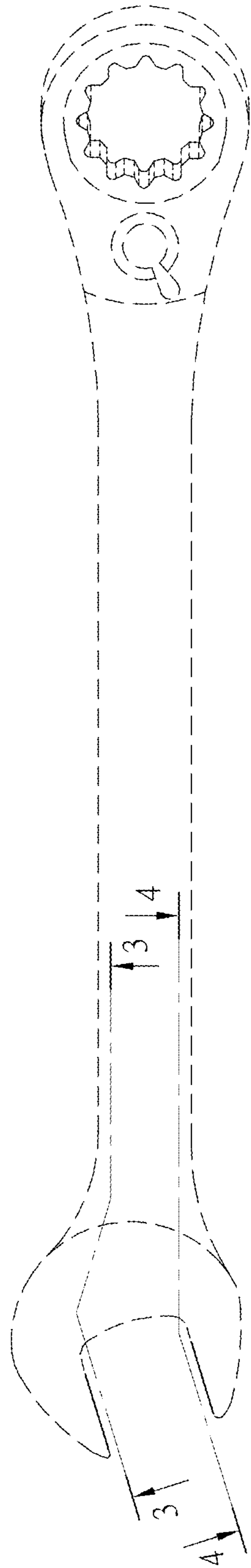

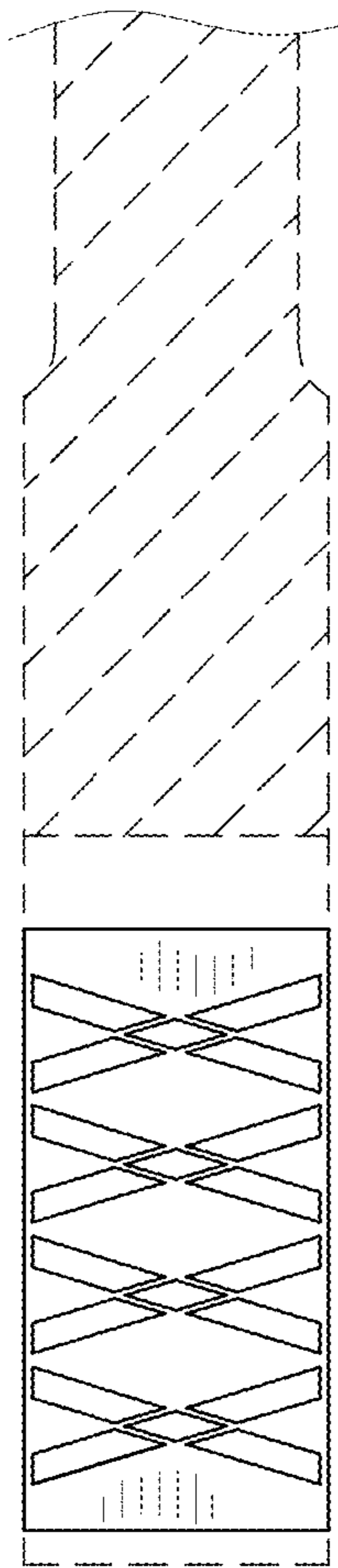

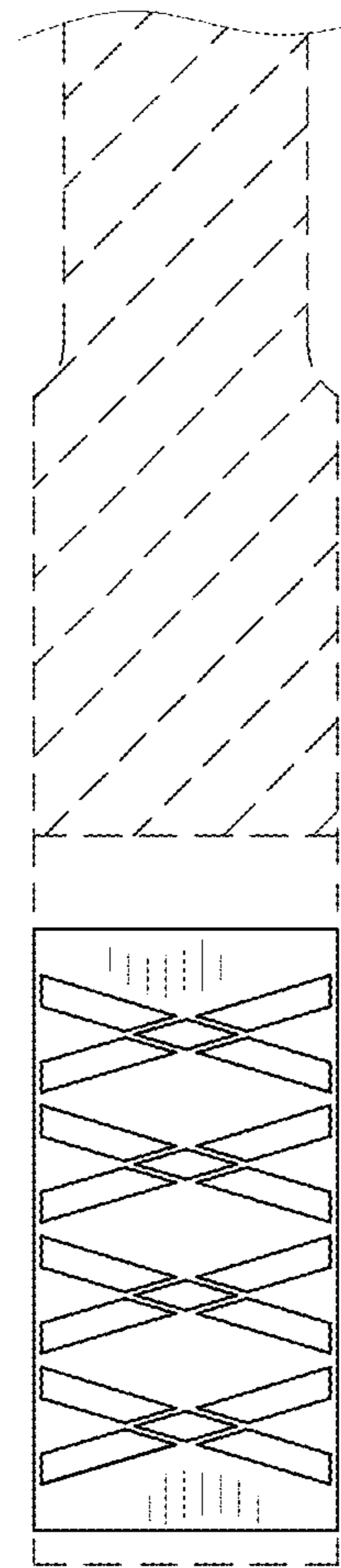

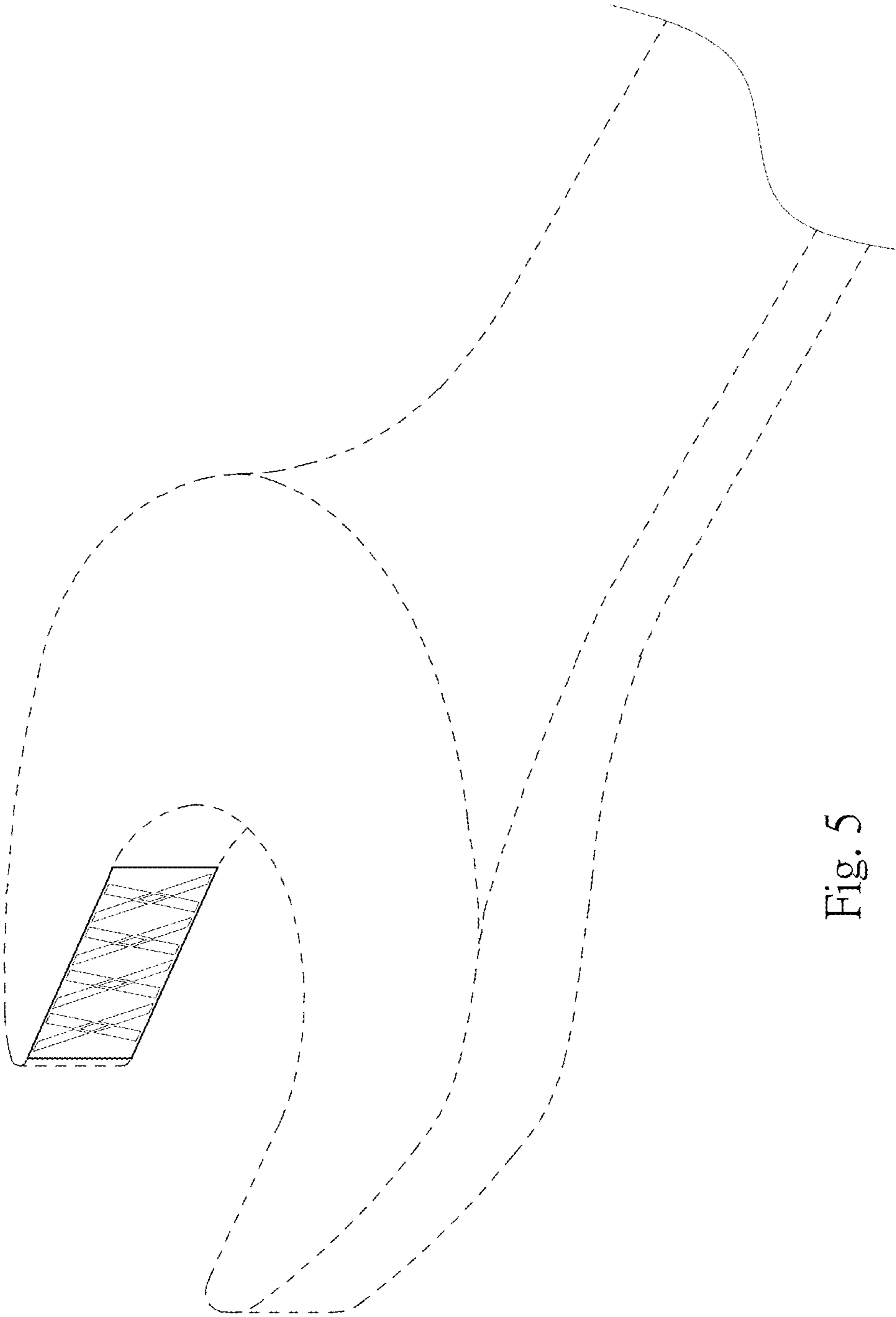

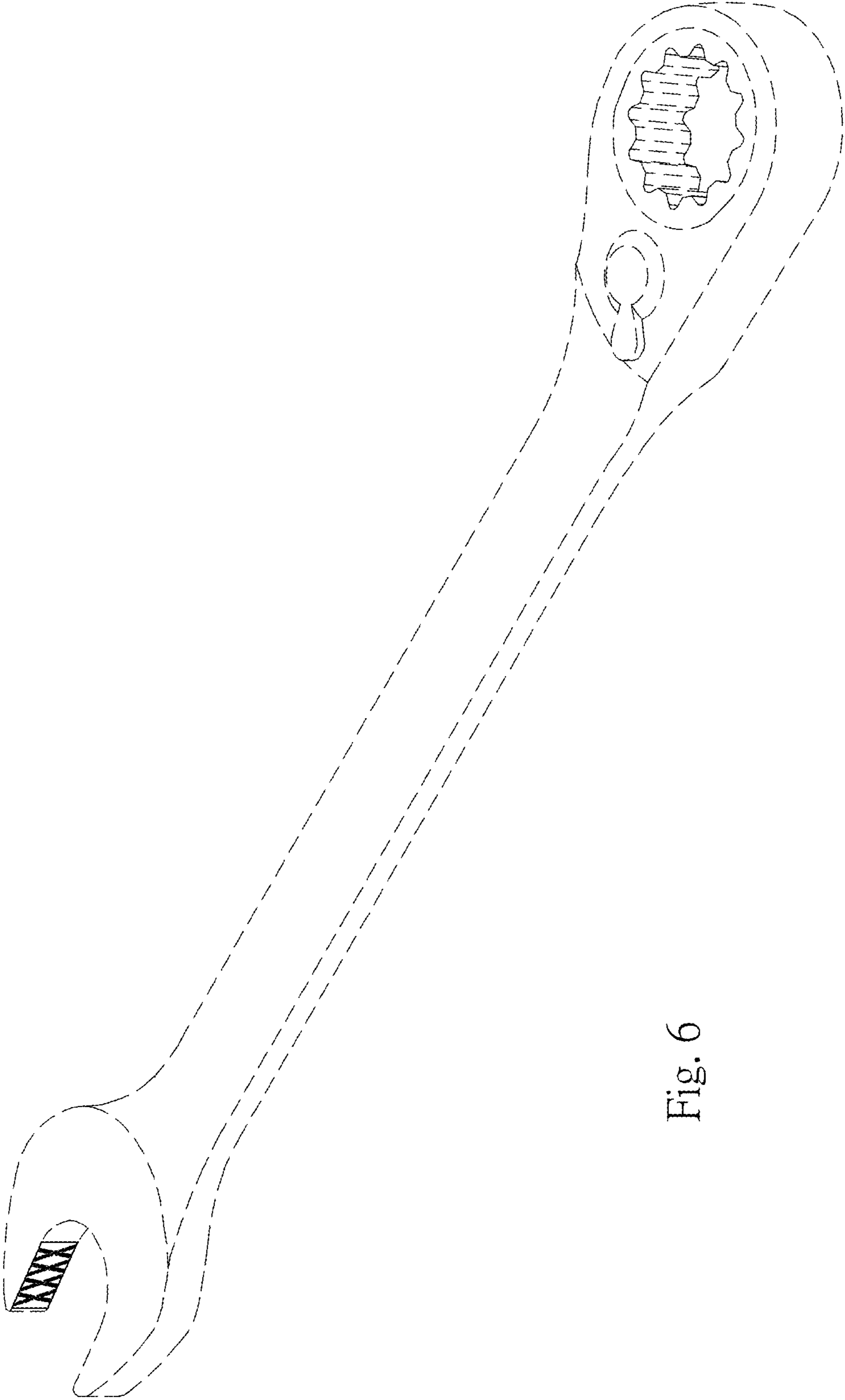

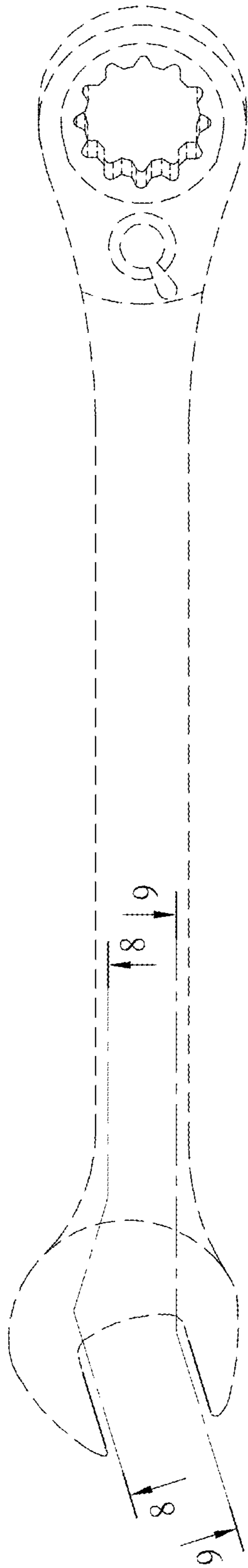

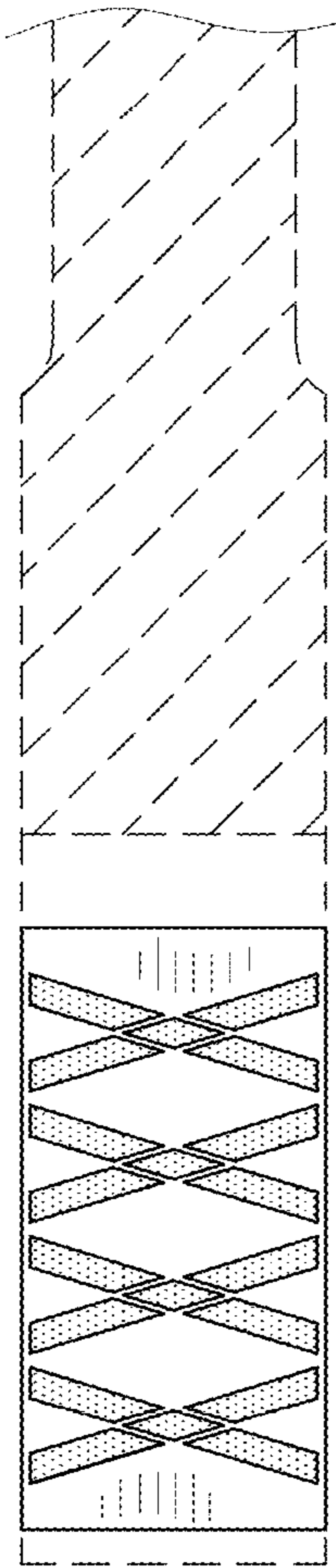

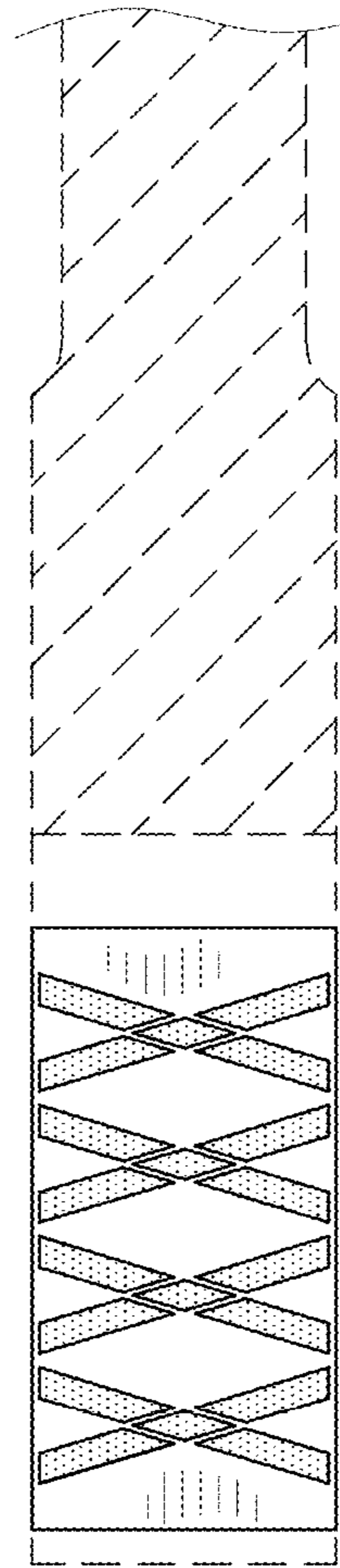

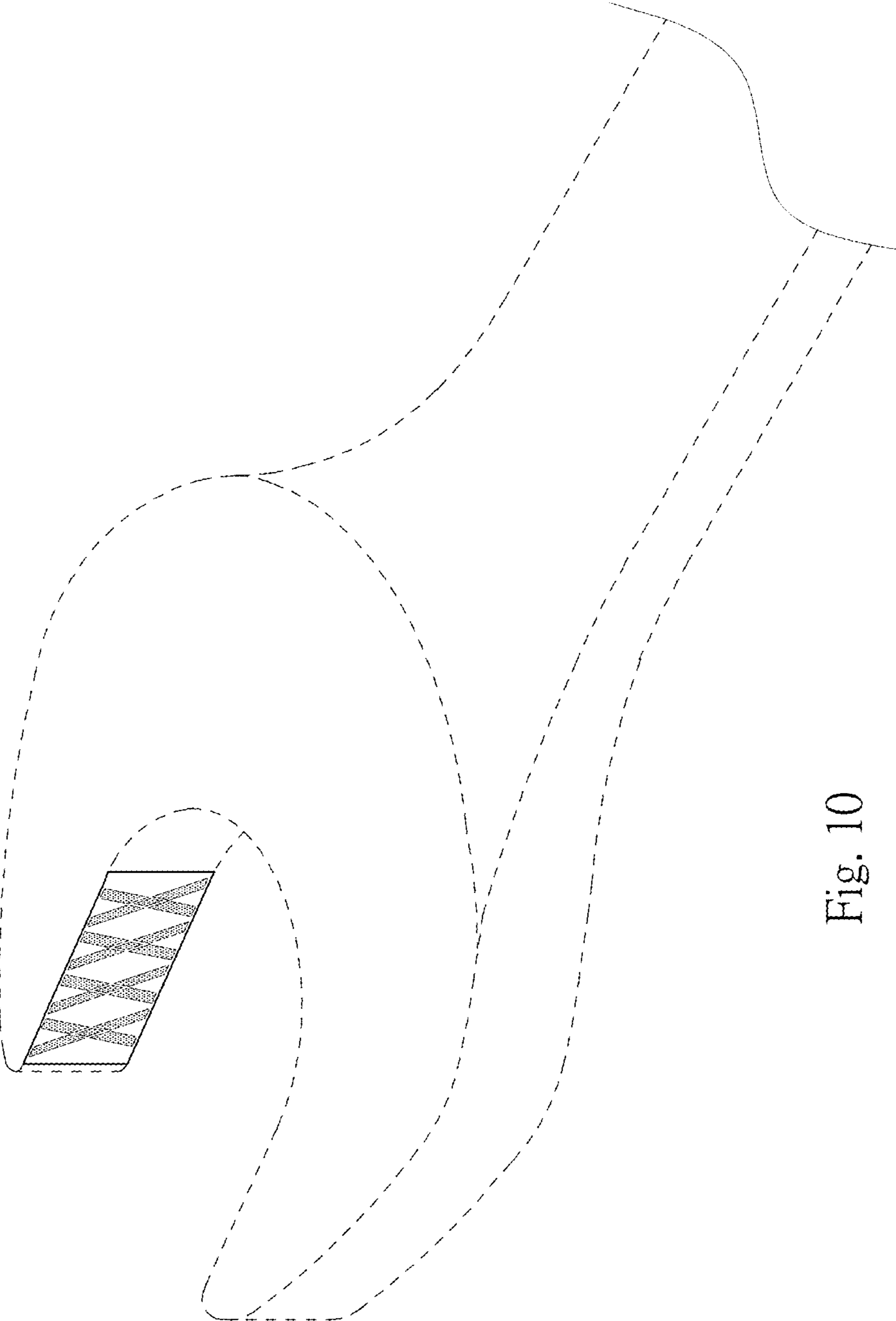
