8;

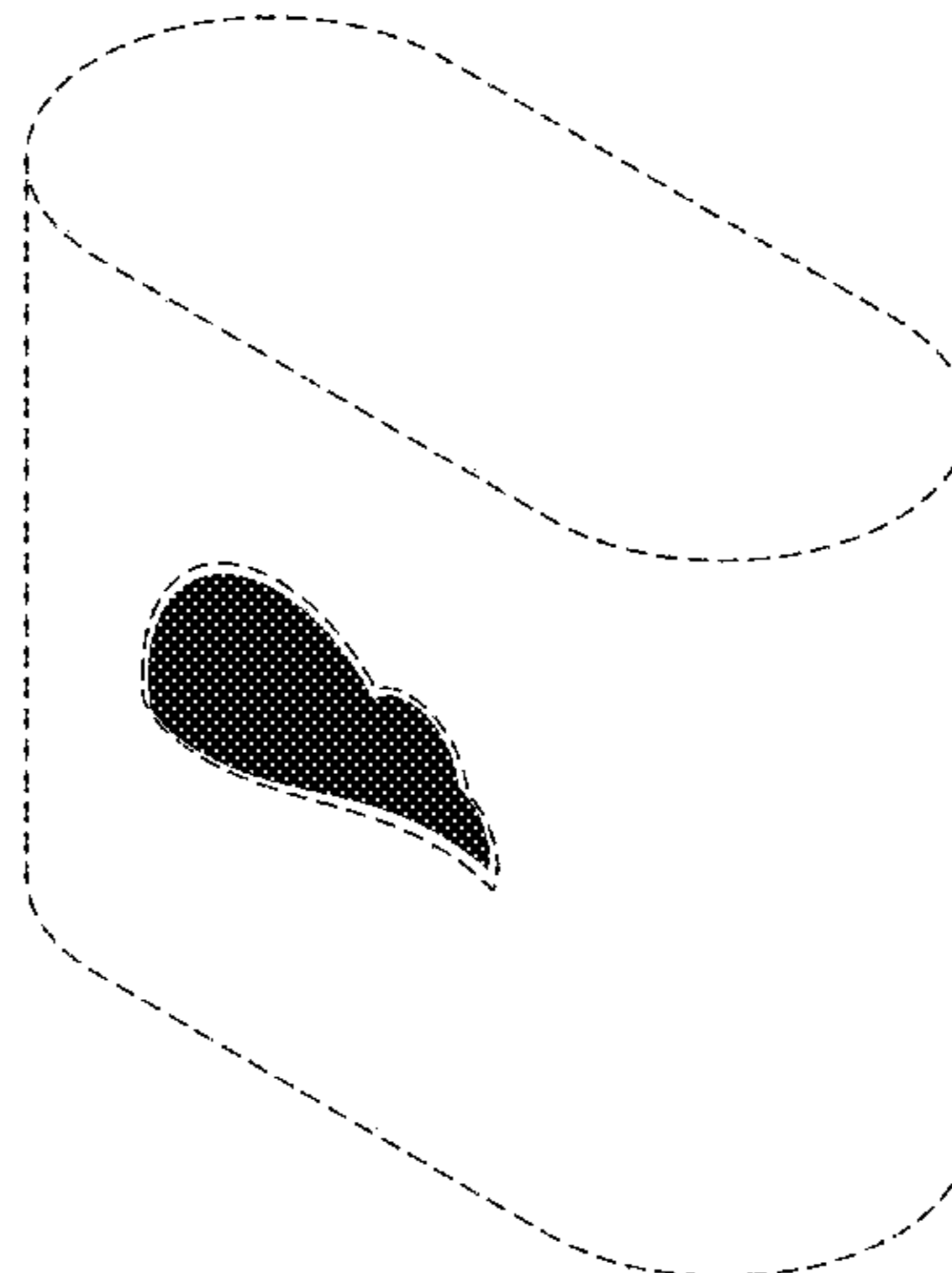
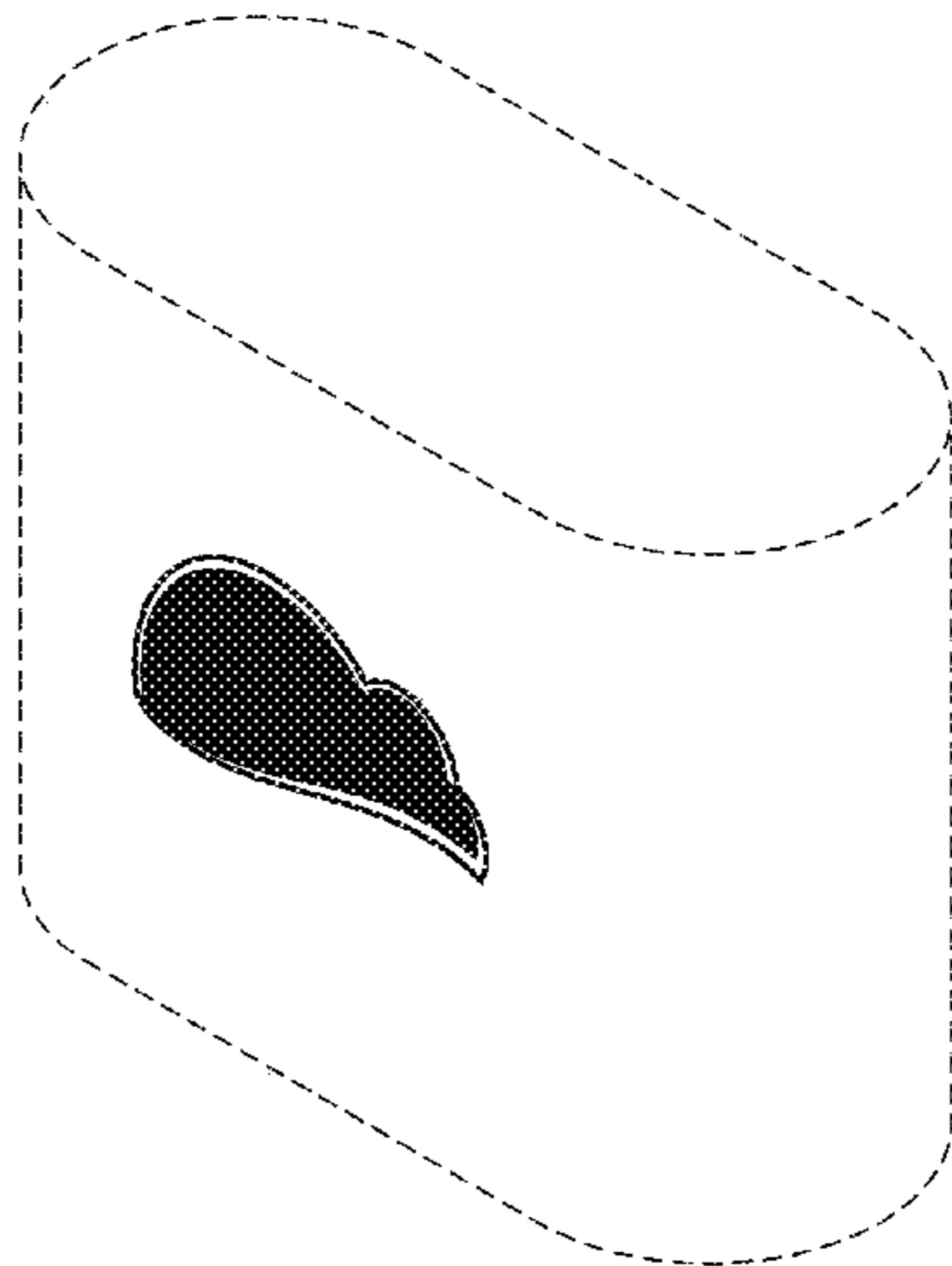
FIG. 12 is a right-side elevational view of the package of

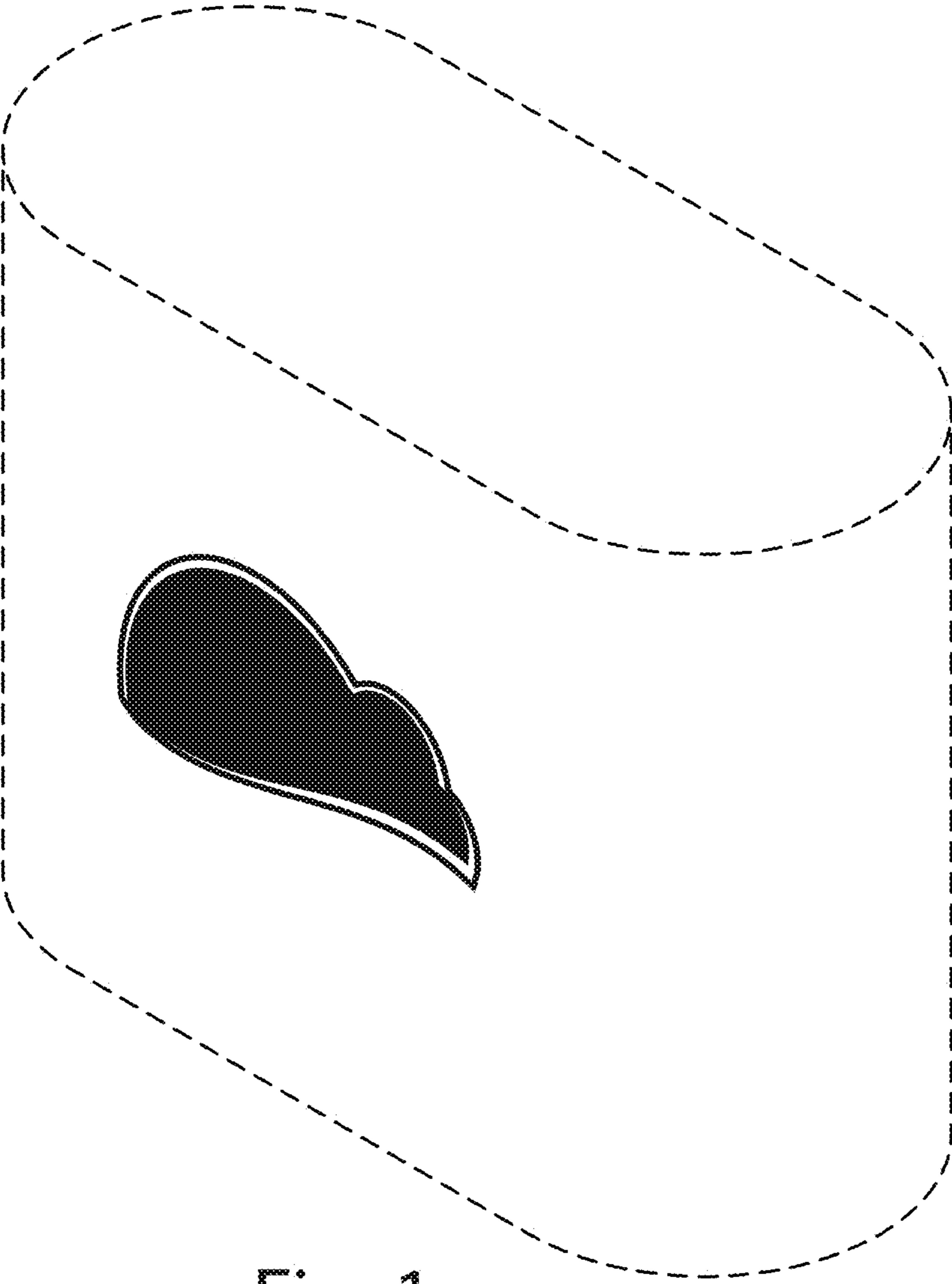

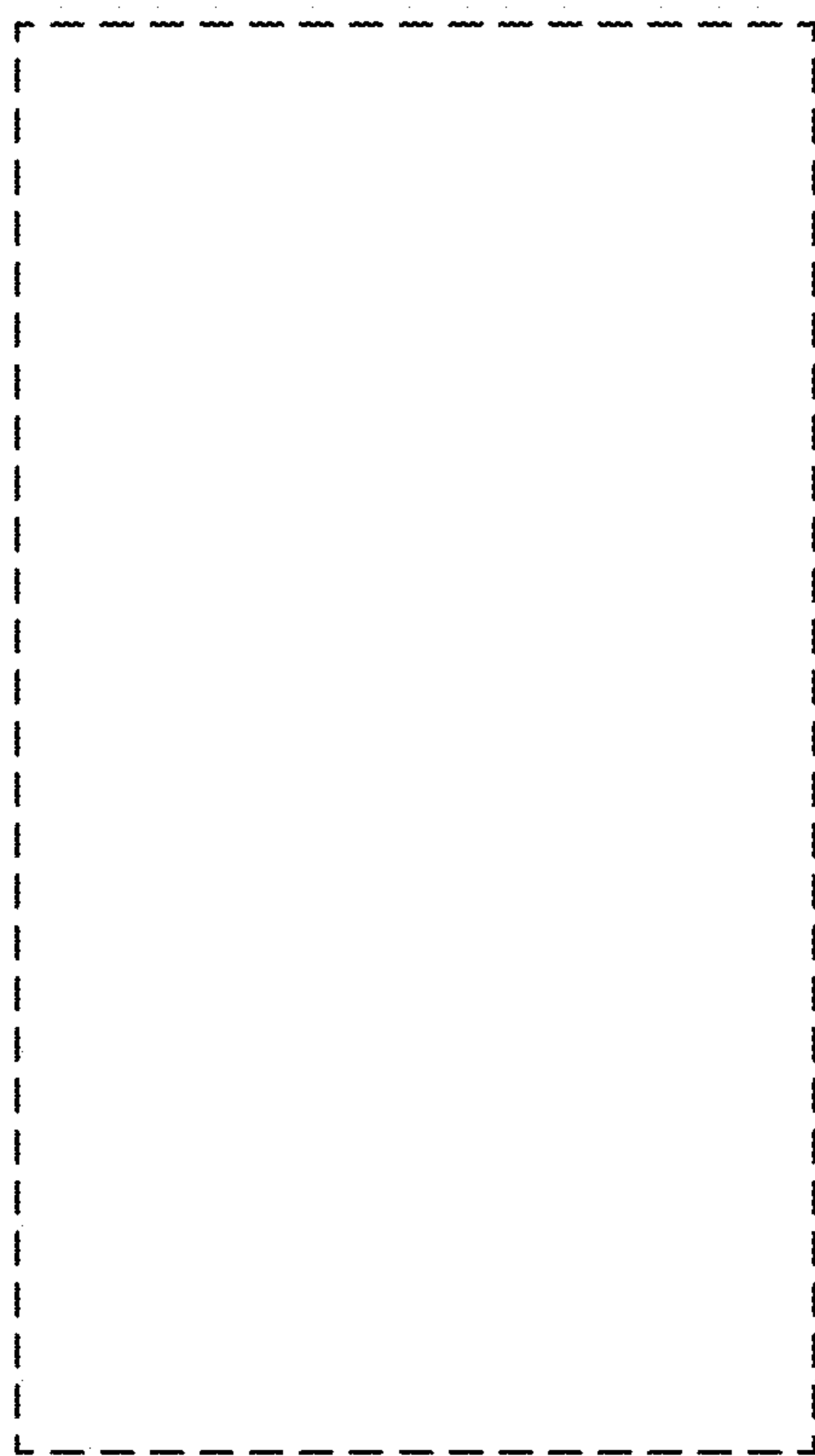

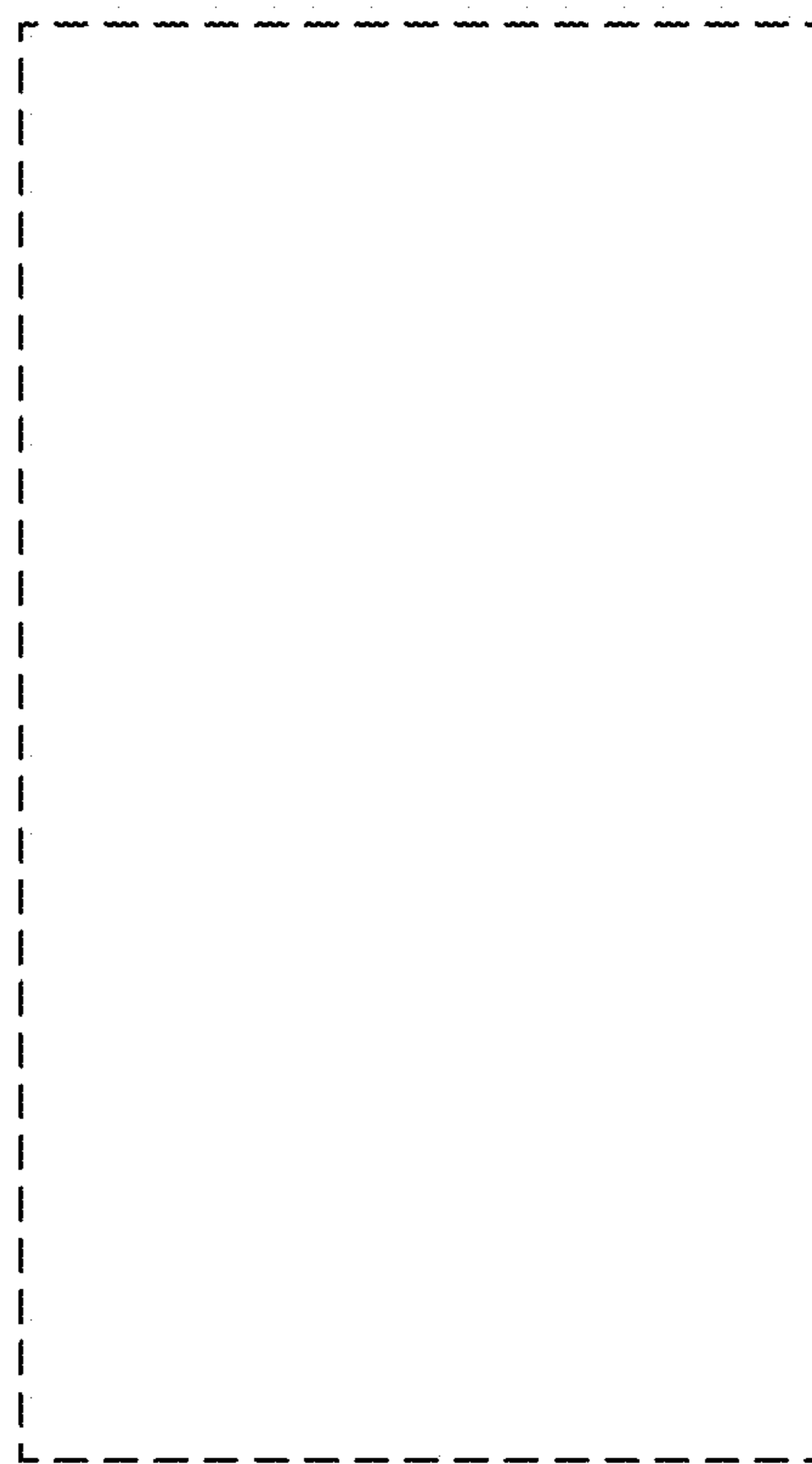

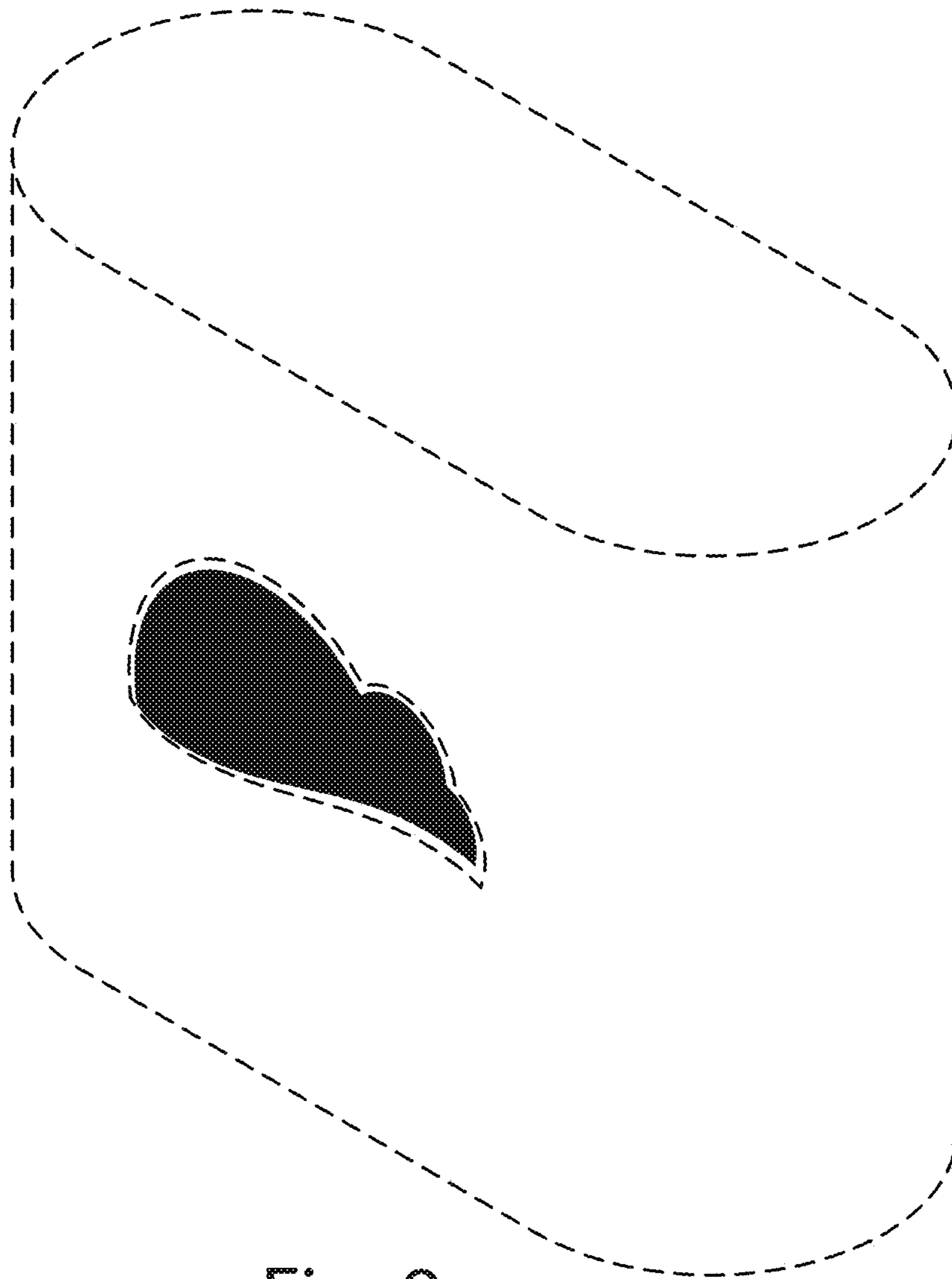

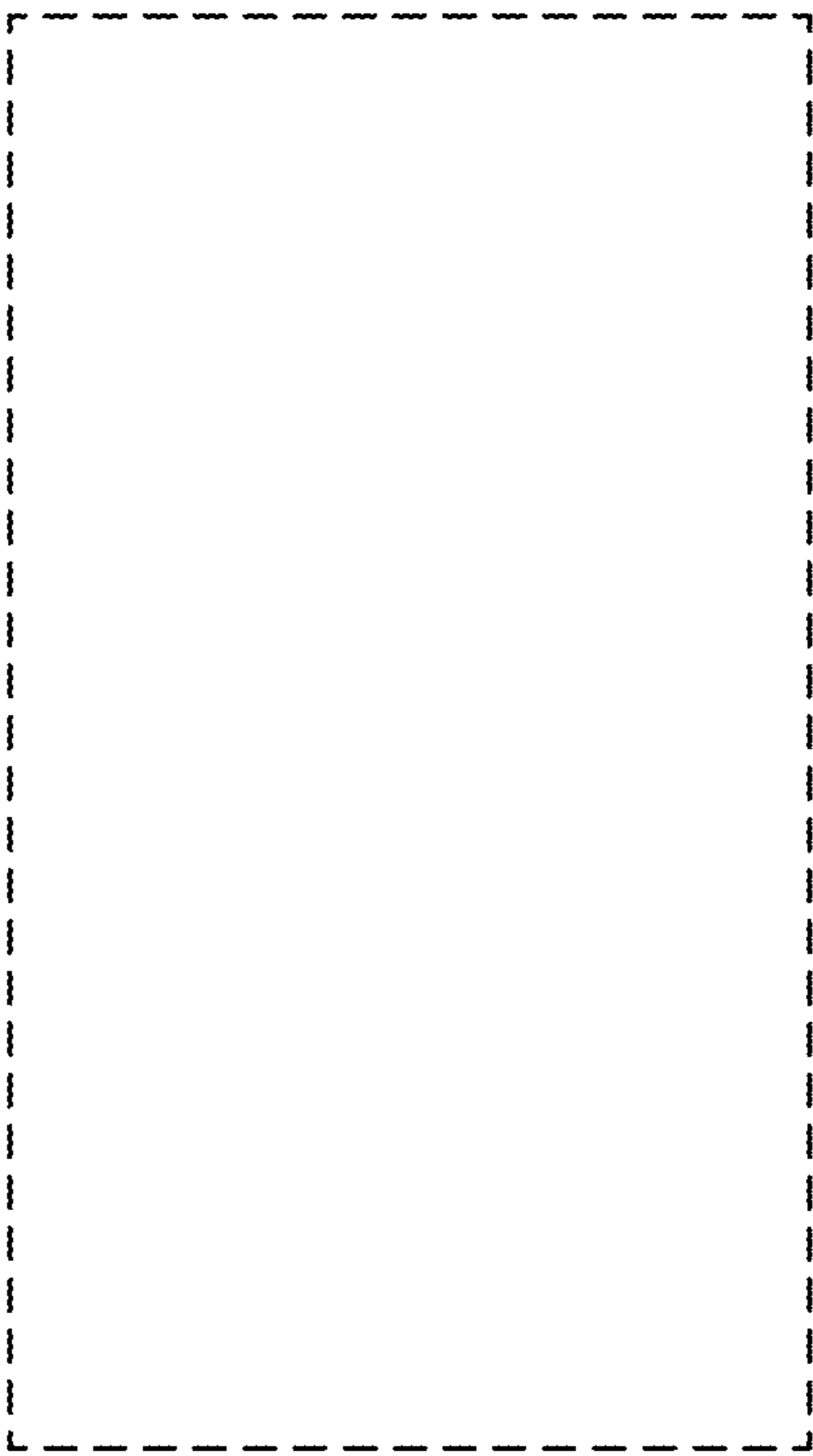

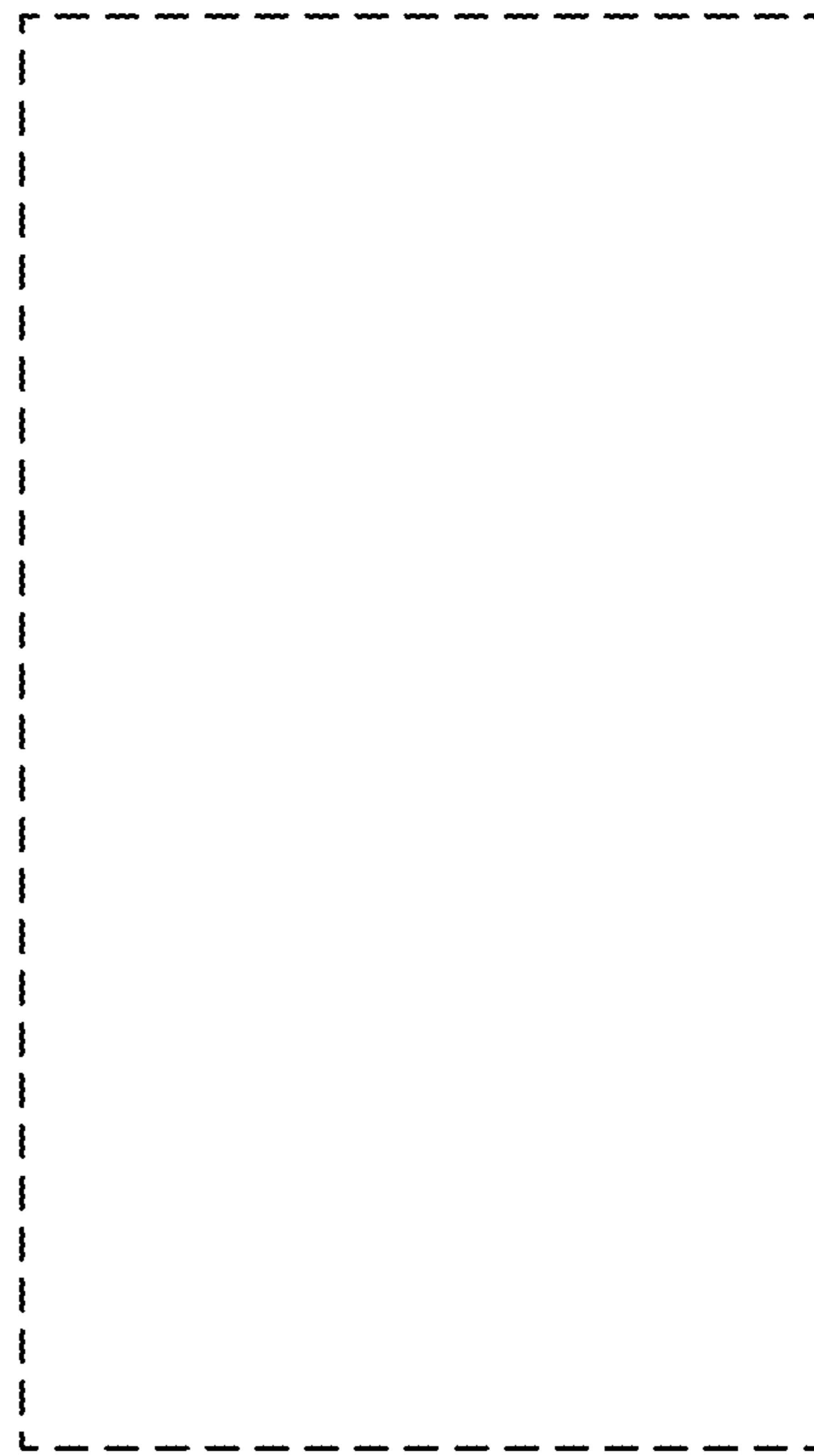
