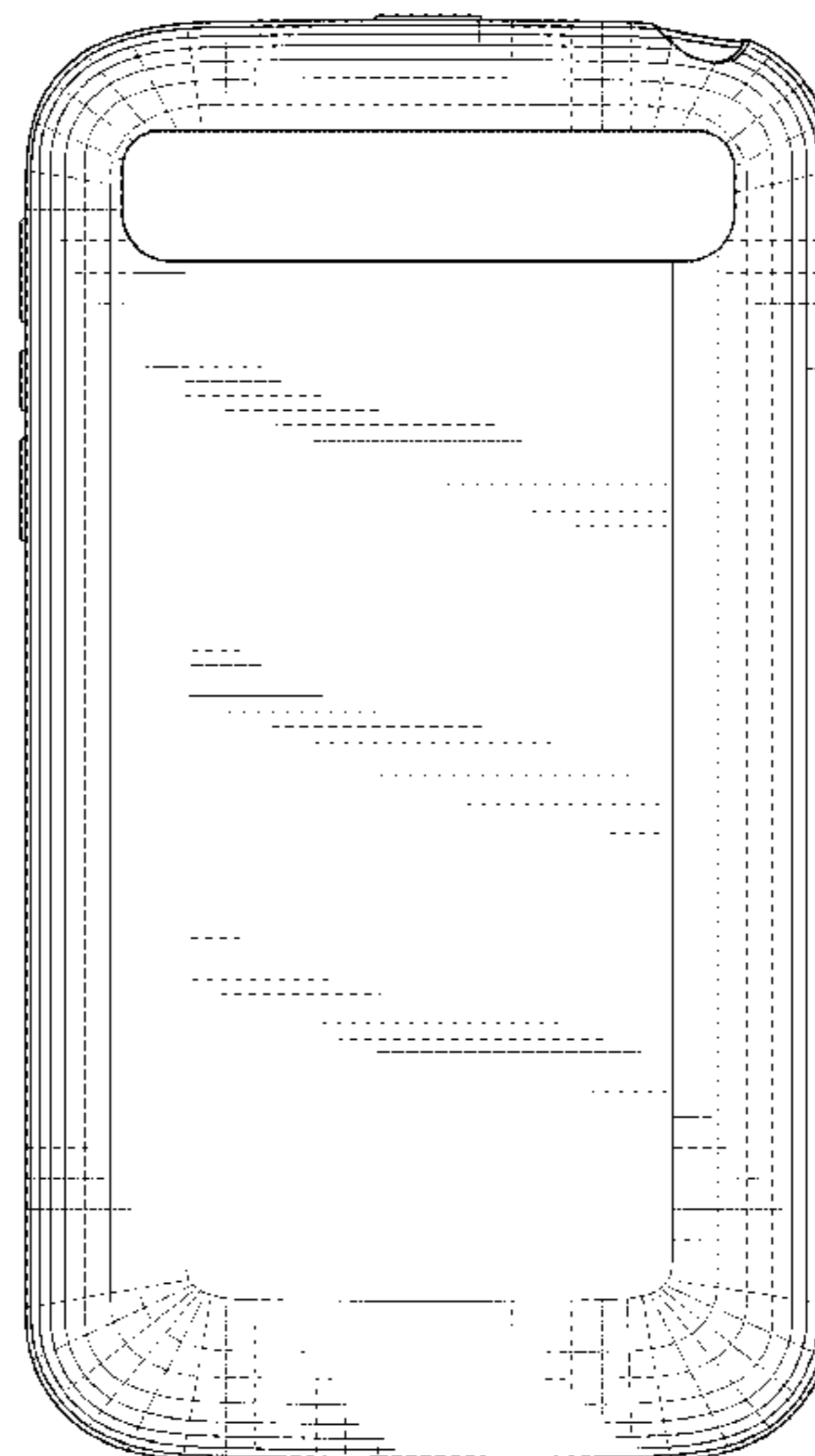
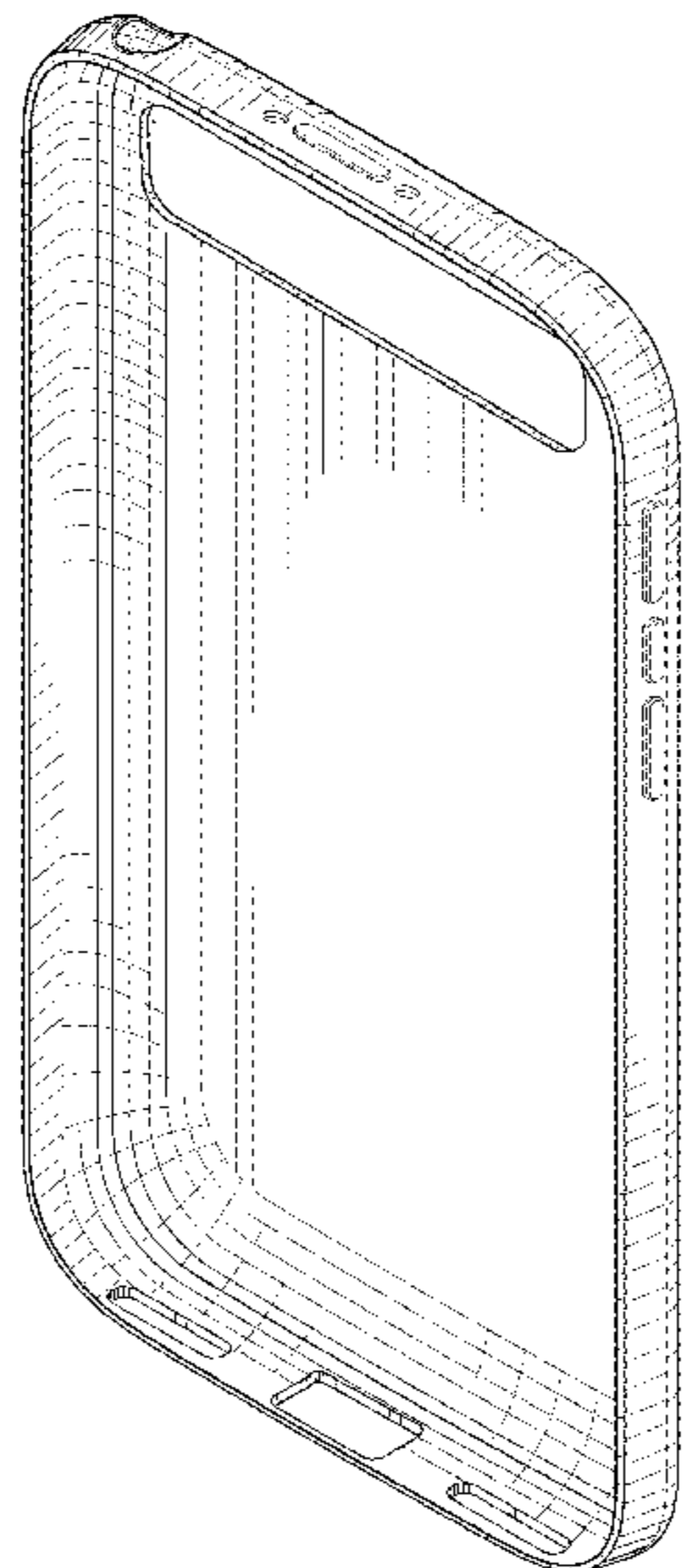
(57) **CLAIM**

The ornamental design for a cover for electronic communications device, as shown and described.

**DESCRIPTION**

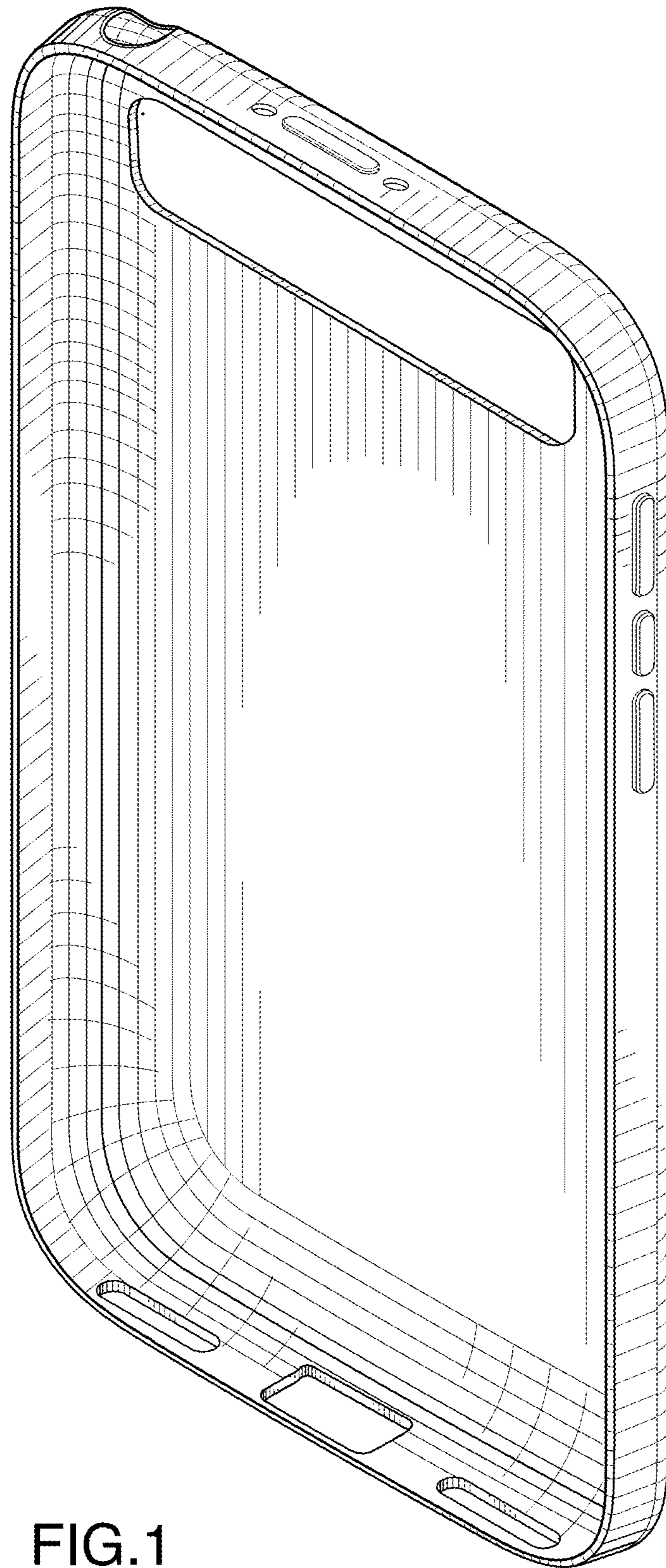

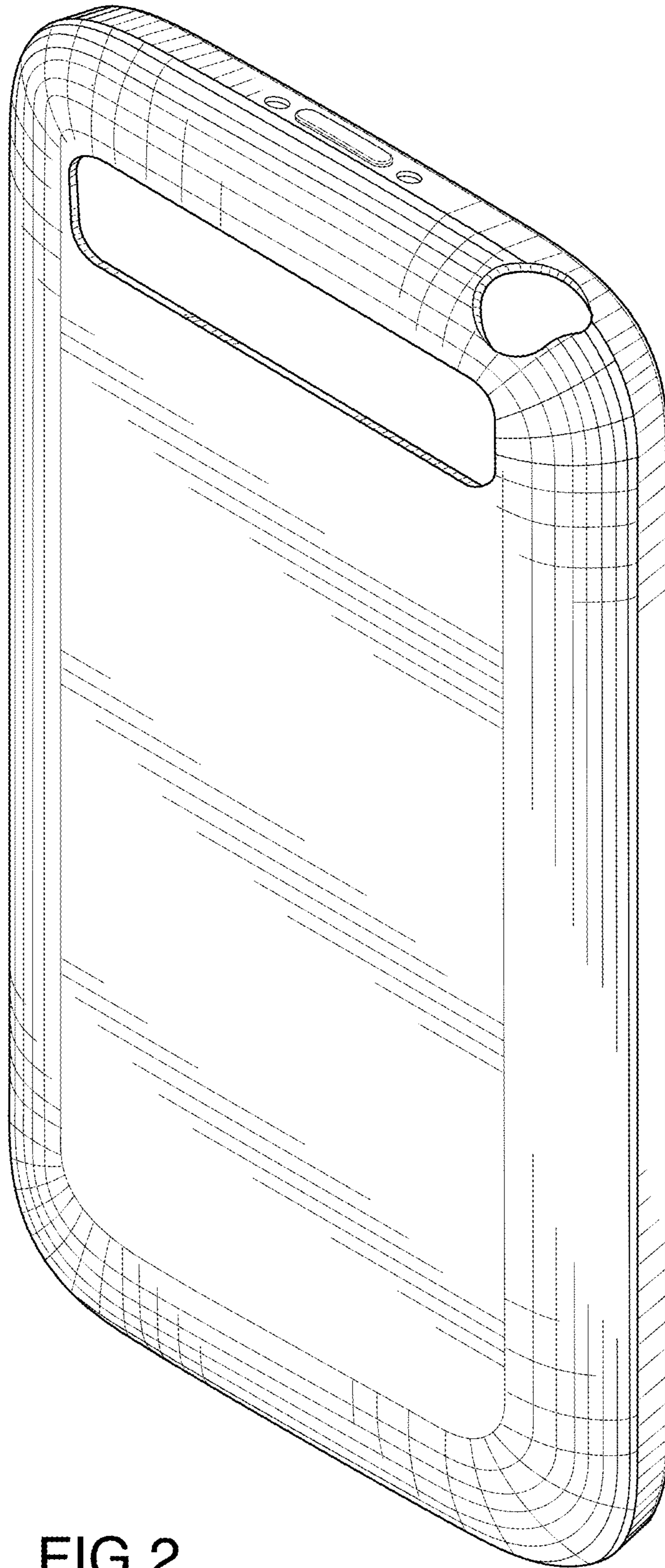

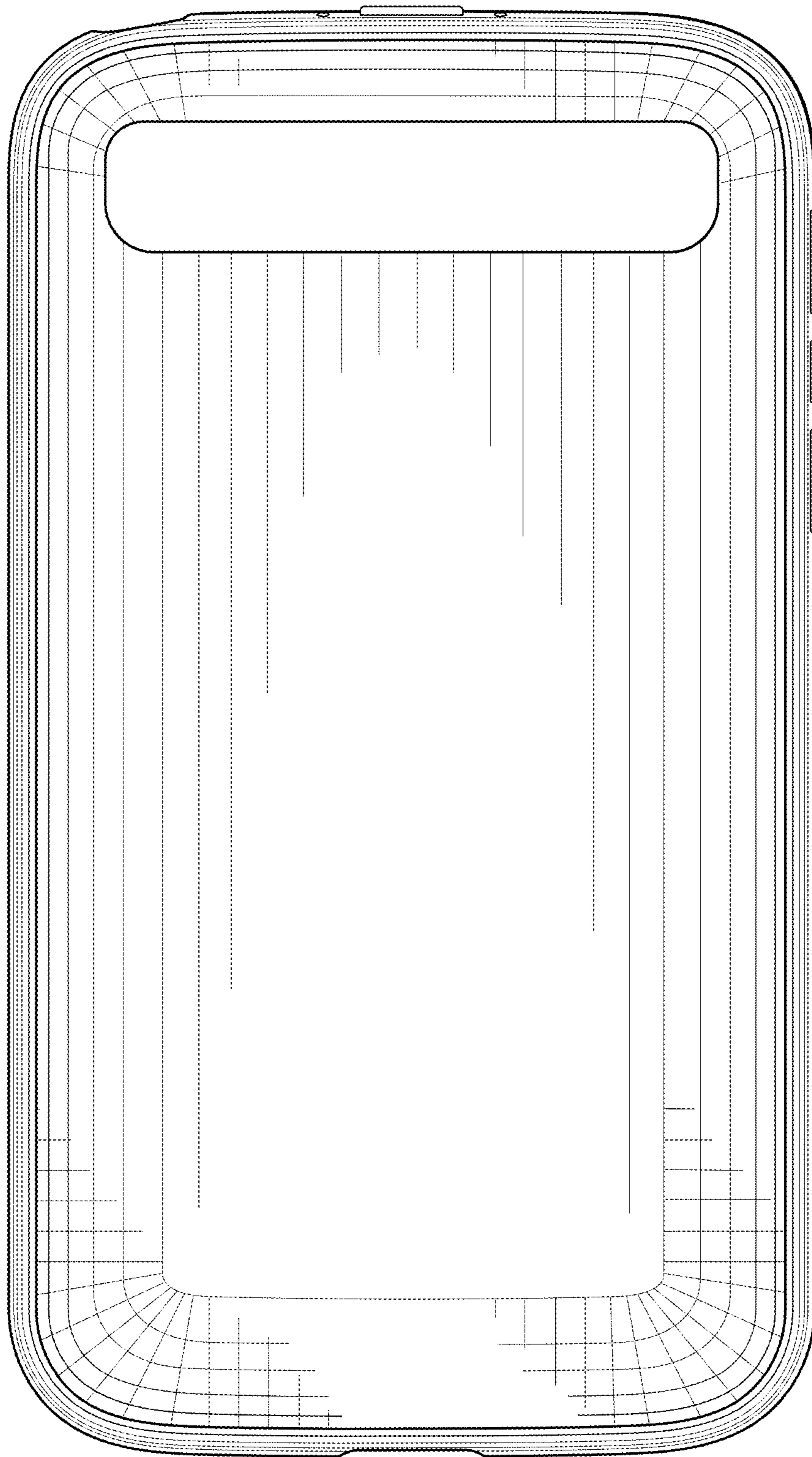

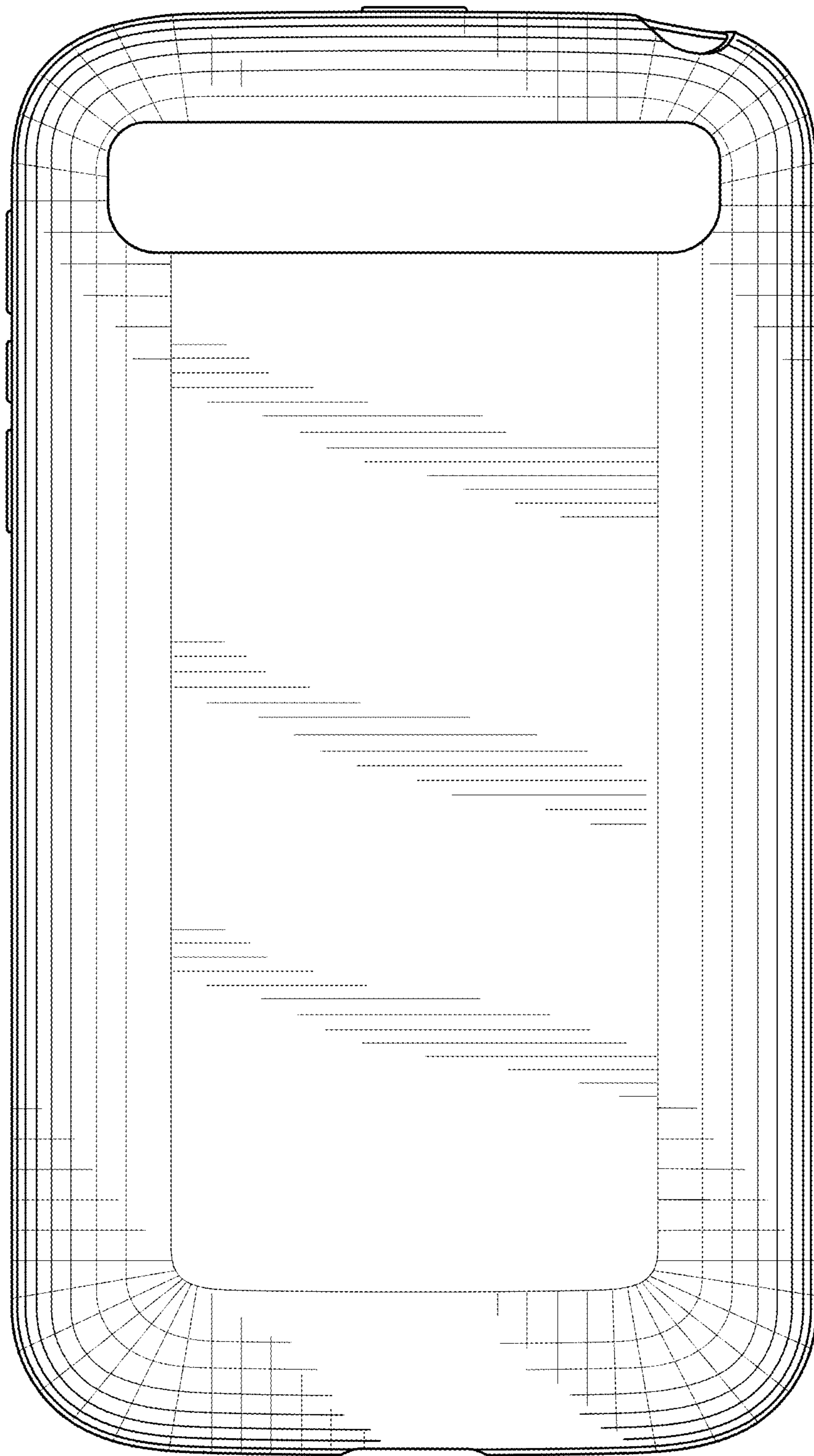

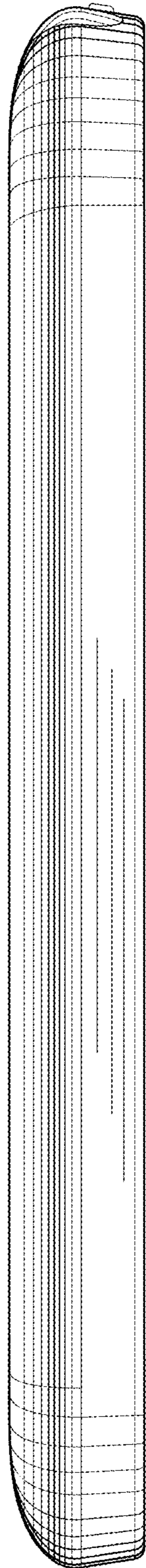

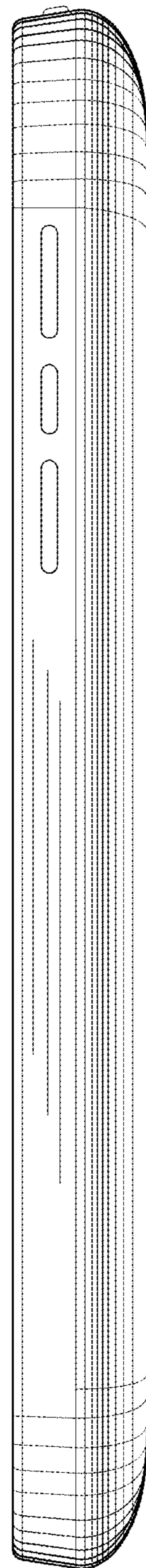

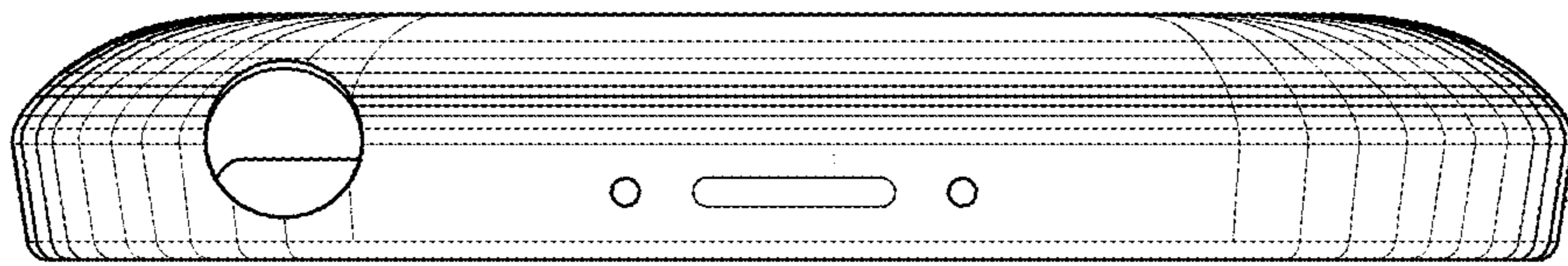

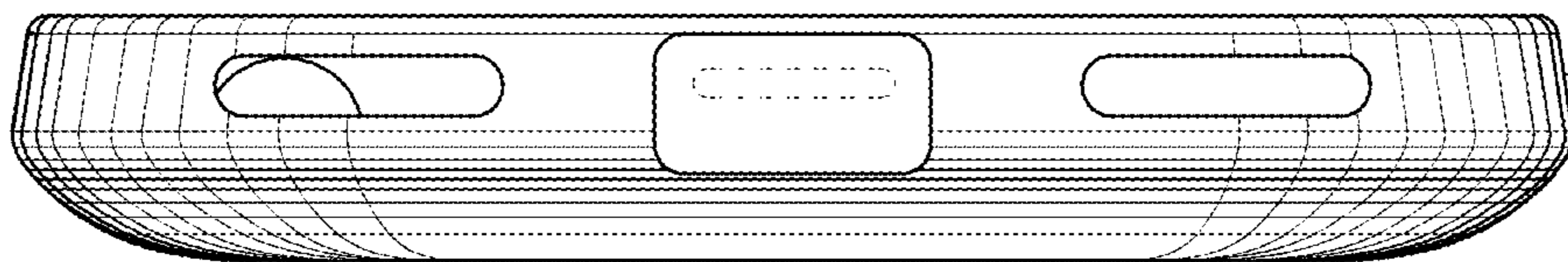
