FIG. 17 is the seventeenth image thereof;

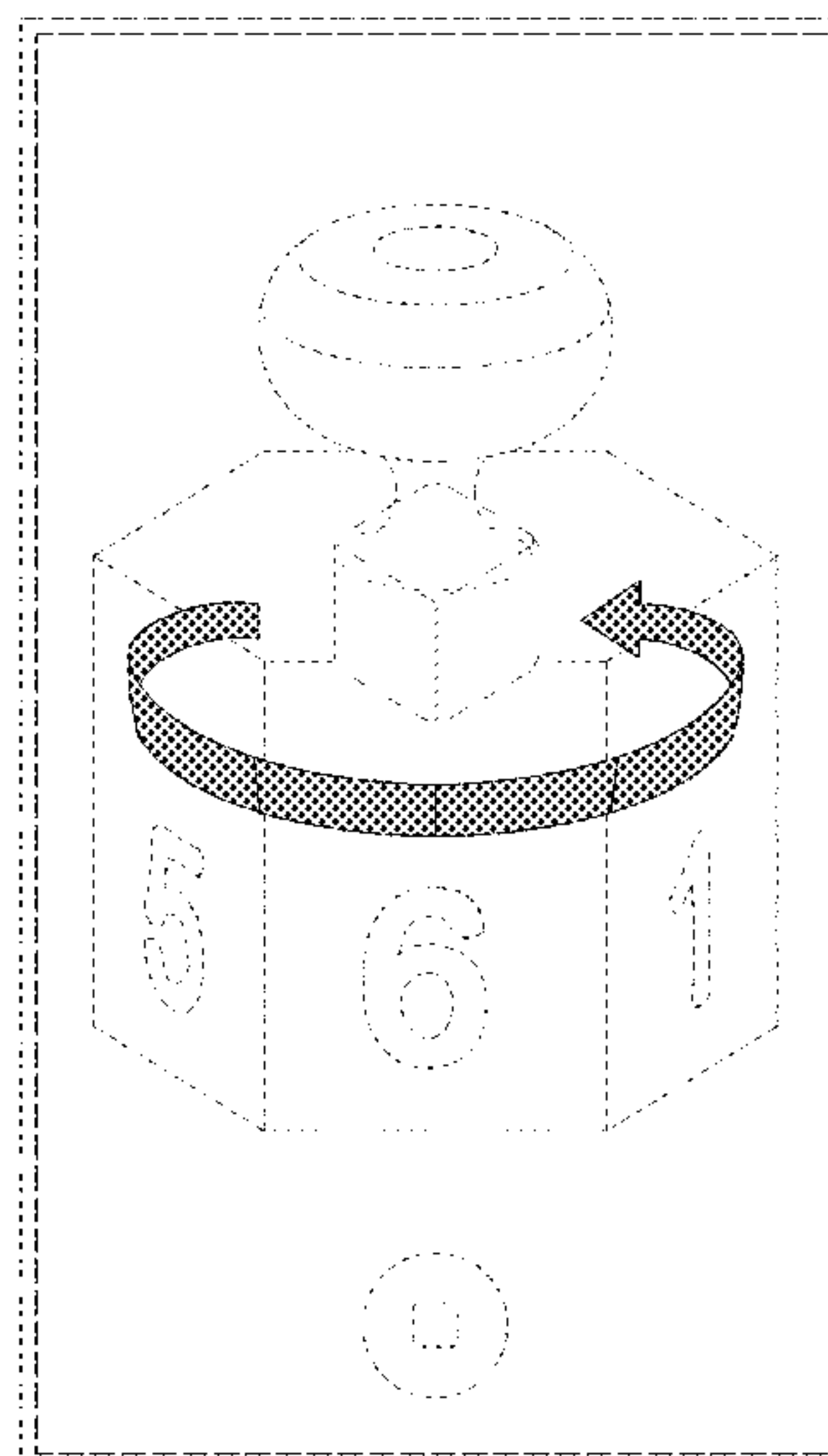
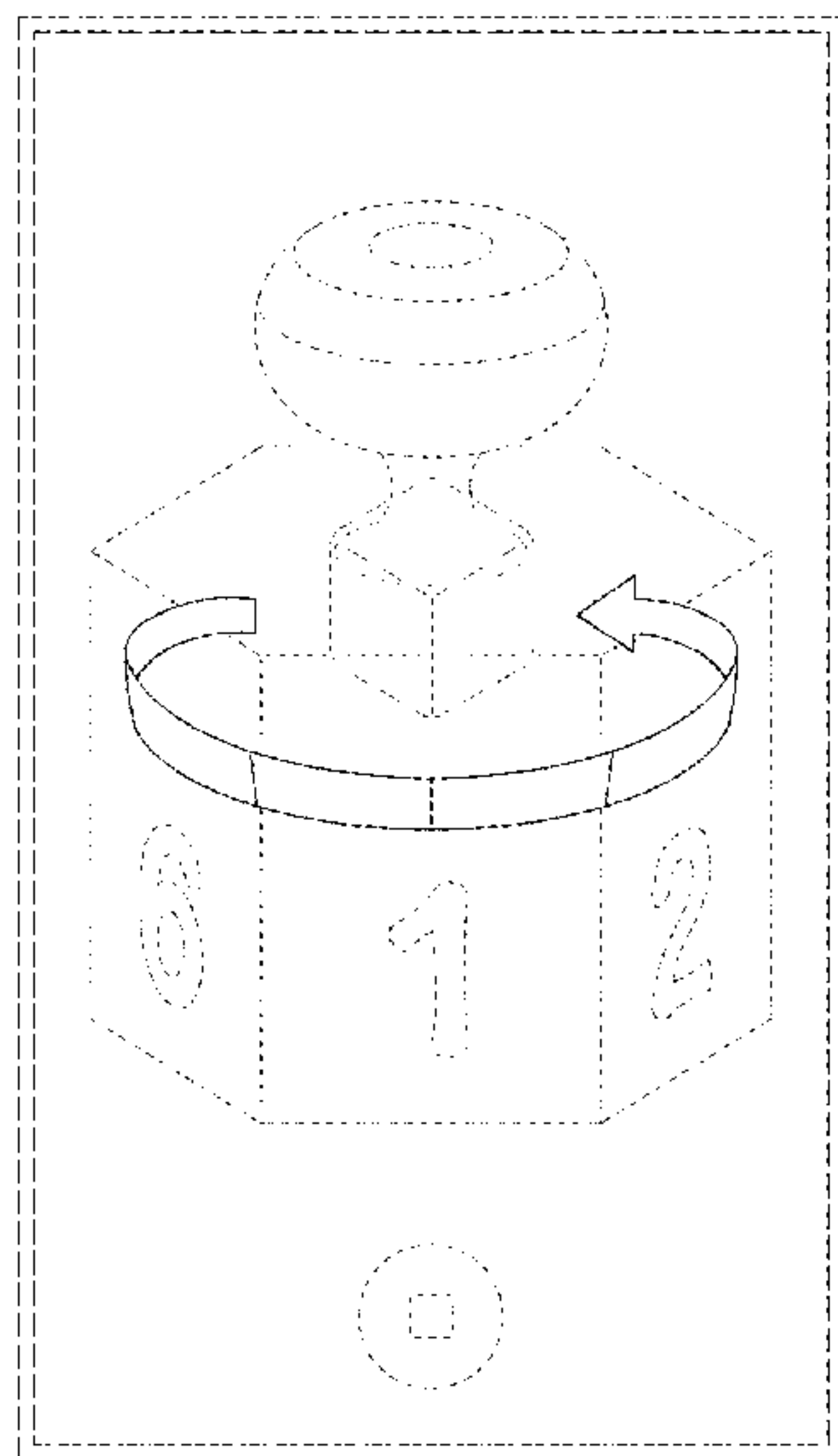
FIG. 18 is the eighteenth image thereof; and,

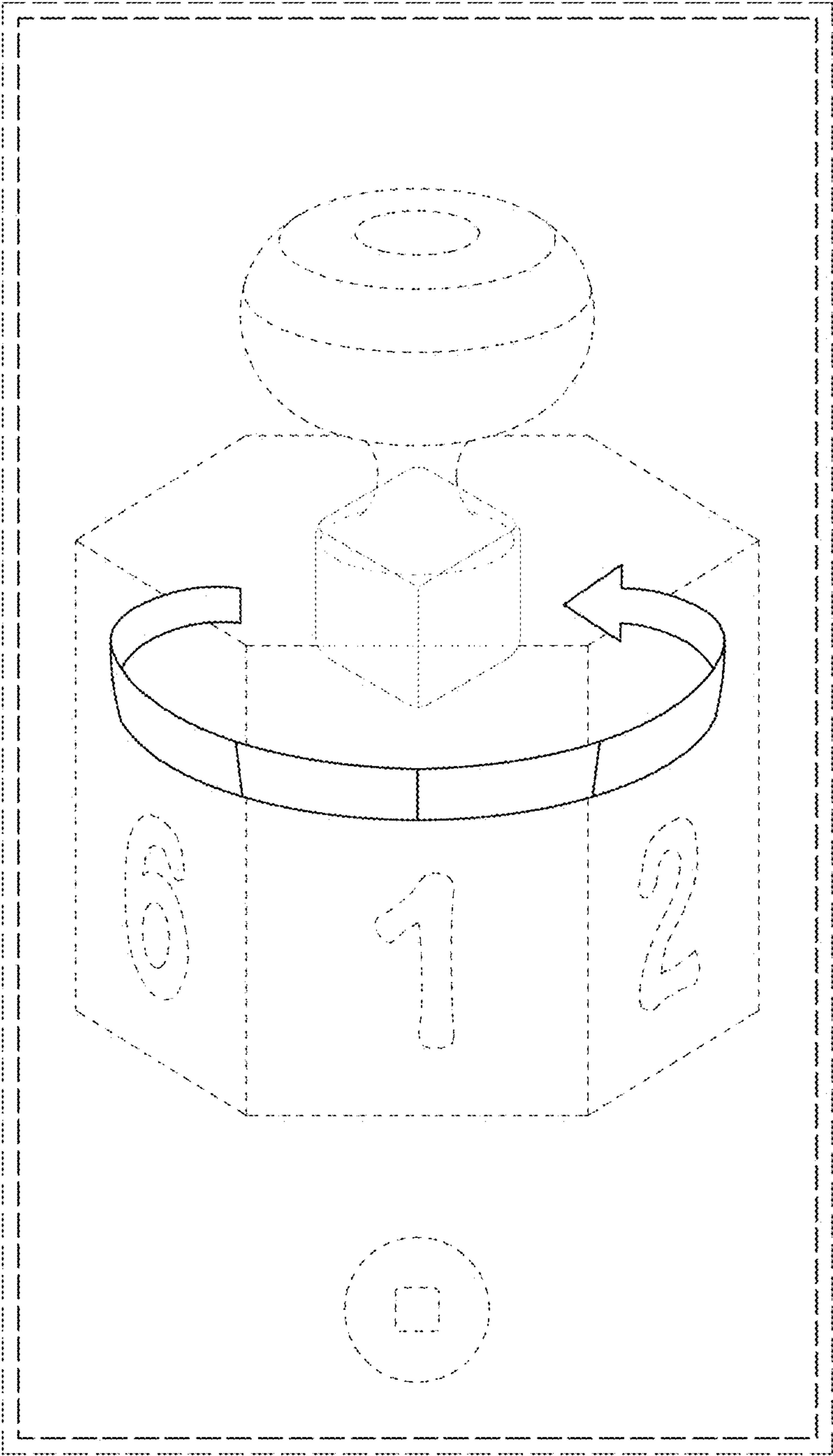

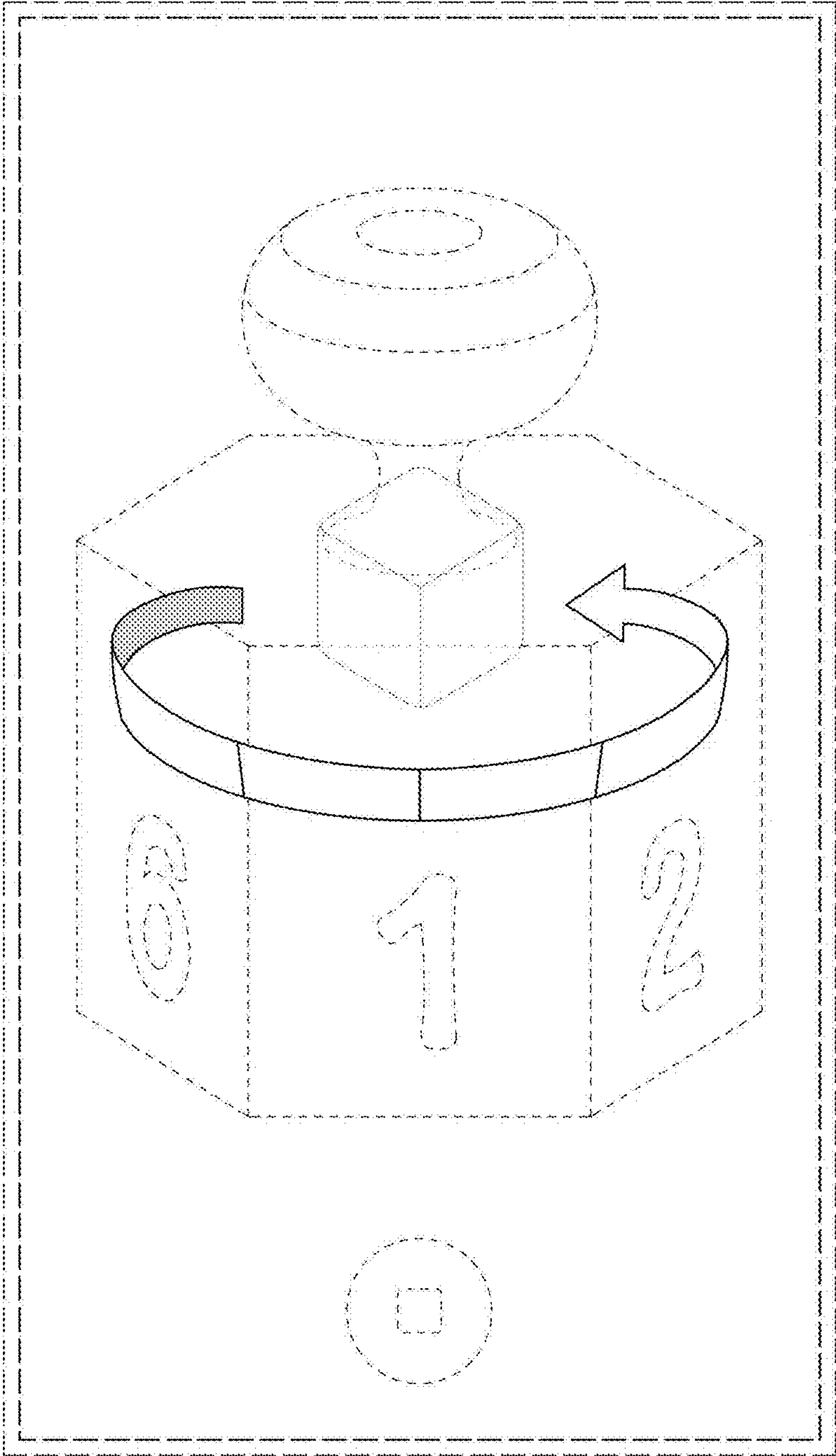

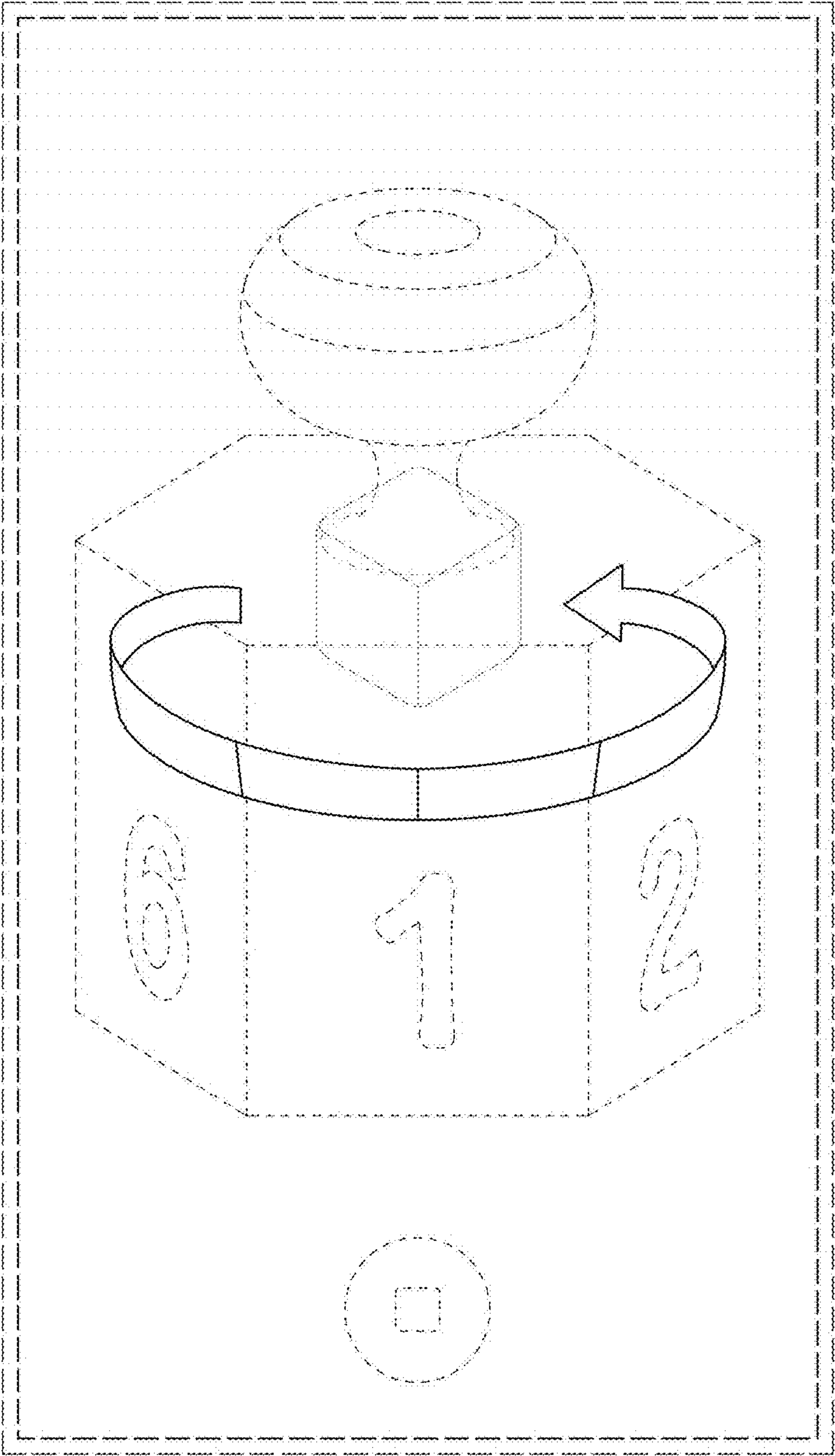

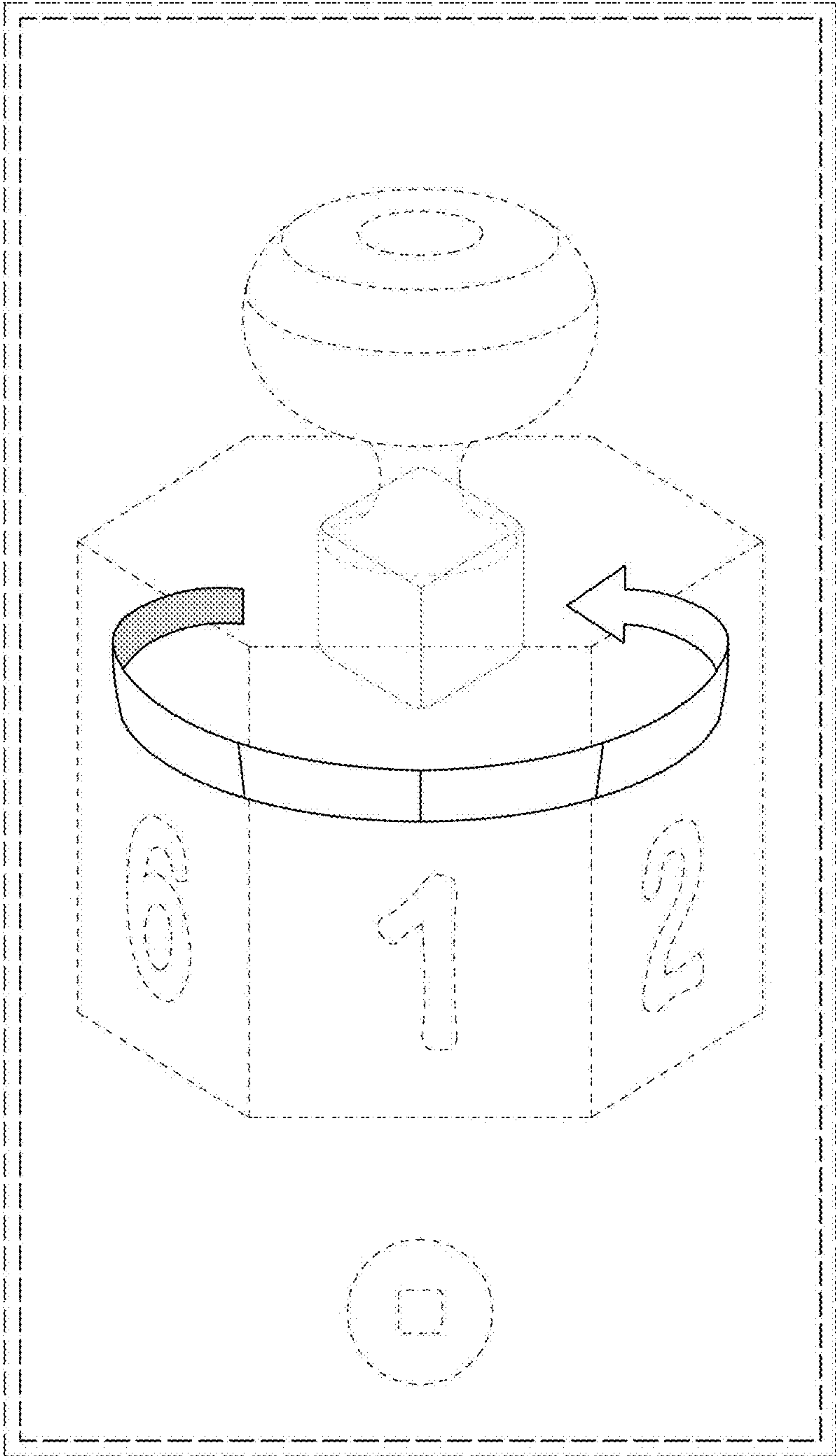

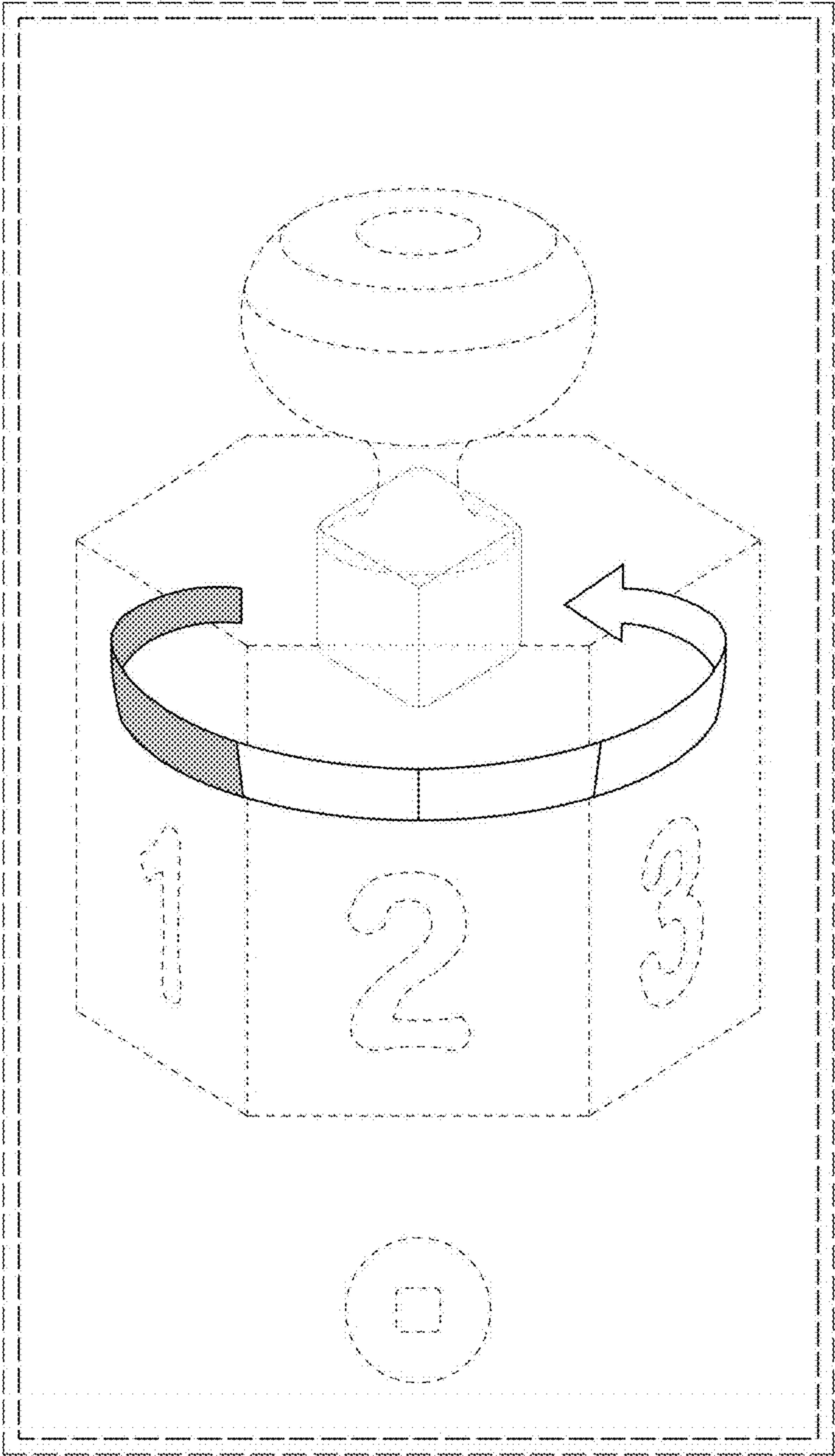

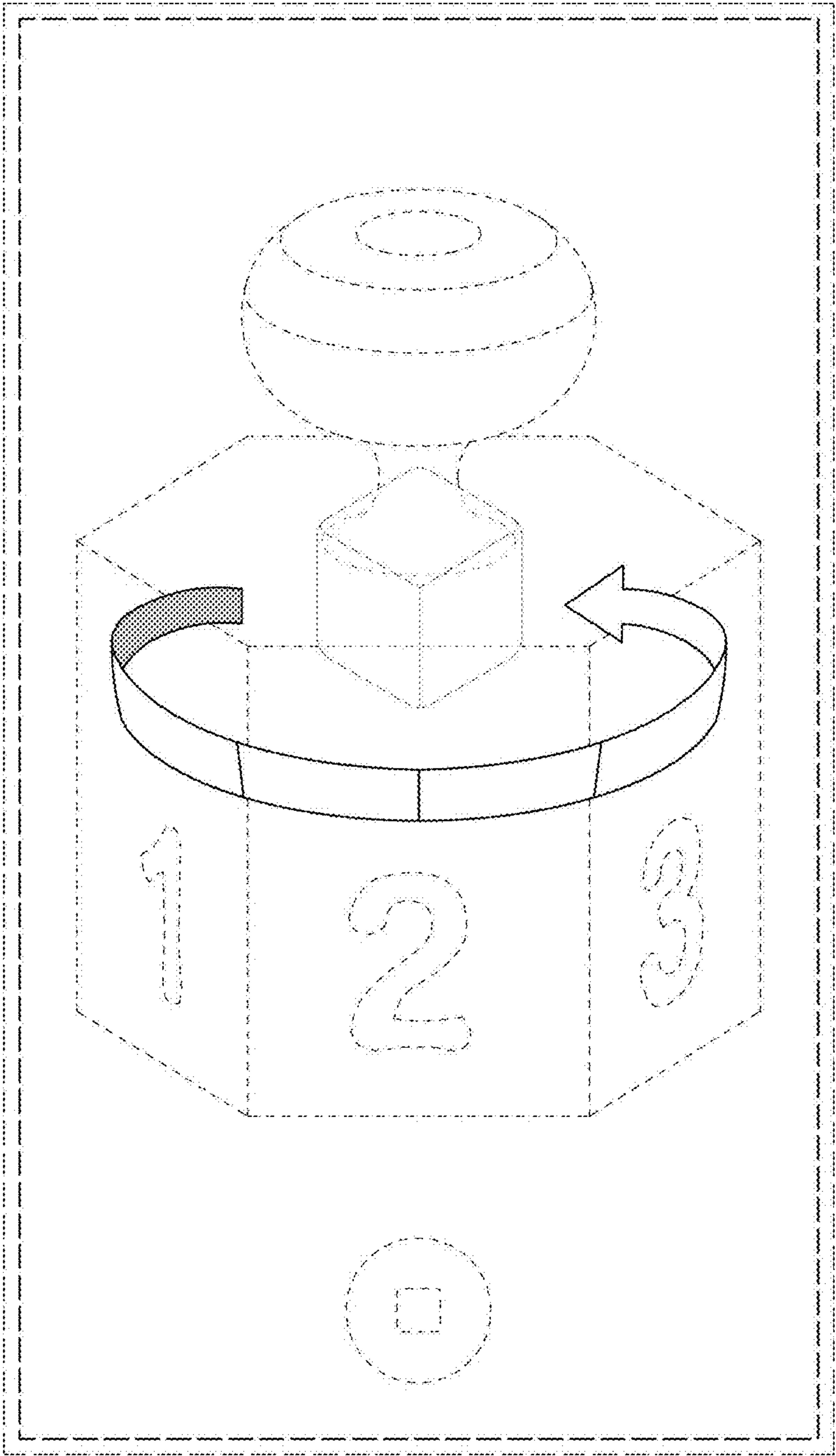

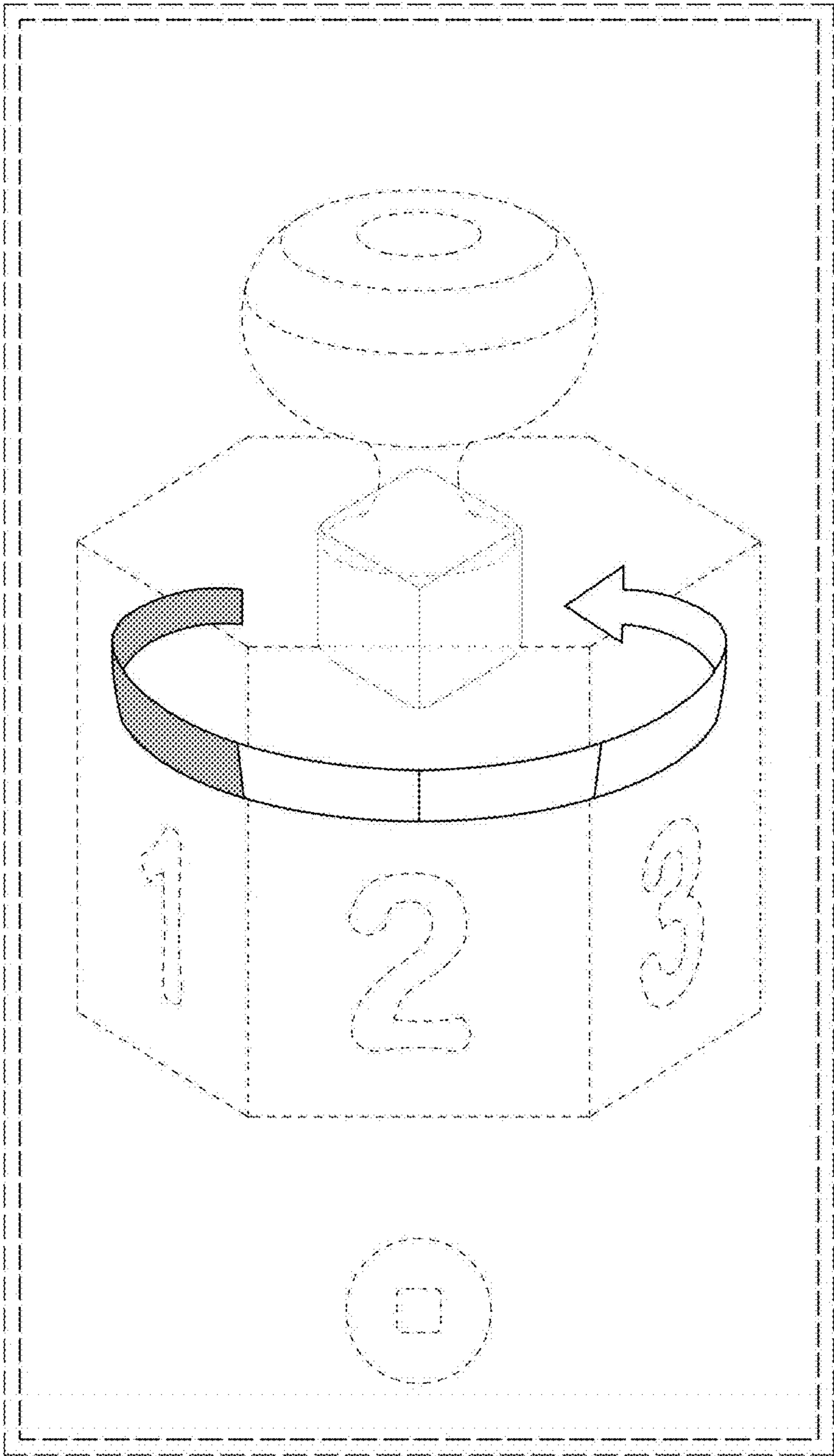

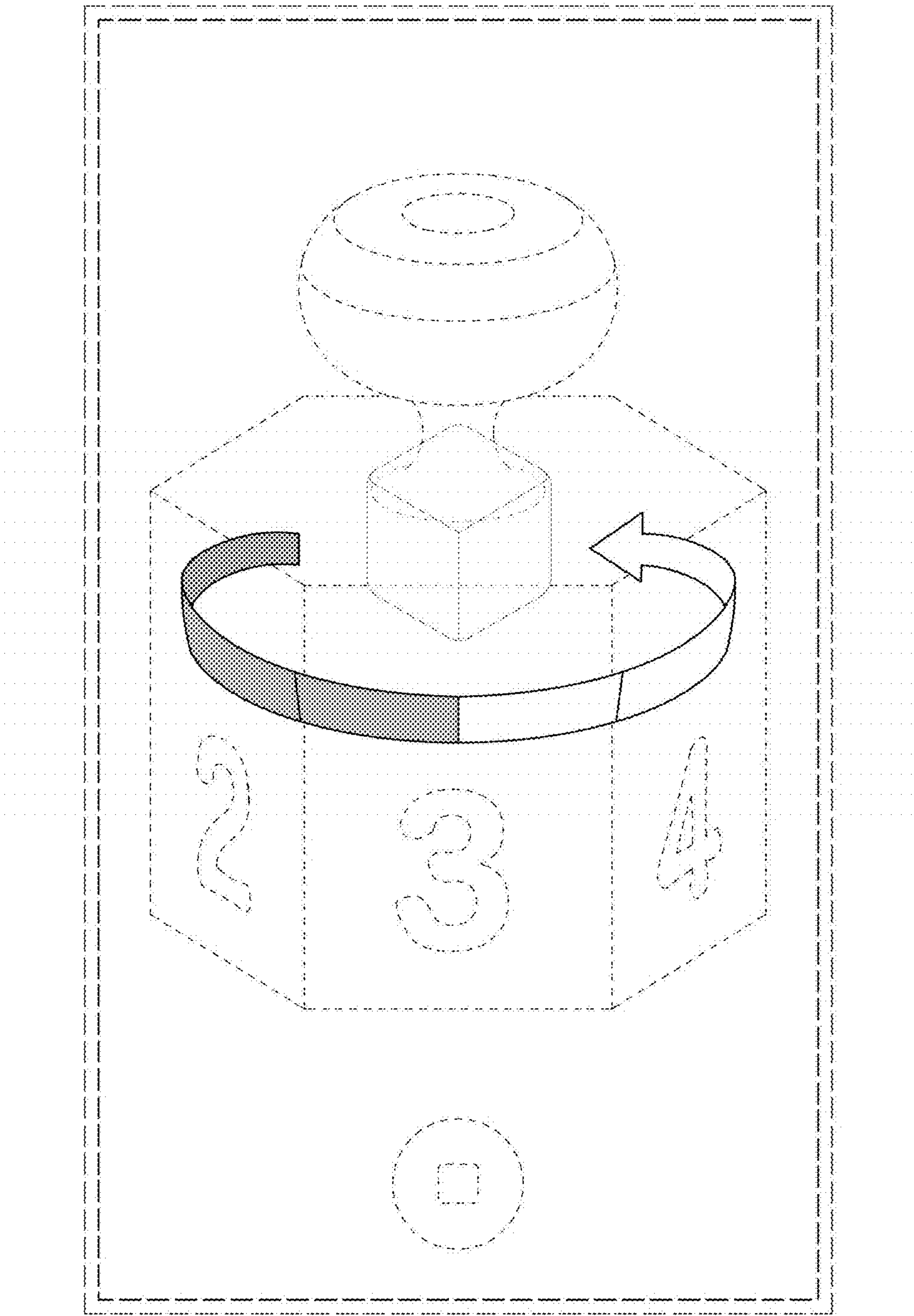

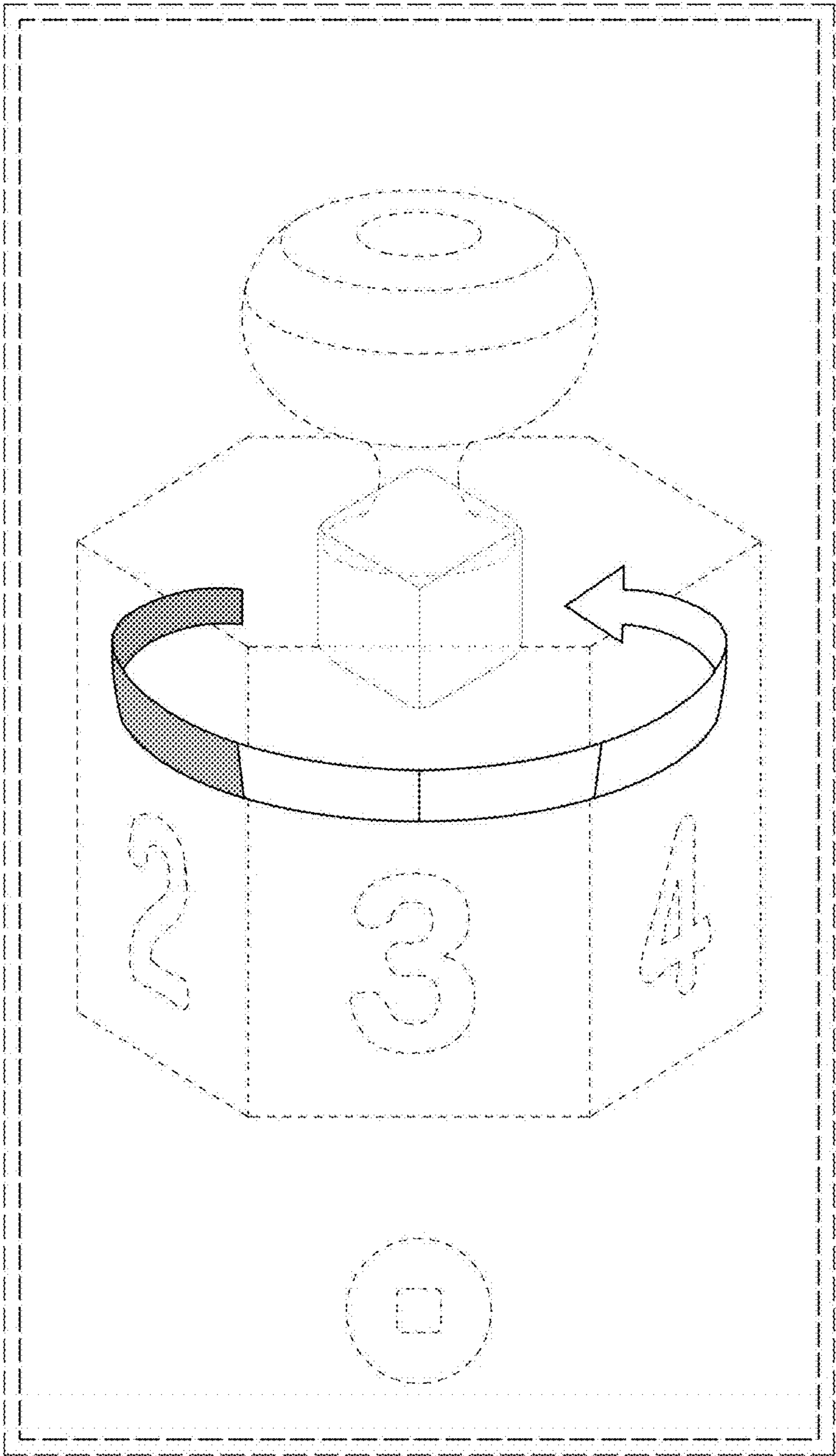

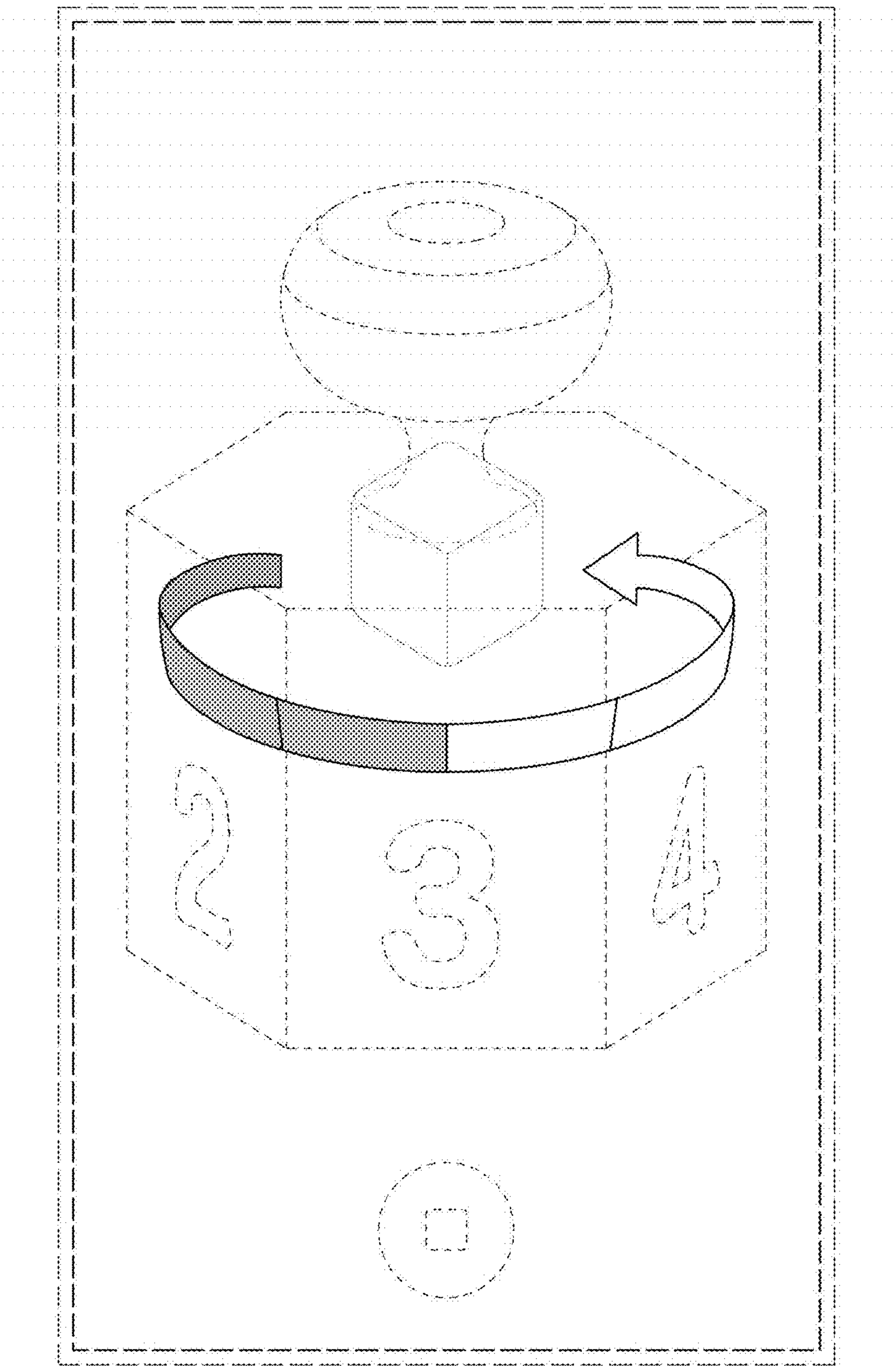

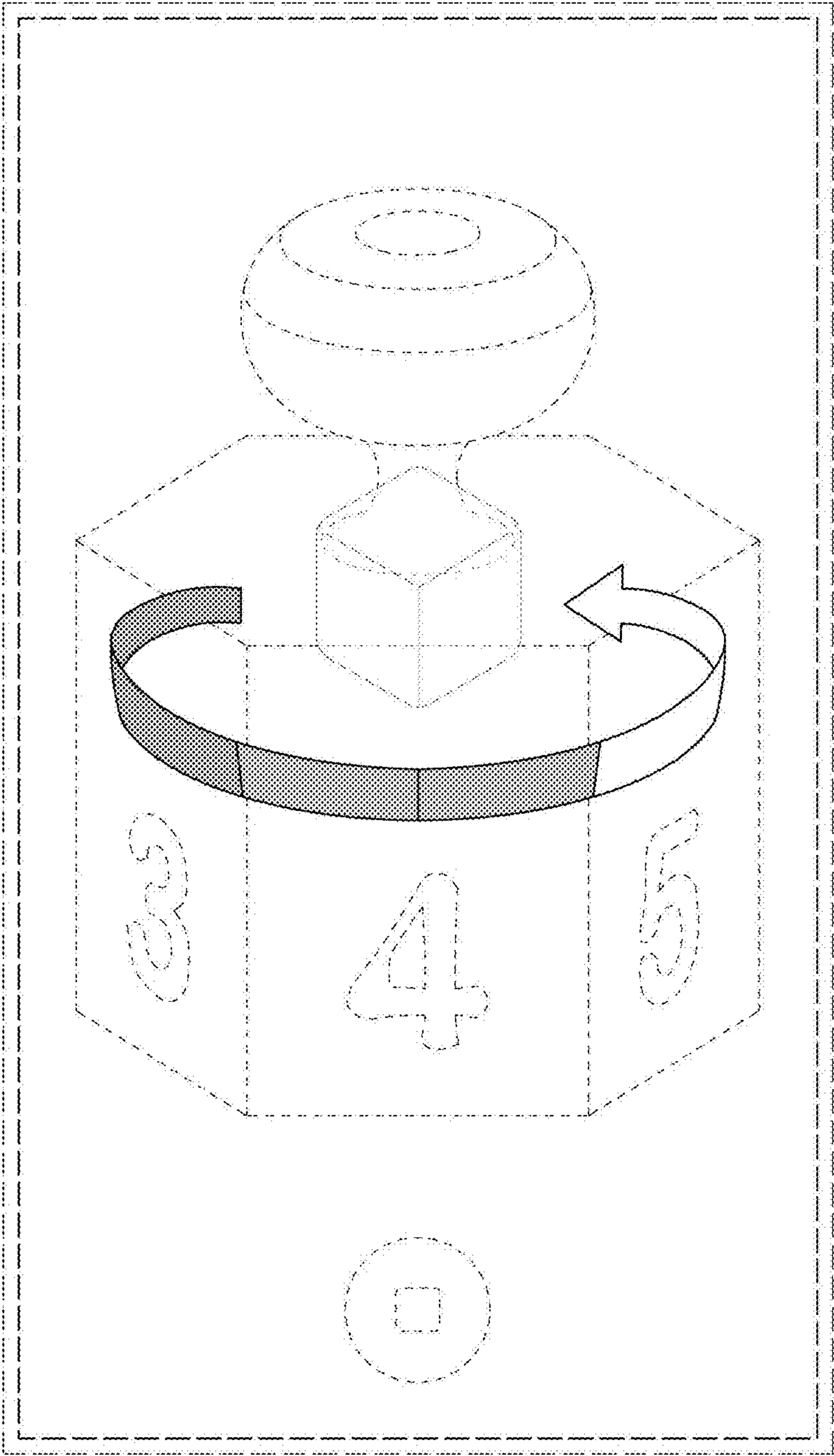

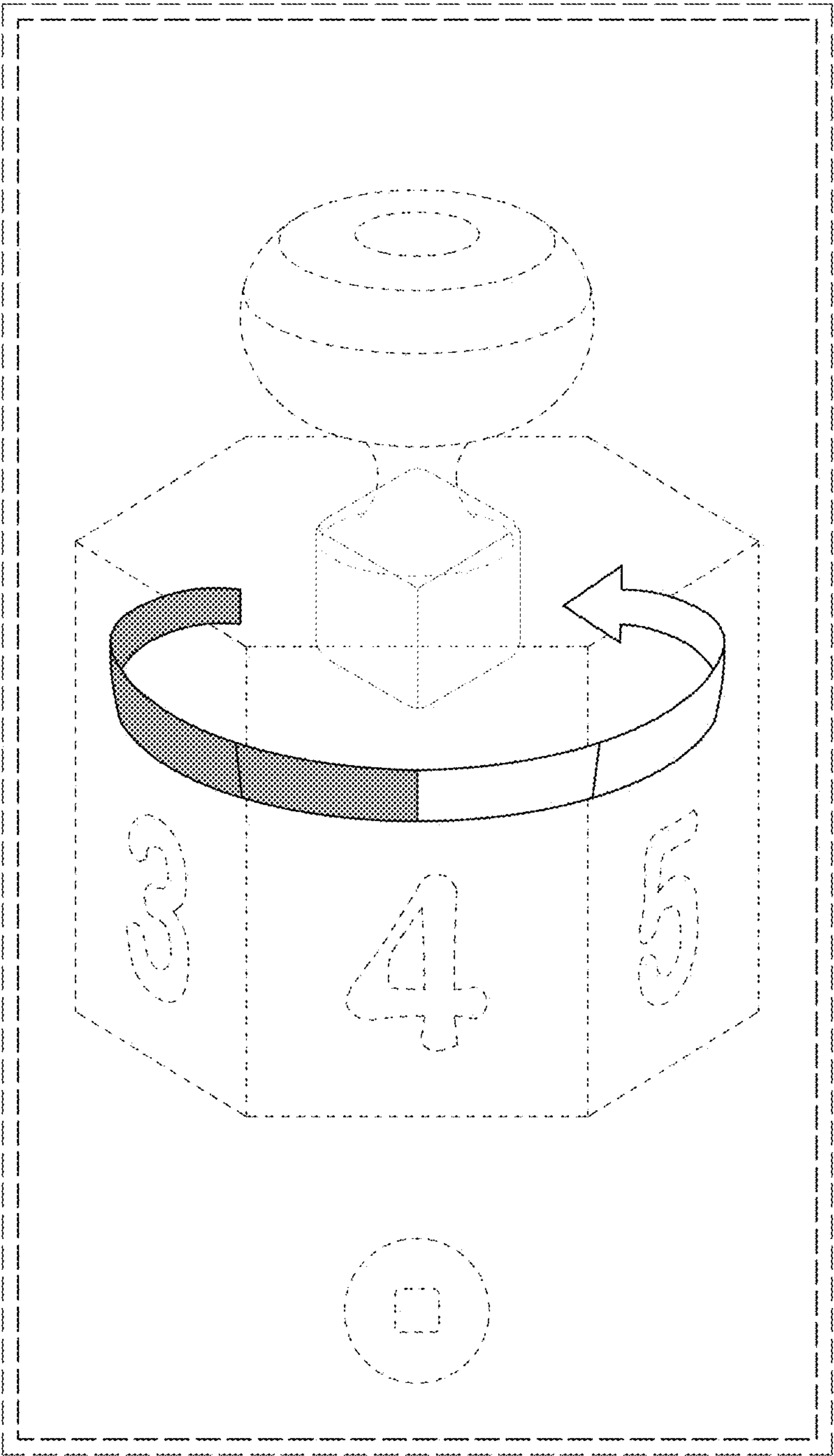

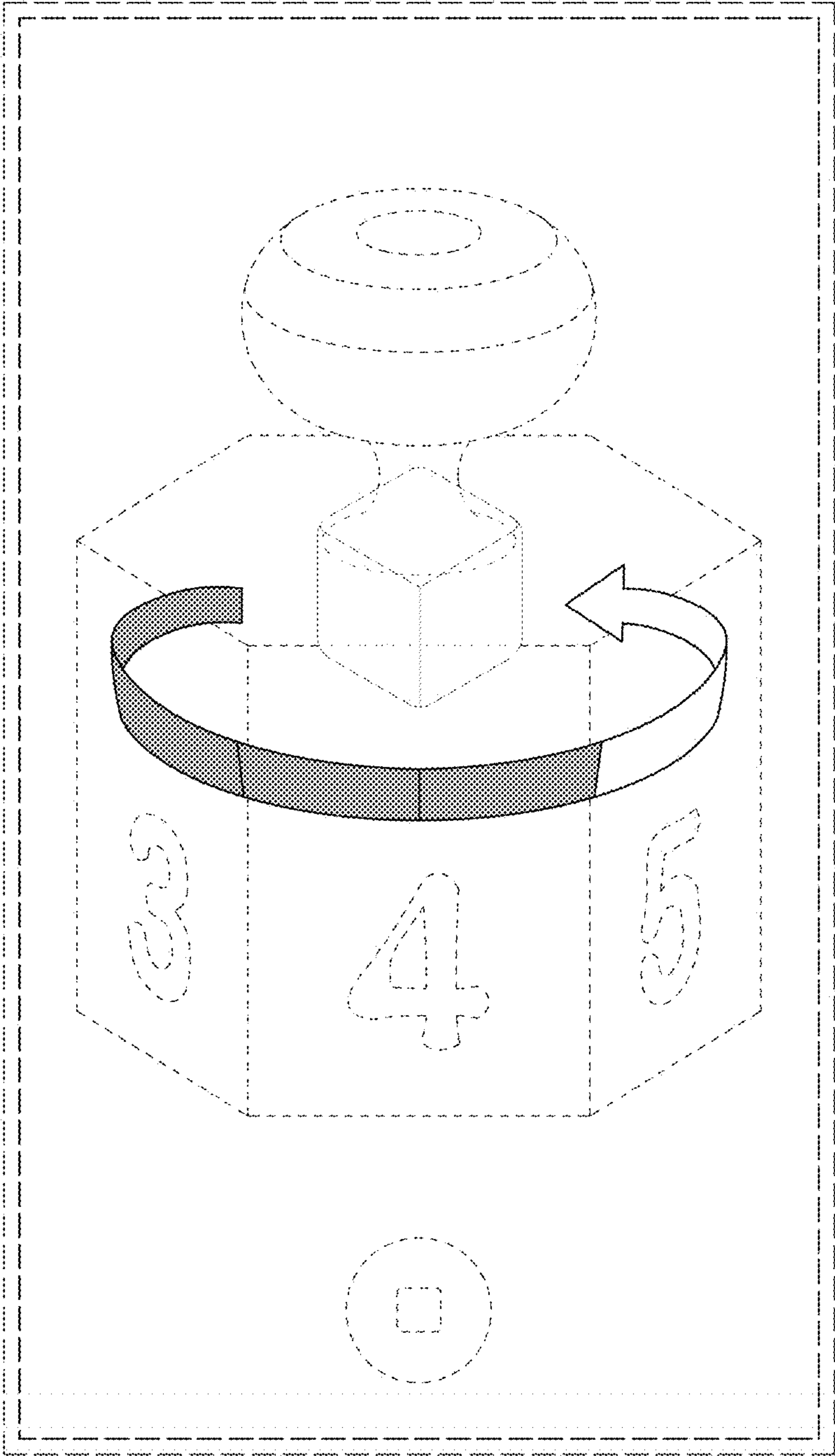

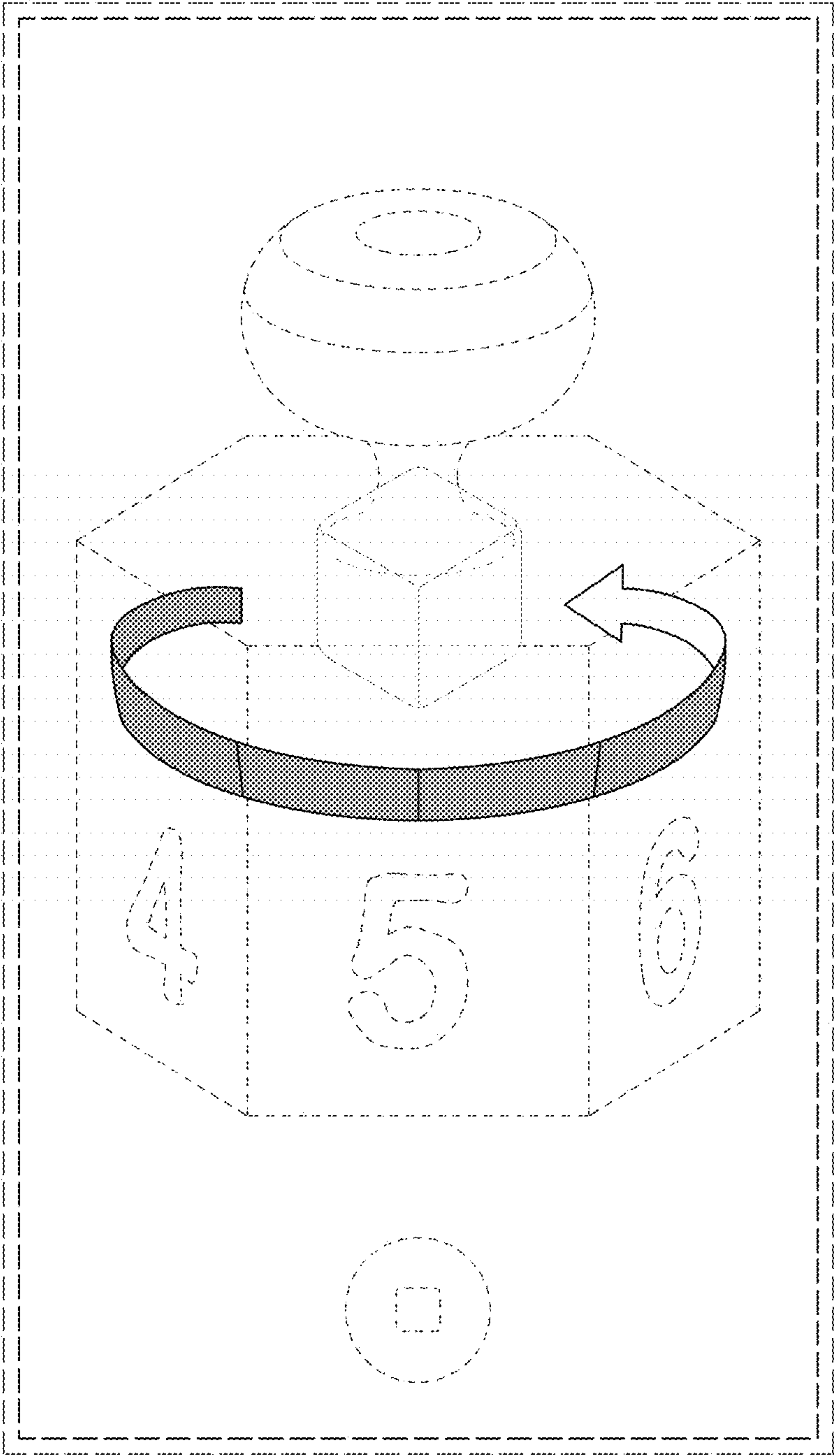

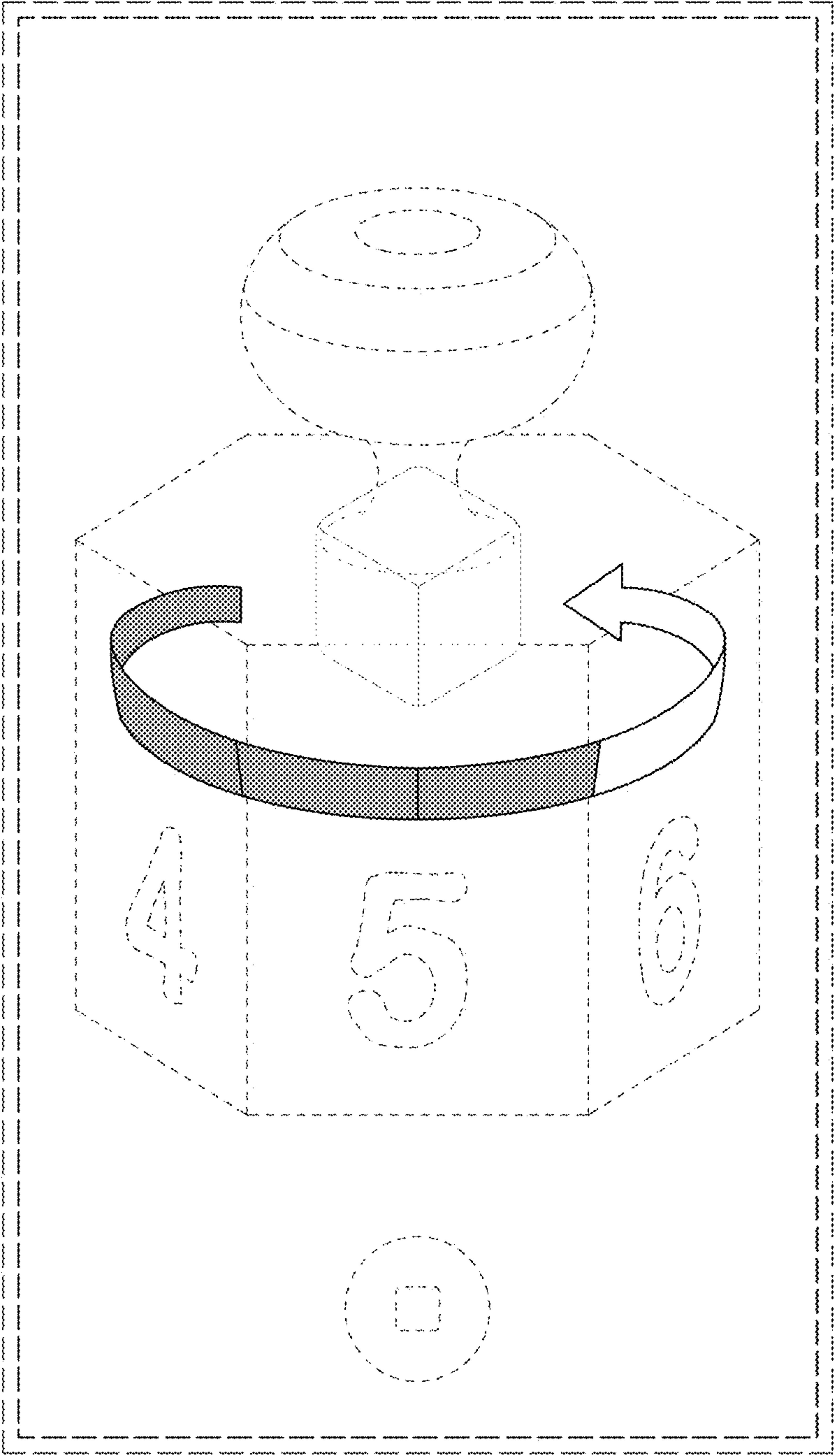

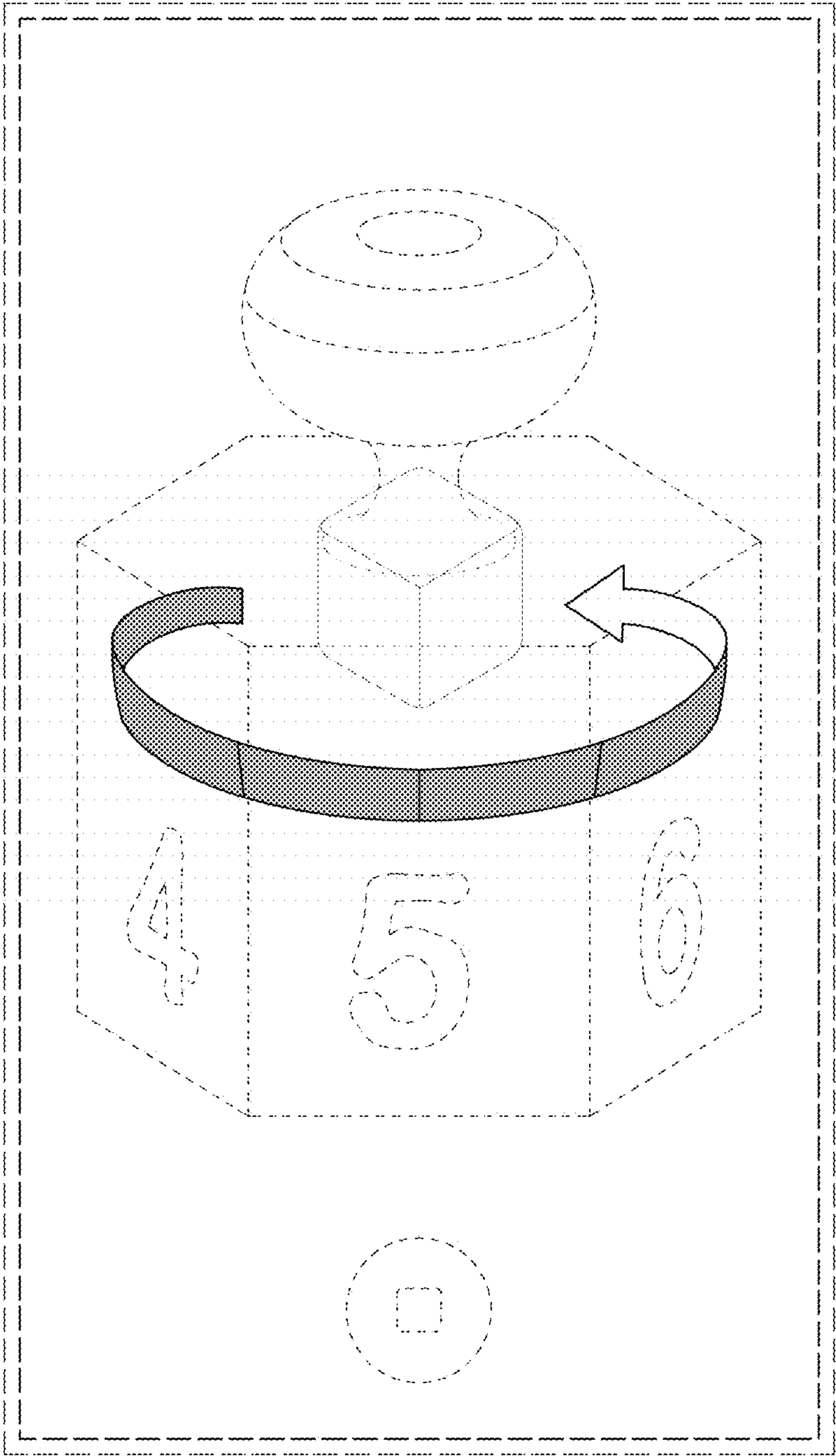

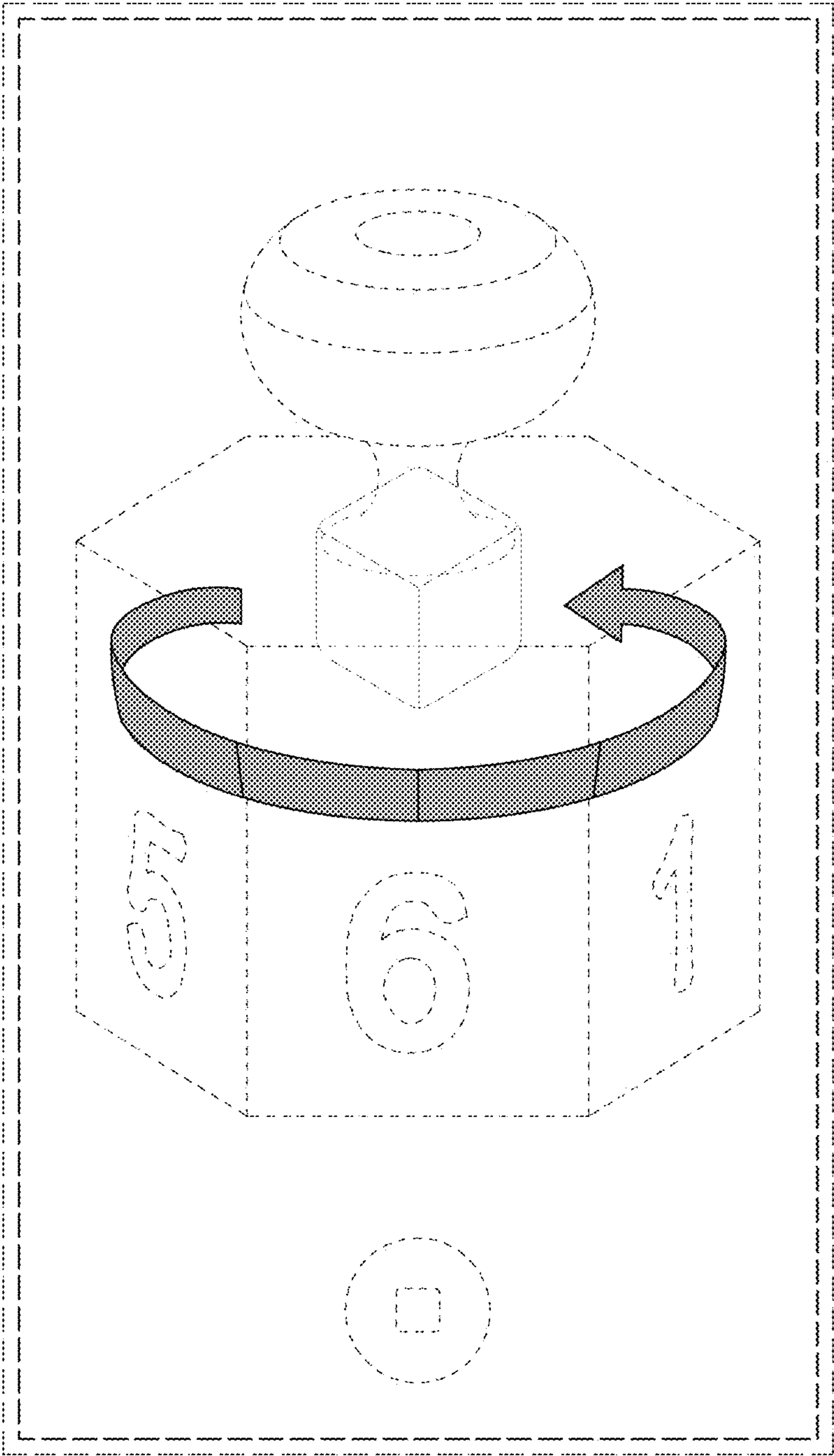

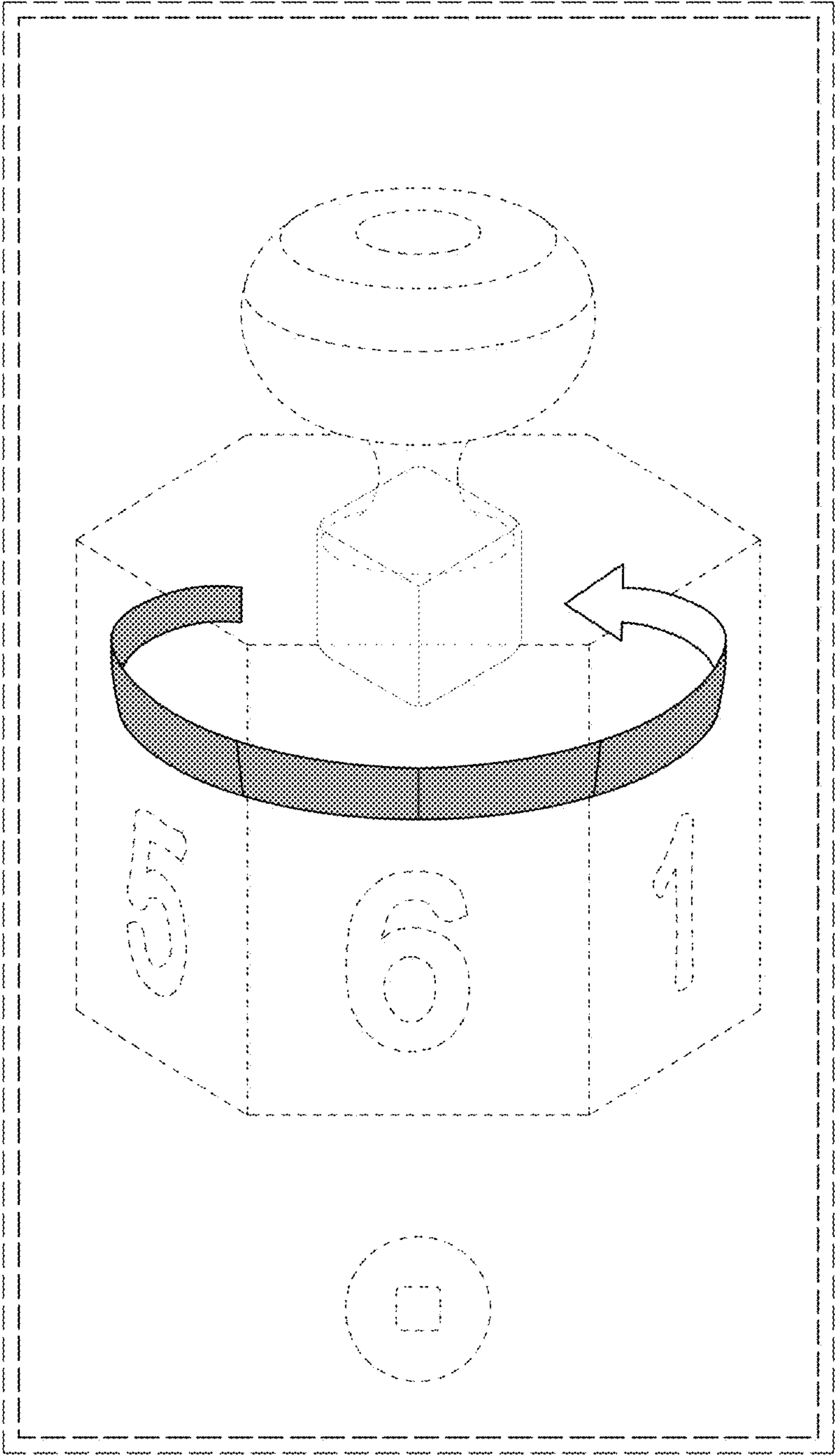
