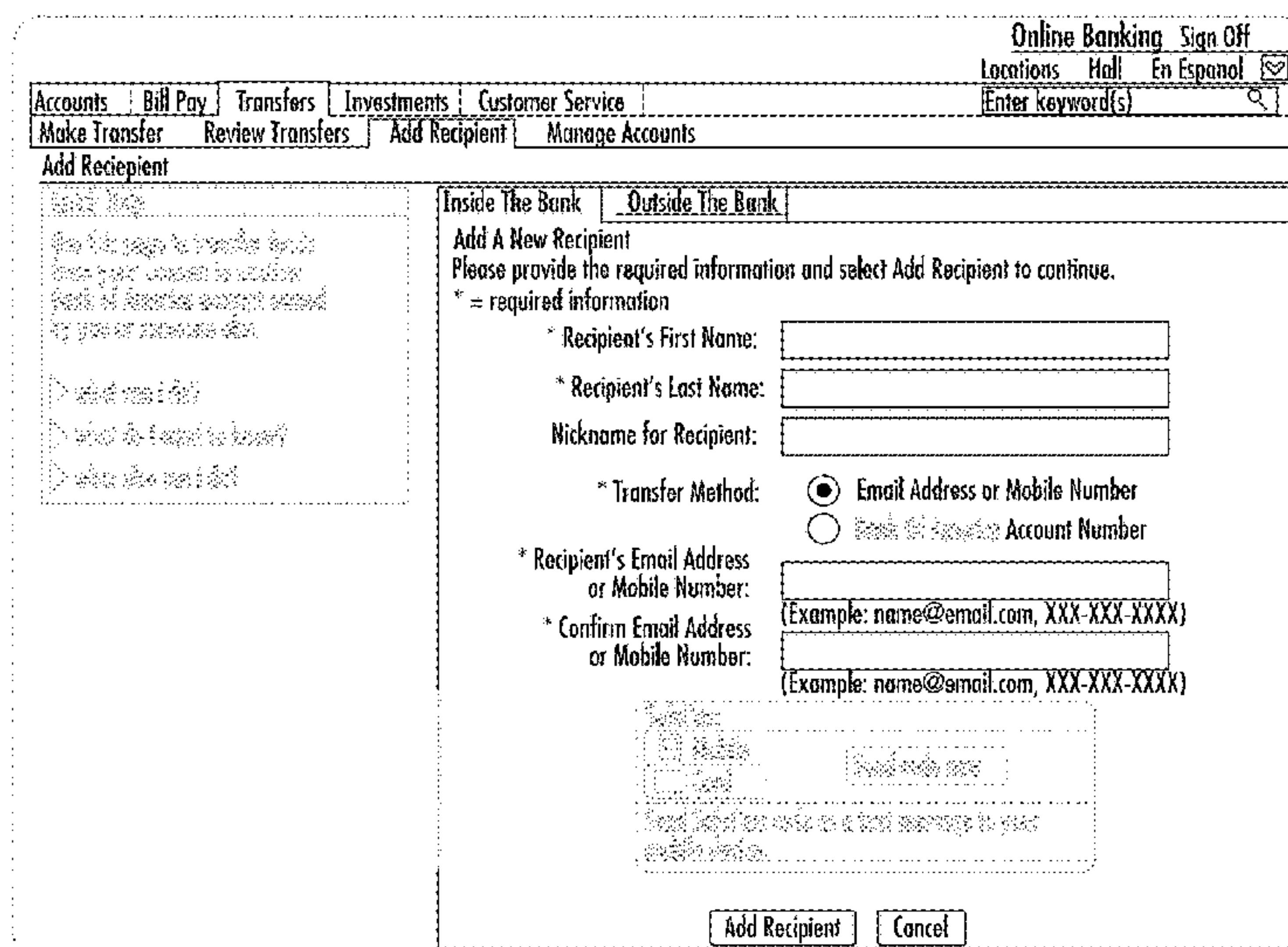
The ornamental design for display screen with graphical user interface for funds transfer, as shown and described.
