FIG. 3 is a front view of a third embodiment thereof;

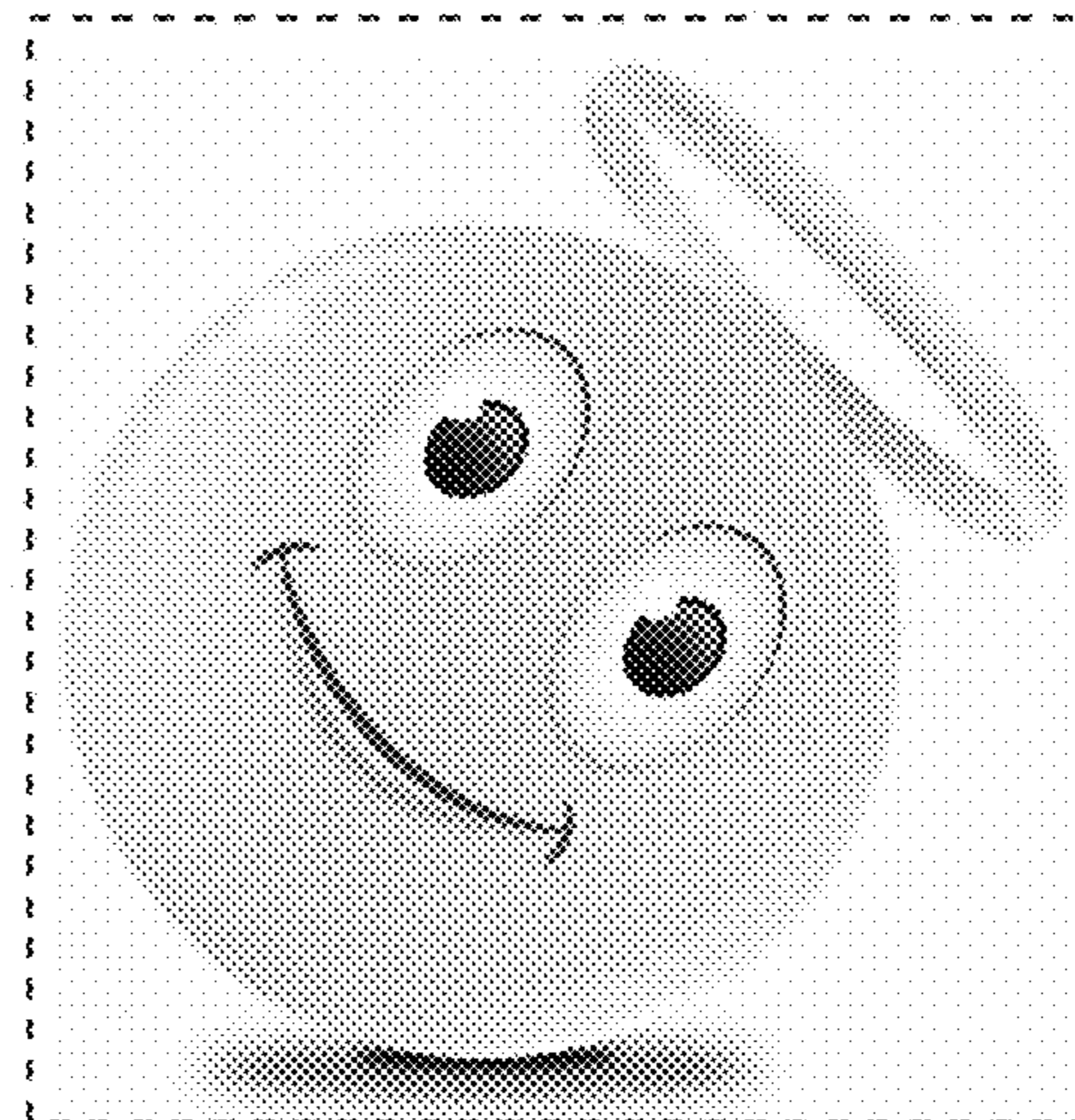
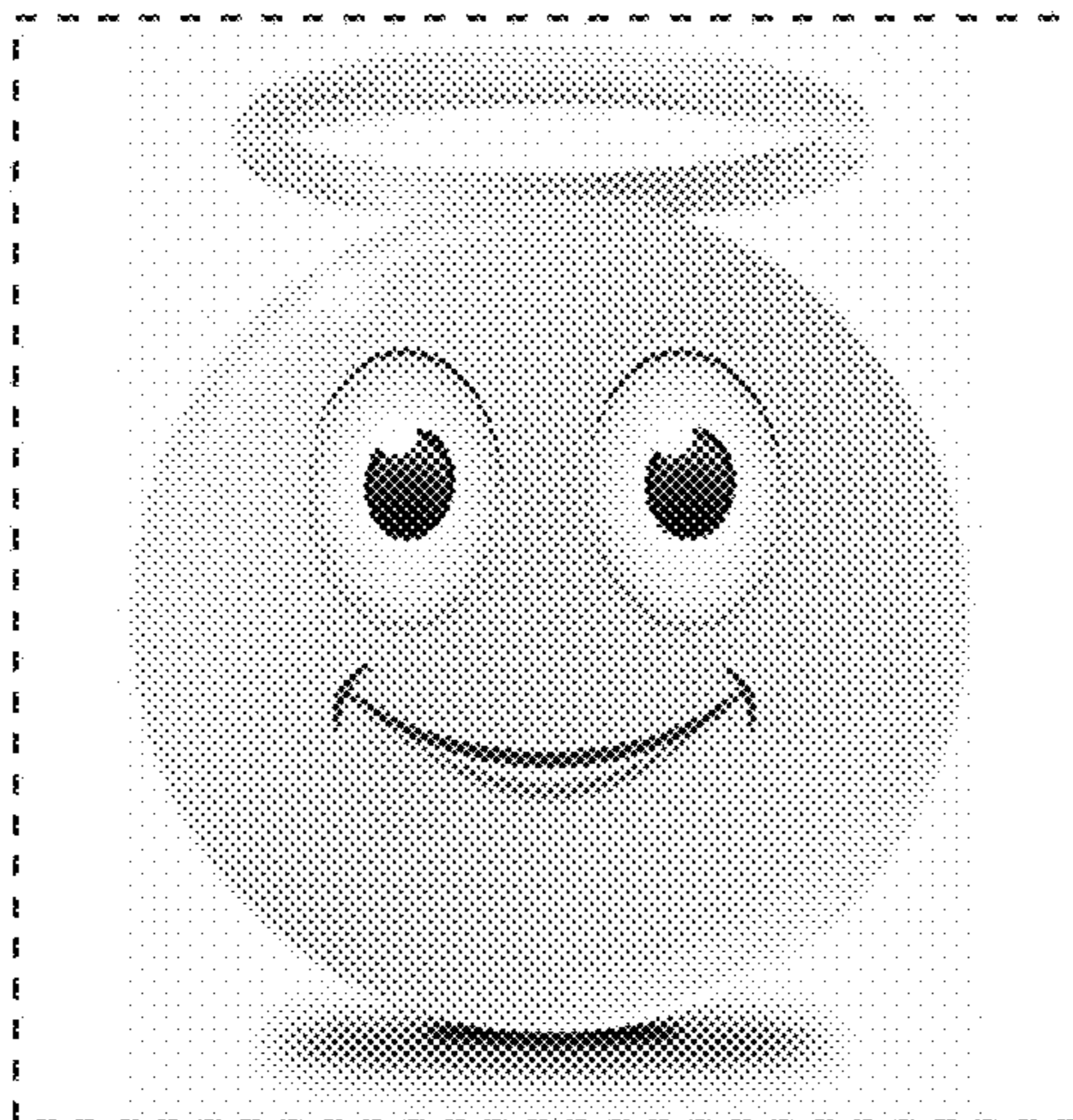
FIG. 4 is a front view of a fourth embodiment thereof;

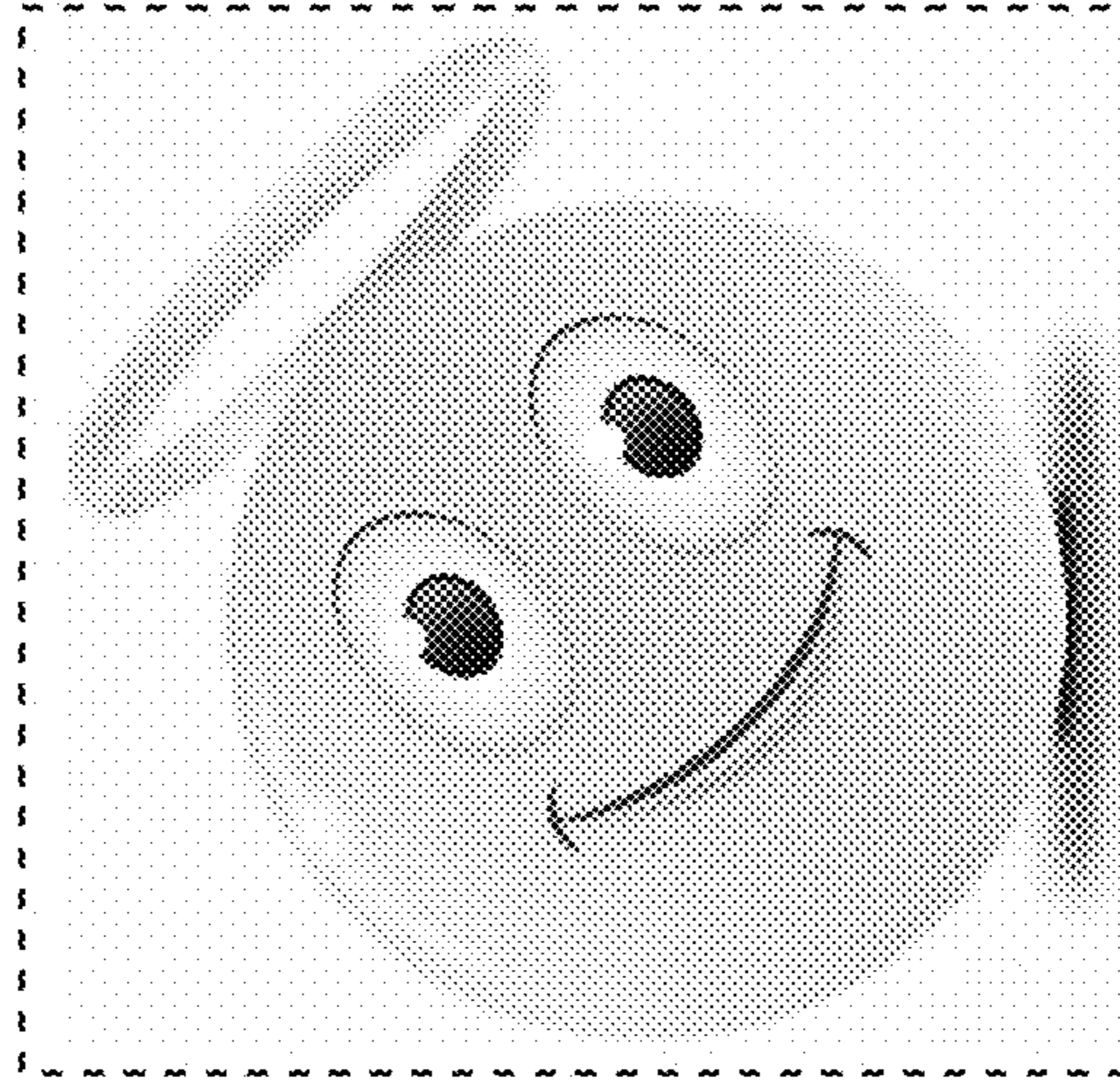

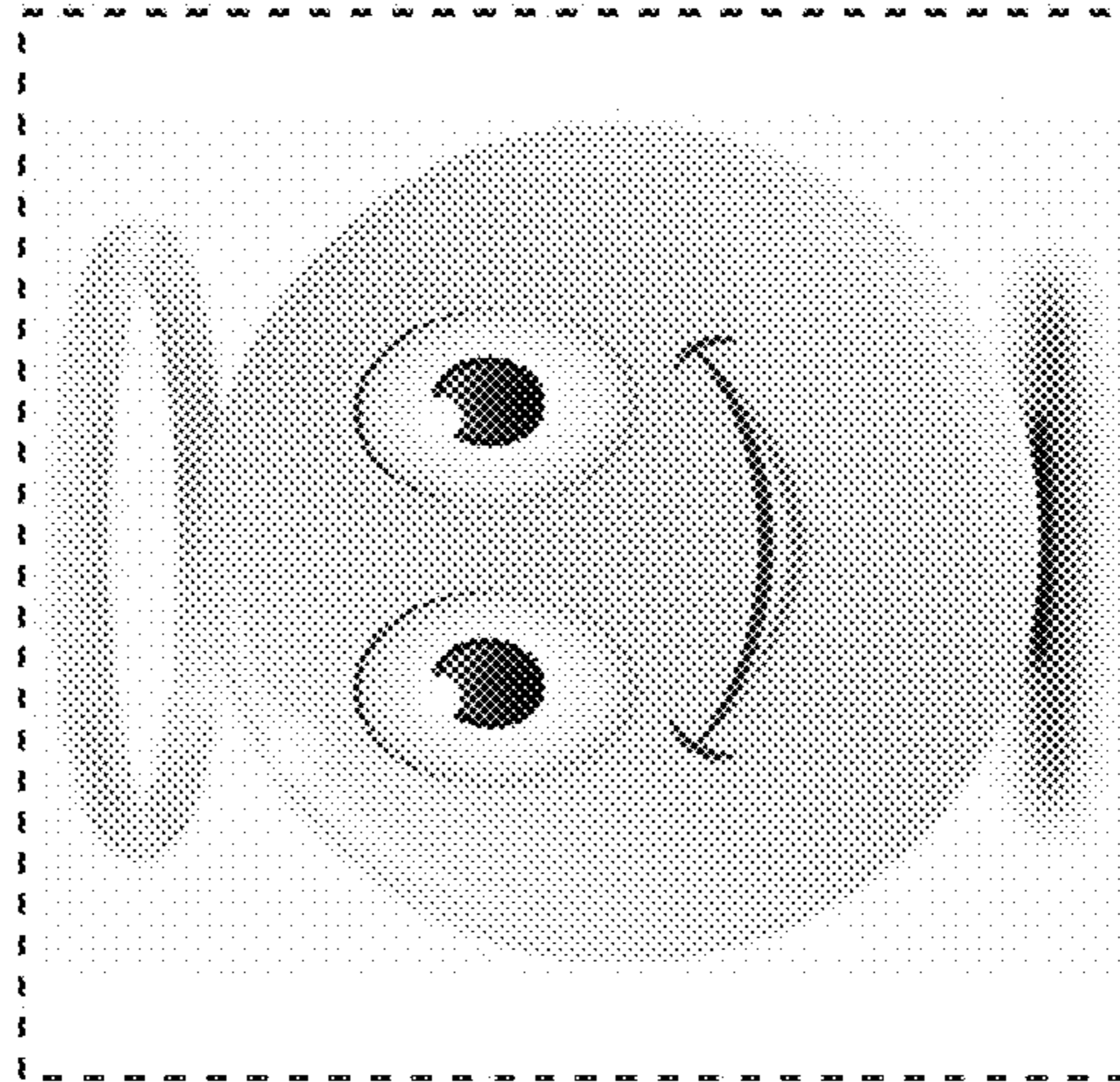

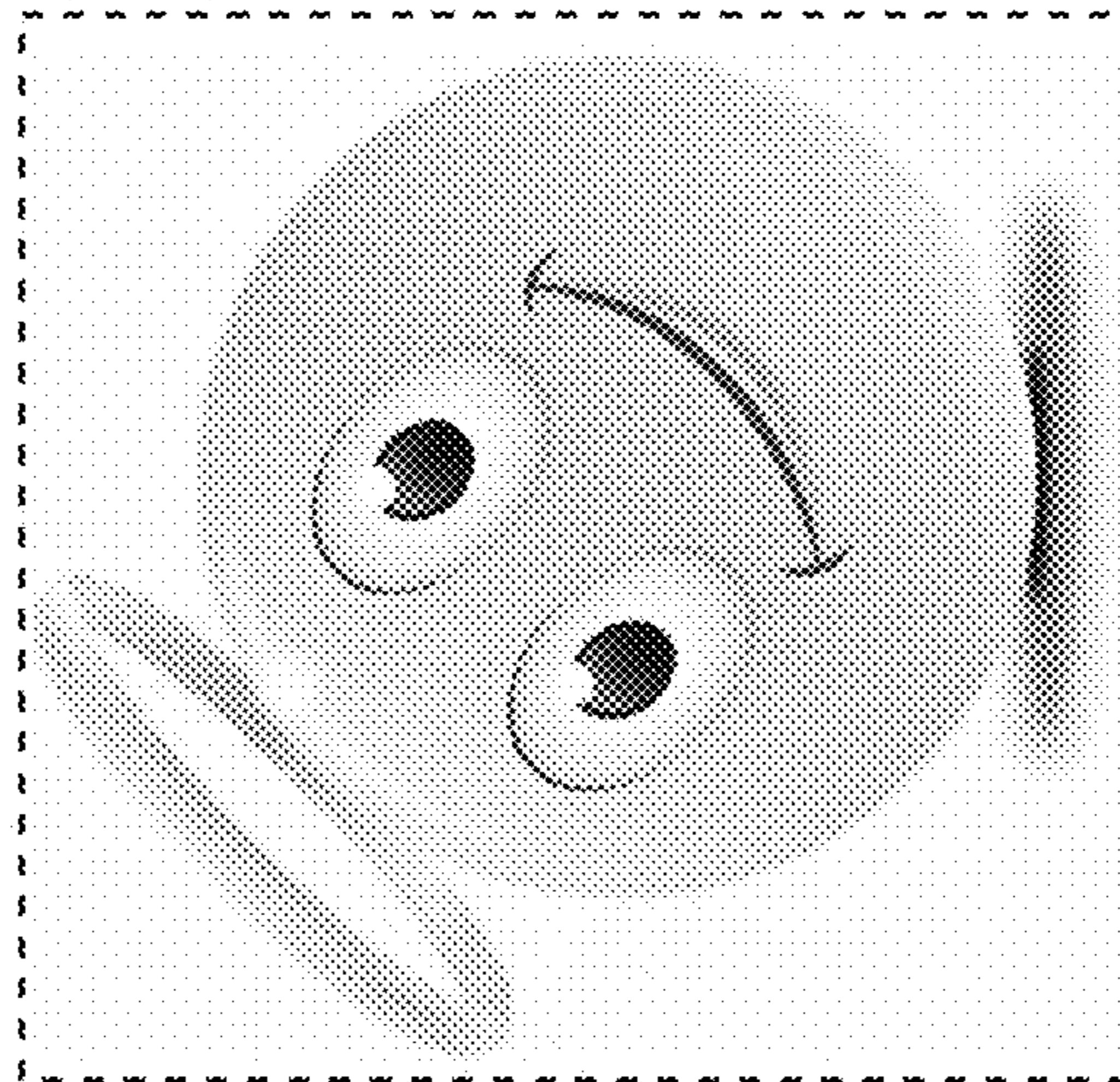

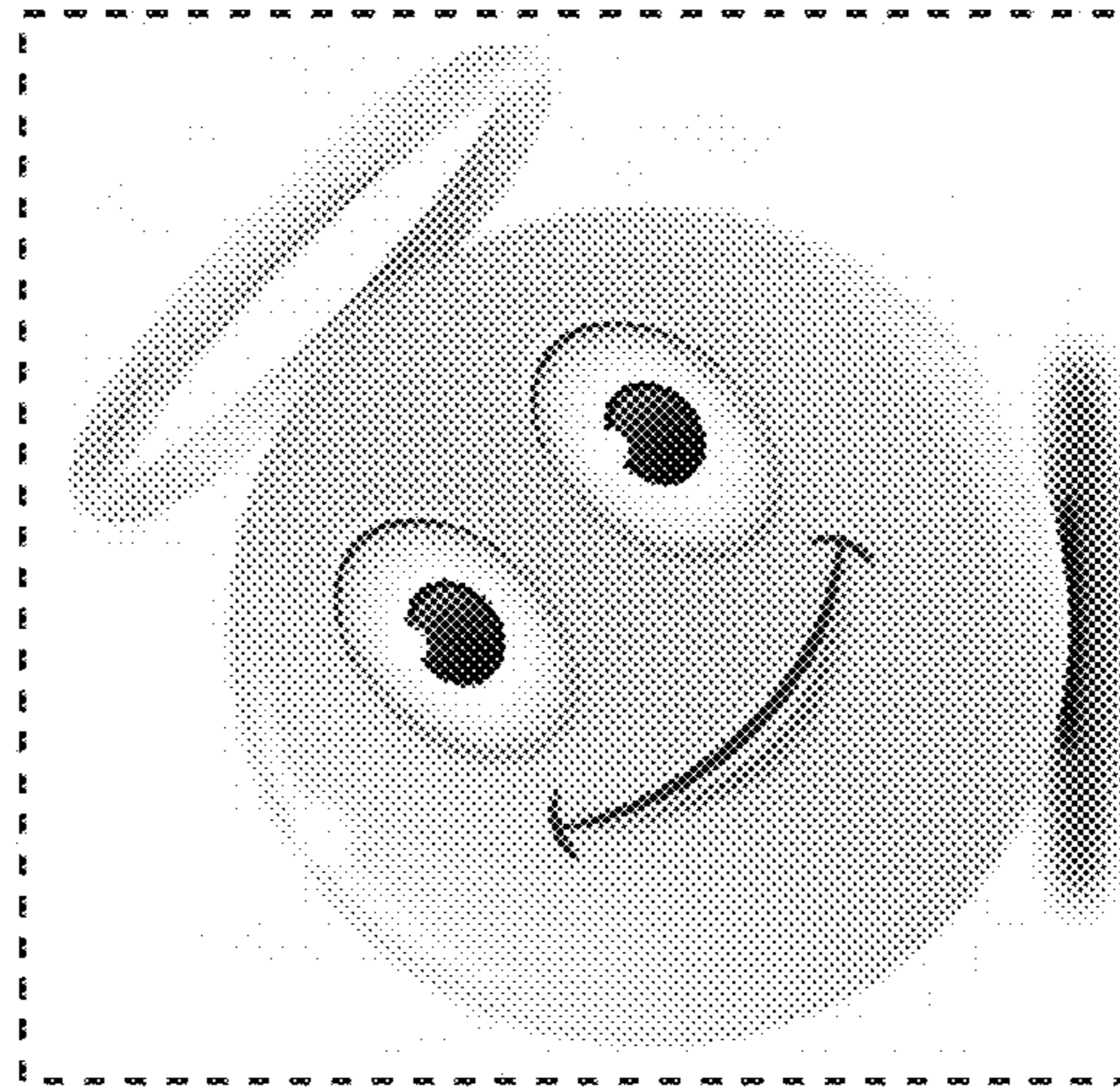

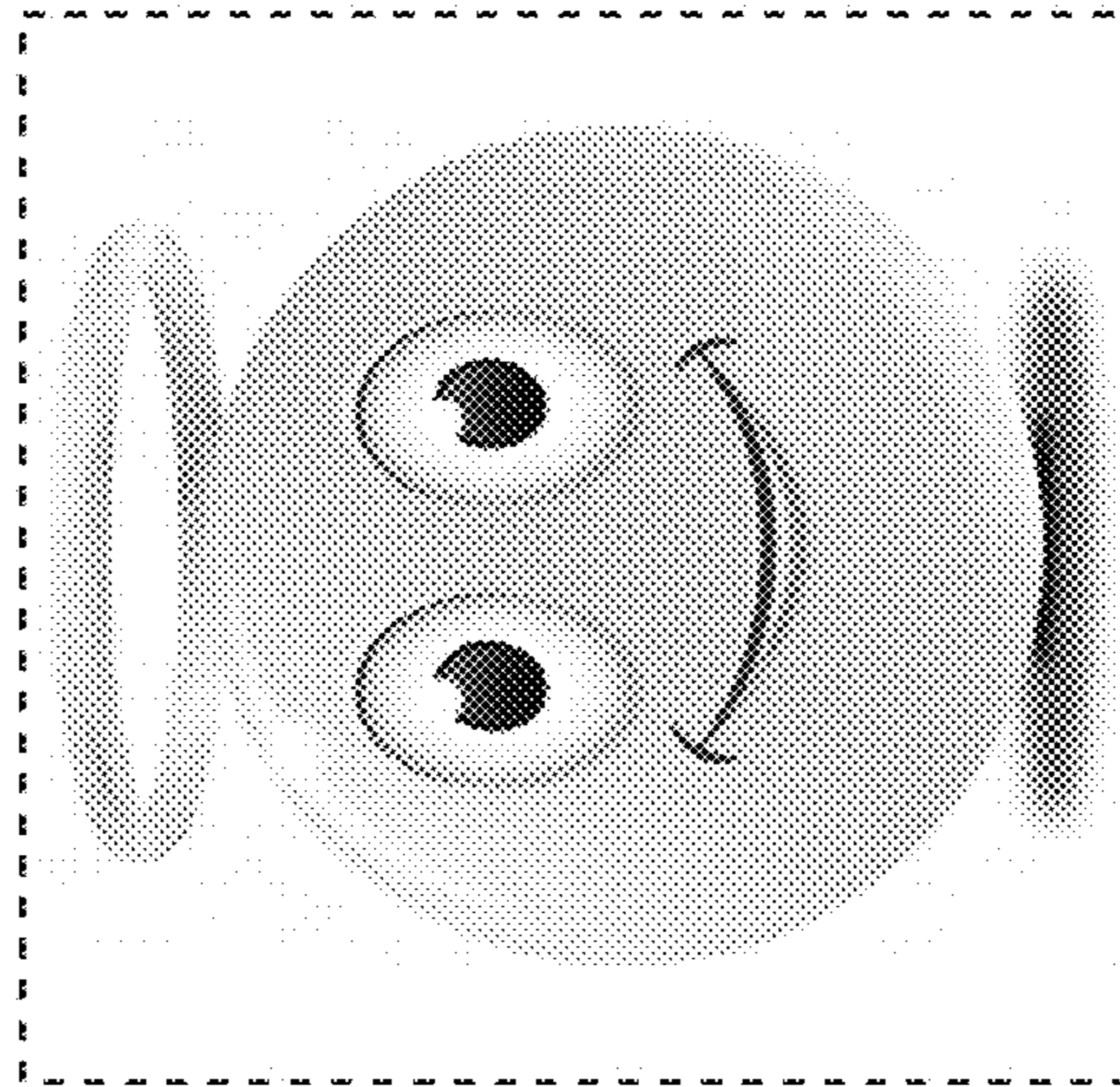

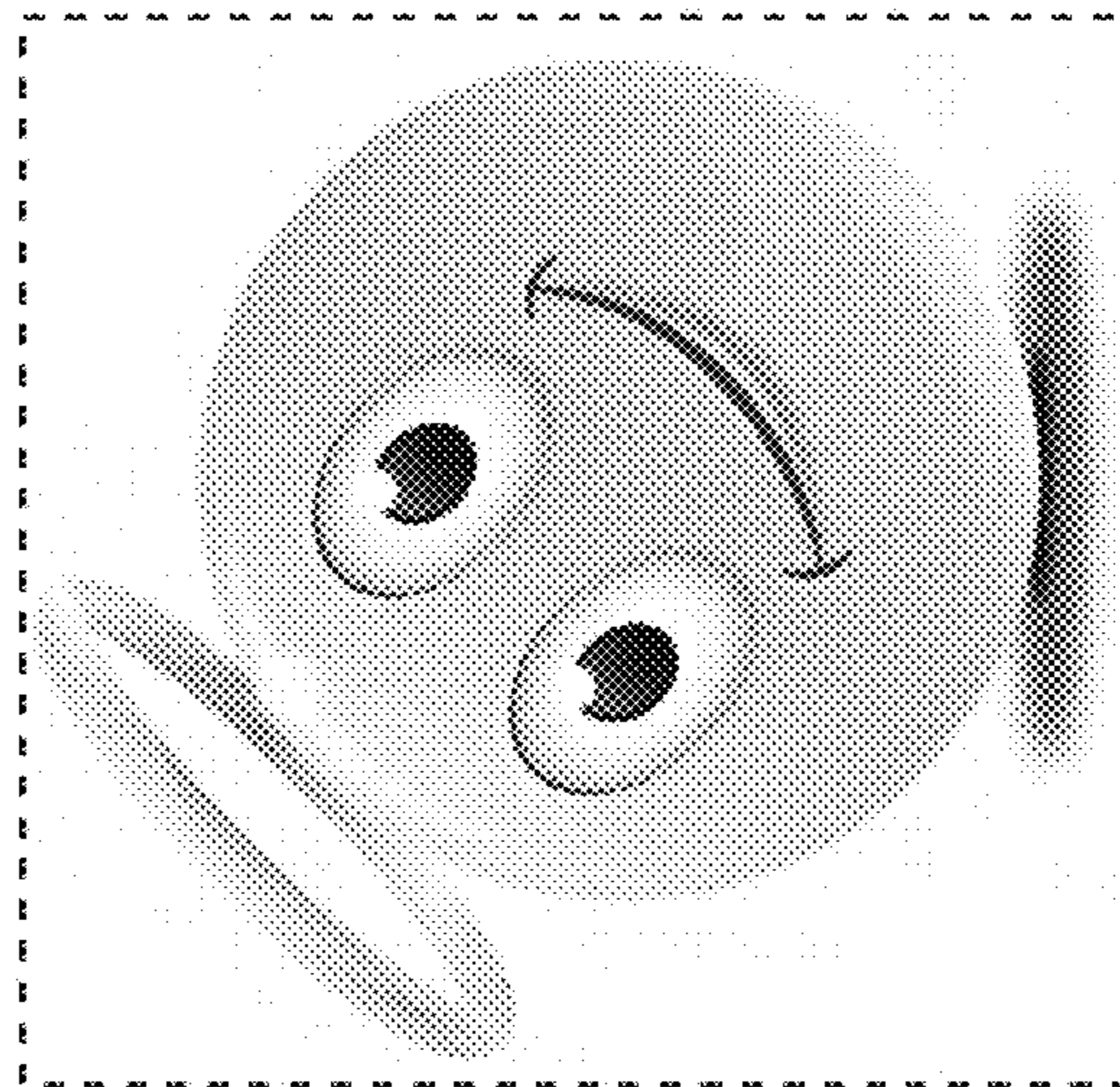
