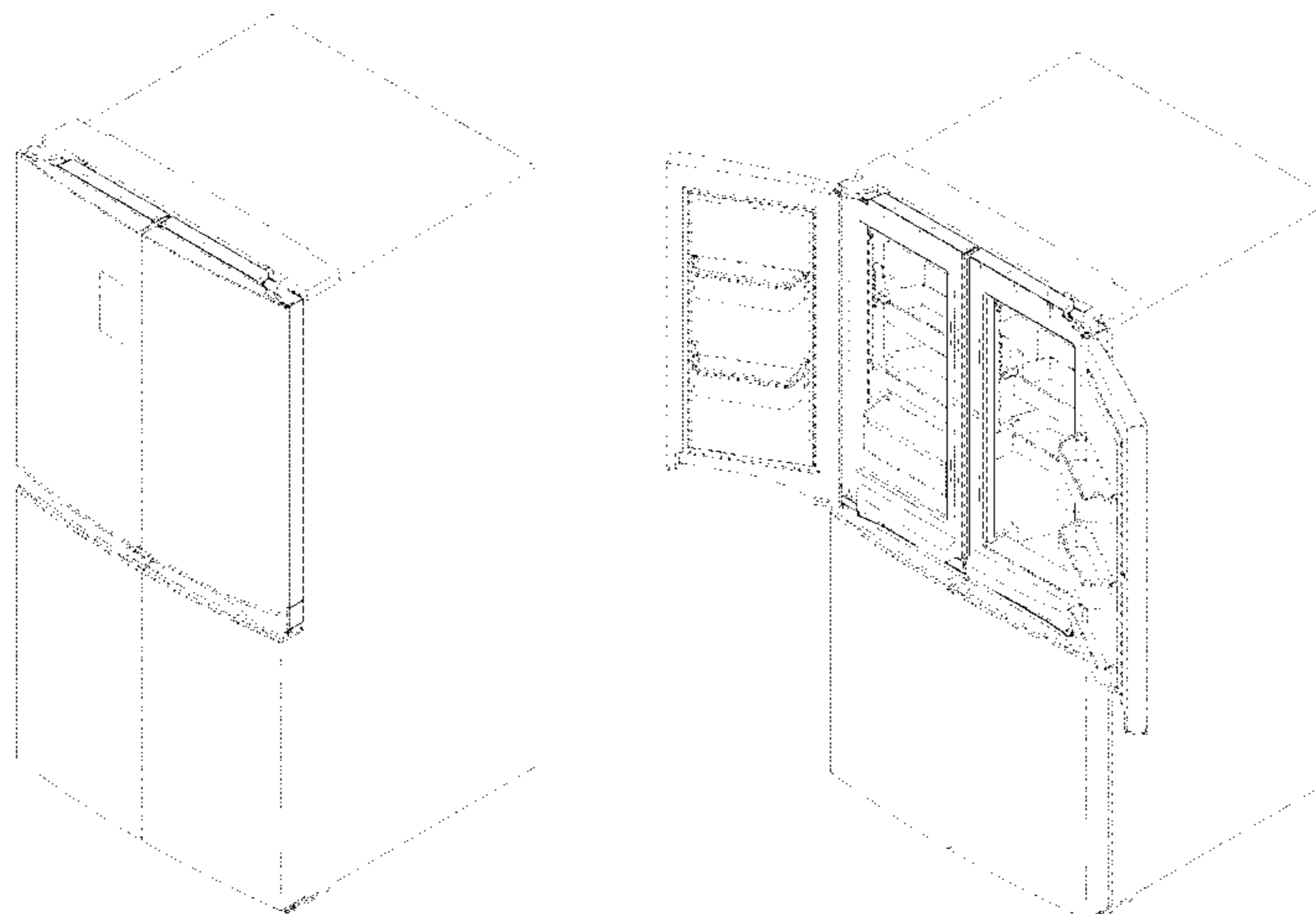
(57) **CLAIM**

The ornamental design for a refrigerator, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, perspective view of a refrigerator showing our new design shown in a closed condition; FIG. 2 is a front view thereof; FIG. 3 is a perspective view, shown in an open condition; and, FIG. 4 is a perspective view thereof, shown in another open condition. The broken lines shown in the drawings illustrate unclaimed portions of the refrigerator and form no part of the claimed design.

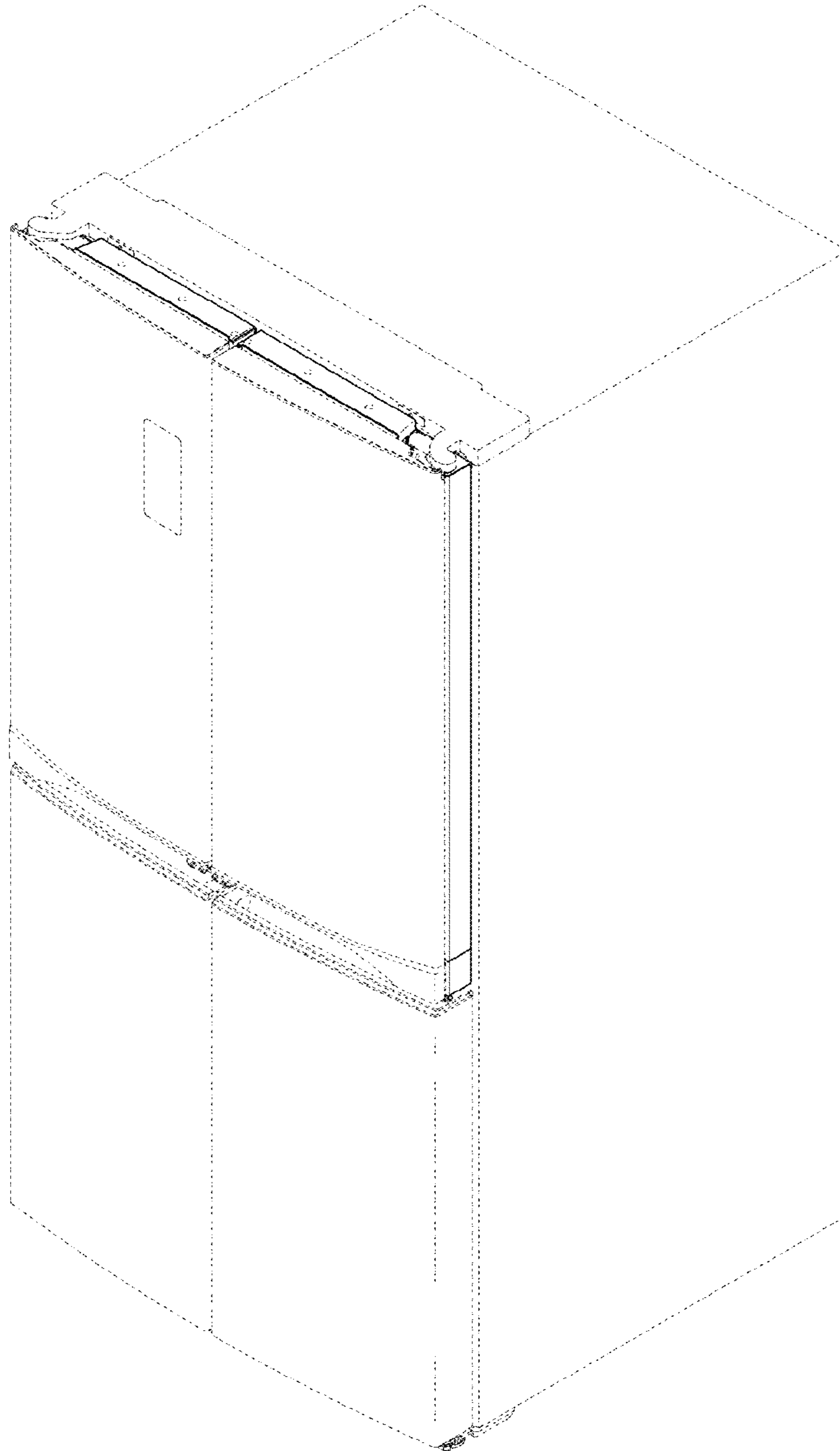

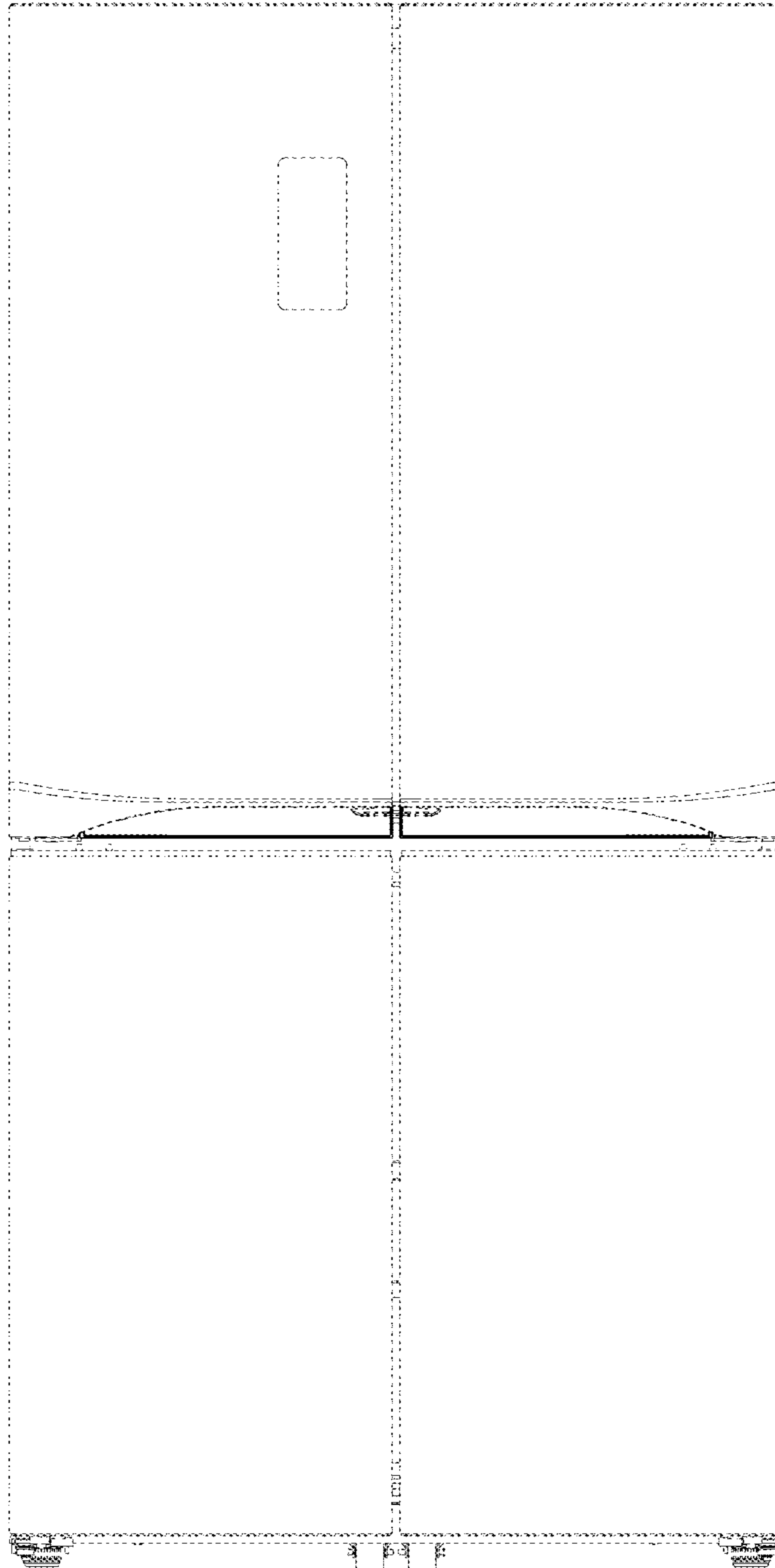

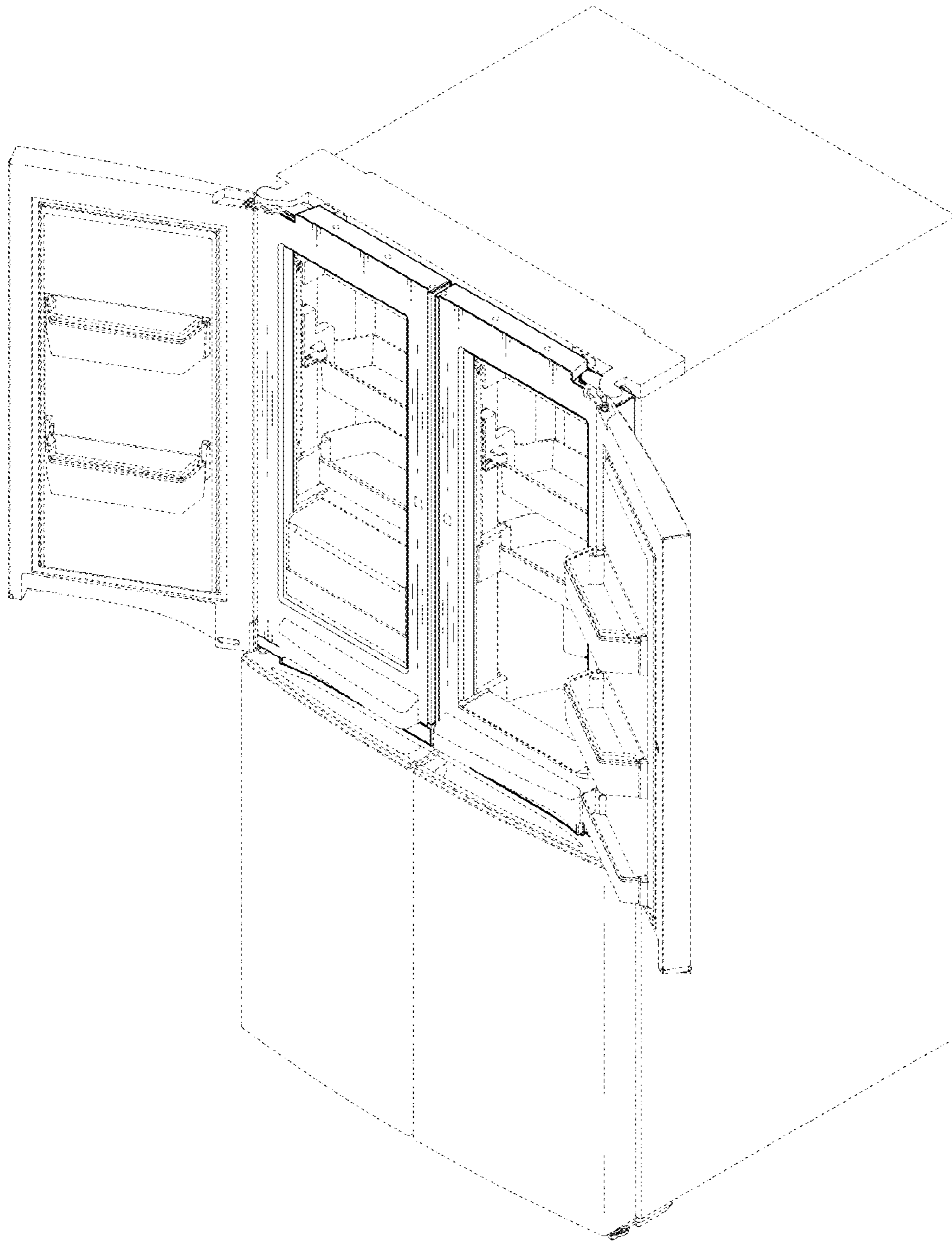
