DESCRIPTION

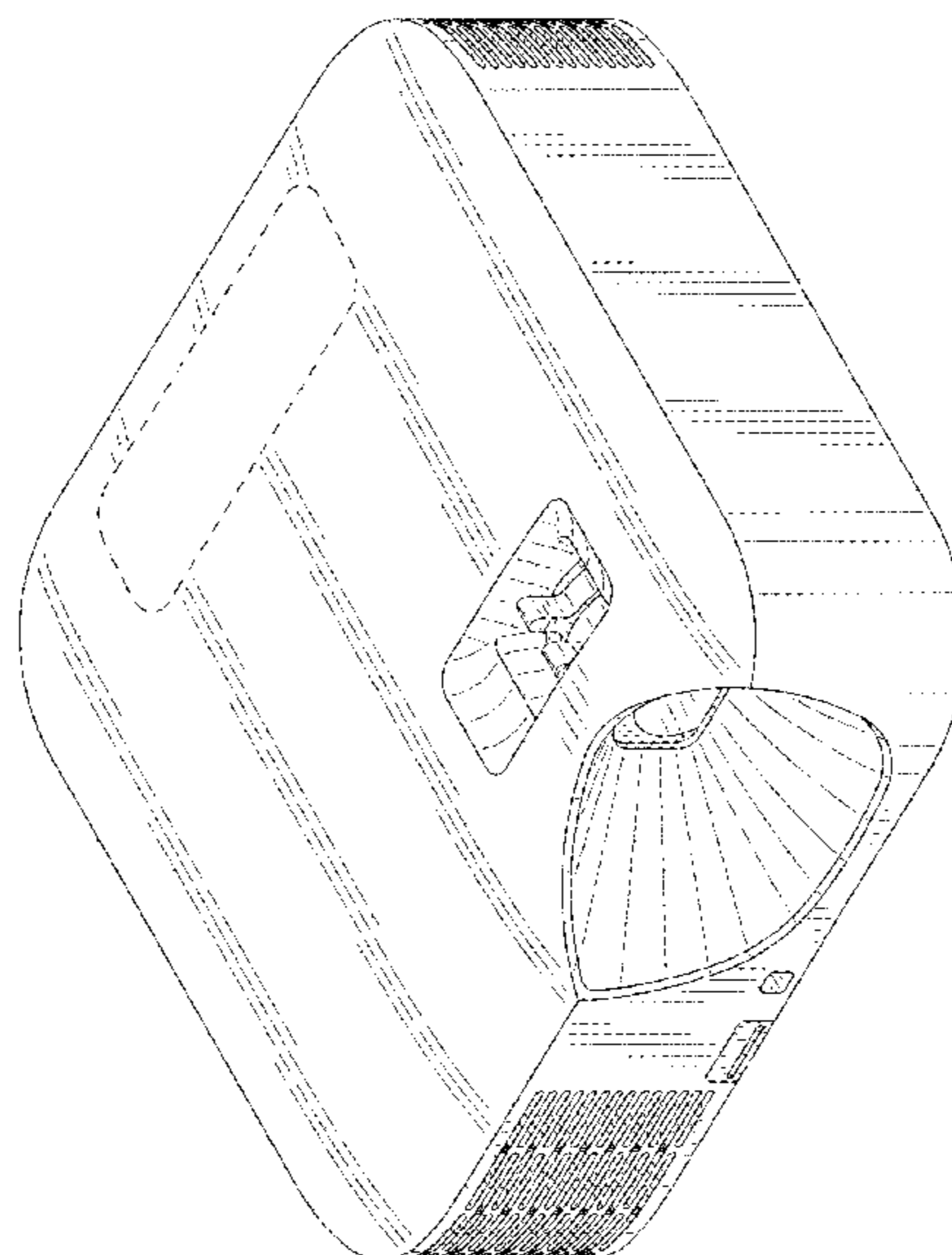

The broken lines shown in the figures are included for the purpose of illustrating portions of the projector and form no part of the claimed design.

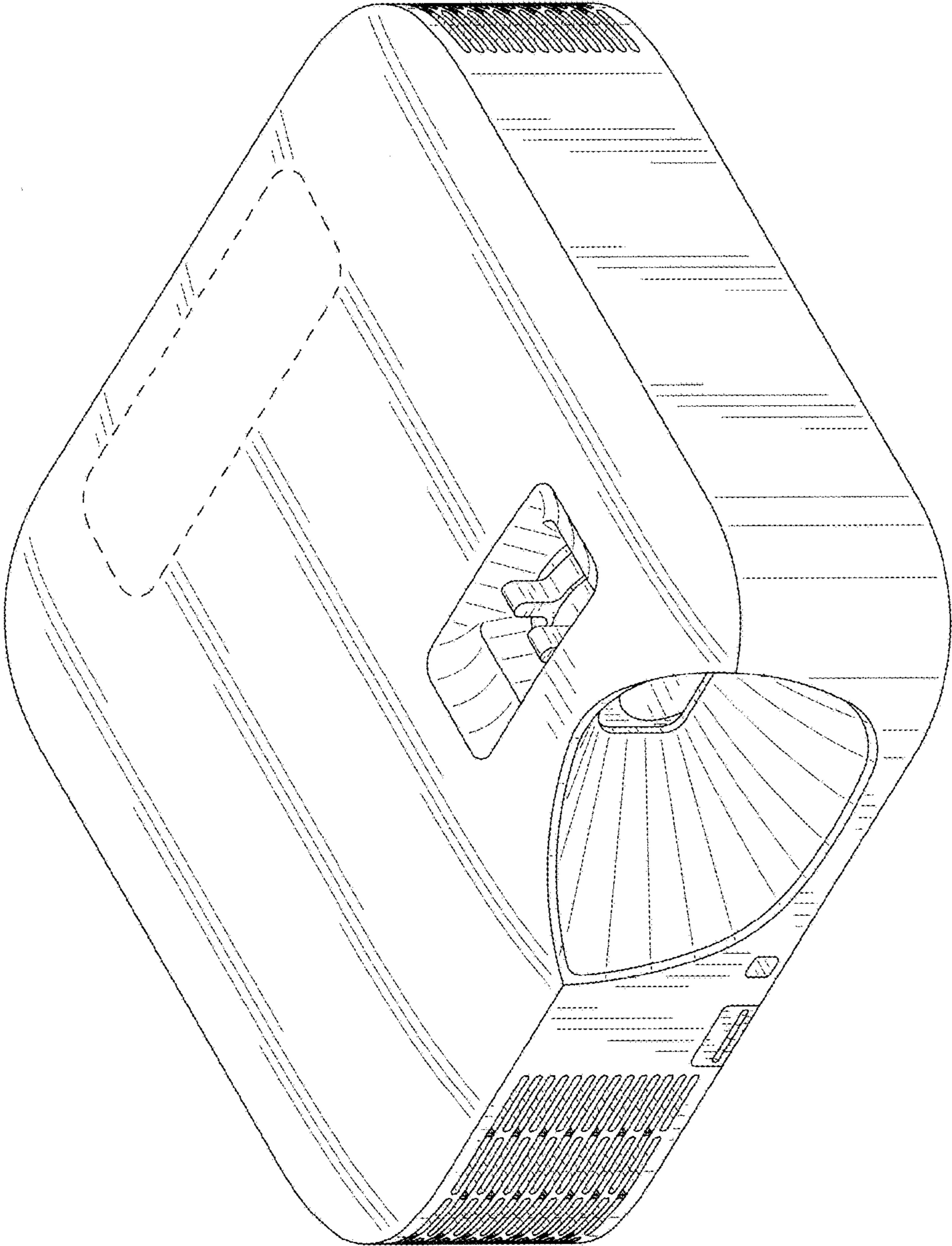

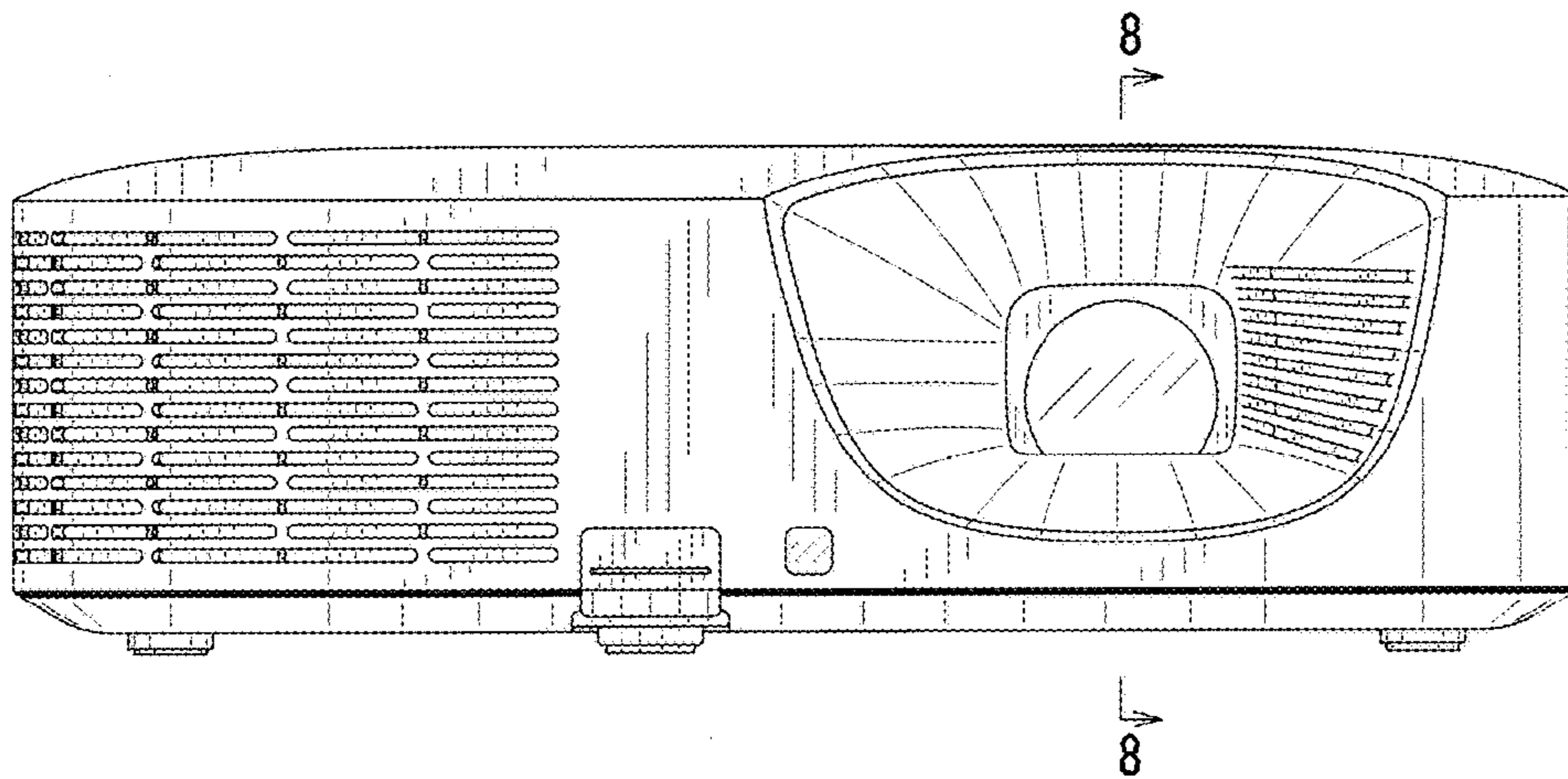

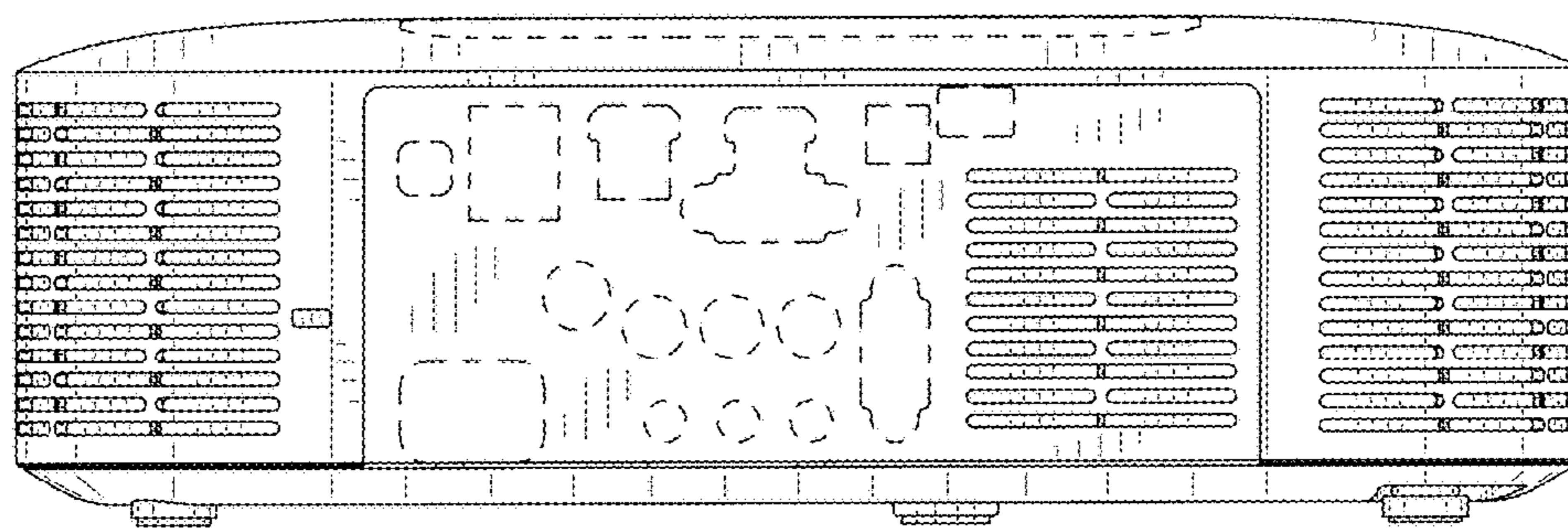

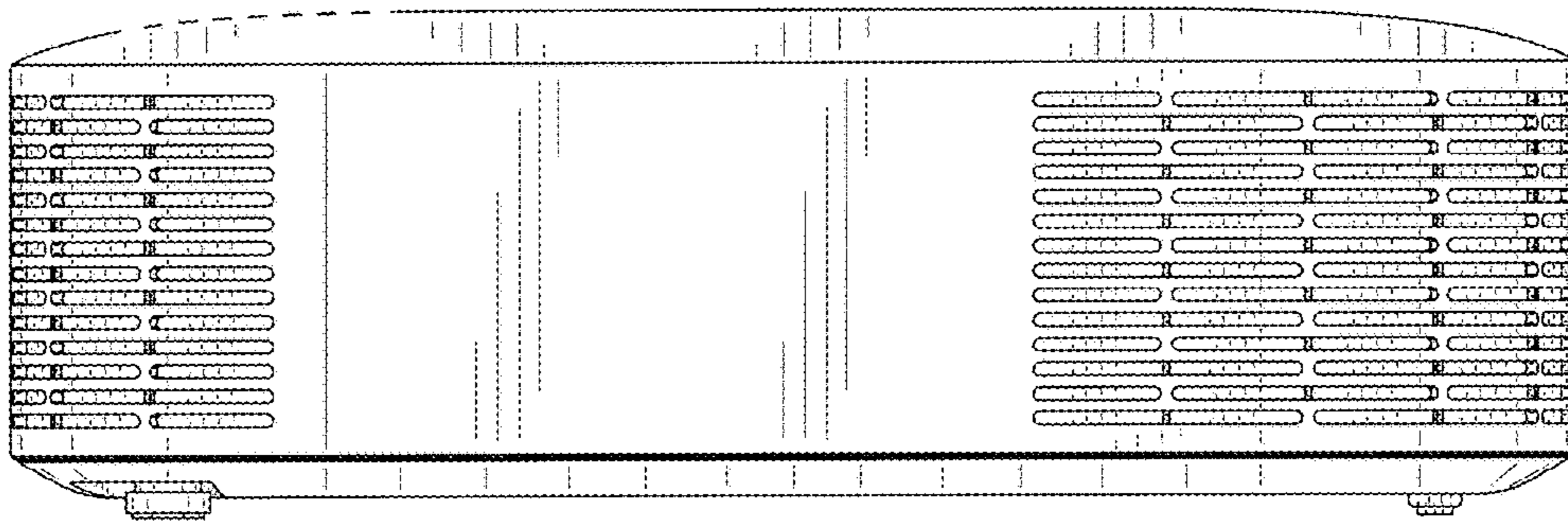

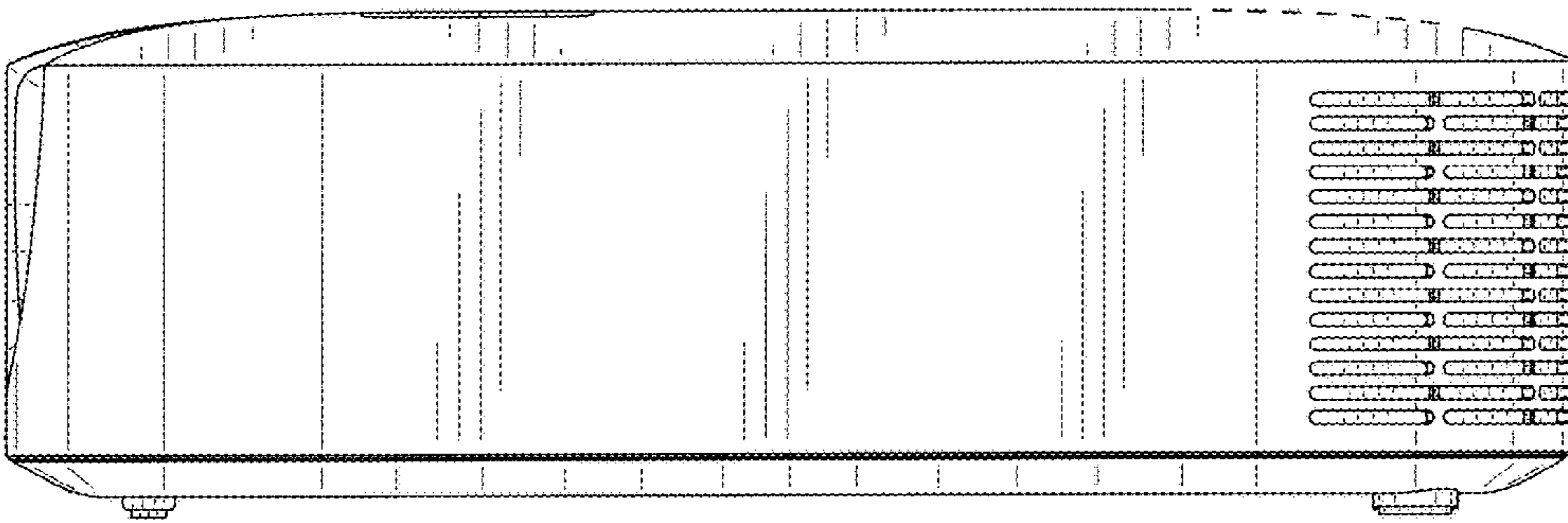

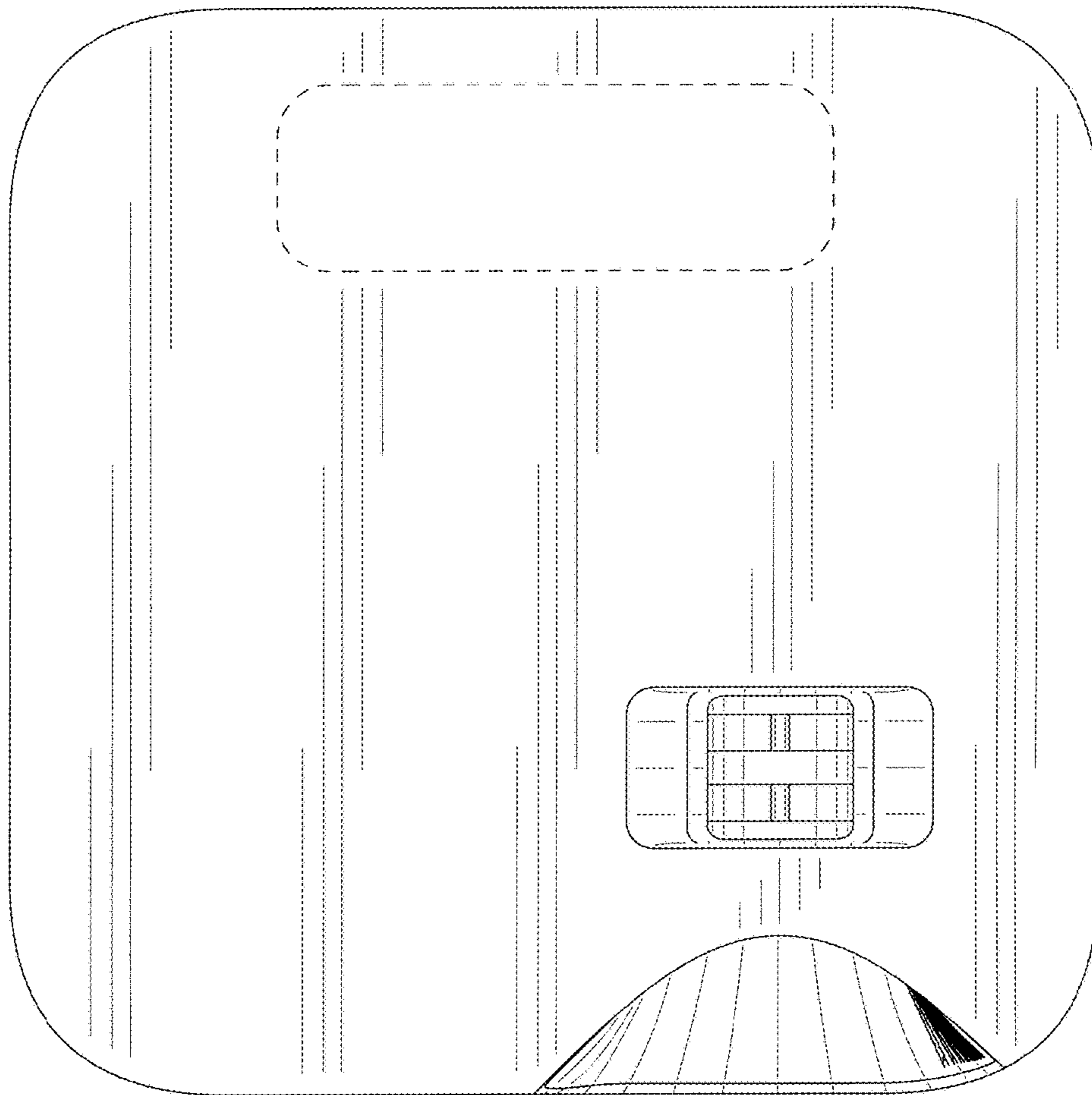

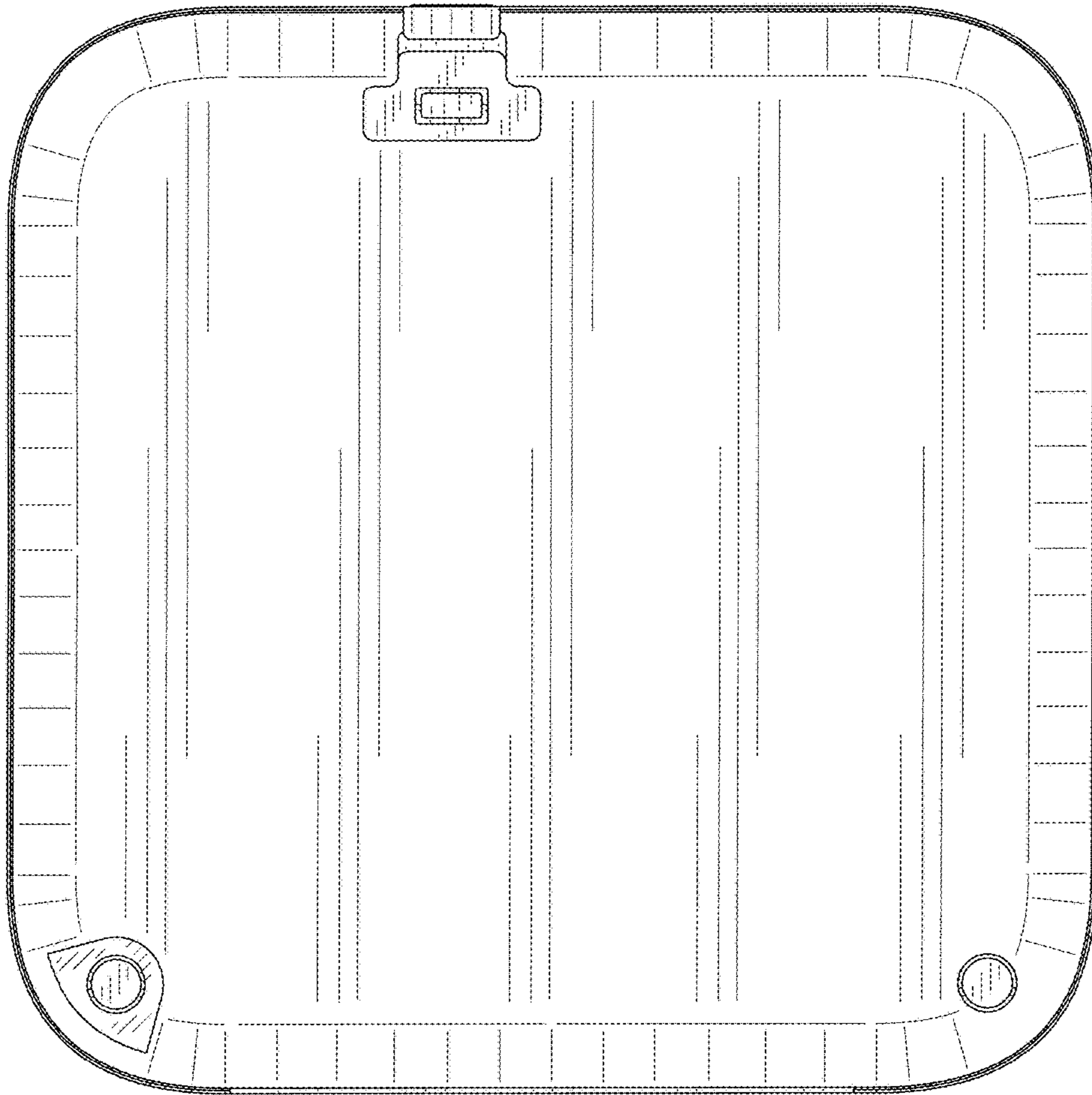

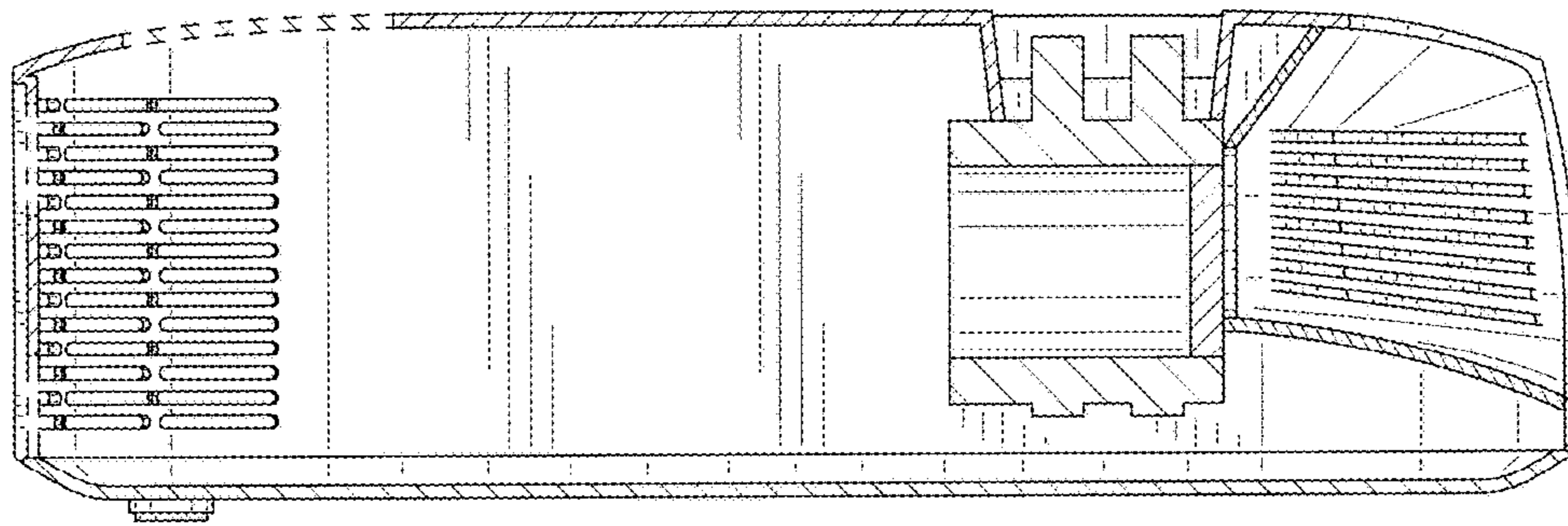
