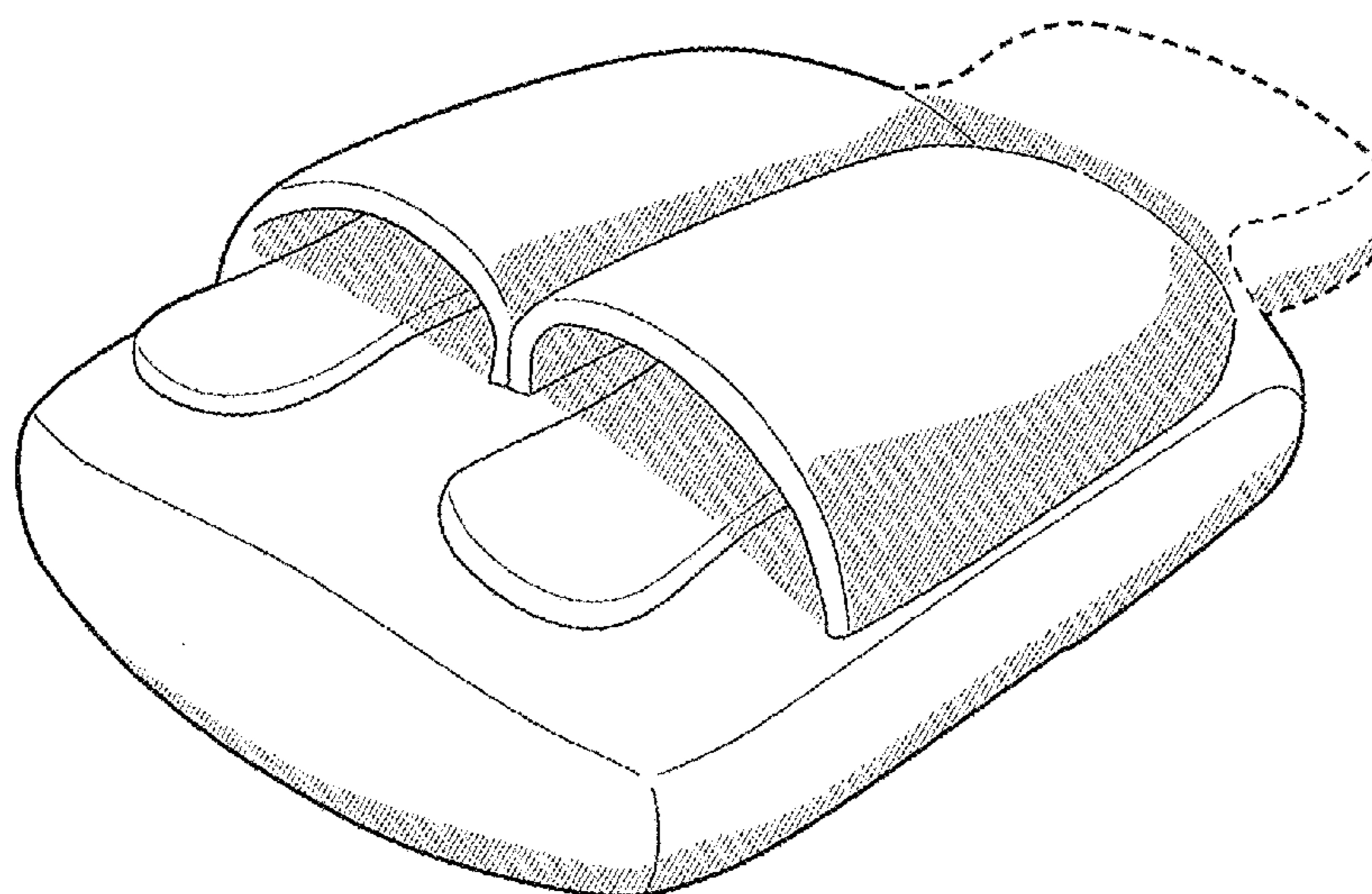
(57) **CLAIM**

The ornamental design for a hot water bottle cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hot water bottle cover, wherein the broken lines represent environment only and form no part of the claimed design;
FIG. 2 is a top view thereof;
FIG. 3 is a right side view thereof, the left side being a mirror image;
FIG. 4 is a bottom view thereof;

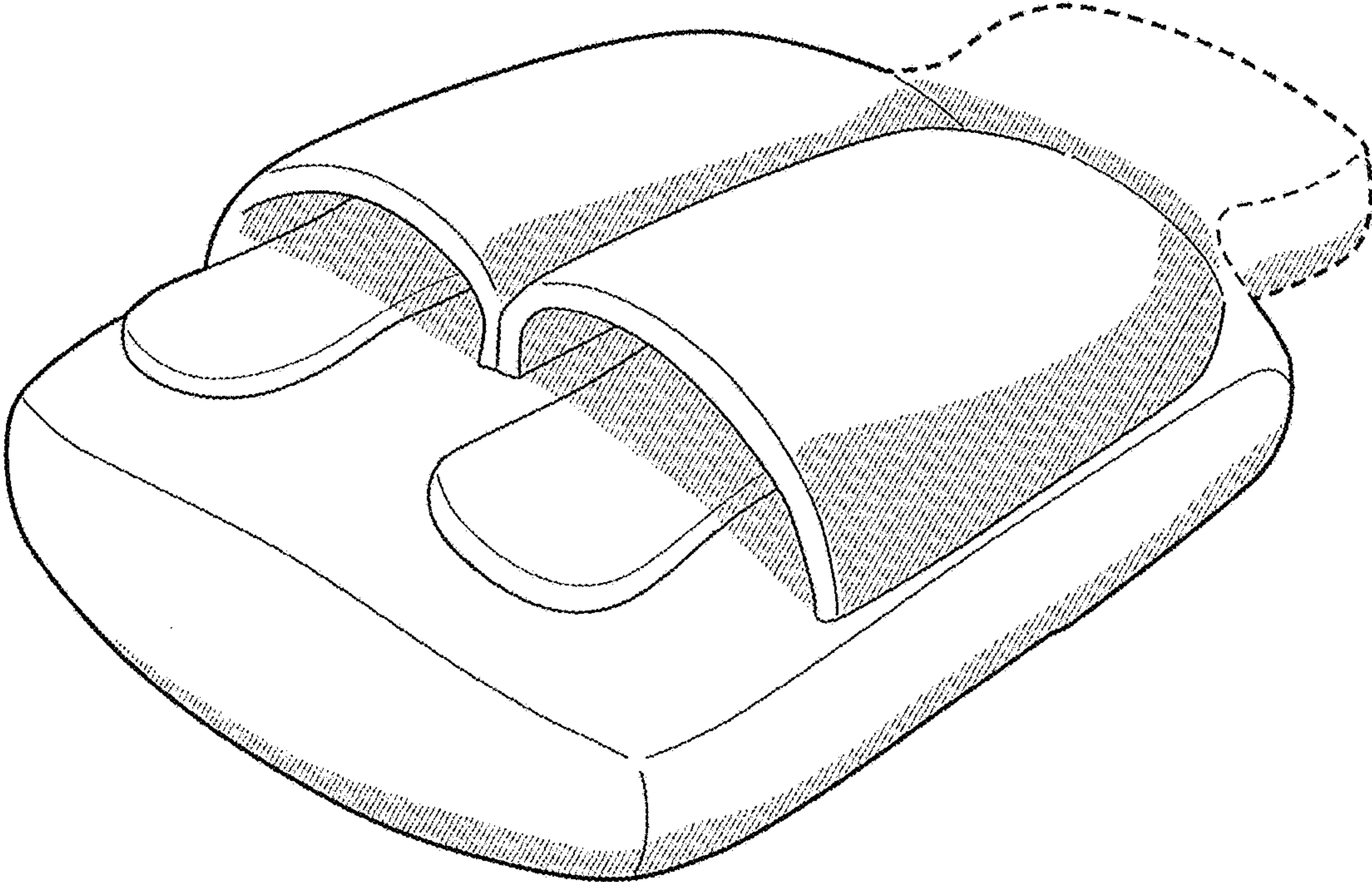

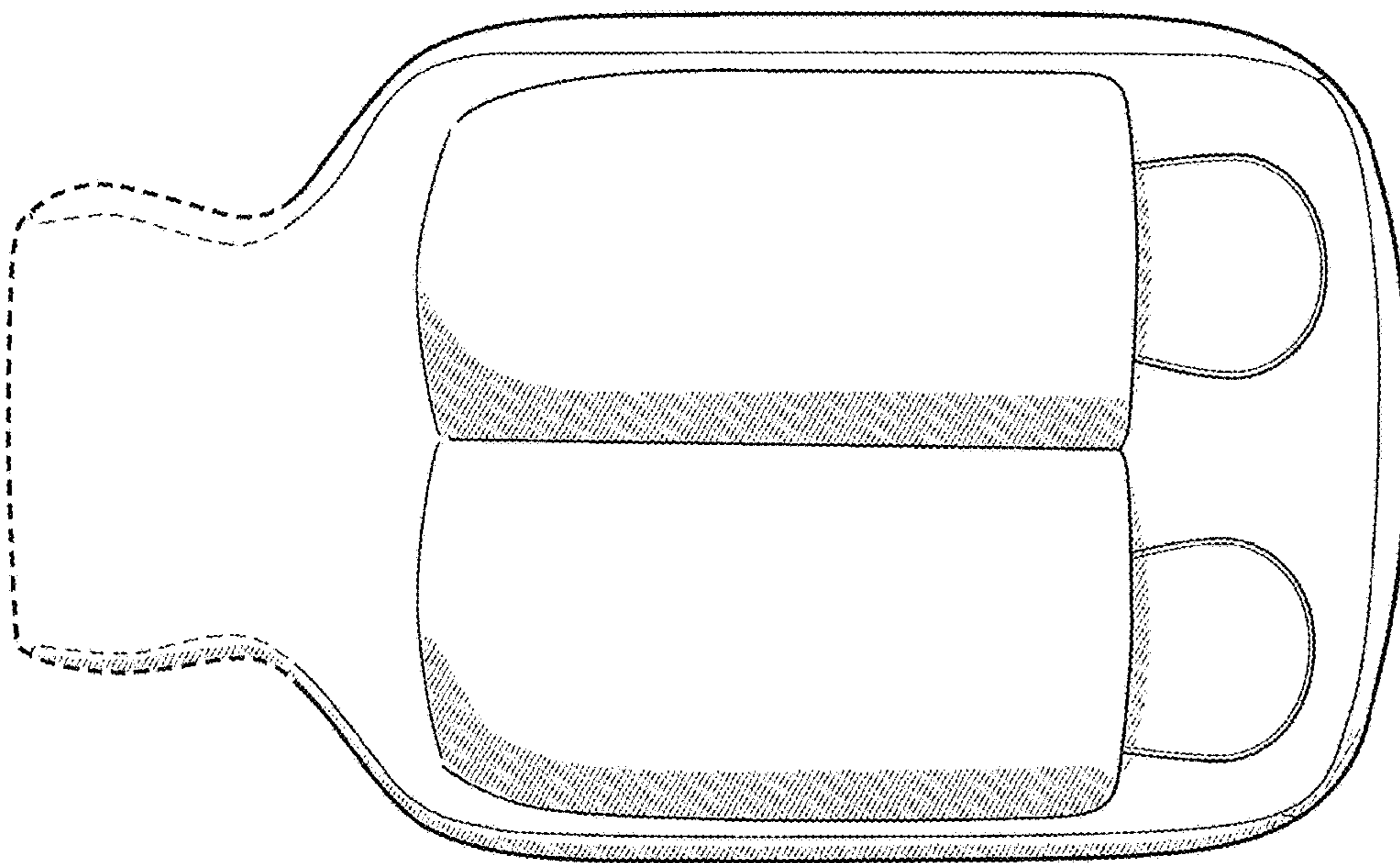

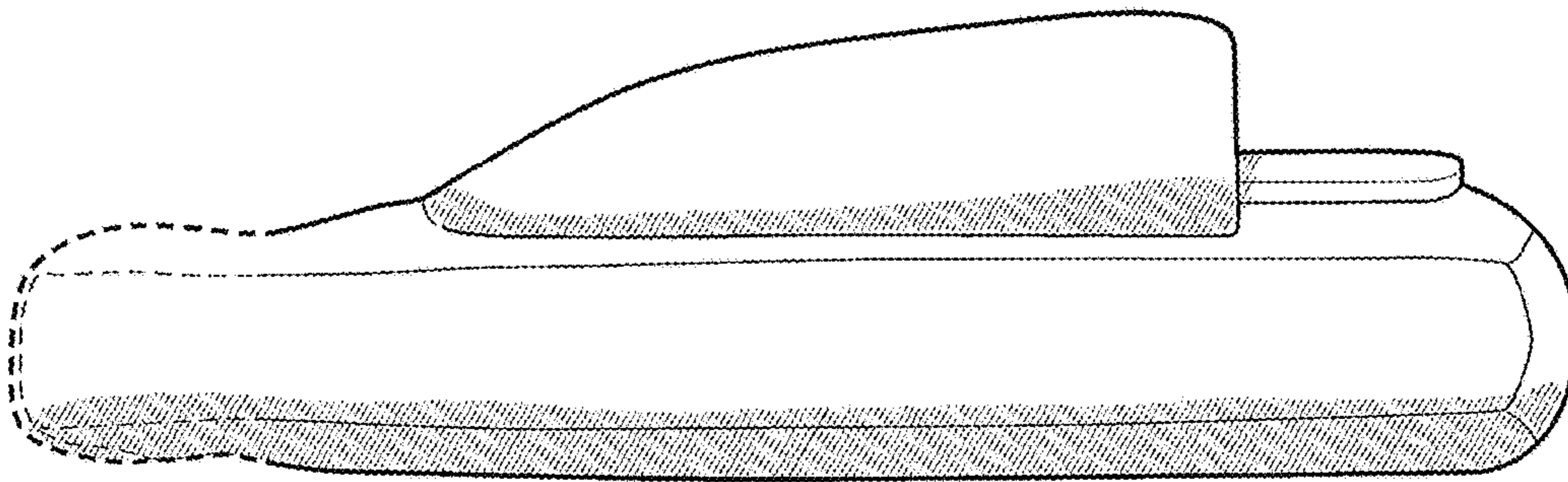

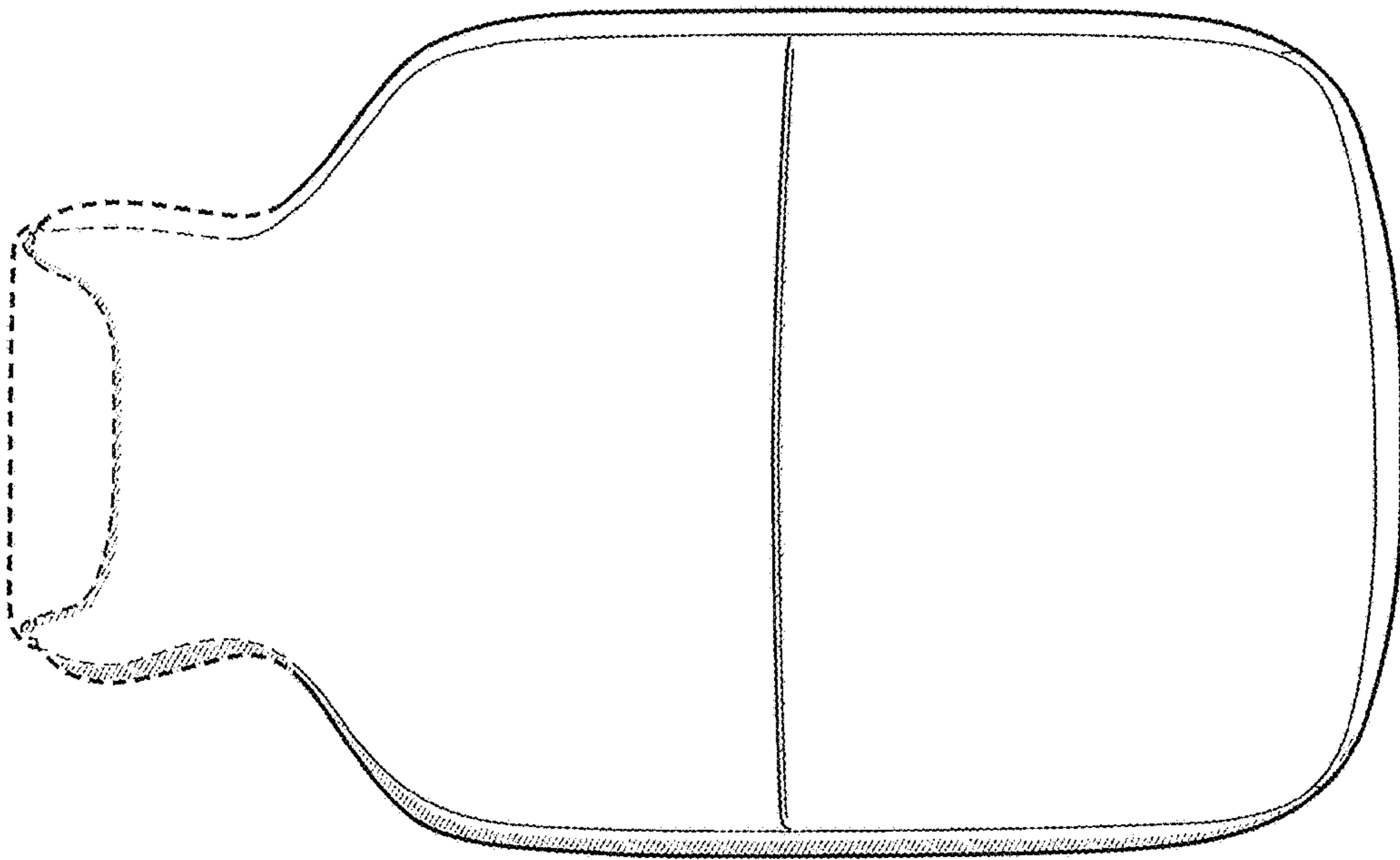

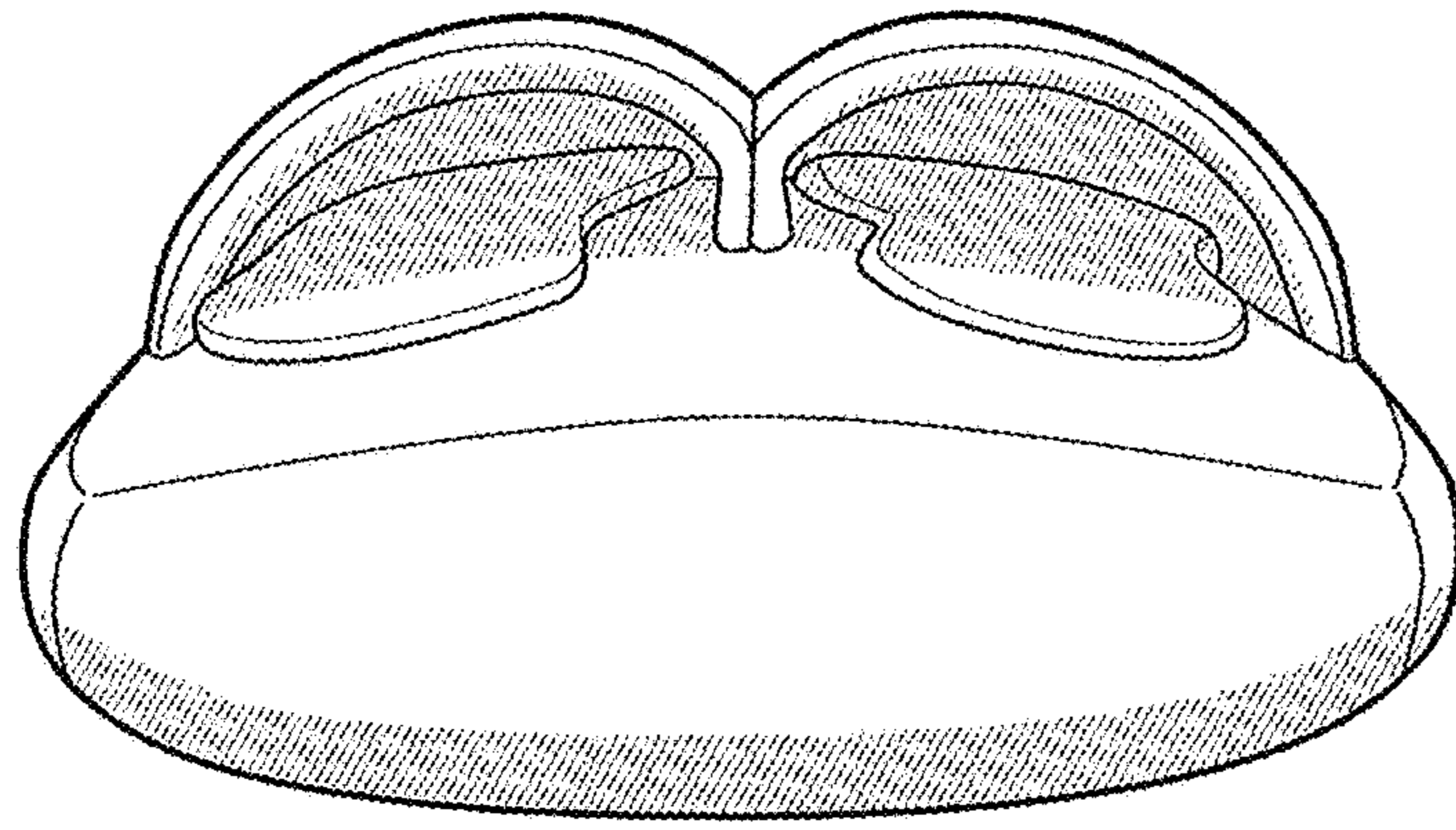

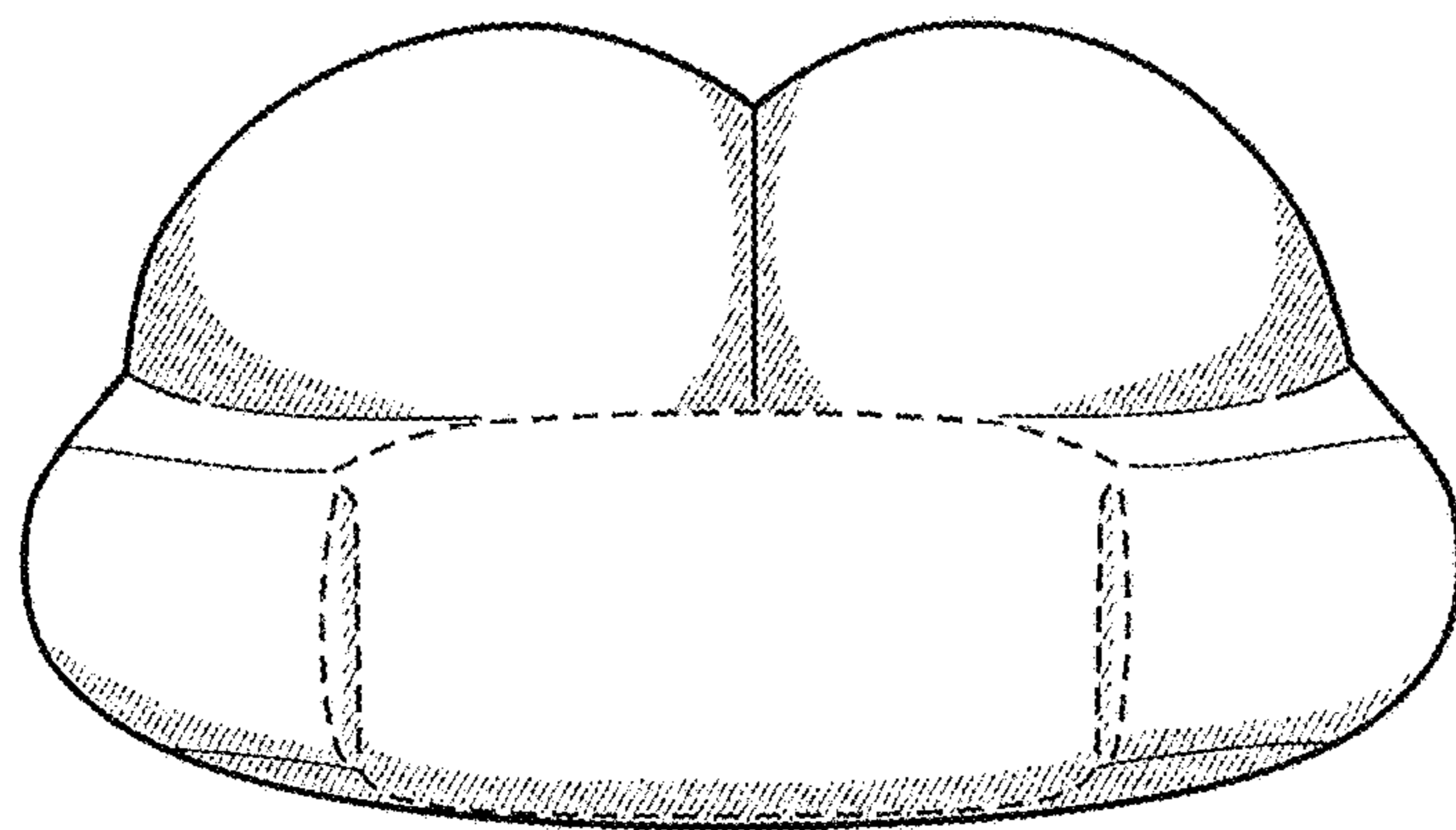
