FIG. 18 is a side view depicting a third embodiment of a curved armor plate;

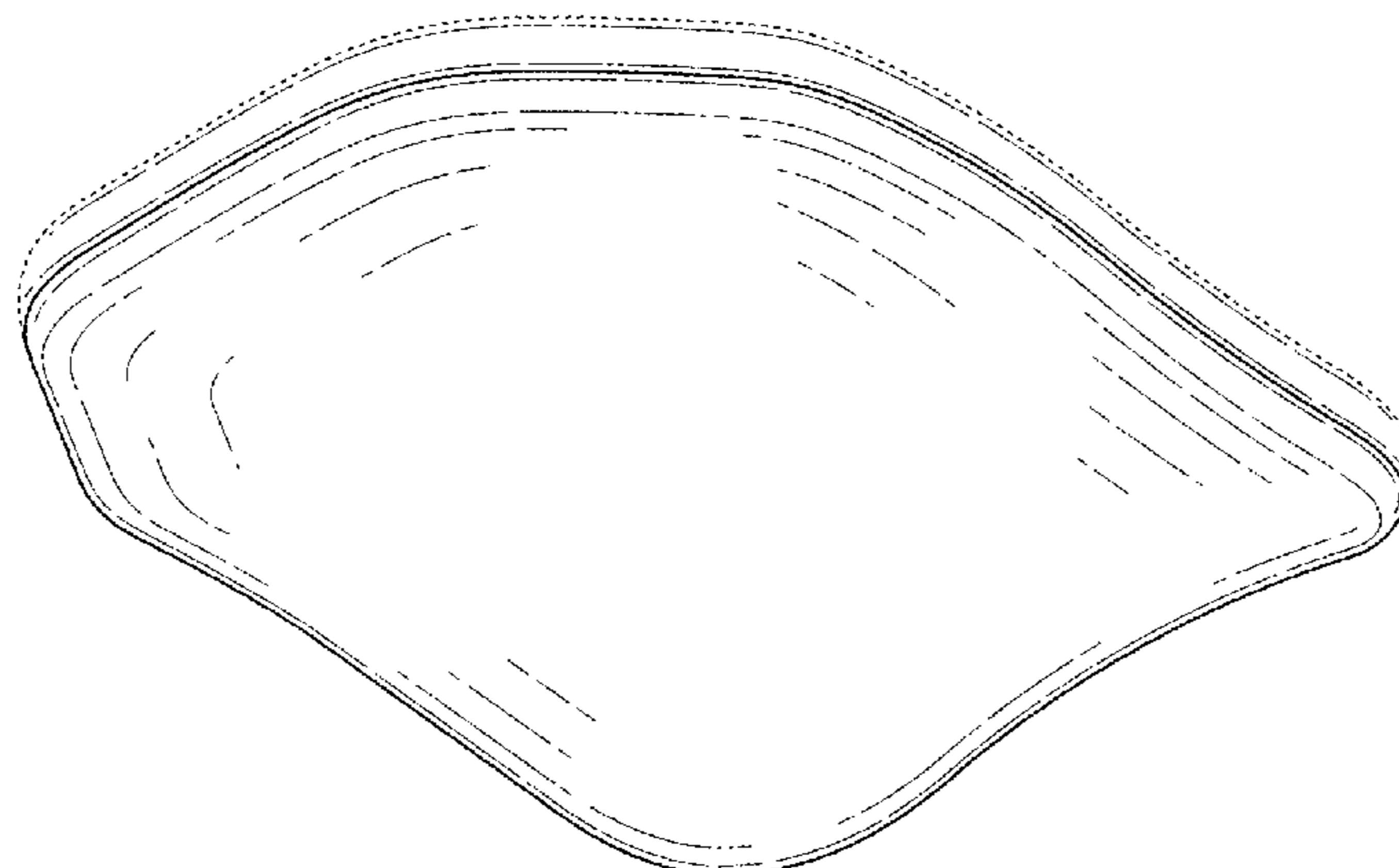
FIG. 19 is a side view depicting a third embodiment of a curved armor plate;

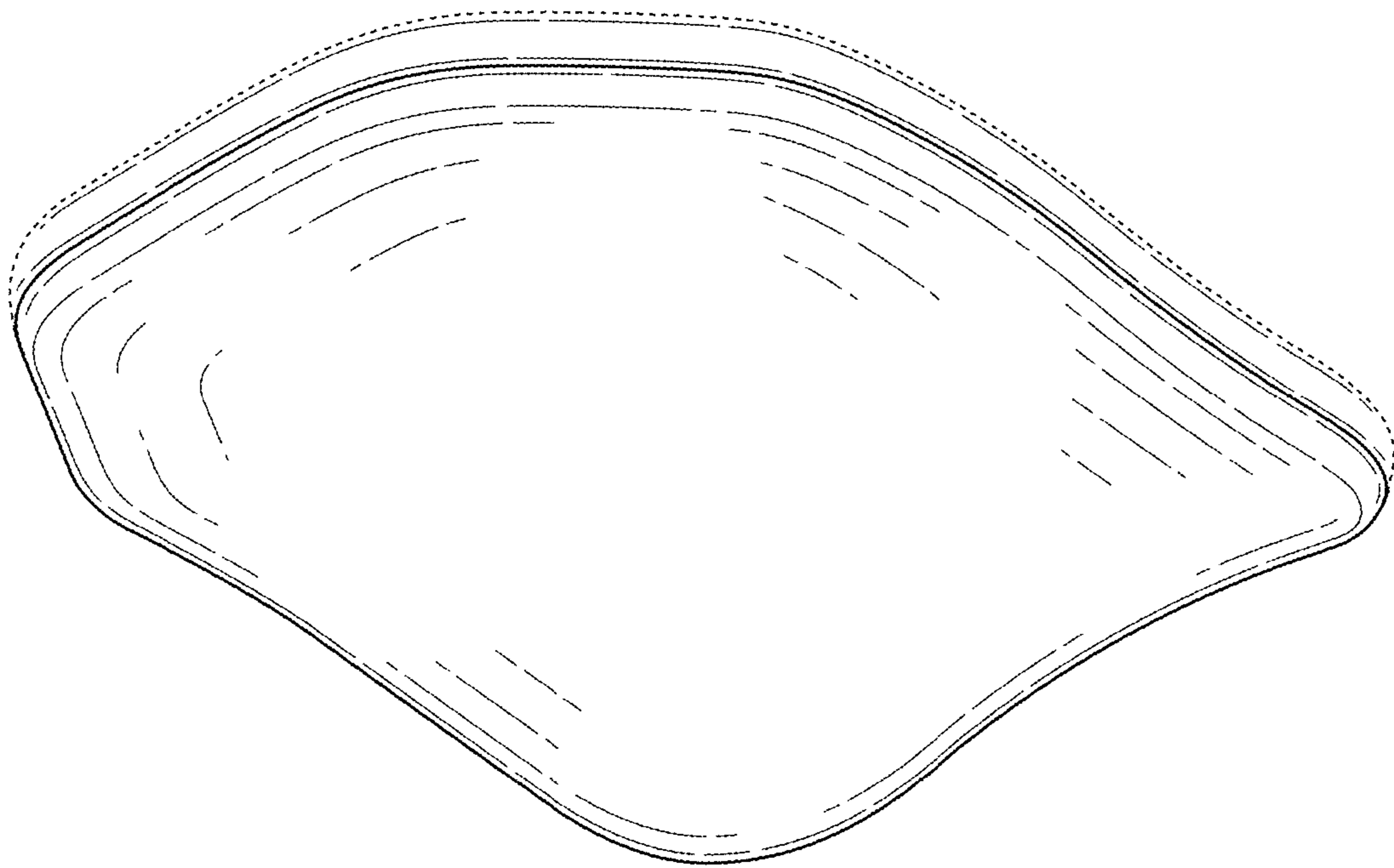

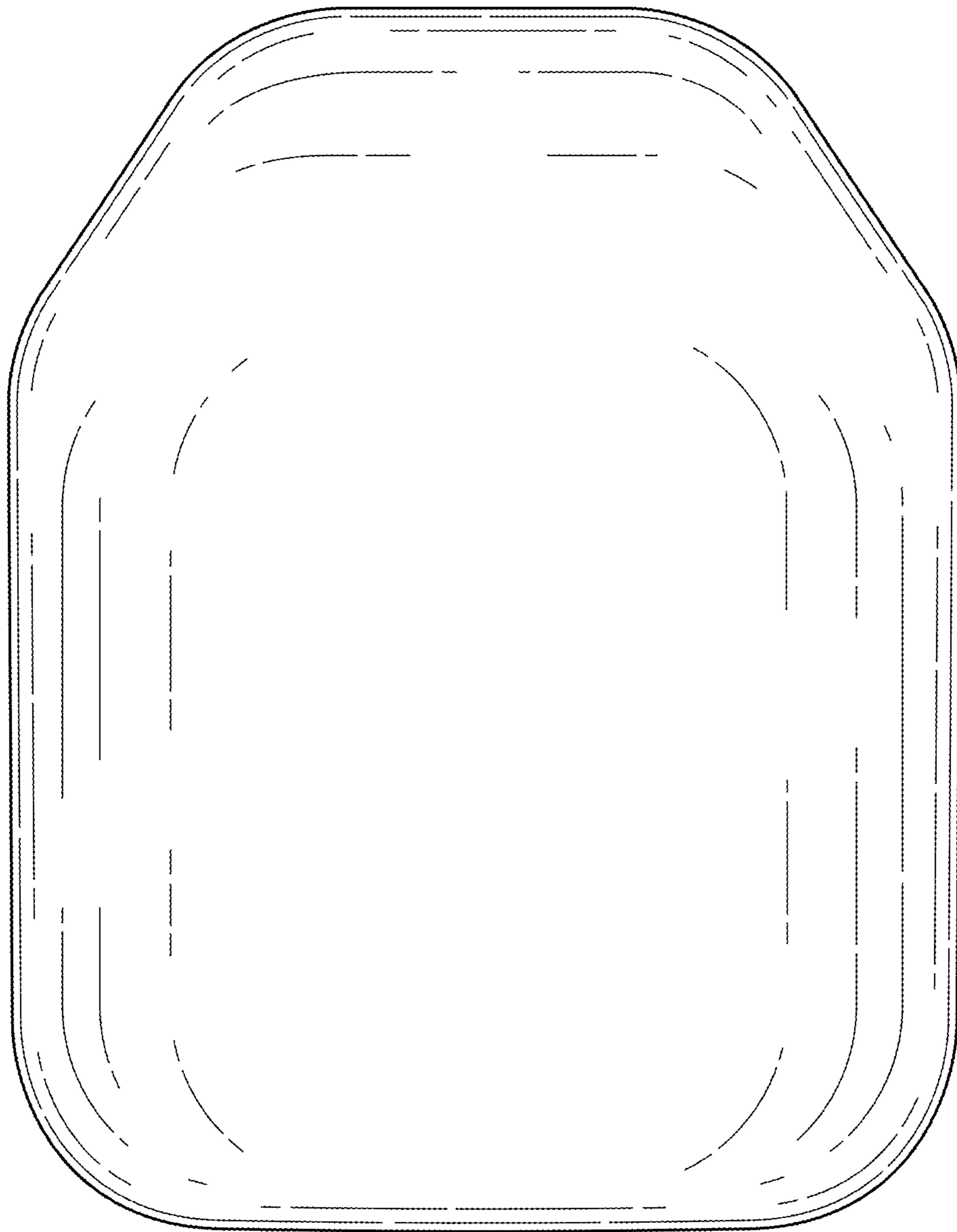

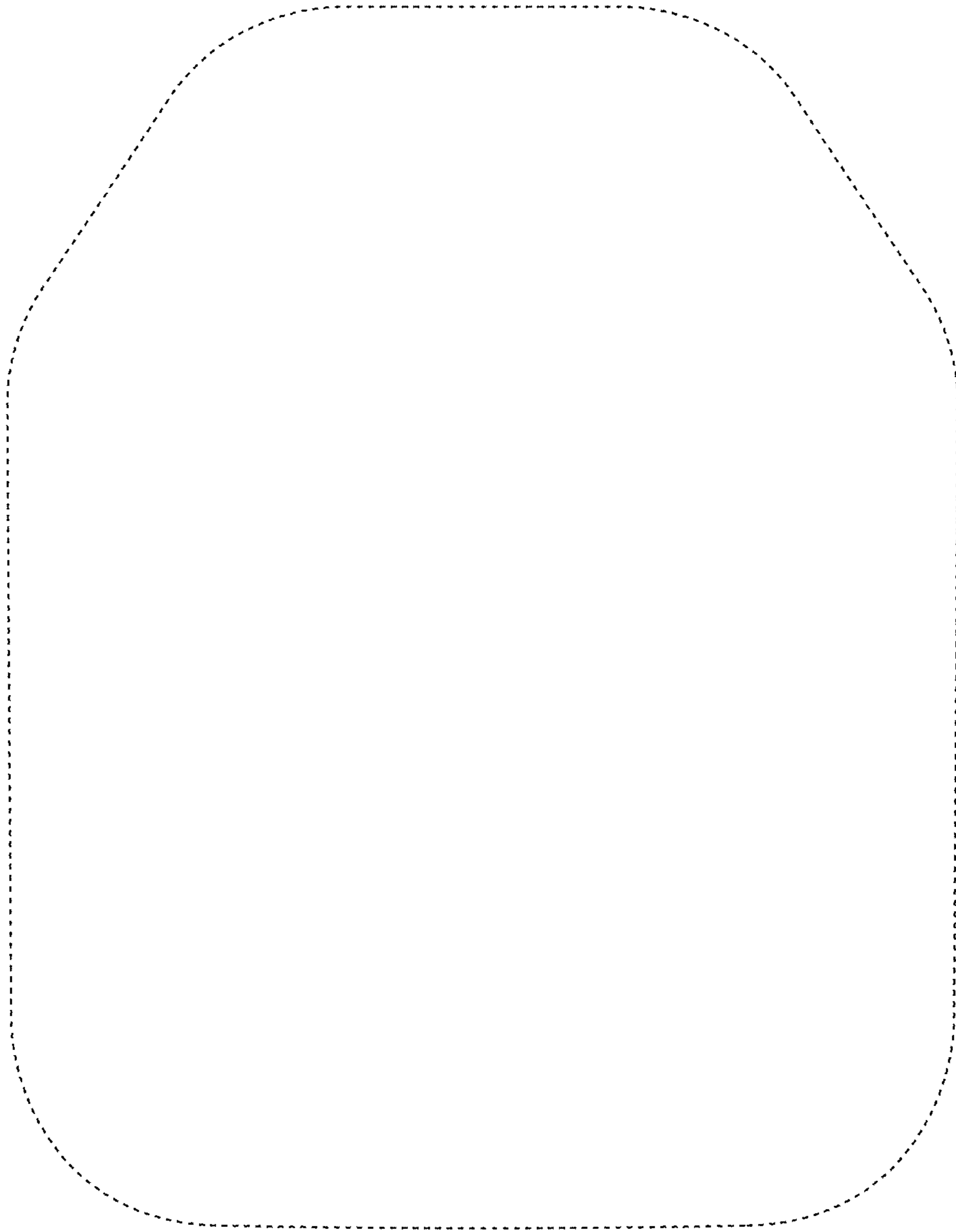

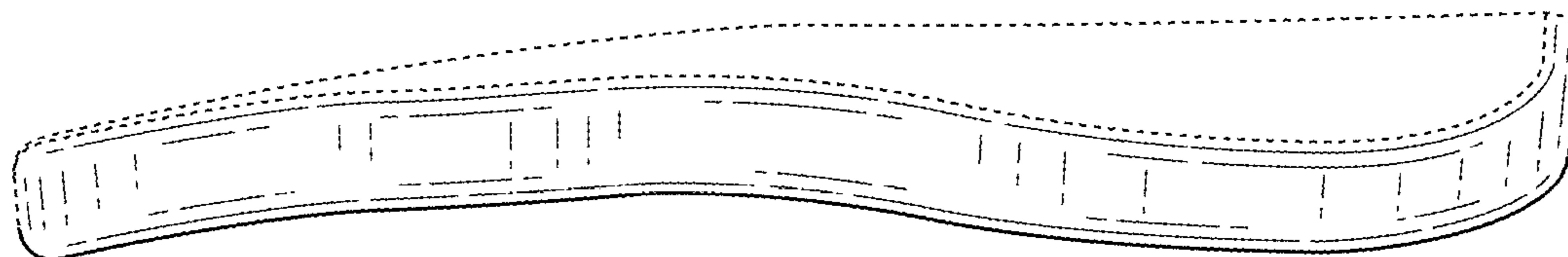

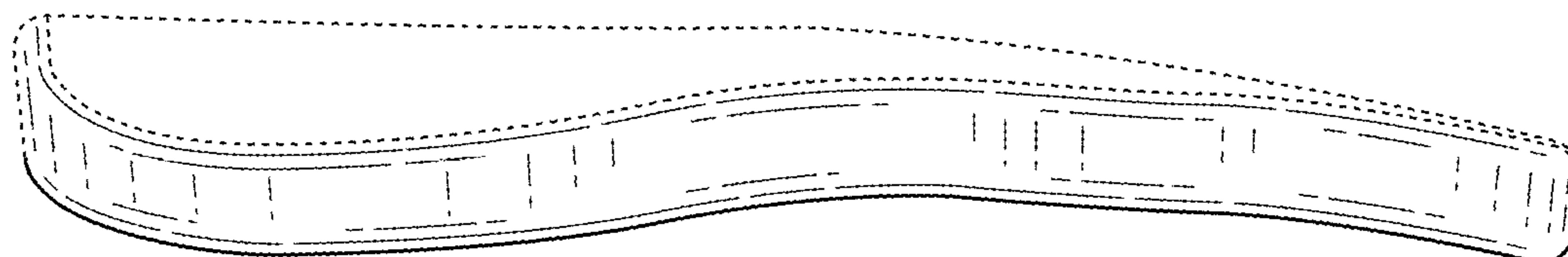

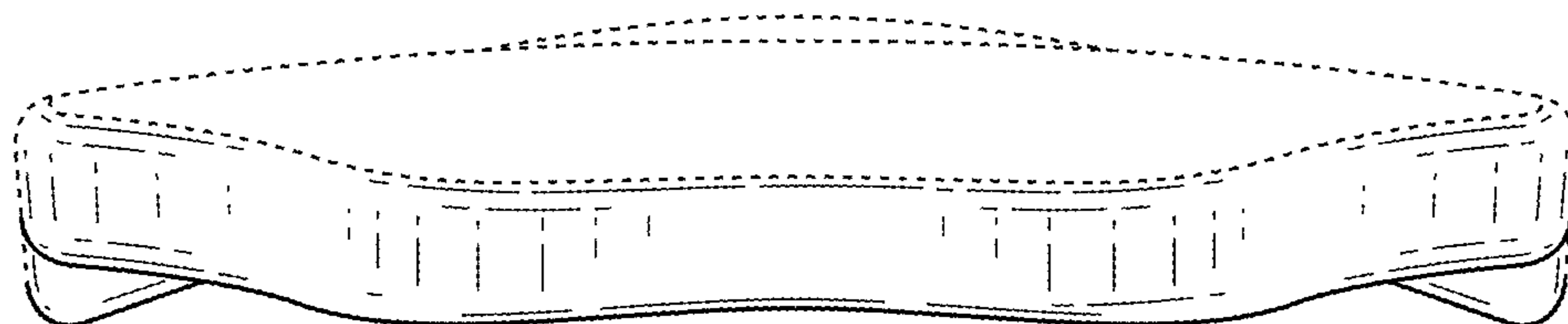

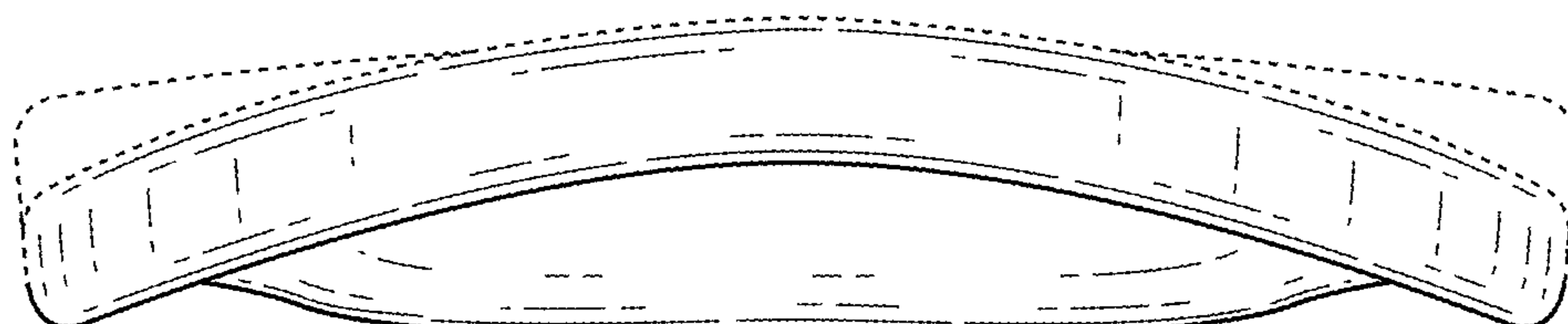

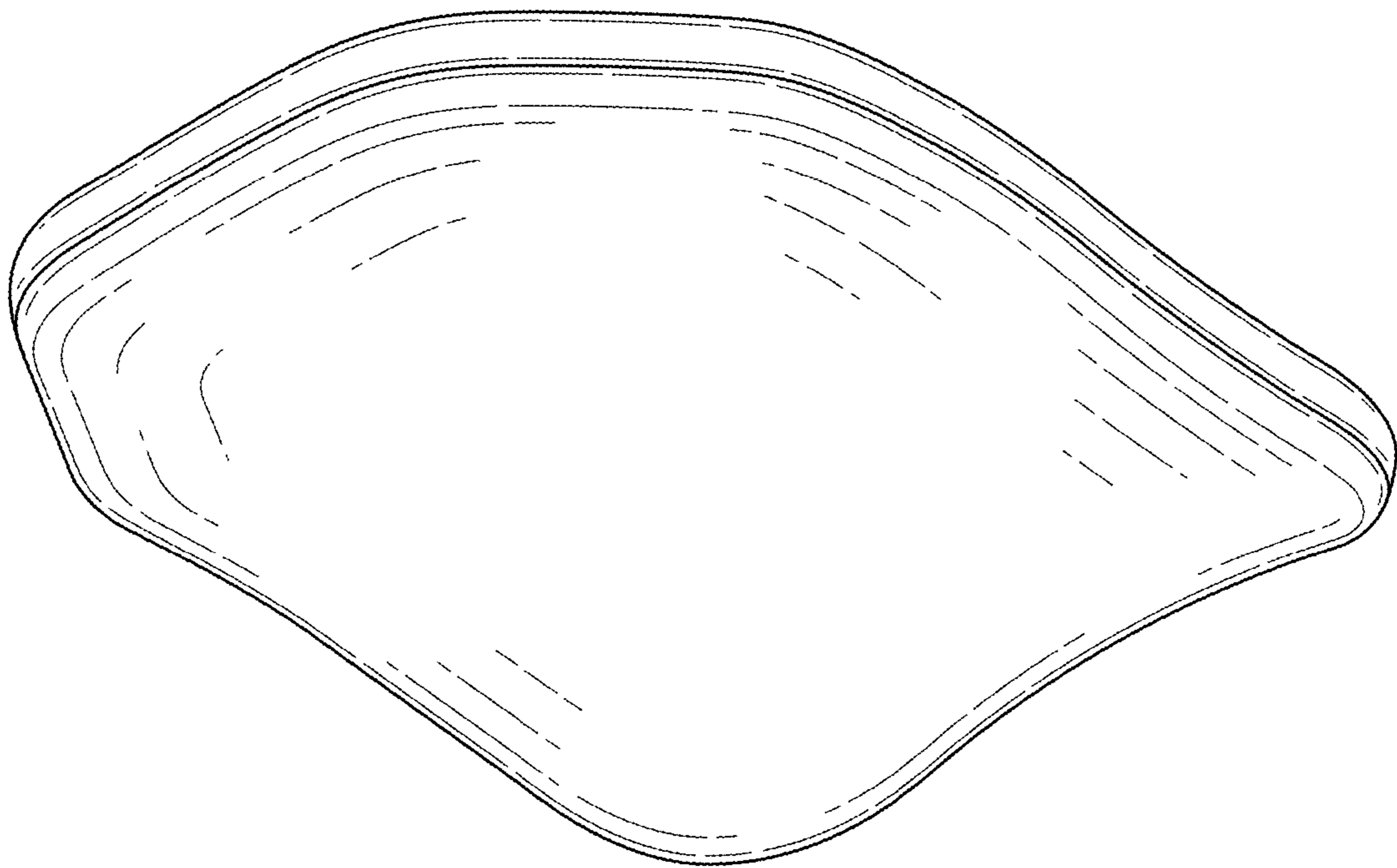

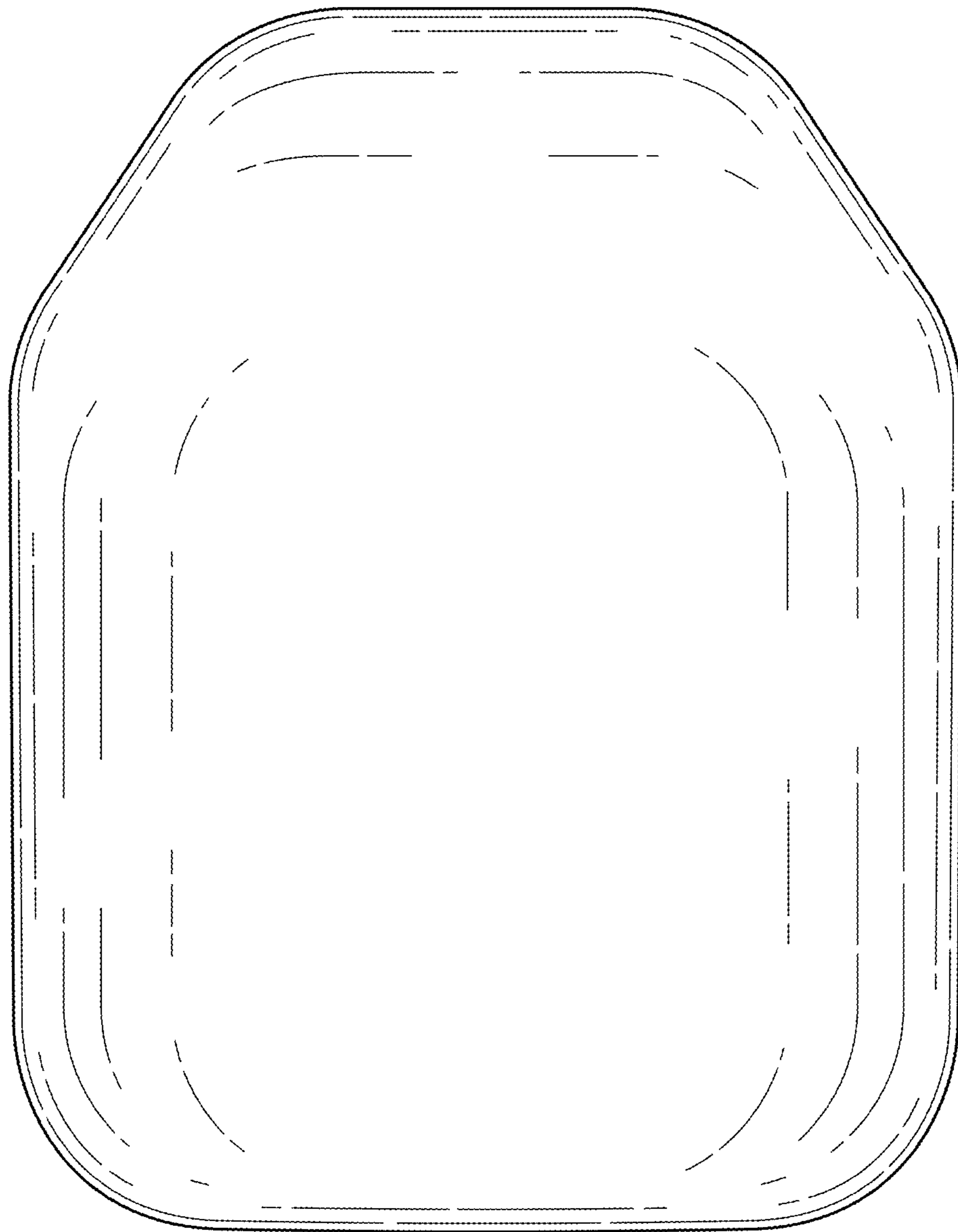

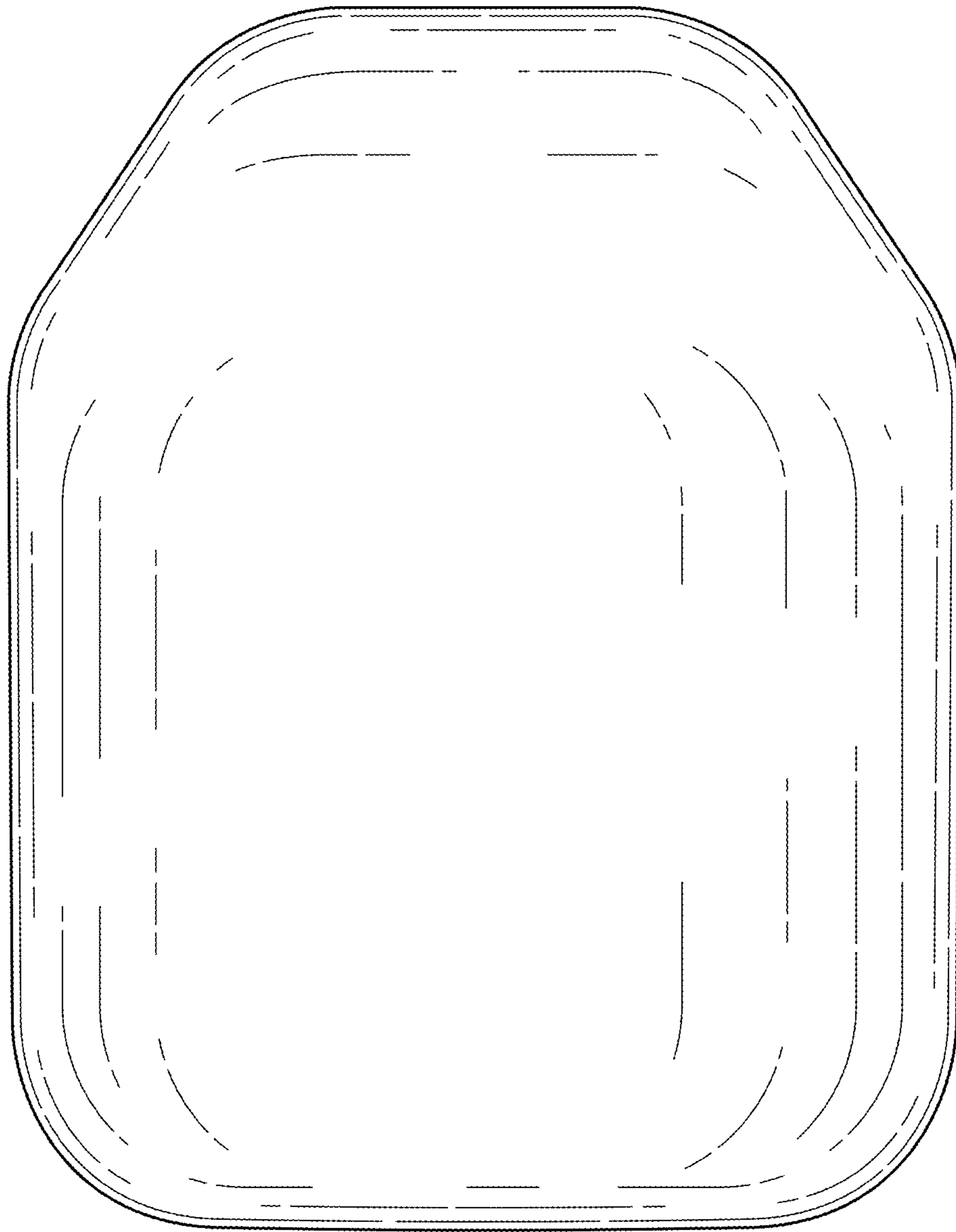

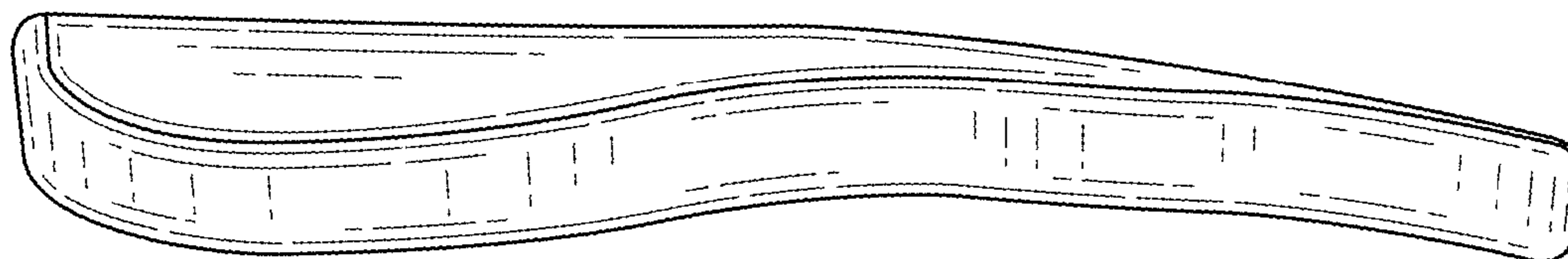

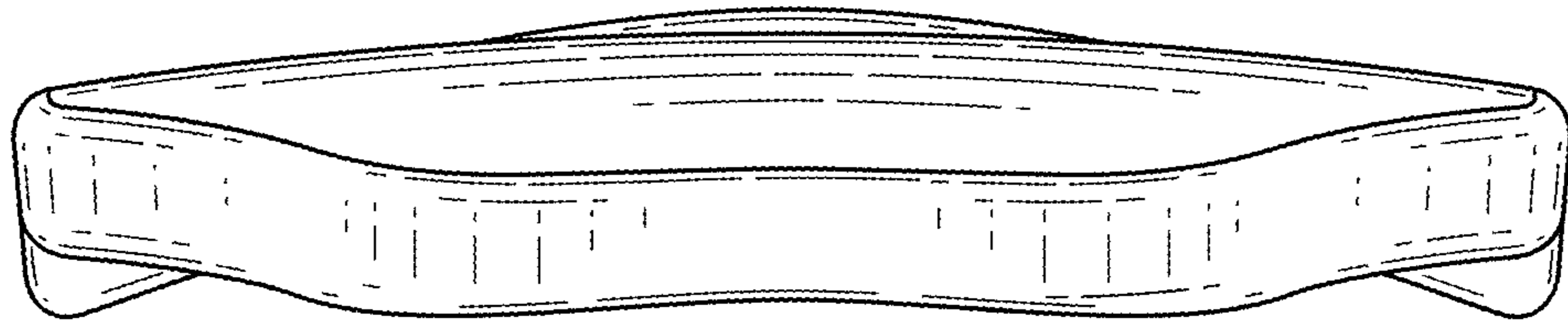

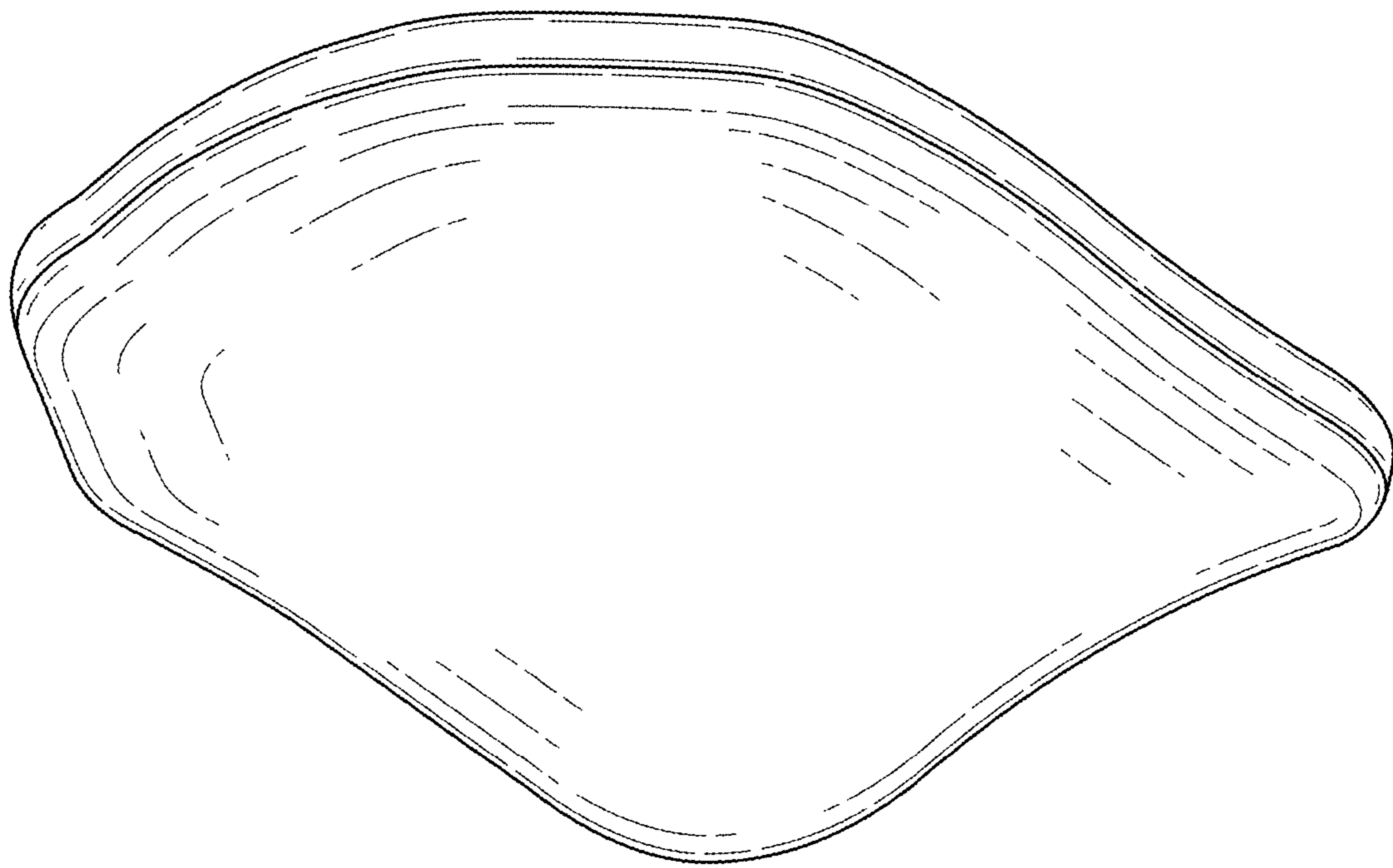

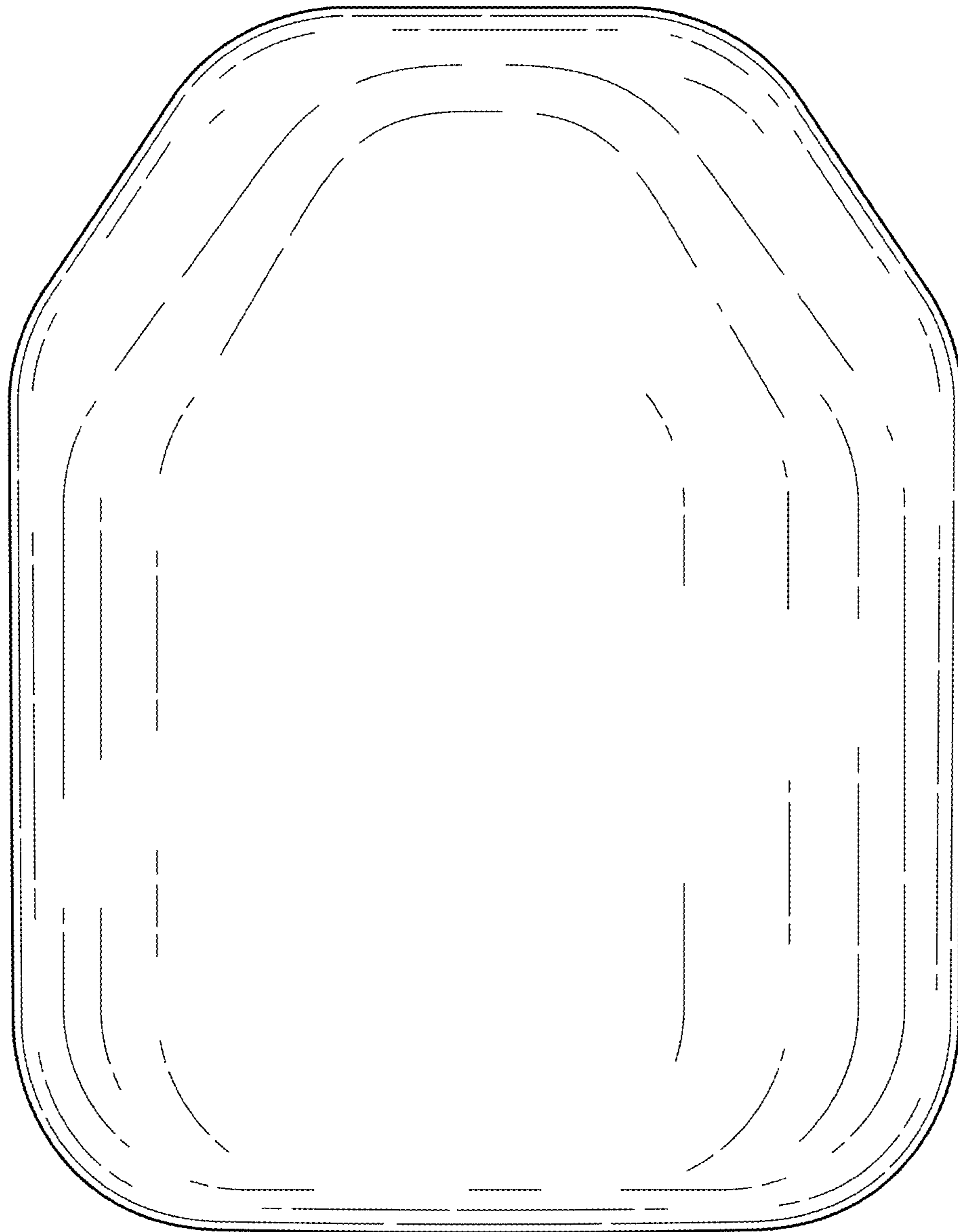

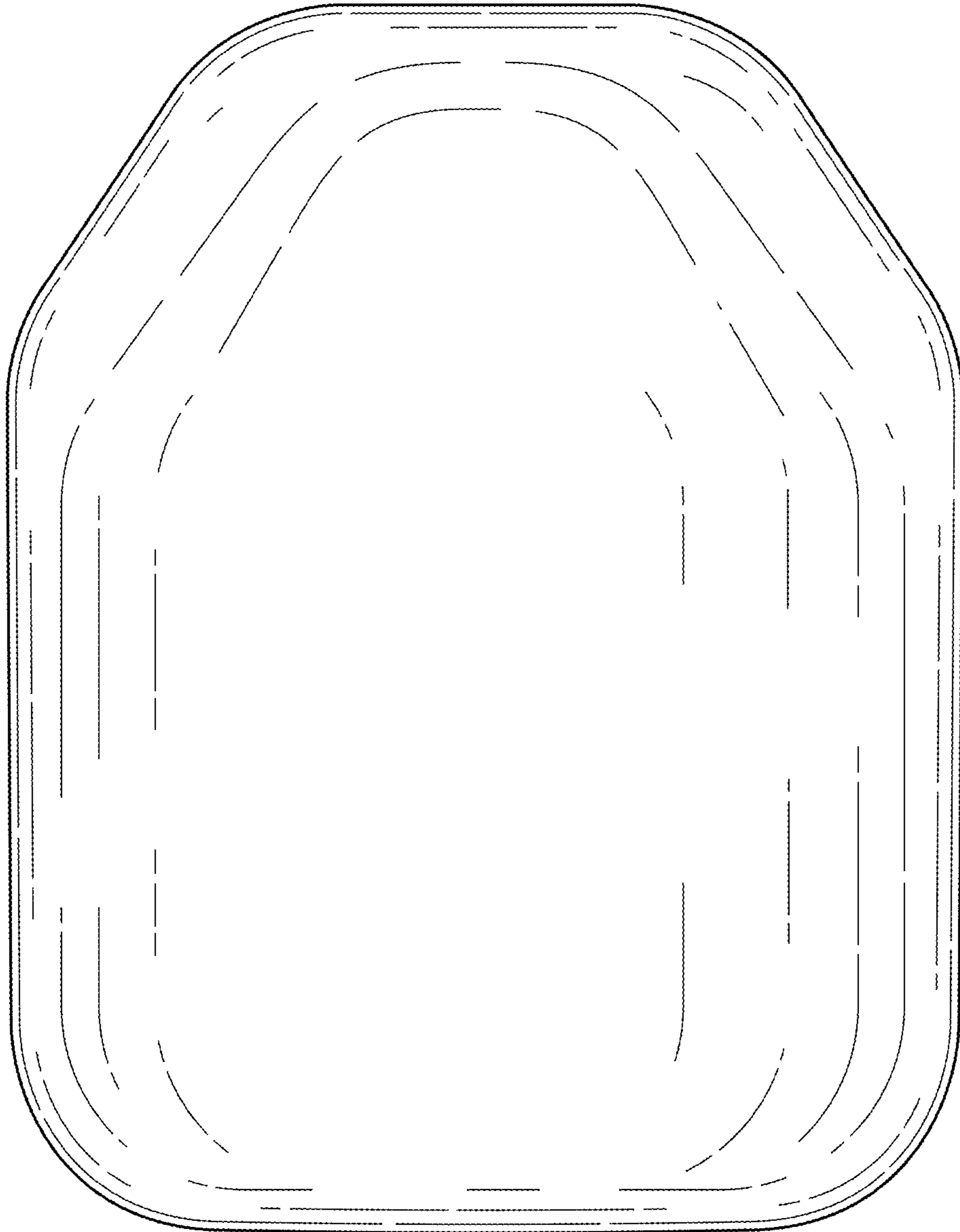

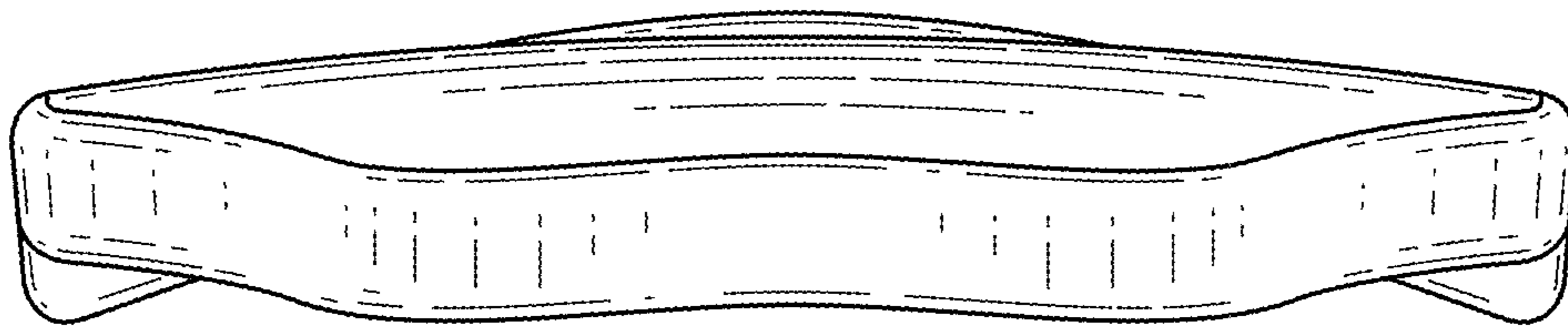

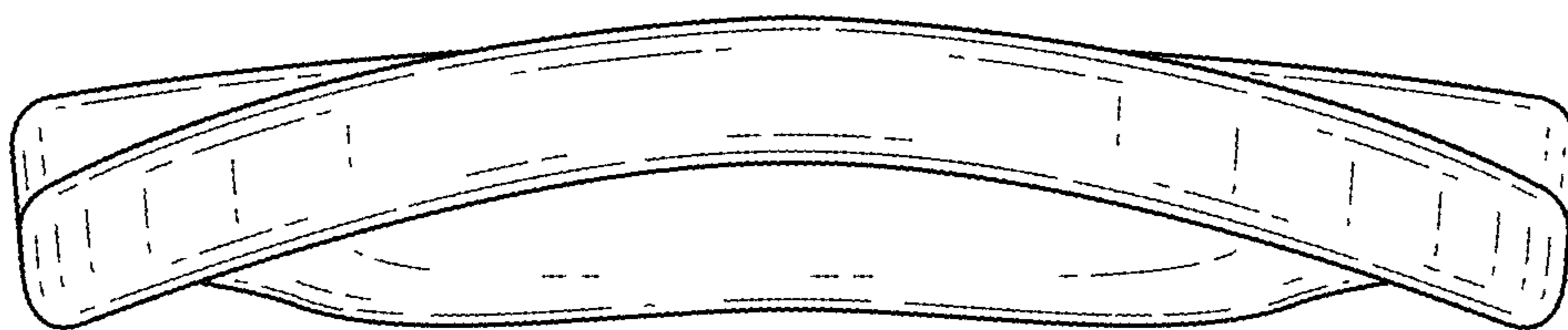
