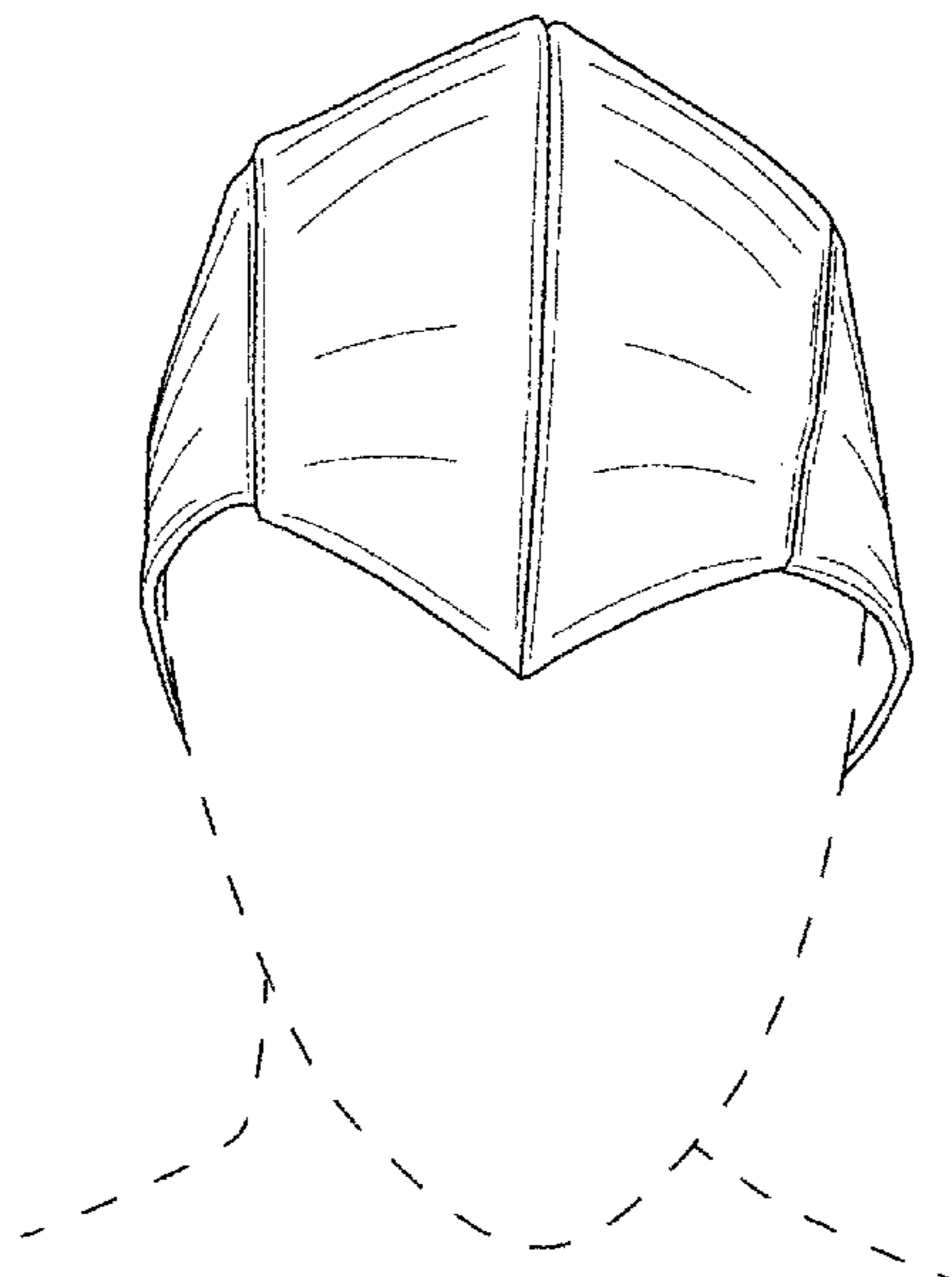
FIG. 1 is a front view of a radiation protective headwear in

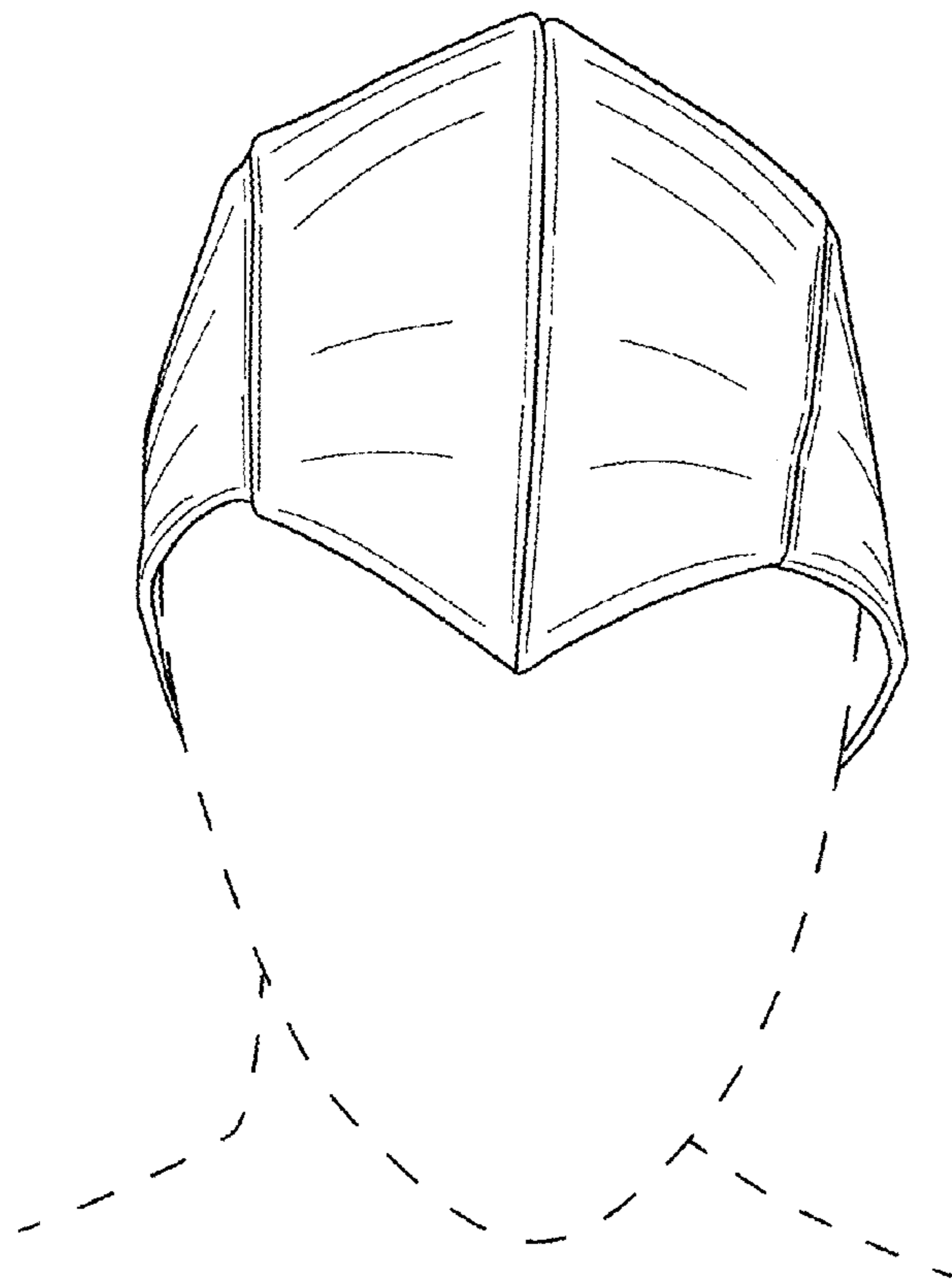

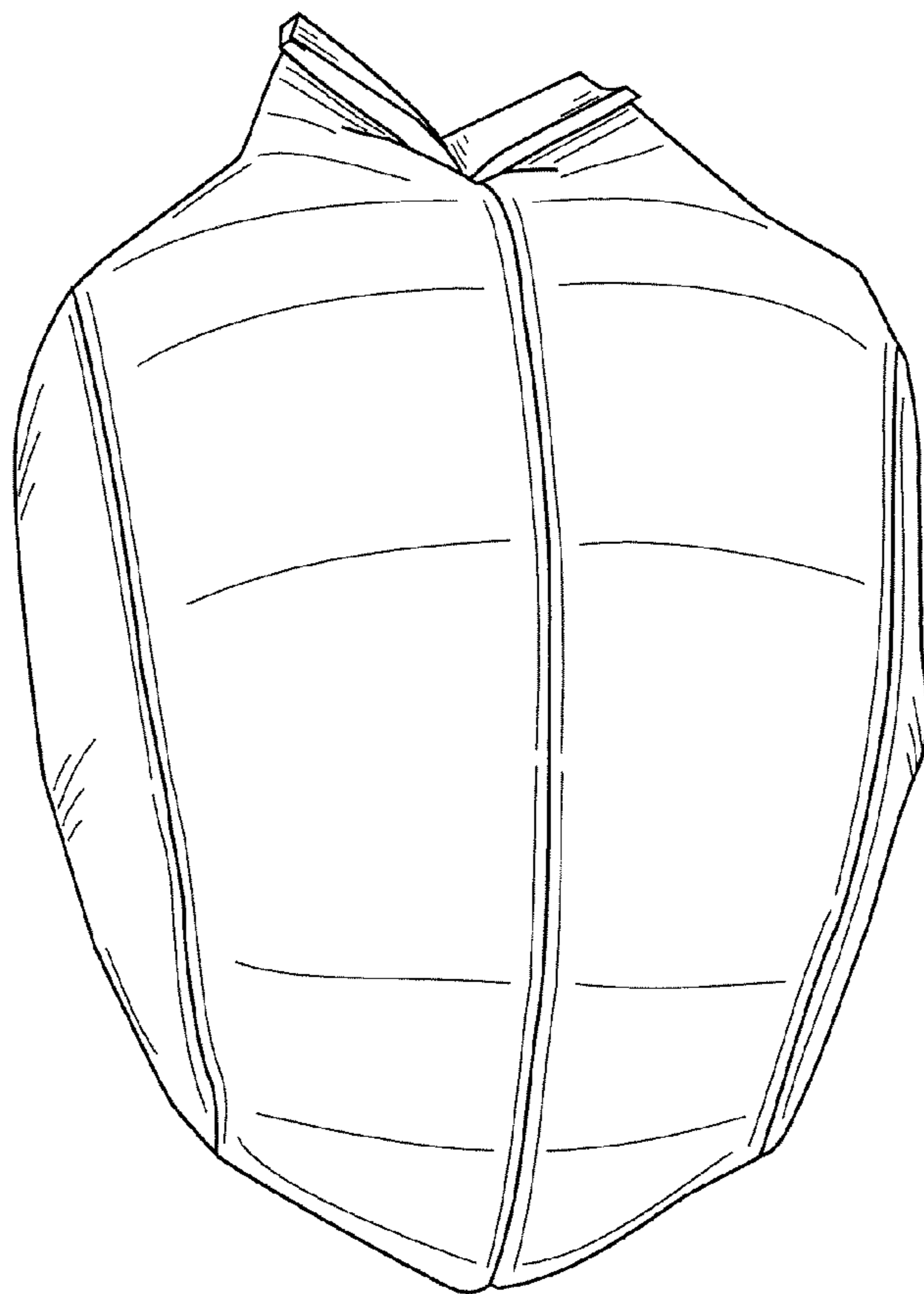

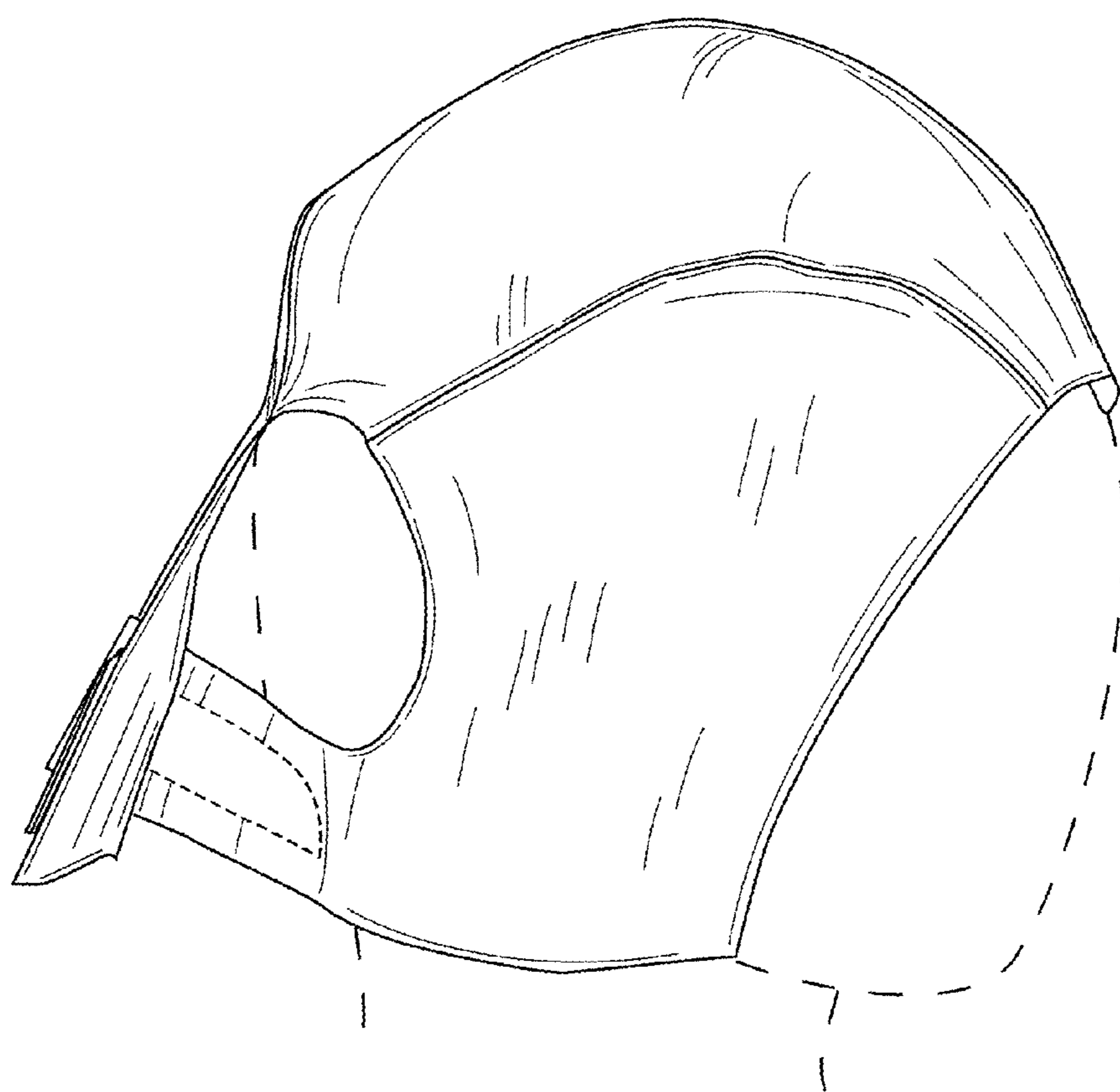

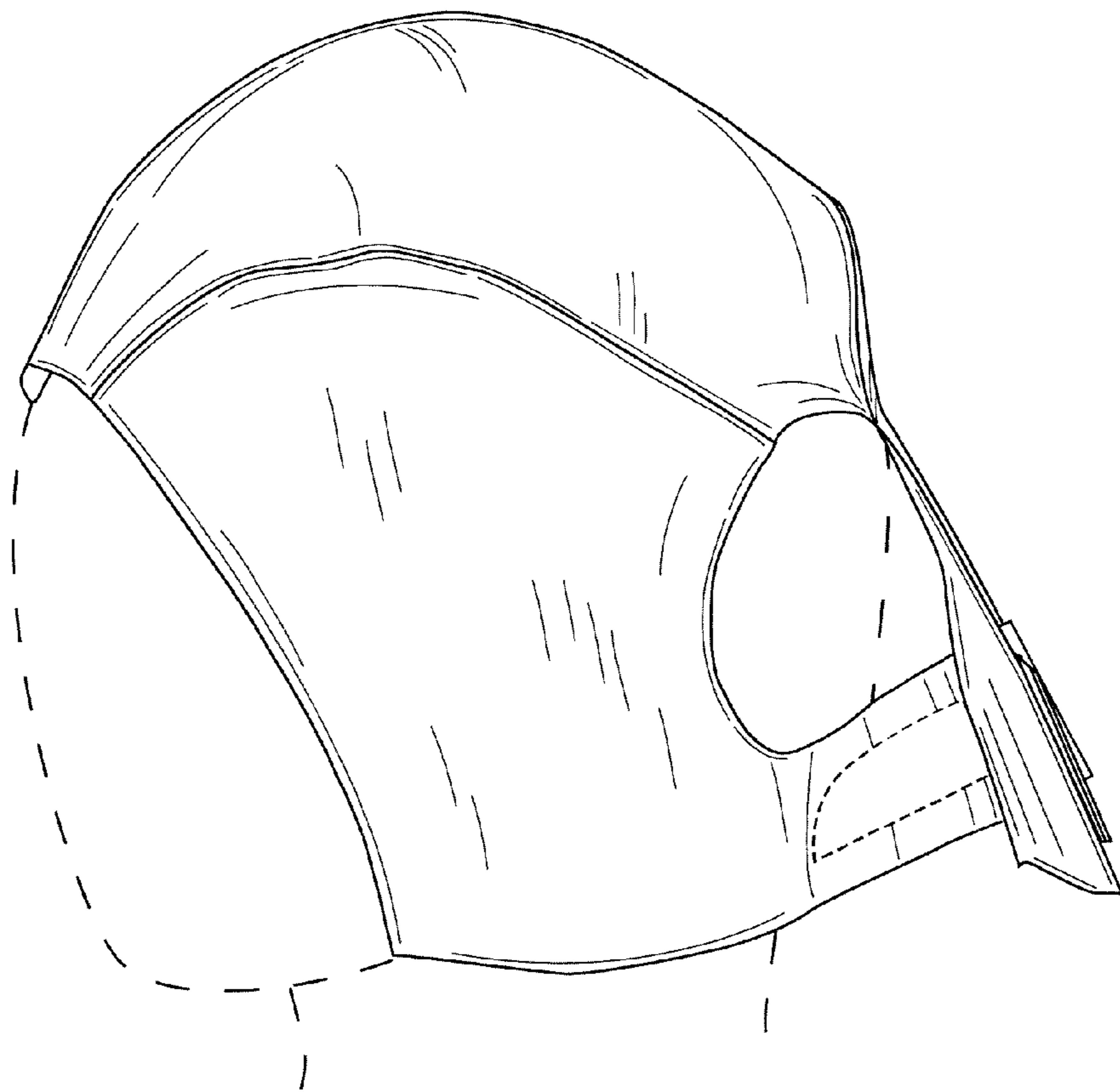

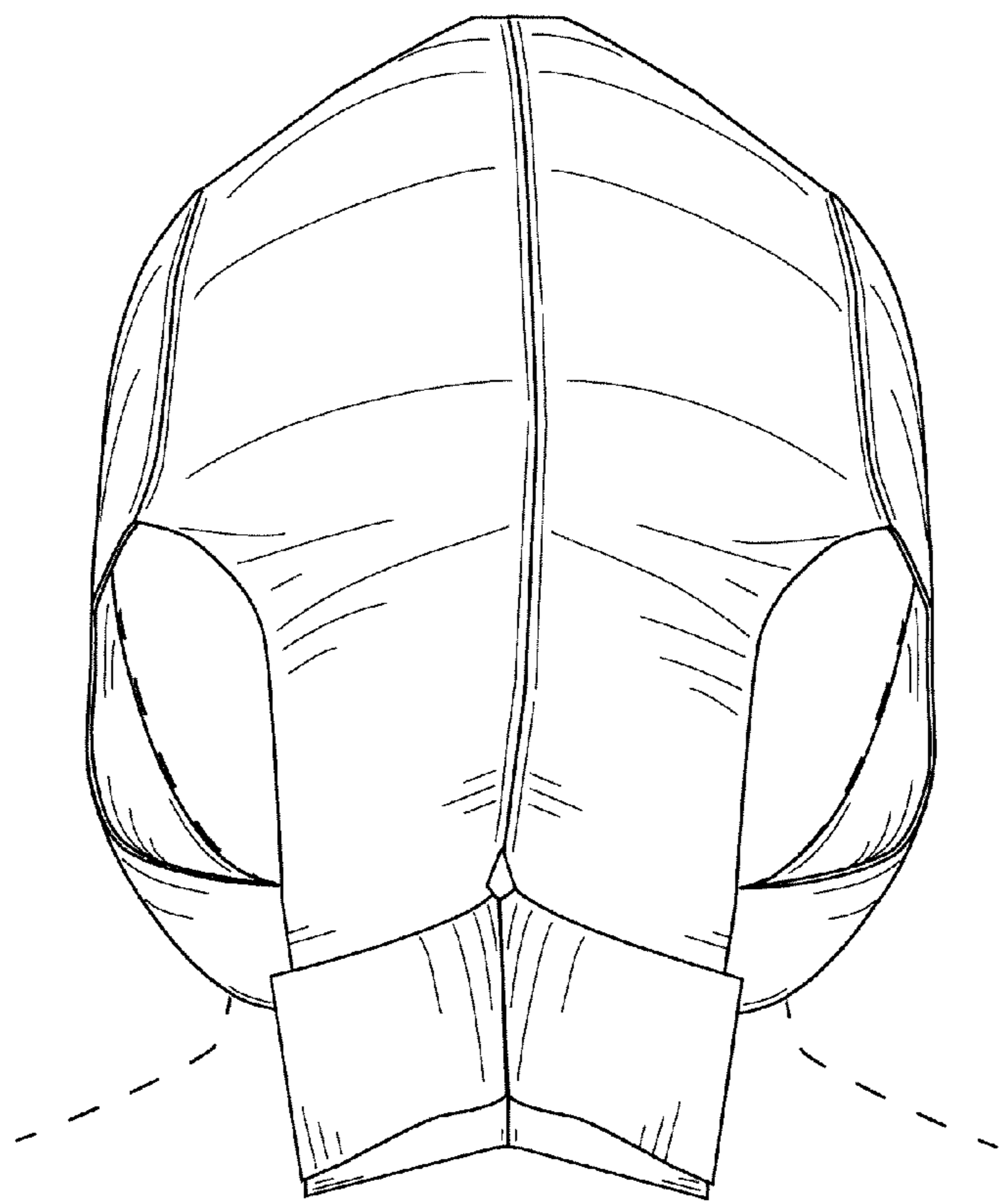

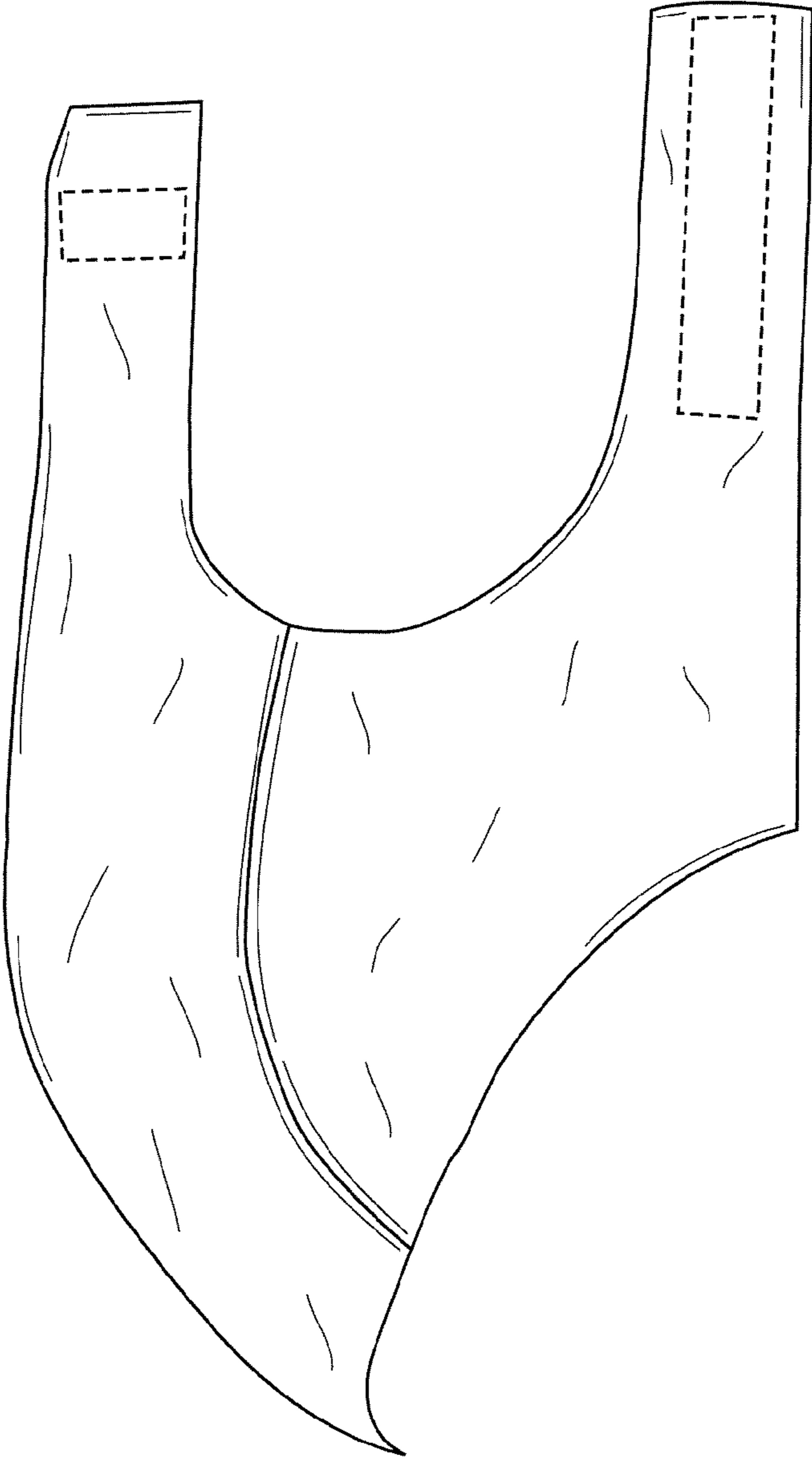
