DESCRIPTION

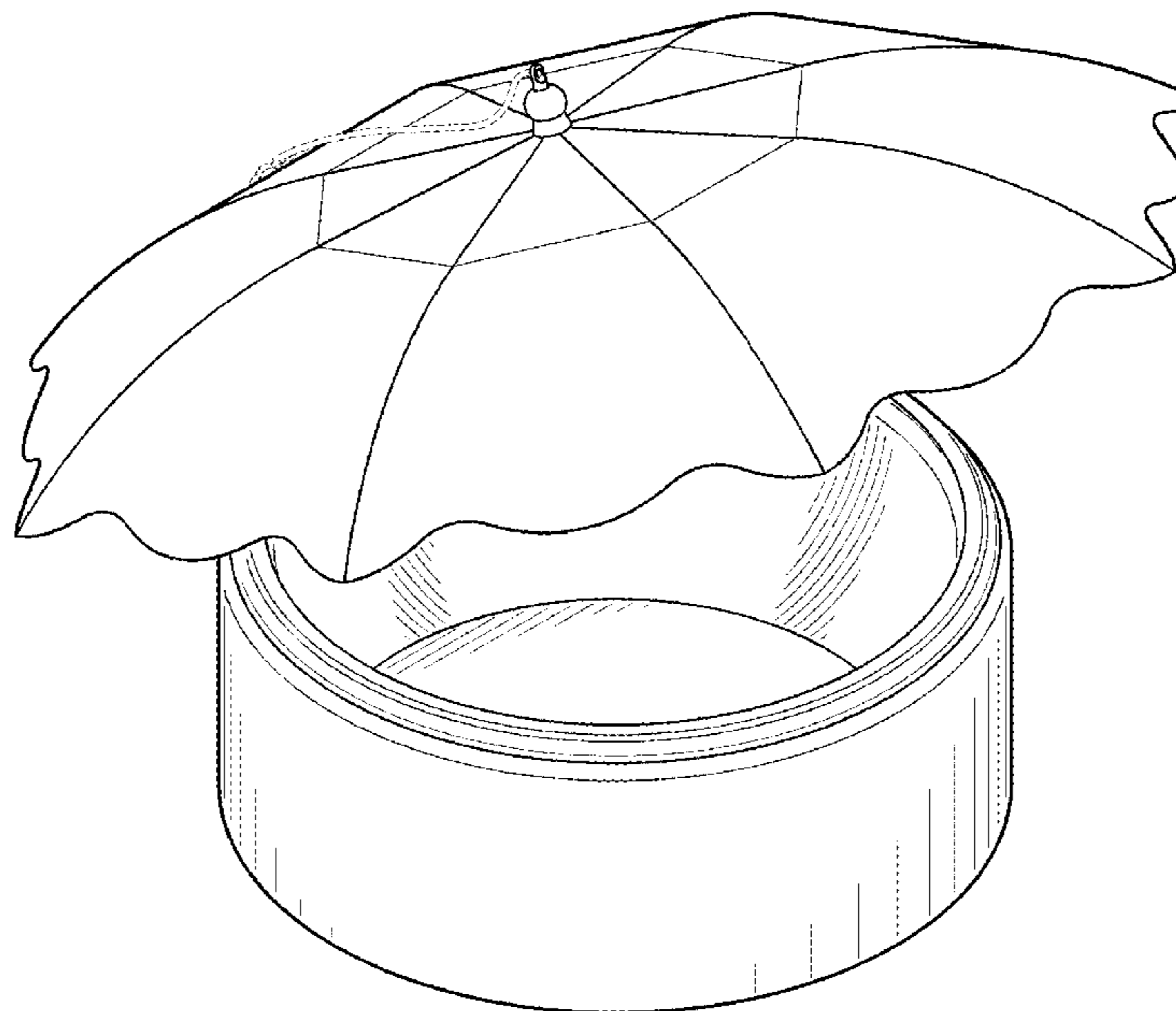
FIG. 1 is a perspective view of a pet bed showing my new design;

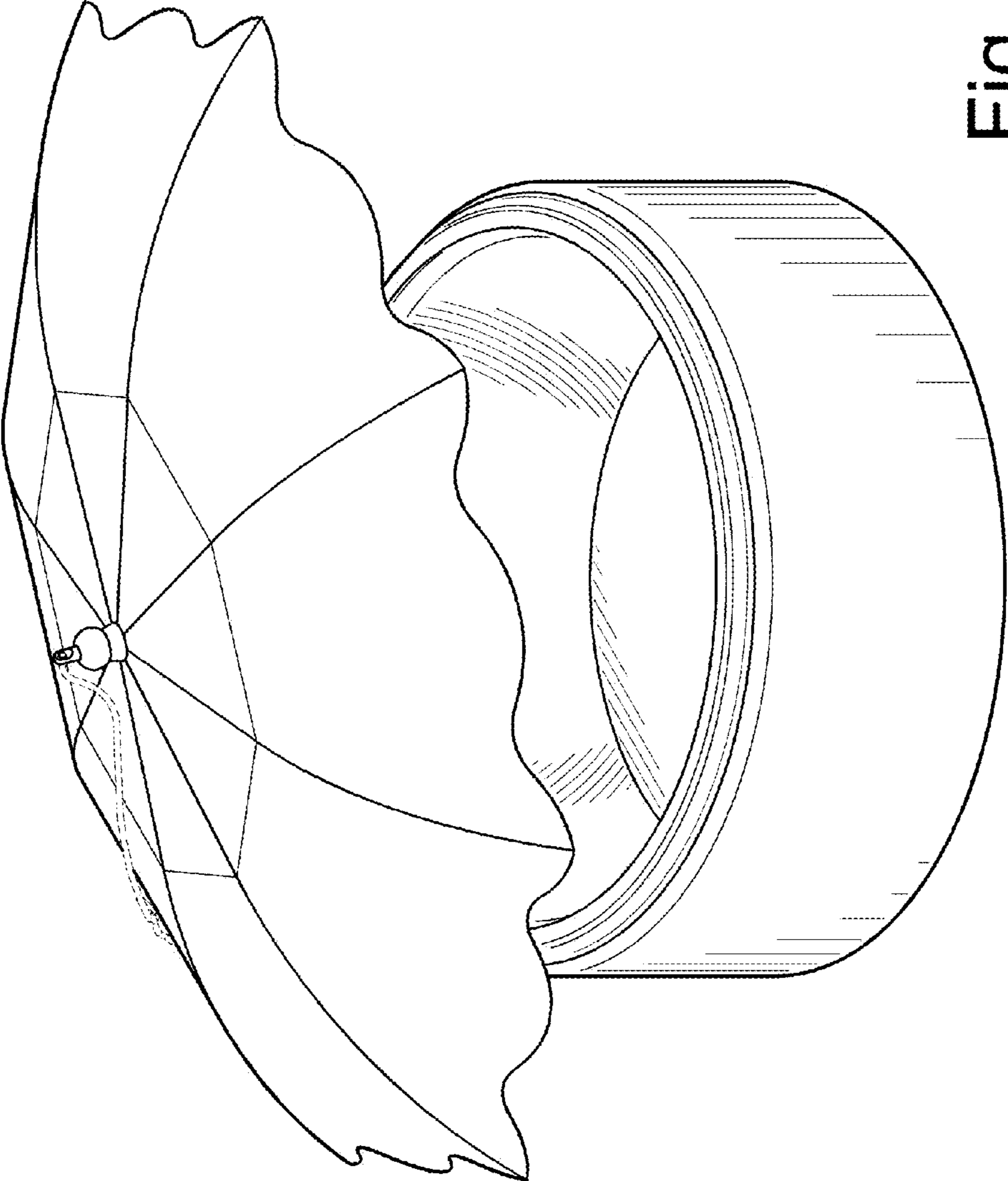

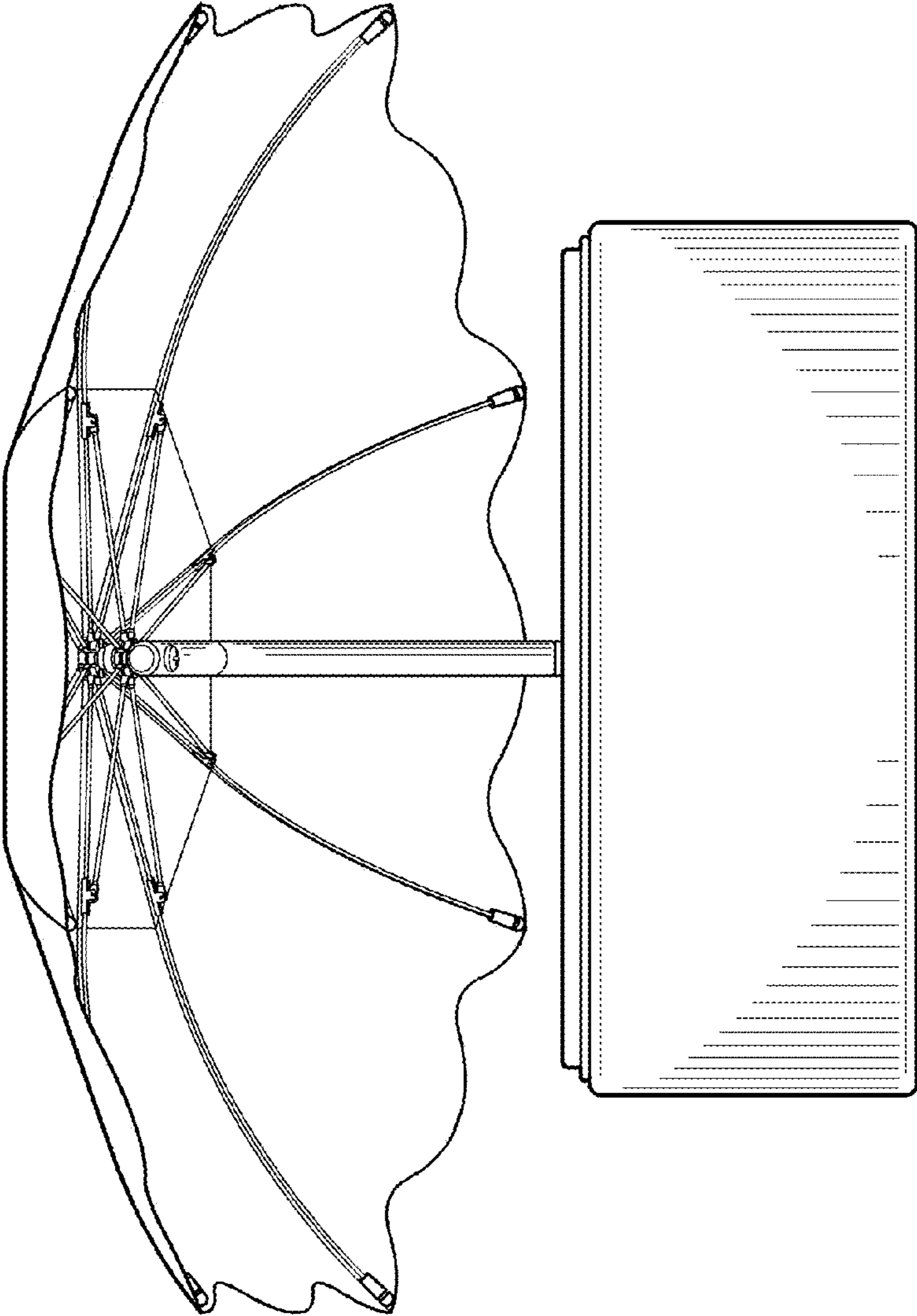

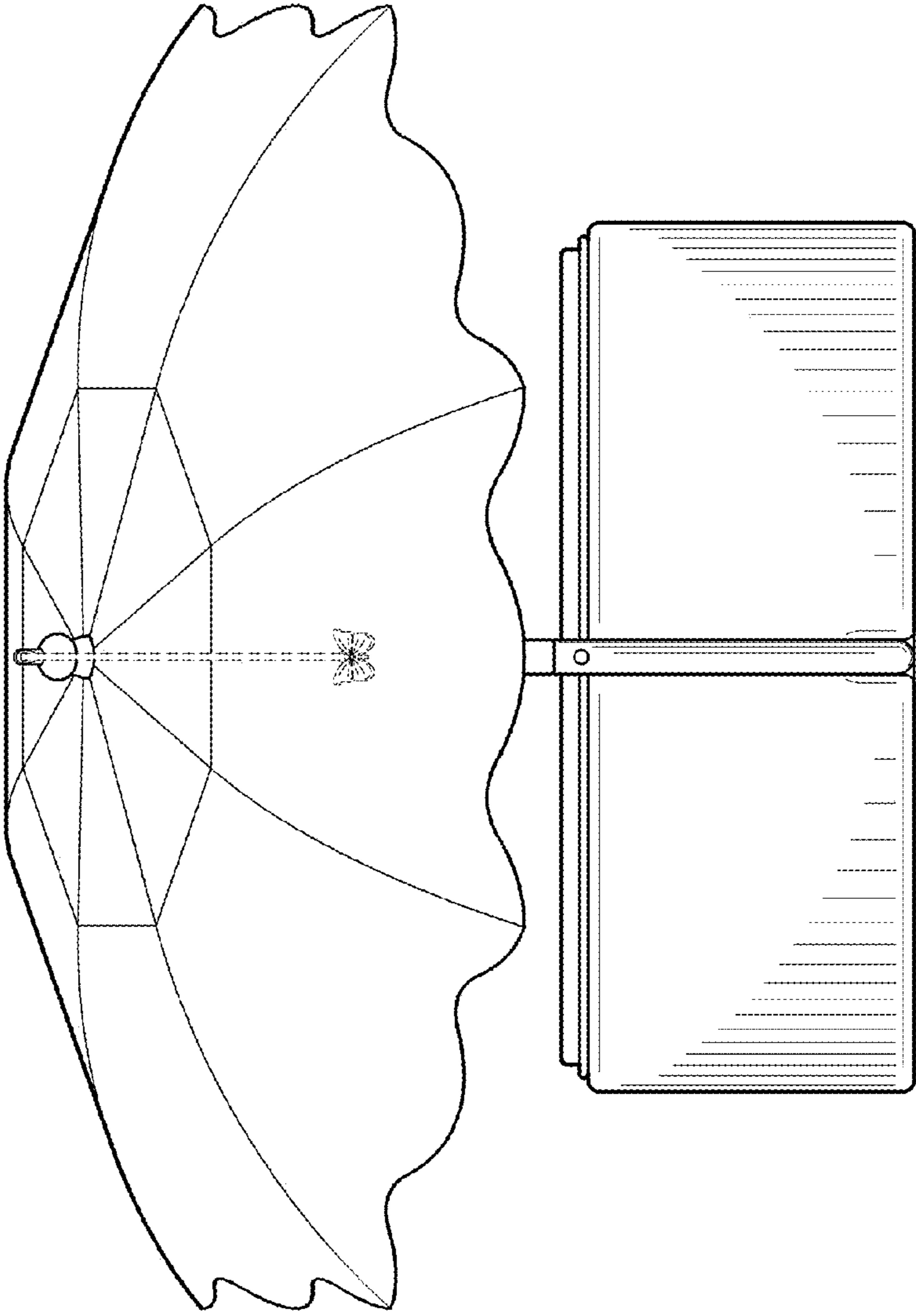

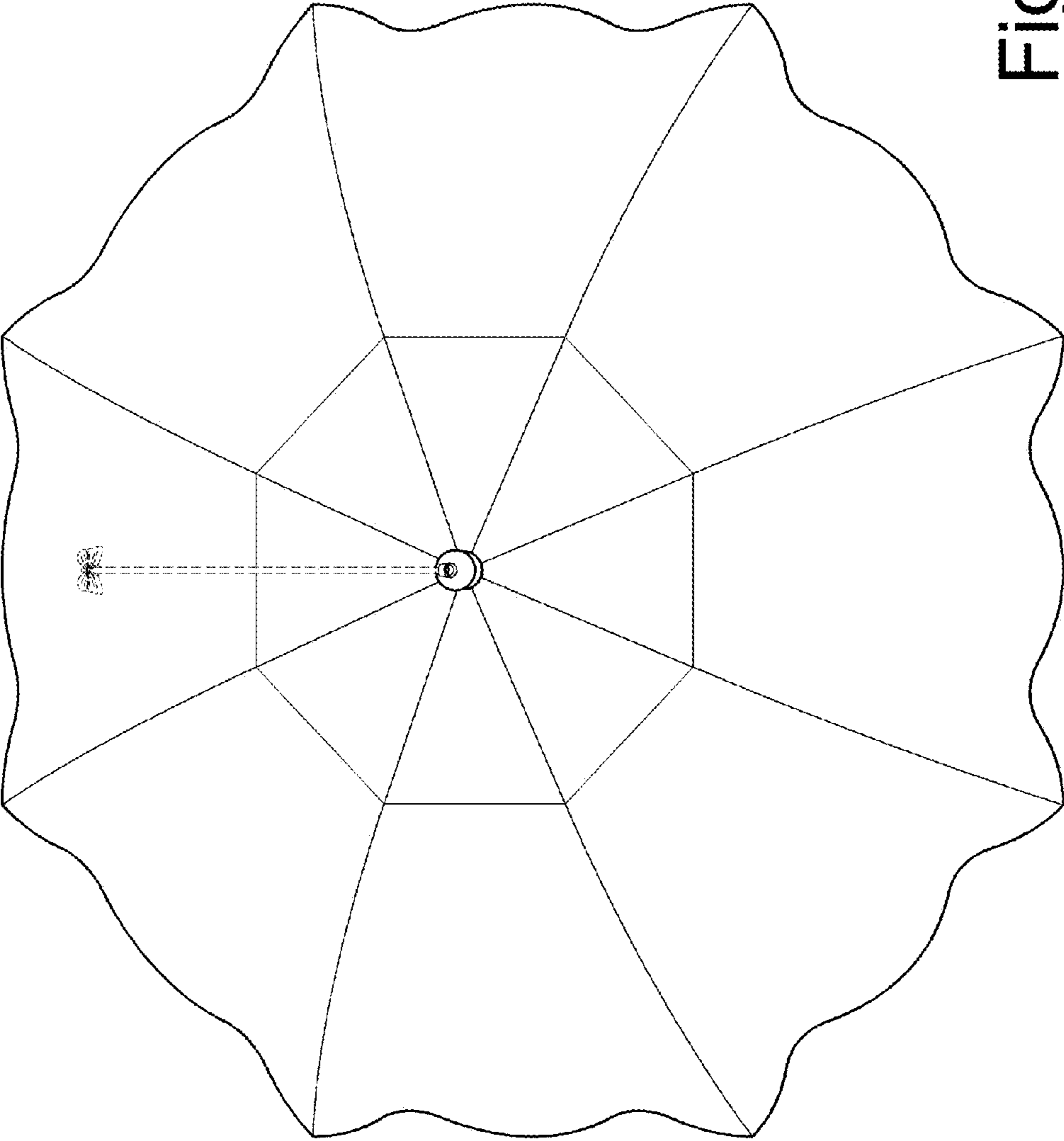

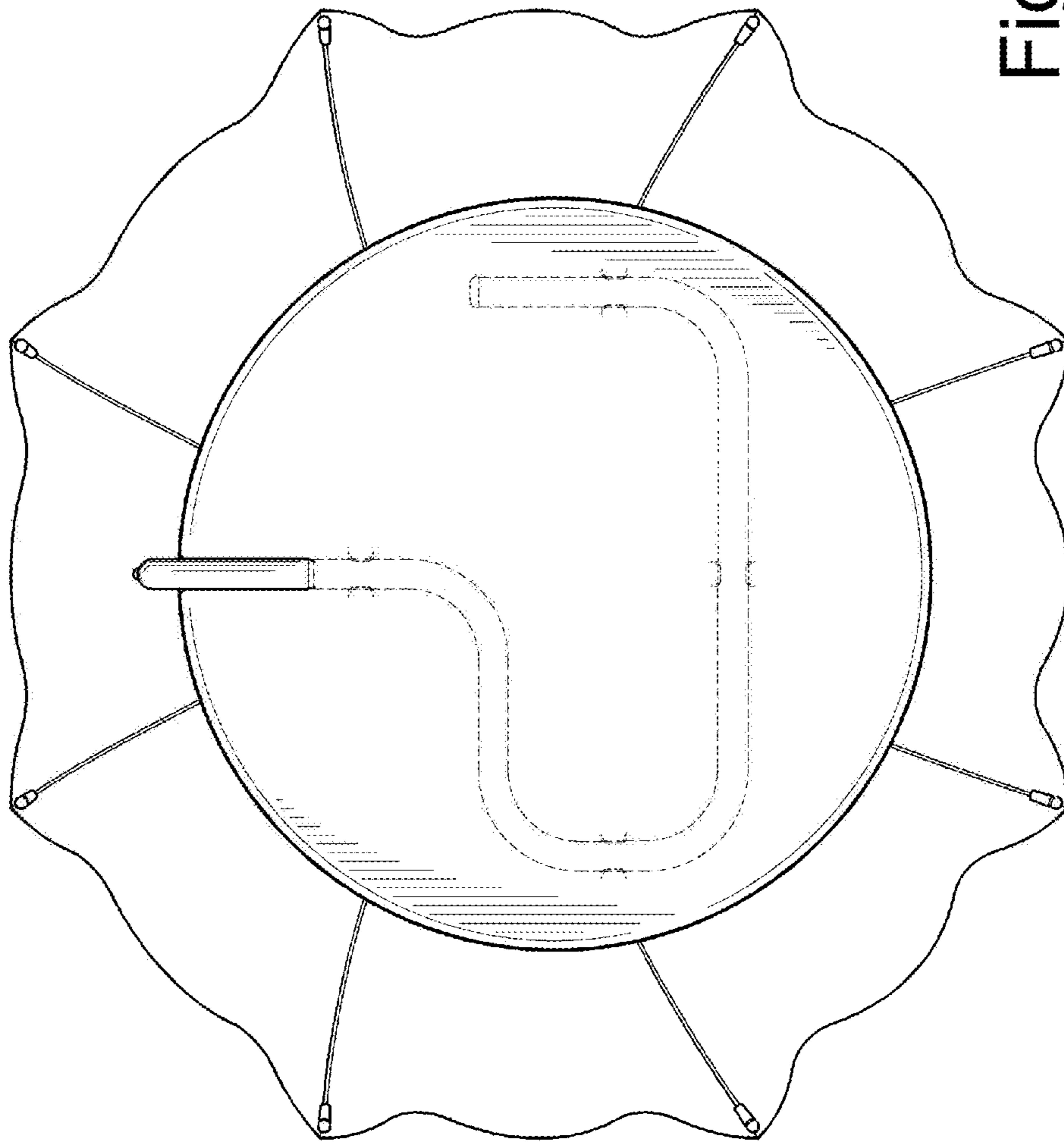

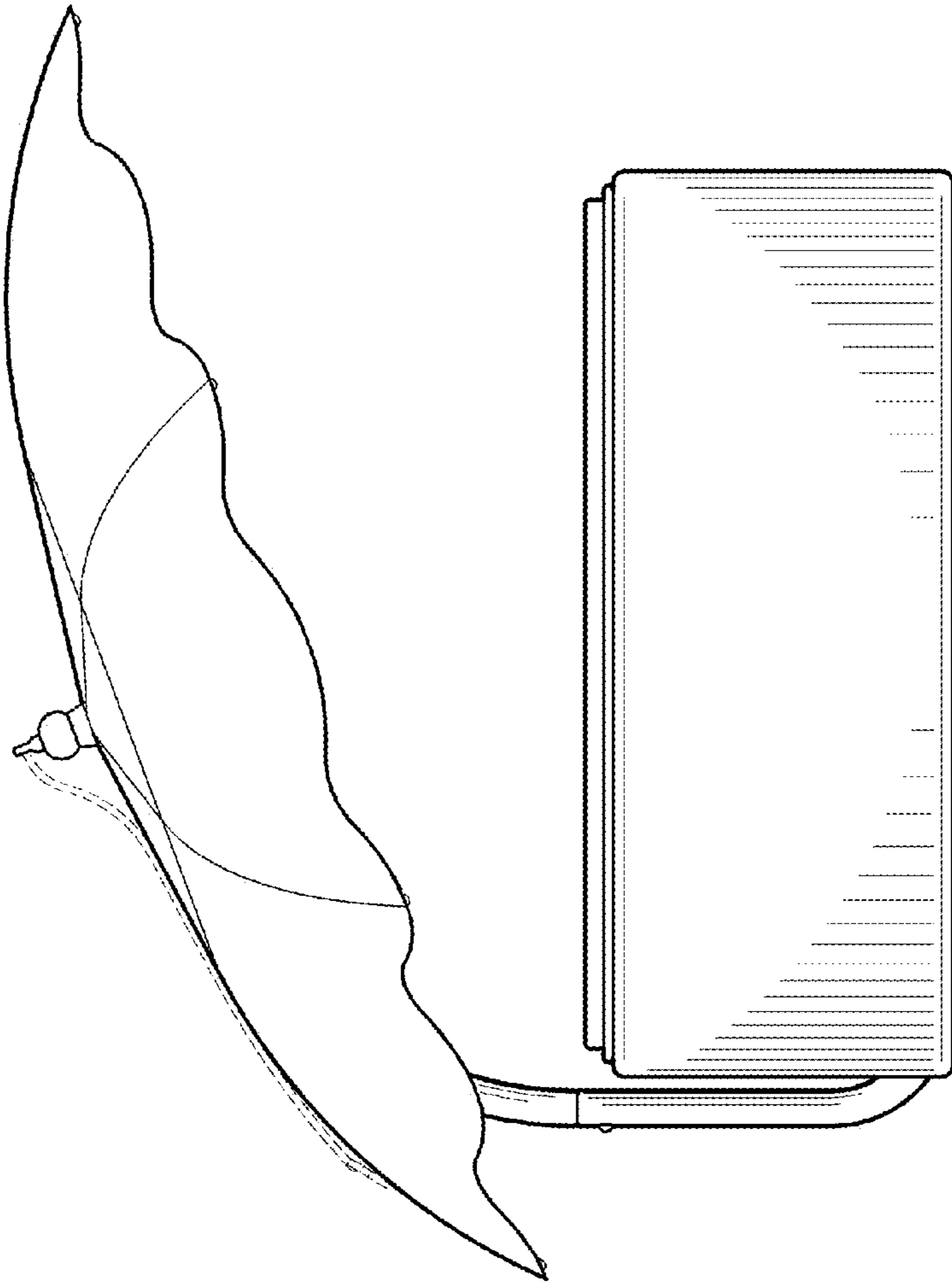
