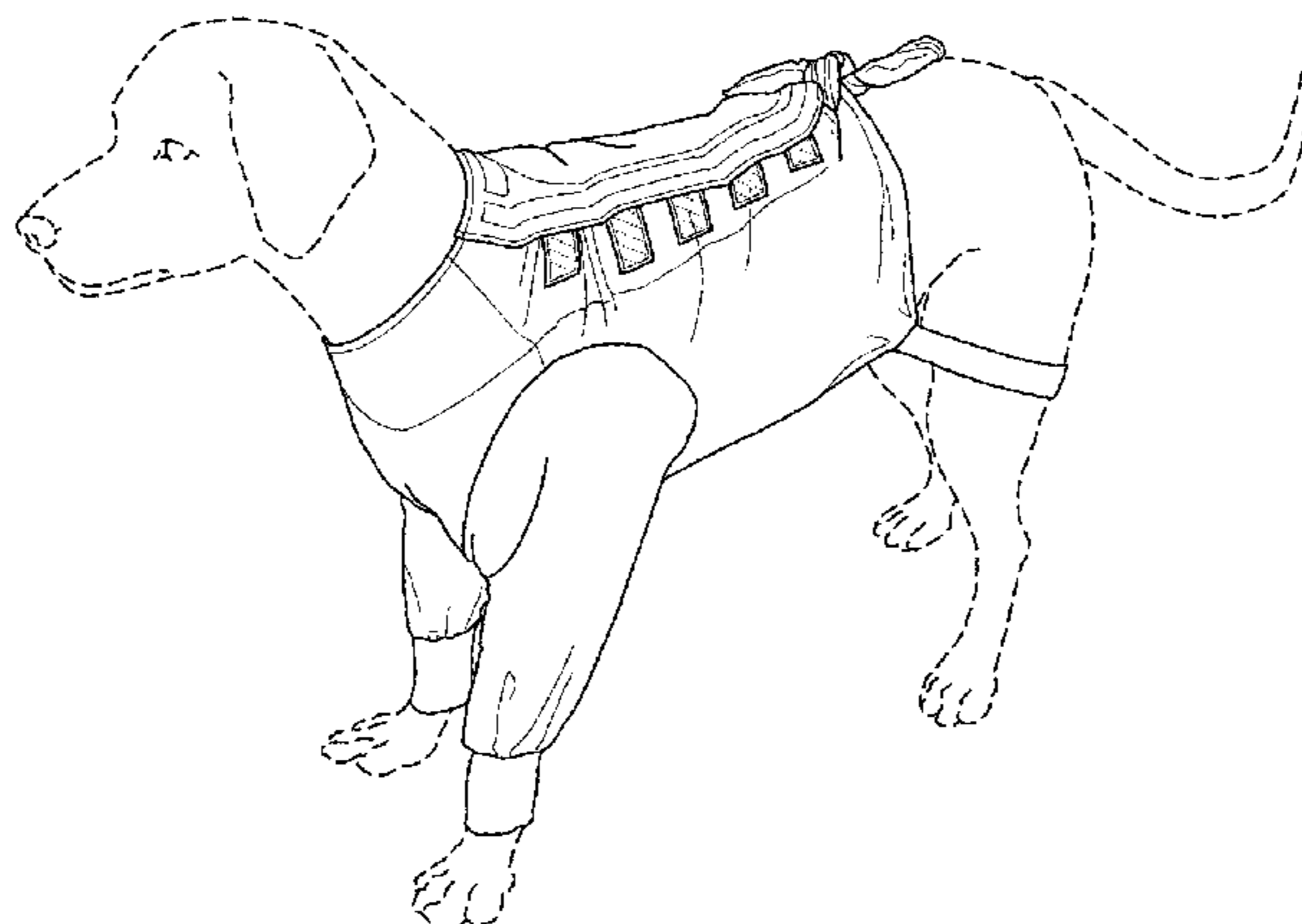
(57) **CLAIM**

The ornamental design for a post-operative protection garment for dogs, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of the post-operative protection garment for dogs showing my new design, shown in use;
FIG. 2 is an alternative side perspective view thereof, shown in use;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a top plan view thereof, shown with garment unfastened and open for clarity of disclosure; and,
FIG. 5 is a top plan view thereof, shown with garment fastened.
The broken line shown in FIGS. 1 and 2 discloses environmental structure that forms no part of the claimed design.

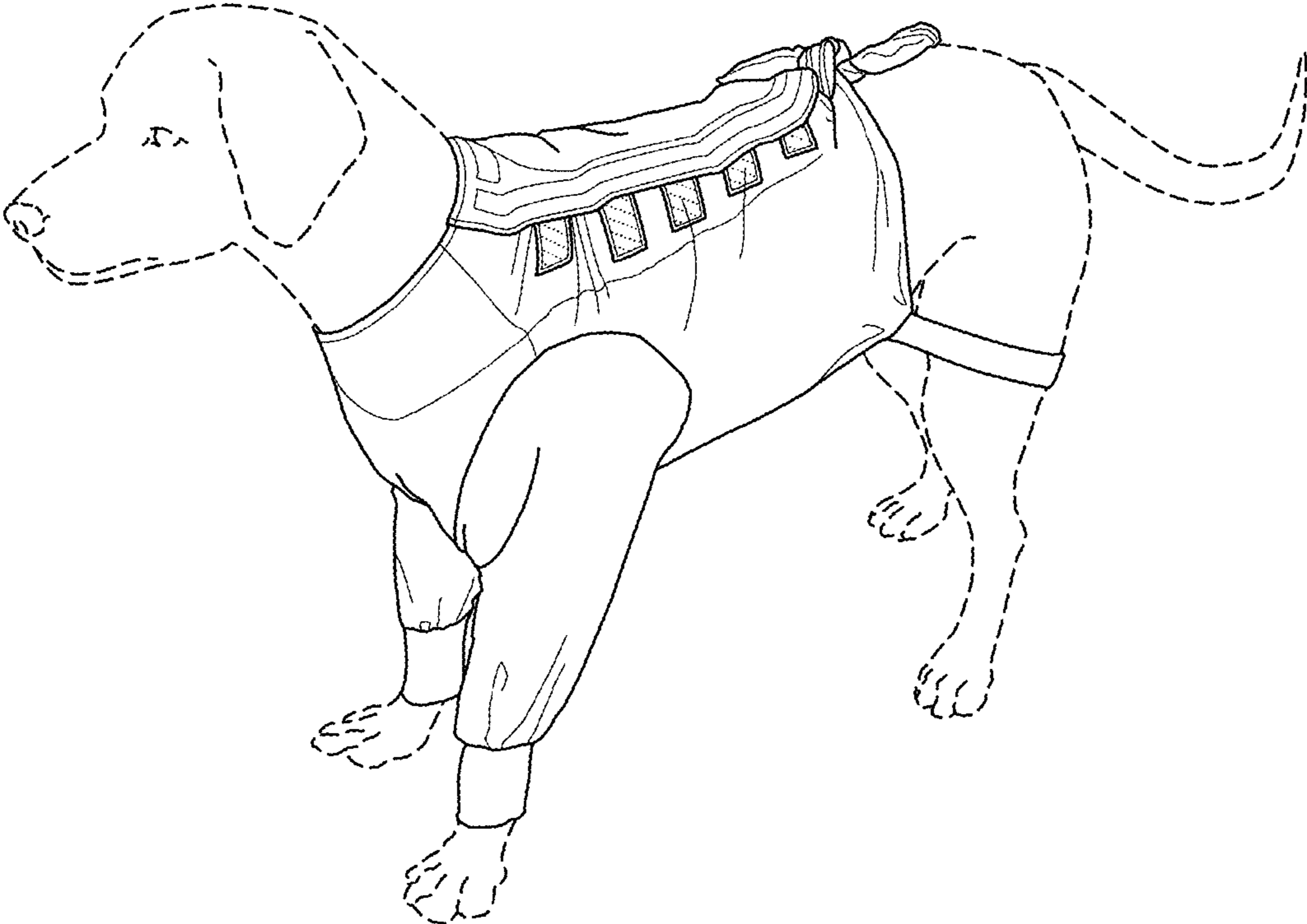

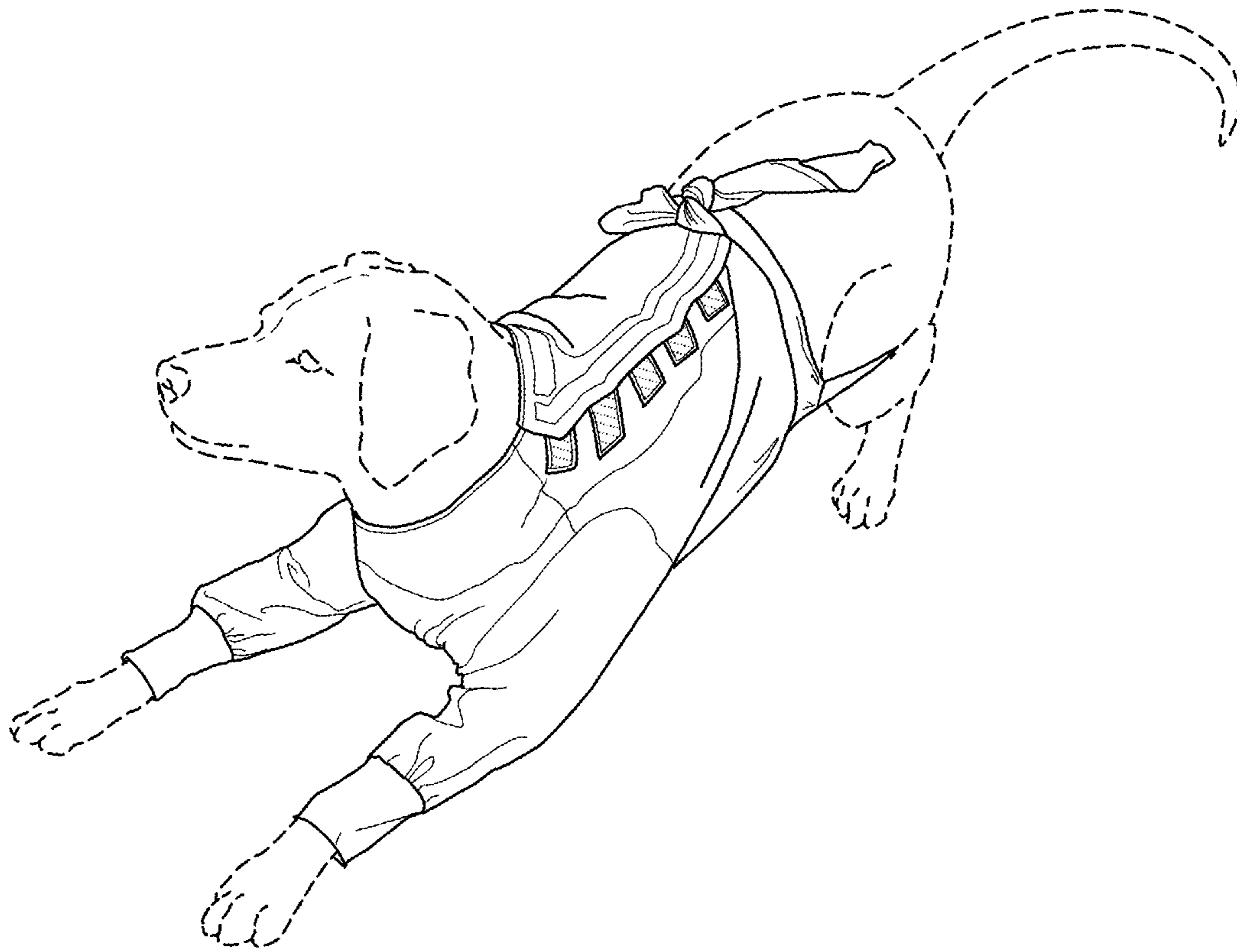

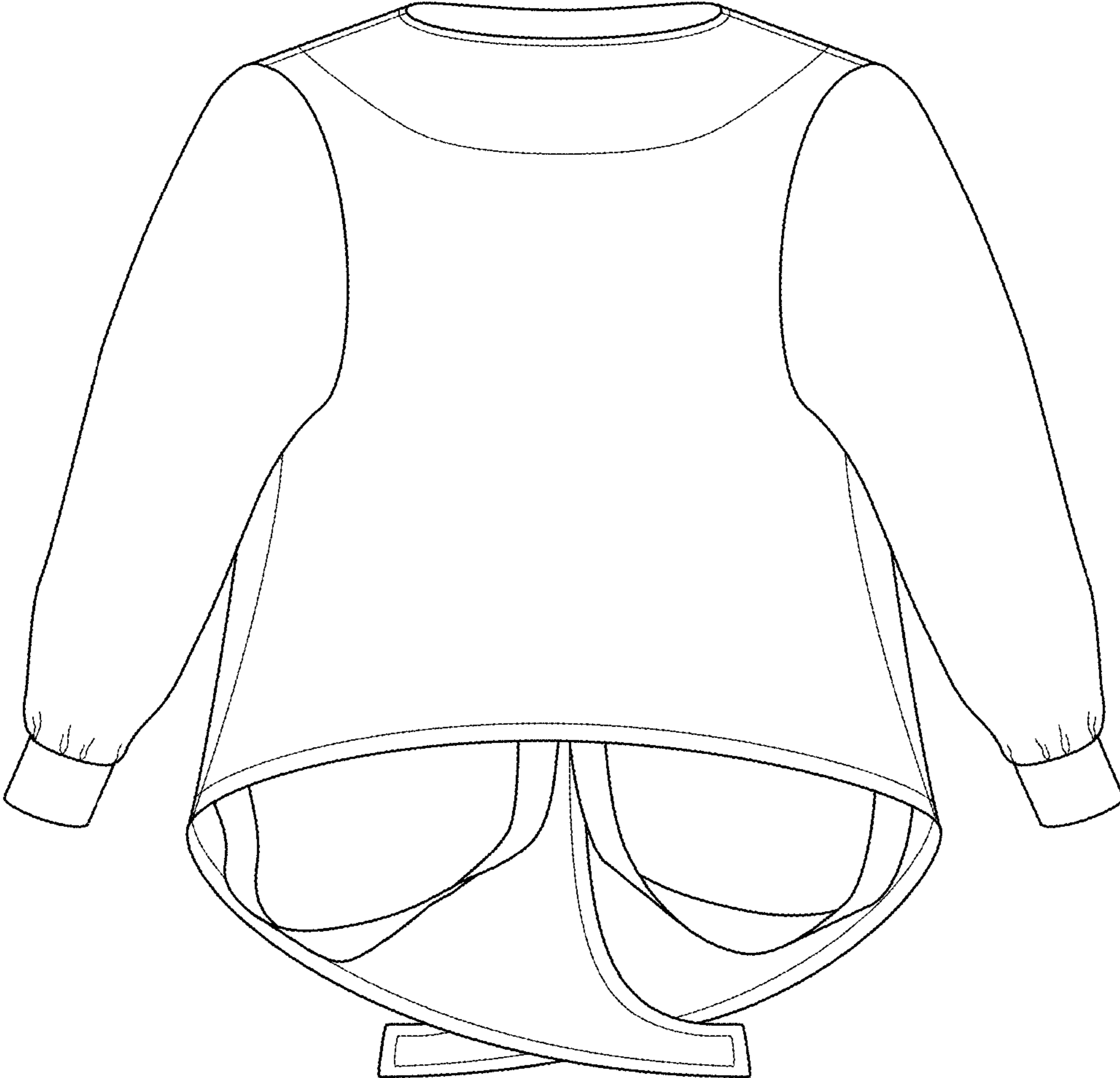

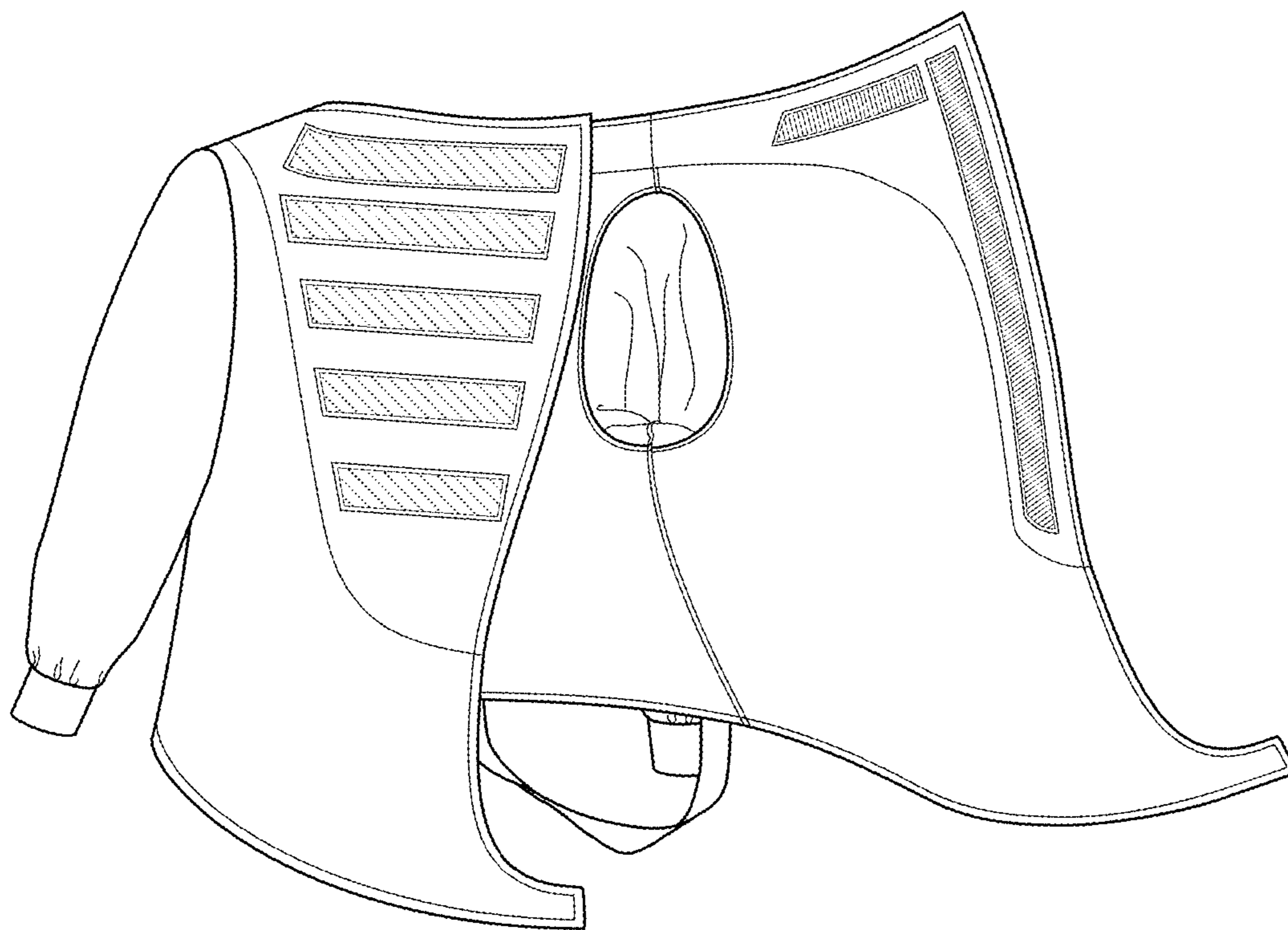

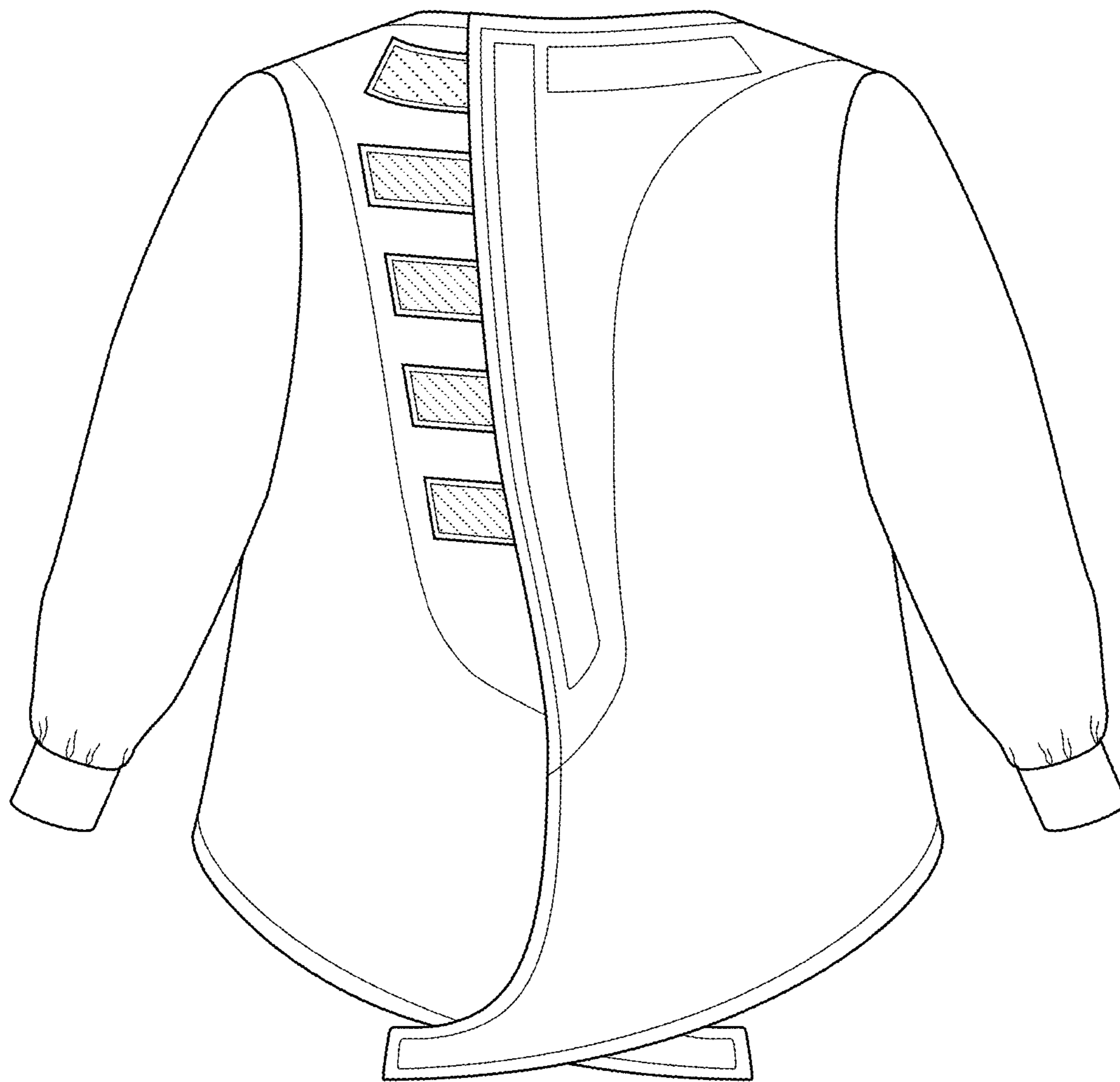
