DESCRIPTION

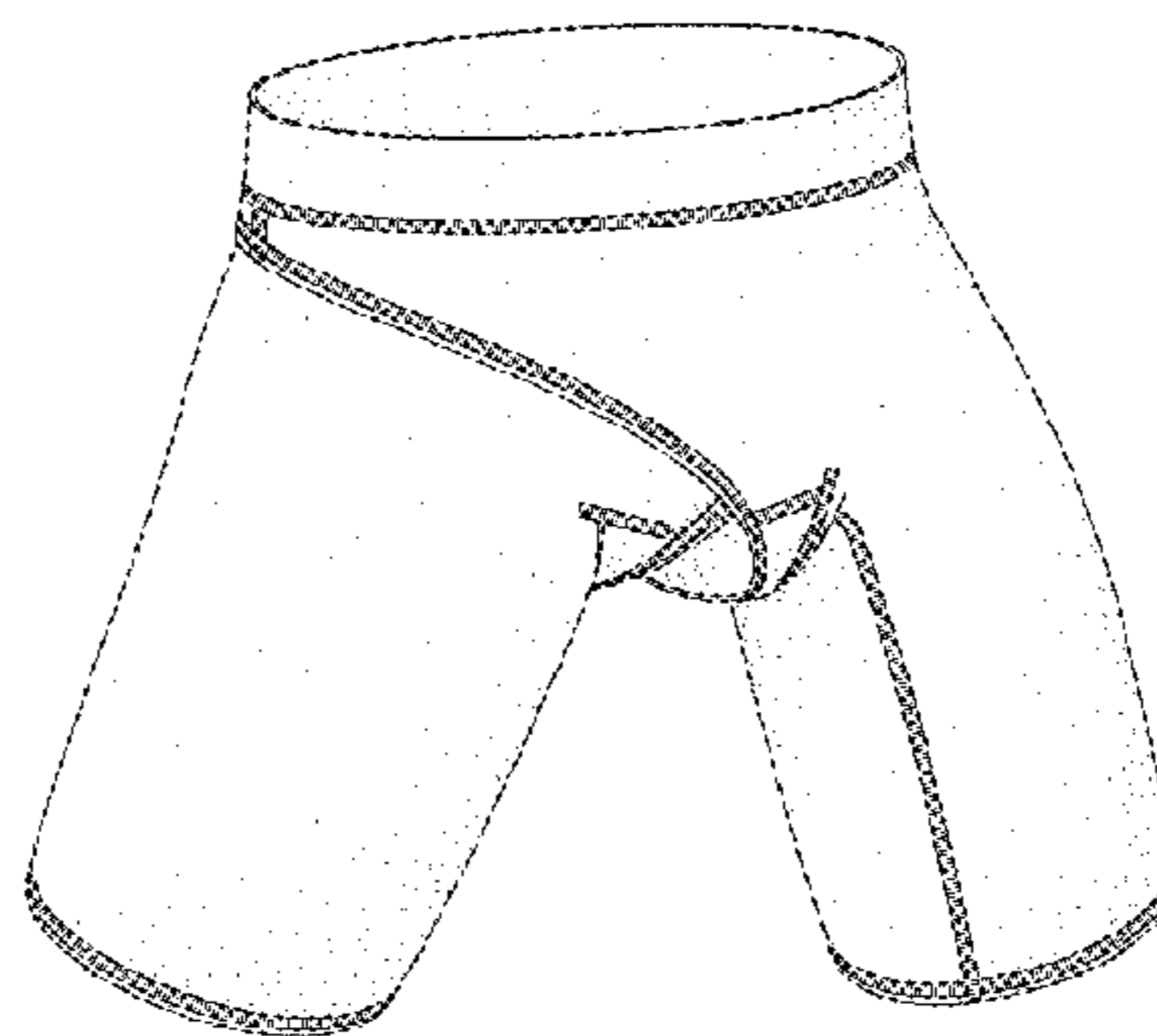
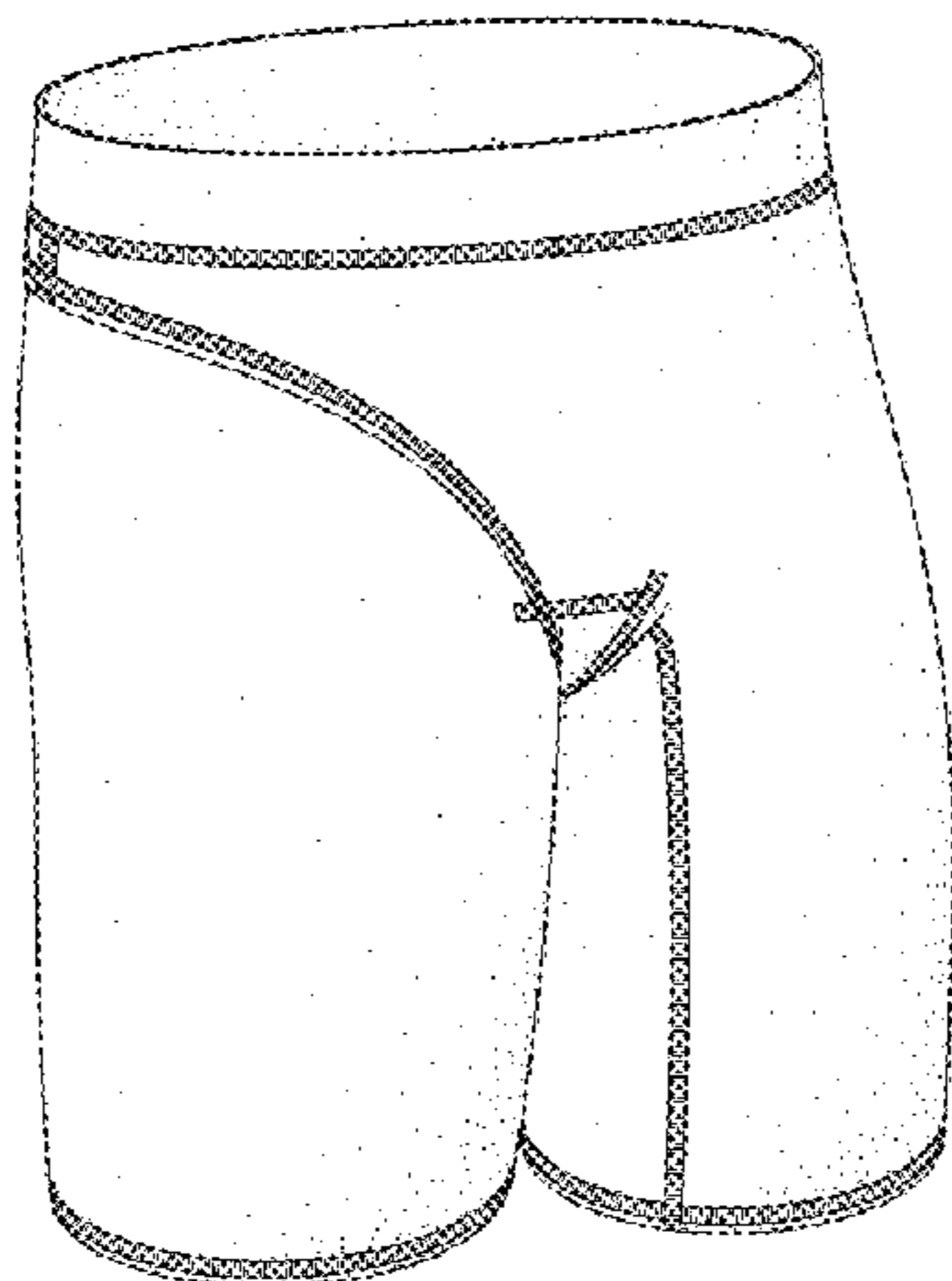
FIG. 1 is an isometric view of a split groin undergarment in the closed configuration;

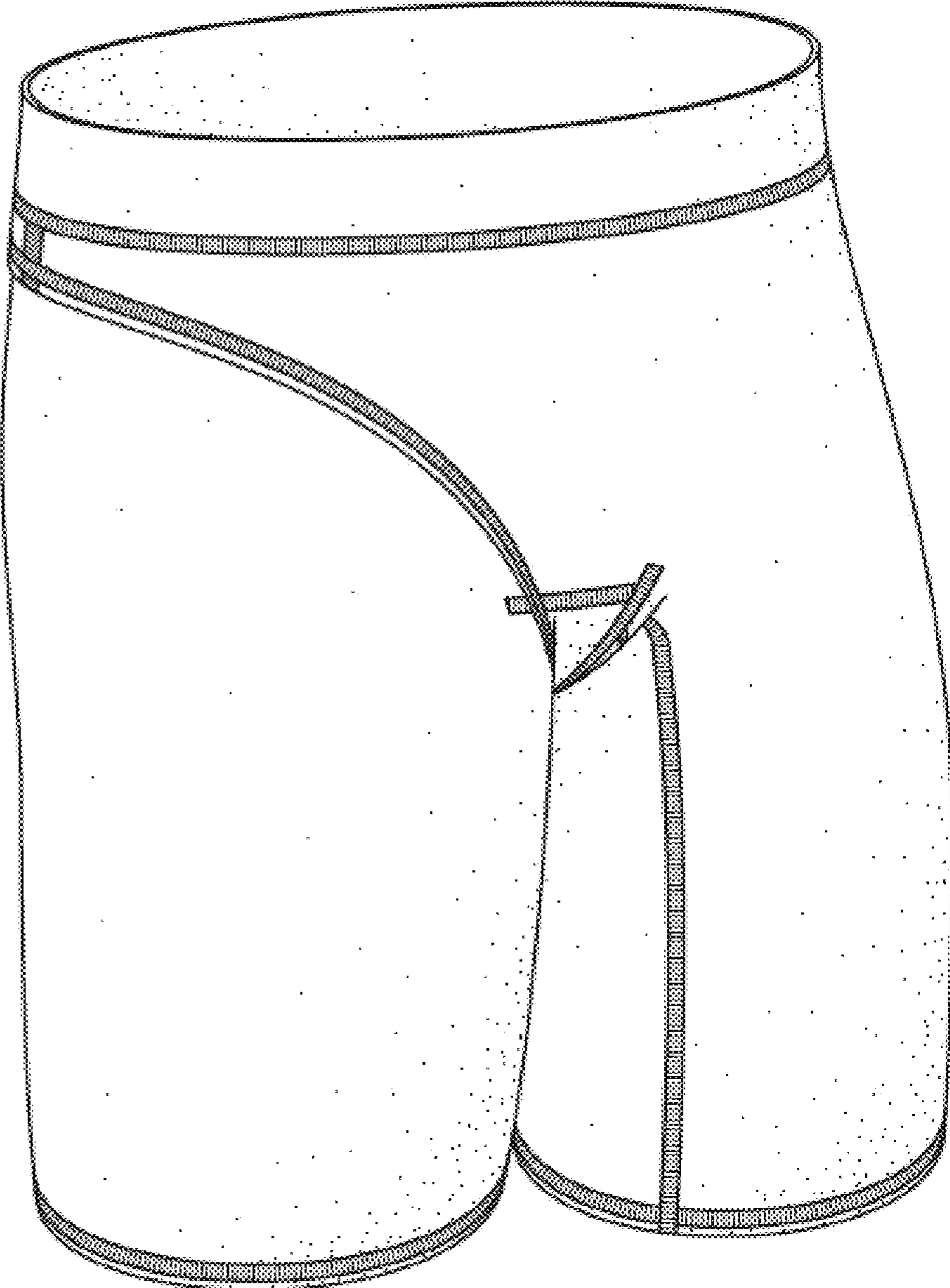

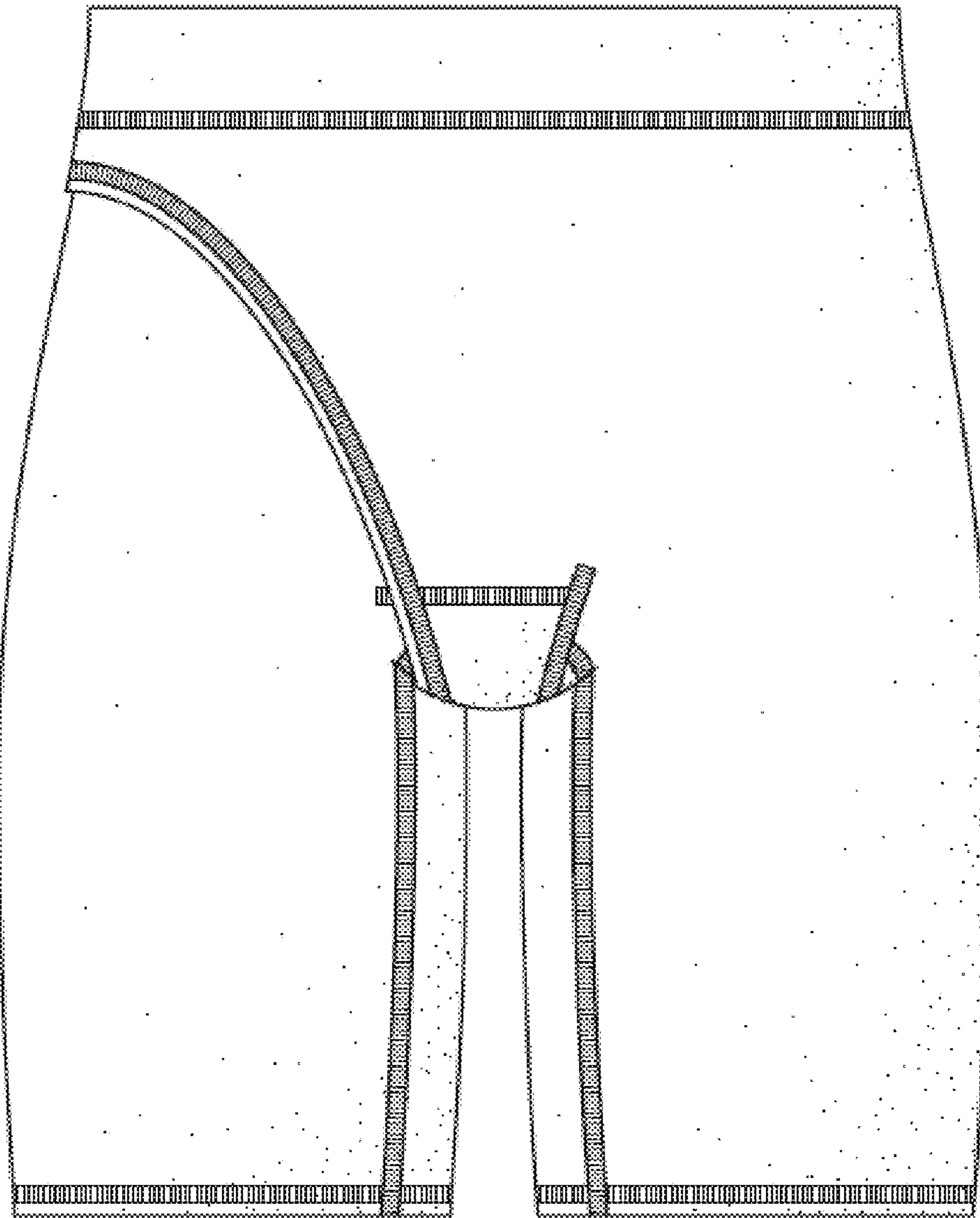

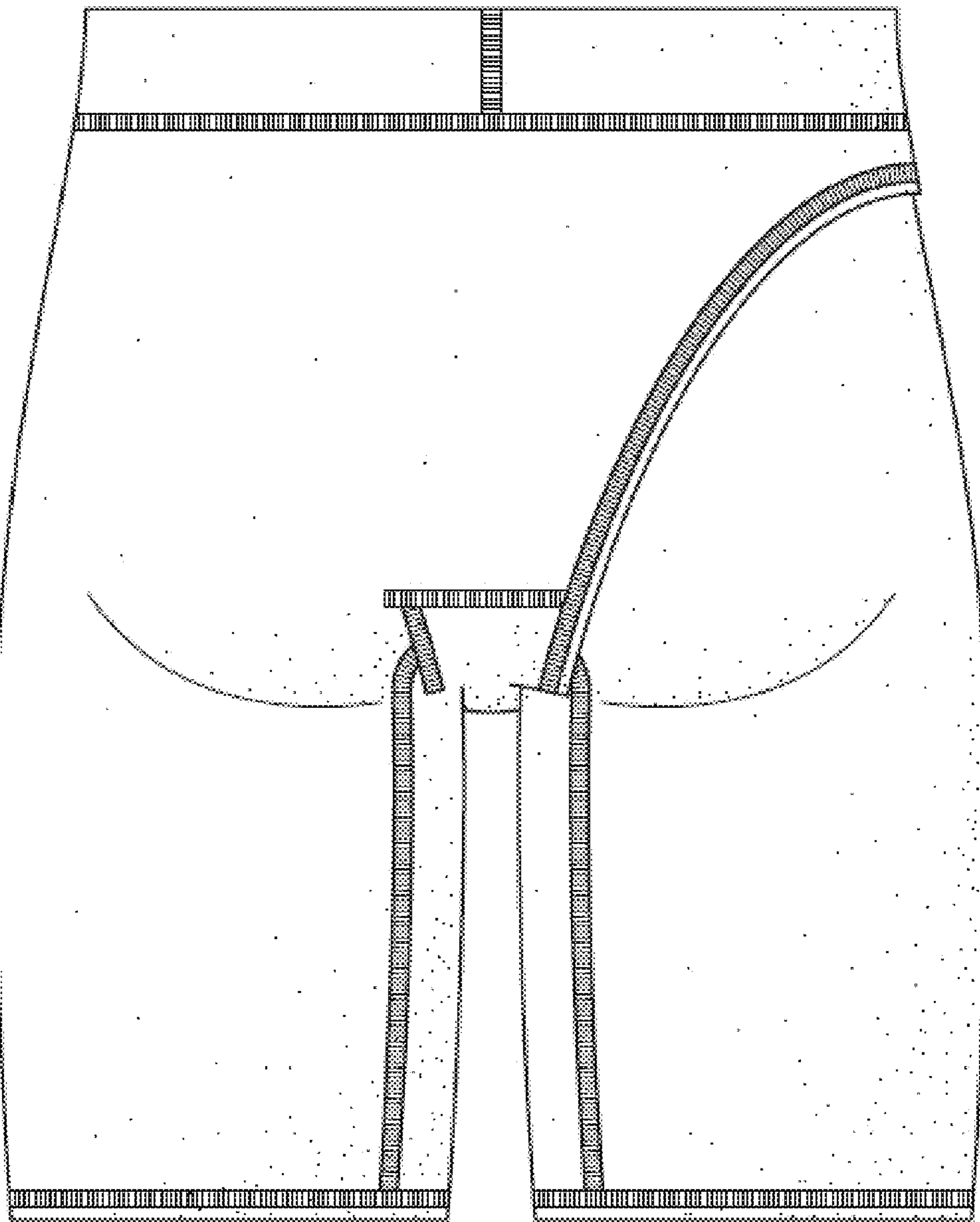

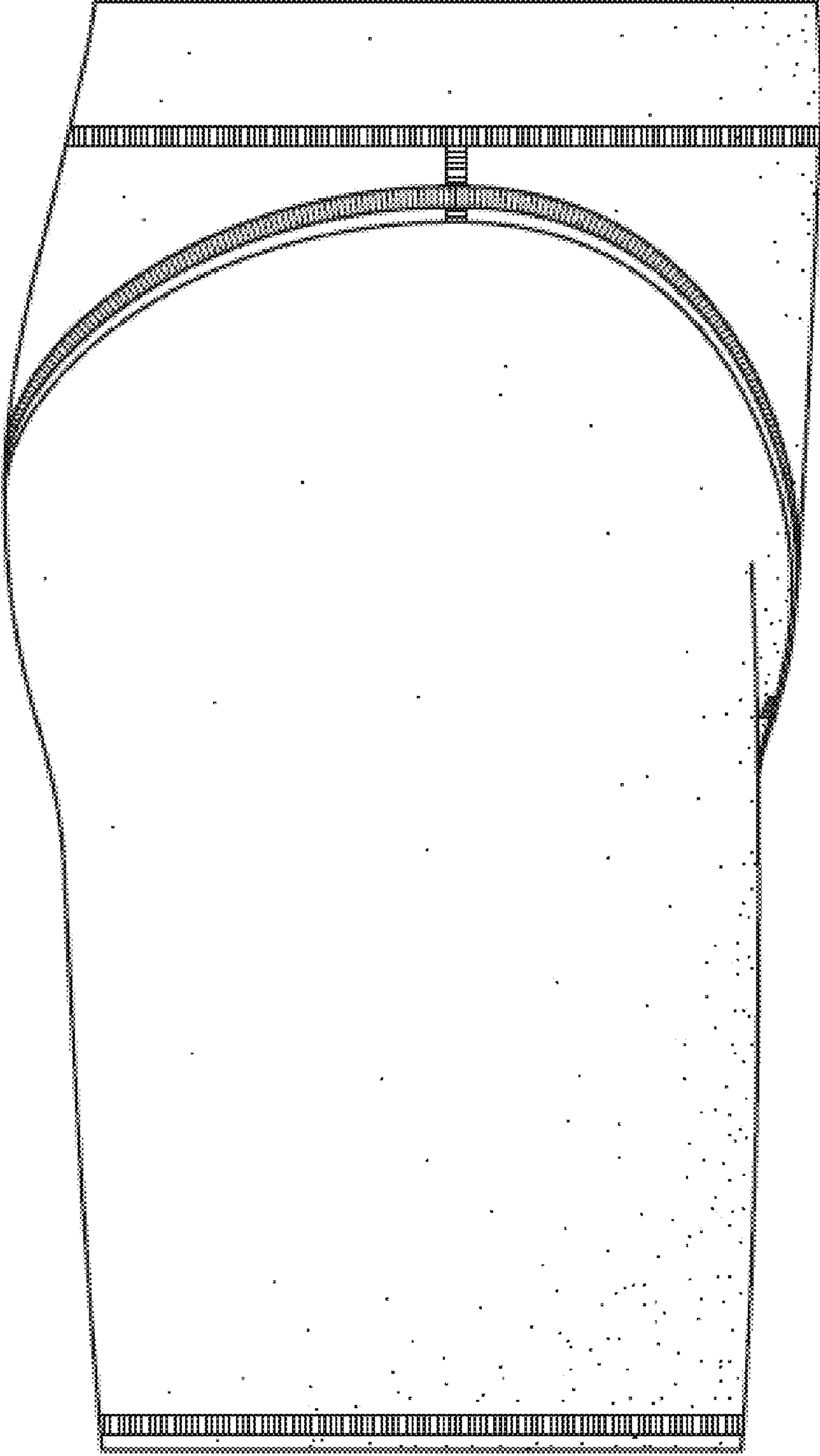

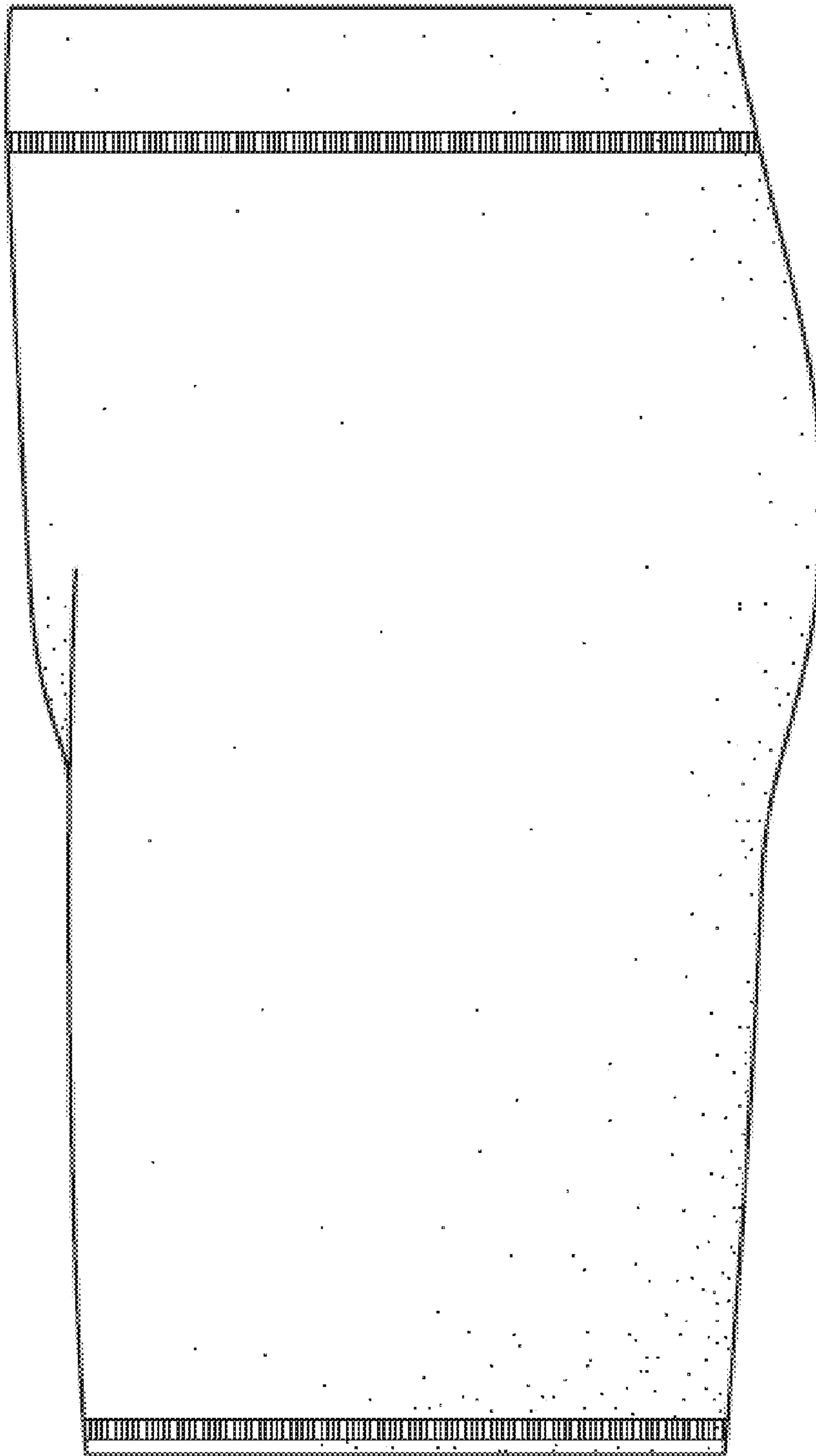

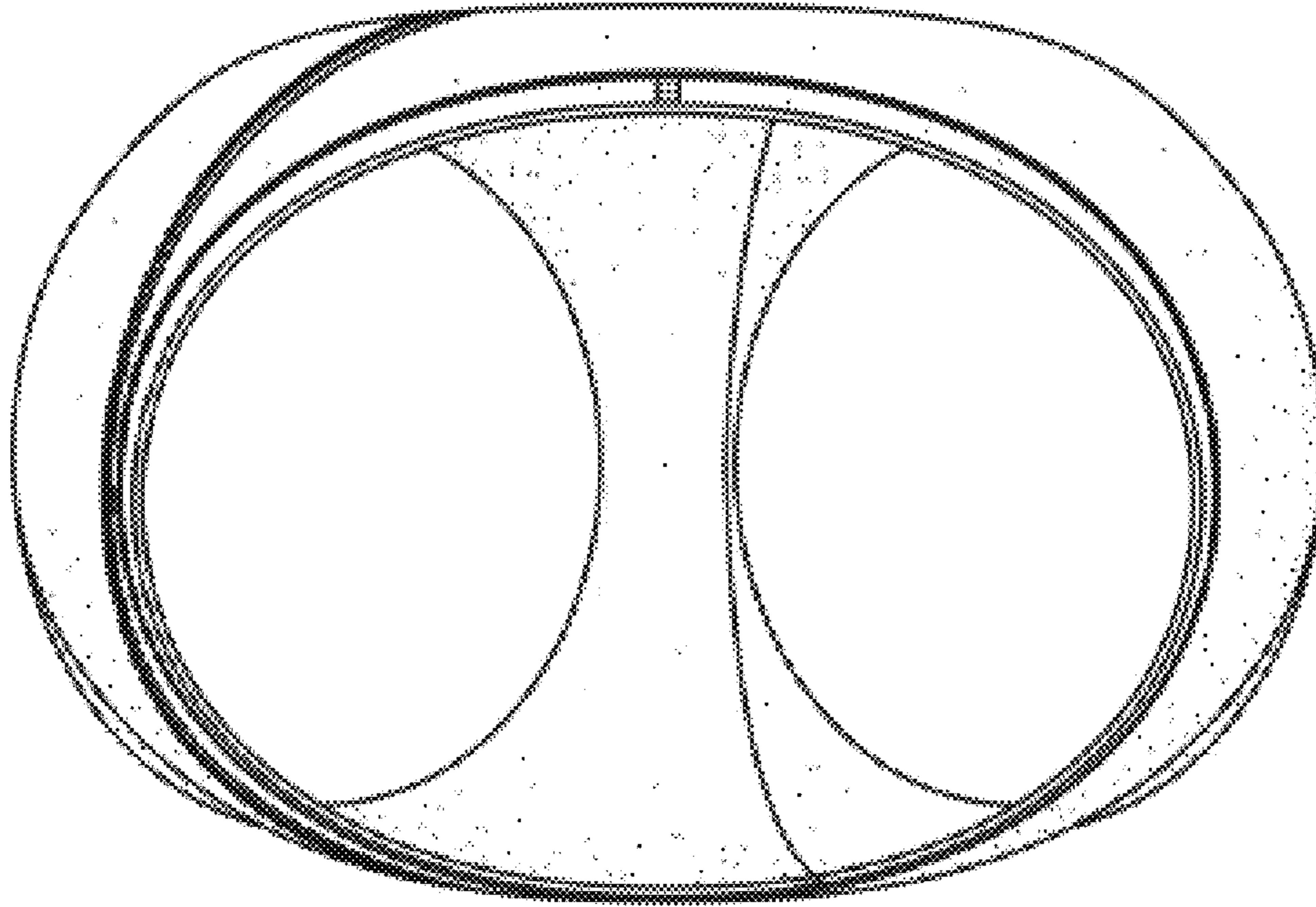

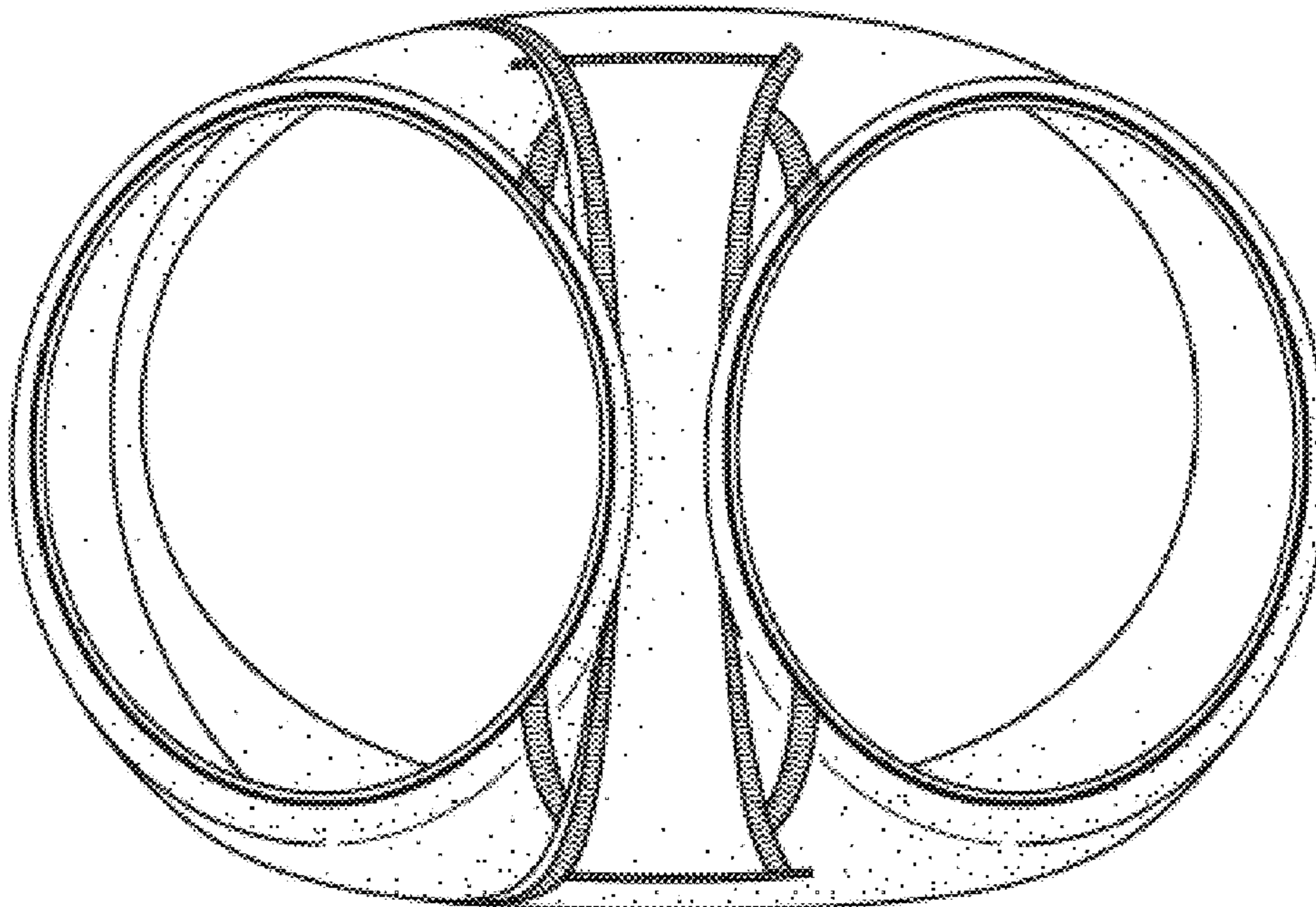

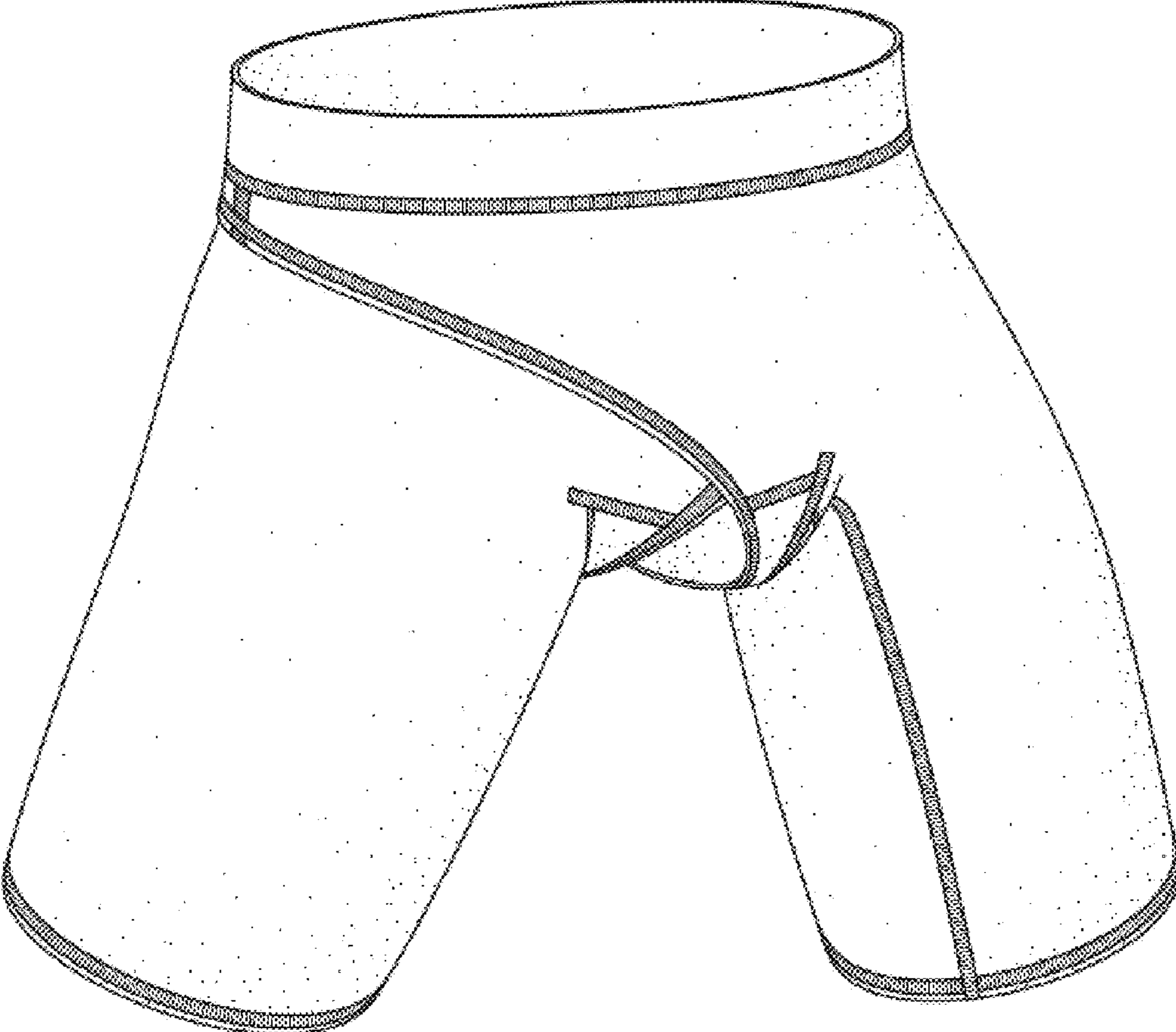

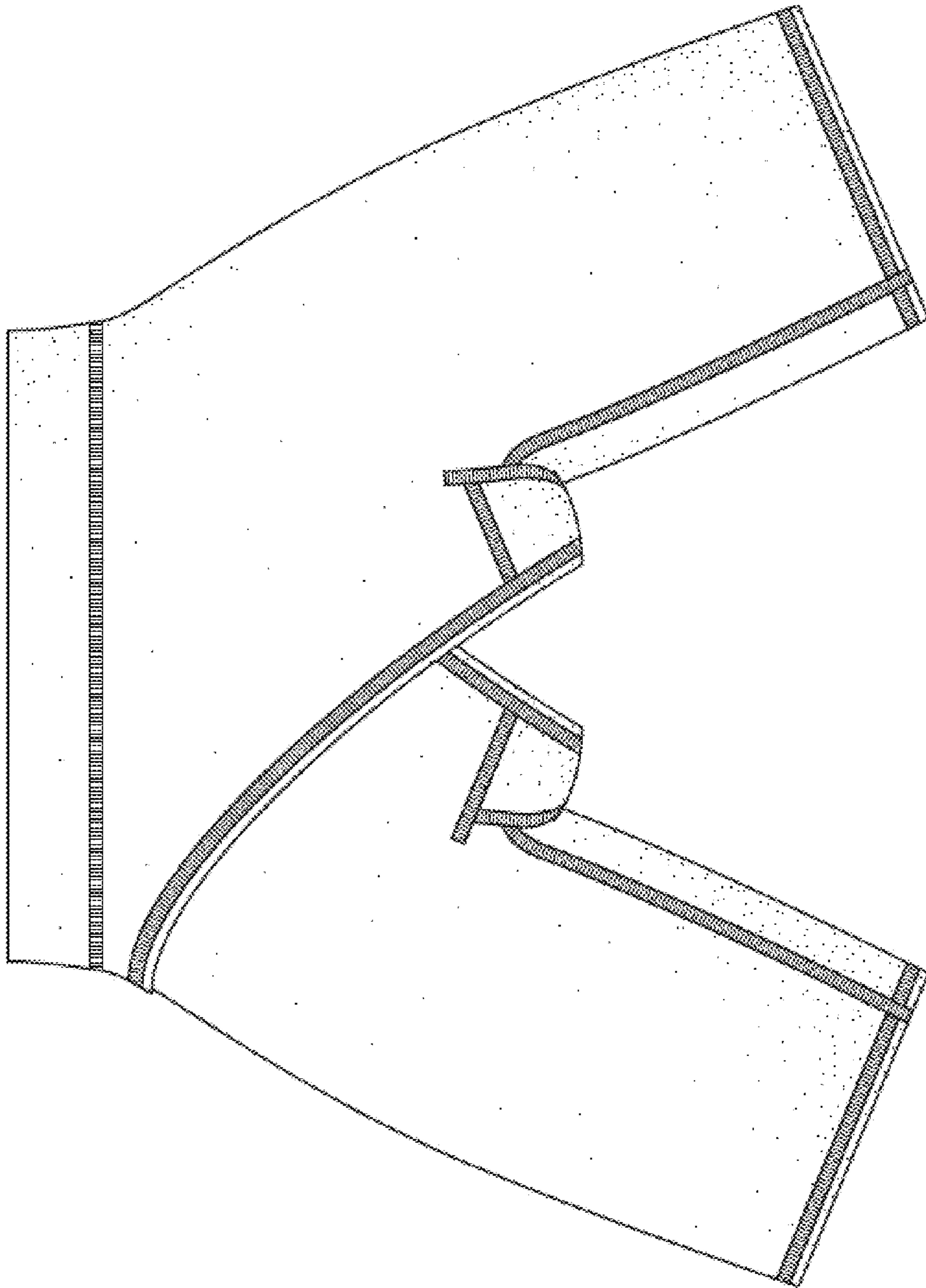

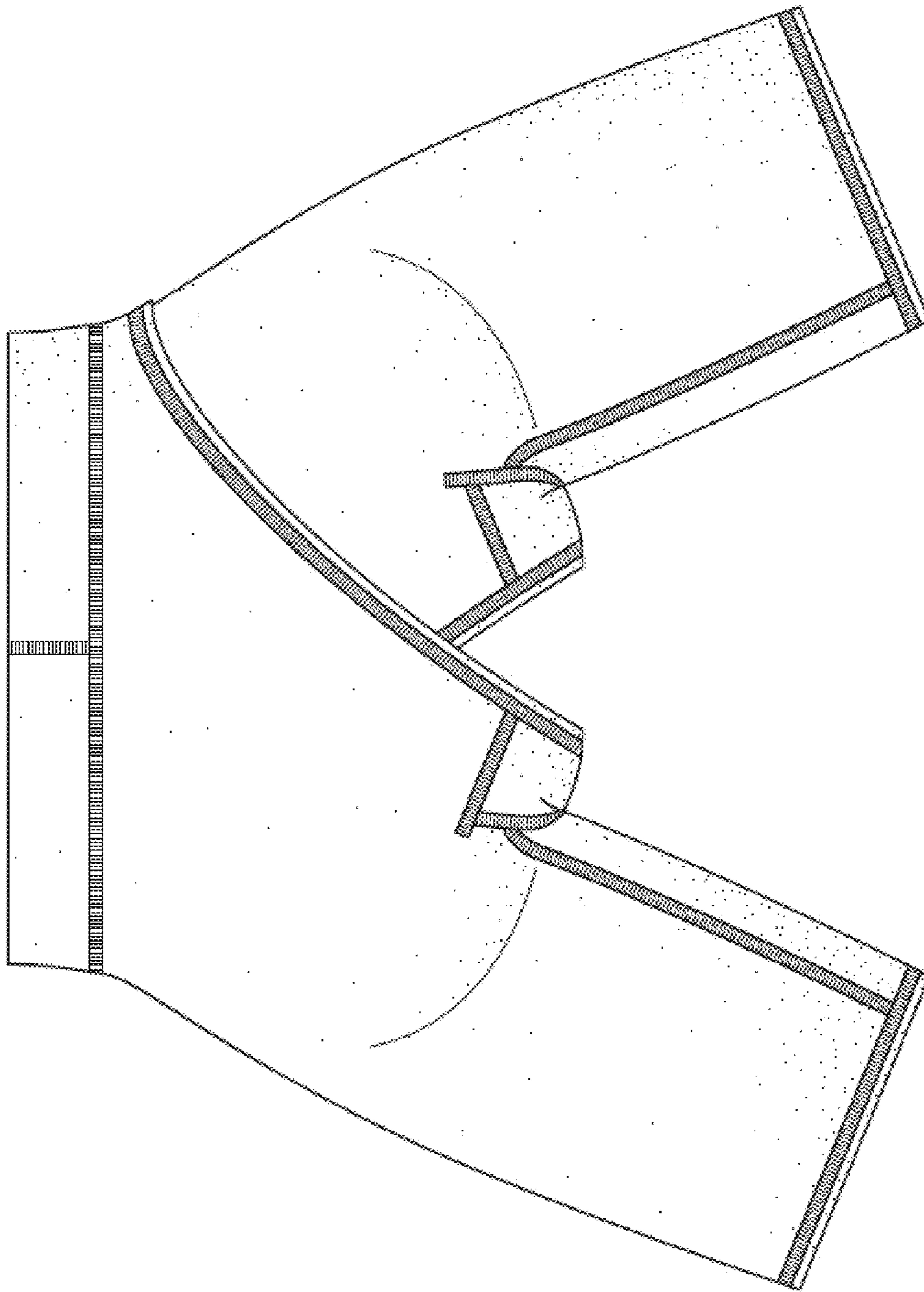

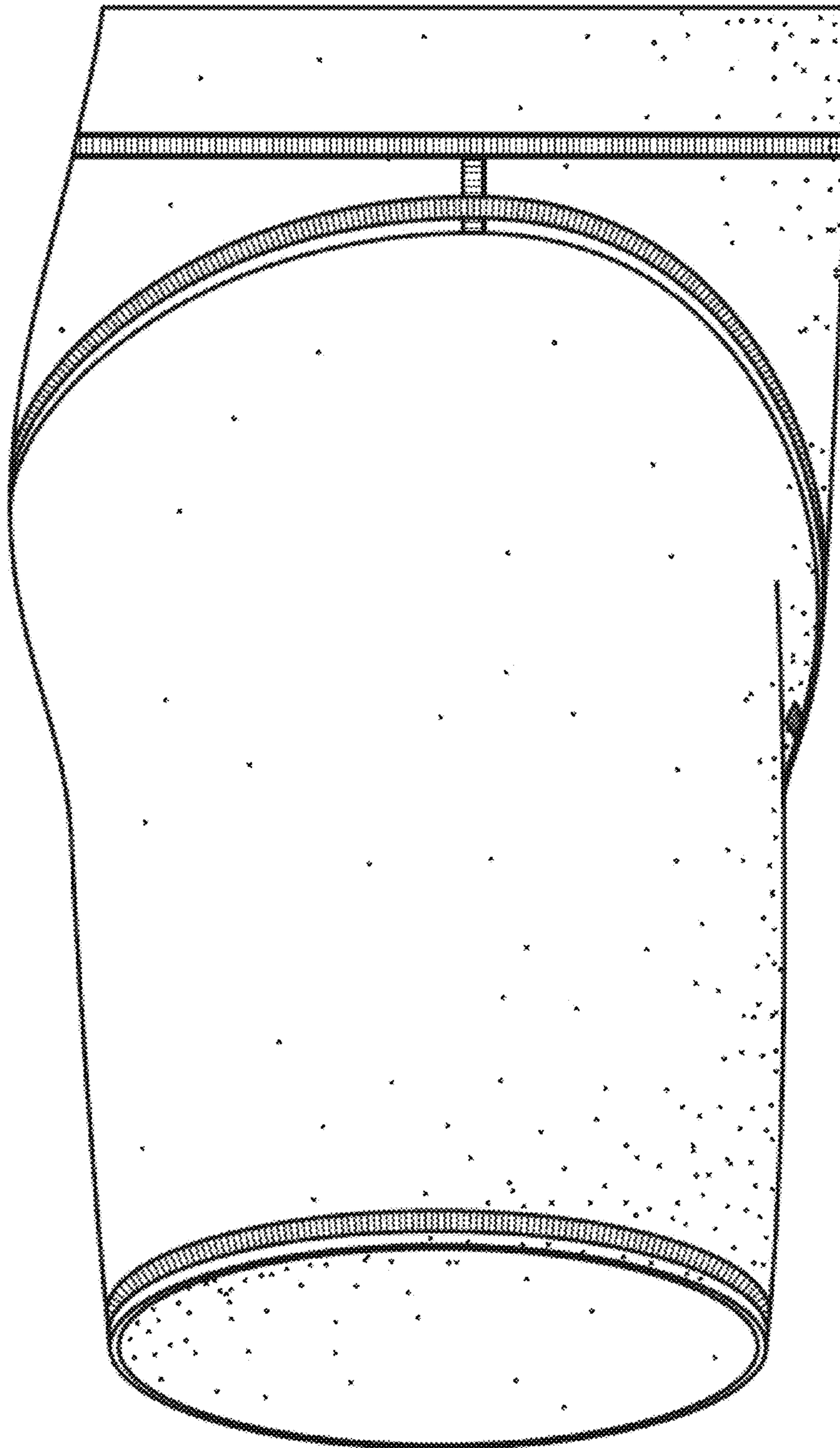

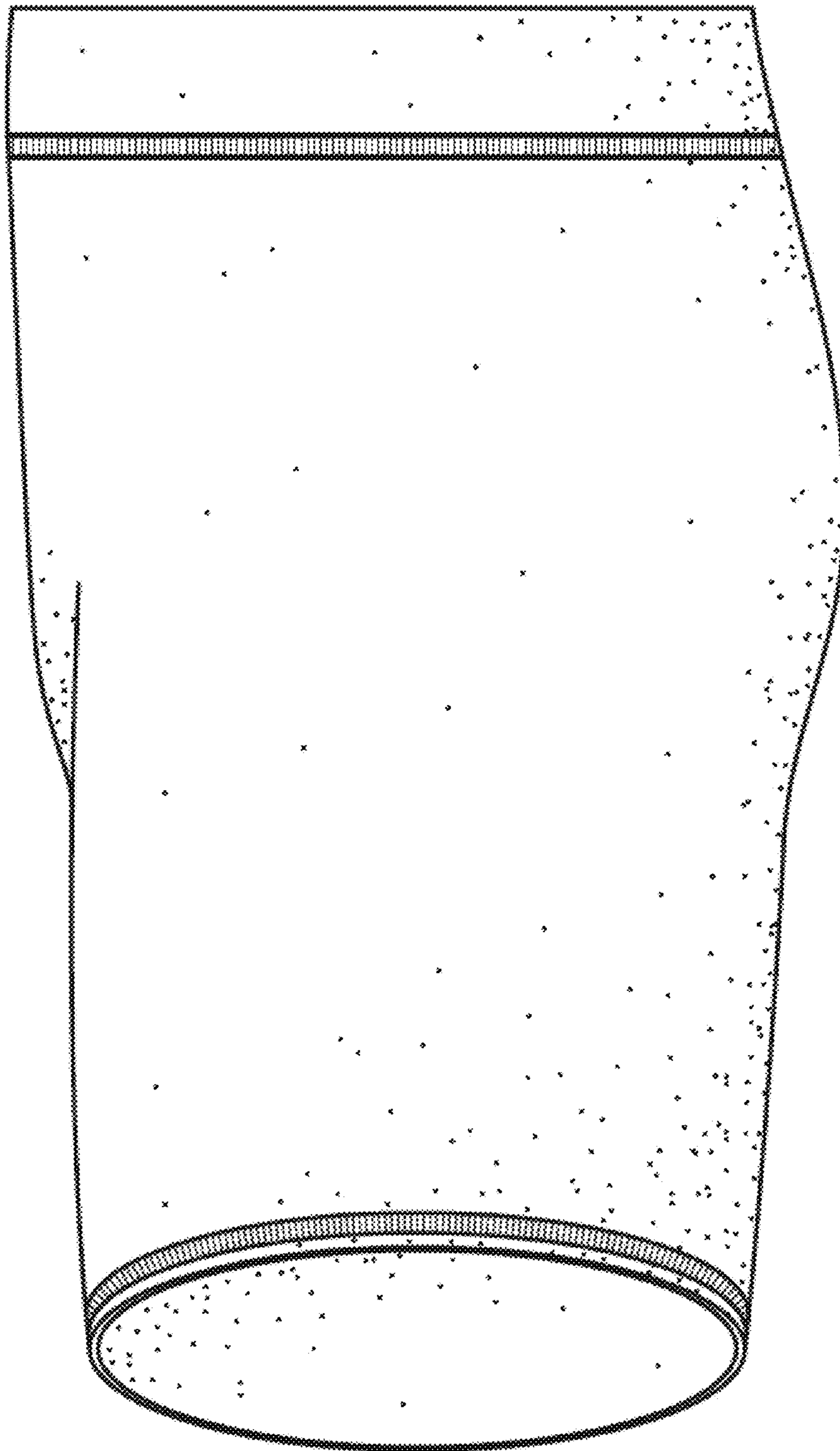

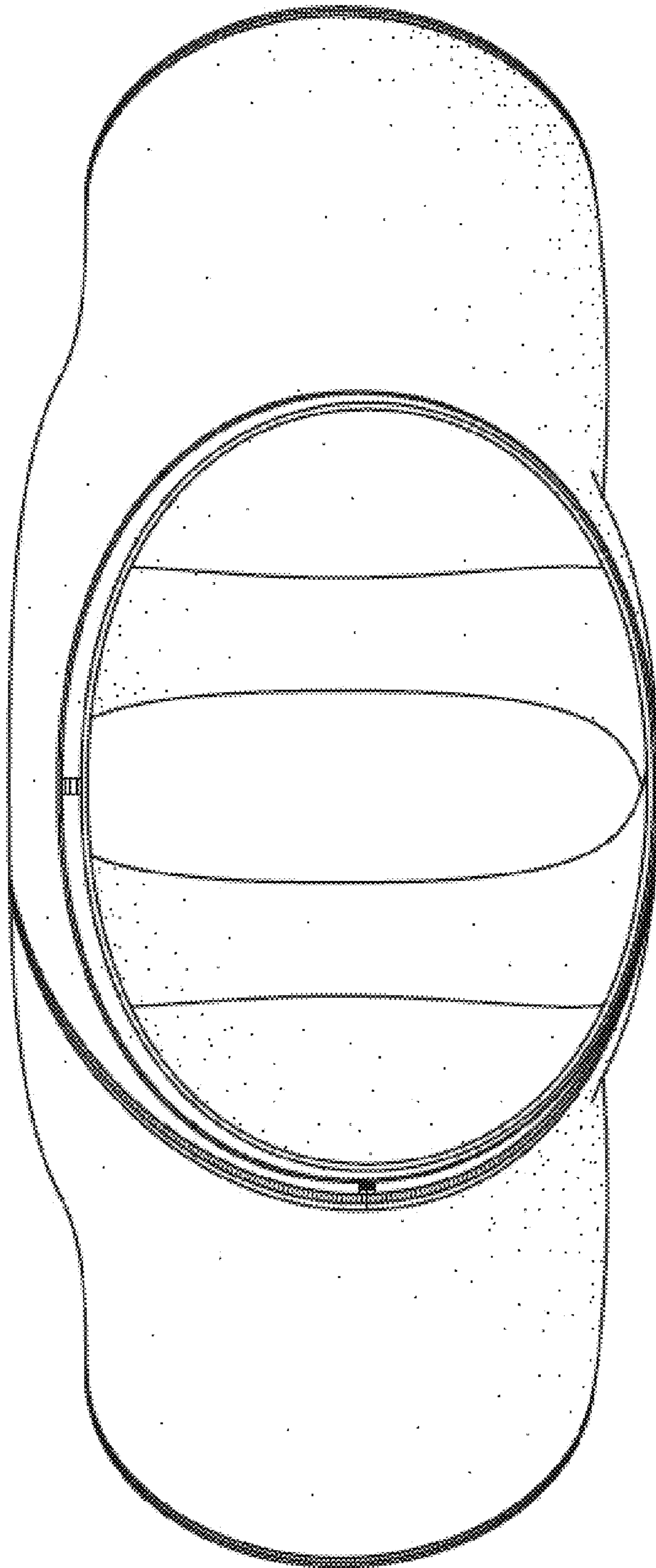

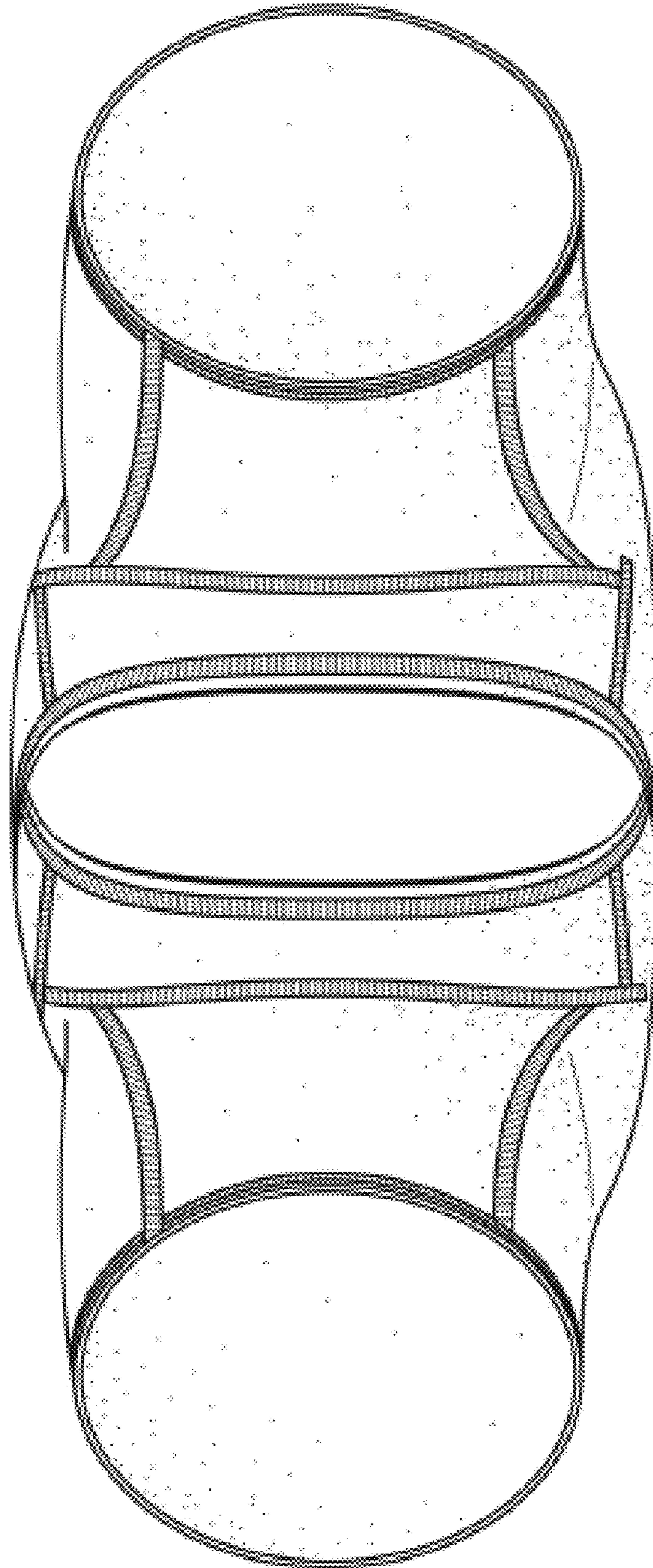
