(57) **CLAIM**

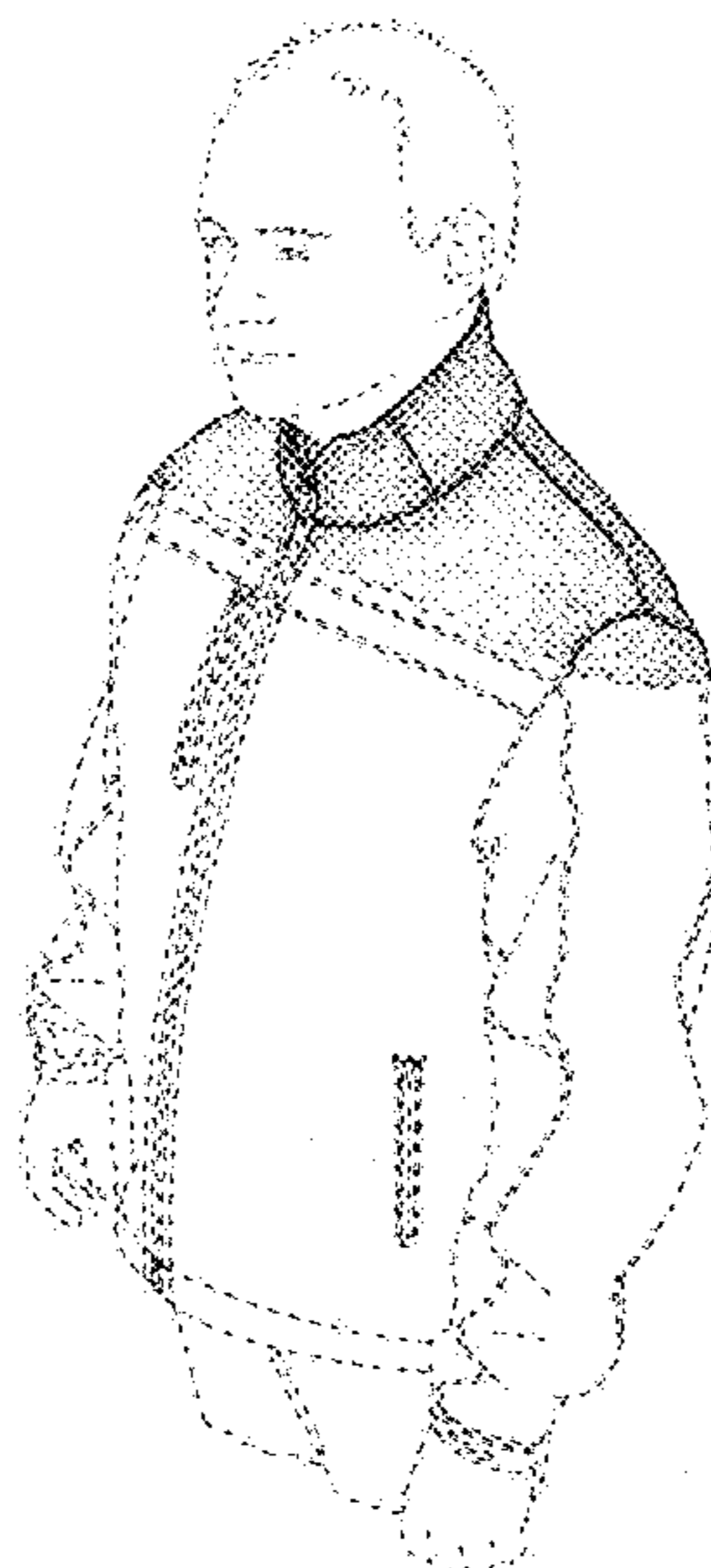
The ornamental design for an upper portion of outerwear, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an upper portion of outerwear showing my new design;
 FIG. 2 is a top view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a side elevation view thereof;
 FIG. 5 is a rear view thereof; and,
 FIG. 6 is an opposite side elevation view thereof.

The broken line showing of the person is included for the purpose of illustrating environment, and the broken line showing of the lower portion of the outerwear is unclaimed subject matter; both form no part of the claimed design. The logo appearing on the rear portion of the outerwear shown in broken lines forms no part of the claimed design. All remaining broken lines are representative of stitching that forms part of the claimed design.

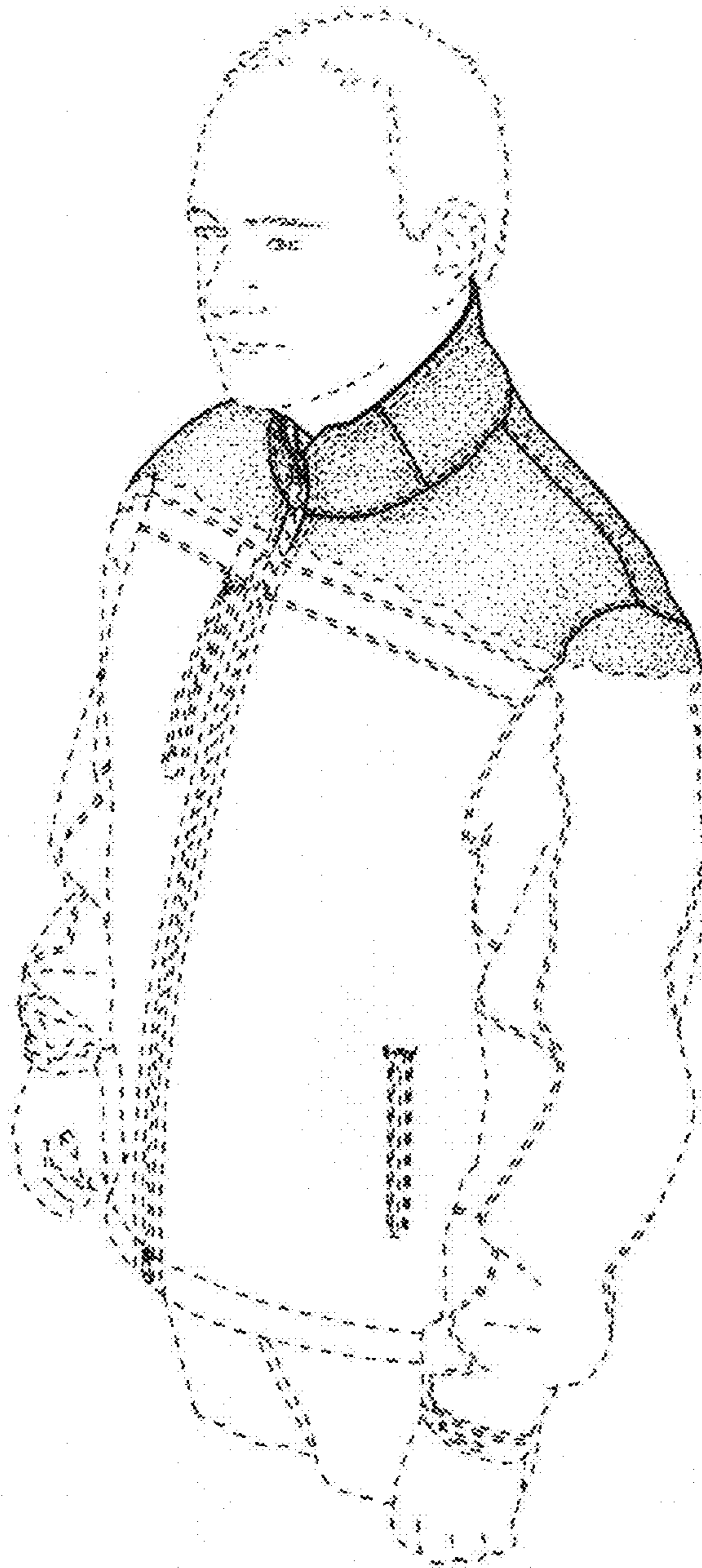
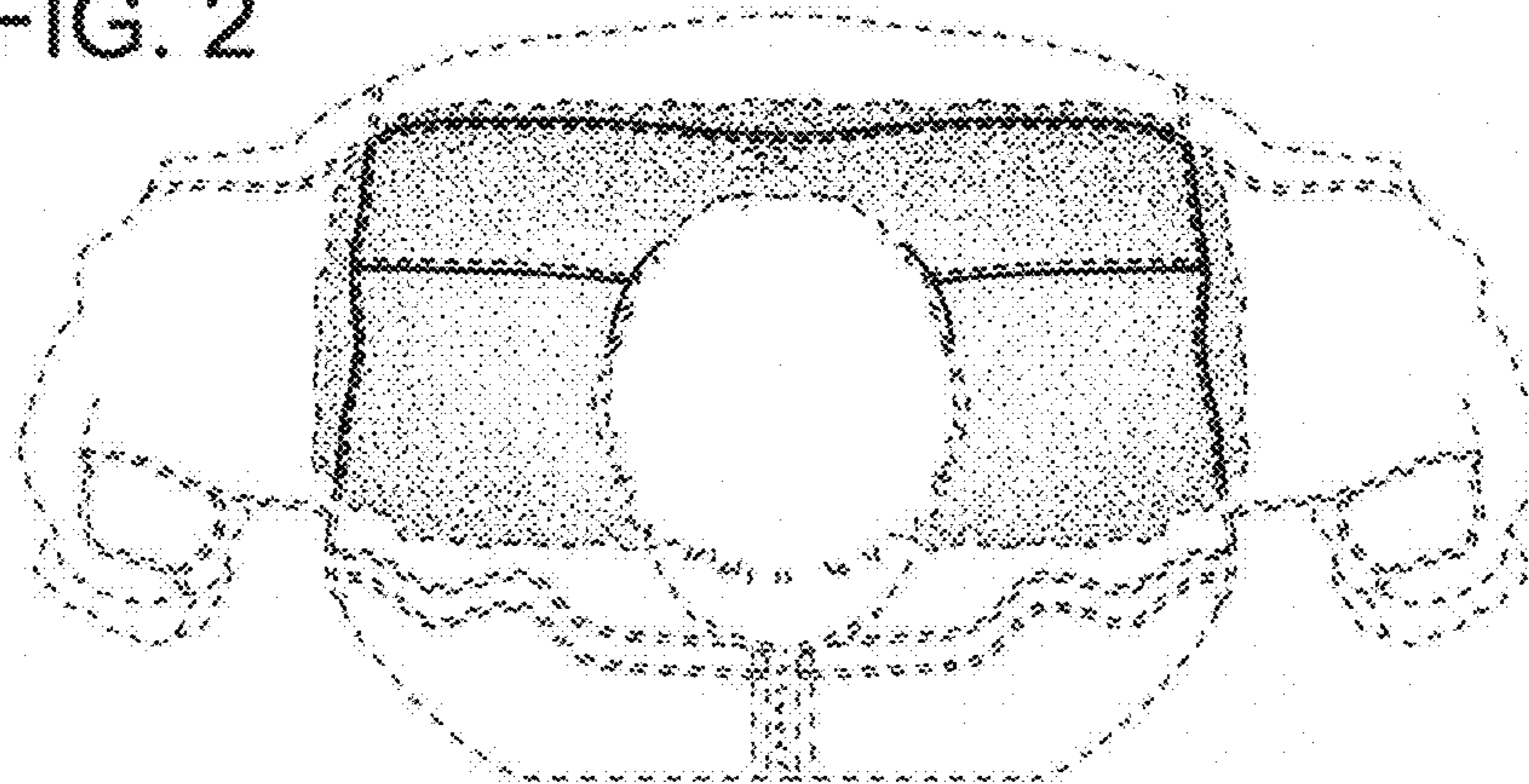

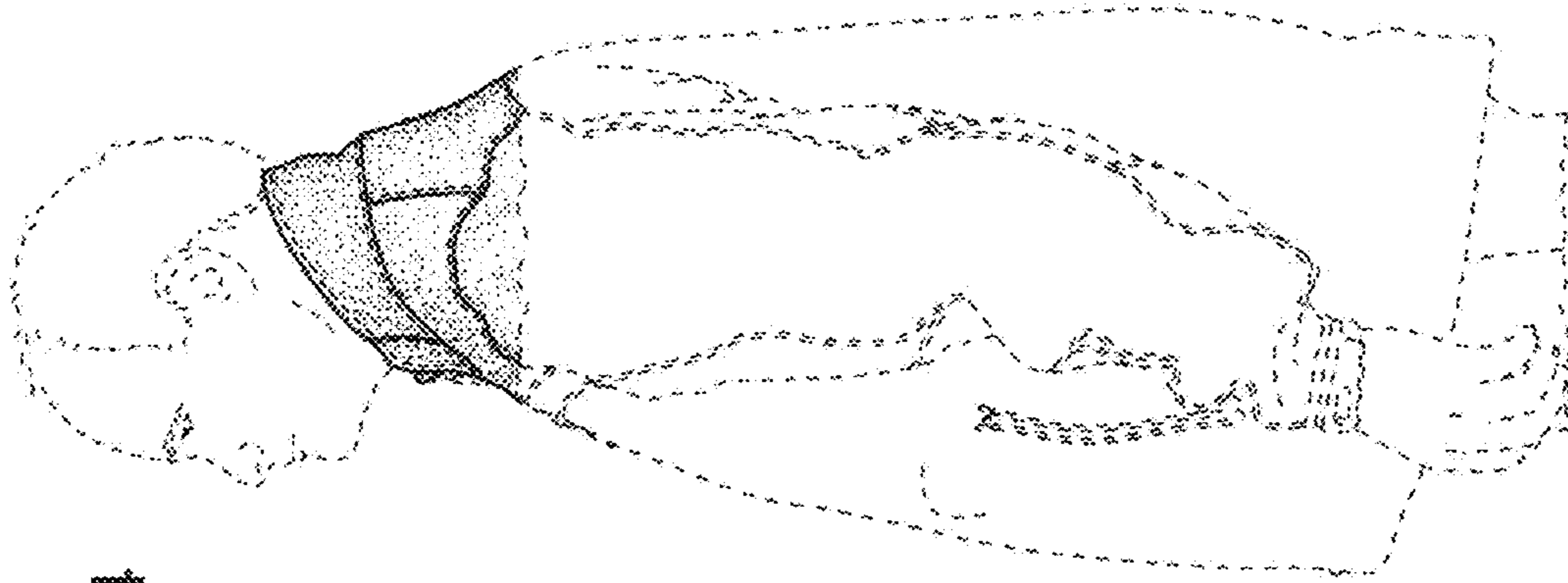

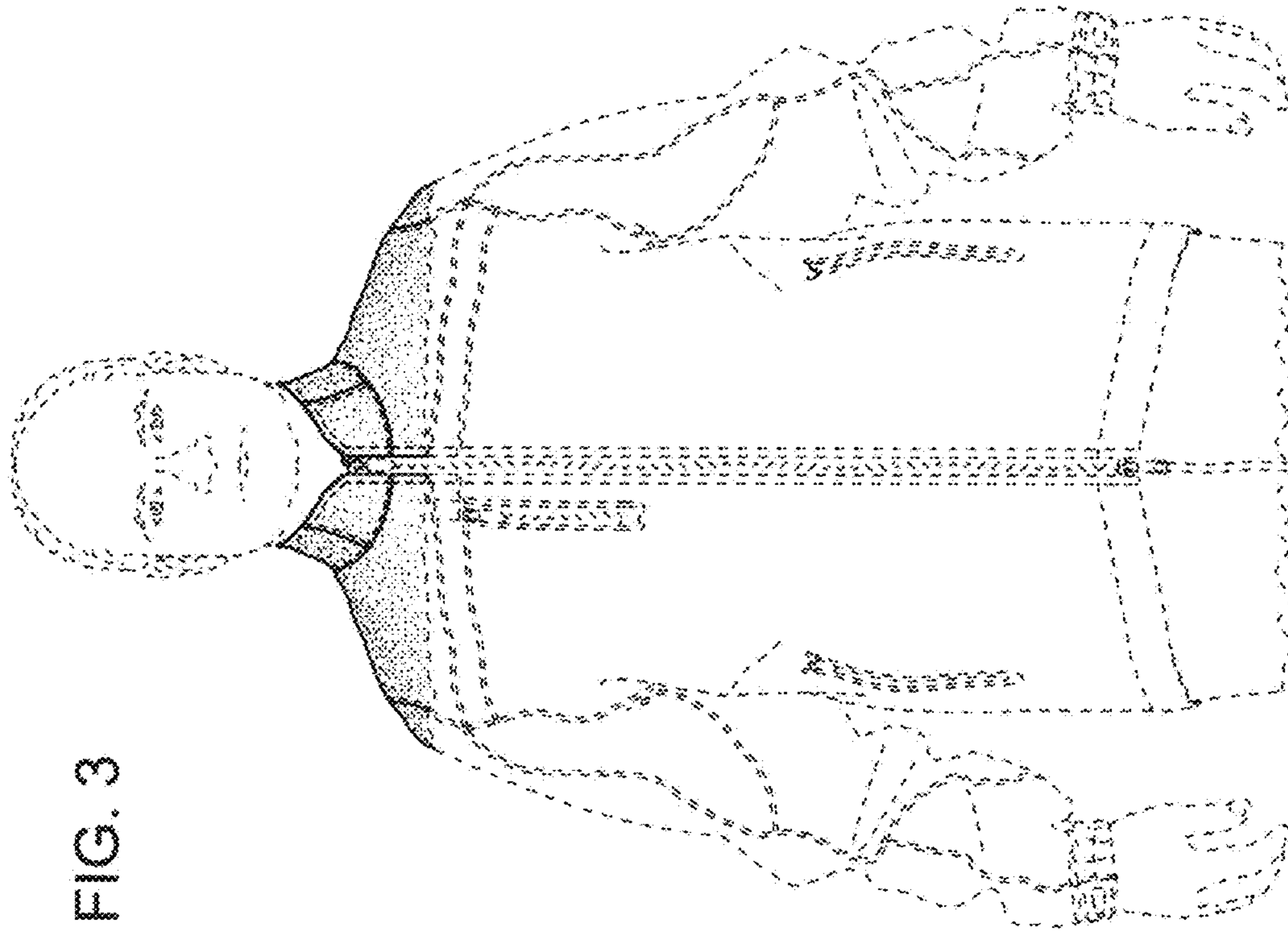

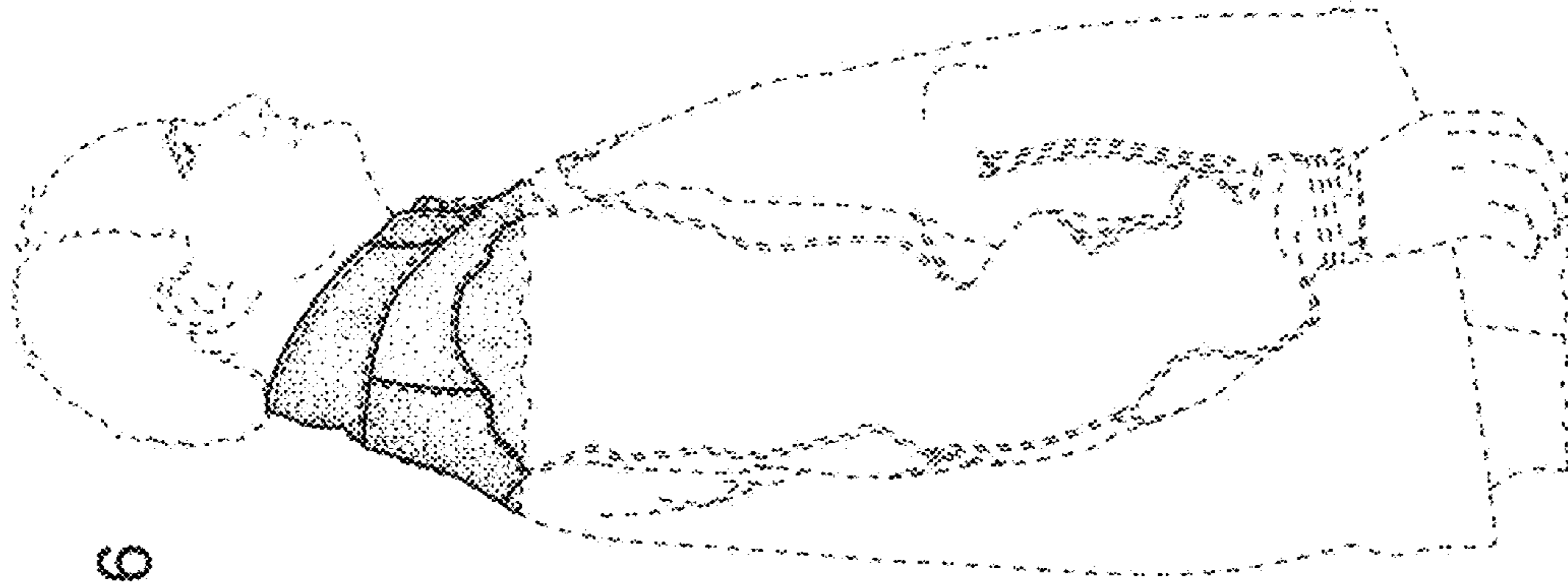

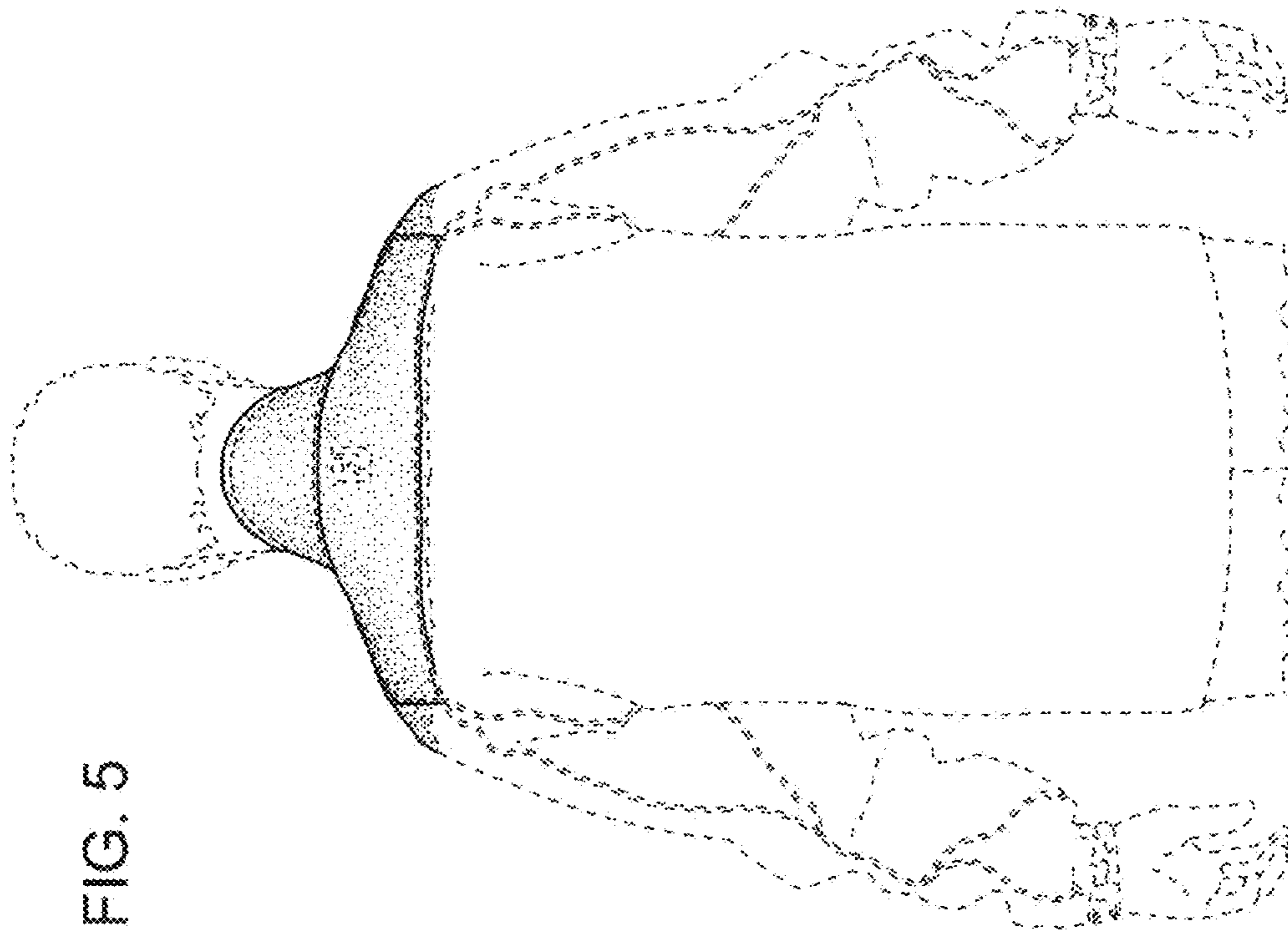
