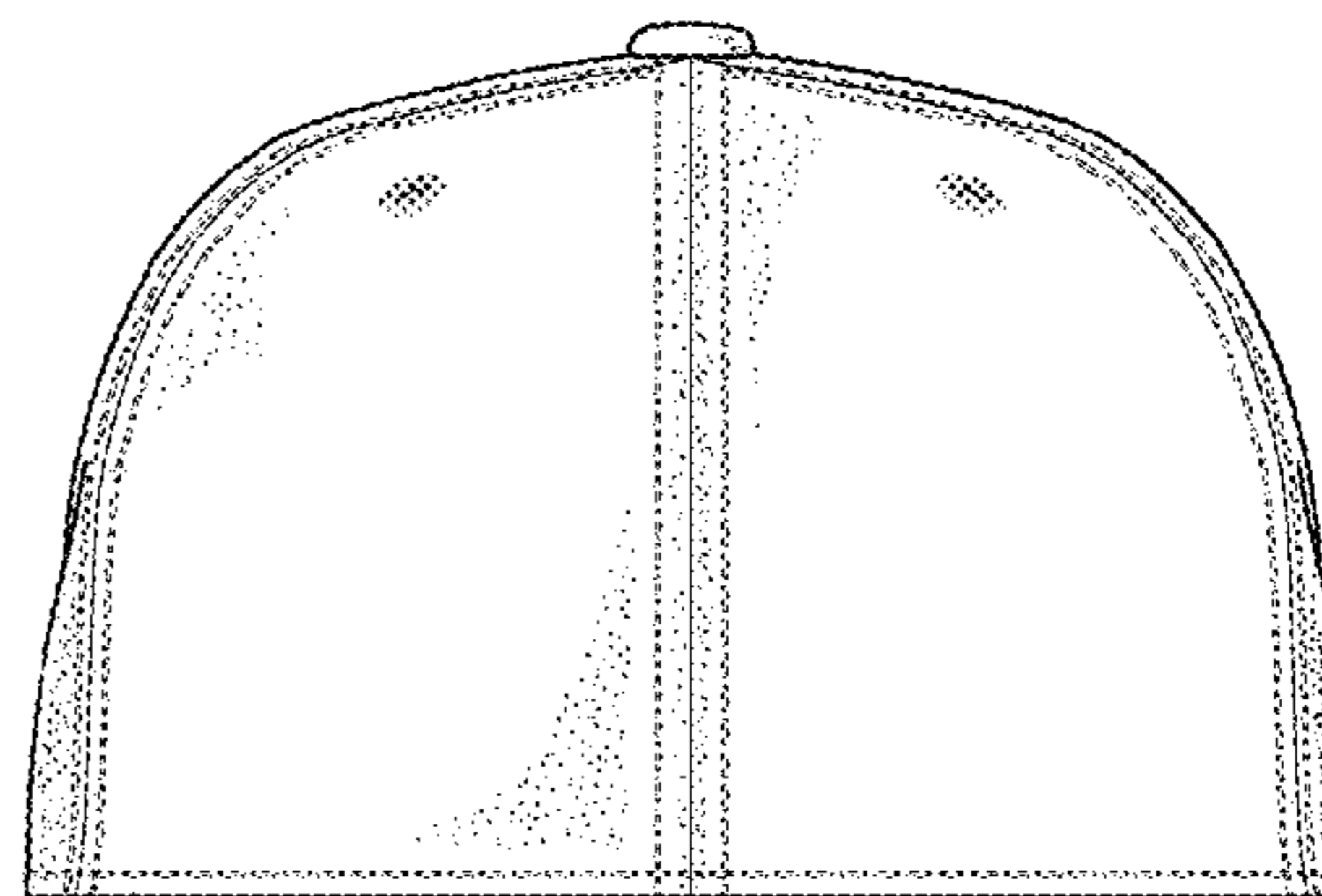
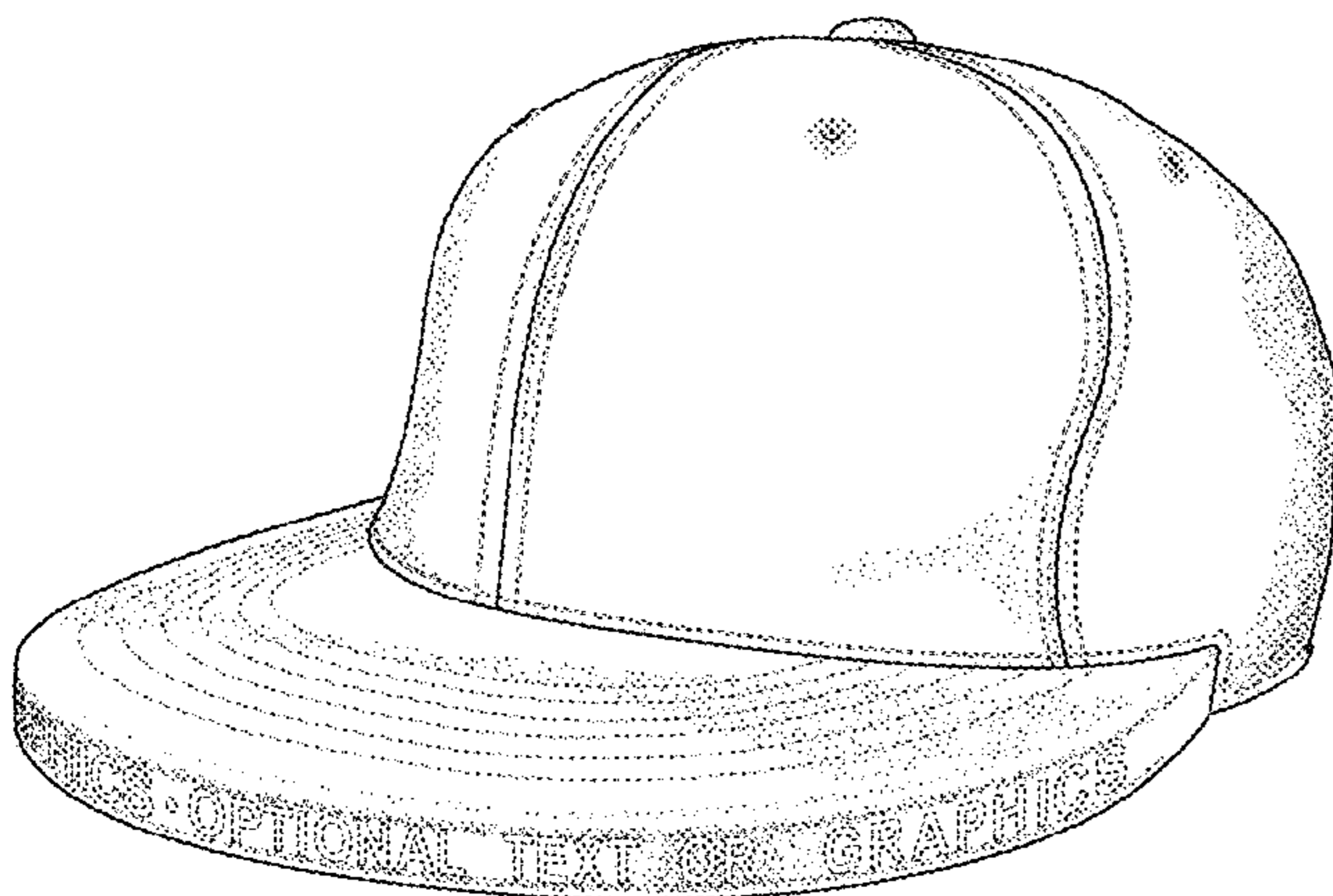
We claim the ornamental design for a hat with flat thick brim, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the claimed design.  
FIG. 2 is a front elevation view thereof.  
FIG. 3 is a rear elevation view thereof.  
FIG. 4 is a left-side elevation view thereof.  
FIG. 5 is a right-side elevation view thereof.  
FIG. 6 is a top plan view thereof.  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is a perspective view of the claimed design as worn by a user in one embodiment.

The solid lines represent the bounds of the claimed design, whereas those features shown in broken lines, including broken line text on the brim, form no part of the claimed

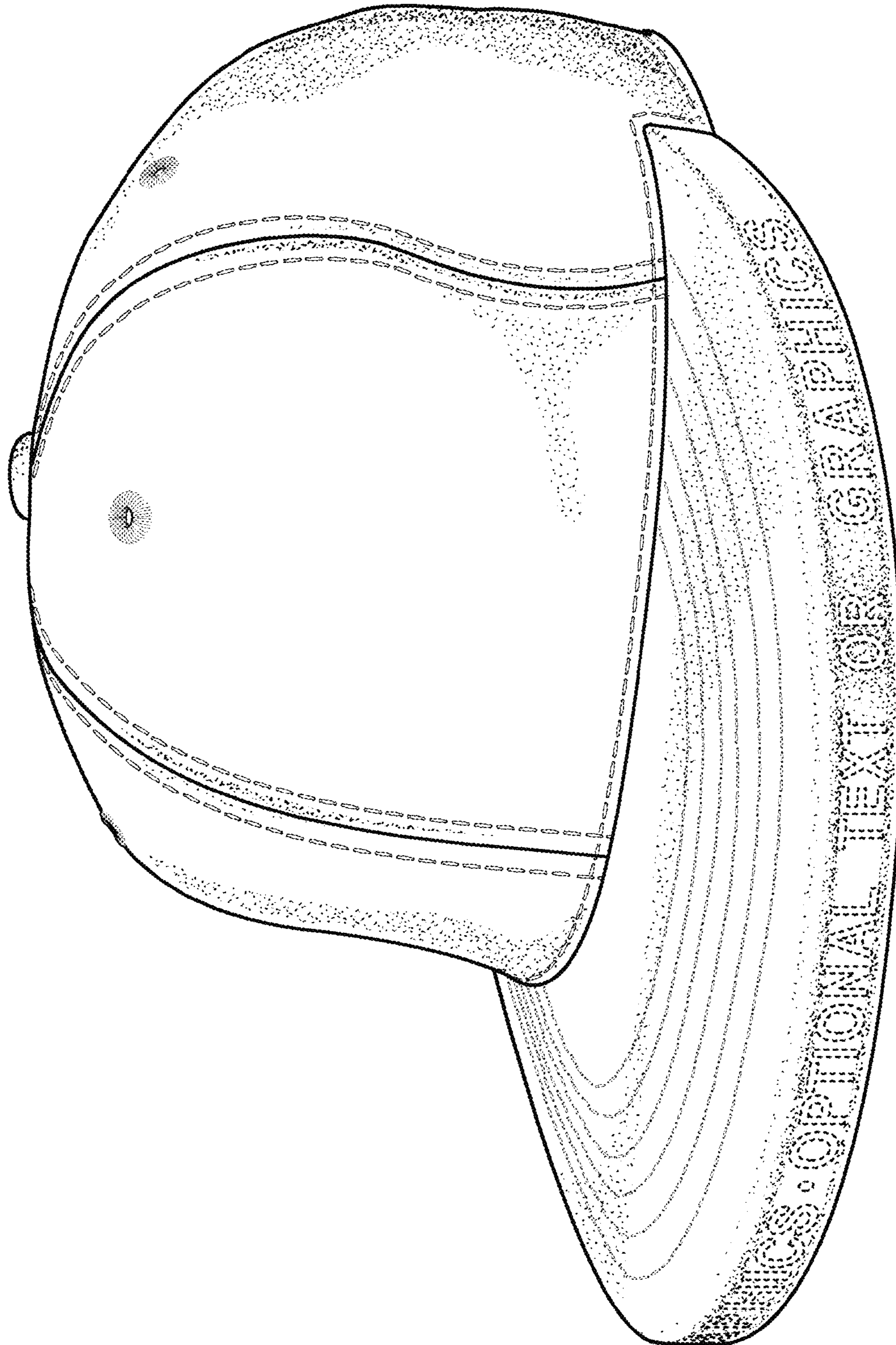

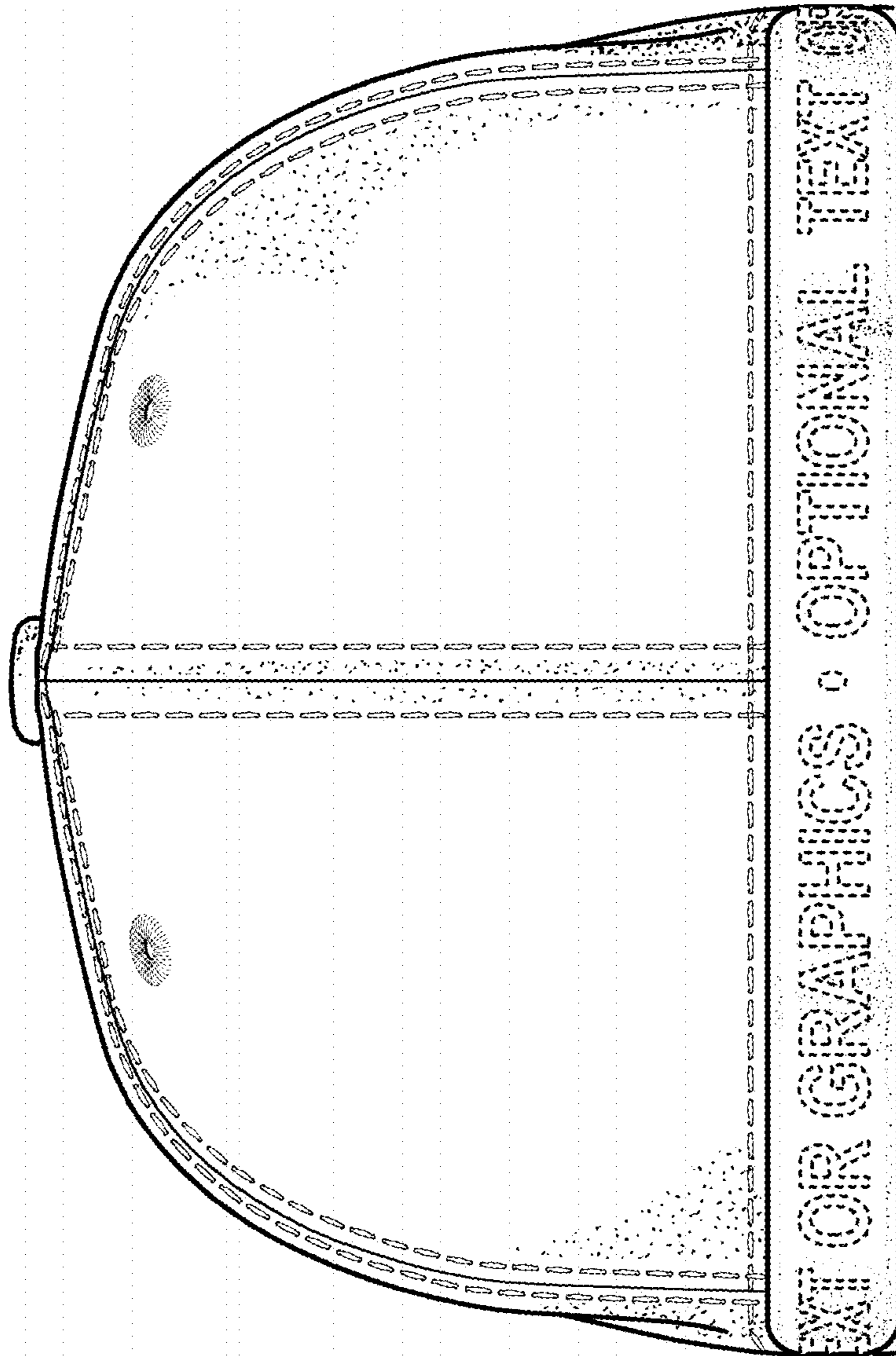

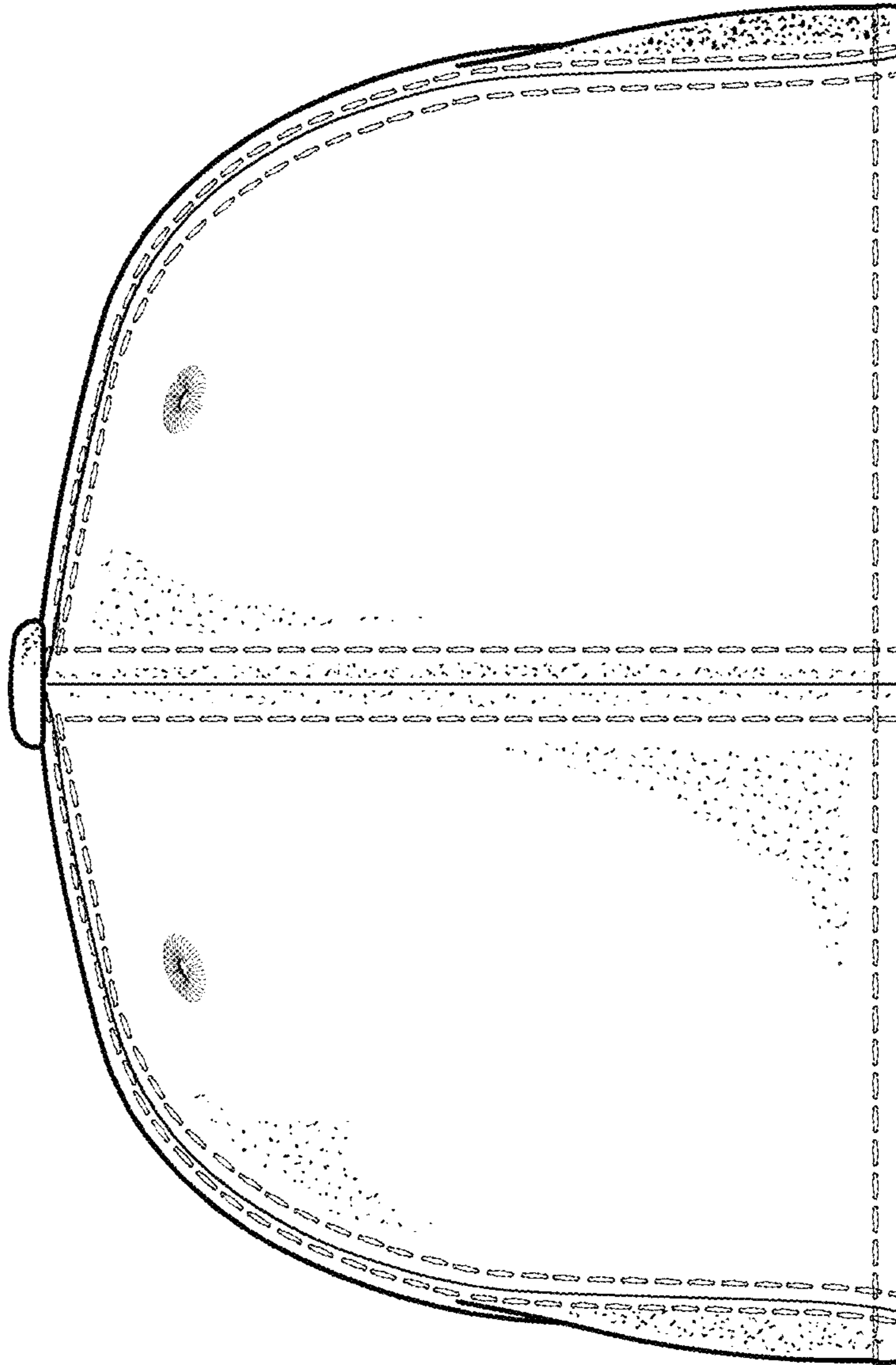

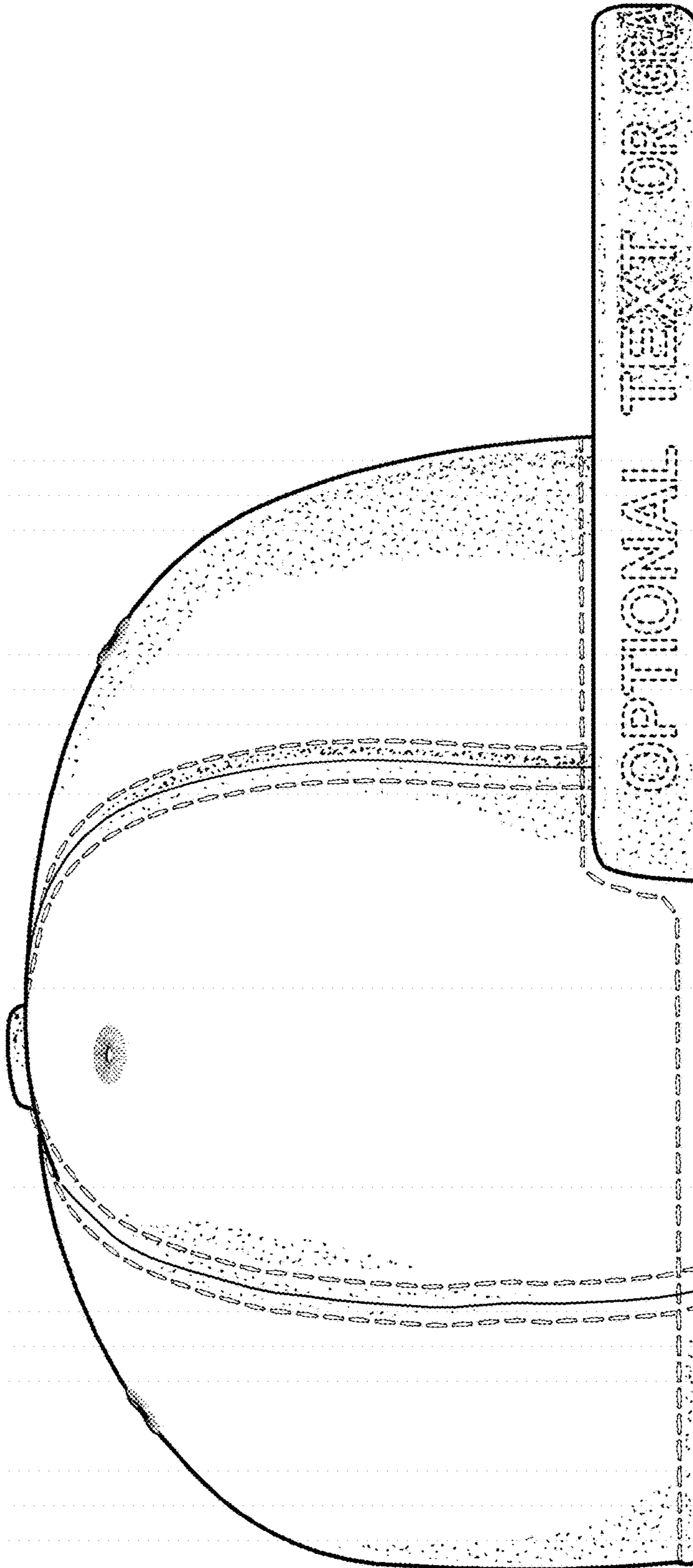

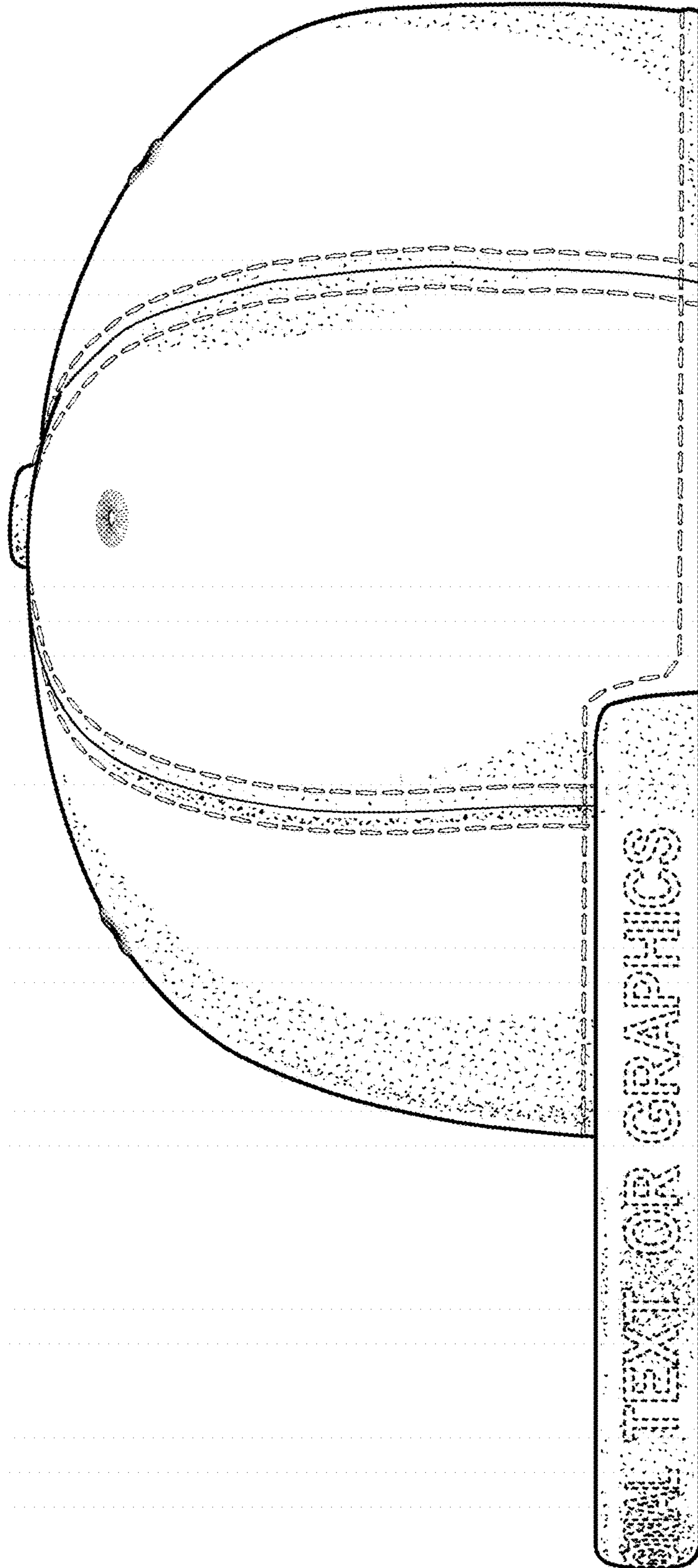

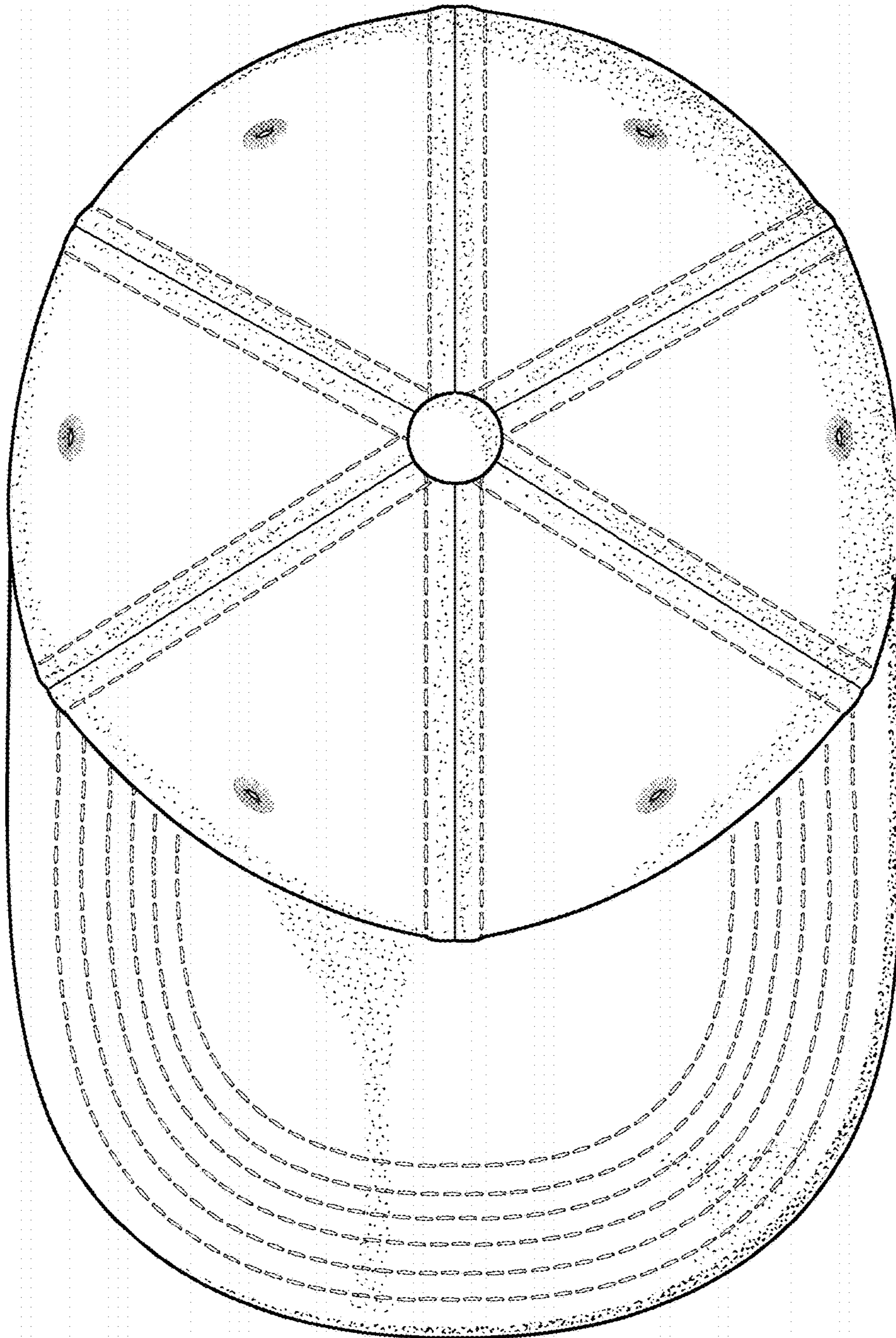

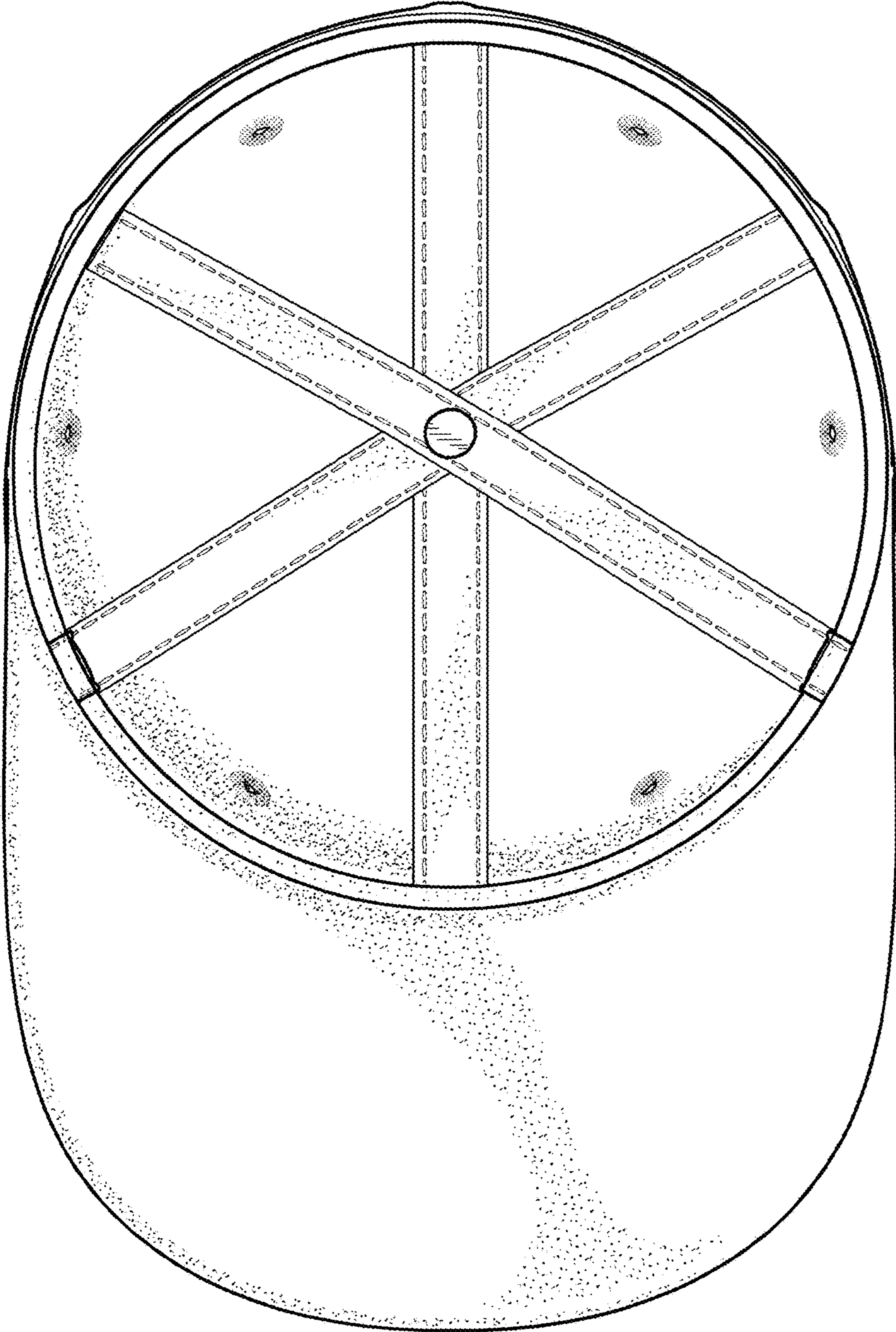

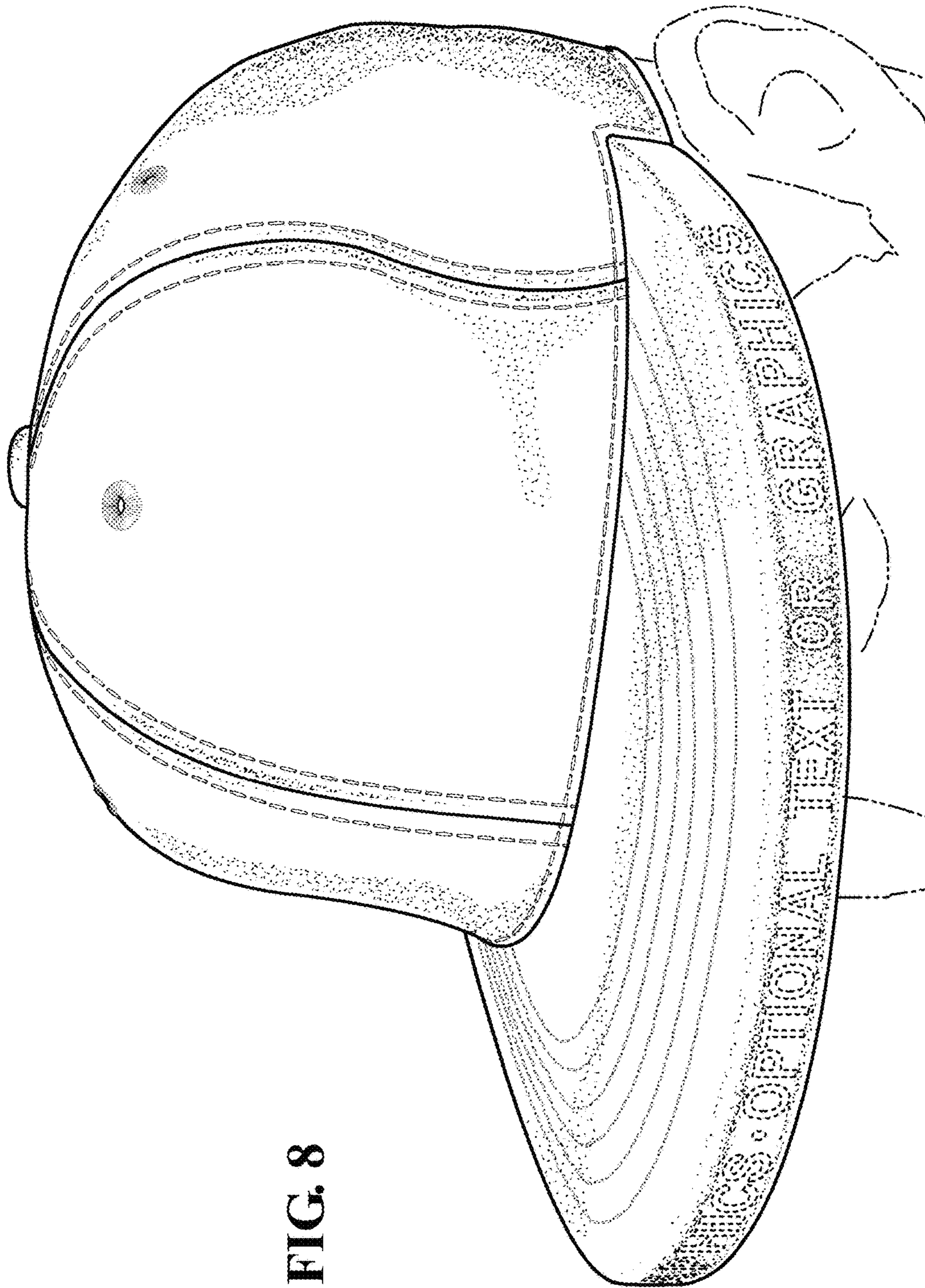
