The ornamental design for an athletic arm band, as shown and described.

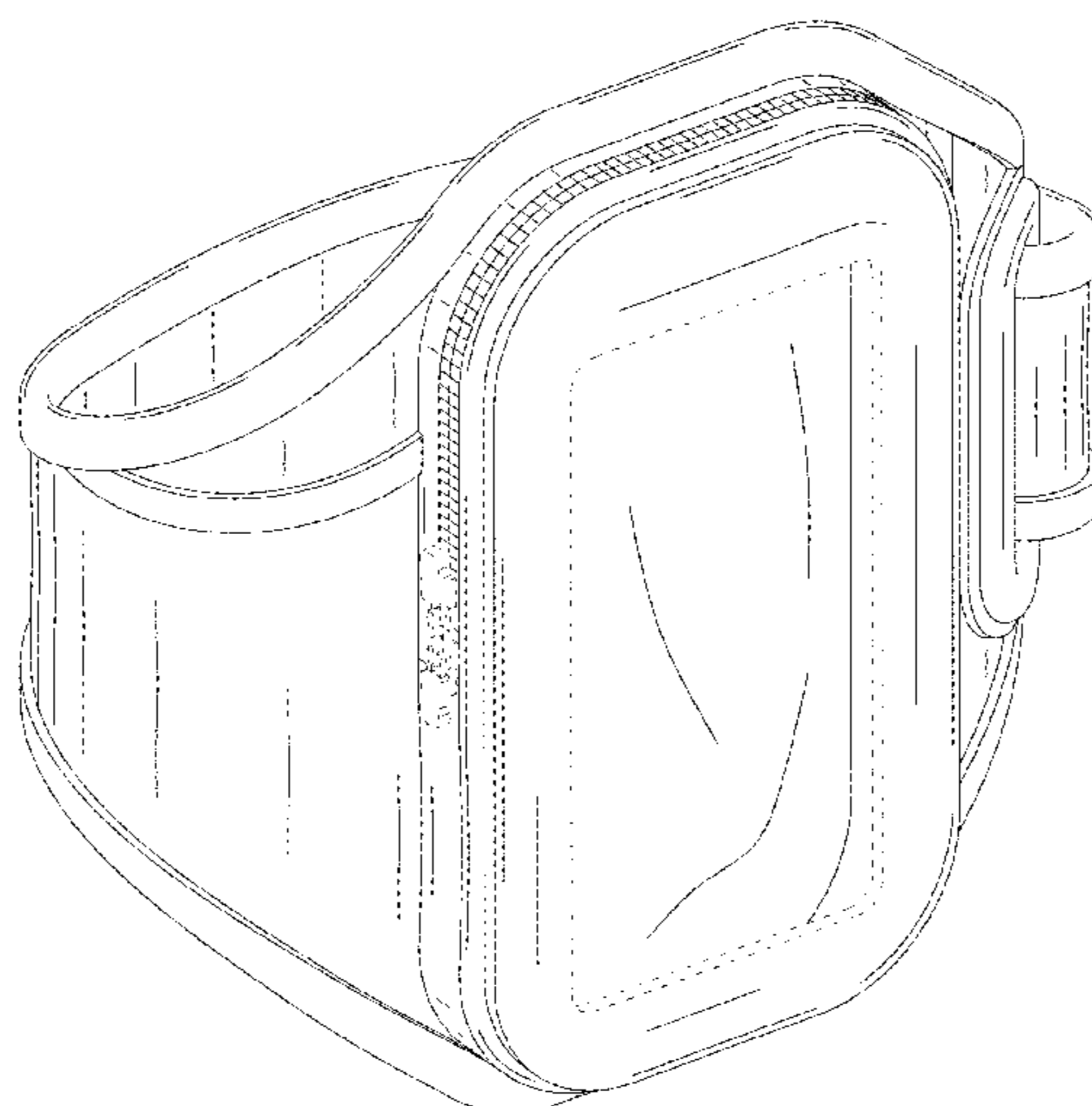
**DESCRIPTION**

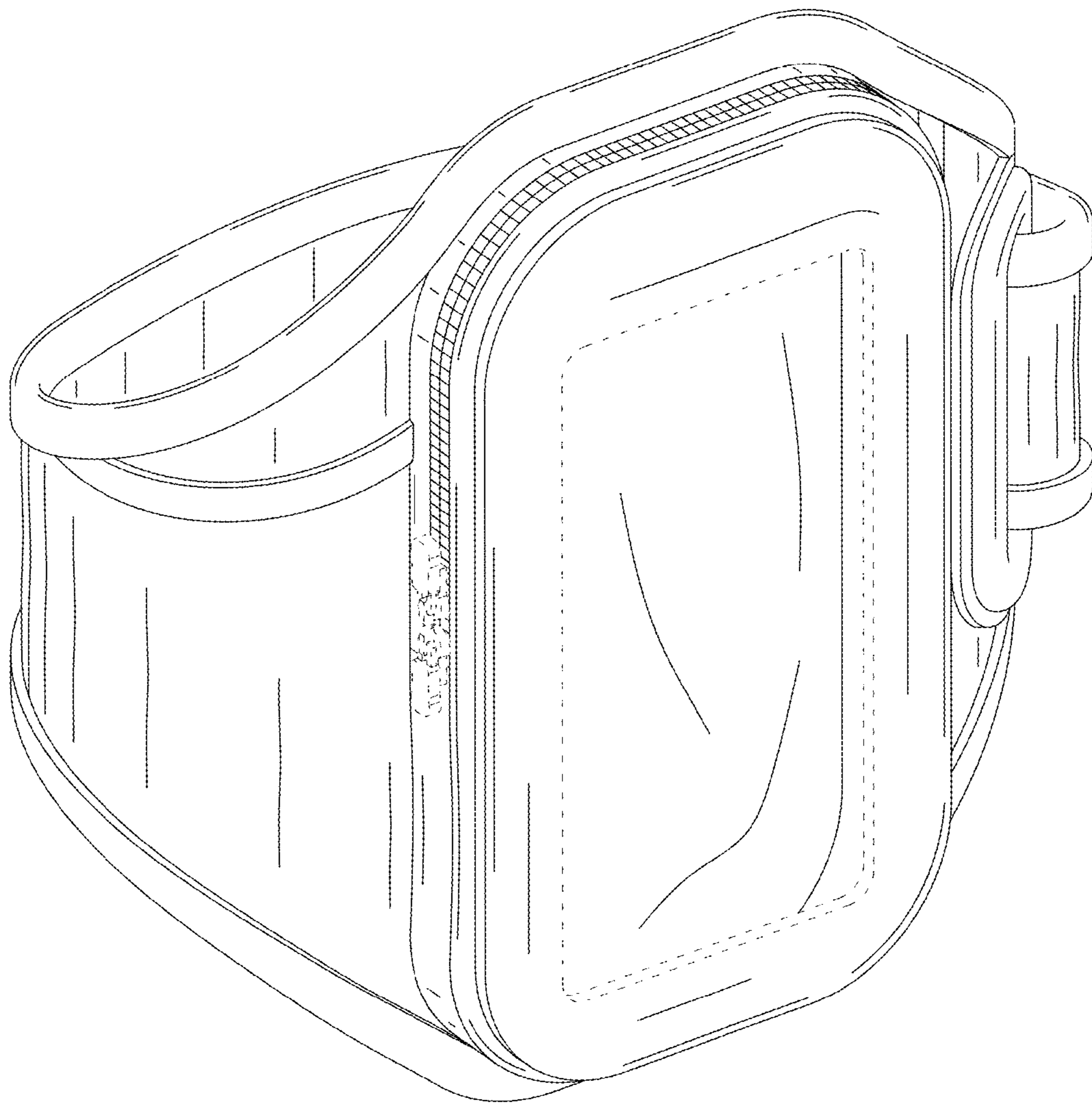

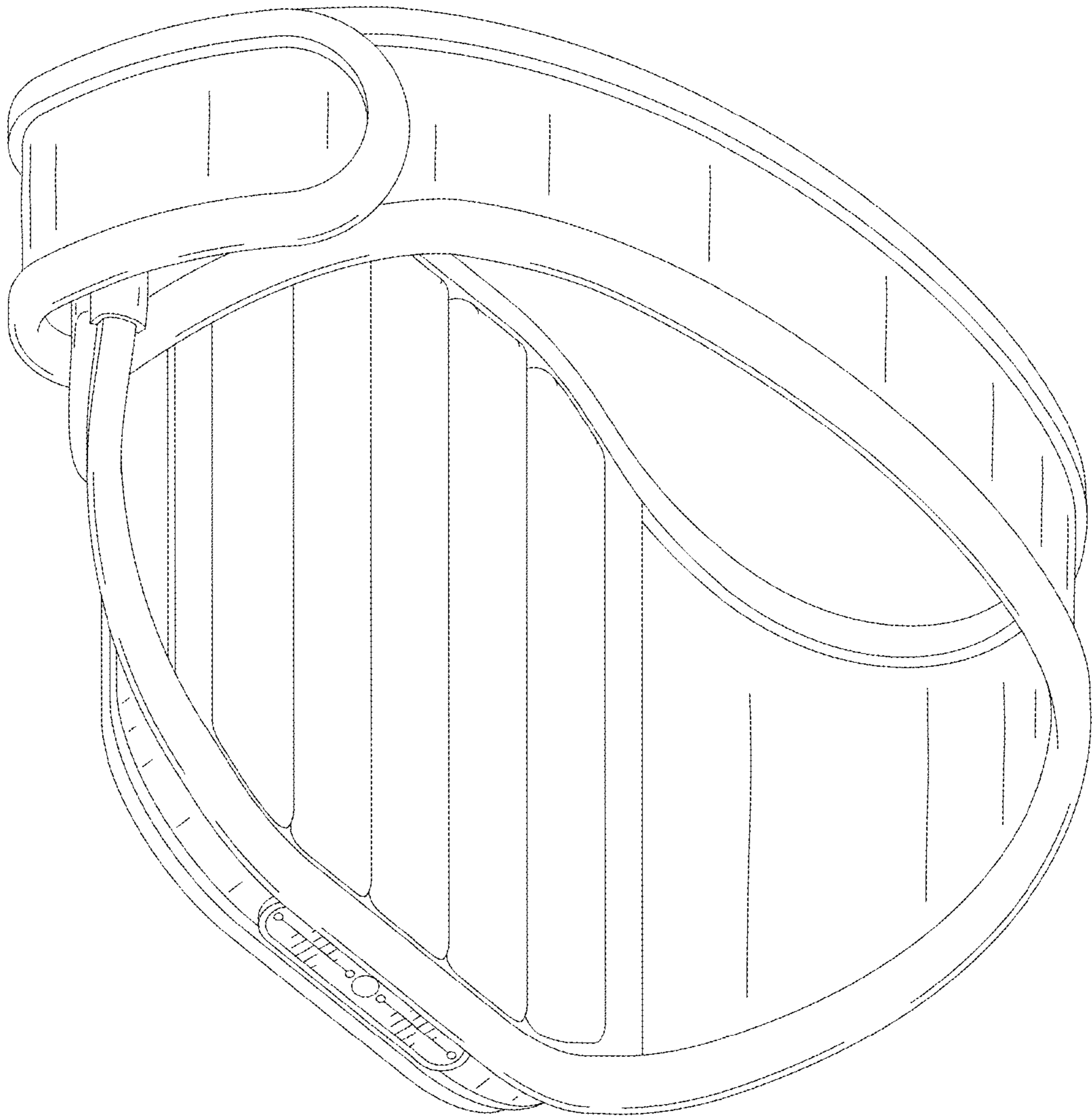

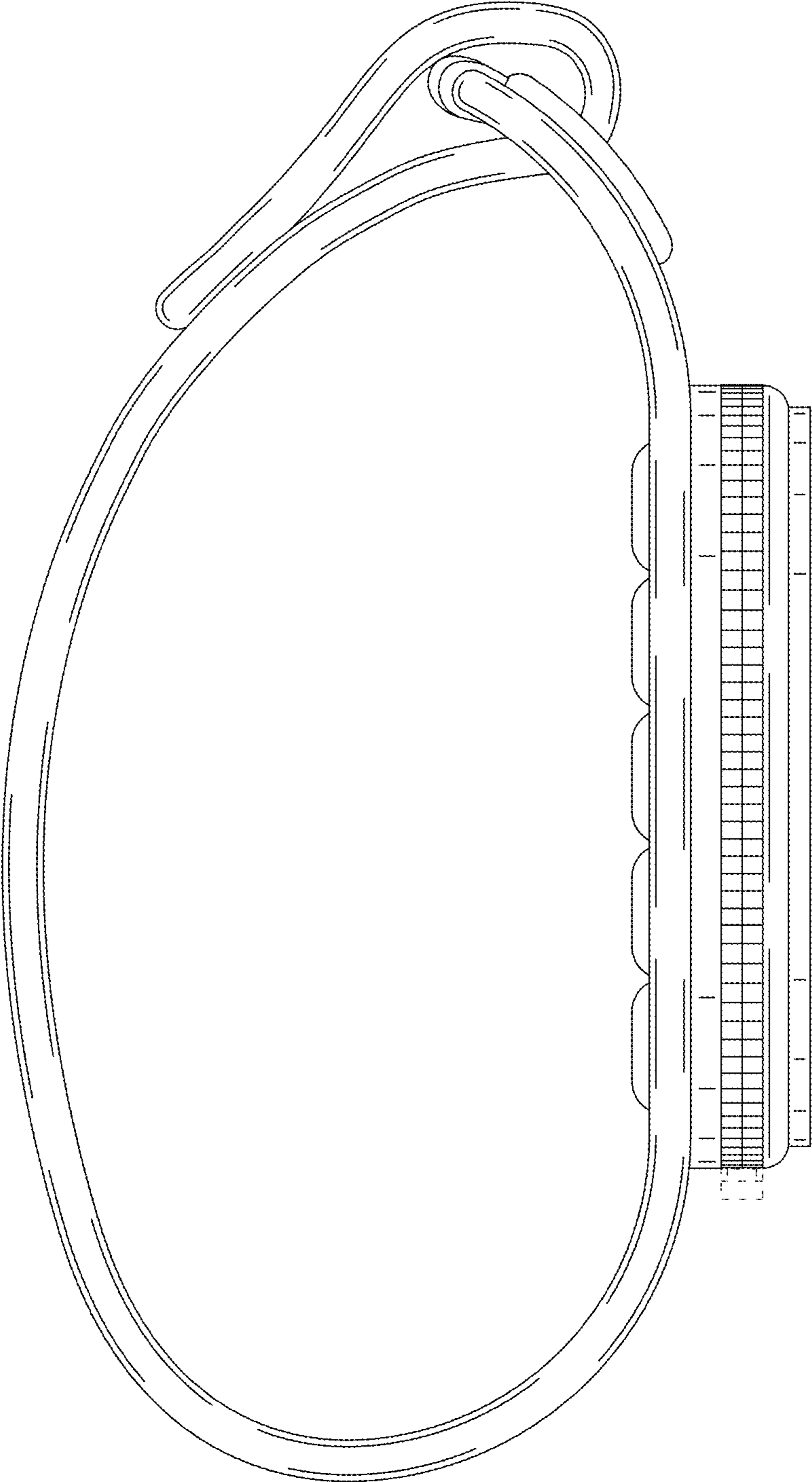

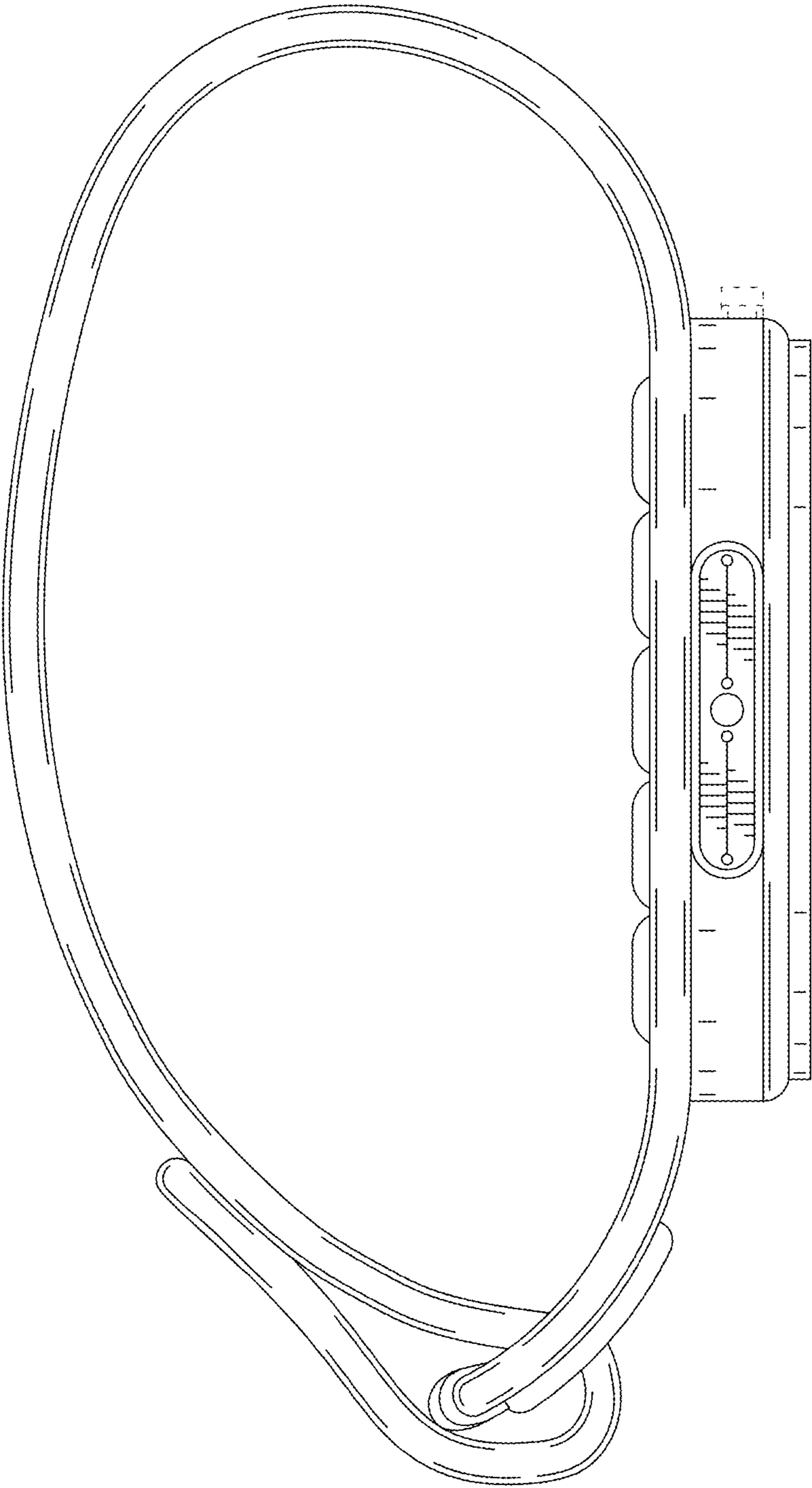

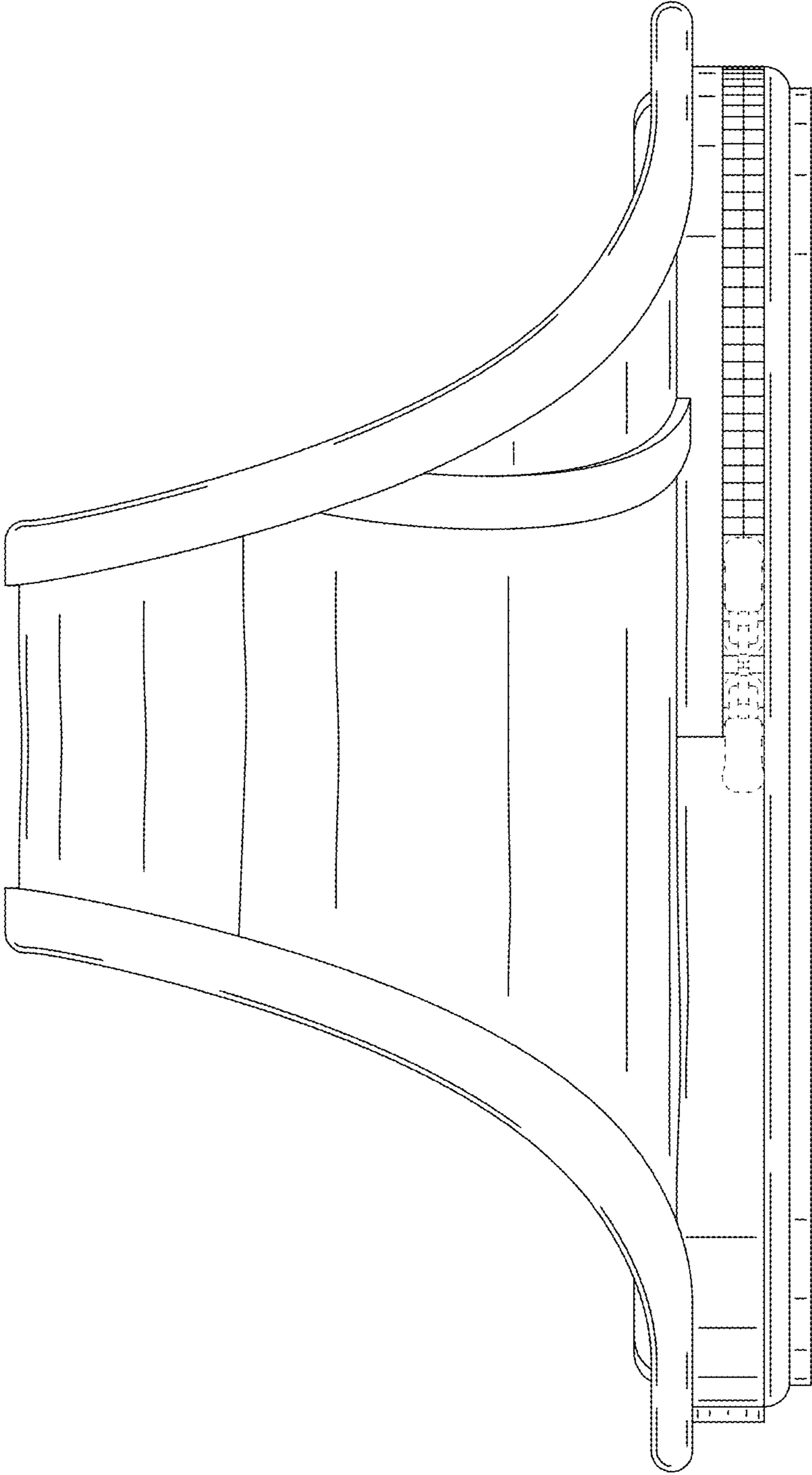

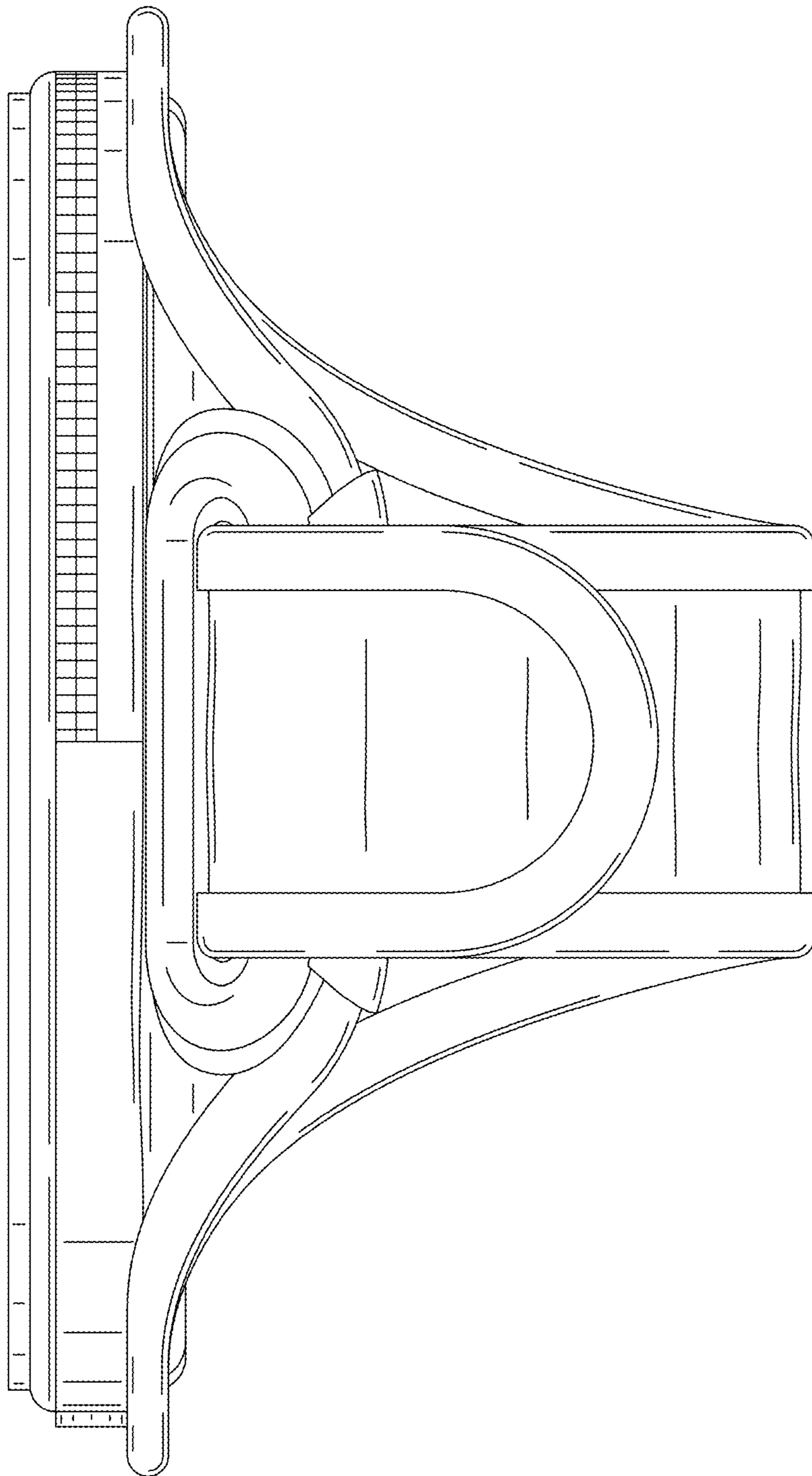

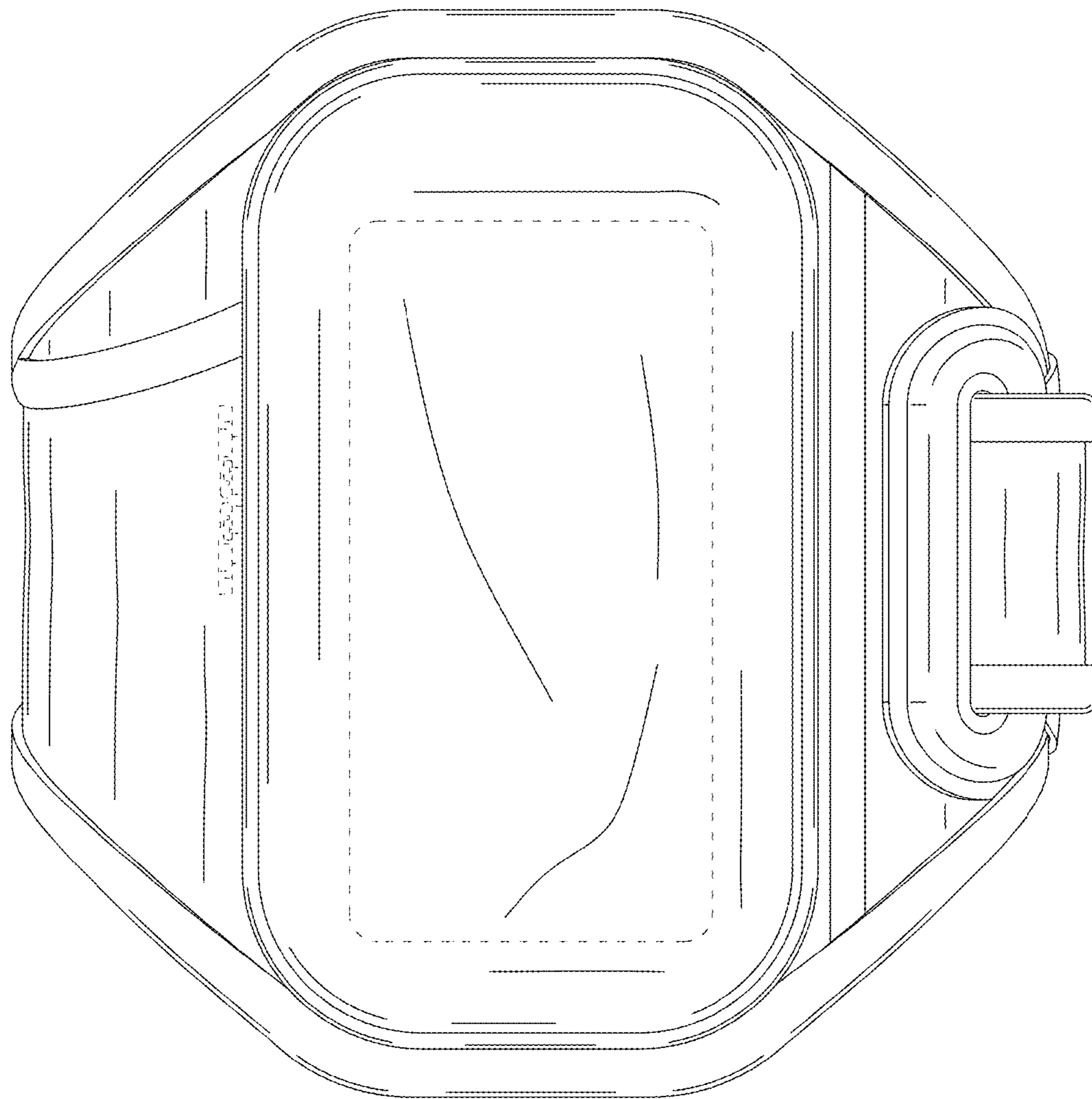

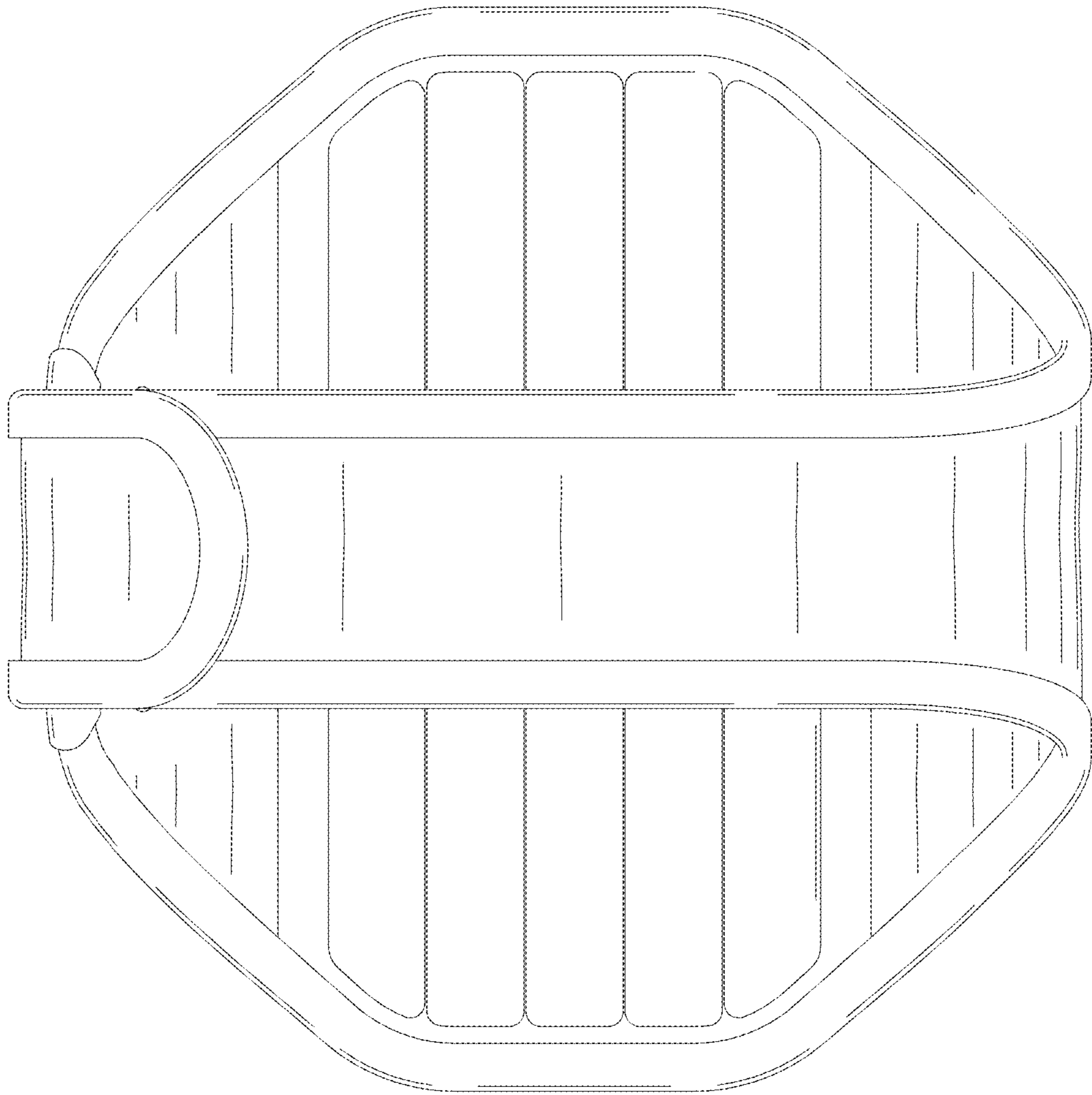

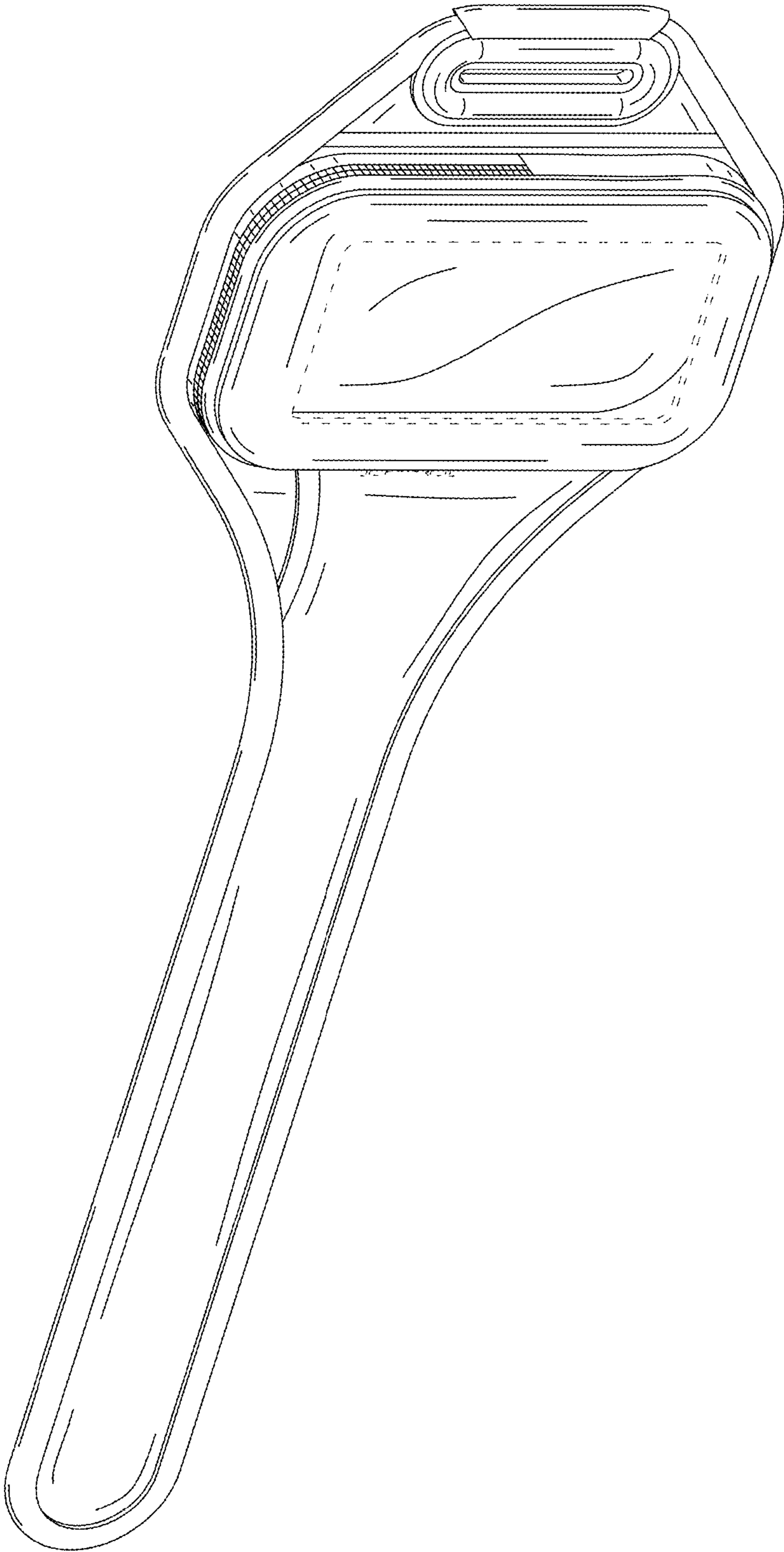

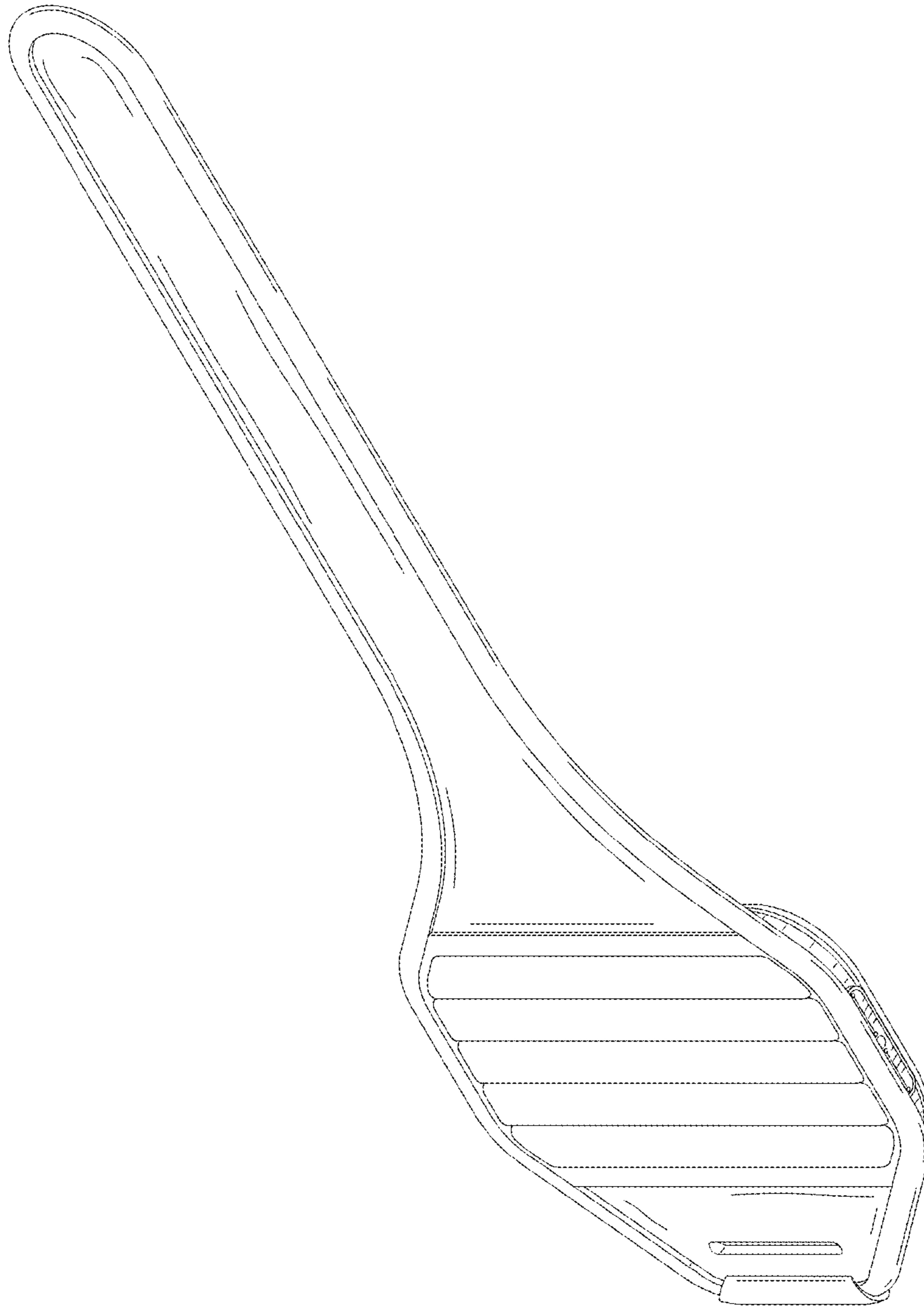
