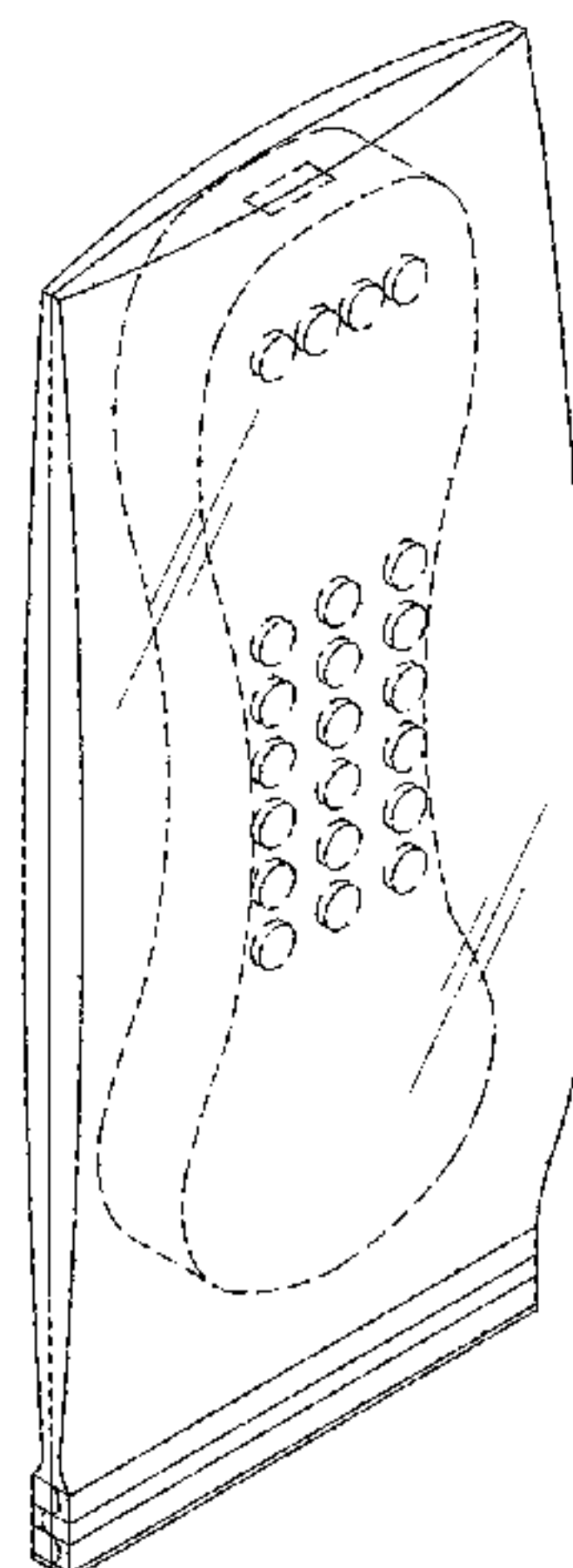
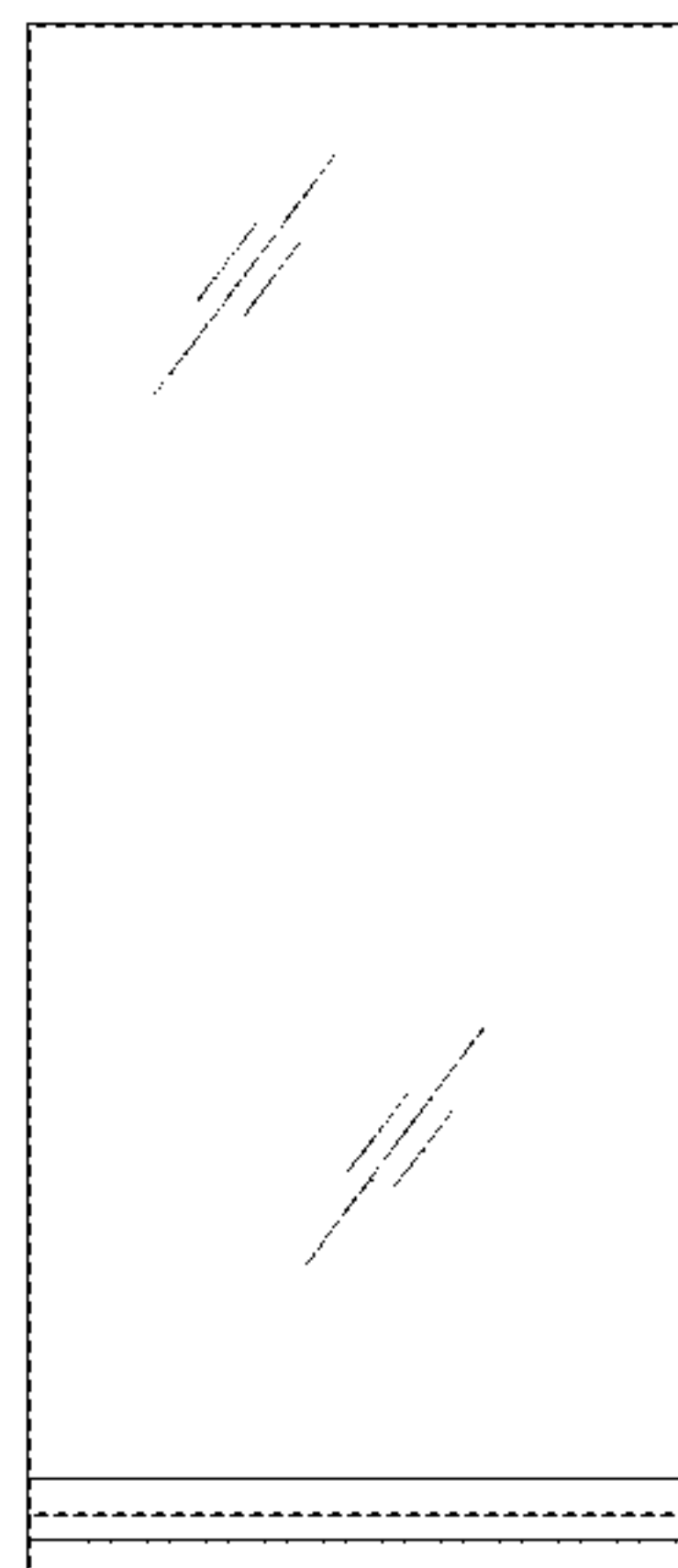
(57) **CLAIM**

The ornamental design for a sanitary transparent remote control enclosure, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a sanitary transparent remote control enclosure showing my new design, a rear view thereof being identical;
FIG. 2 is a left side view of the sanitary transparent remote control enclosure, a right side view being a mirror image thereof;
FIG. 3 is a top view of the sanitary transparent remote control enclosure;
FIG. 4 is a bottom view of the sanitary transparent remote control enclosure; and,
FIG. 5 is a top front side perspective view of the sanitary transparent remote control enclosure in use.

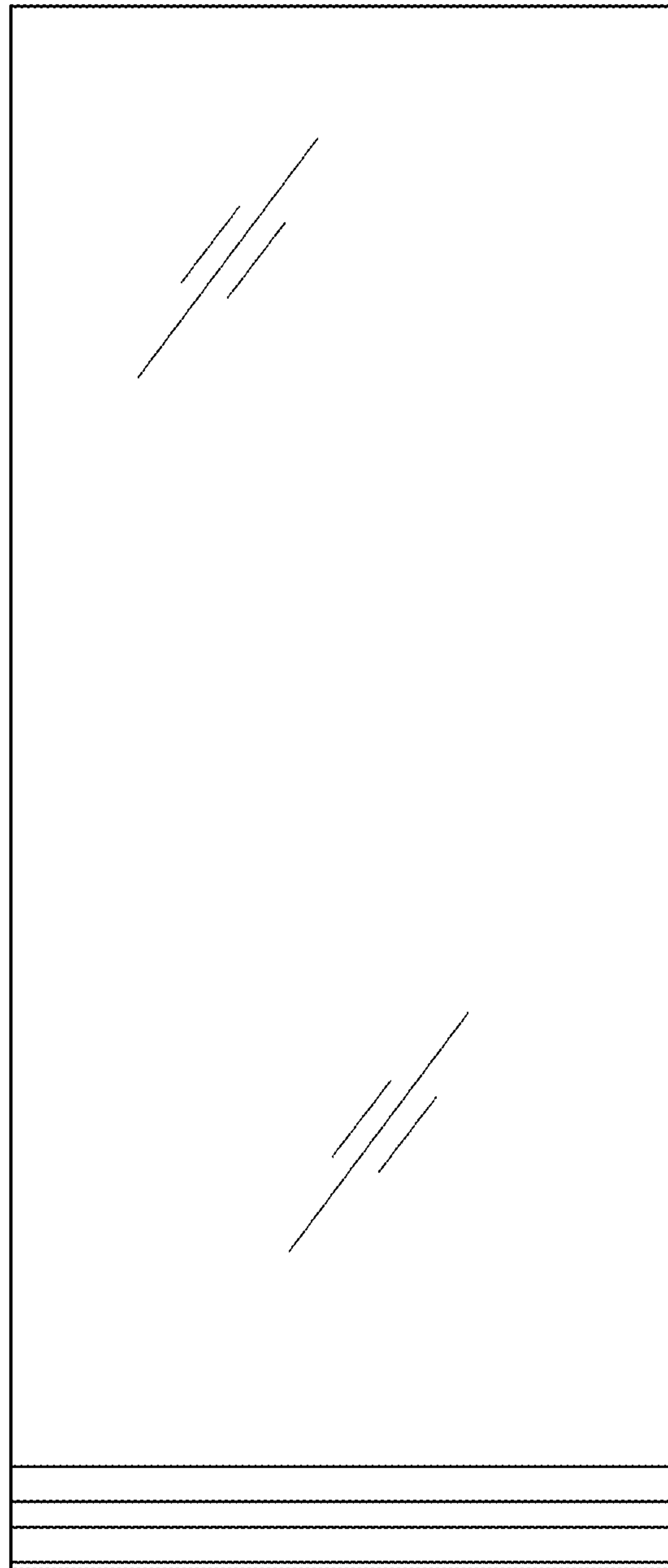

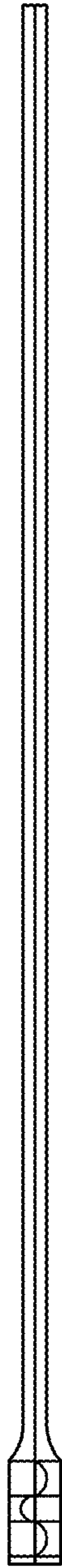

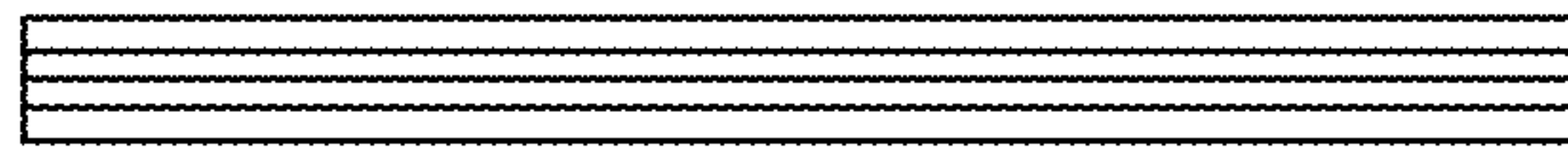

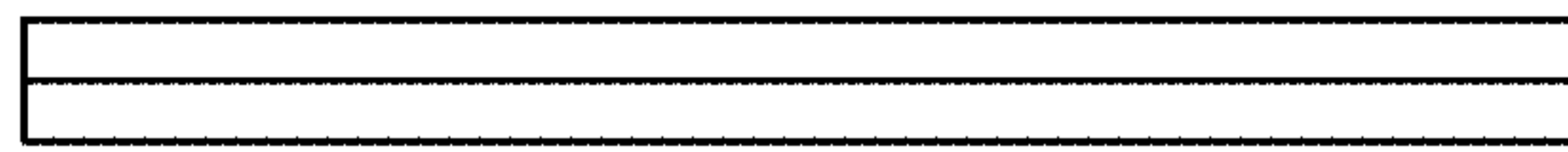

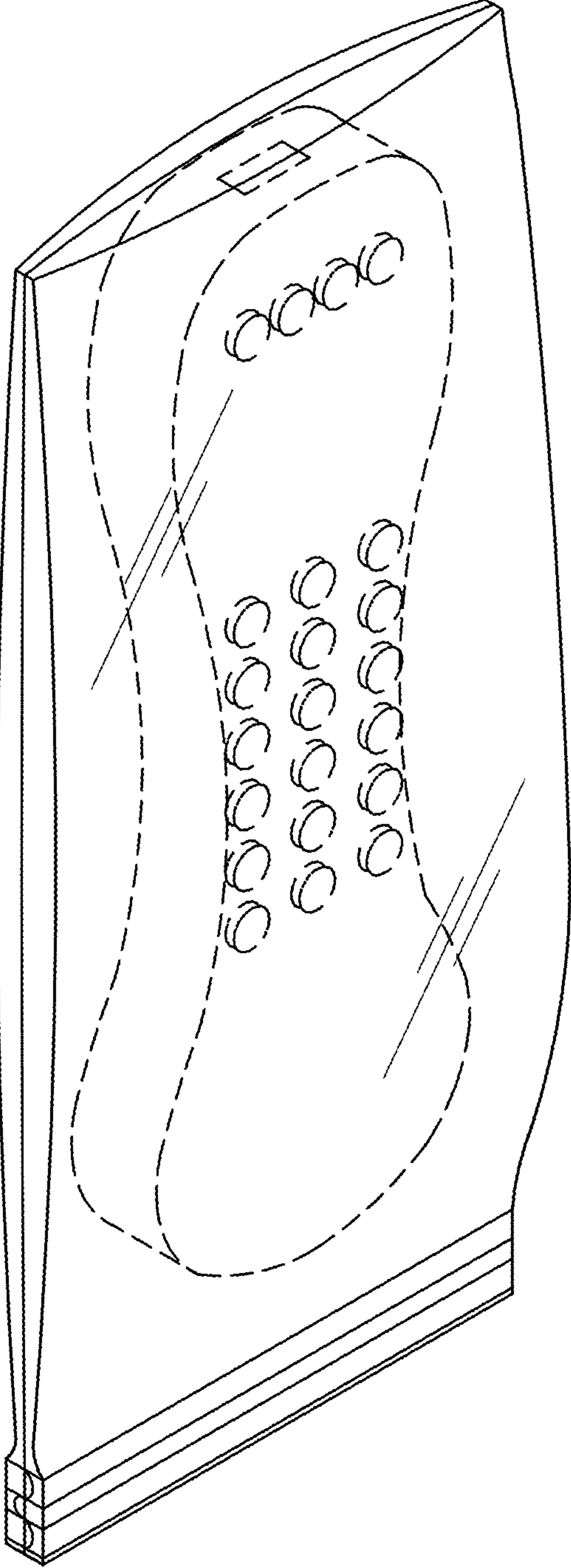
