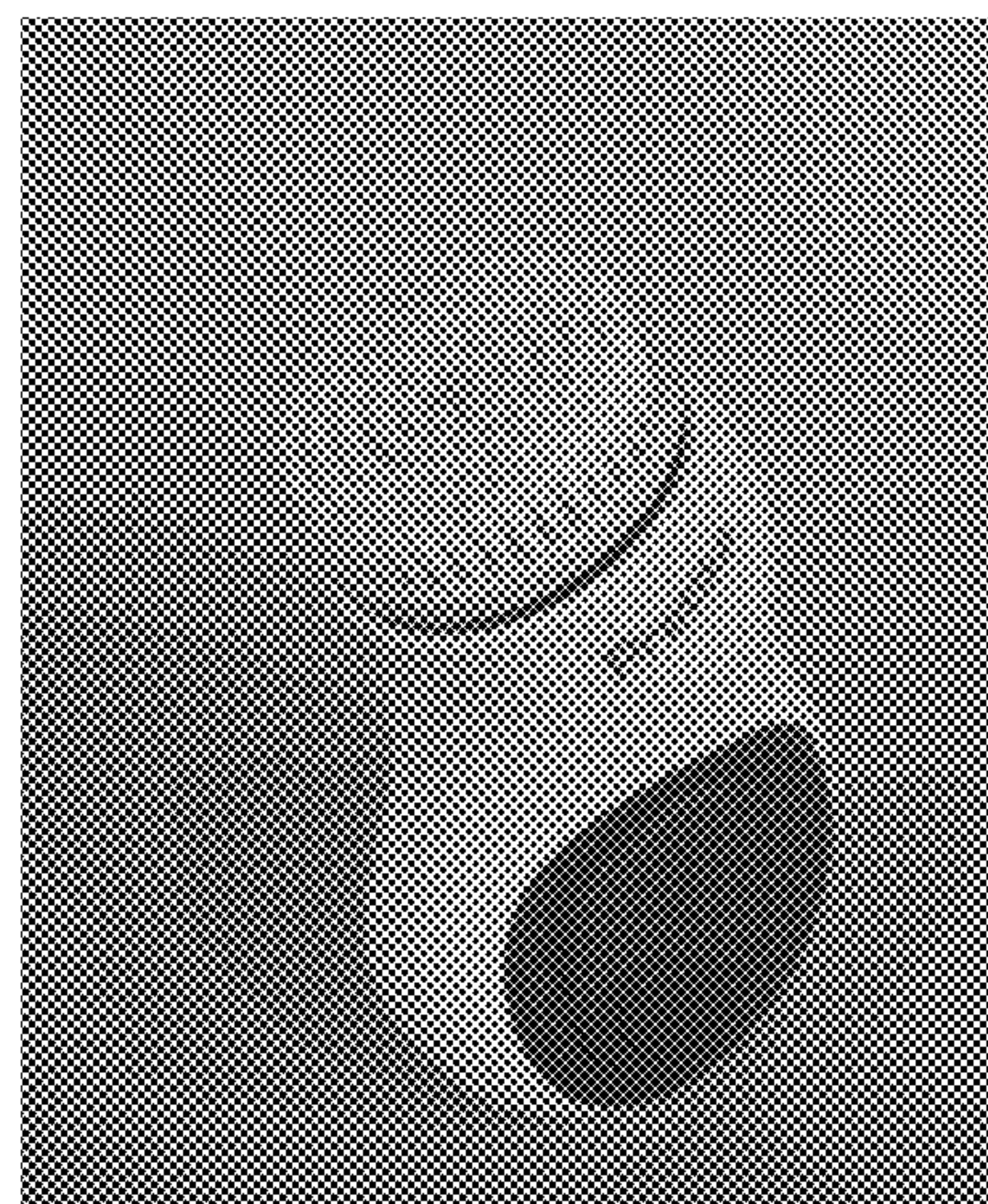
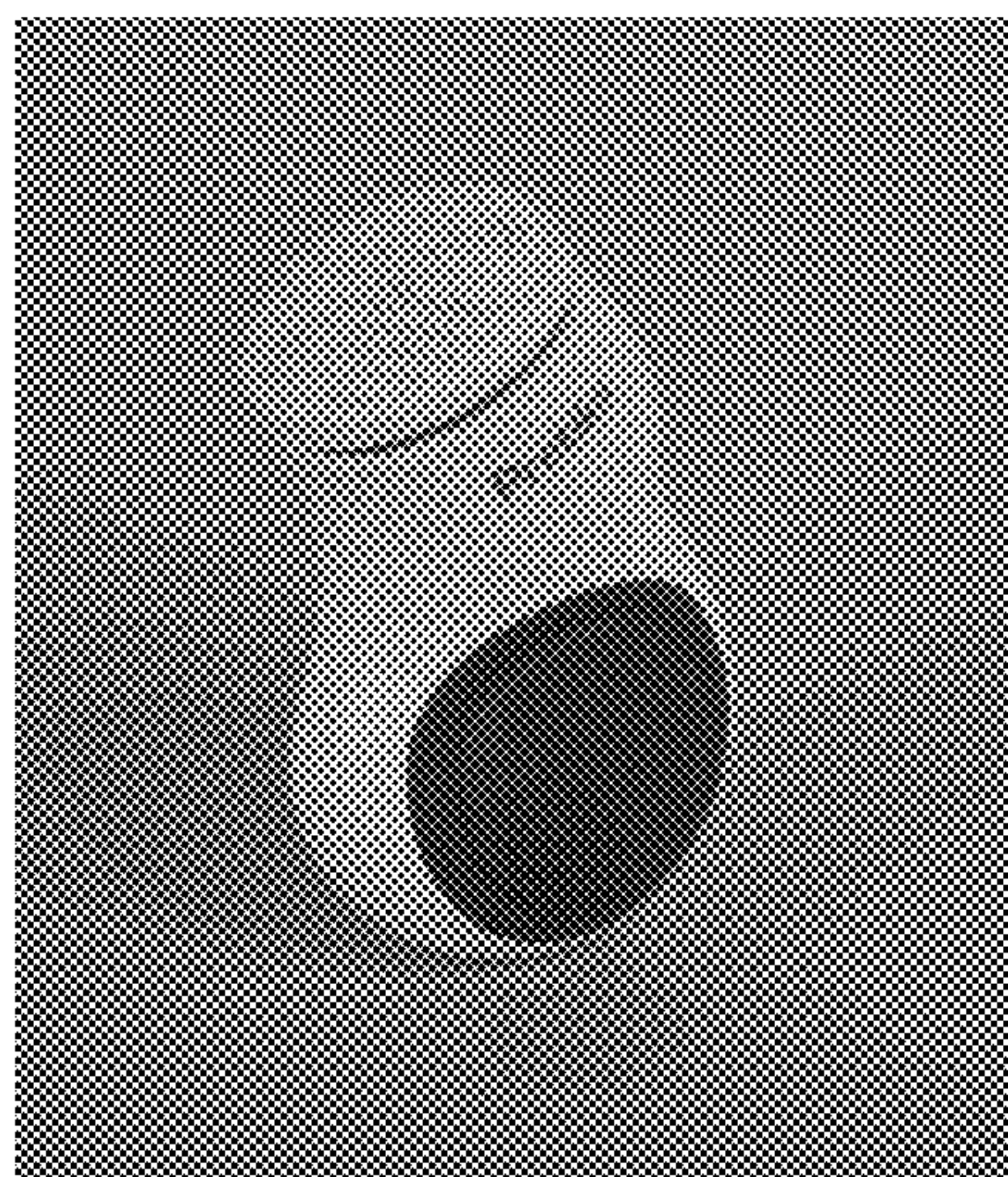
(57) **CLAIM**

What is claimed is the ornamental design for a handheld motorized device for makeup removal, as shown and described.

FIG. 1 is a left perspective view of the handheld motorized device for makeup removal;
 FIG. 2 is a right perspective view thereof;
 FIG. 3 is a left rear perspective view thereof;
 FIG. 4 is a right rear perspective view thereof;
 FIG. 5 is a left side view thereof;
 FIG. 6 is a right side view thereof;
 FIG. 7 is a front view thereof;
 FIG. 8 is a back view thereof;
 FIG. 9 is a top view thereof;
 FIG. 10 is a bottom view thereof;
 FIG. 11 is an exploded left perspective view of the housing and treatment head;
 FIG. 12 is an exploded left perspective view of the housing and bottom perspective view of the treatment head;
 FIG. 13 is an exploded left perspective view of the housing and bottom perspective view of the treatment head and treatment cover therefor;
 FIG. 14 is an exploded left perspective view of the housing and top perspective view of the treatment head and treatment cover therefor;
 FIG. 15 is a left perspective view of a second embodiment of the handheld motorized device for makeup removal, with the brush head attached;
 FIG. 16 is an exploded left perspective view of the housing of the device embodiment of FIG. 15, and top perspective view of the detached brush head thereof; and,
 FIG. 17 is an exploded left perspective view of the housing of the device embodiment of FIG. 15, and bottom perspective view of the detached brush head thereof.

The main body appearance of the right side, rear and bottom of the FIG. 15 second embodiment of the handheld motorized device for makeup removal is the same as that of the first embodiment of the handheld motorized device for makeup removal, visible in FIGS. 2,4,6,7,8 and 10.

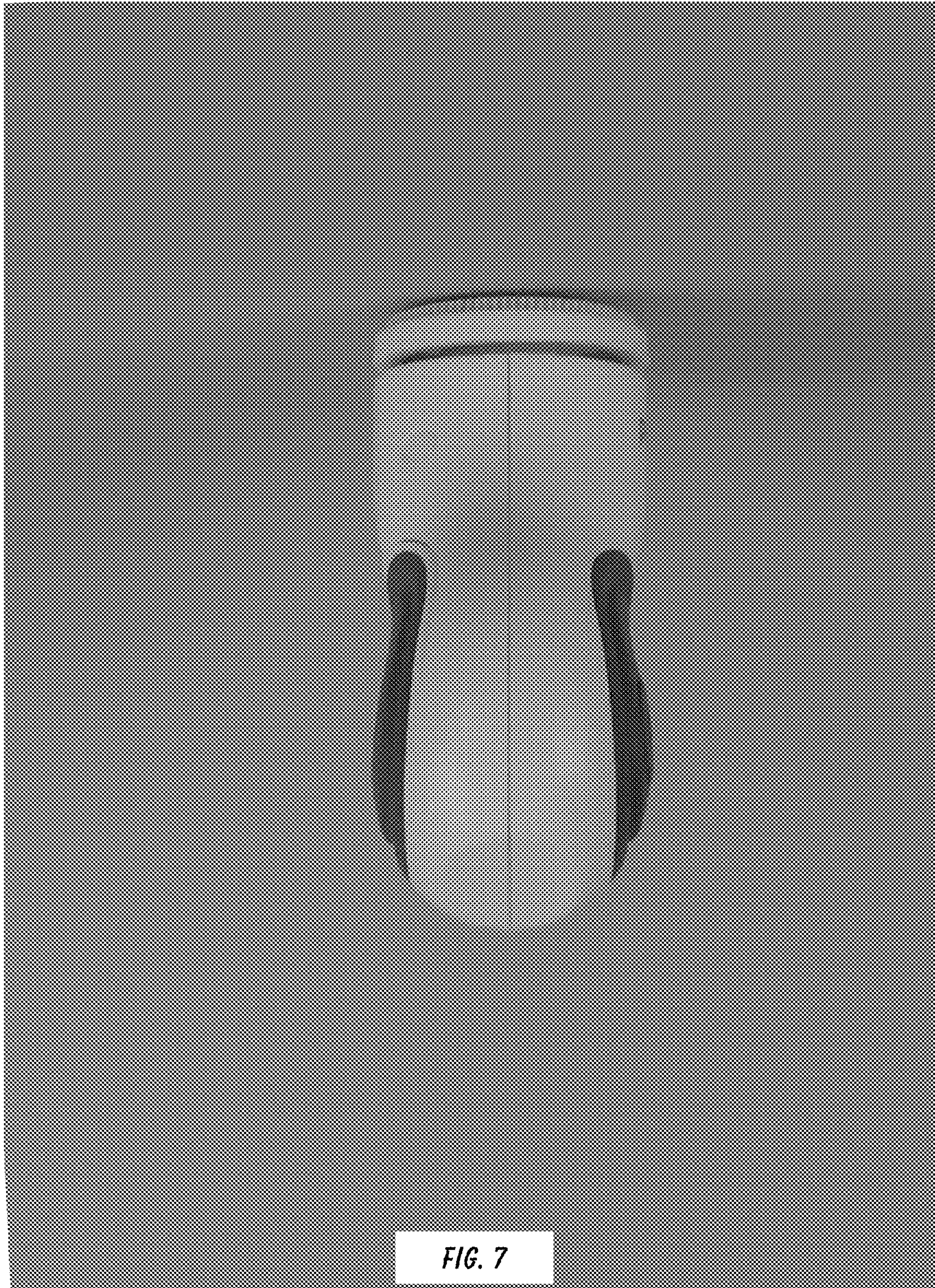

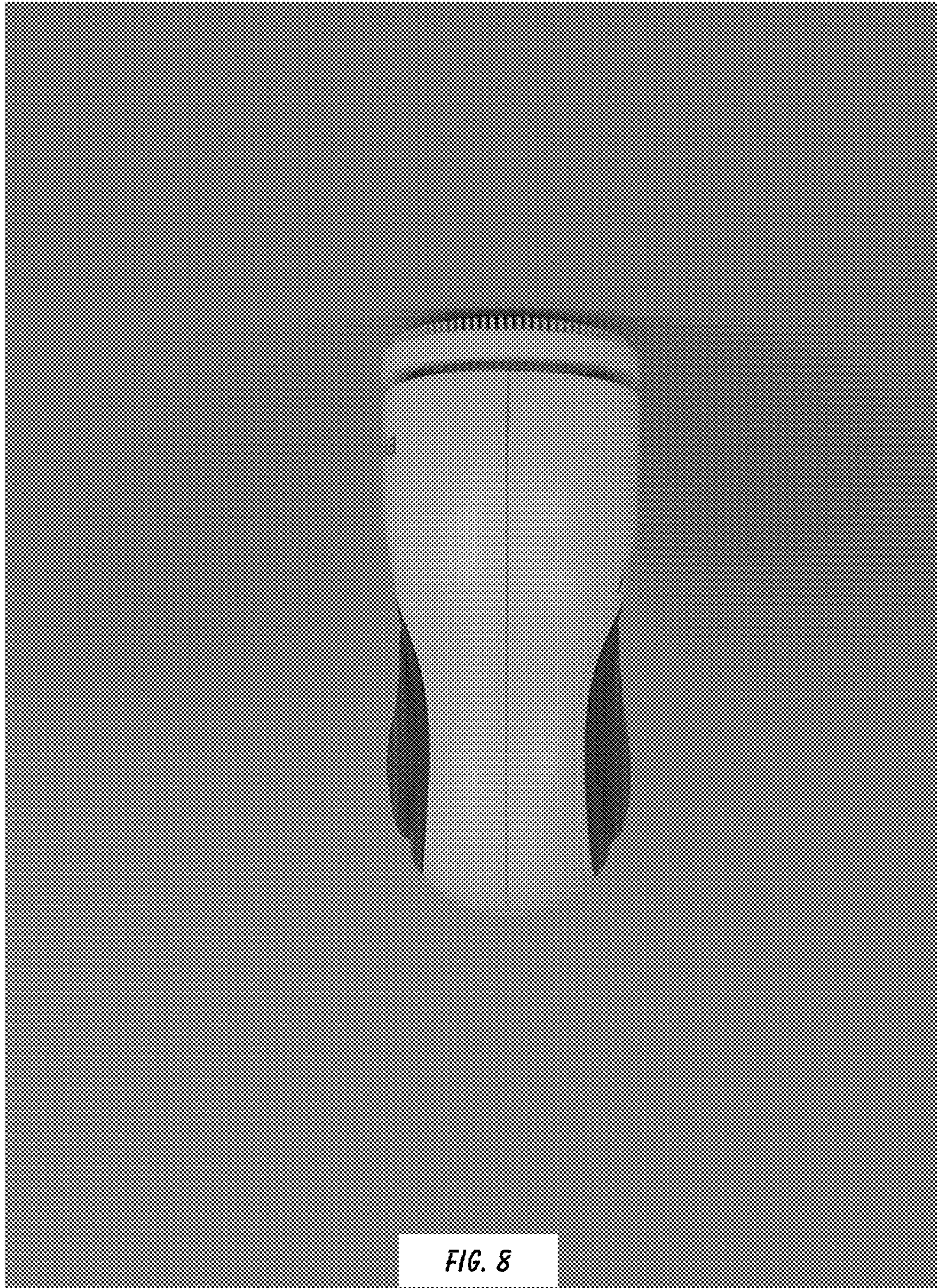
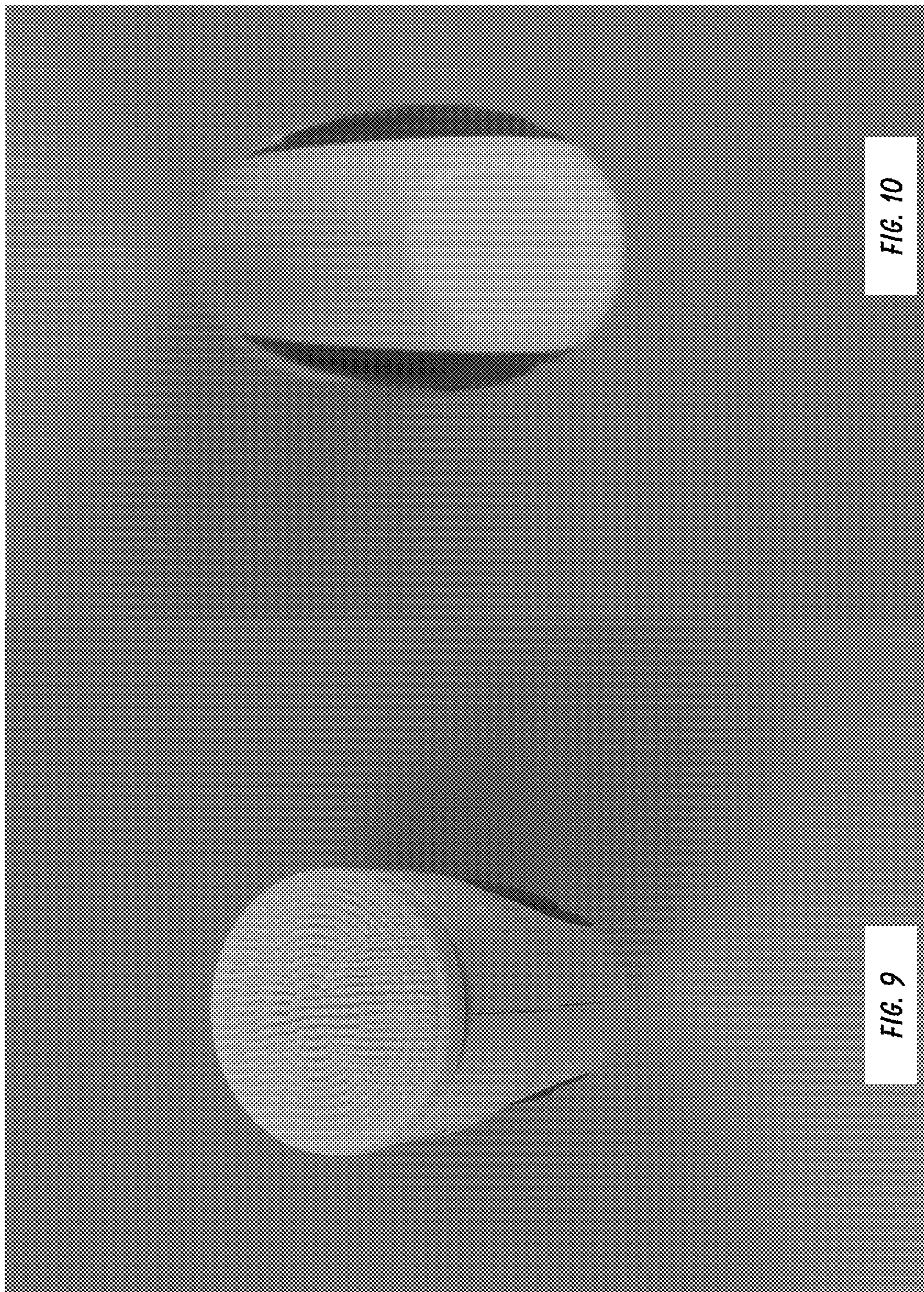

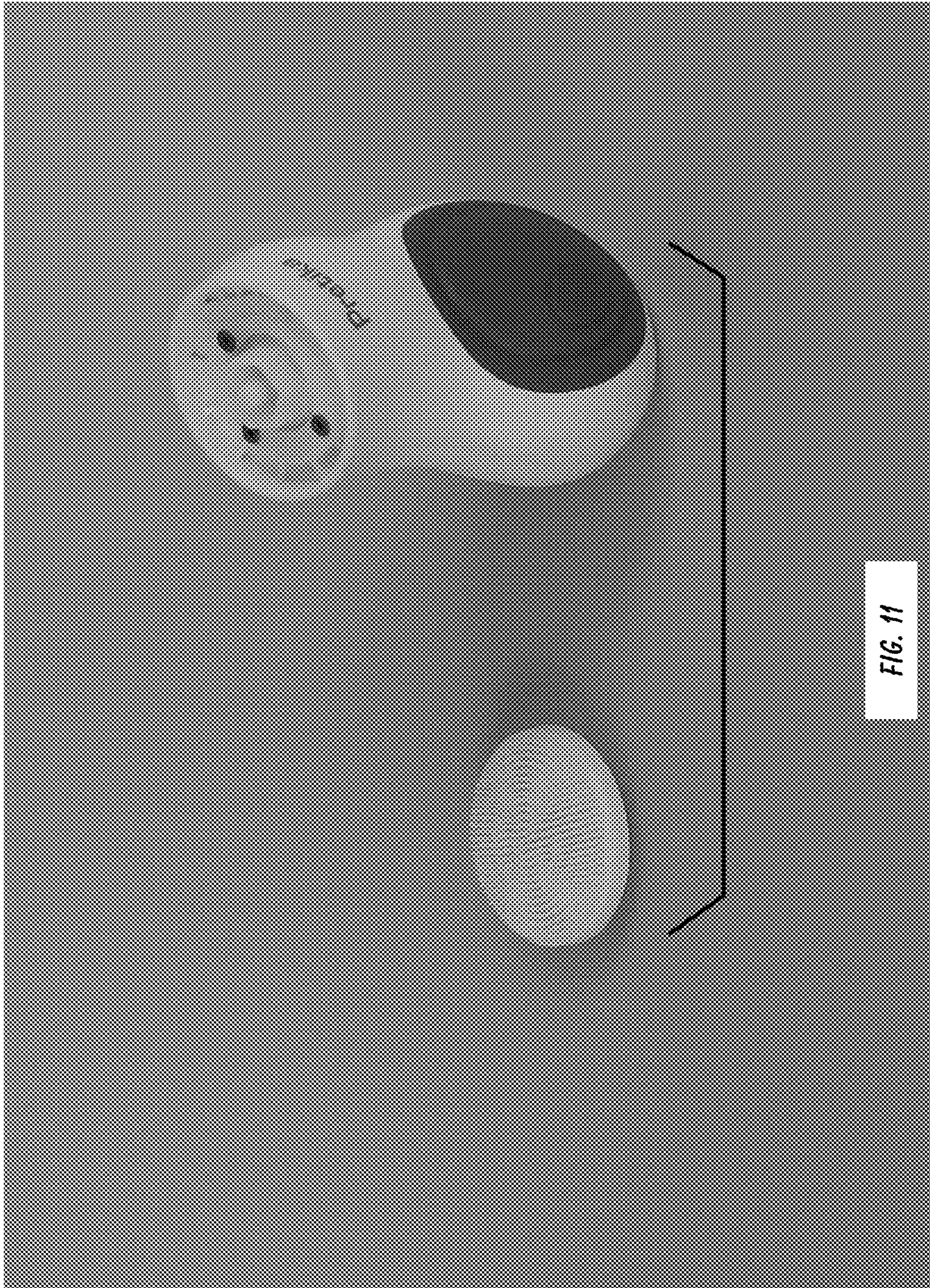
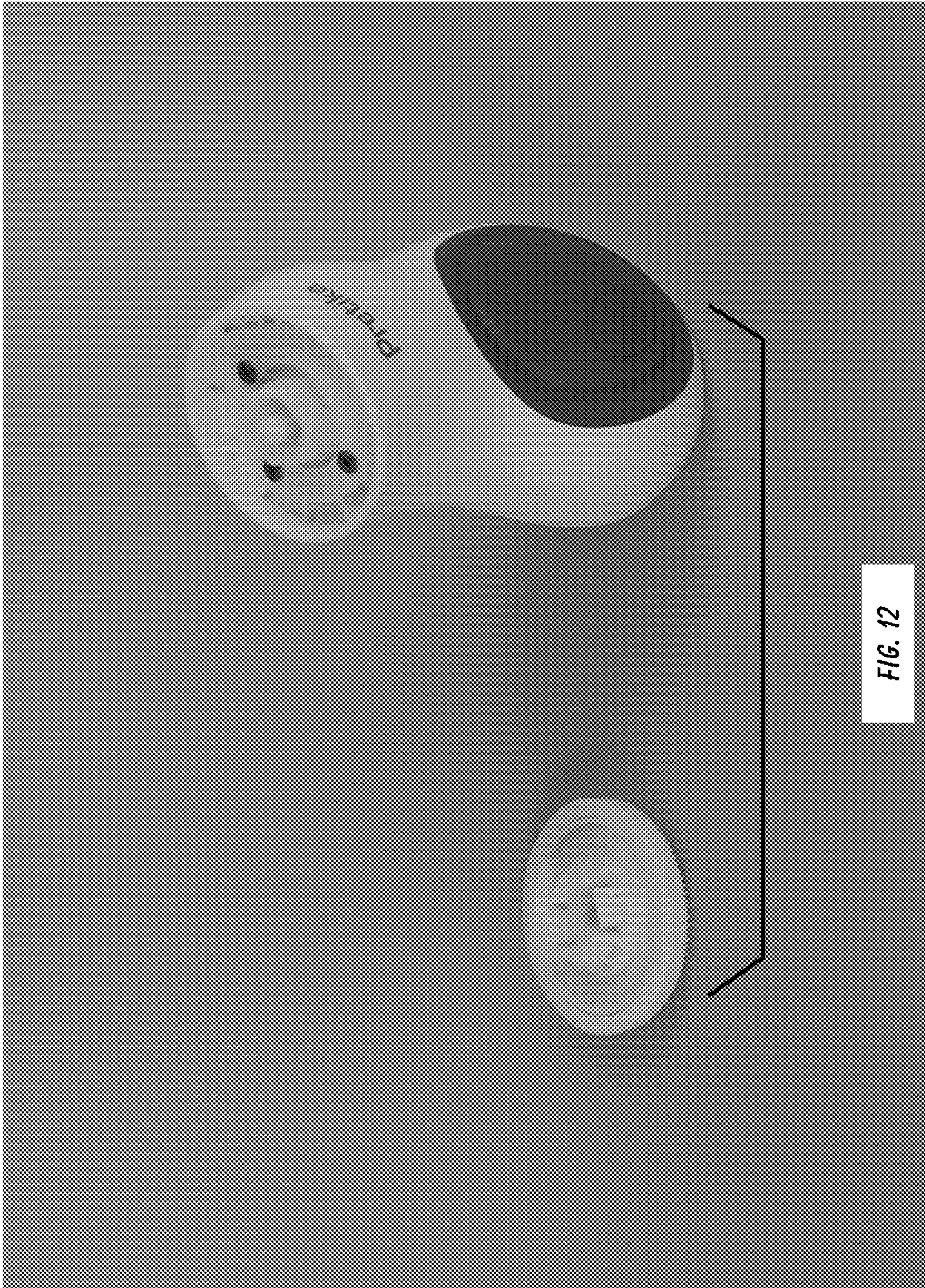

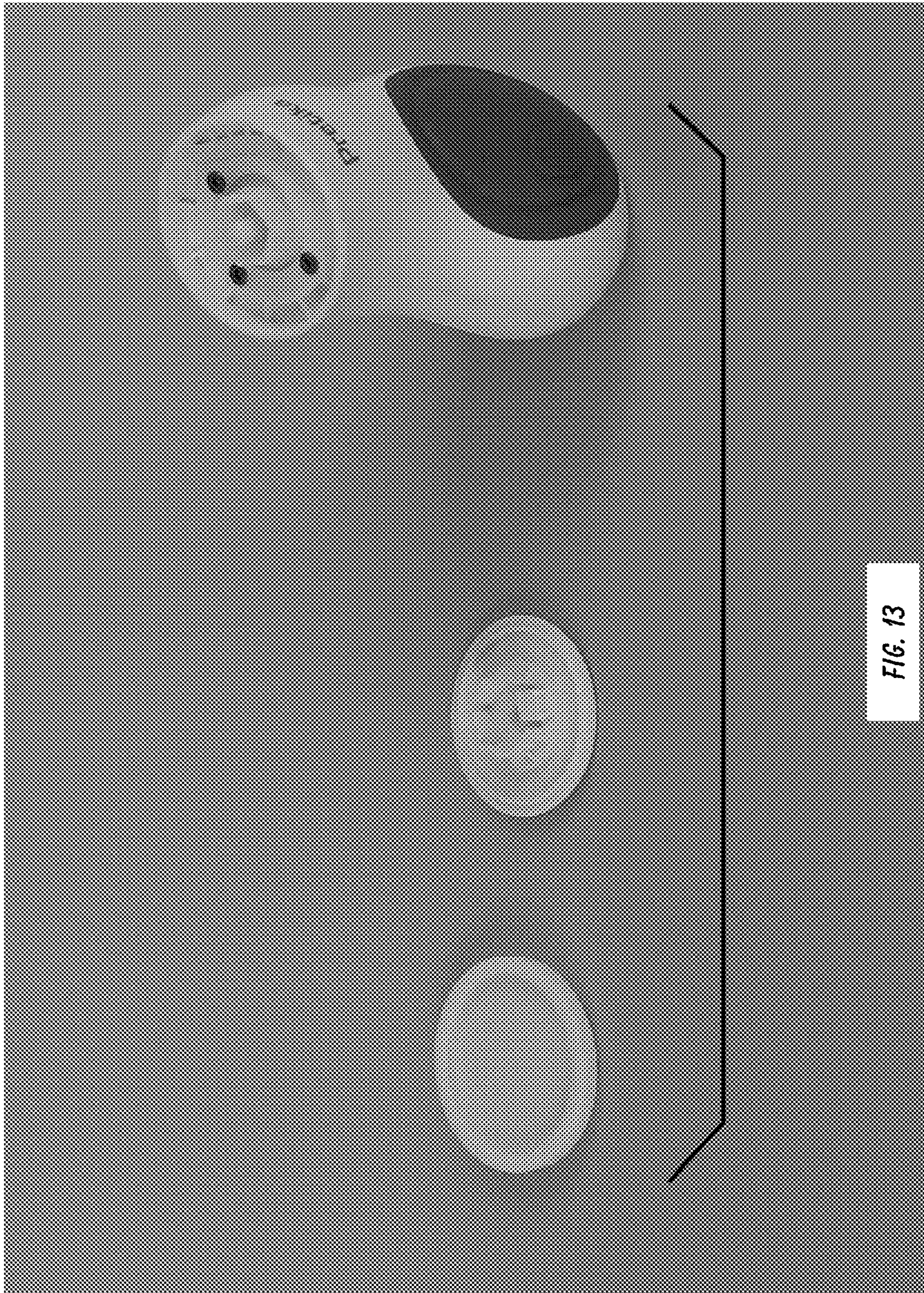
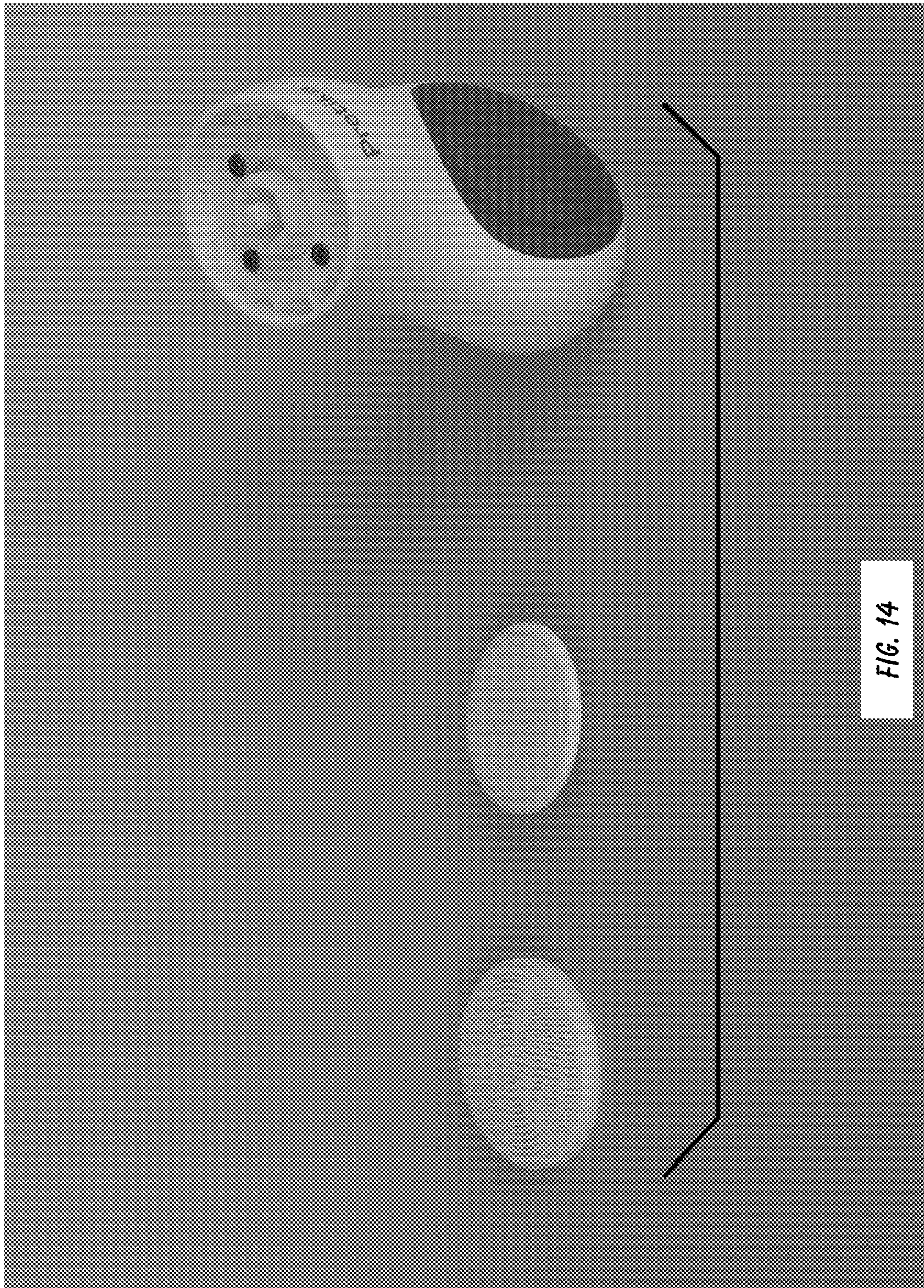

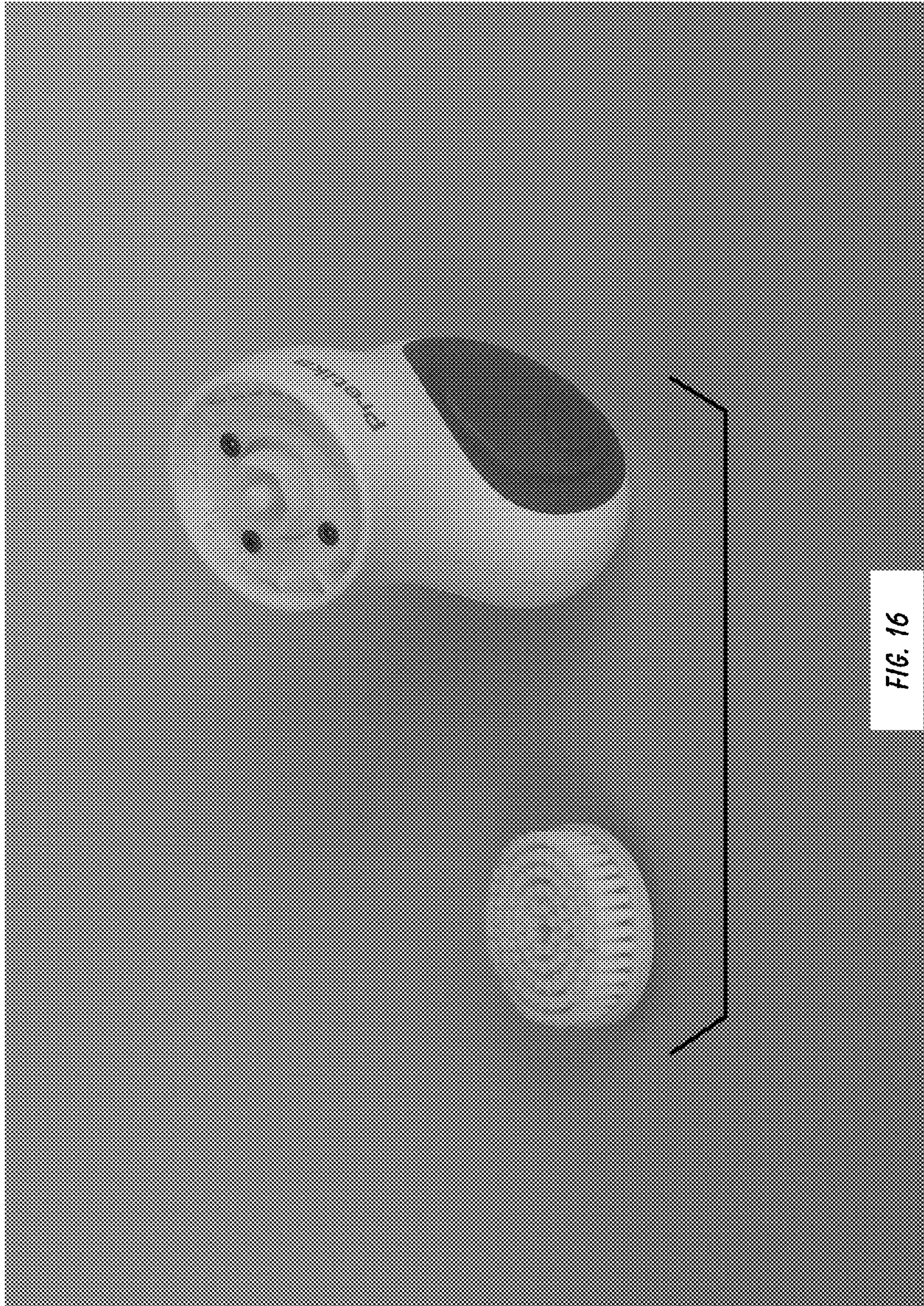

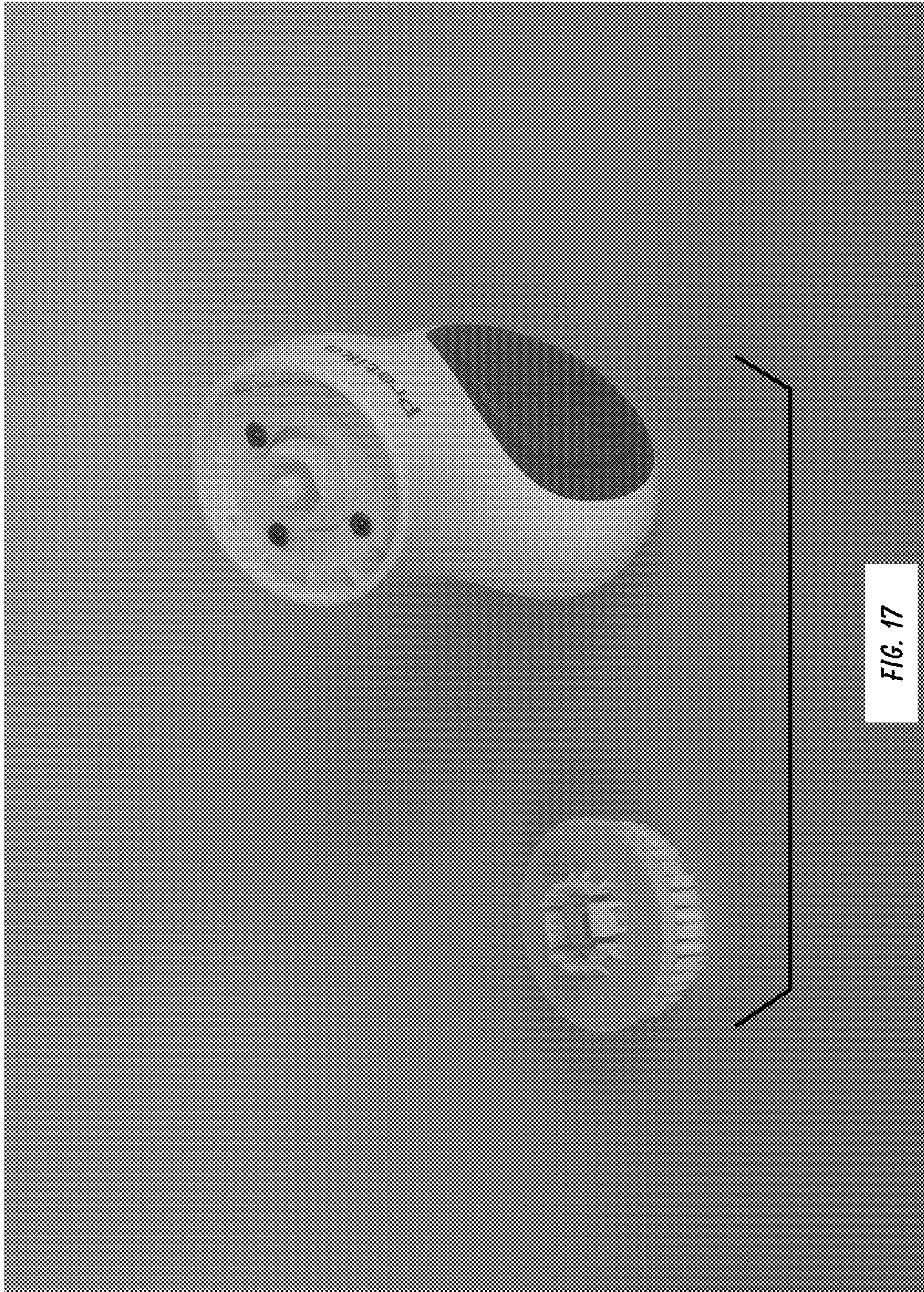
