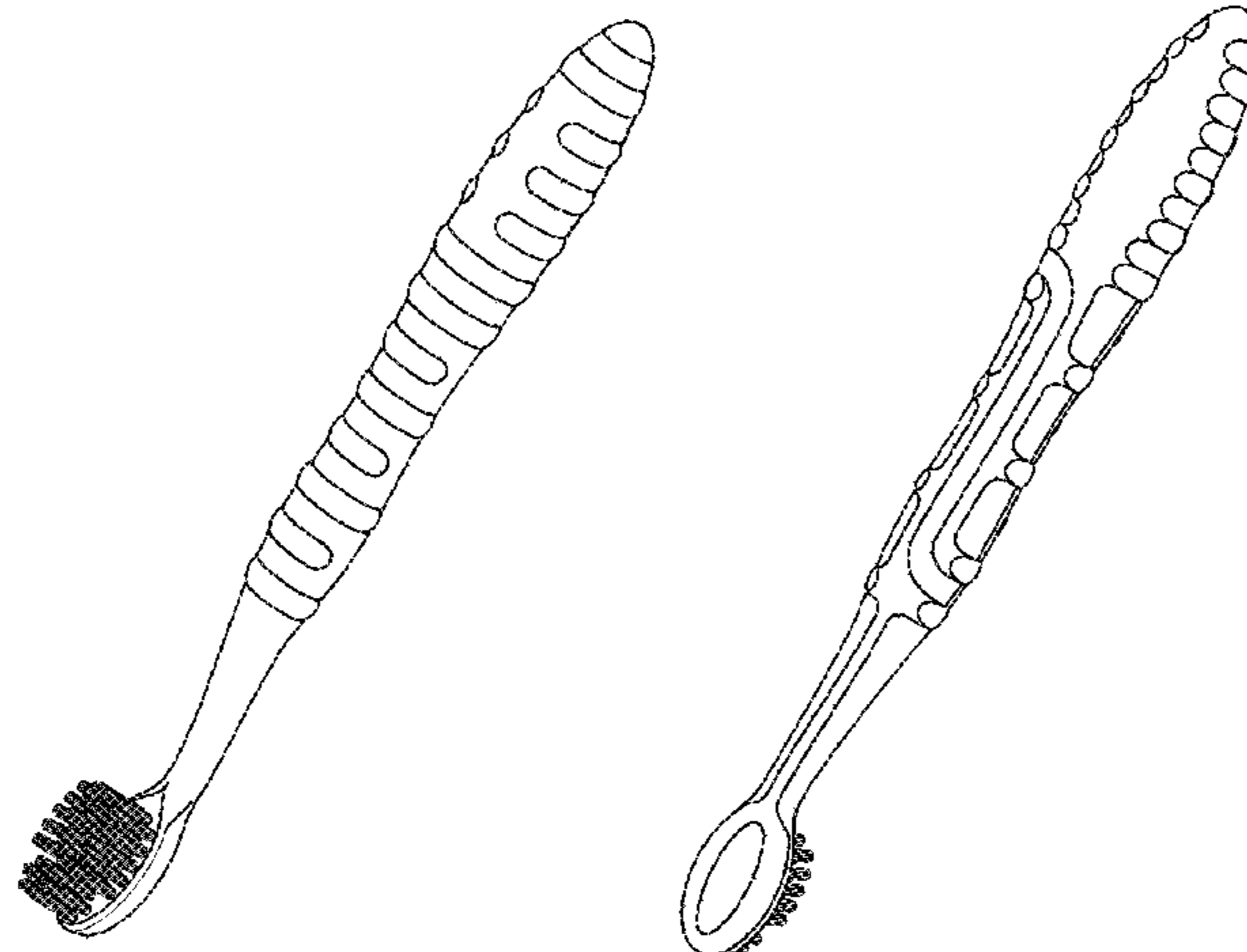


FIG. 6 is an opposite side elevational view thereof. The portions depicted in broken line illustrate parts of the toothbrush that form no part of the claimed design.

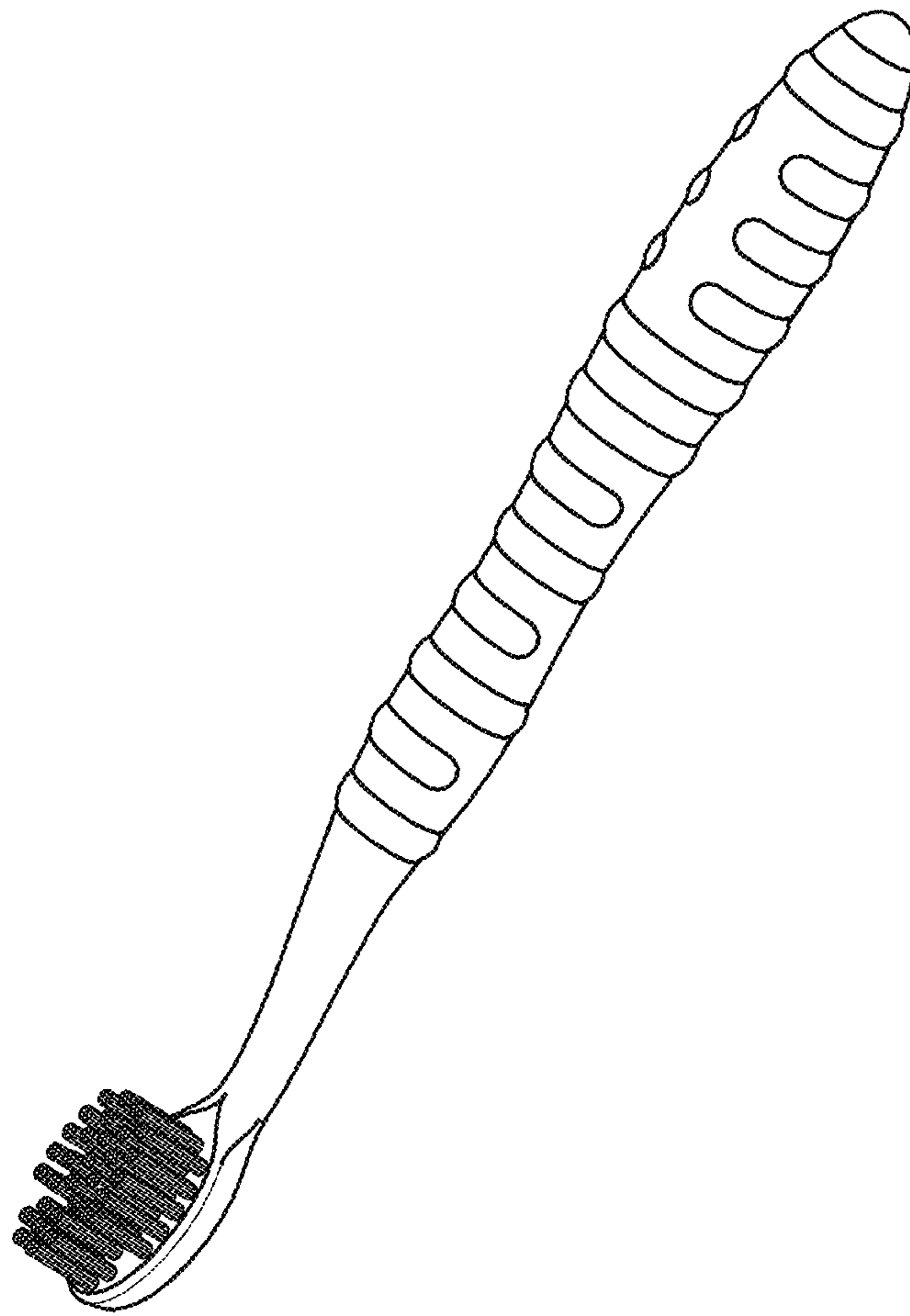

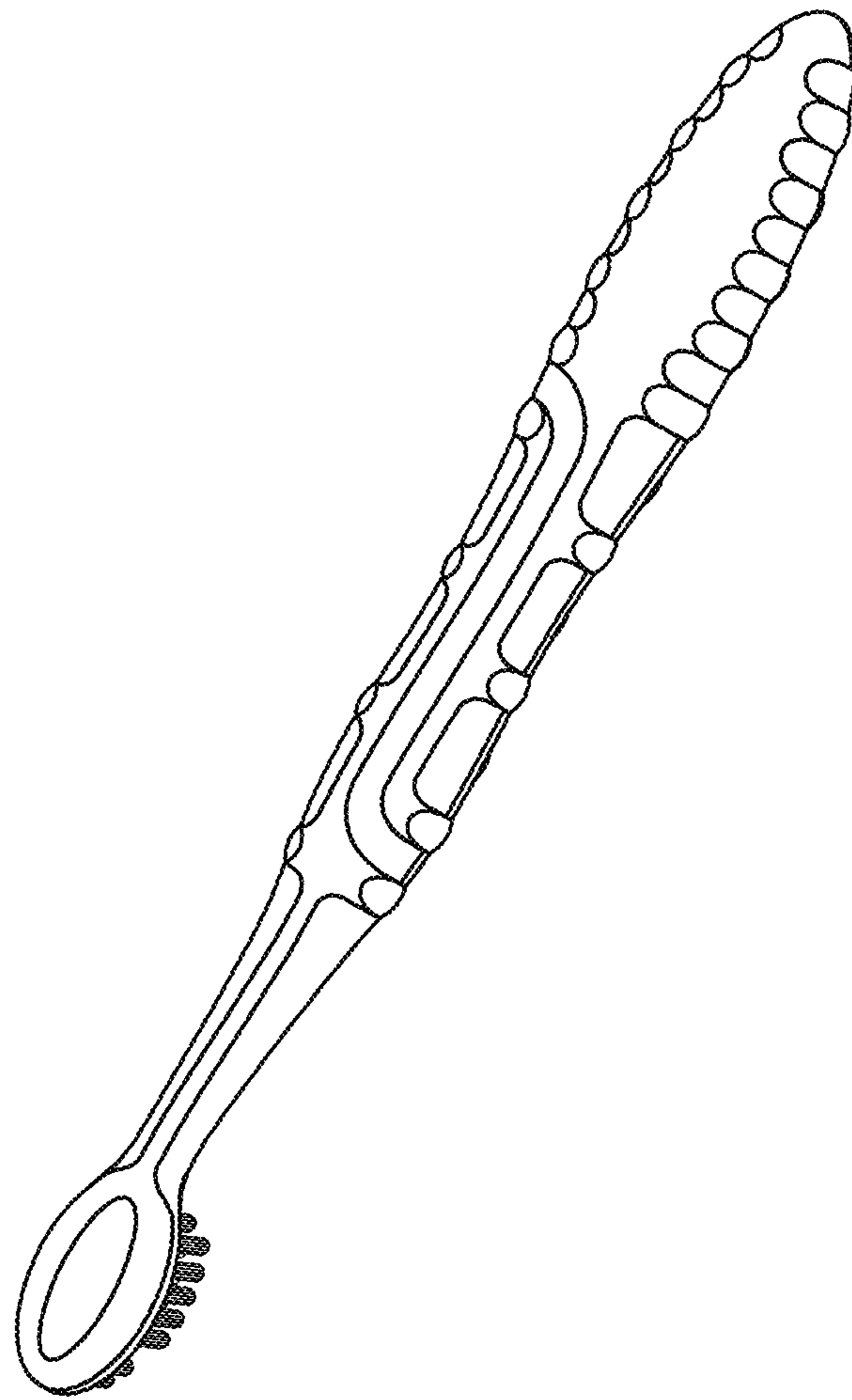

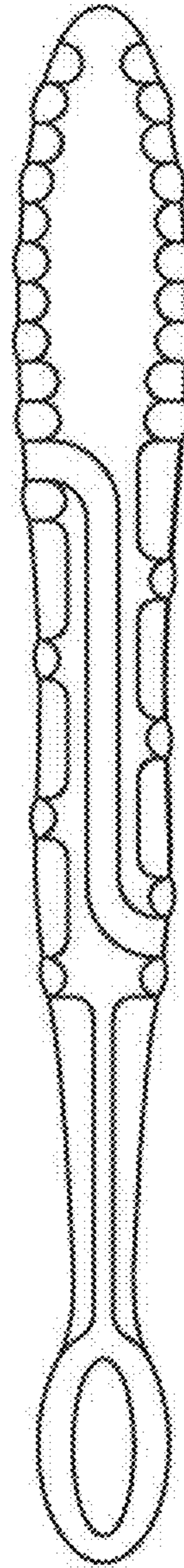

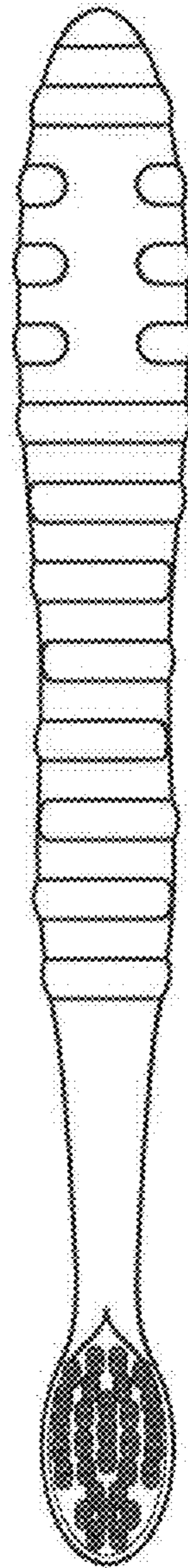

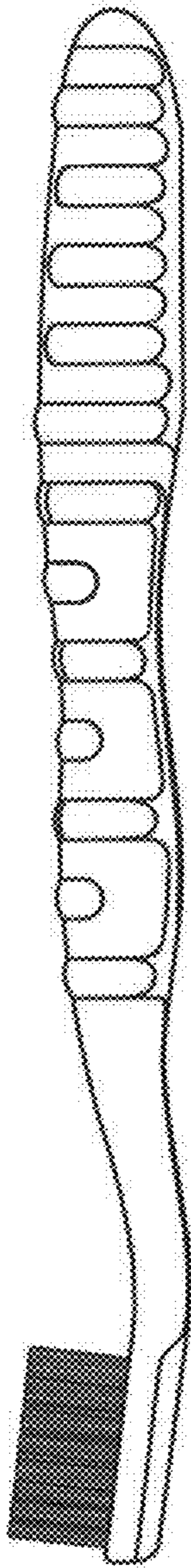

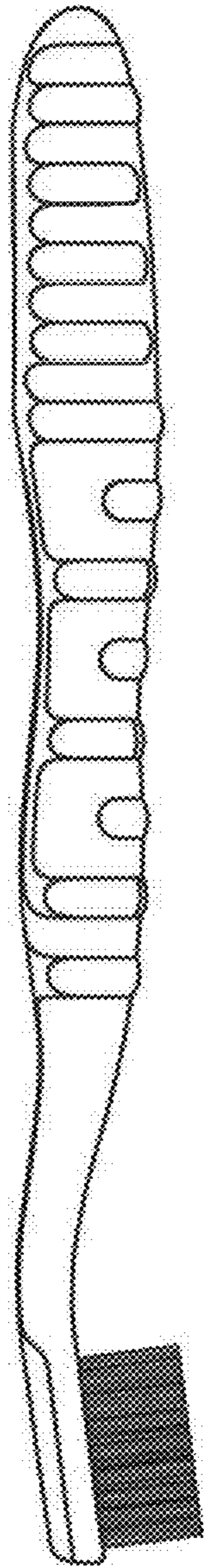
