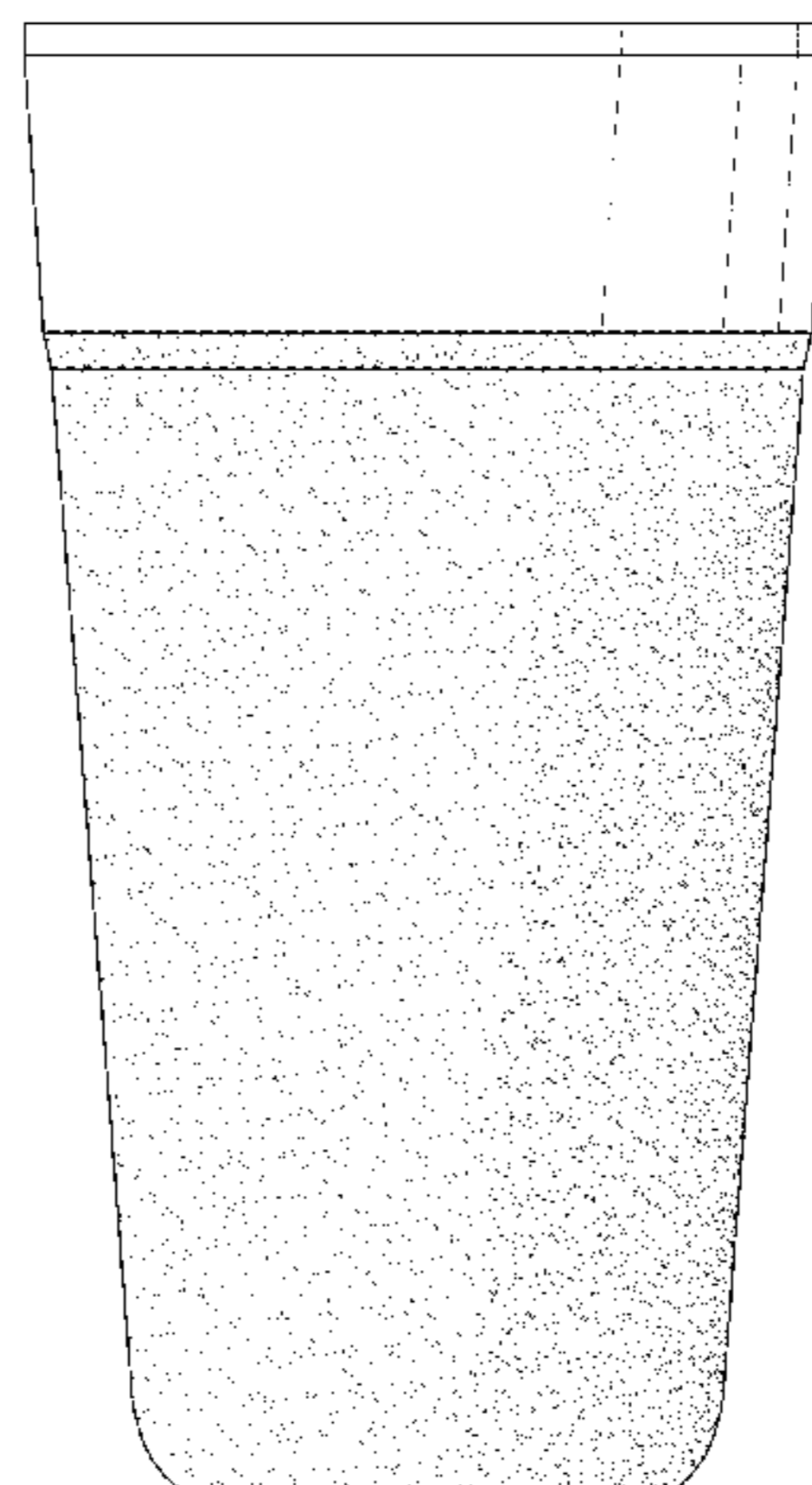
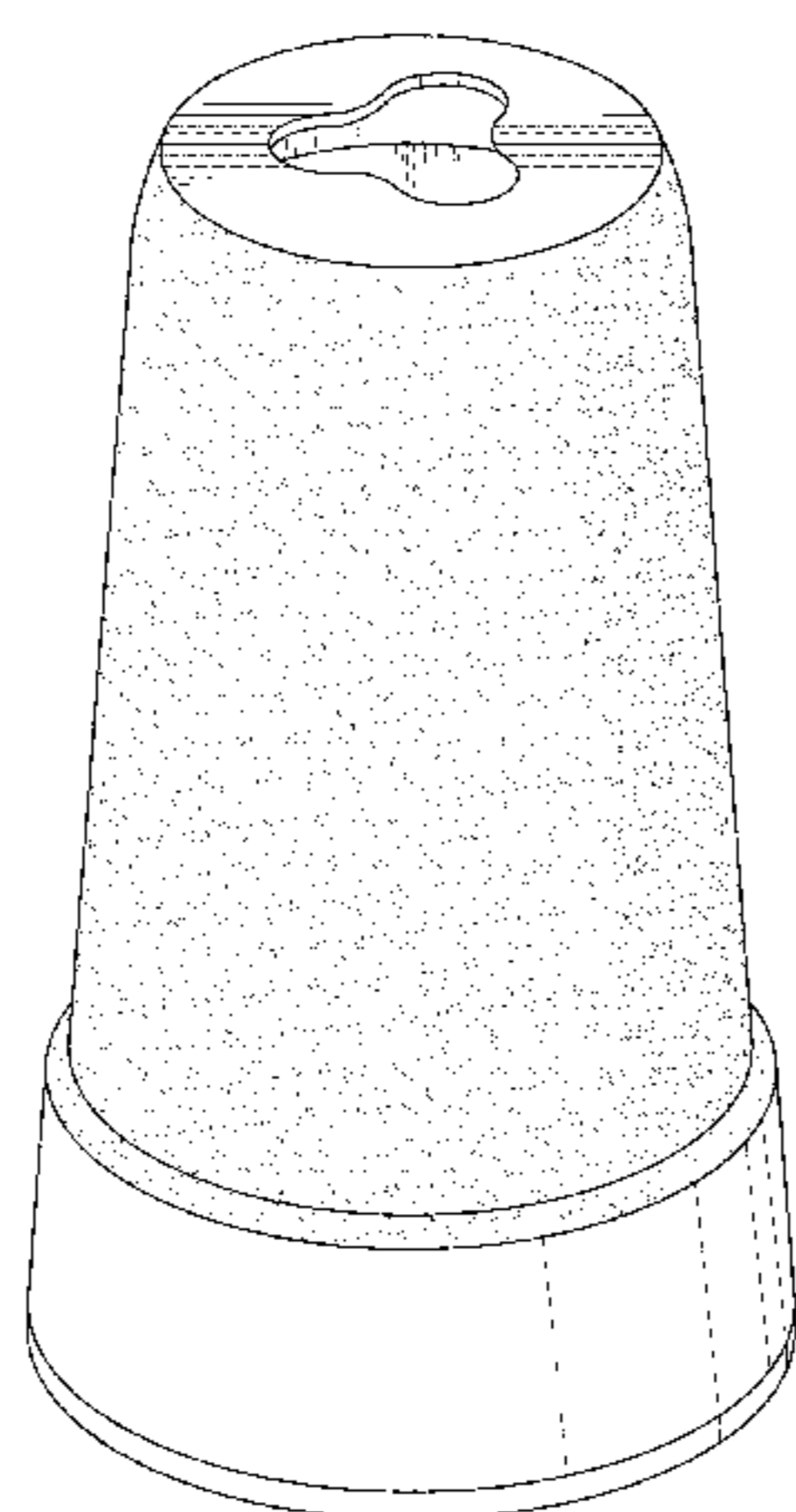
(57) **CLAIM**

We claim the ornamental design for a beverage container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a beverage container showing my new design;

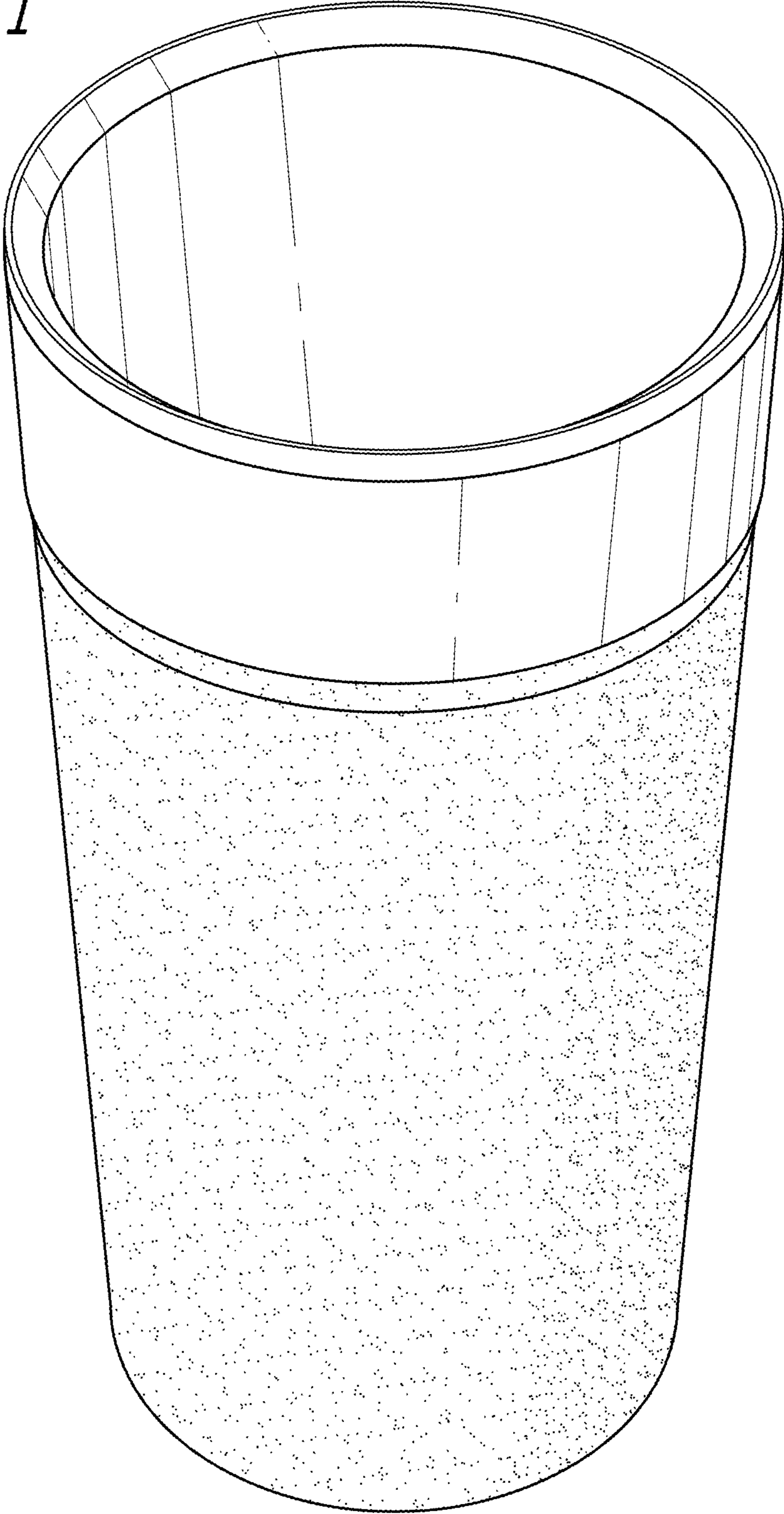

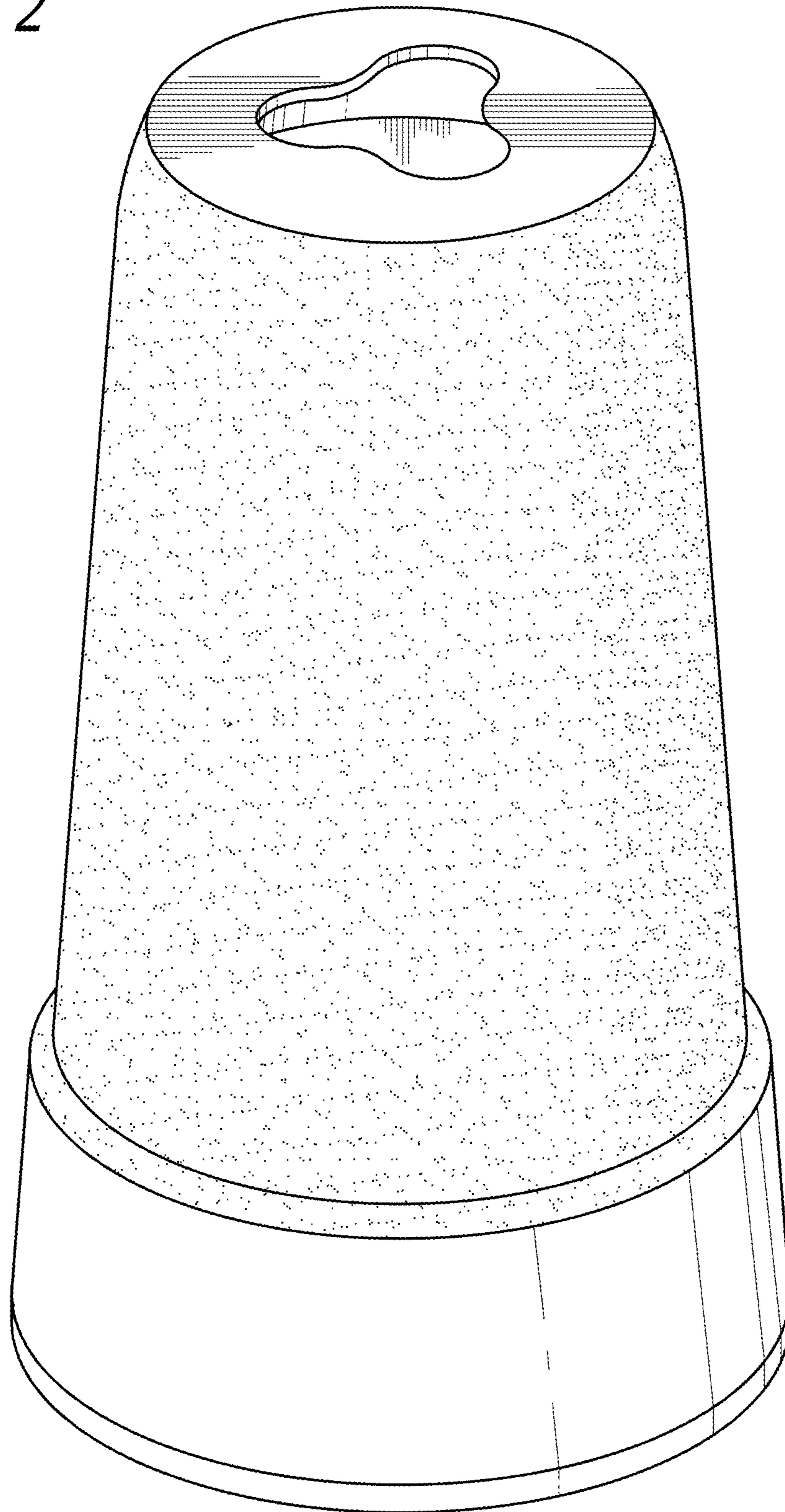

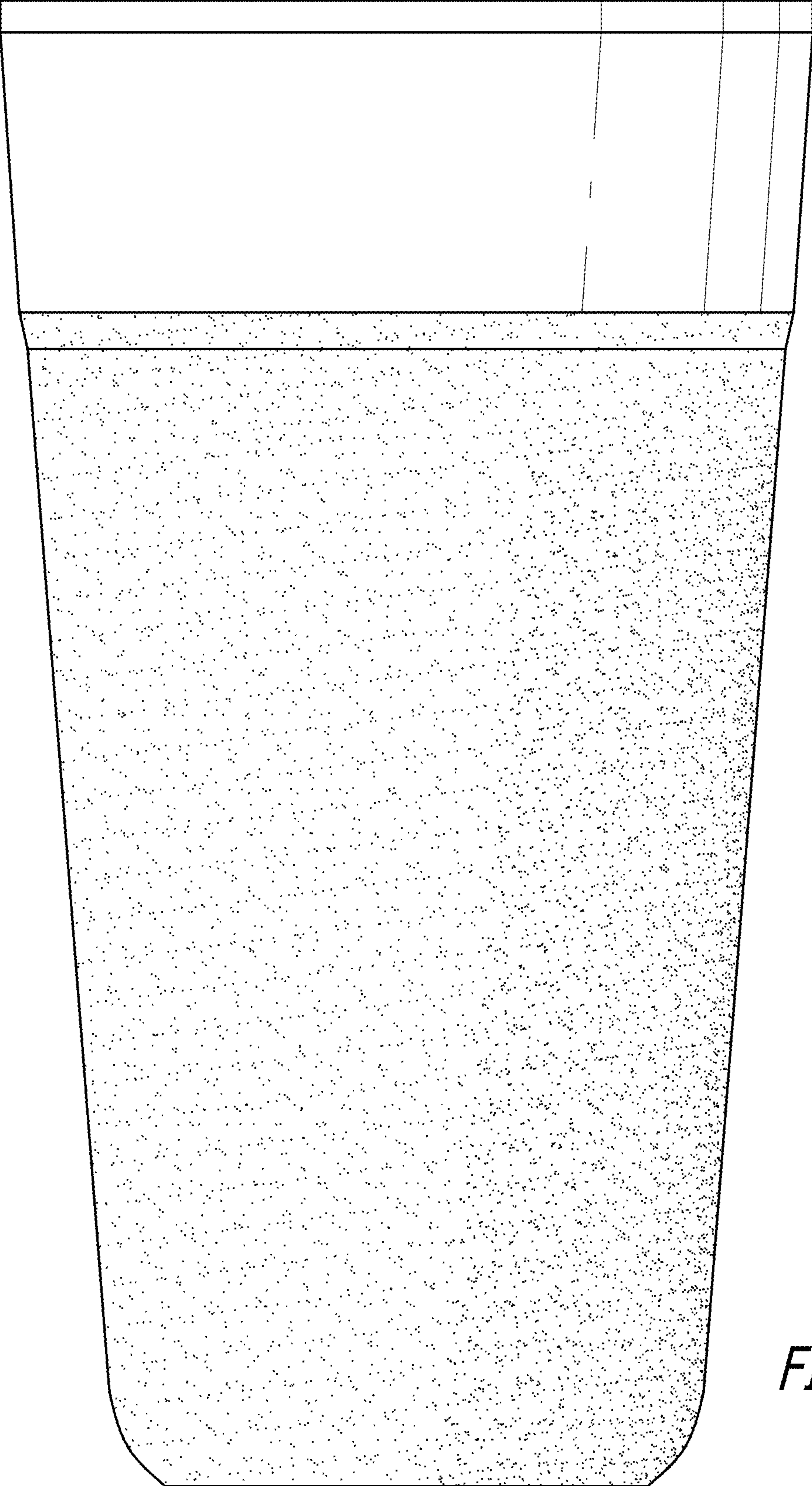

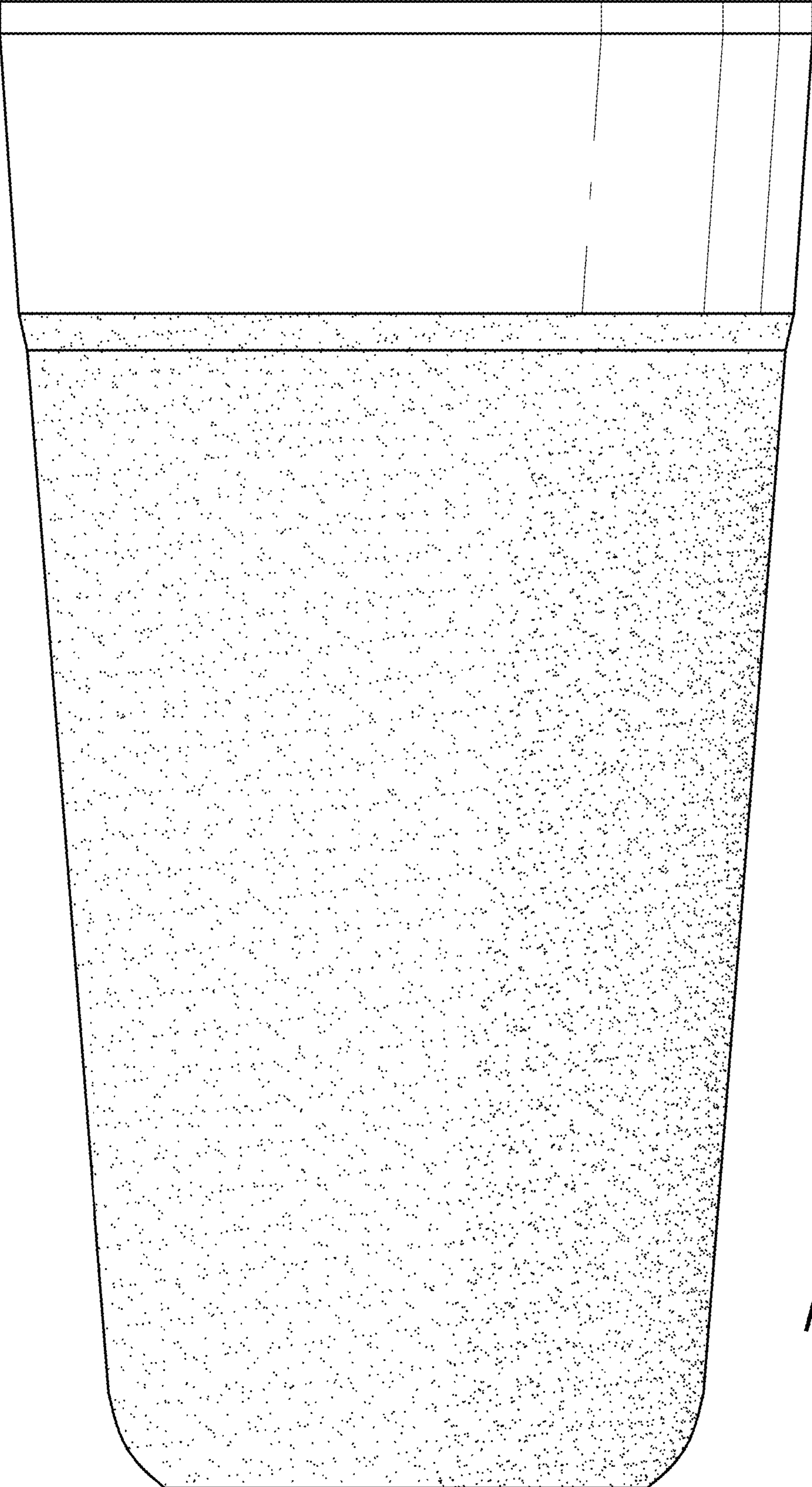

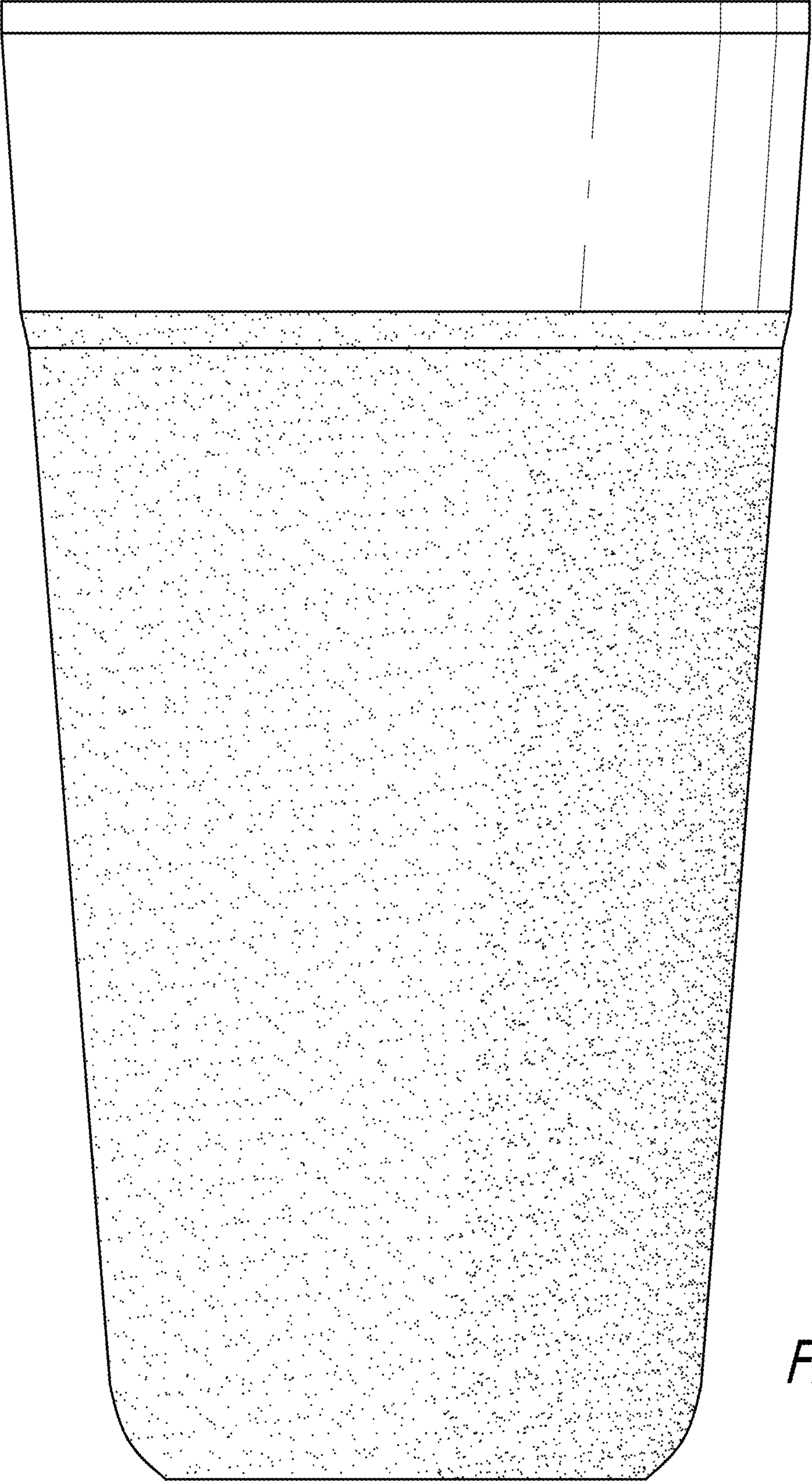

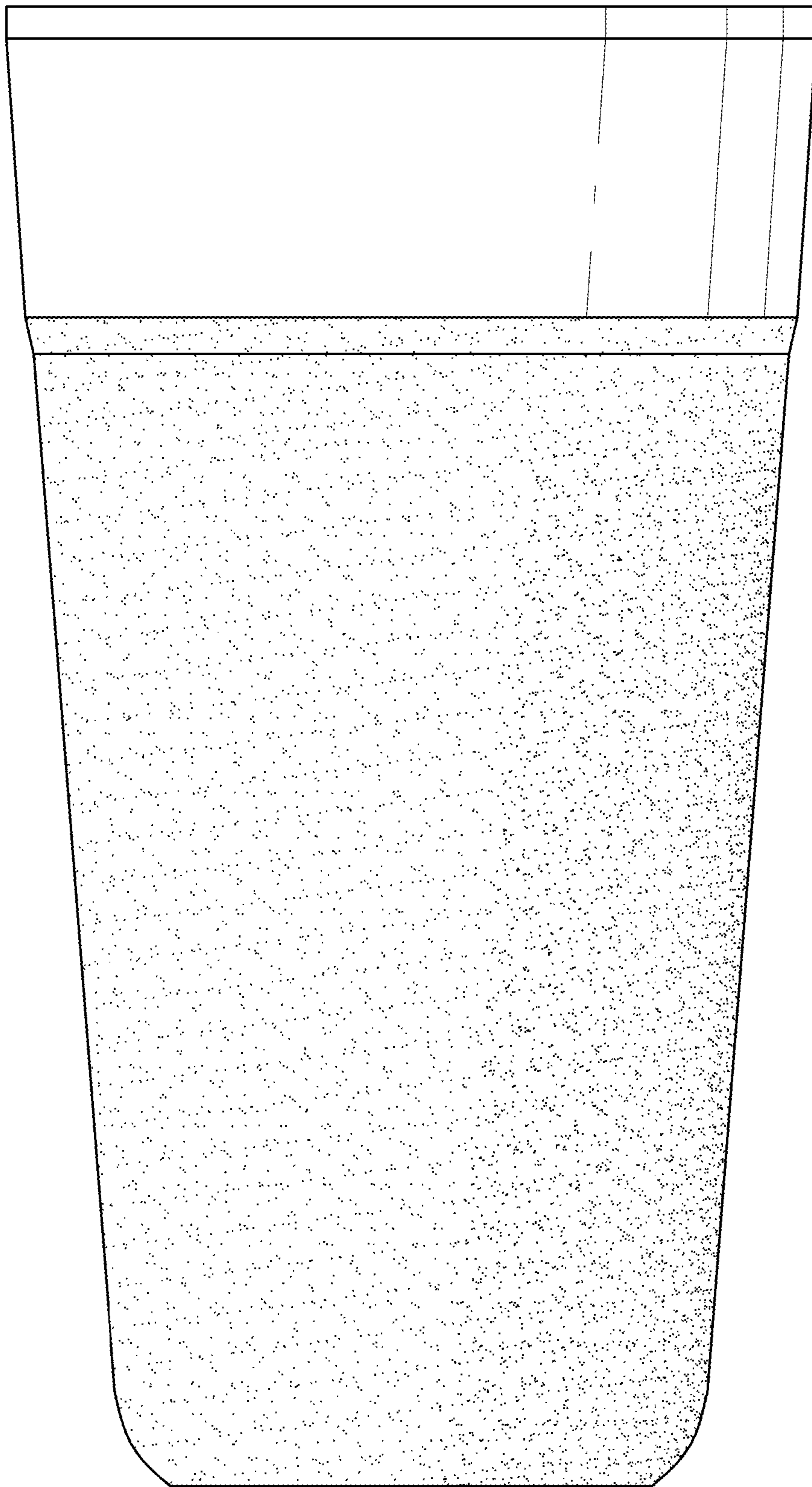

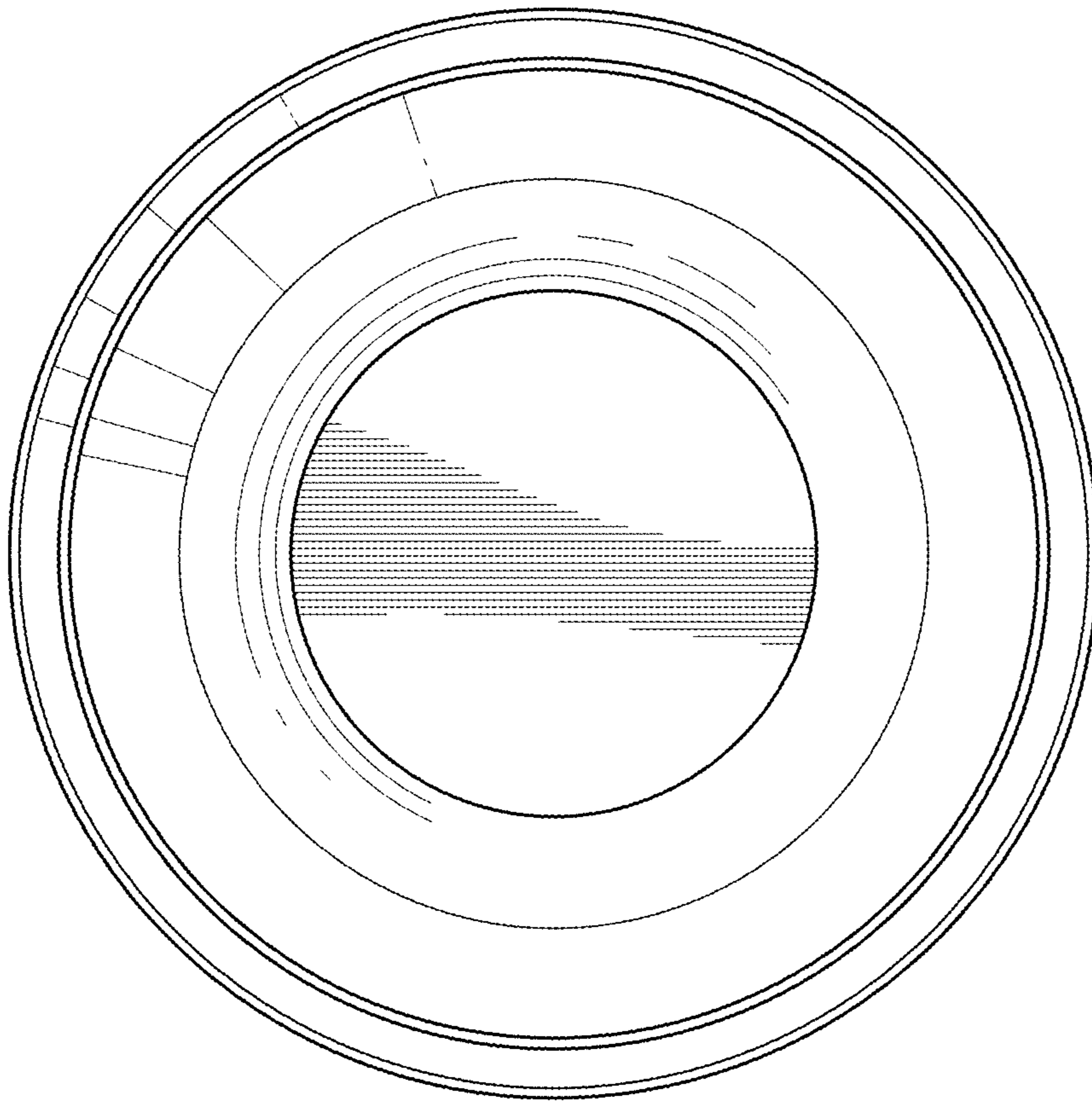

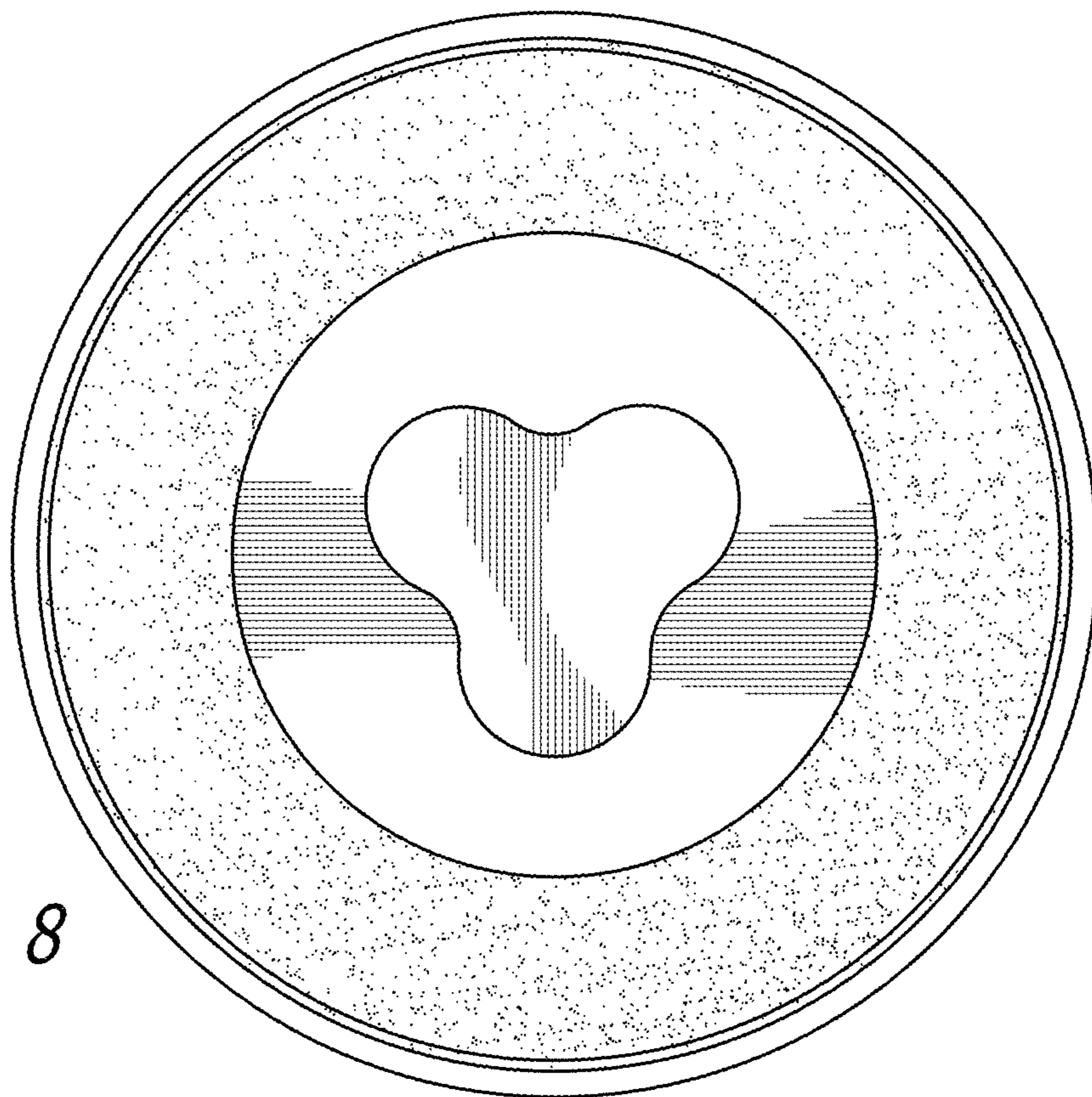
