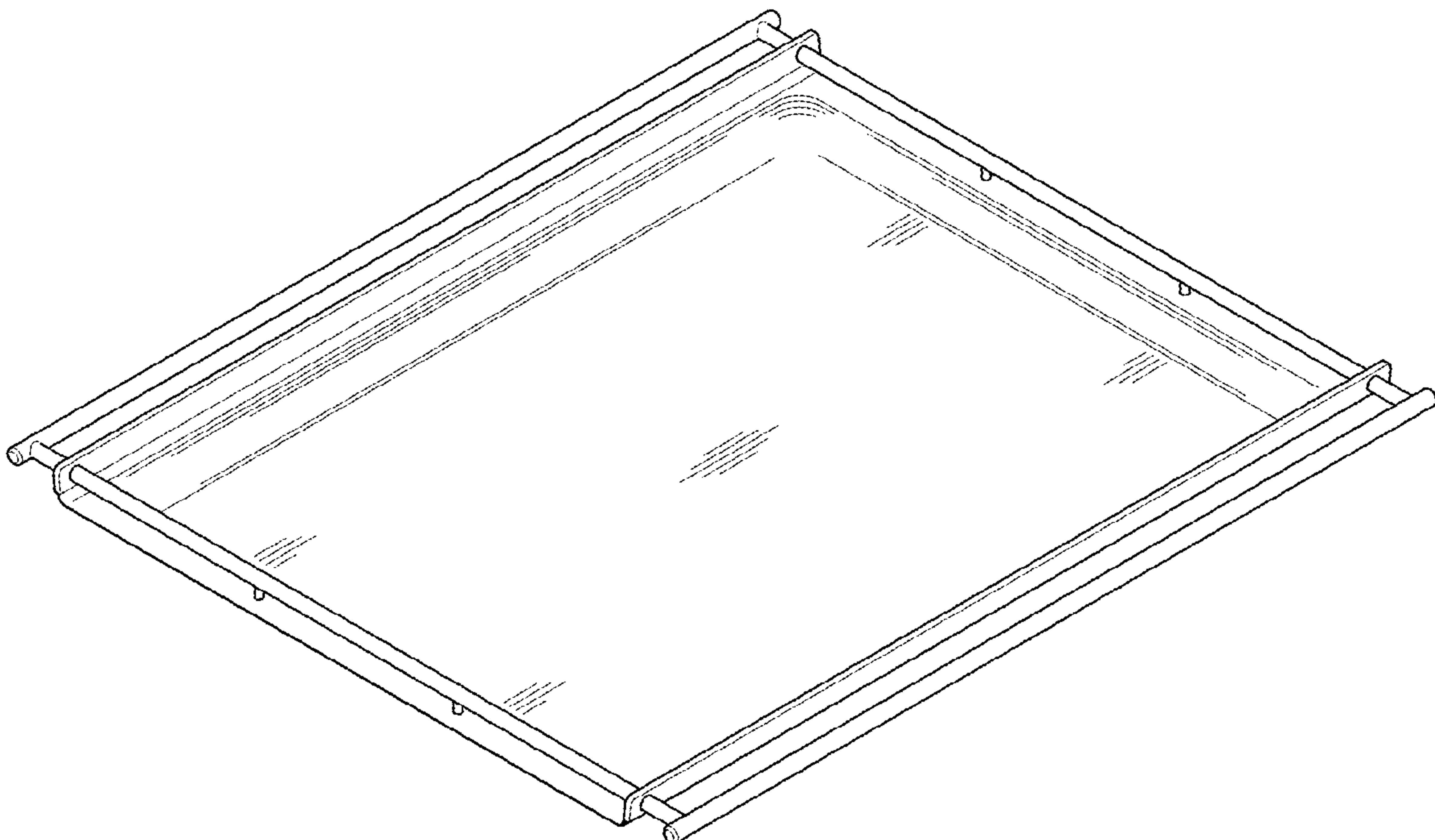

The ornamental design for a tray, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of our new ornamental design for a tray.
FIG. 2 is a front elevation view thereof, the opposite rear elevation view being a mirror image.
FIG. 3 is a side elevation view thereof, the opposite side elevation view being a mirror image.
FIG. 4 is a top view thereof; and,
FIG. 5 is a bottom view thereof.

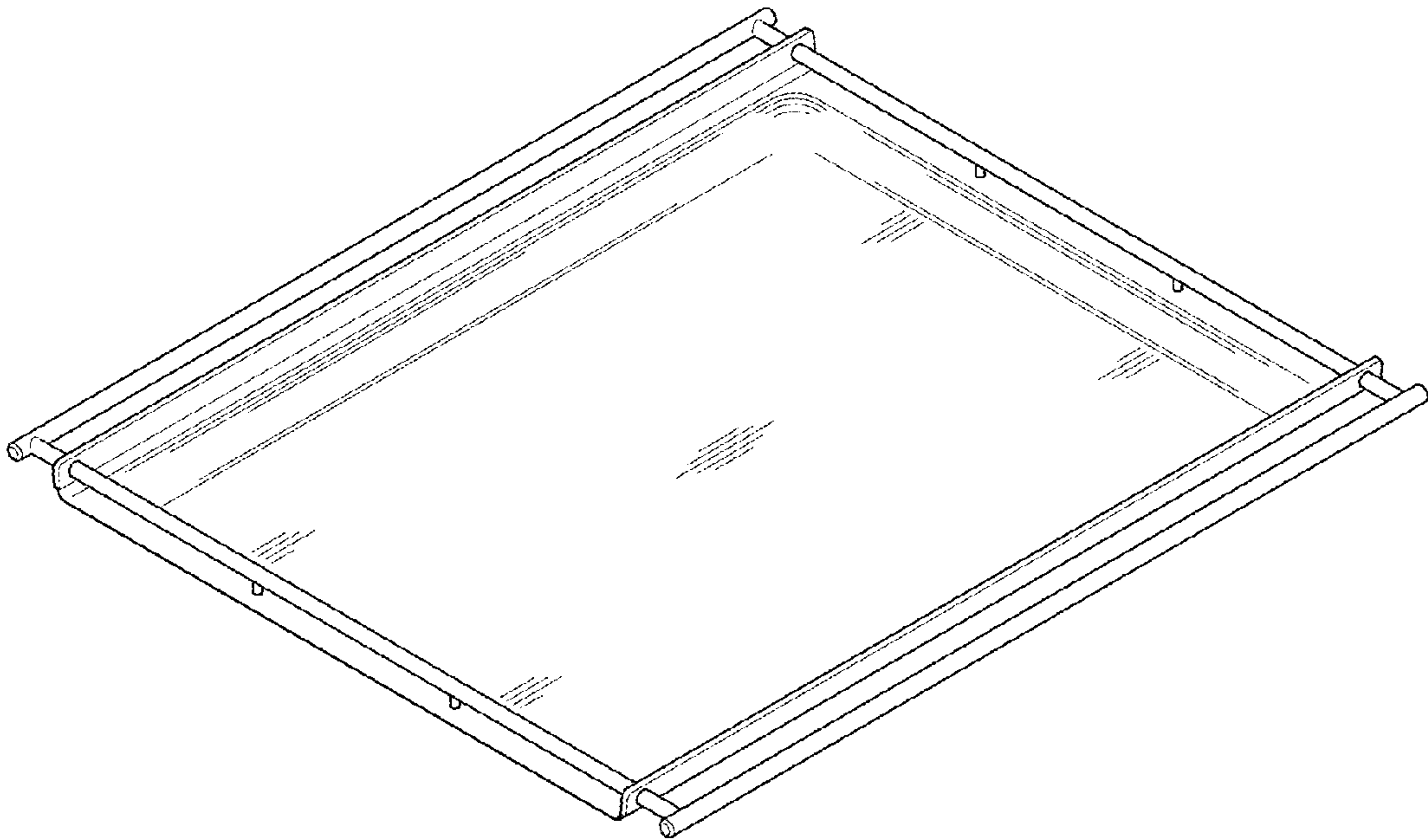

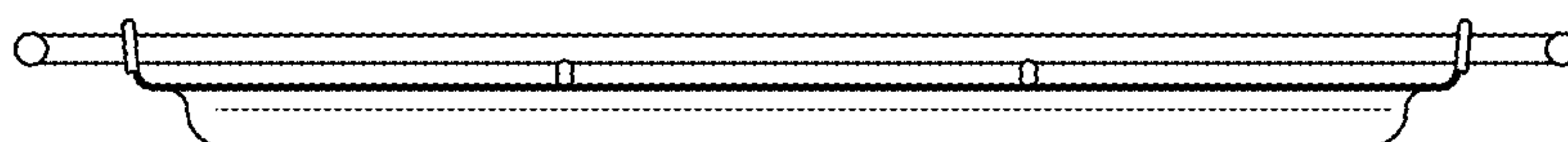

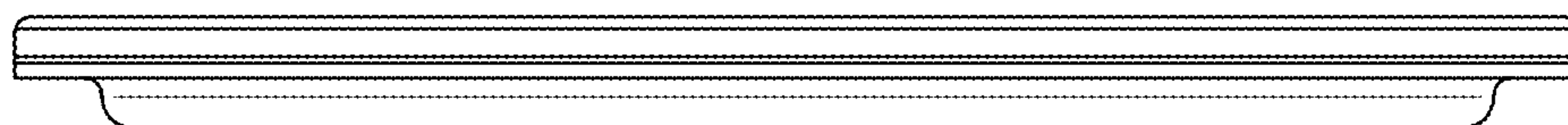

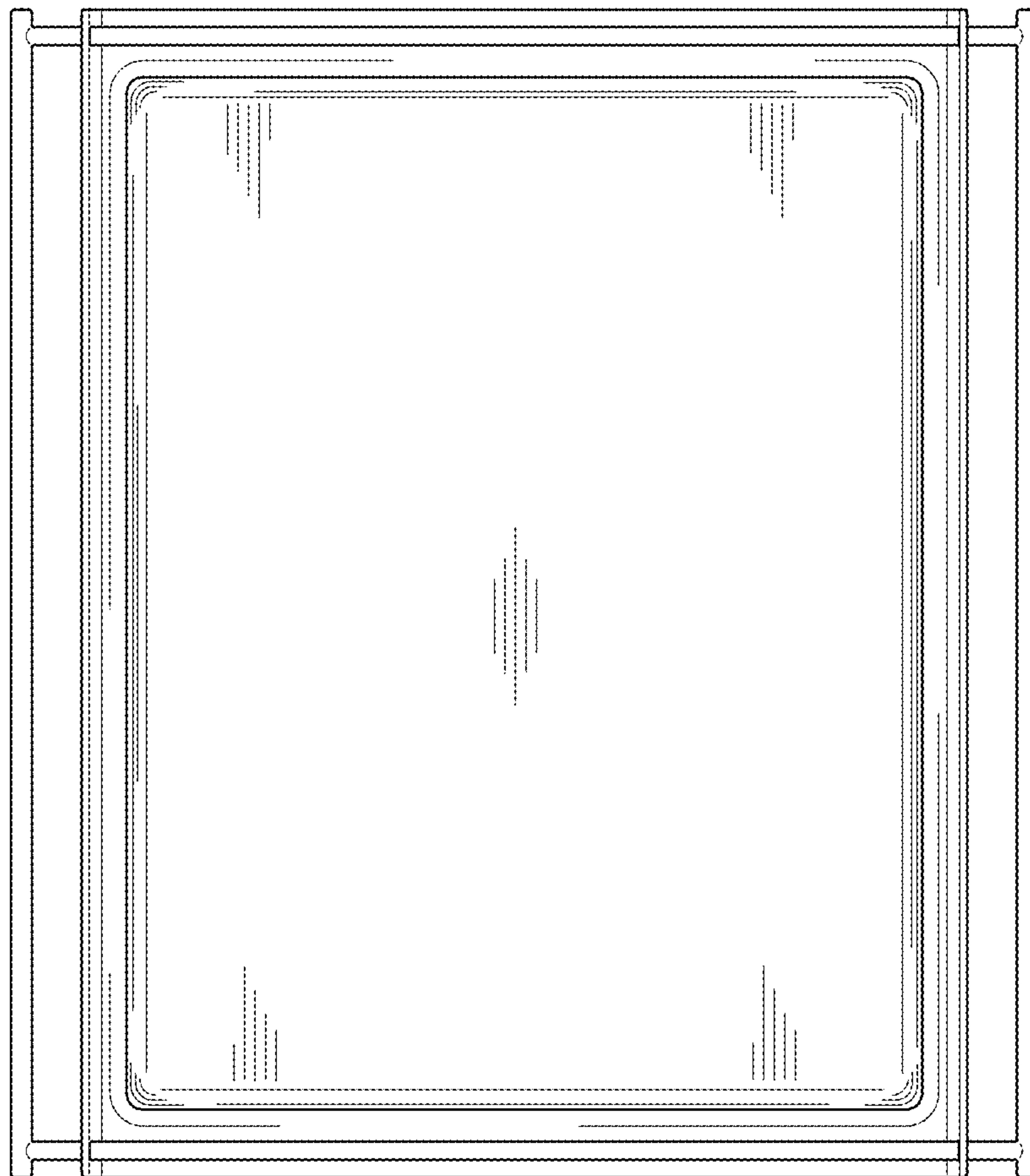

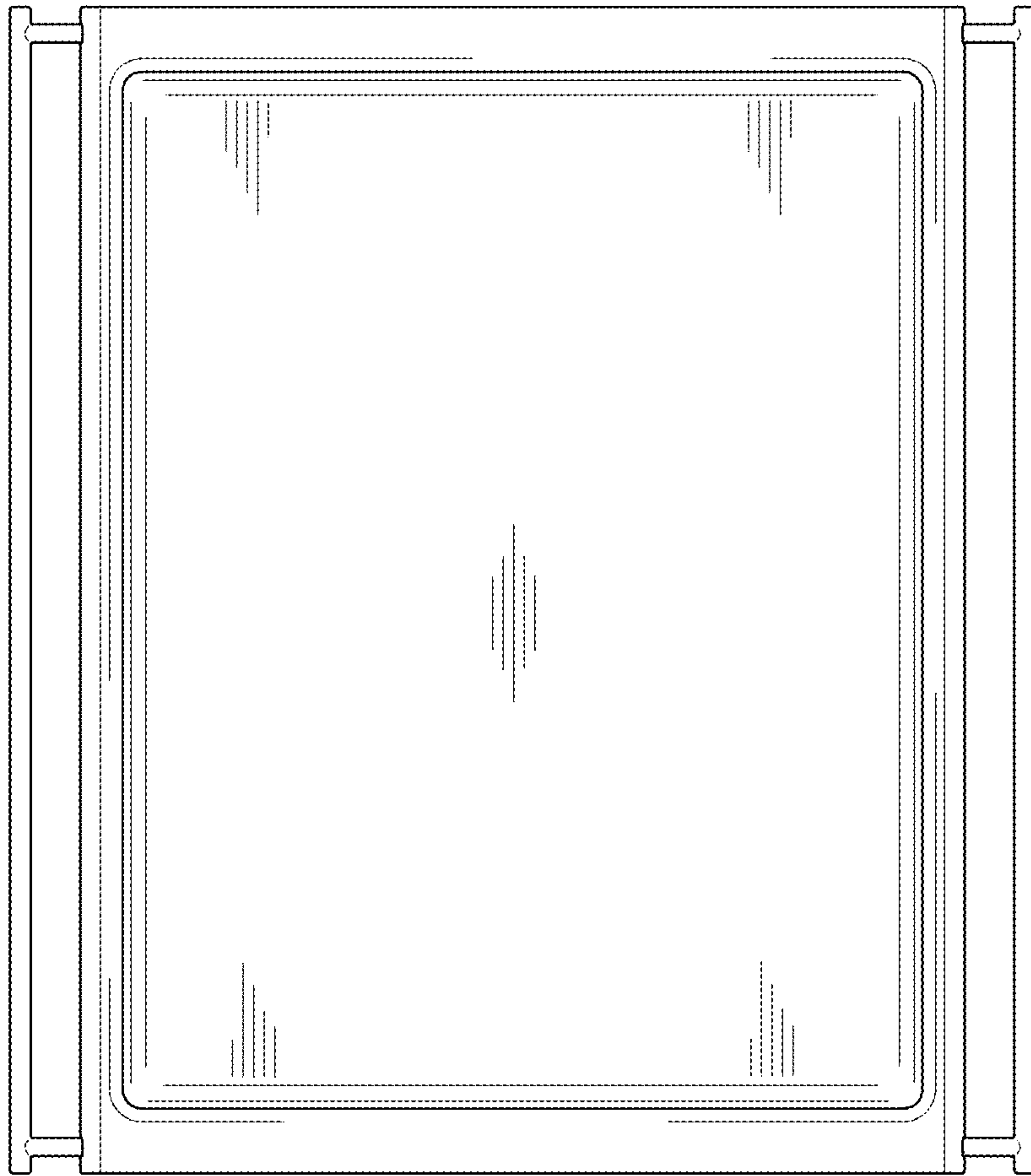
