The ornamental design of an insulator sleeve, as shown and described.

DESCRIPTION
FIG. 1 is a side view of the insulator sleeve in accordance with the invention shown on a coffee container, all side views are identical;

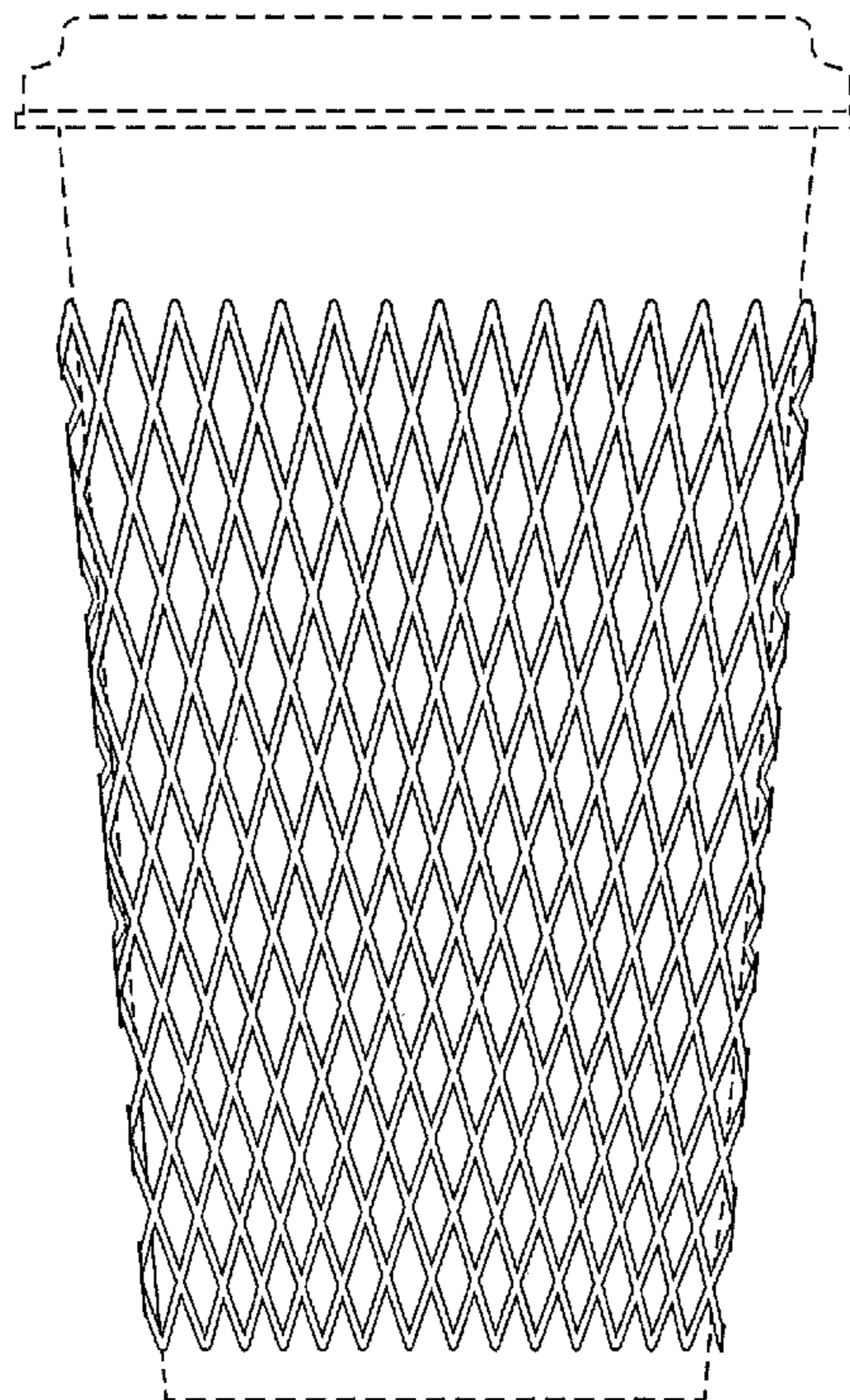

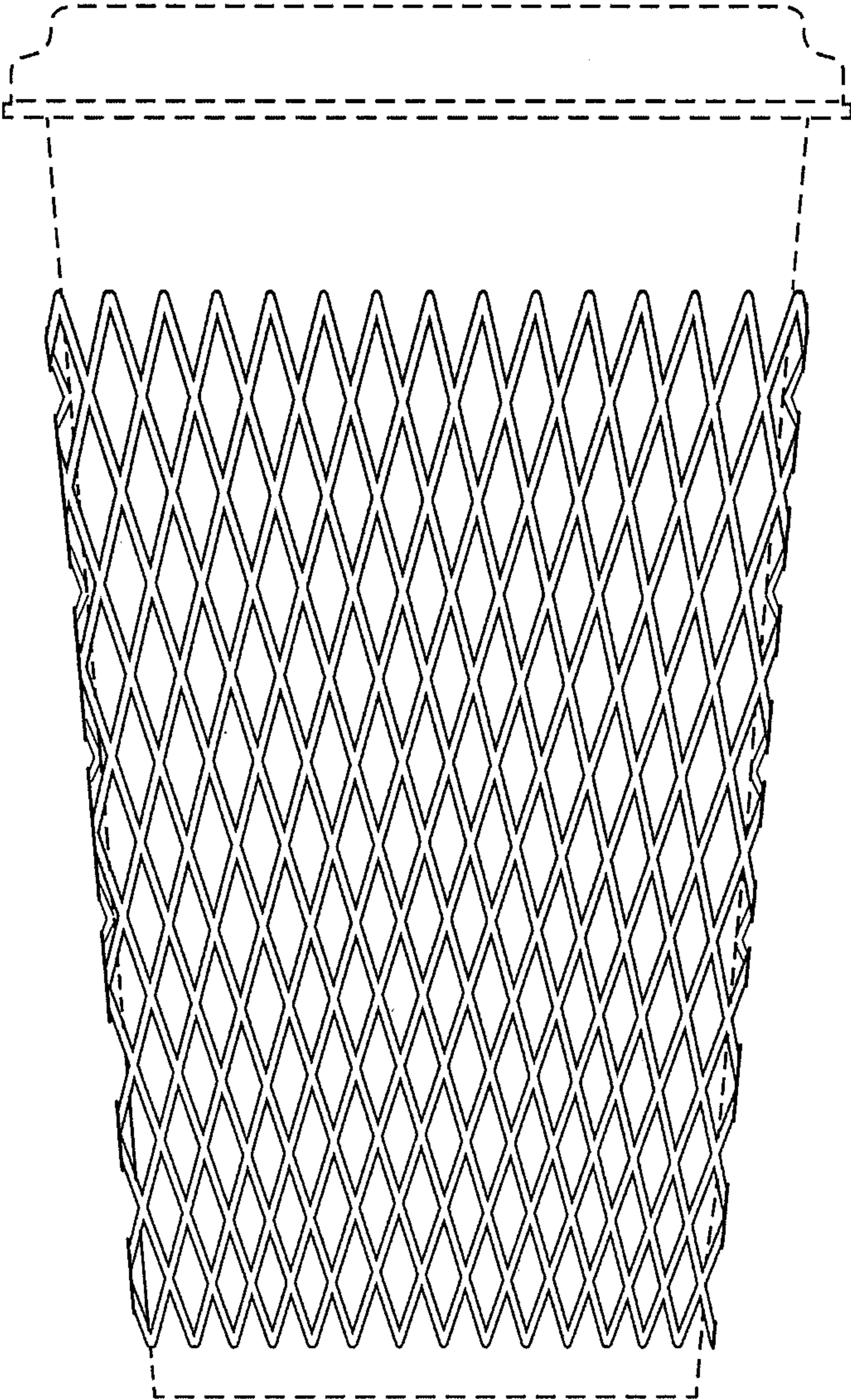

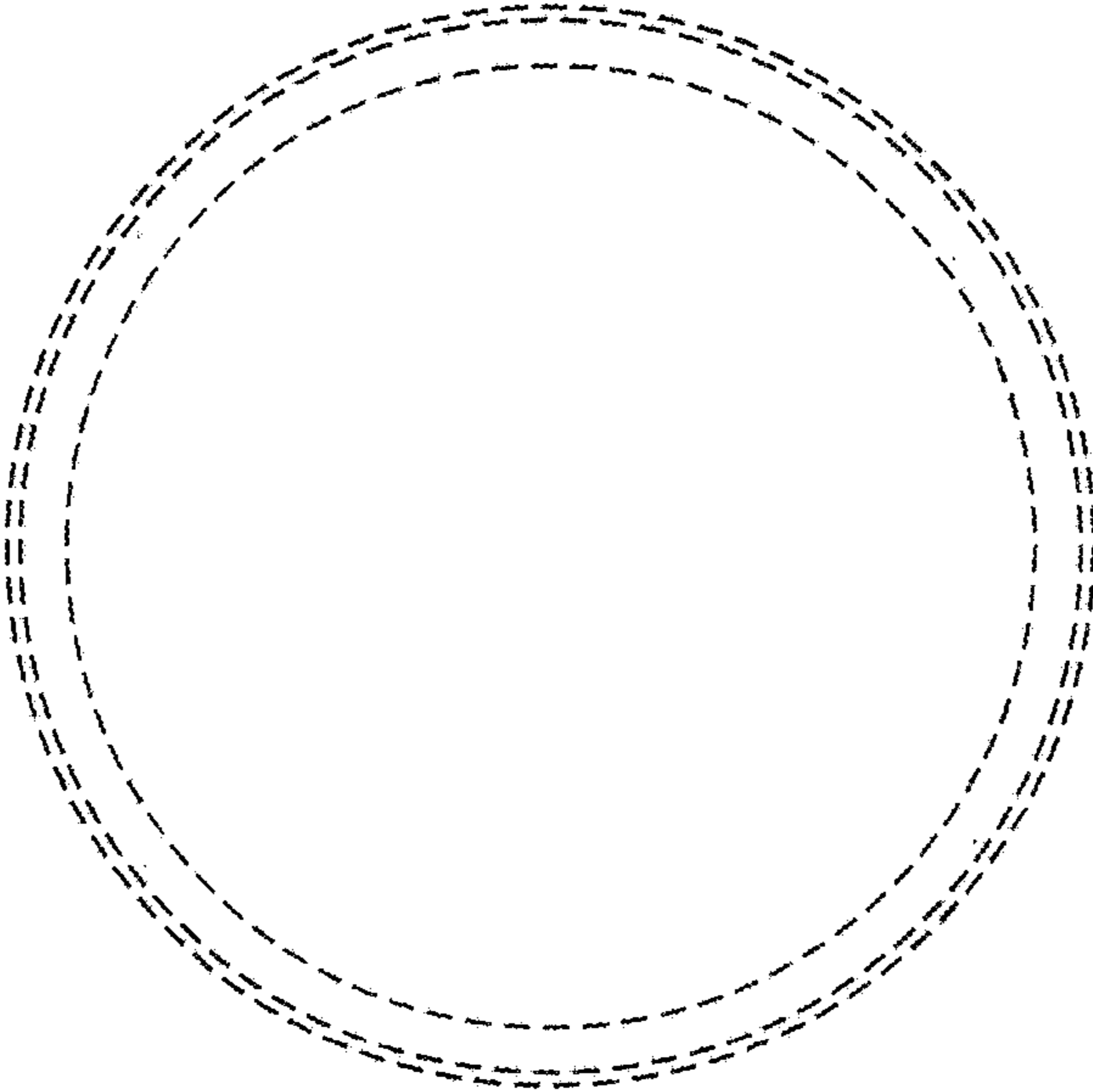
