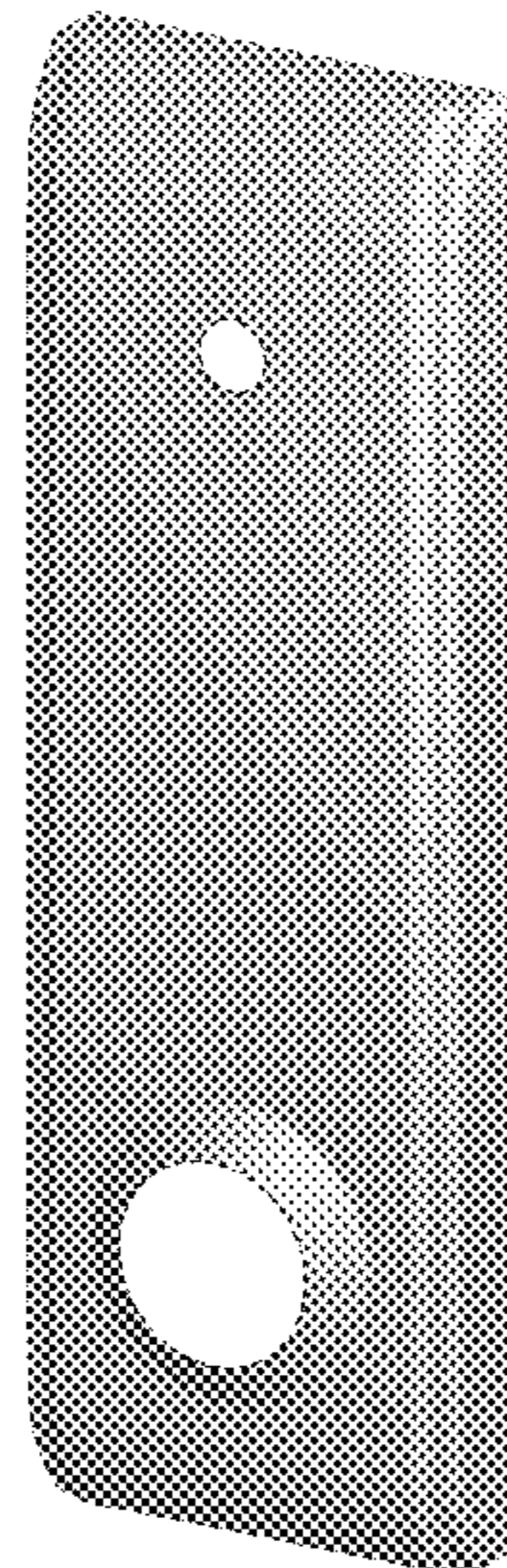
DESCRIPTION

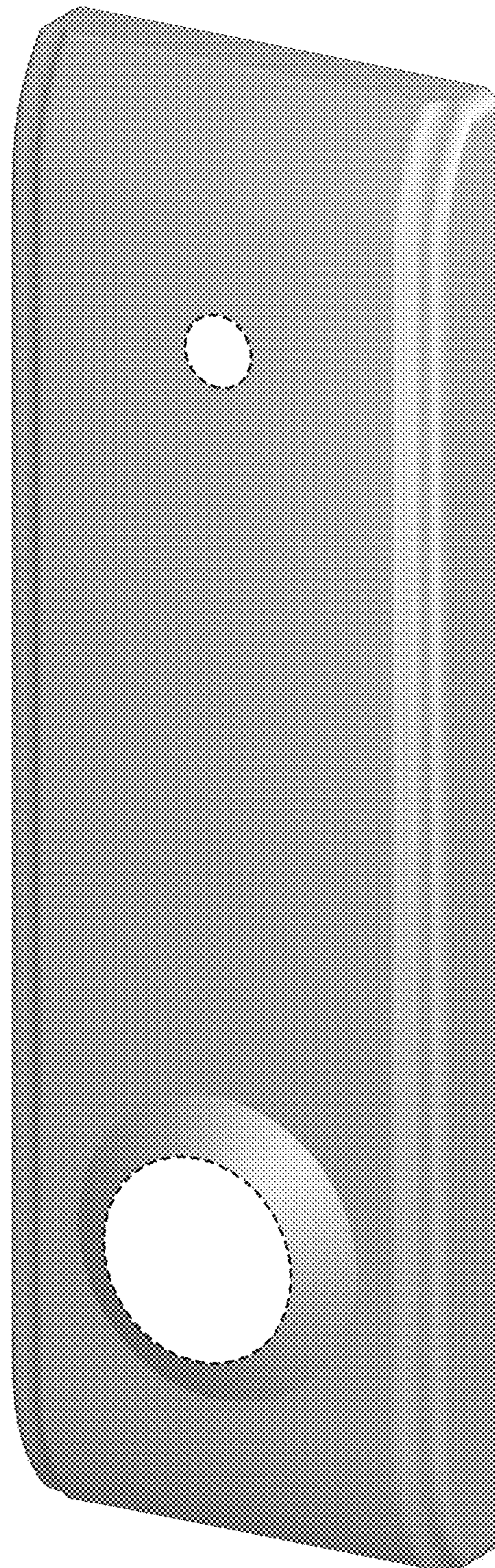

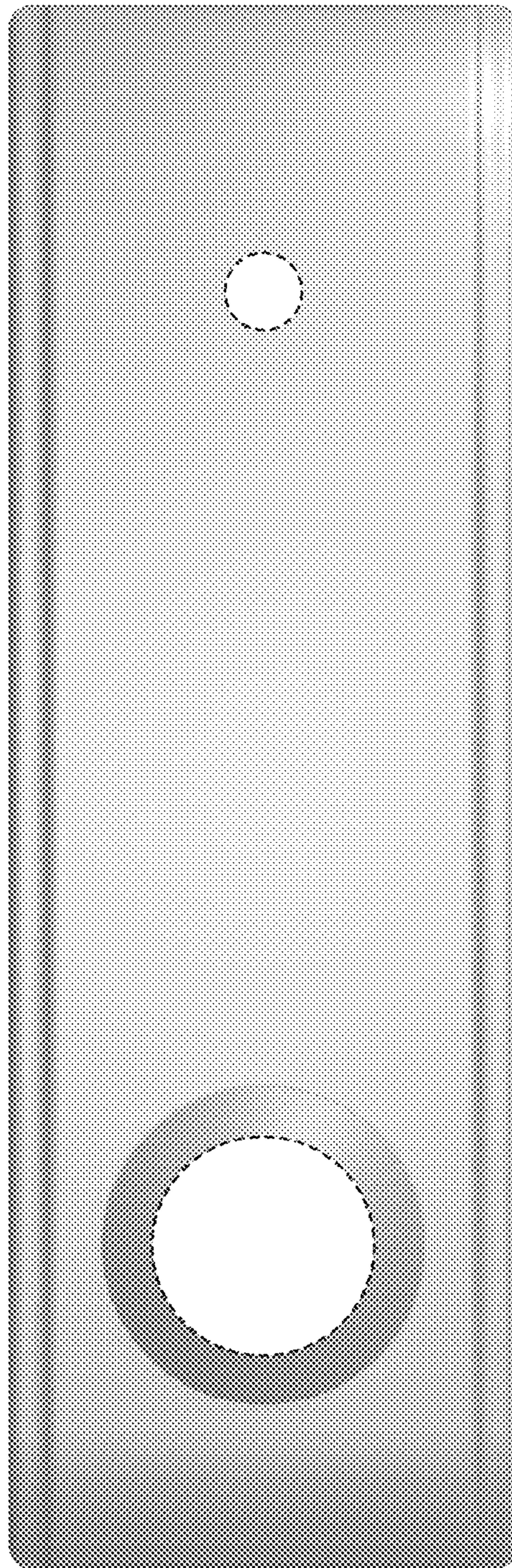

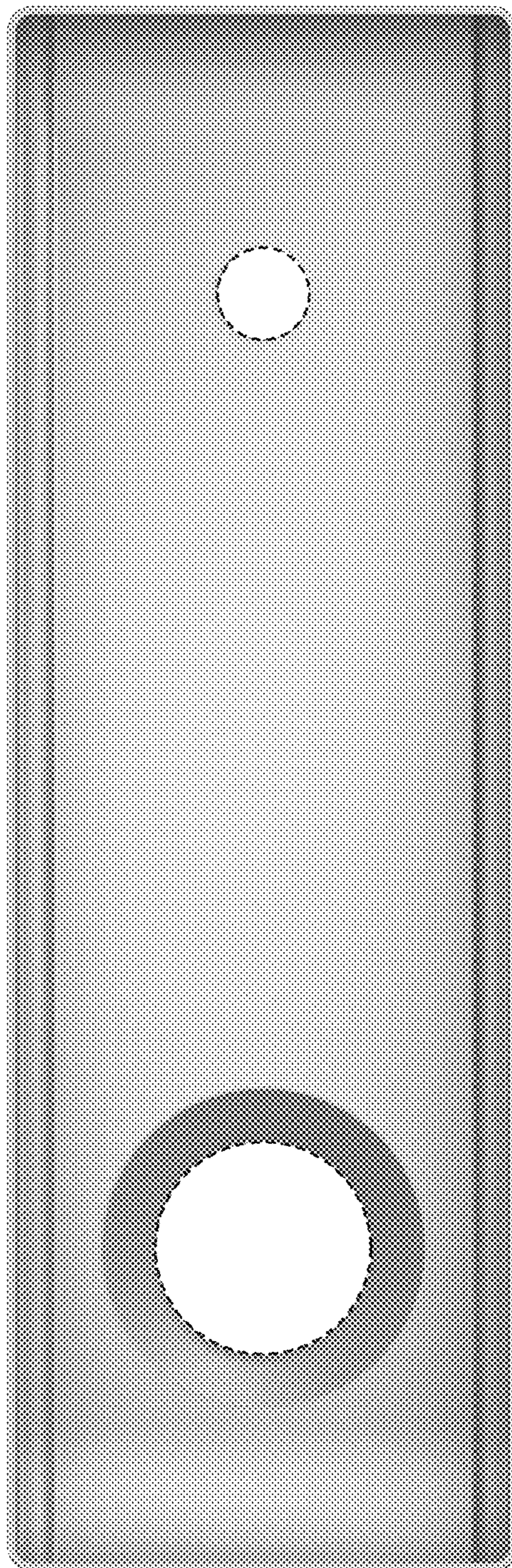

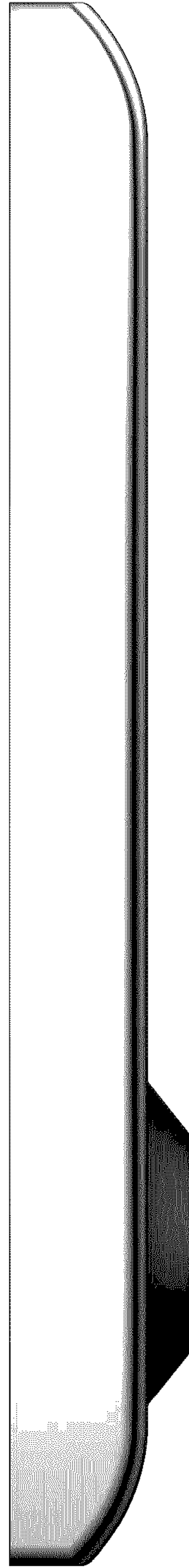

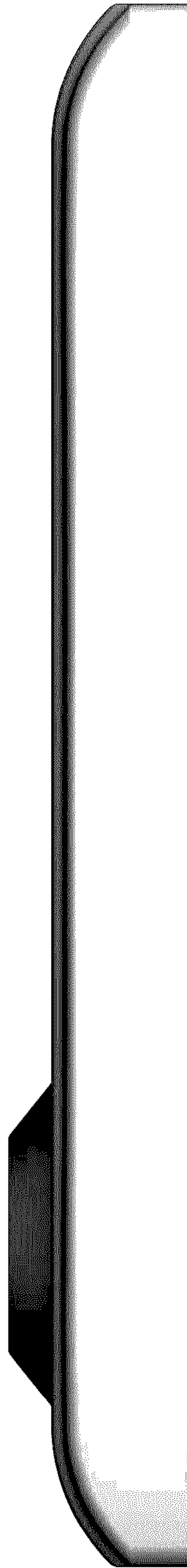

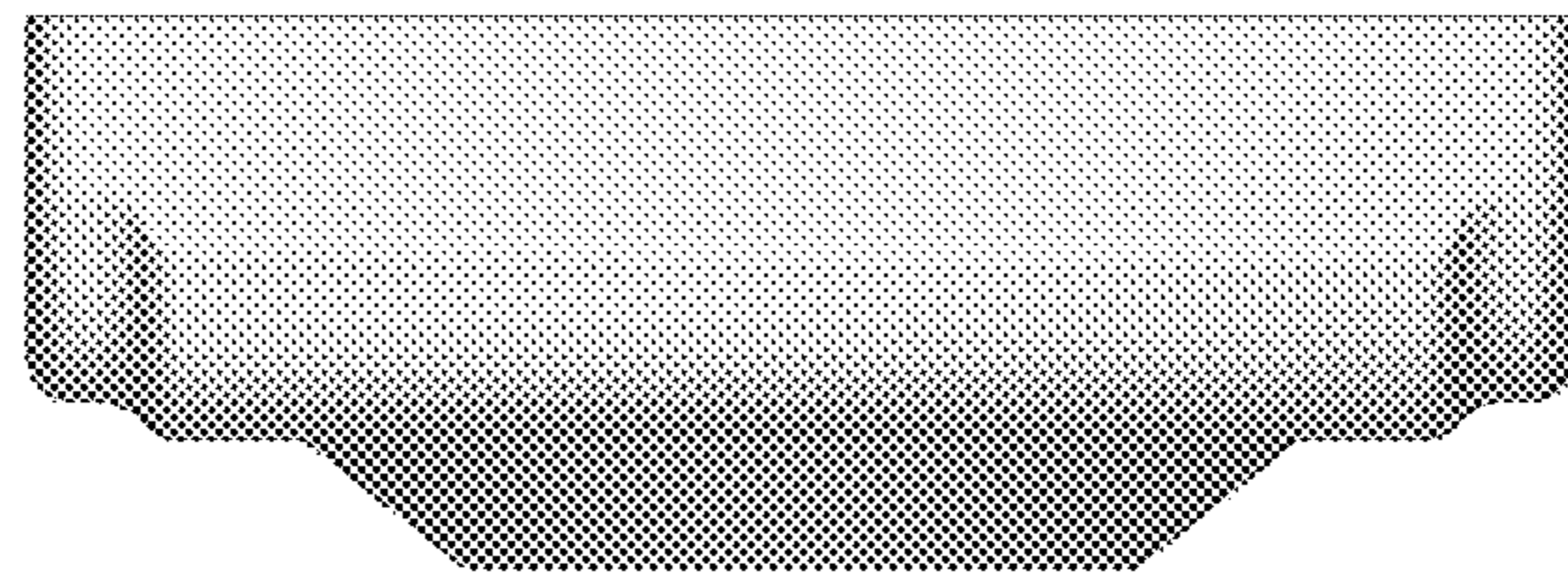

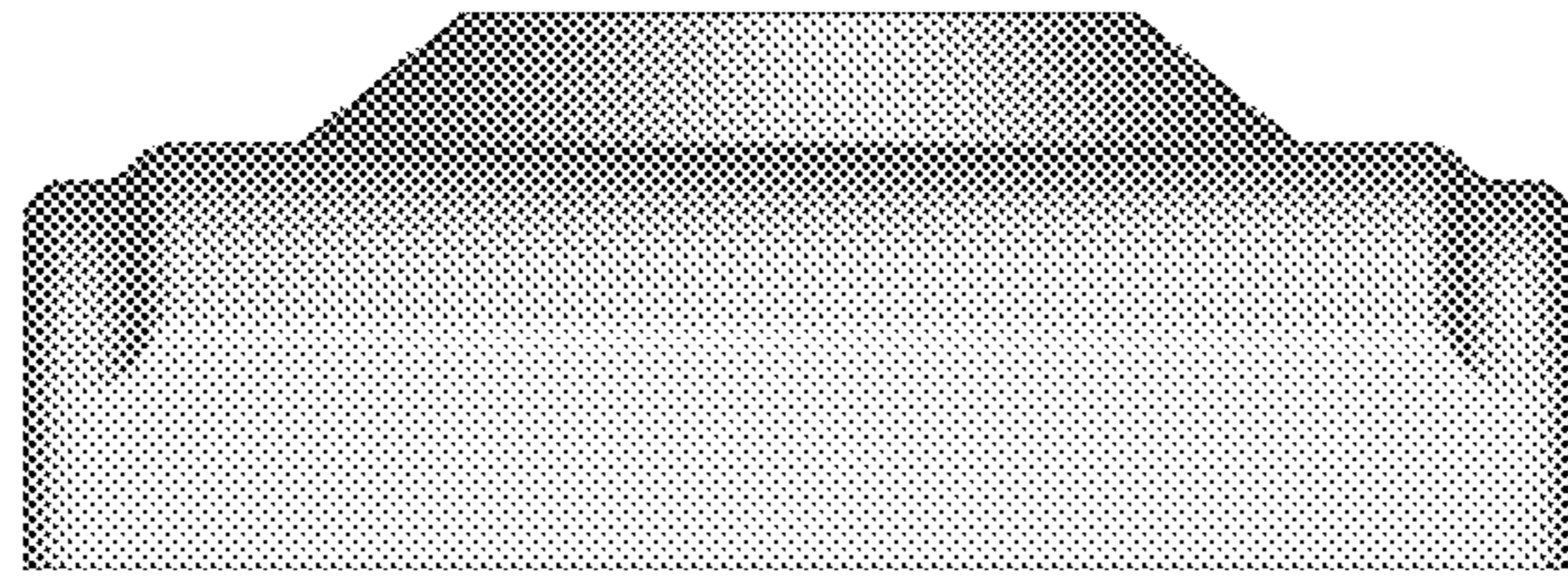

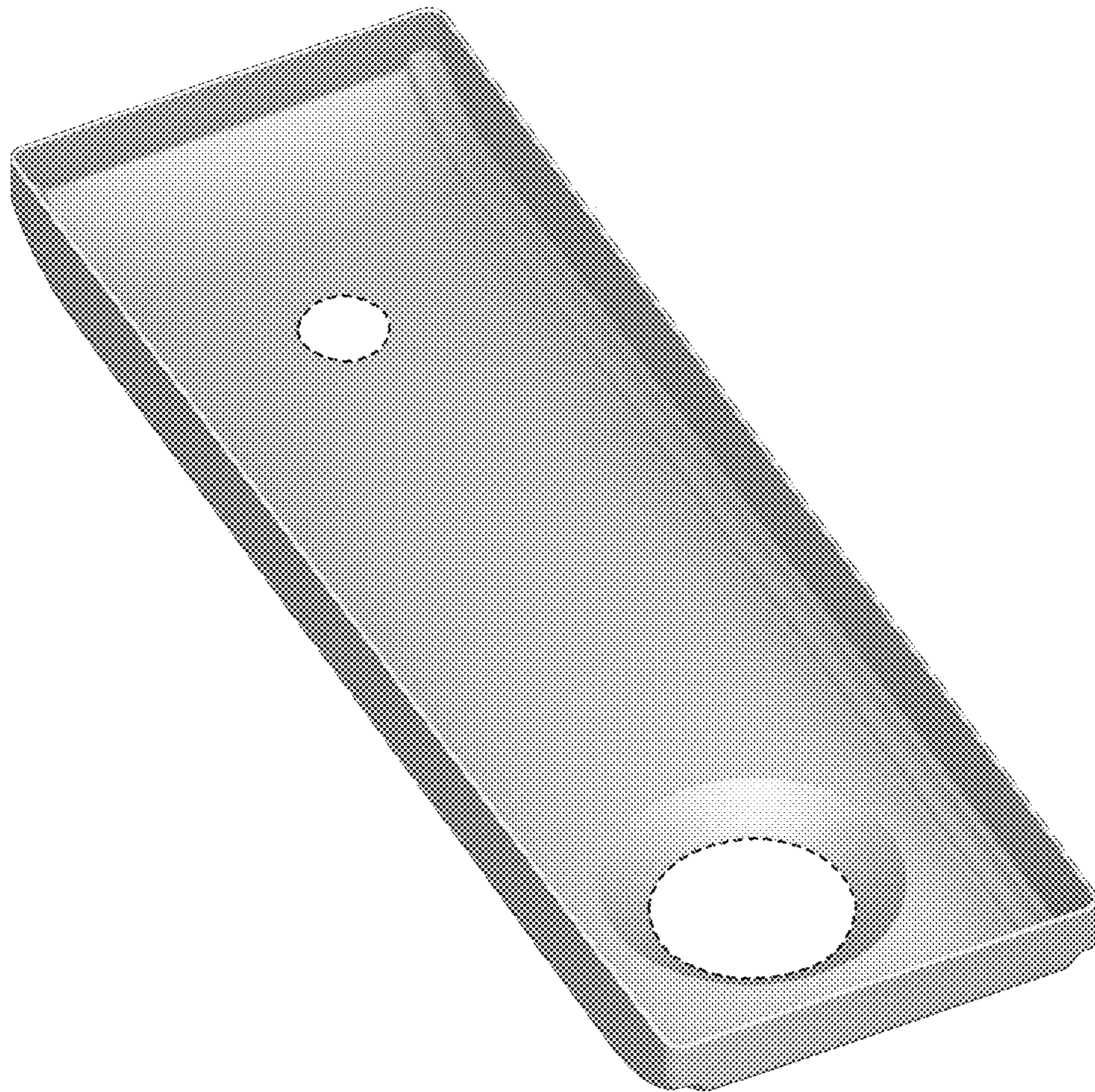
