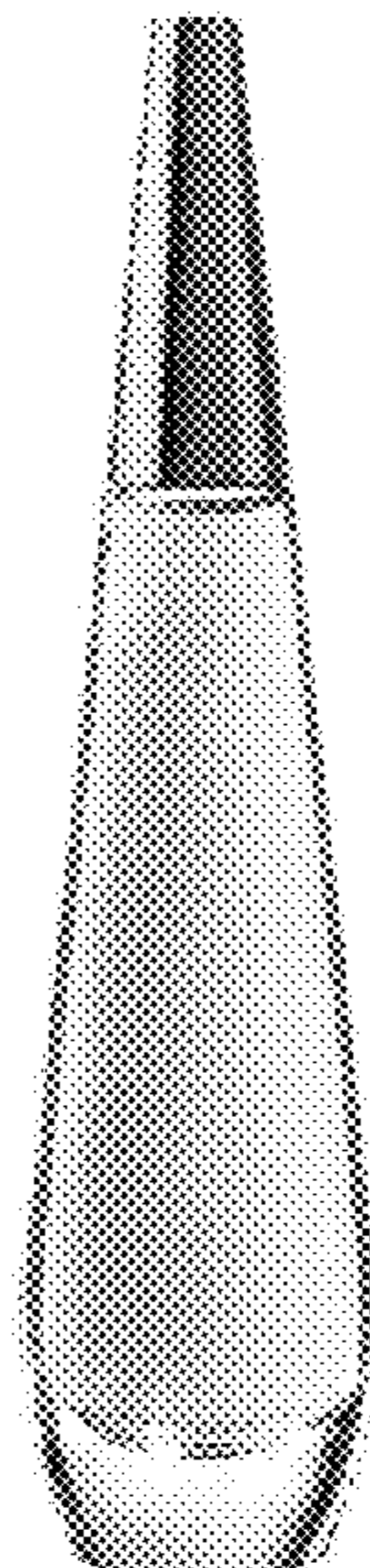
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

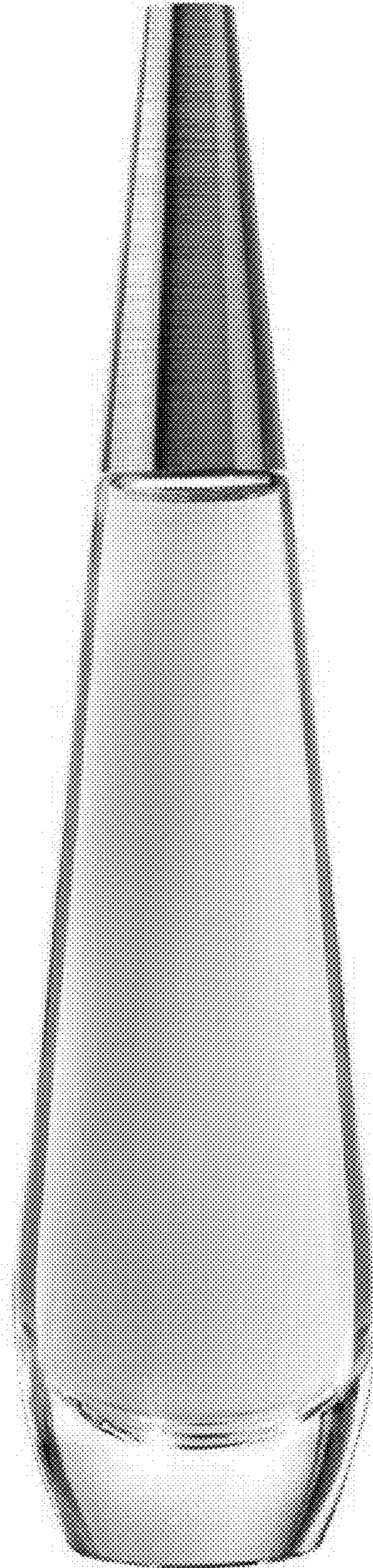
DESCRIPTION

FIG. 1.5 is a bottom view of the bottle.

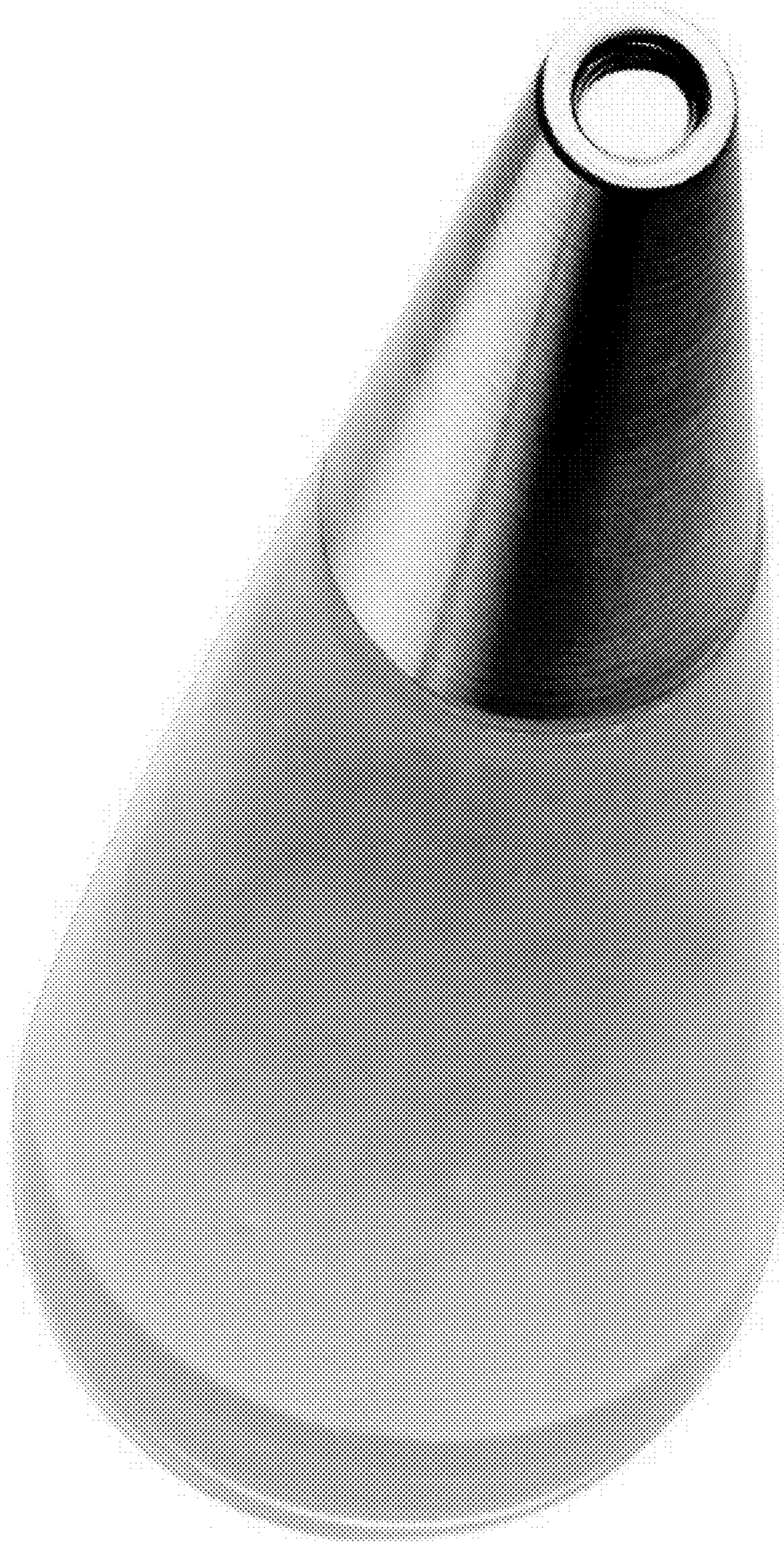
