(57) **CLAIM**

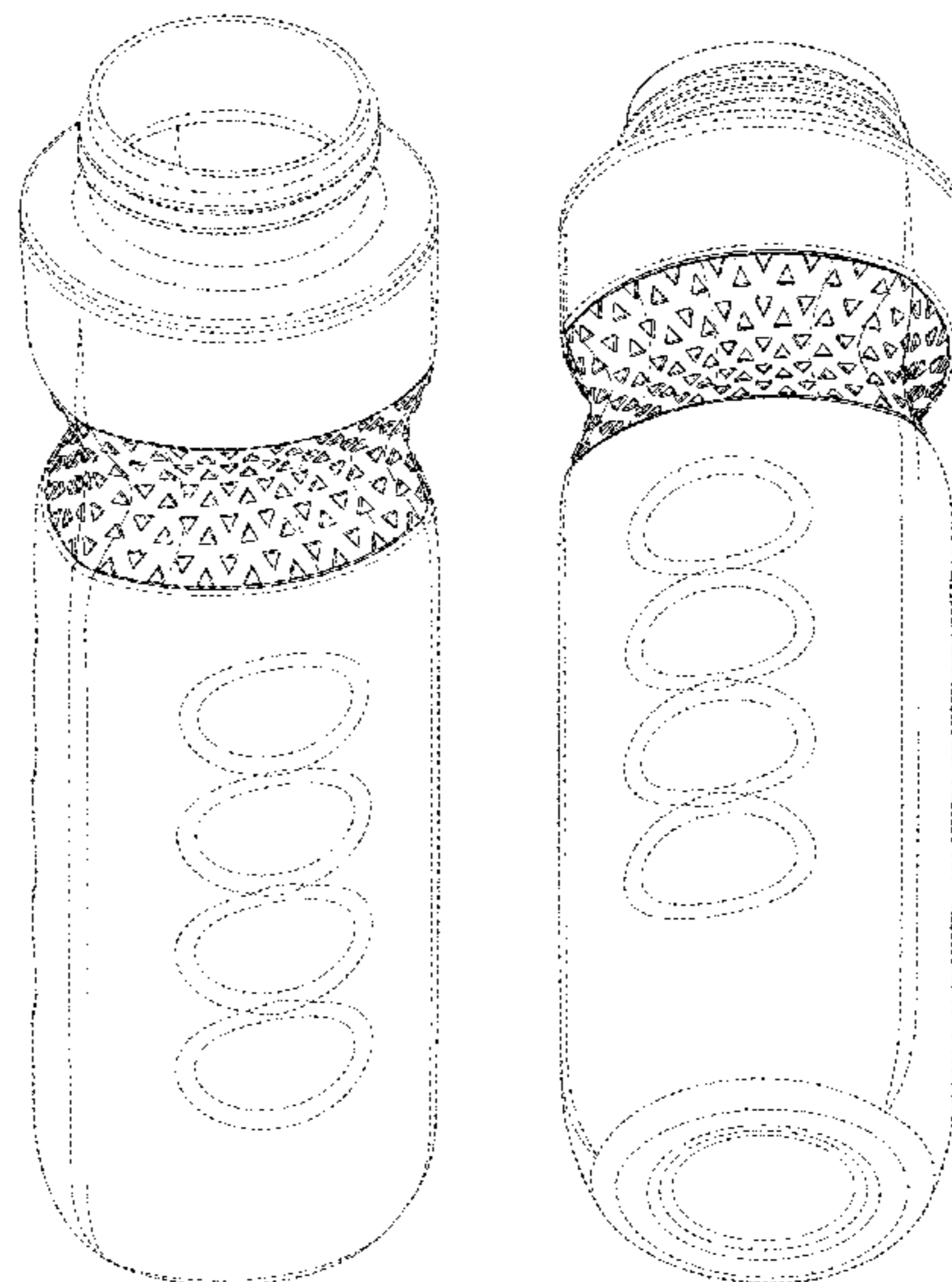
We claim the ornamental design for a decorative band for three sided bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the decorative band for three sided bottle showing our new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a top view thereof; FIG. 8 is a bottom view thereof; and, FIG. 9 is a magnified view of the portion of FIG. 6 identified by the dash-dot broken line.

The dashed broken lines in FIGS. 1-8 depict environmental subject matter only and form no part of the claimed design. The dash-dot broken line in FIG. 6 is included for the sole purpose of identifying a specific portion of the decorative band, the specific portion being depicted in a magnified view in FIG. 9. The dash-dot broken line forms no part of the claimed design.

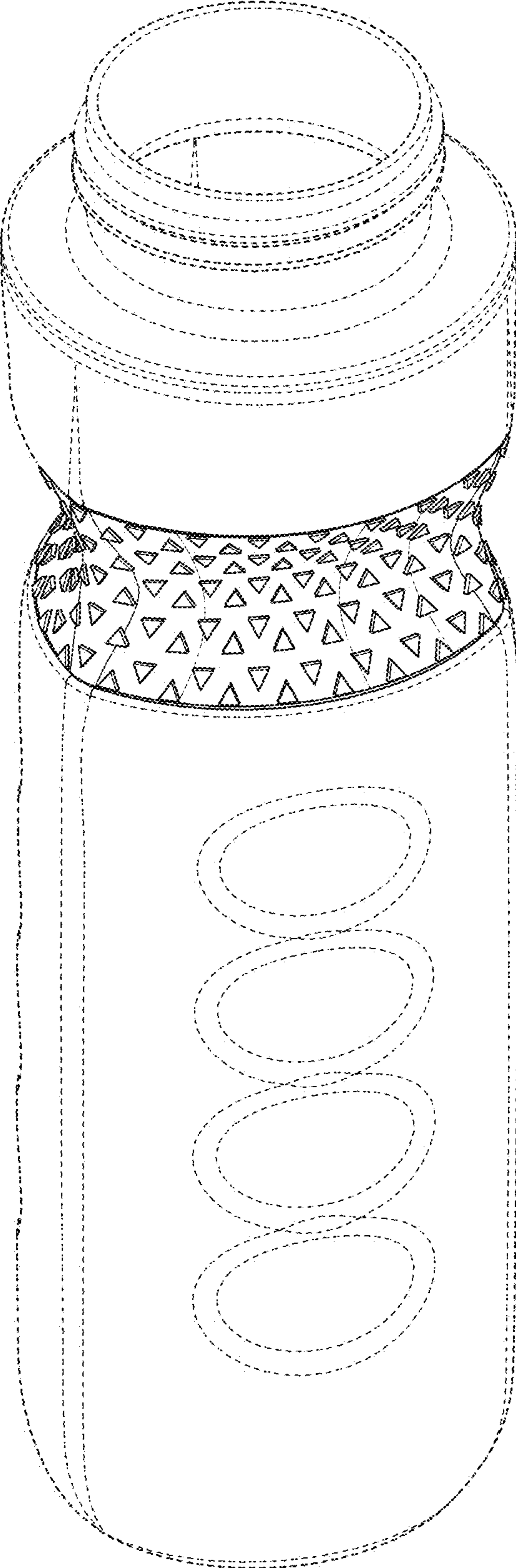

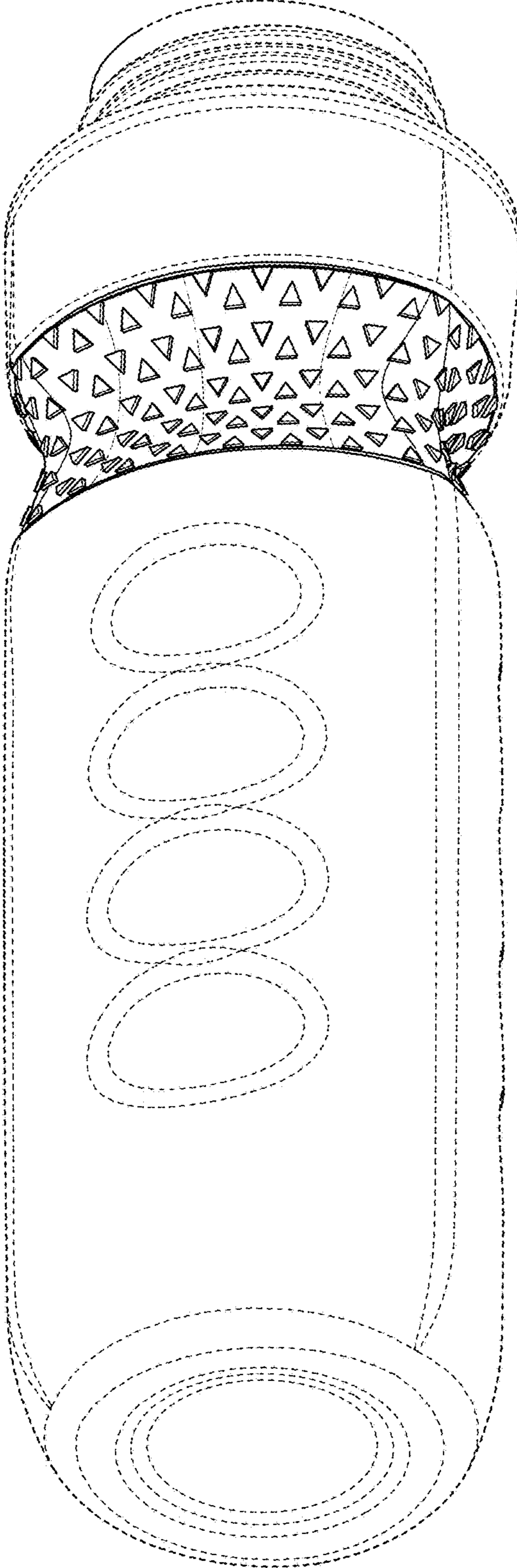

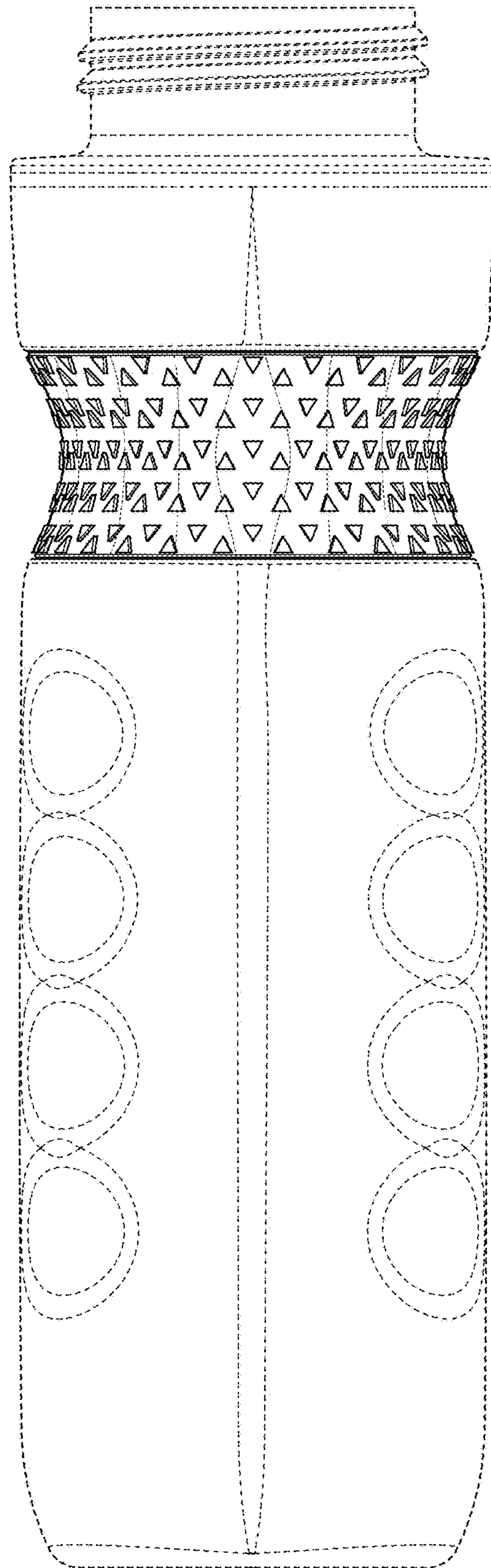

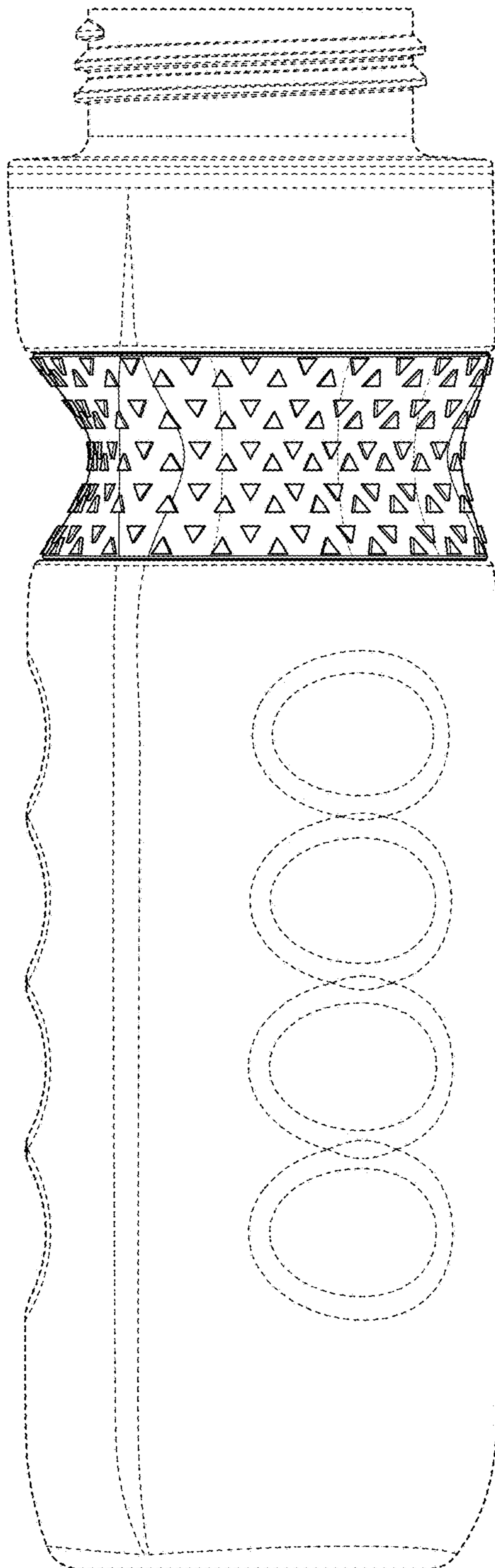

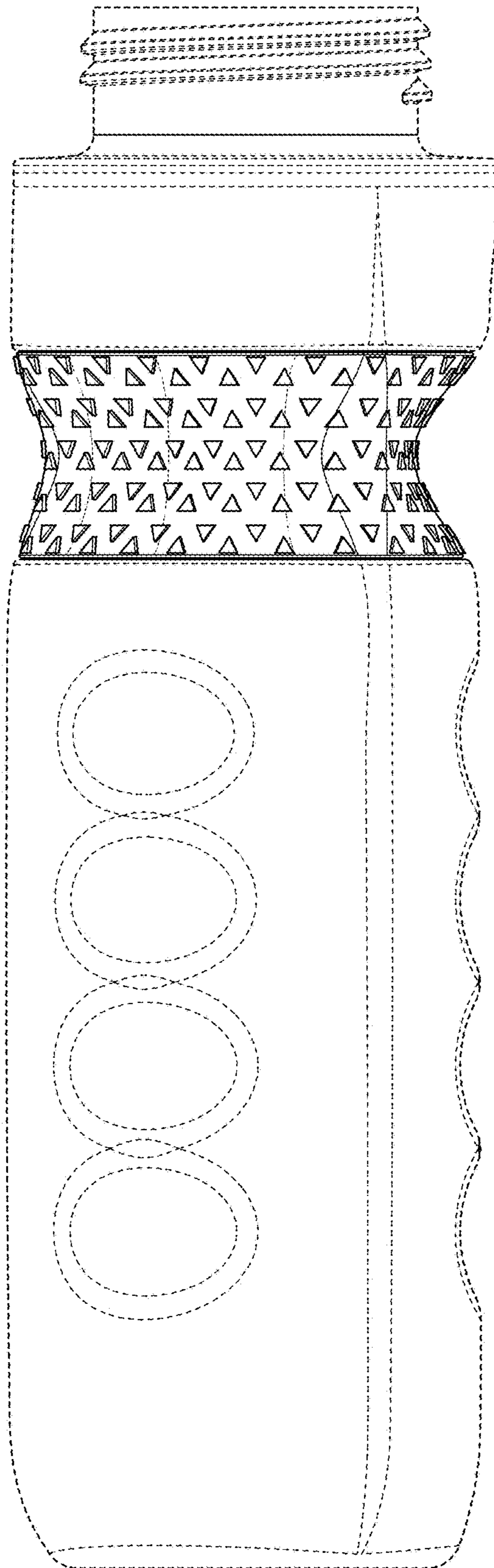

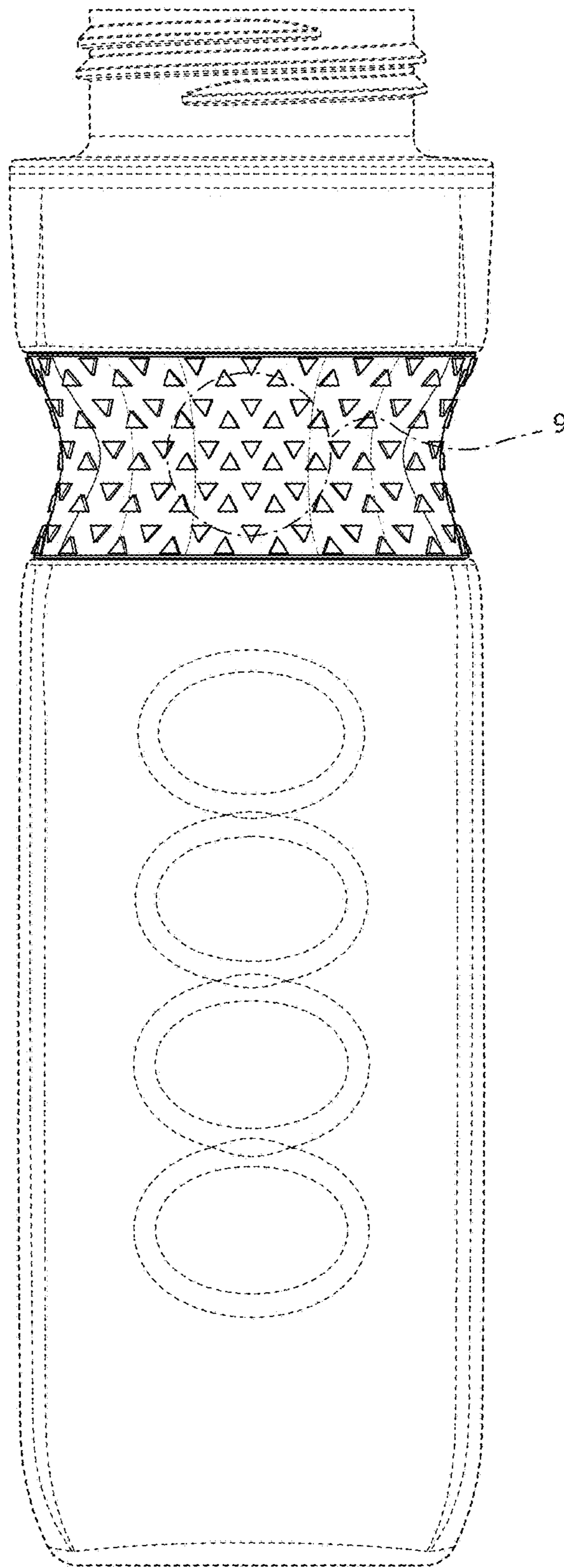

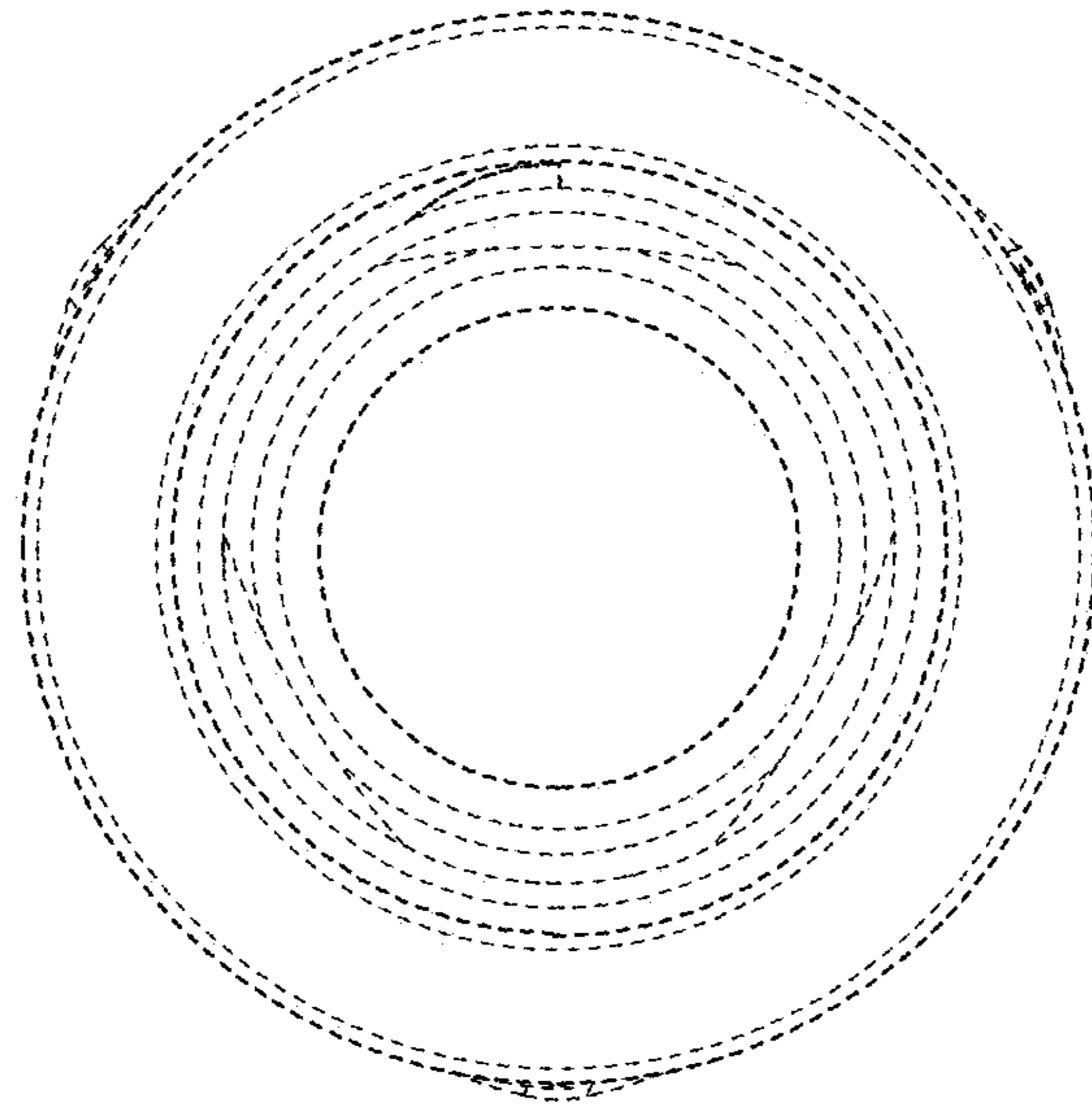

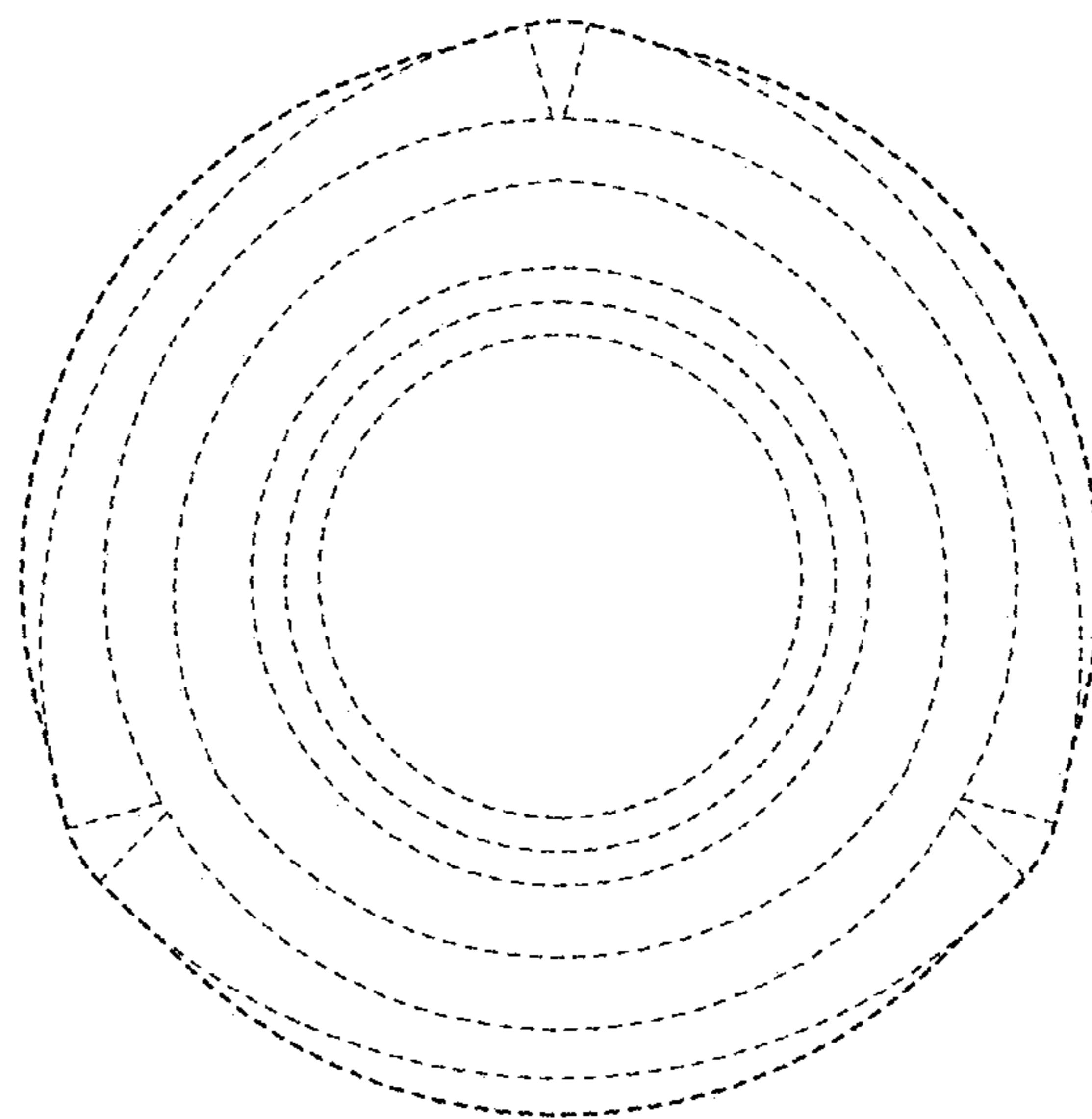

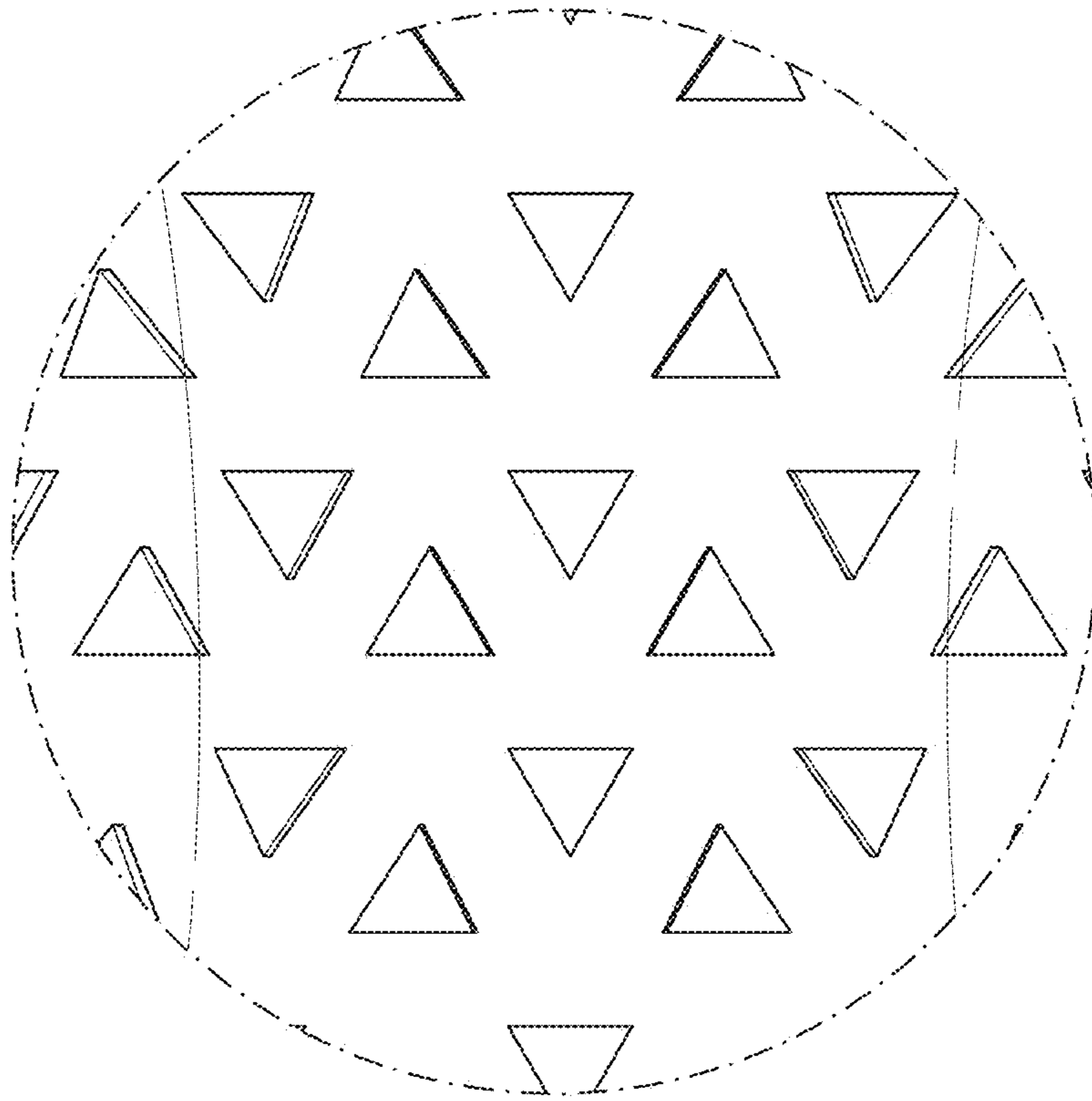
