FIG. 6 is an enlarged front view of the graphical user interface portion thereof.

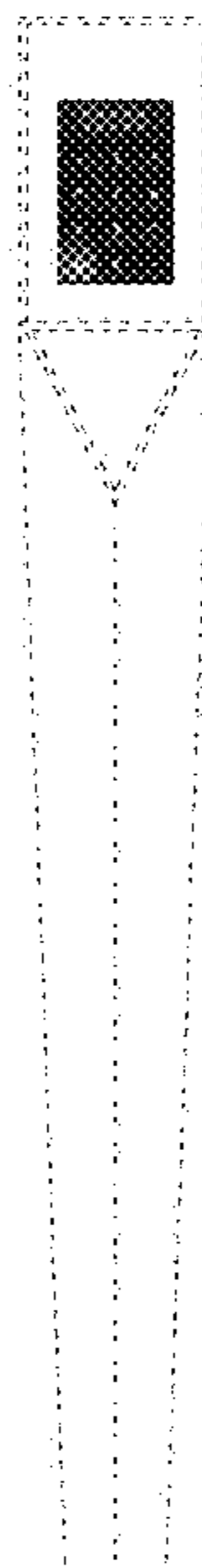
The broken lines in the figures show portions of the elevator control panel with graphical user interface that form no part of the claimed design.

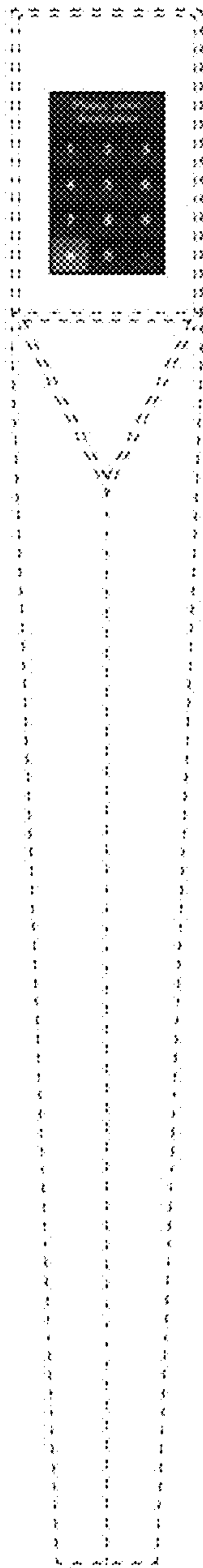

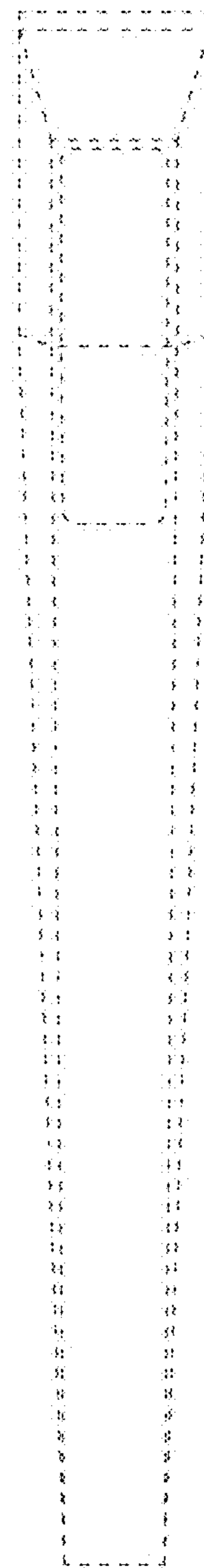

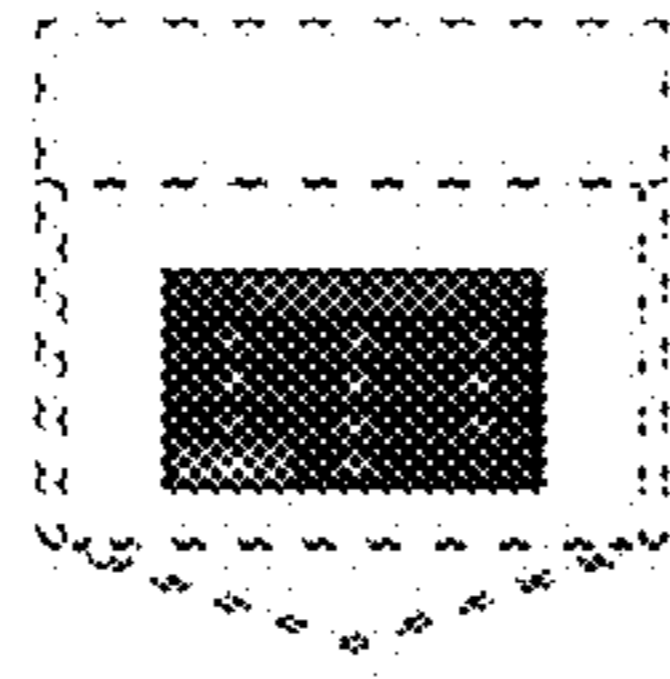

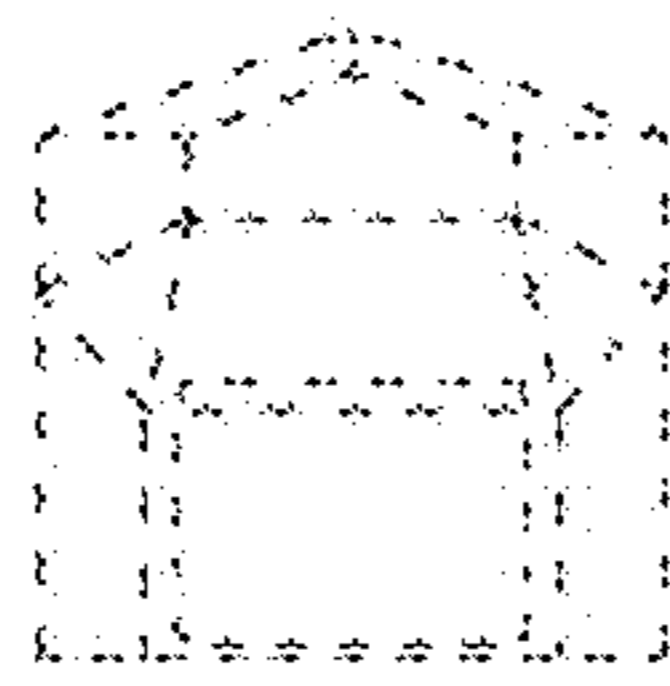

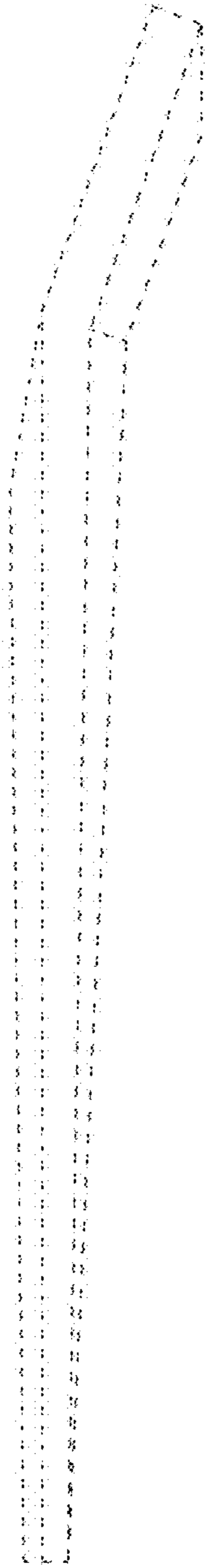

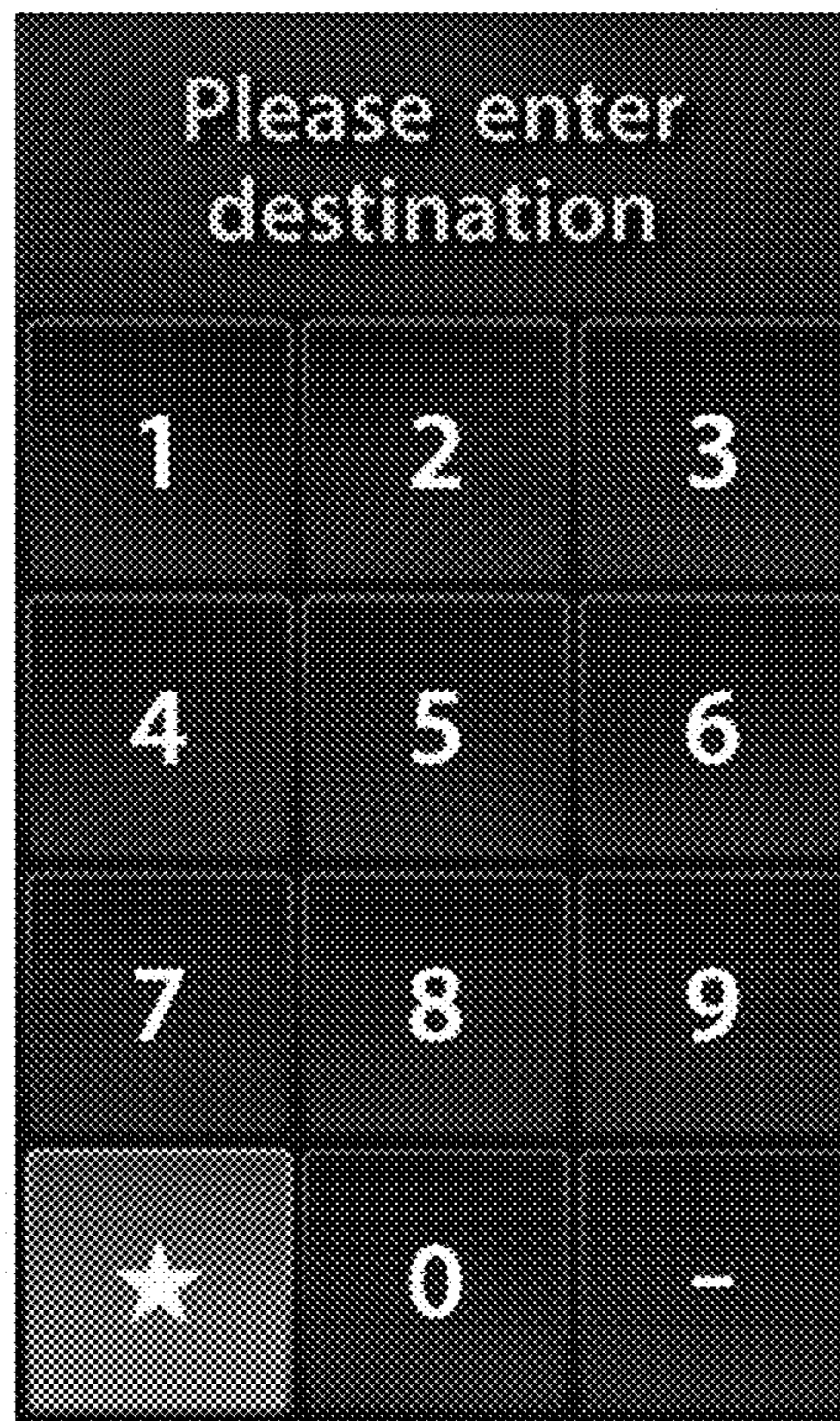
