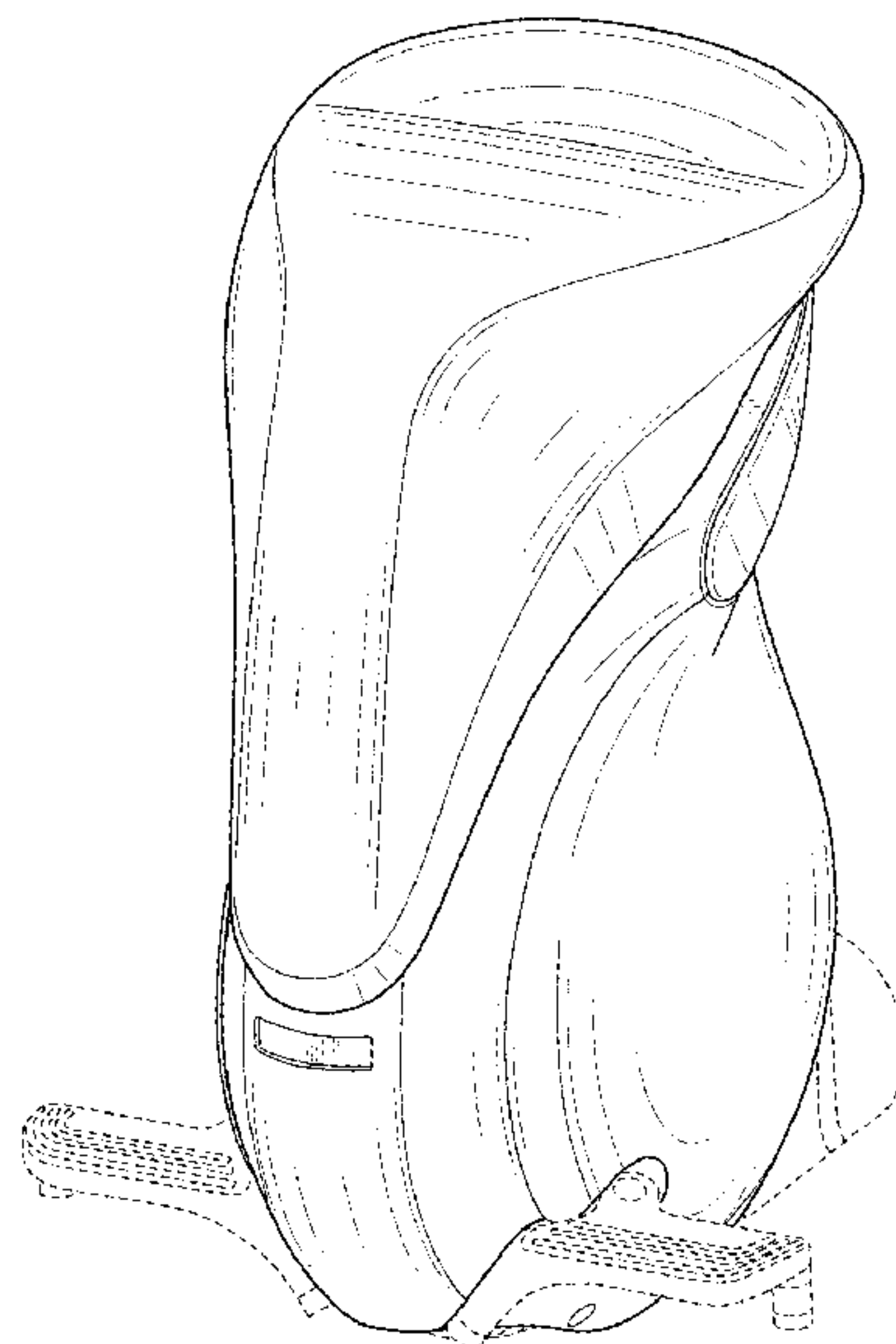
(57) **CLAIM**

The ornamental design for an auto-unicycle with a safety wheel, as shown and described.

DESCRIPTION

FIG. 1 is a front and right-side perspective view of an auto-unicycle with a safety wheel;
FIG. 2 is a rear and right-side perspective view thereof;
FIG. 3 is a front and left-side perspective view thereof;
FIG. 4 is a rear and left-side perspective view thereof;
FIG. 5 is a front elevation view thereof.
FIG. 6 is a rear elevation view thereof.
FIG. 7 is a left side elevation view thereof.
FIG. 8 is a right side elevation view thereof.
FIG. 9 is a top plan view thereof.
FIG. 10 is a bottom plan view thereof.
FIG. 11 is a front and right-side perspective view thereof with the pedals folded away;
FIG. 12 is a rear and right-side perspective view thereof with the pedals folded away;
FIG. 13 is a front and left-side perspective view thereof with the pedals folded away;
FIG. 14 is a rear and left-side perspective view thereof with the pedals folded away;
FIG. 15 is a front elevation view with the pedals folded away.
FIG. 16 is a front perspective view showing use thereof; and,
FIG. 17 is a rear perspective view showing use thereof.

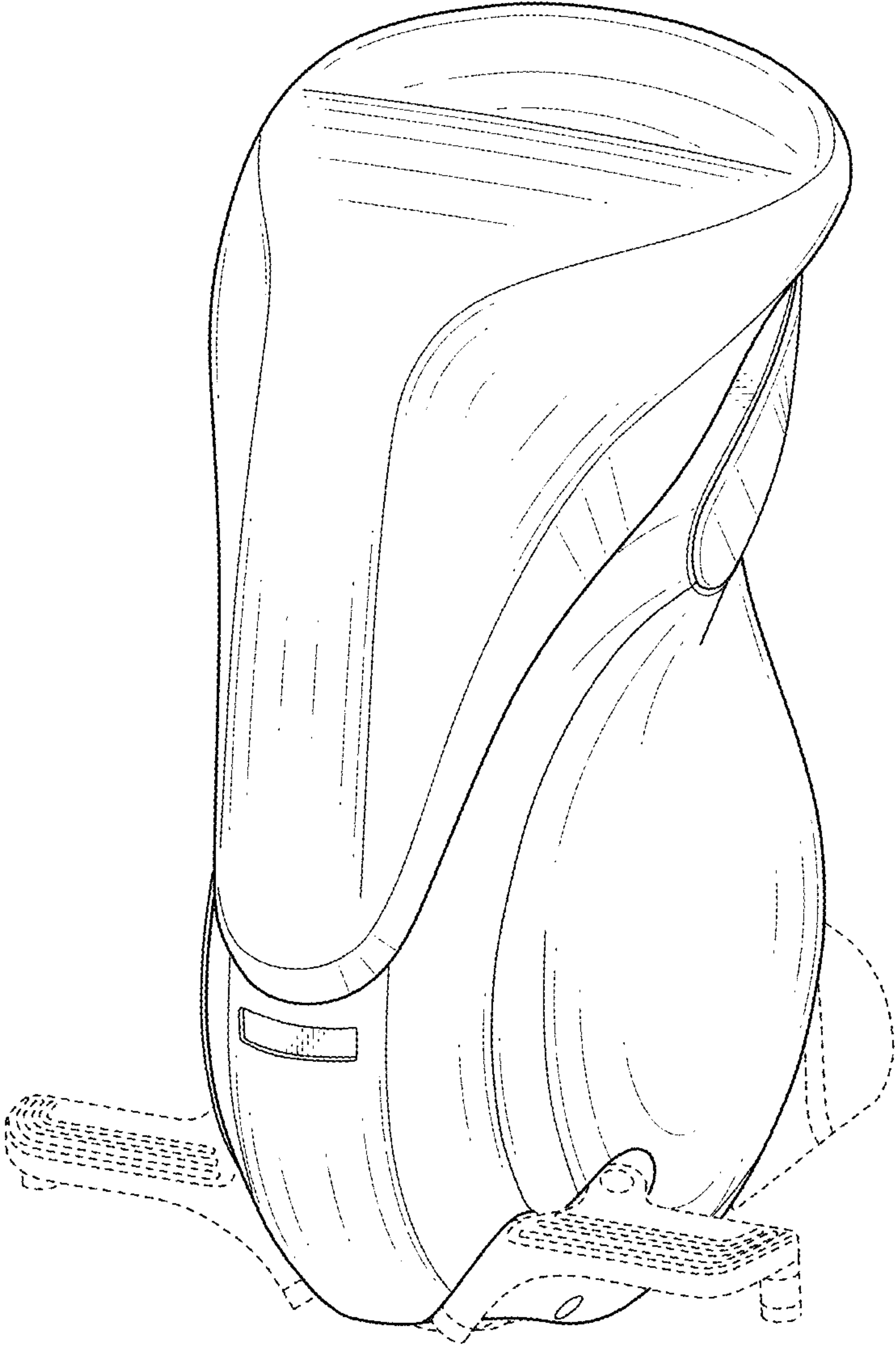

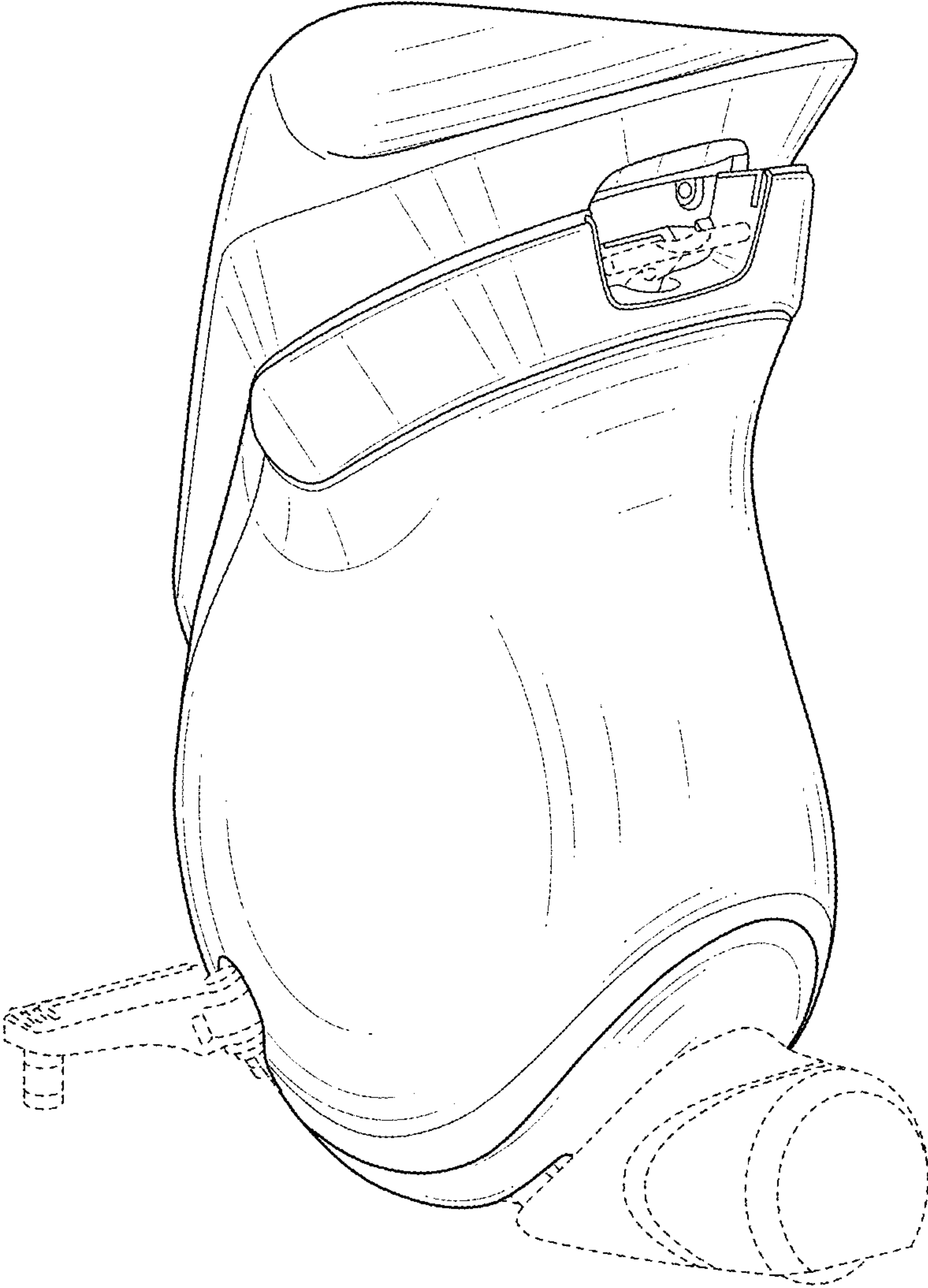

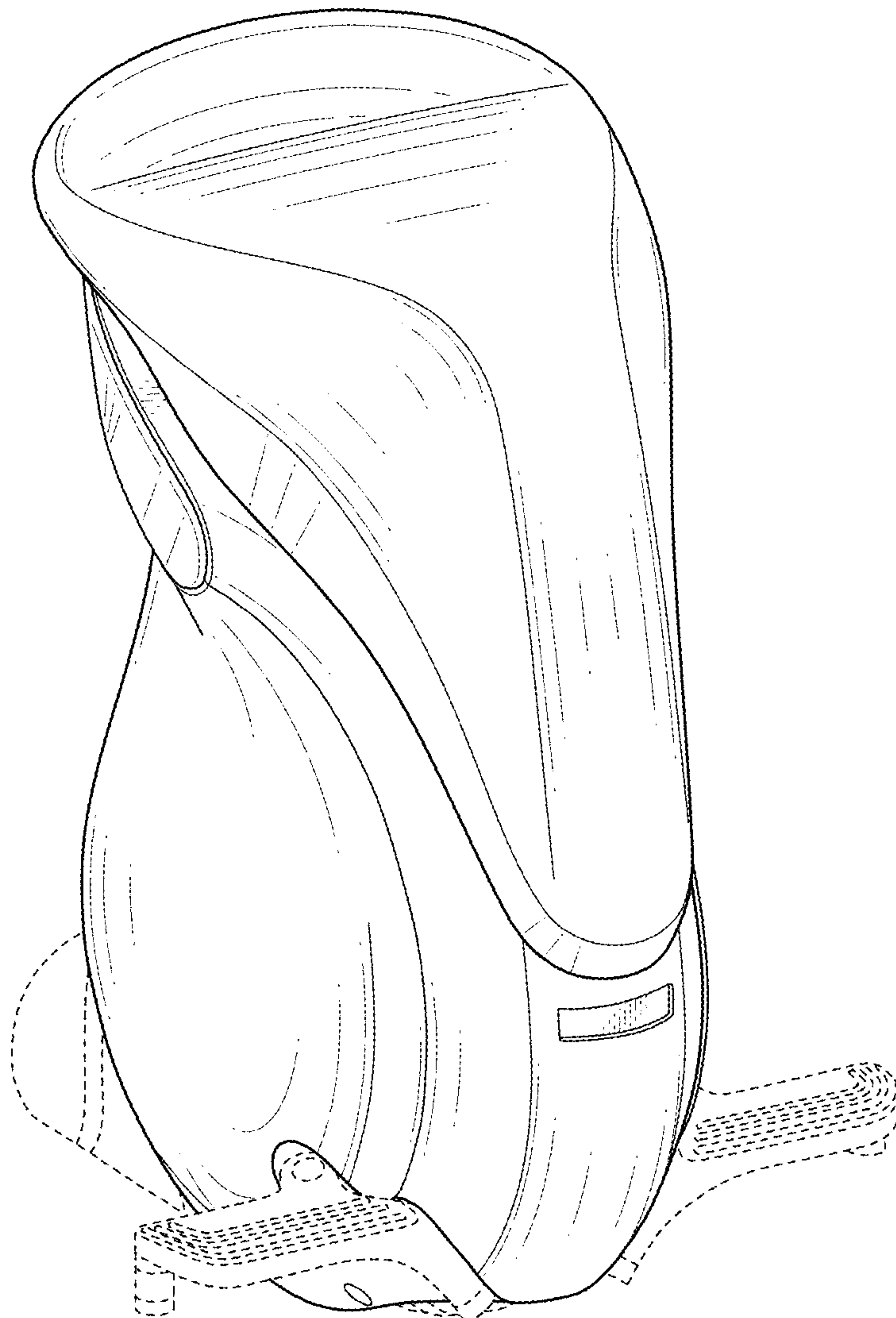

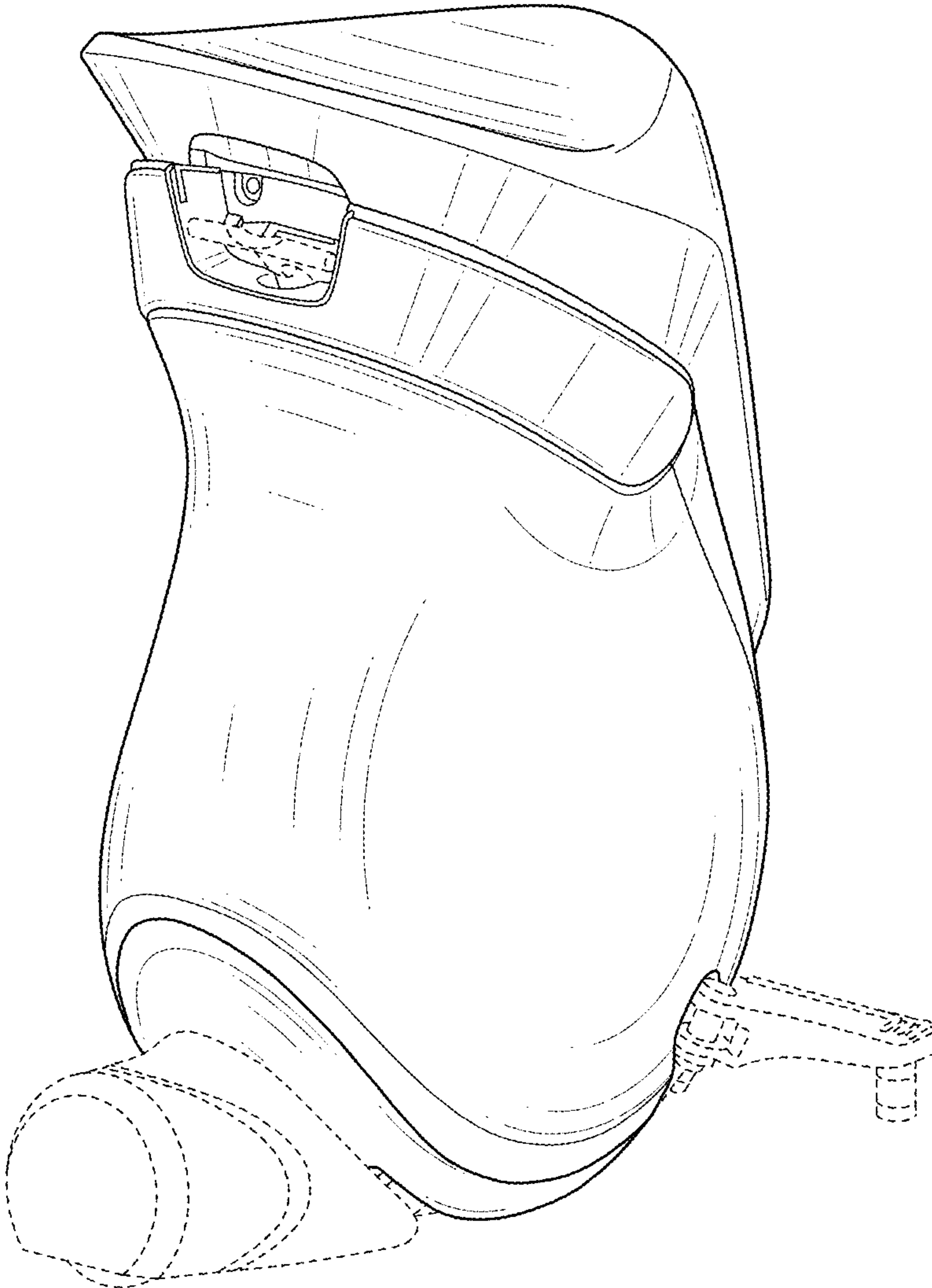

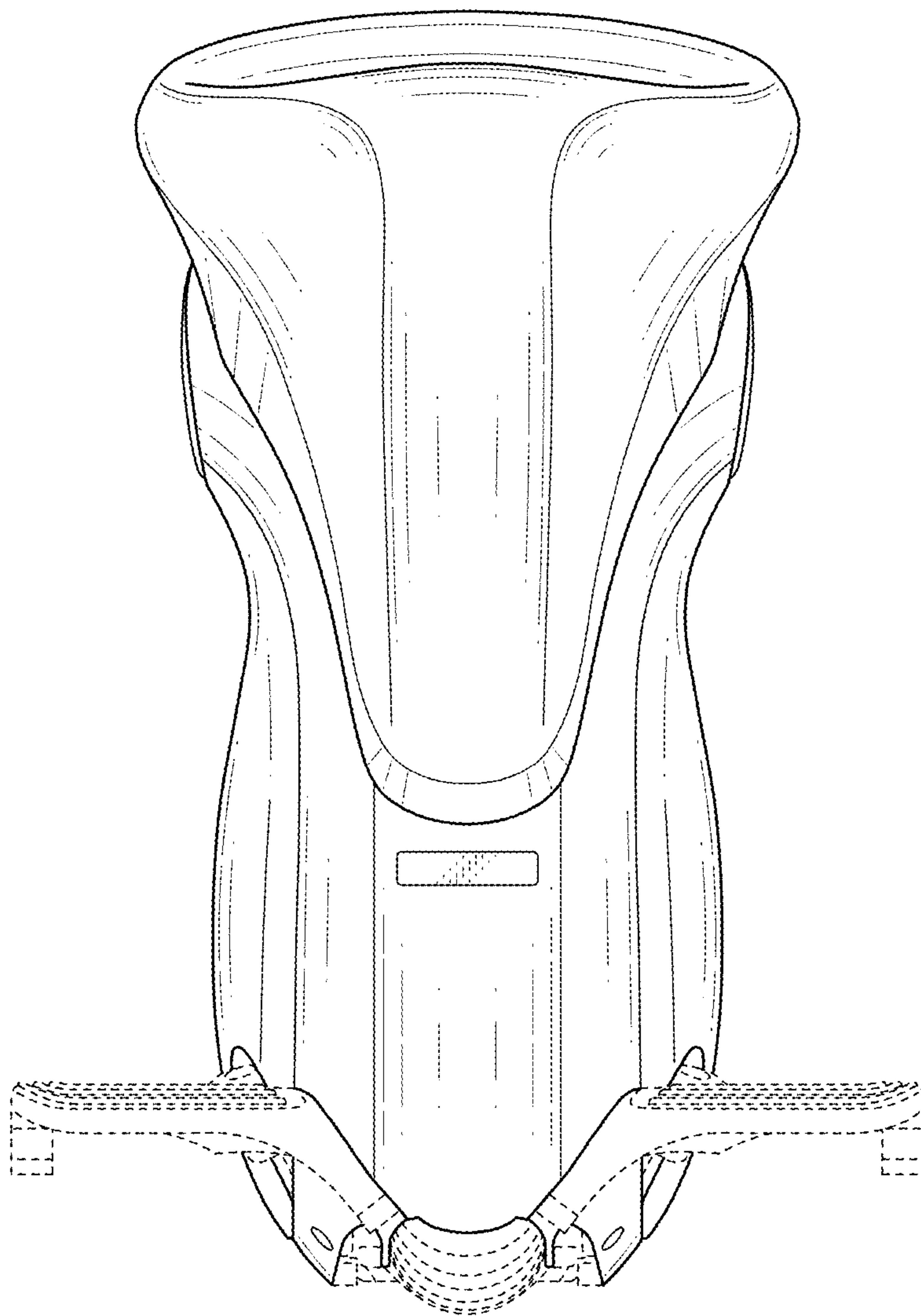

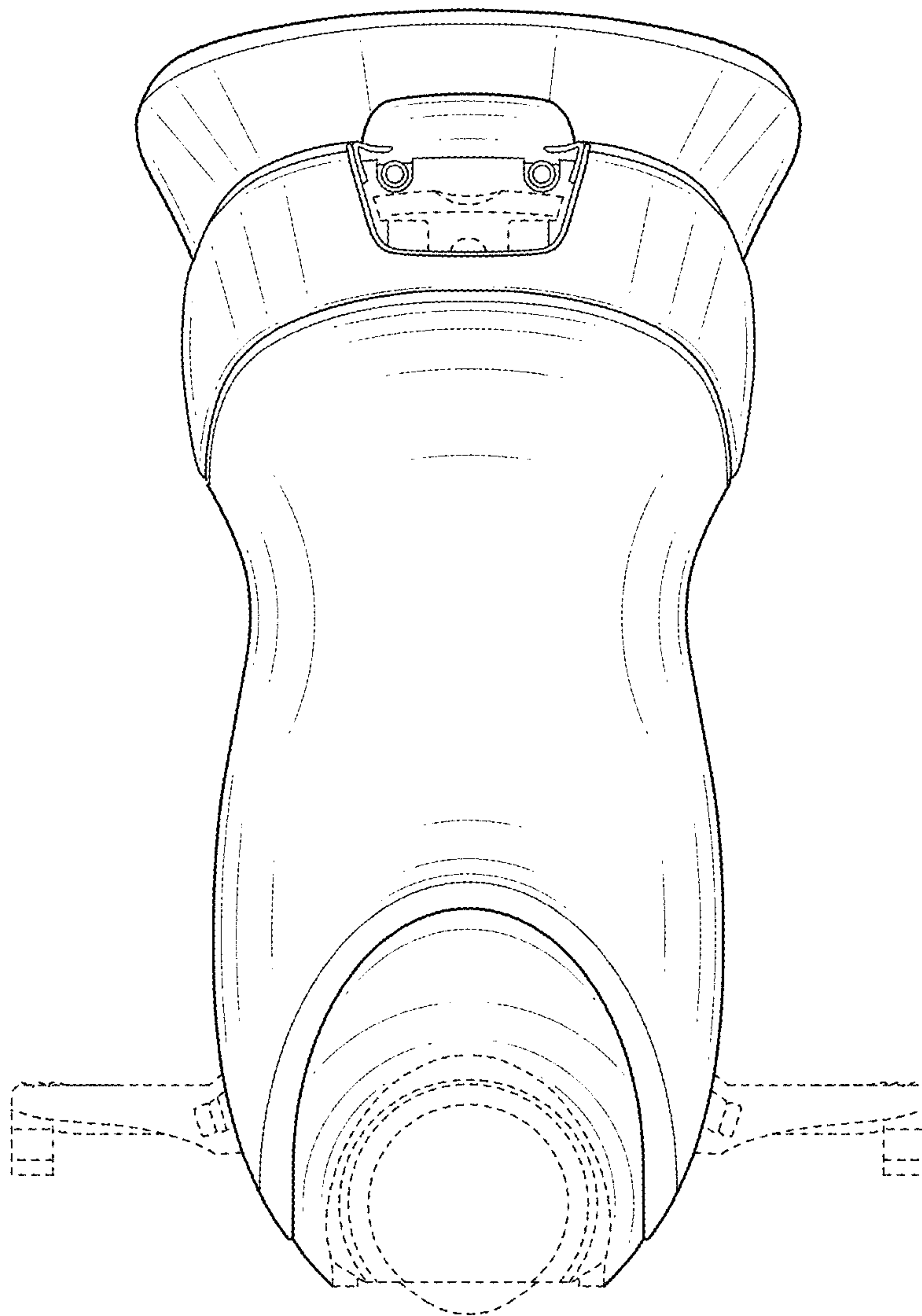

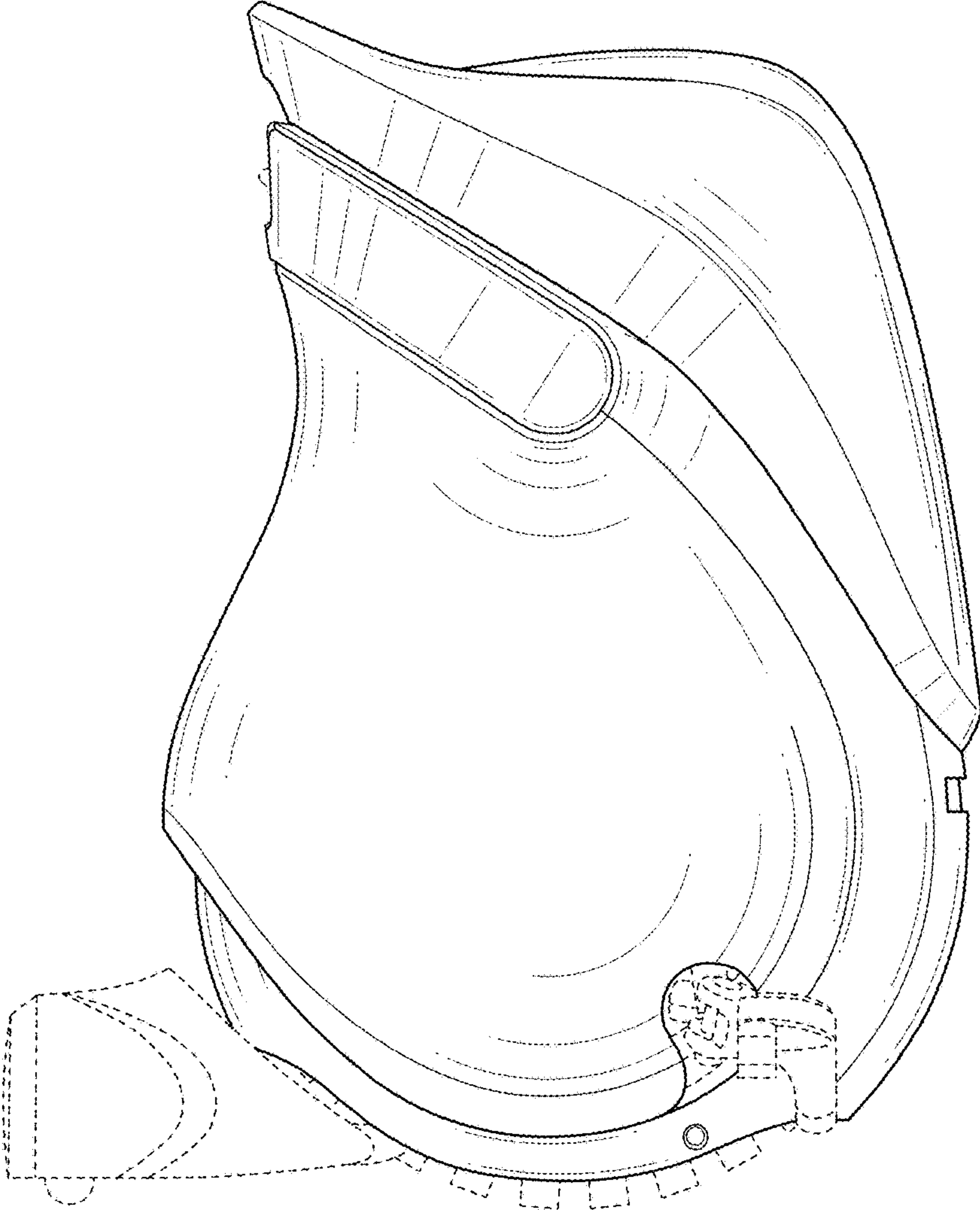

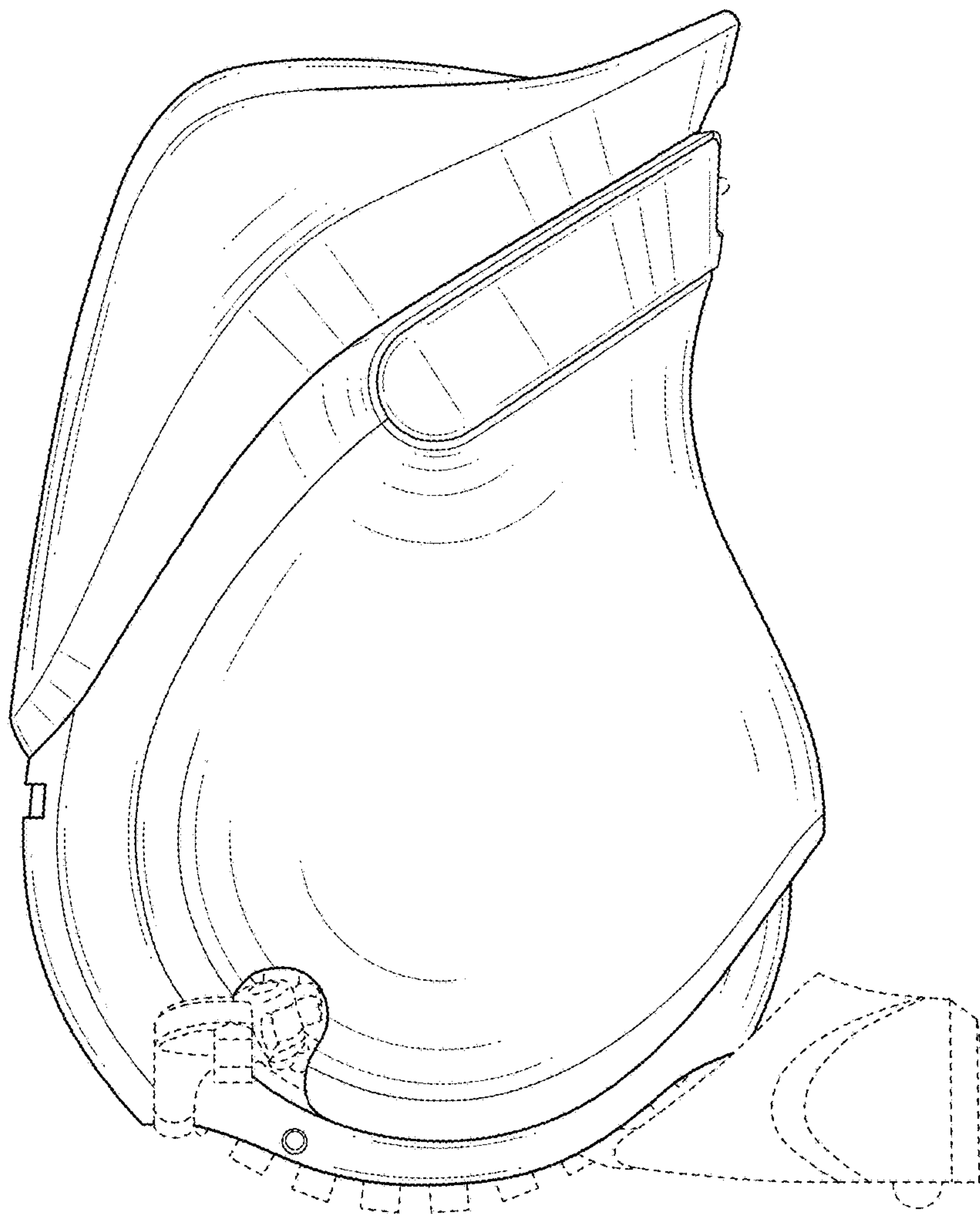

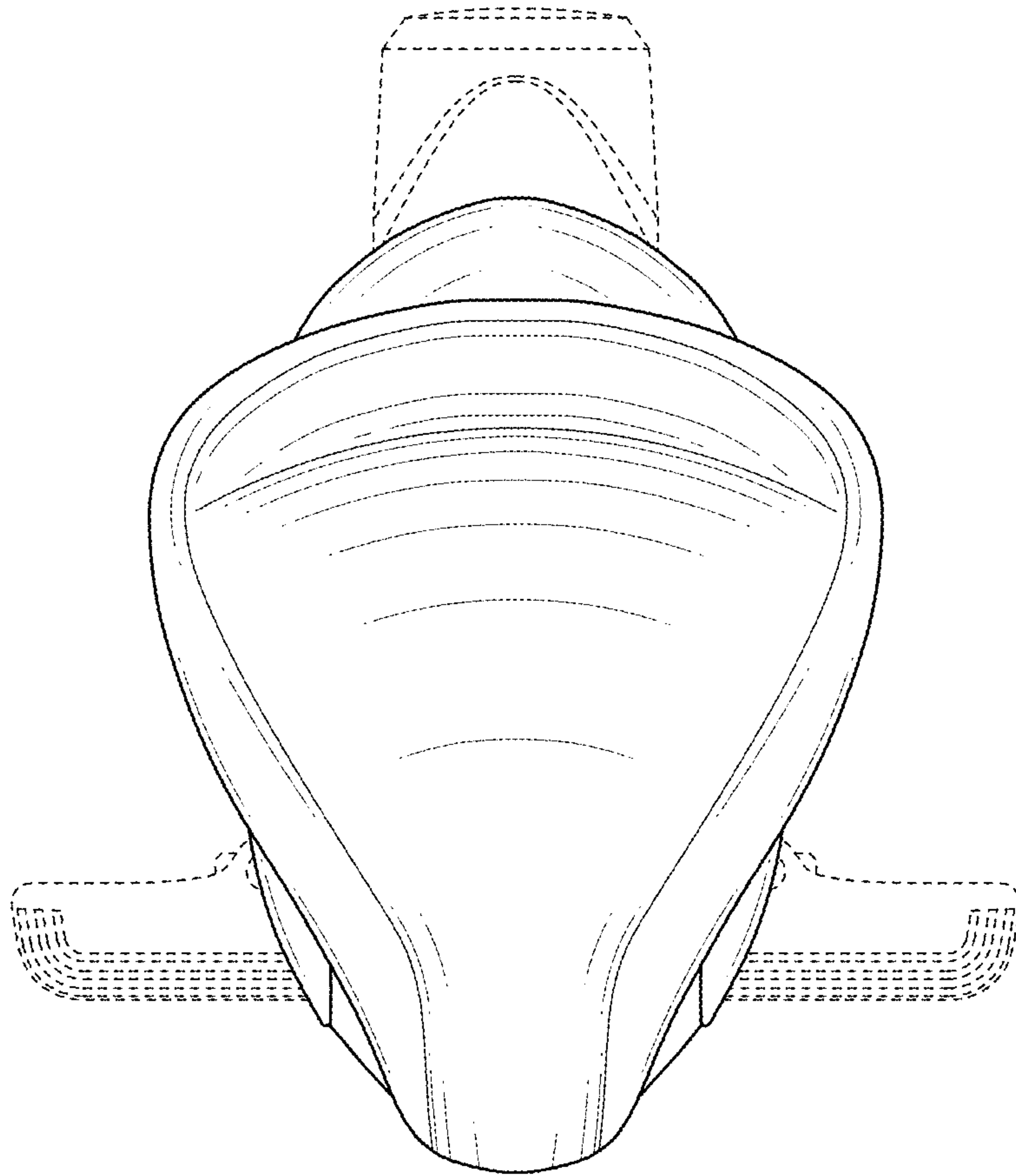

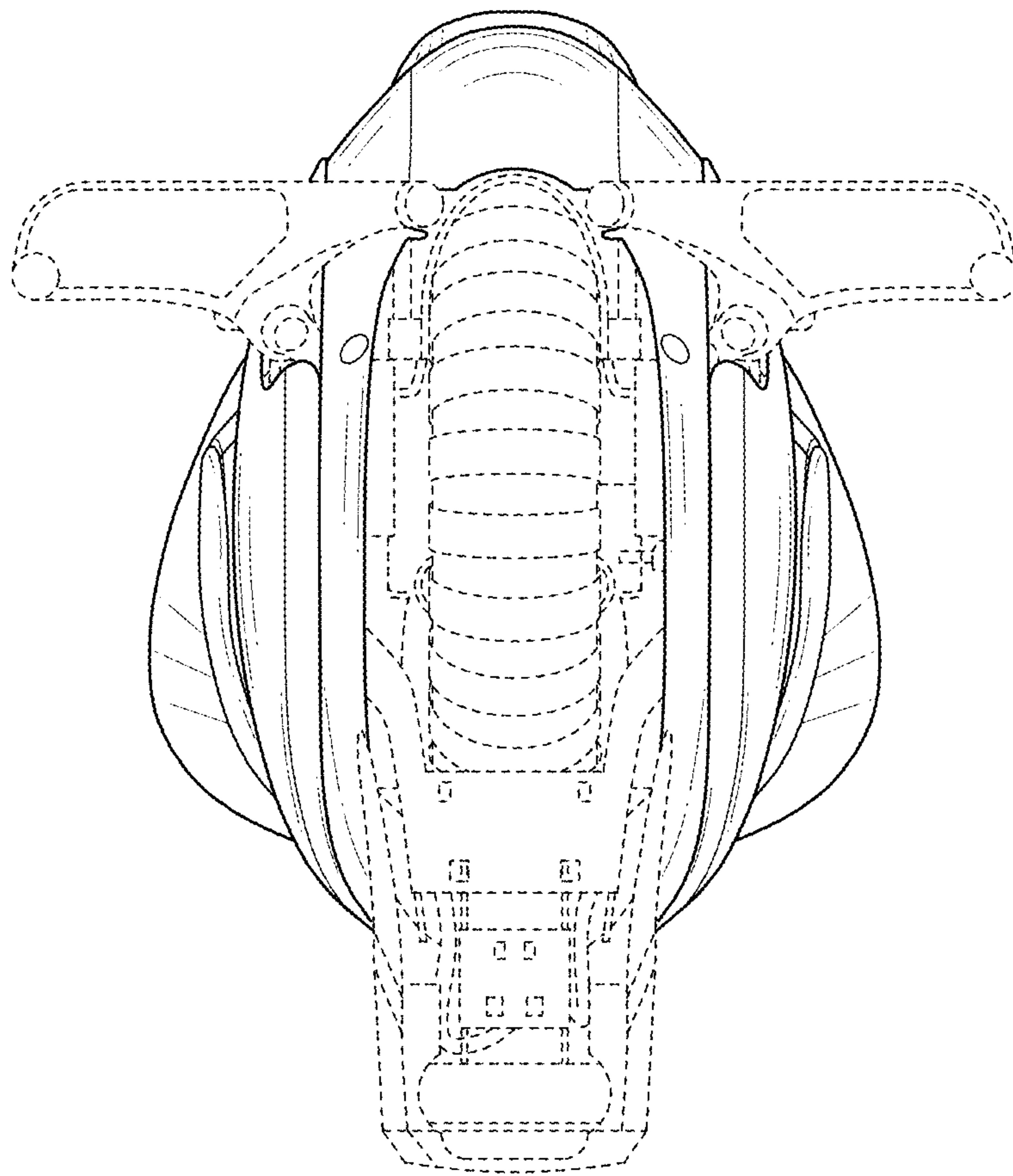

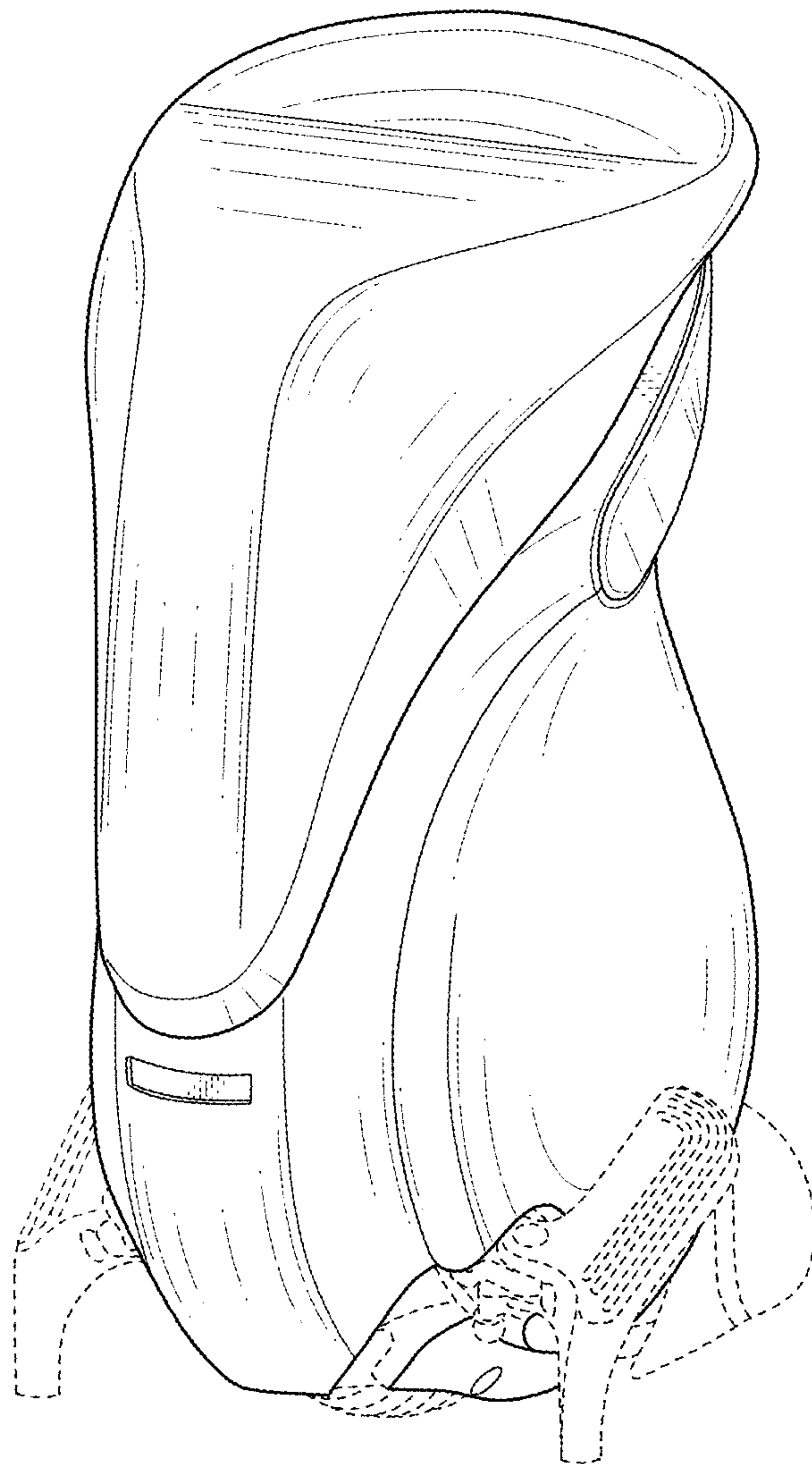

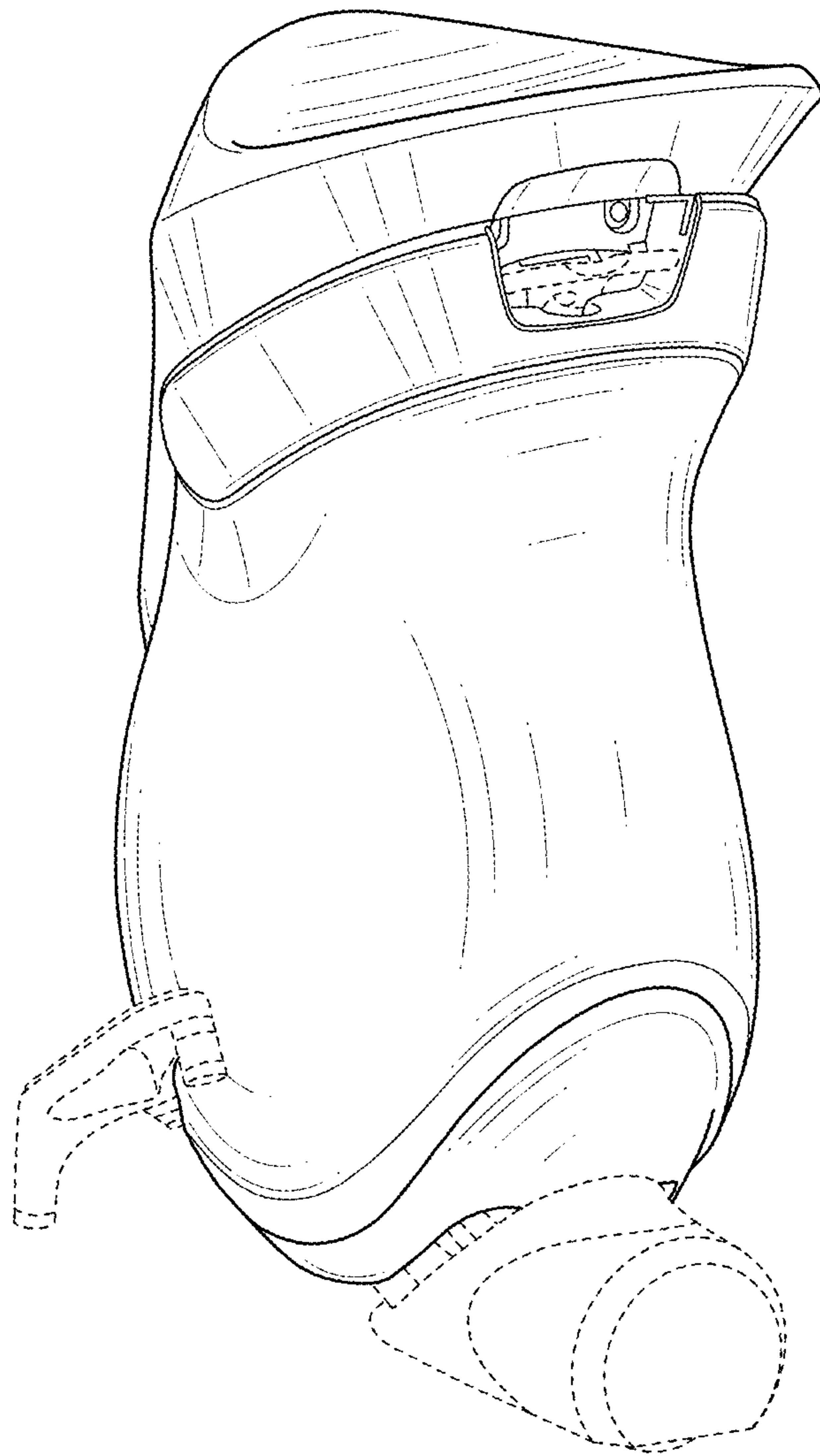

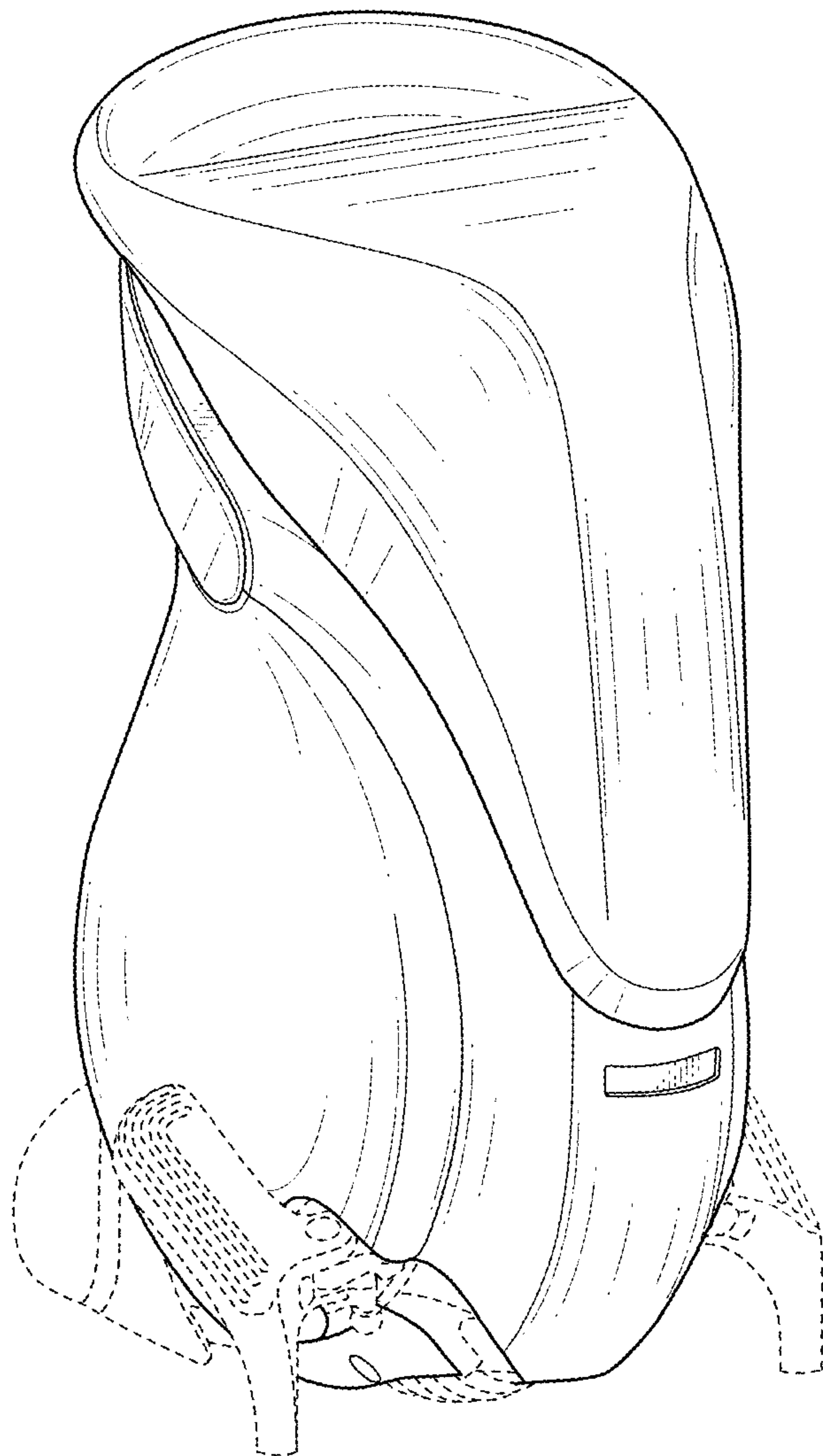

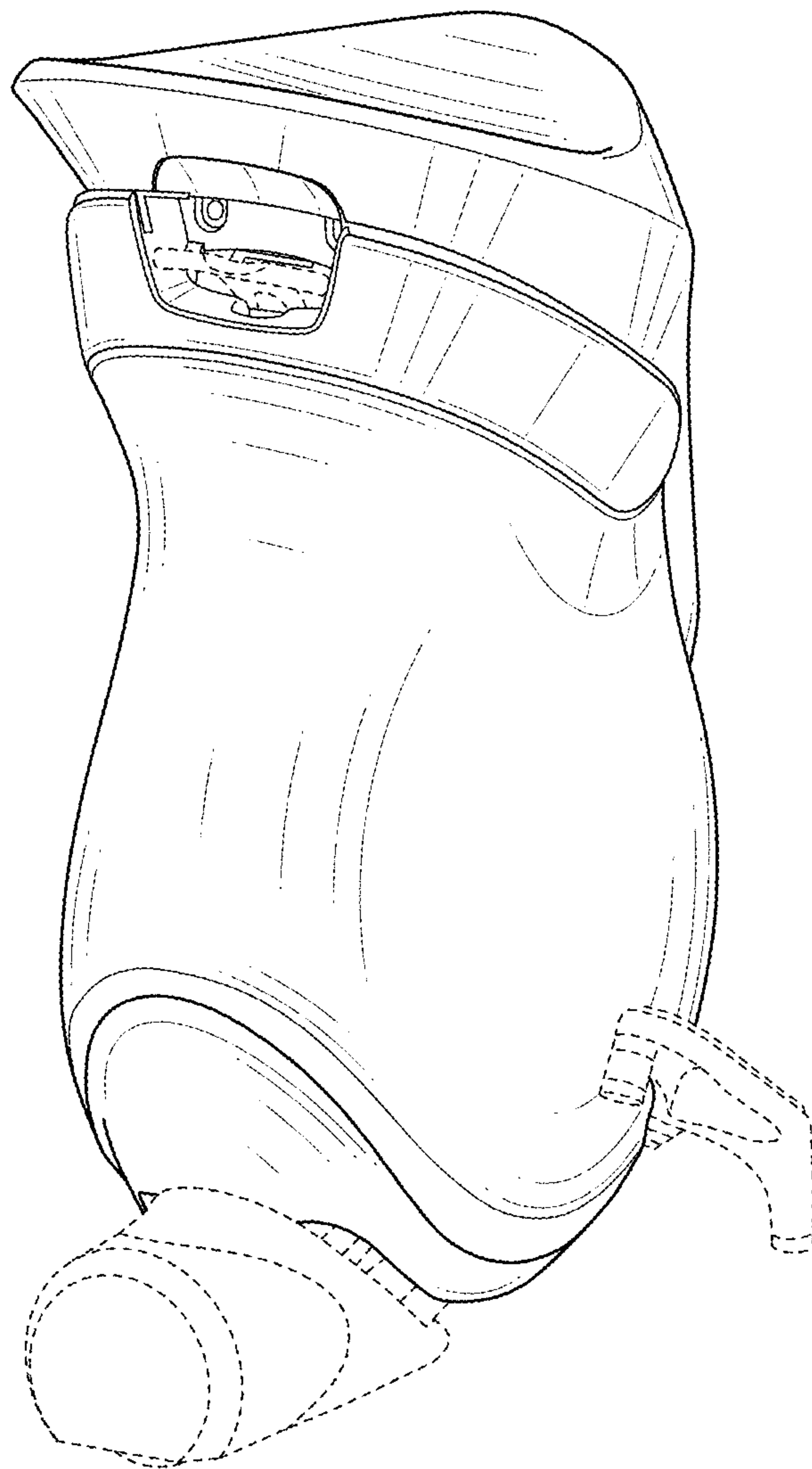

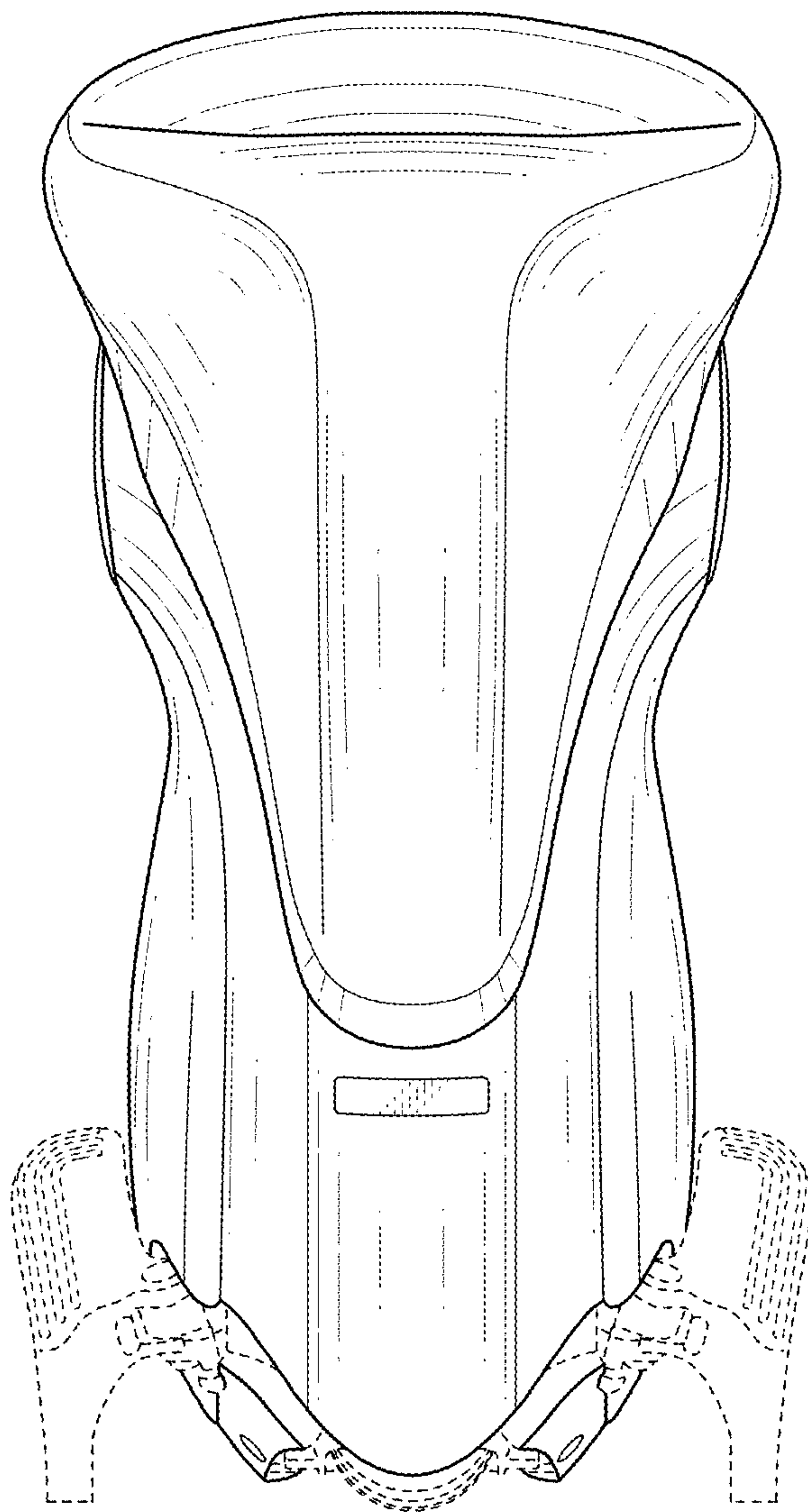

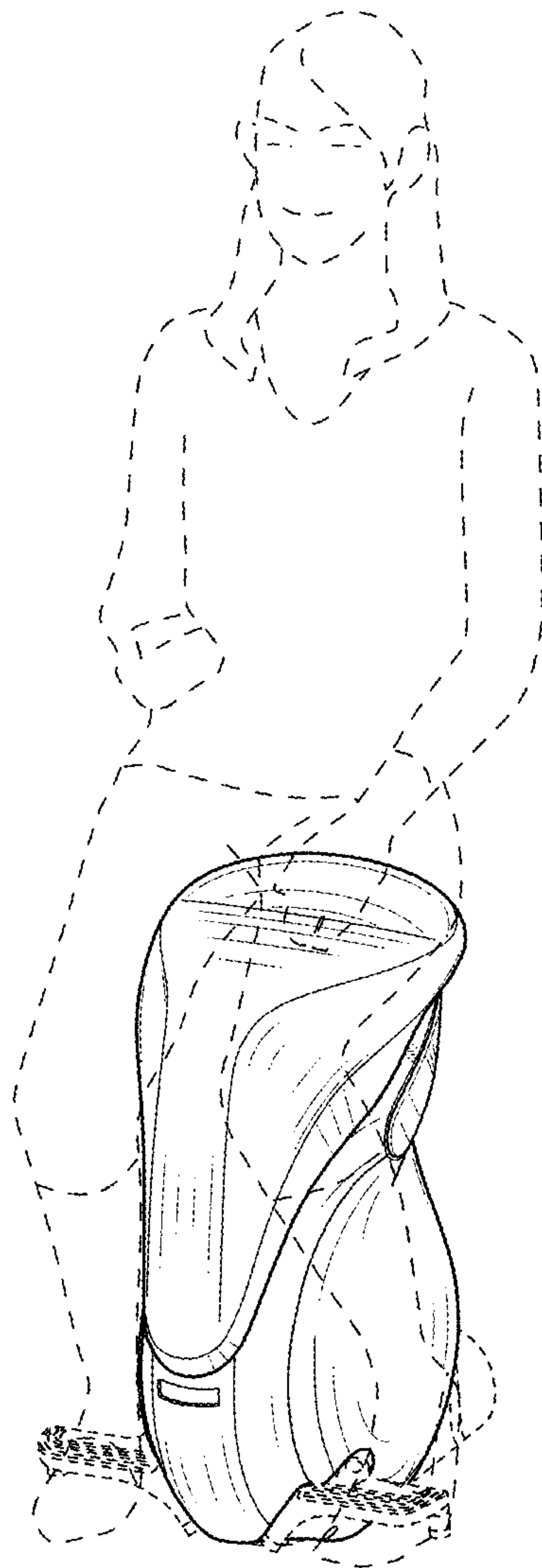
