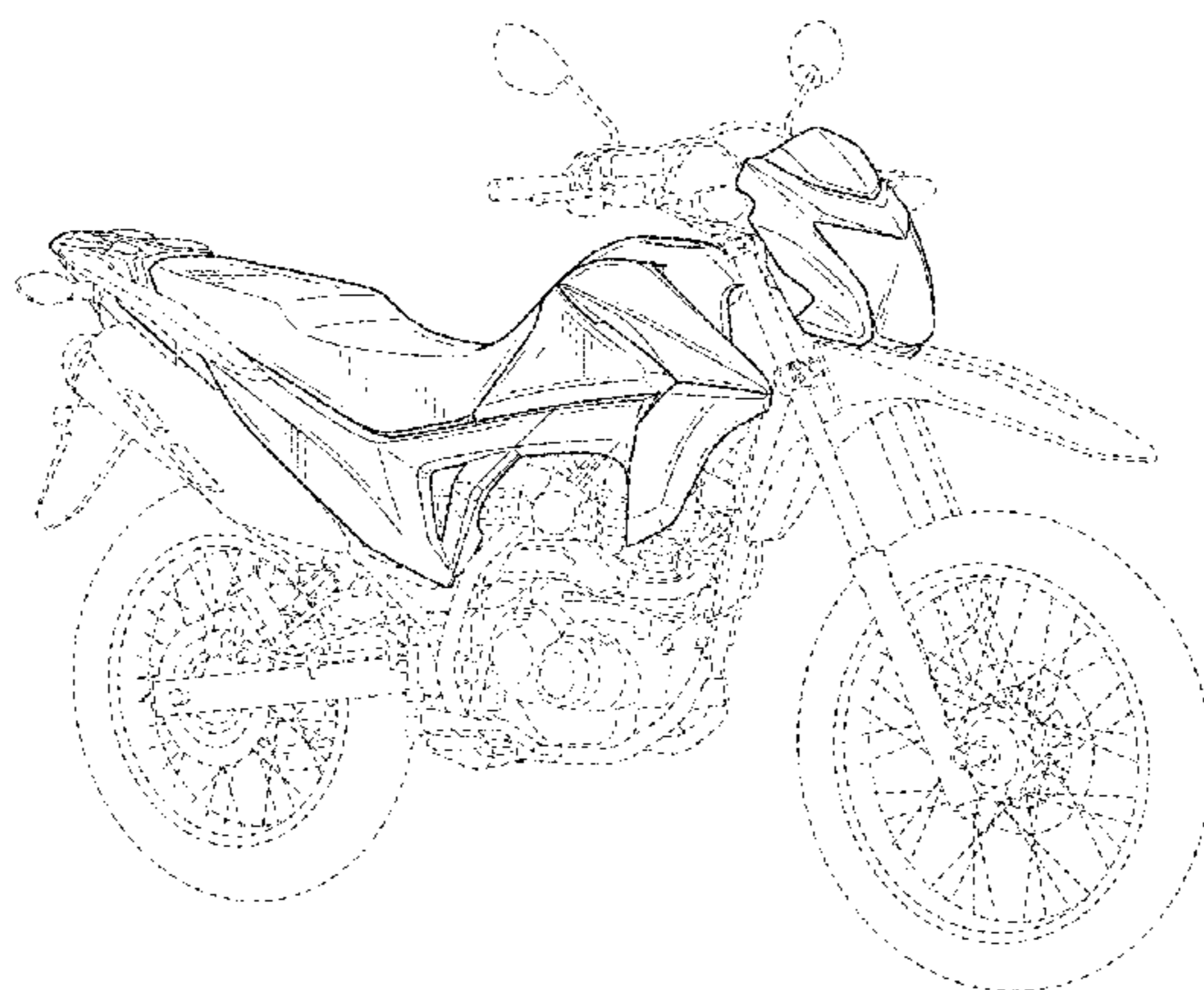
(57) **CLAIM**

The ornamental design for a motorcycle or motorcycle replica, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front and left side of a motorcycle or motorcycle replica;
FIG. 2 is a perspective view from the rear and left side thereof;
FIG. 3 is a perspective view from the front and right side thereof;
FIG. 4 is a perspective view from the rear and right side thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a right side elevation view thereof;
FIG. 7 is a front elevation view thereof;
FIG. 8 is a rear elevation view thereof;
FIG. 9 is a top plan view thereof;
FIG. 10 is a bottom plan view thereof;
FIG. 11 is an enlarged perspective view from the rear and left side thereof; and,
FIG. 12 is an enlarged perspective view of from the rear and right side thereof.

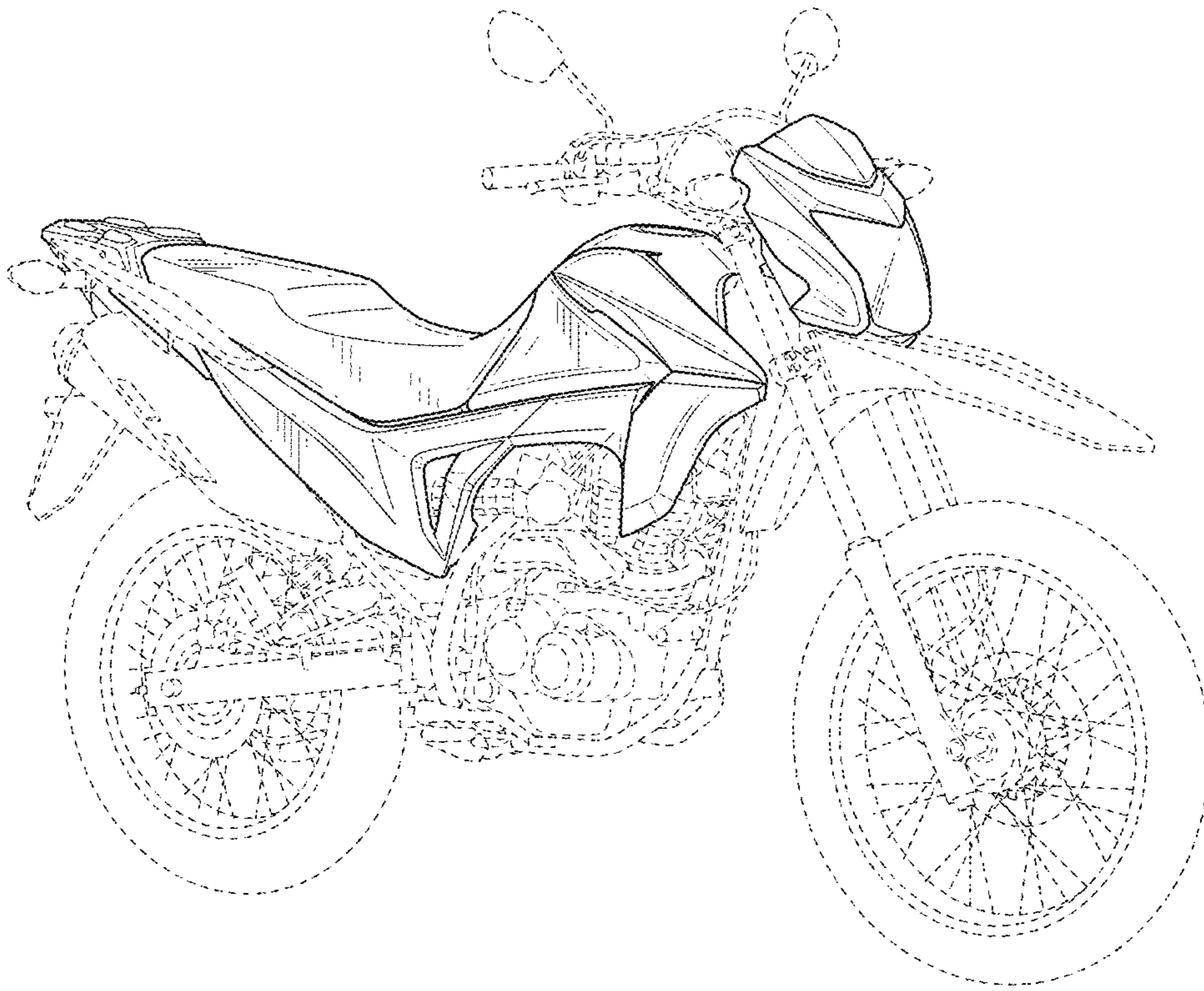

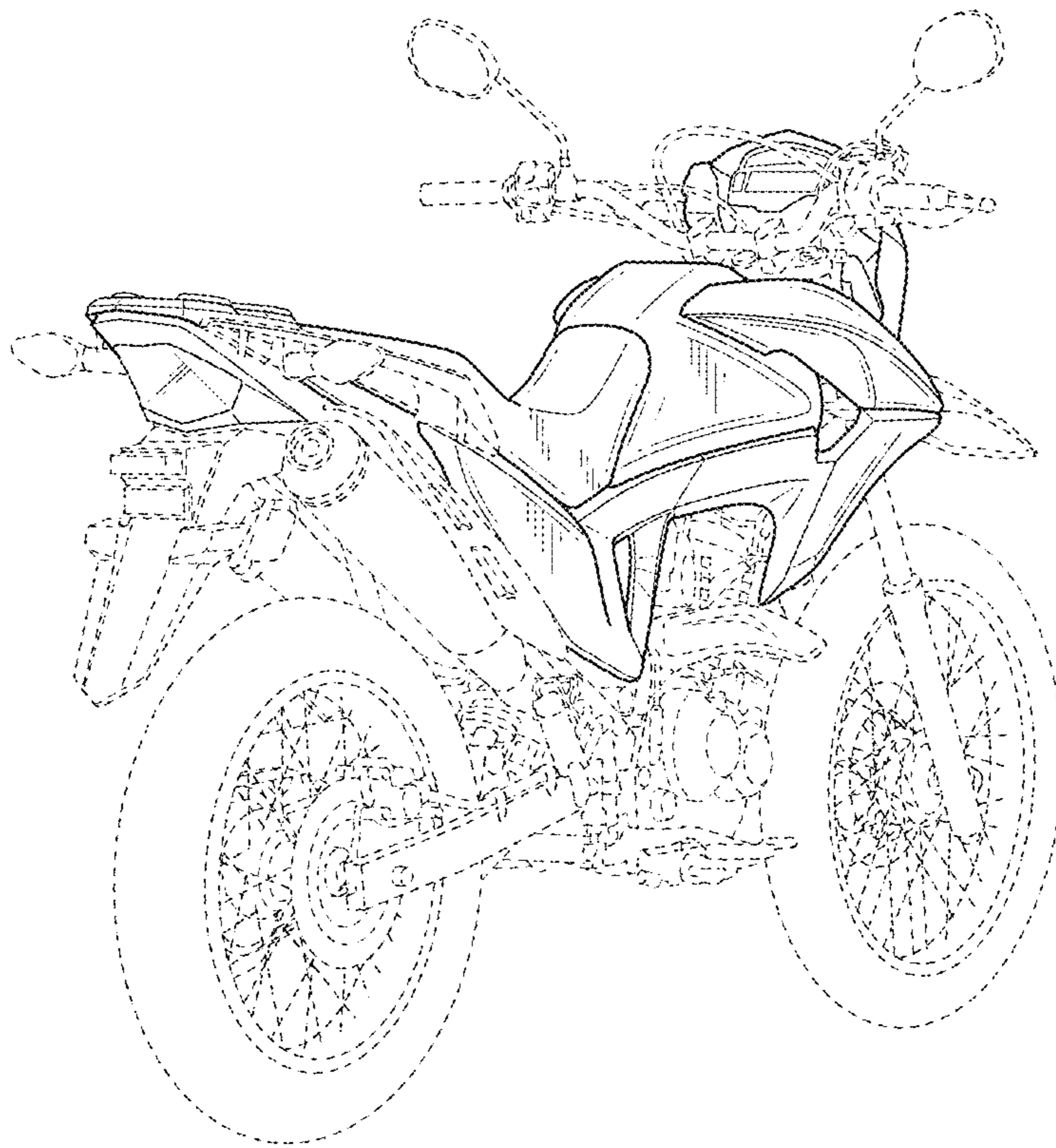

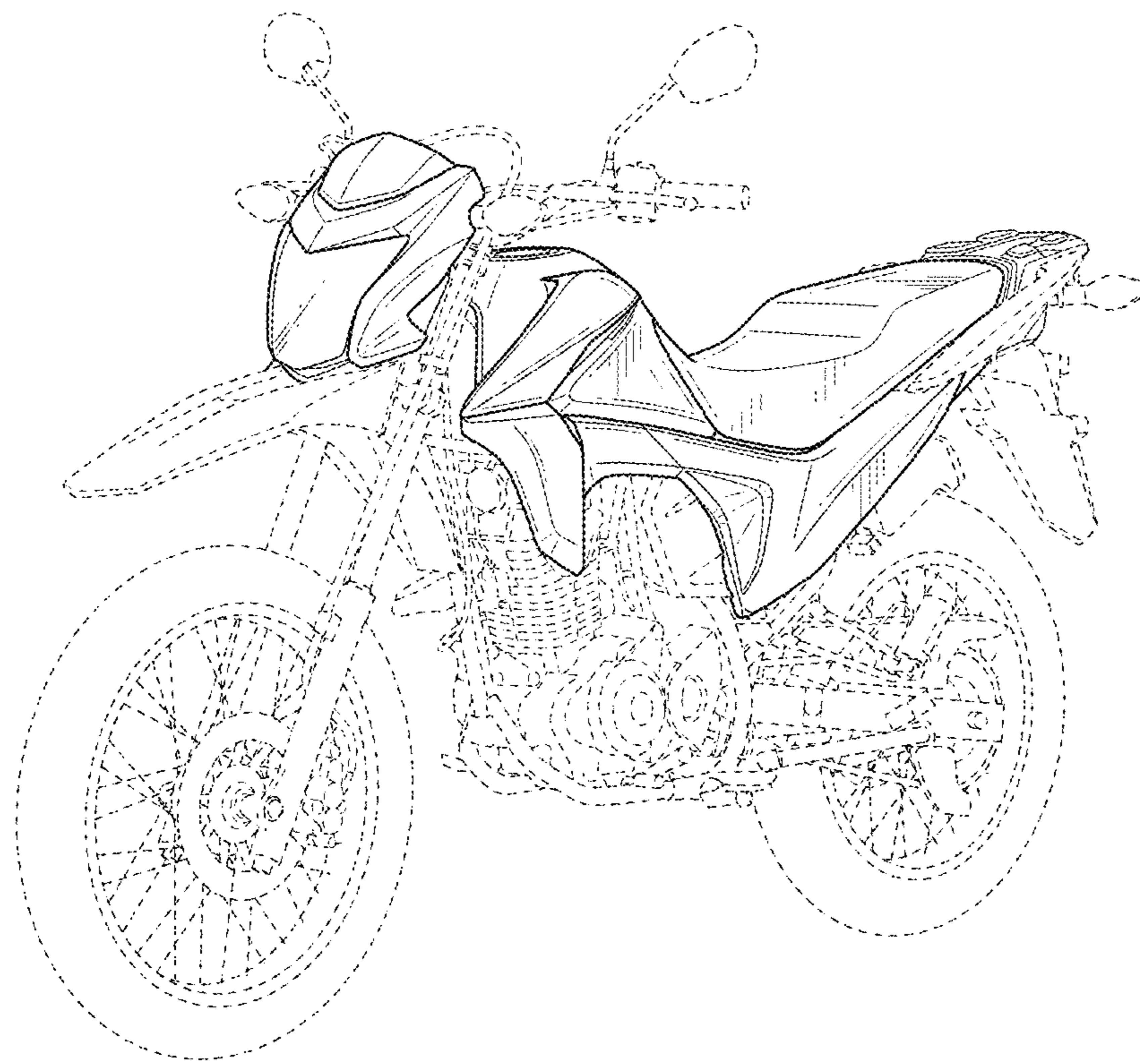

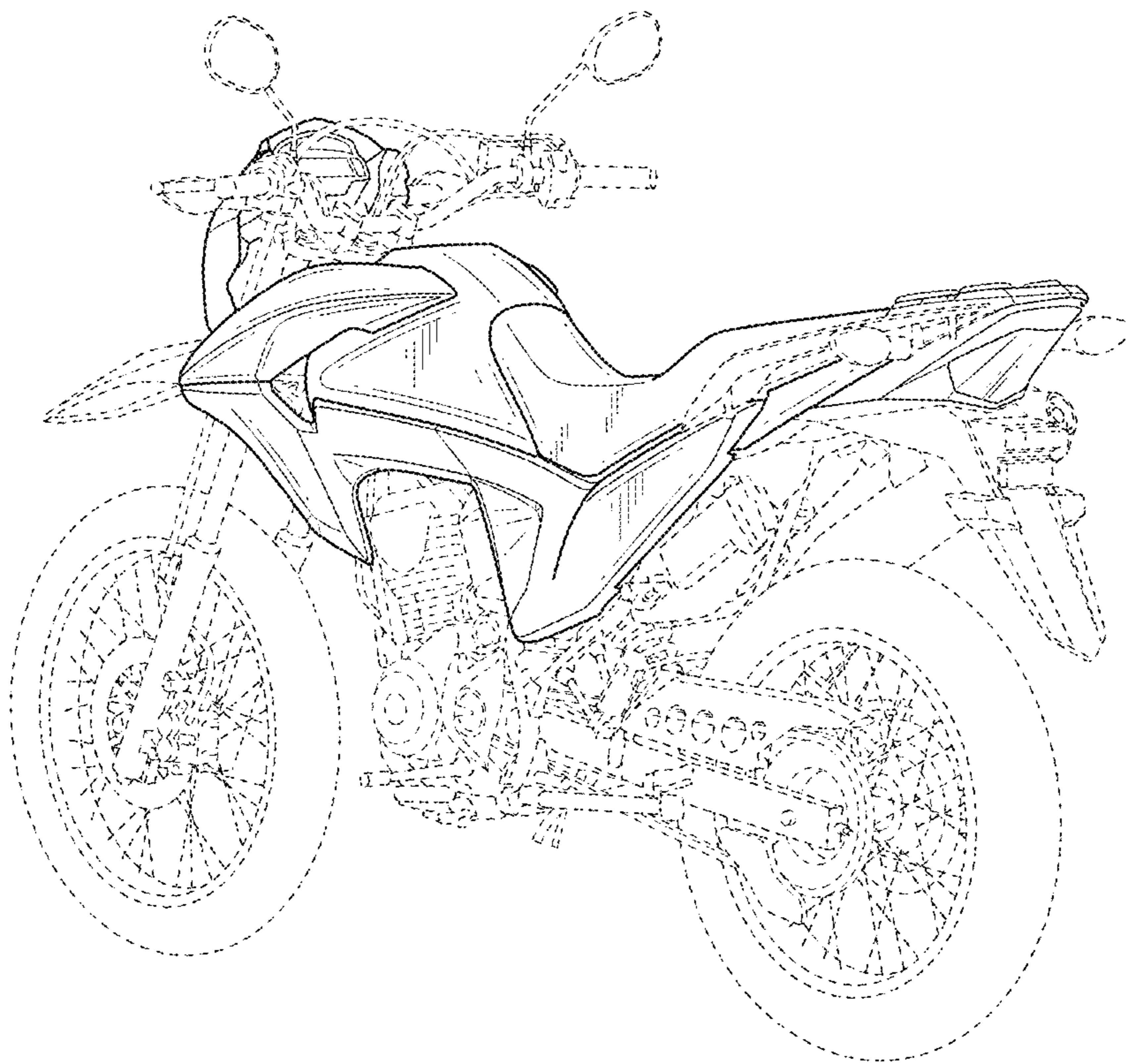

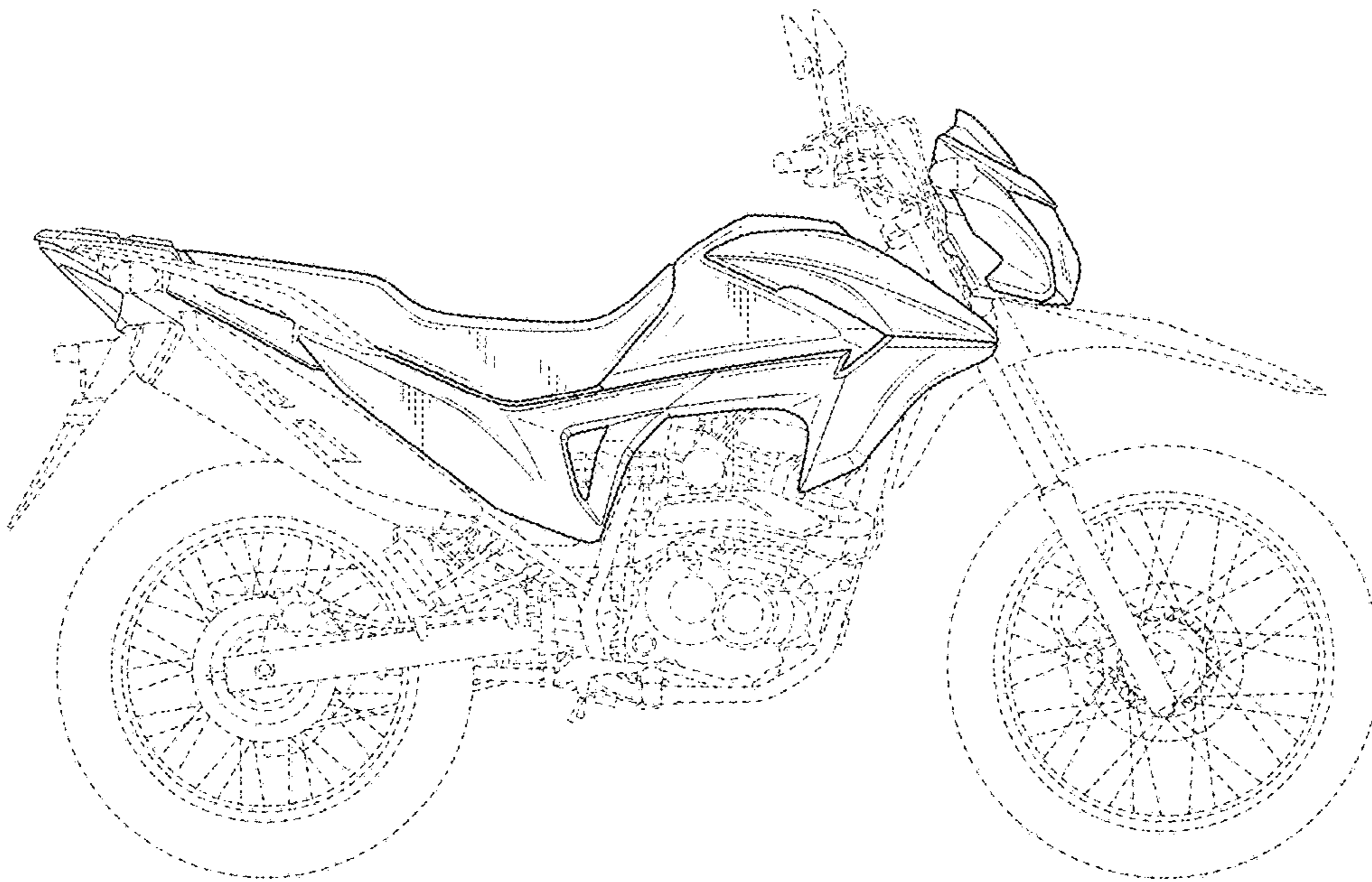

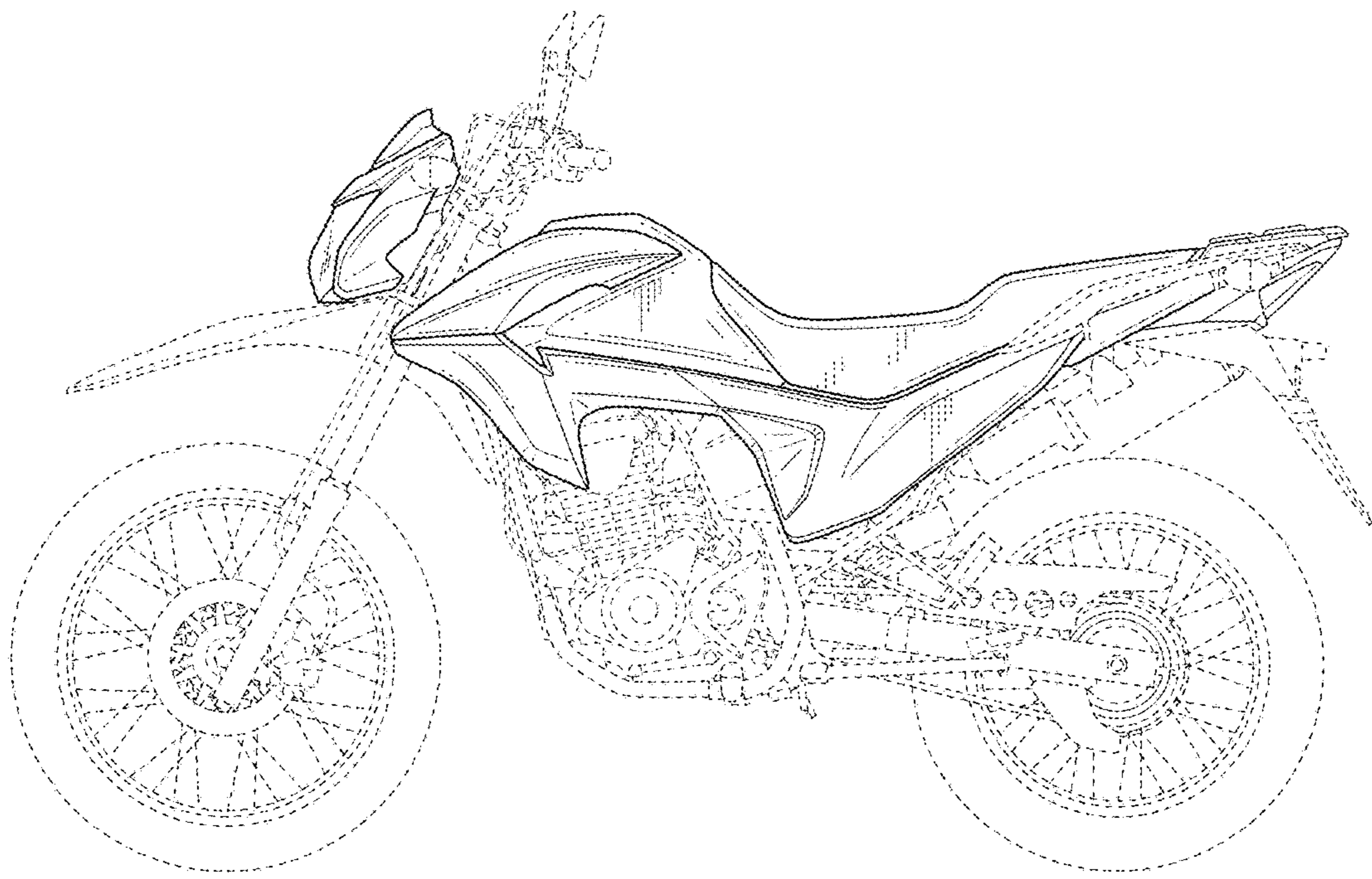

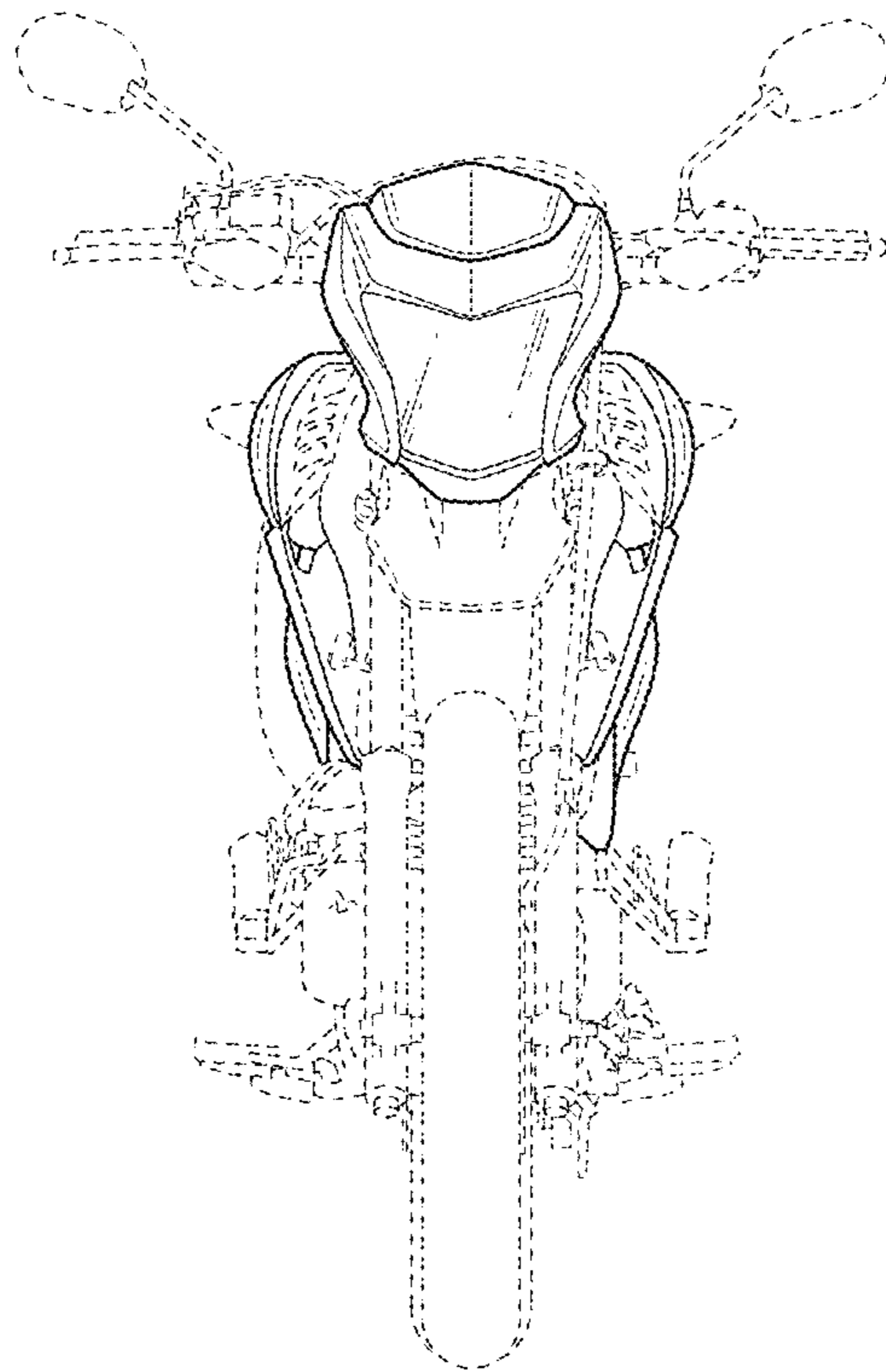

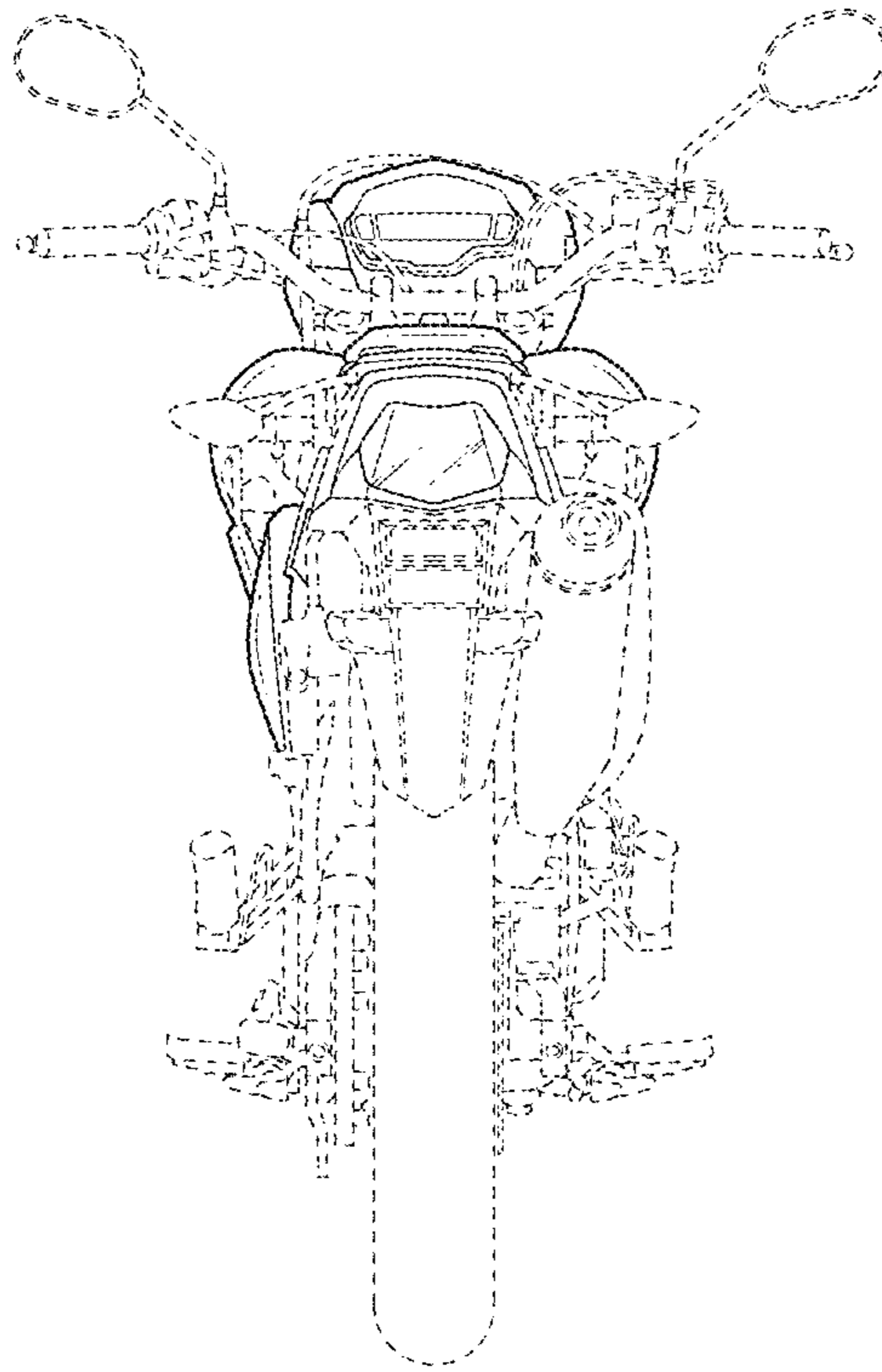

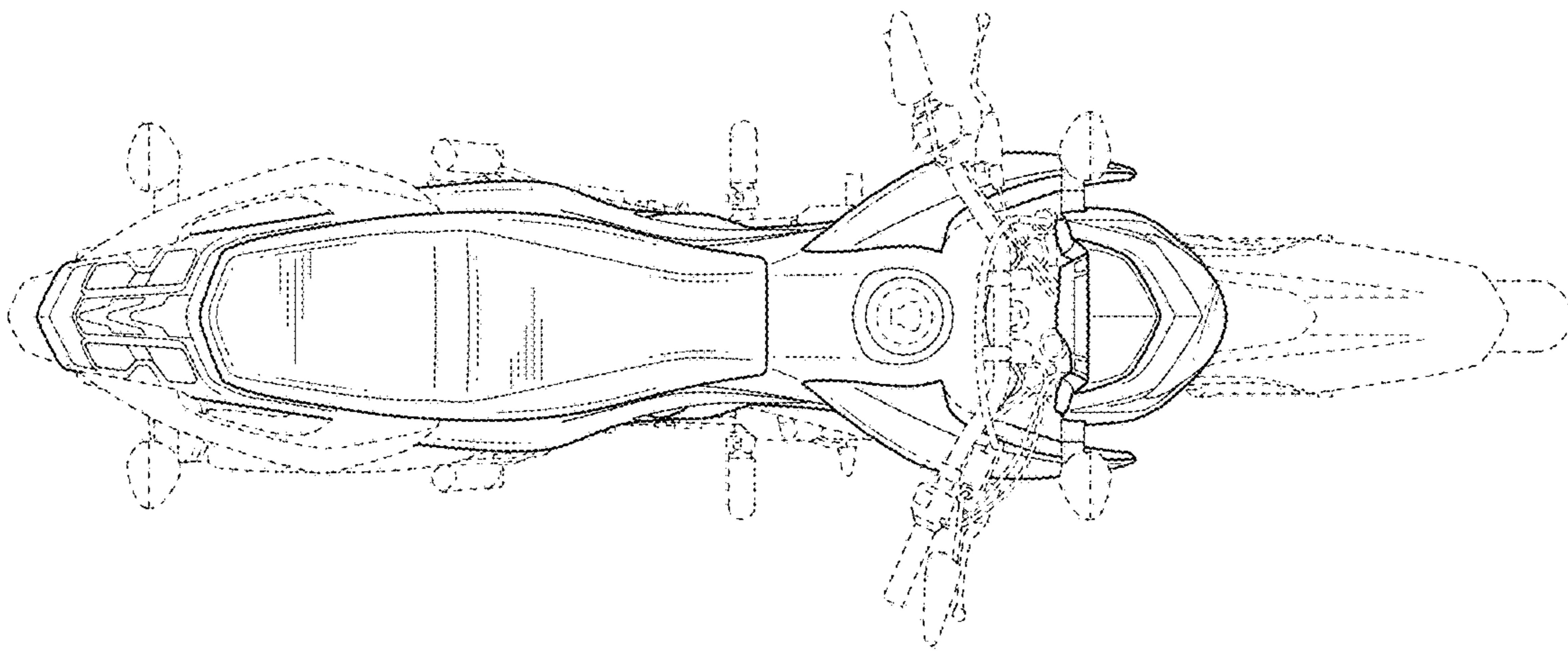

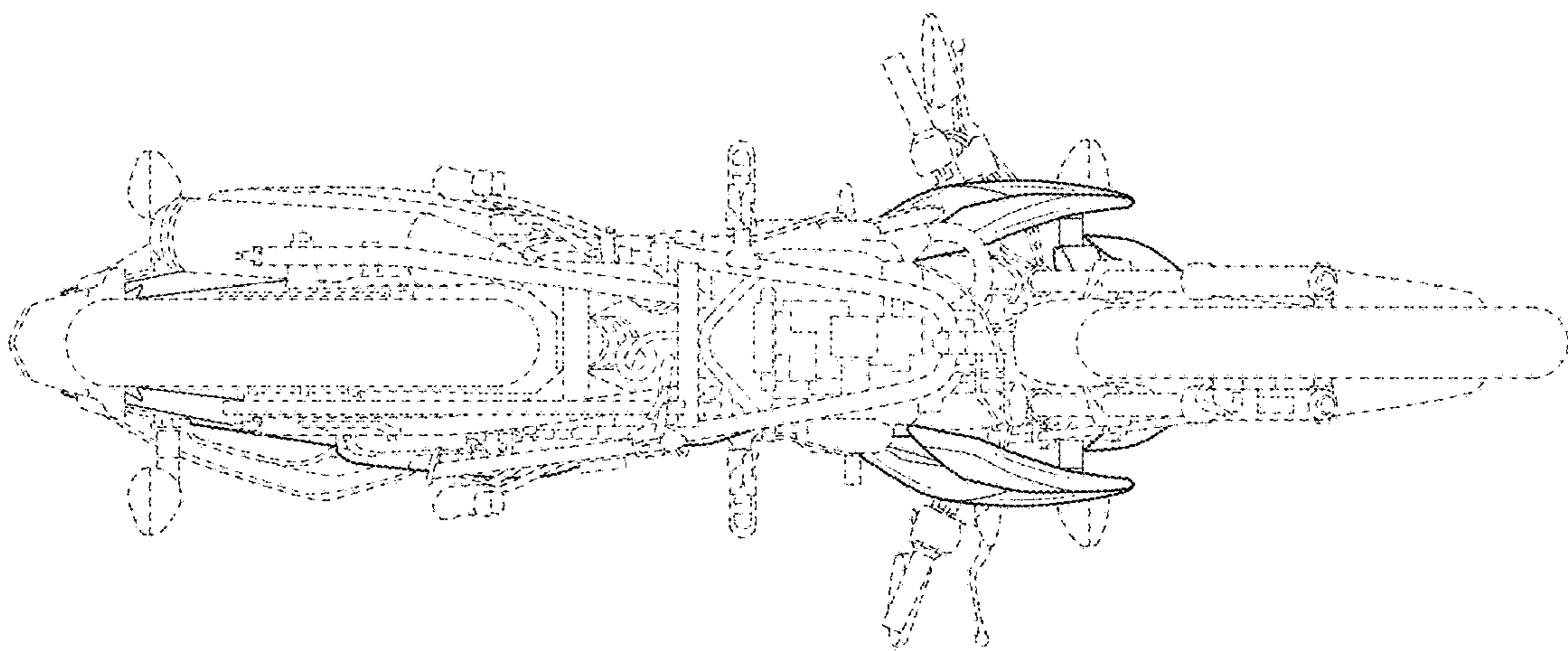

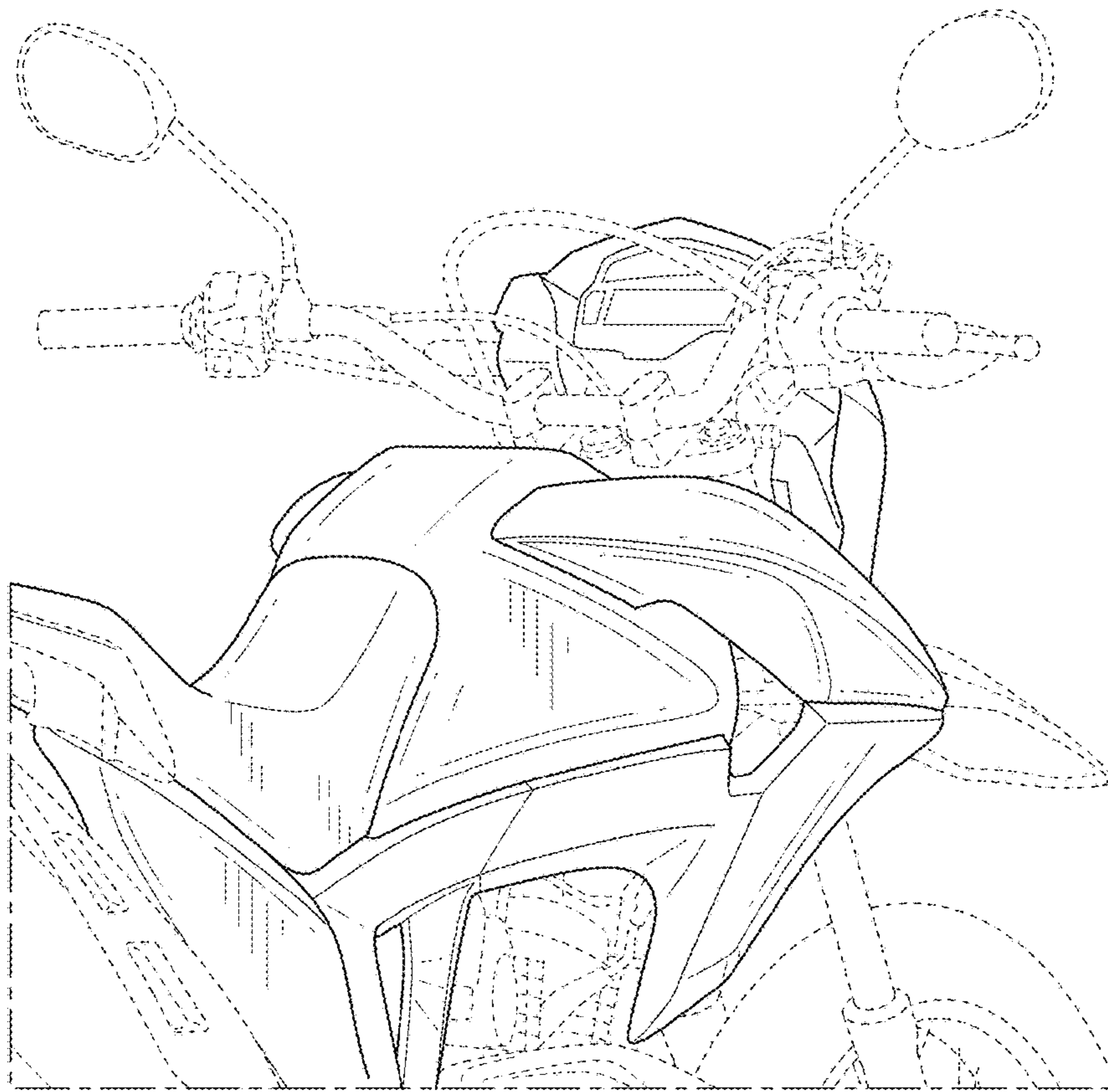
