The ornamental design for a vehicle grille, as shown and described.

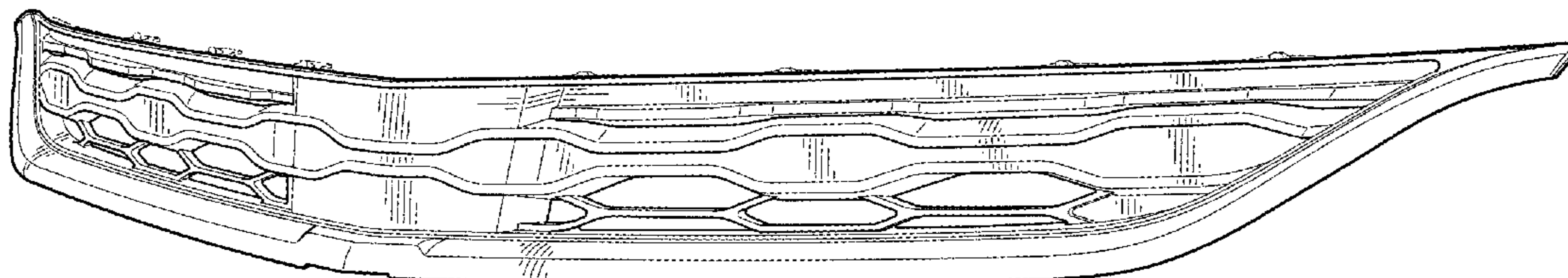
DESCRIPTION

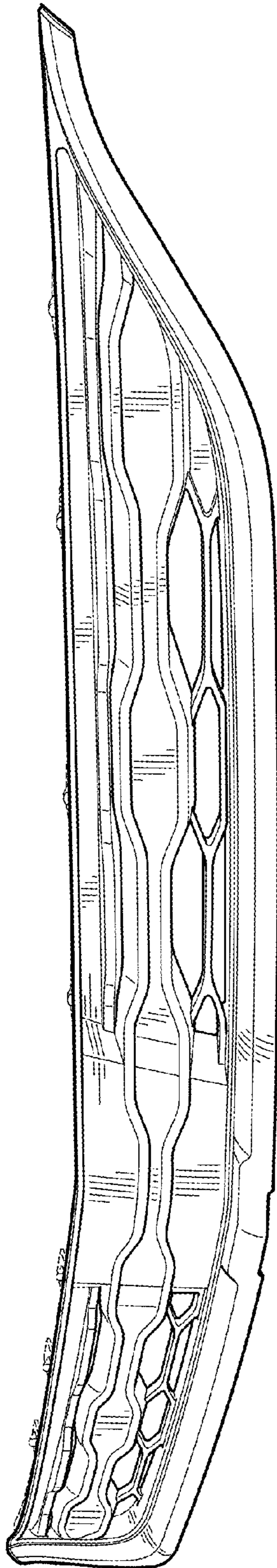

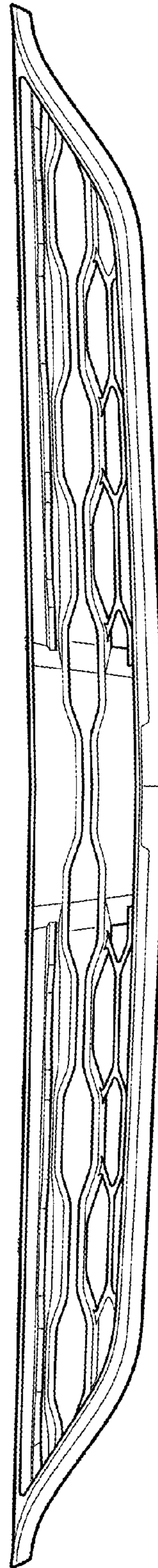

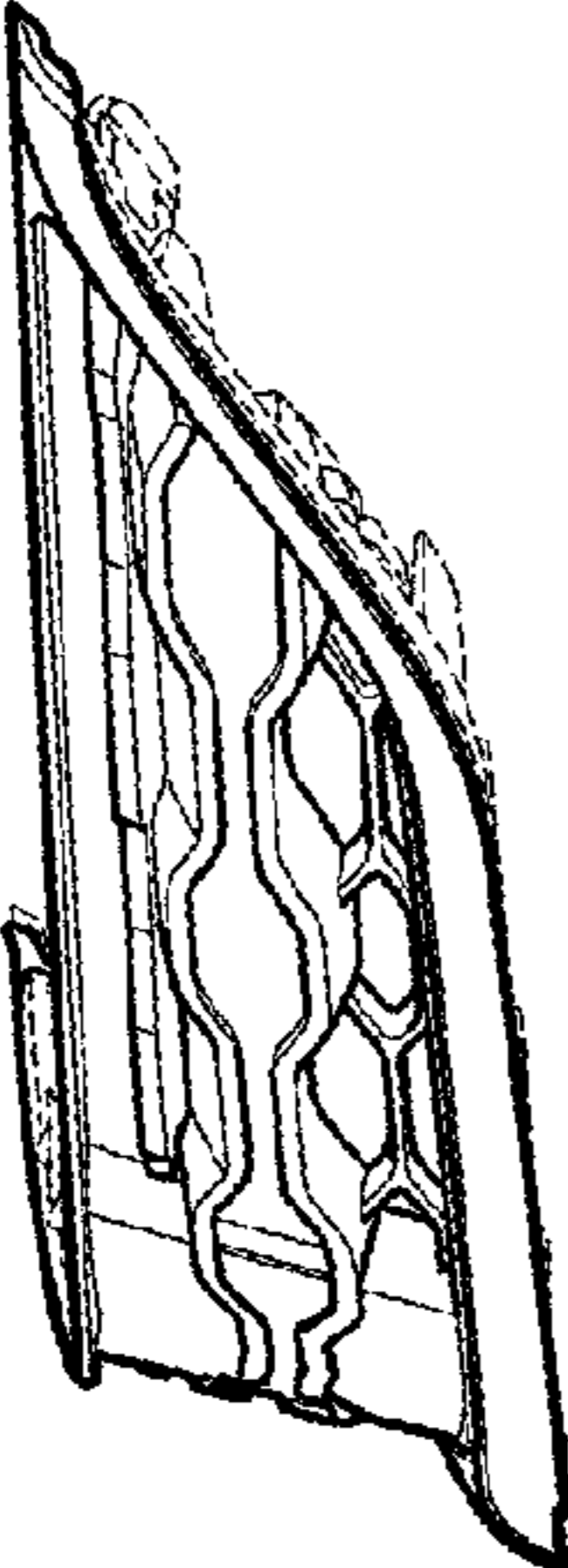

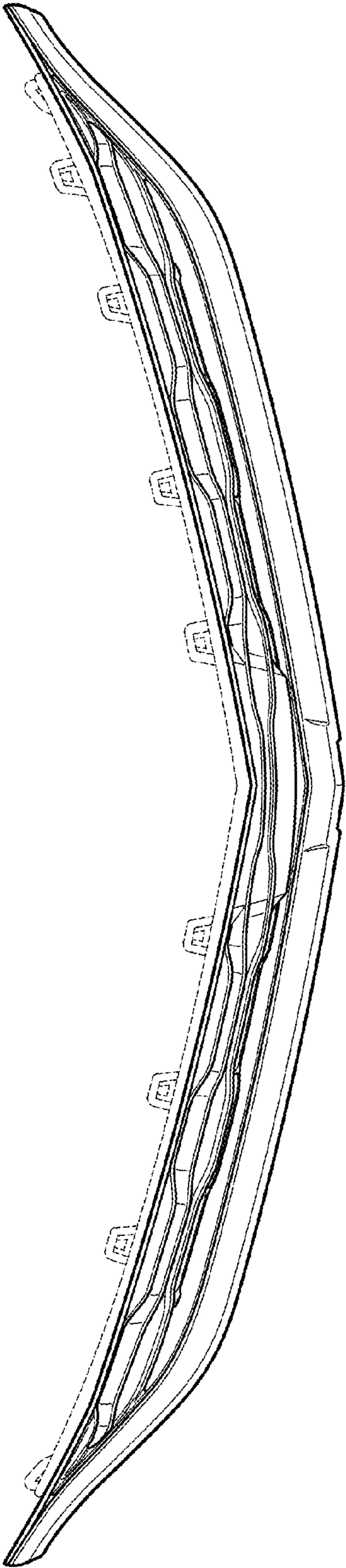
