FIG. 2 is a perspective view thereof.

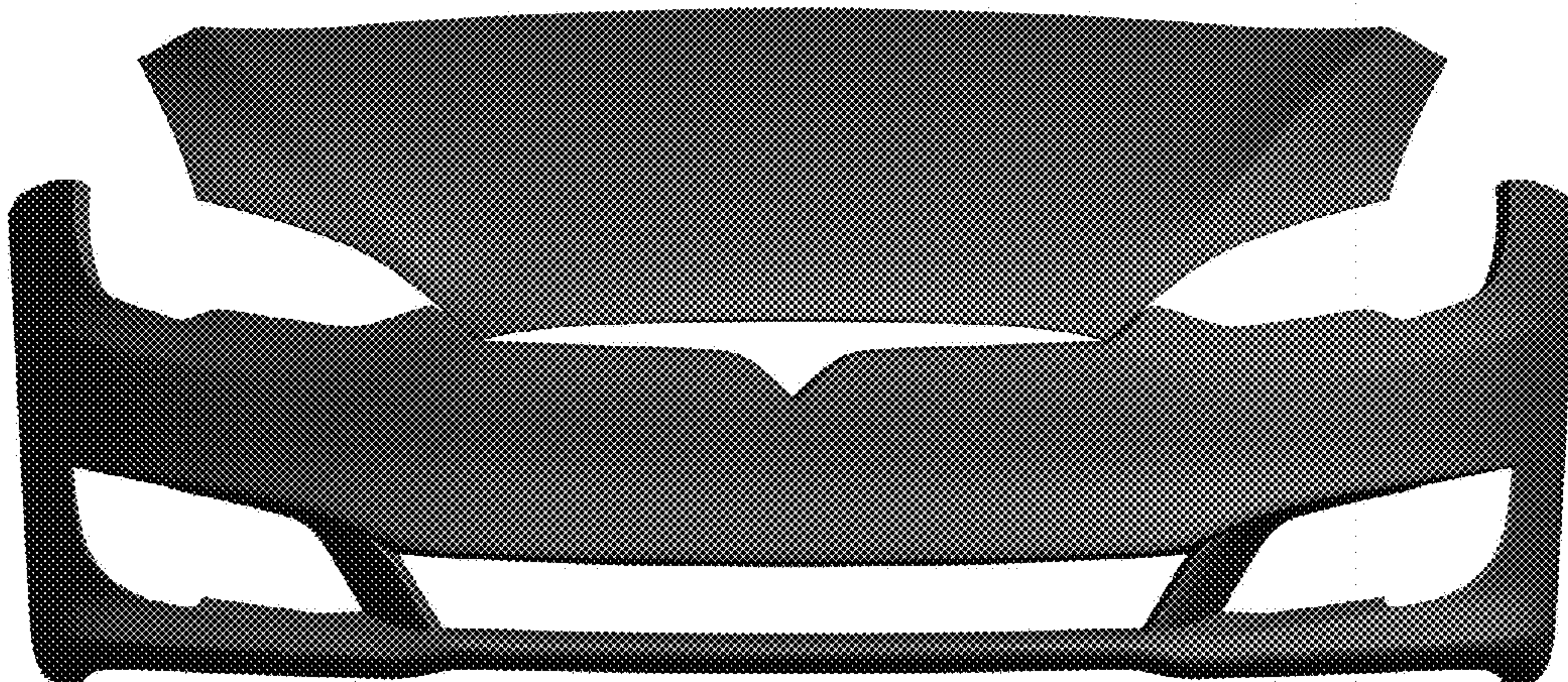
FIG. 3 is a top view thereof.

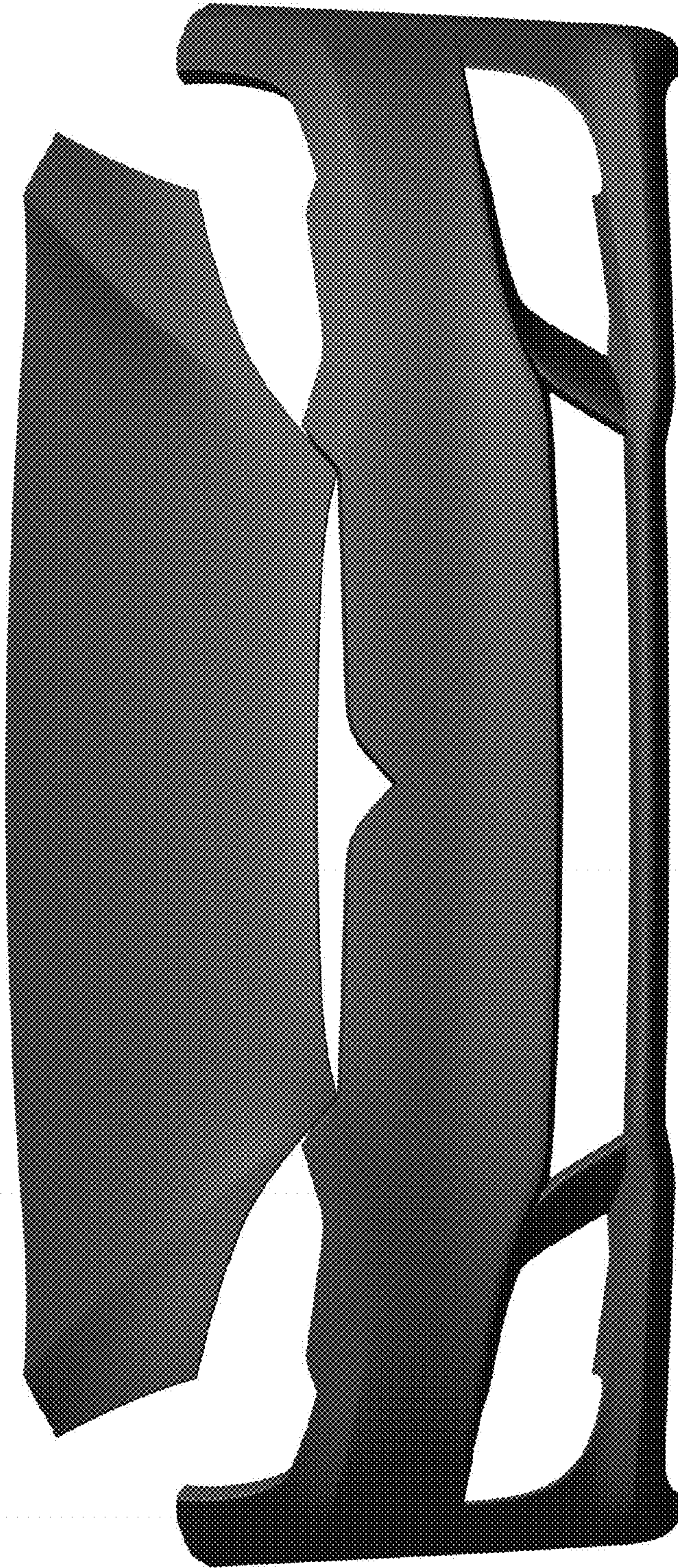

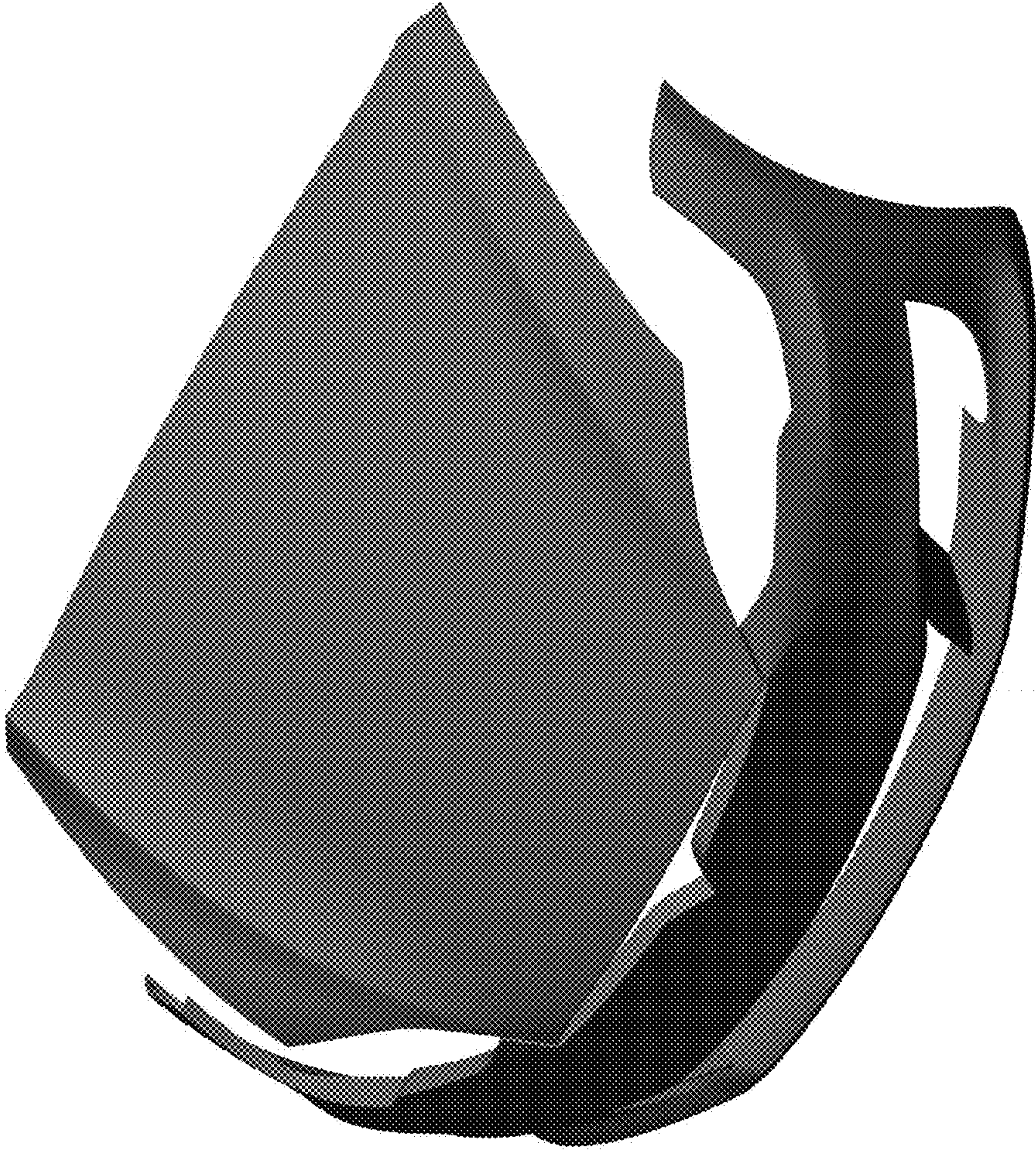

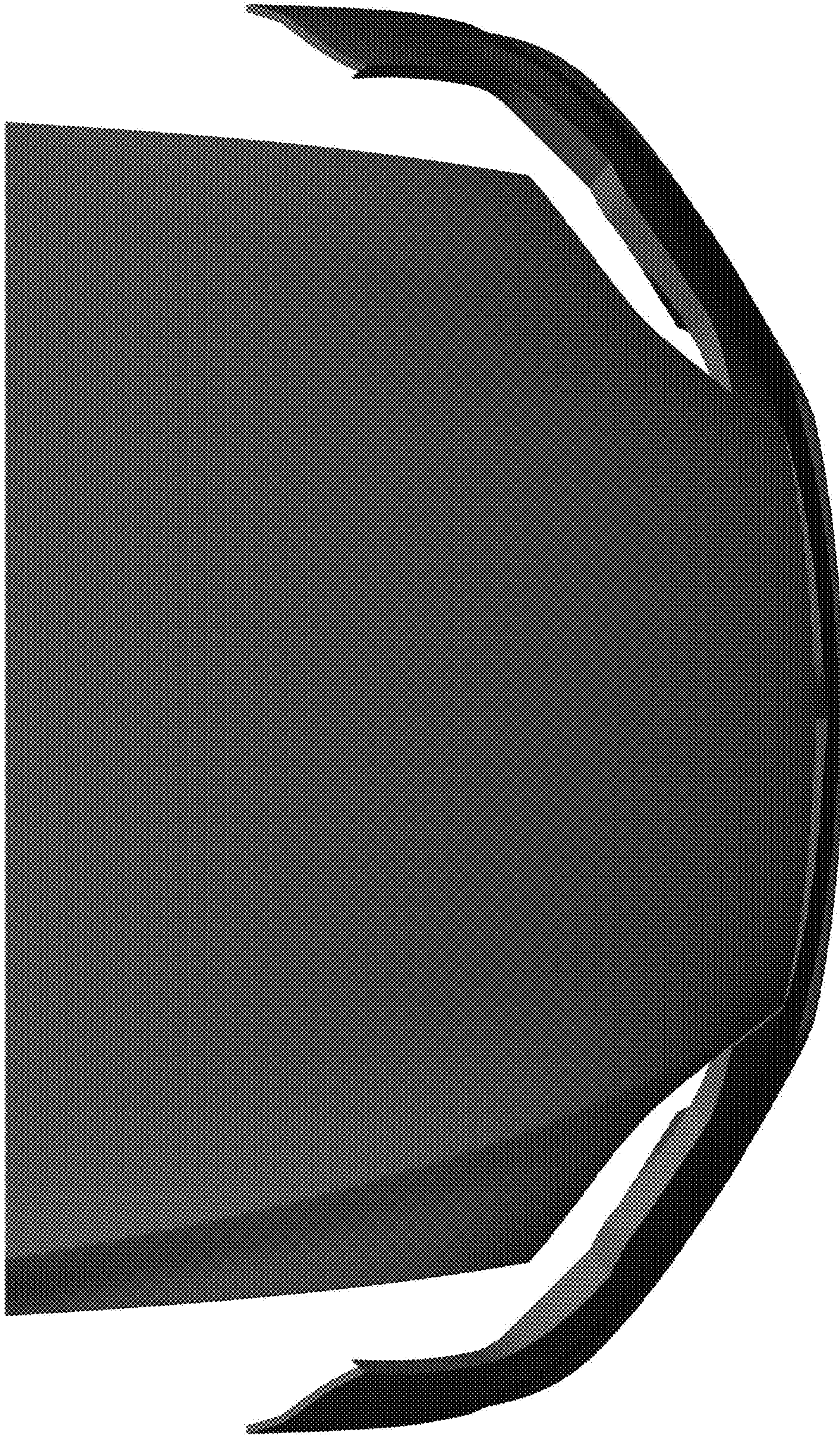

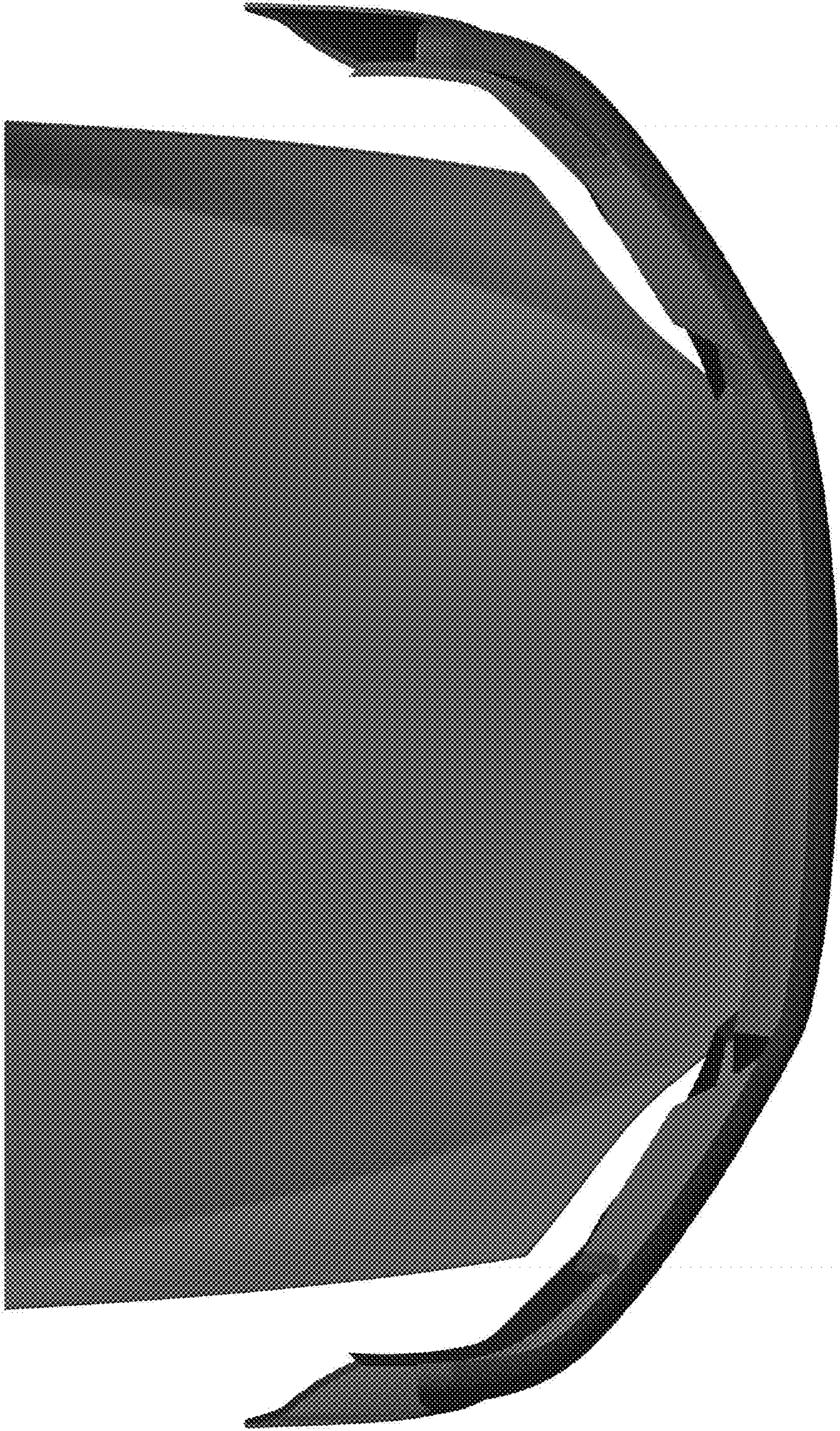

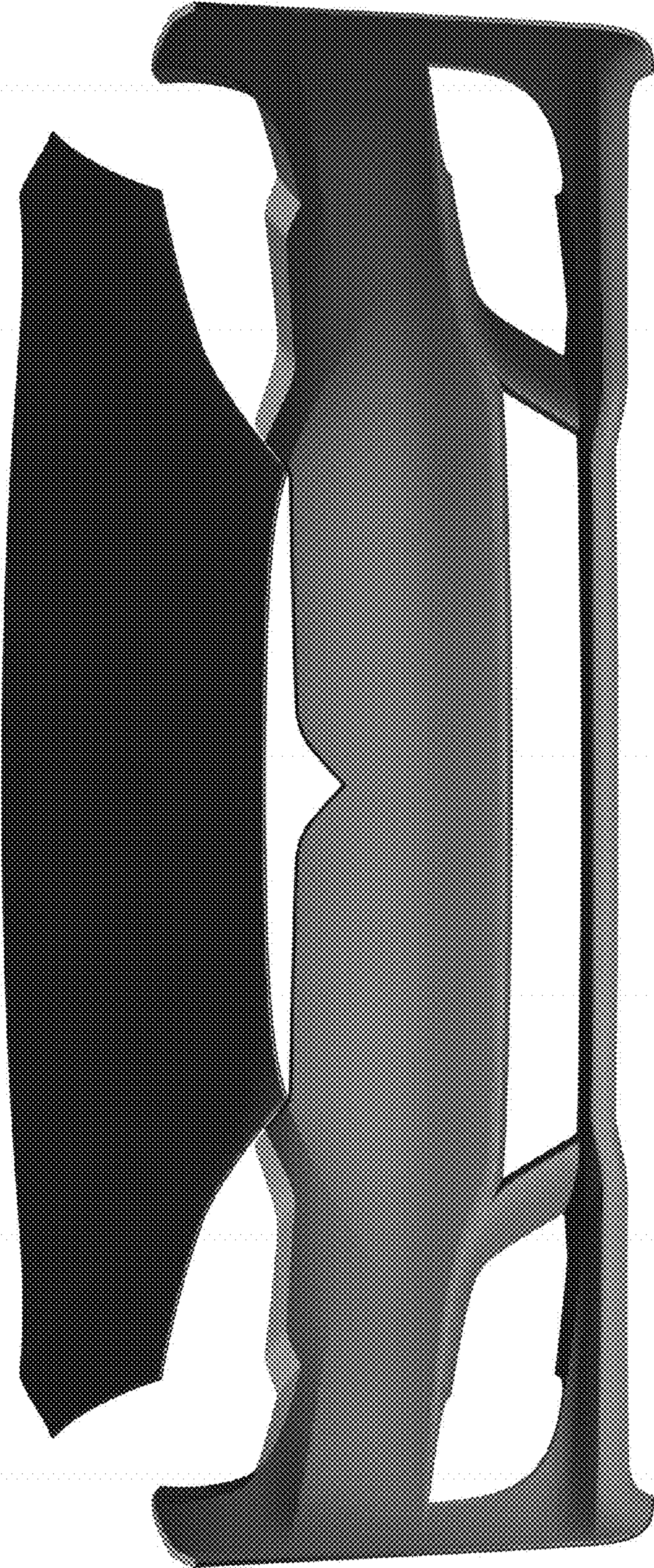
