**DESCRIPTION**

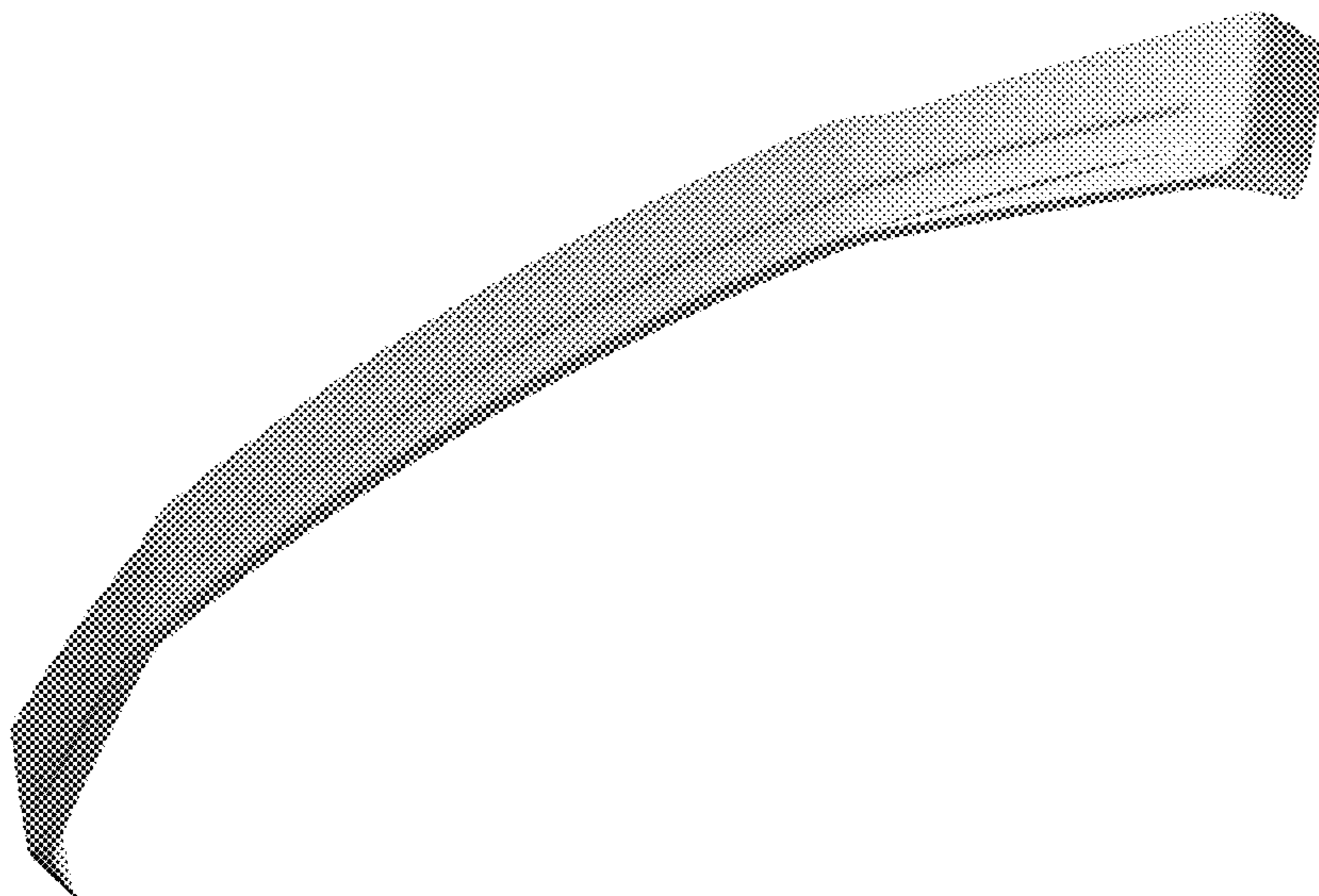
FIG. 1 is a bottom left perspective view of a vehicle front air dam, showing our new design;

FIG. 9 is a bottom plan view thereof.

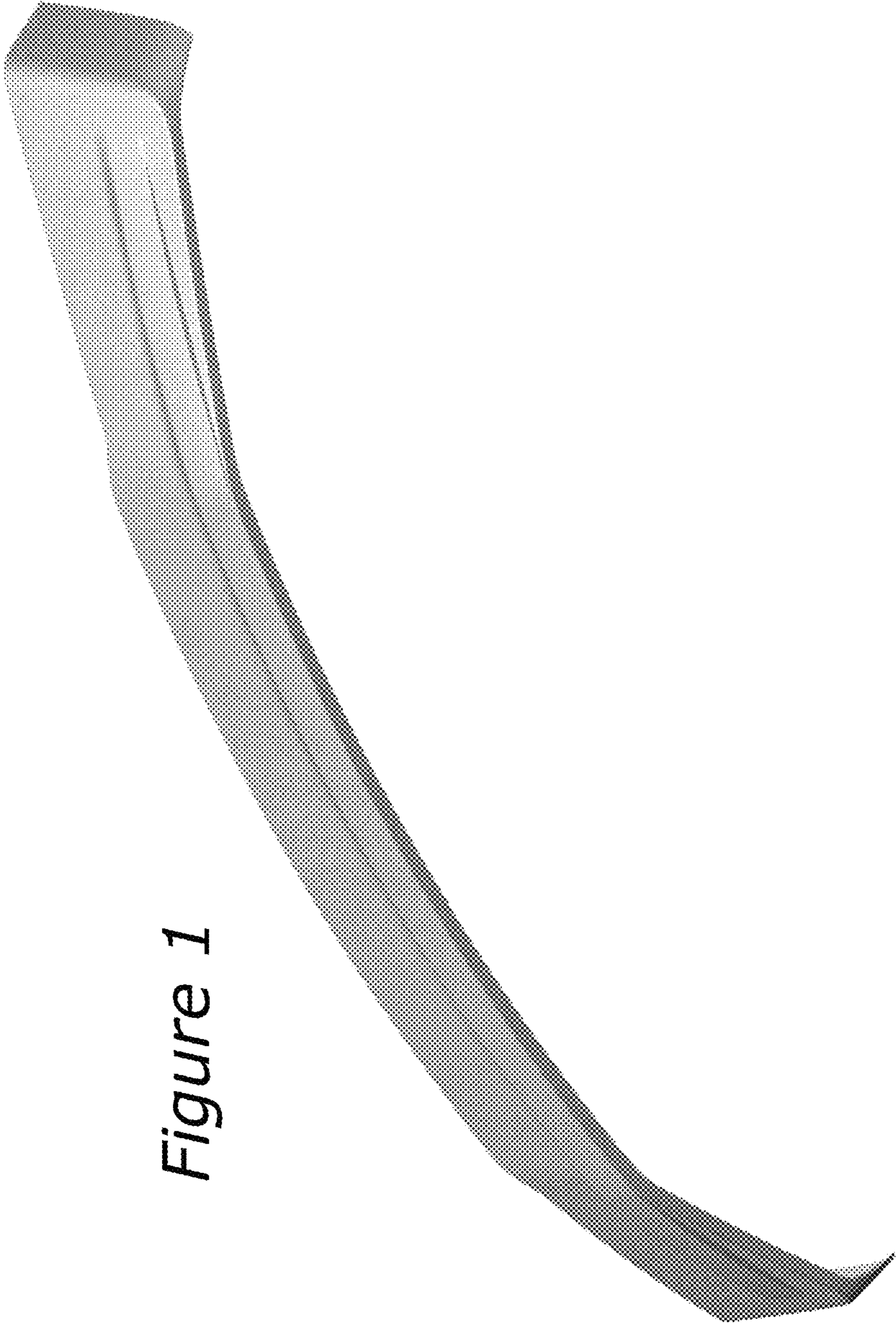

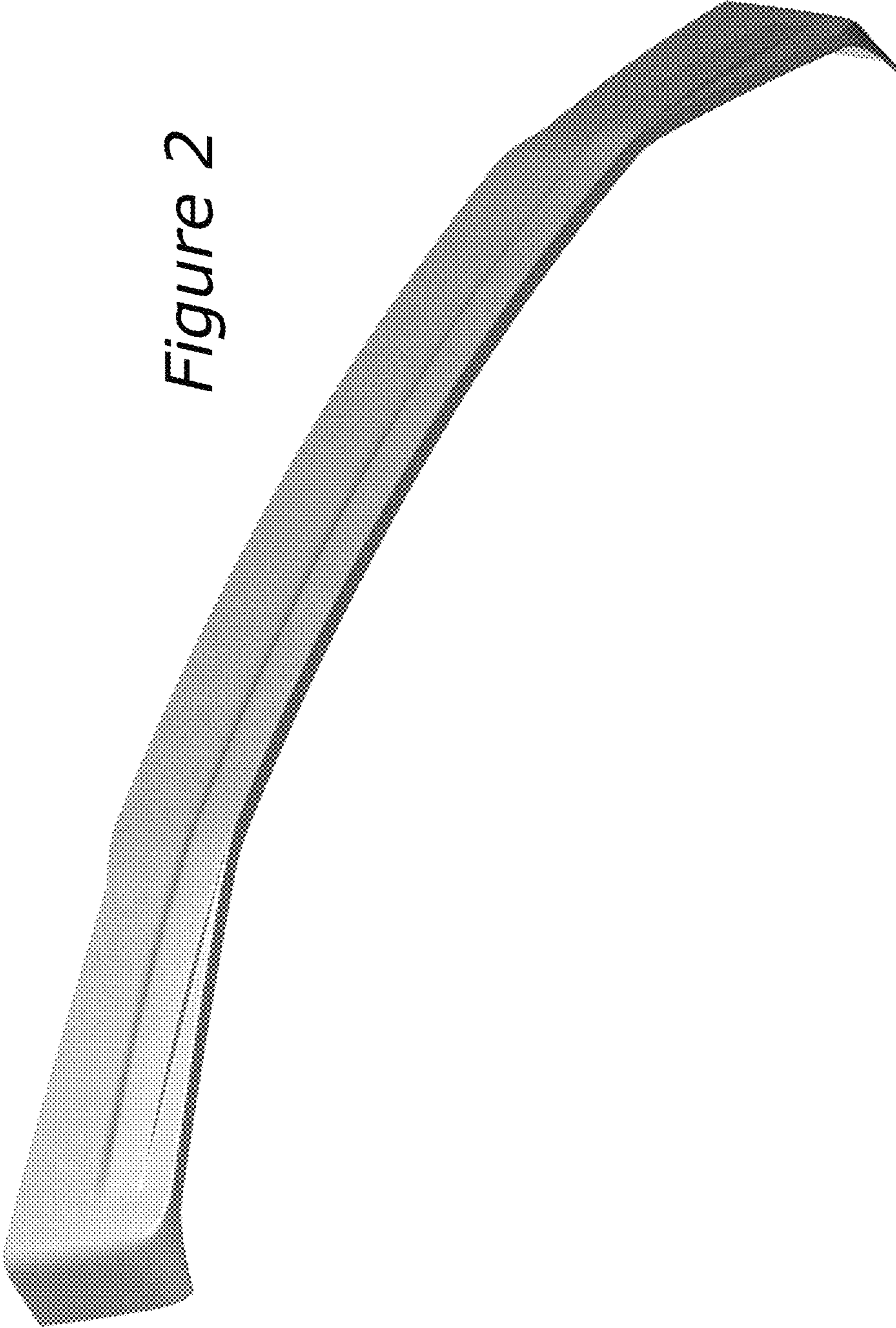

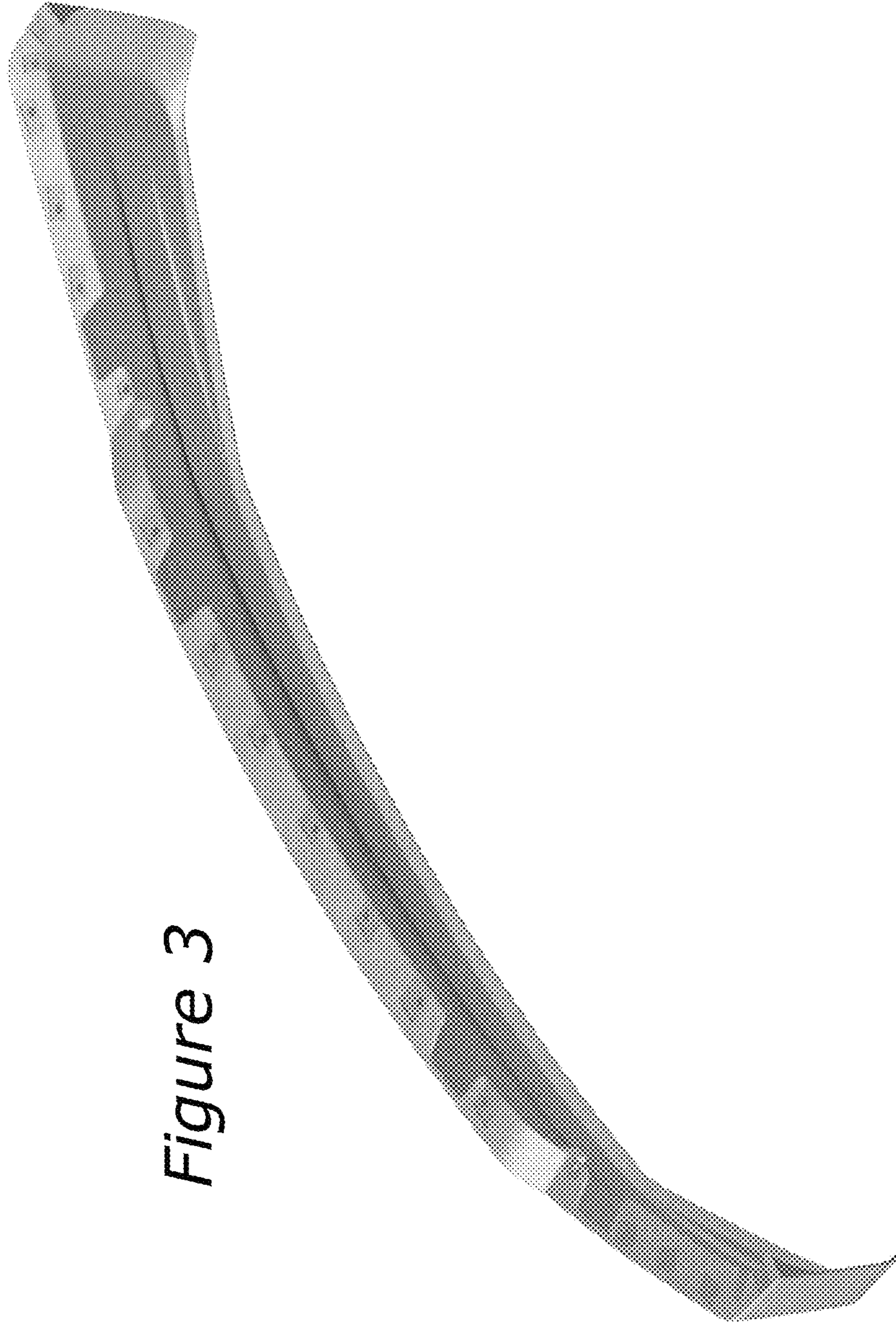

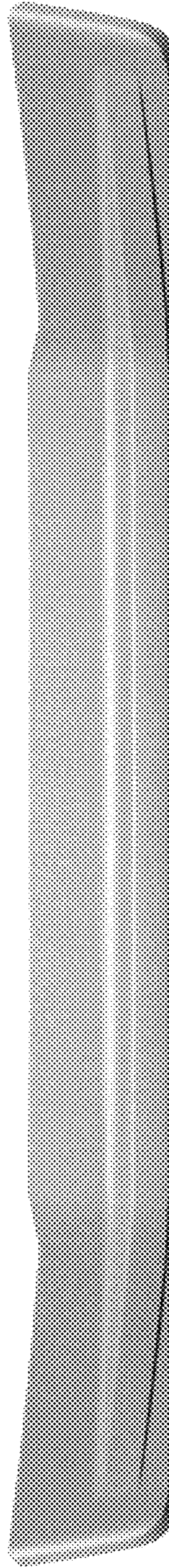

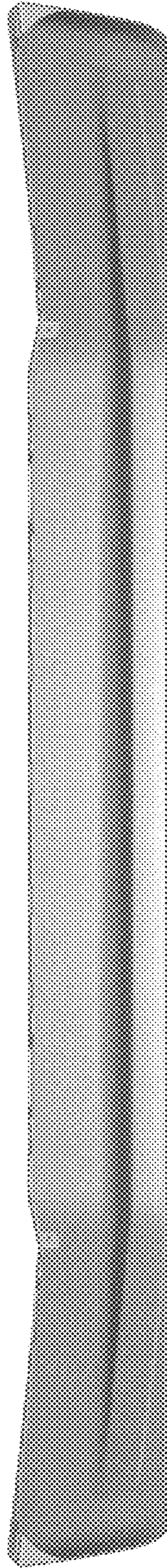
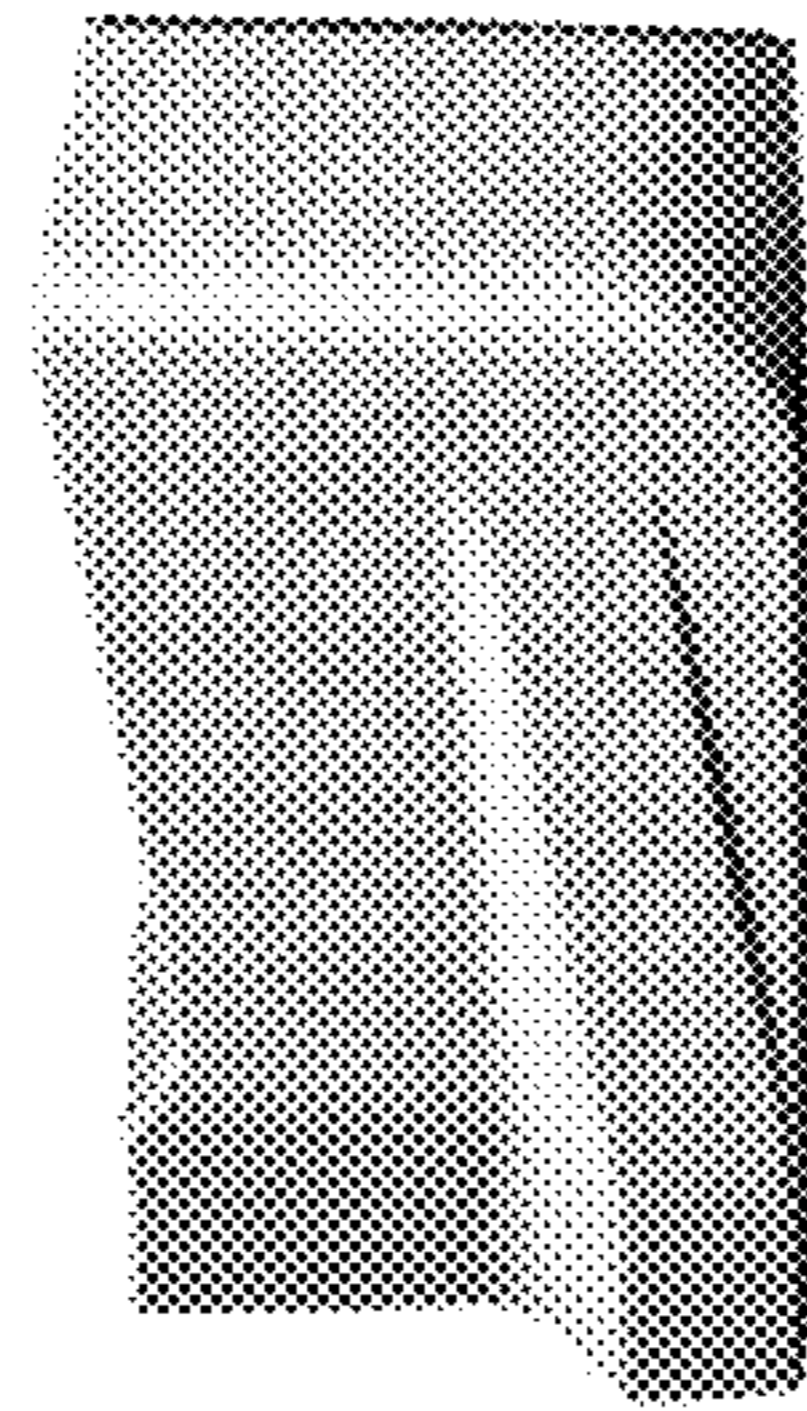
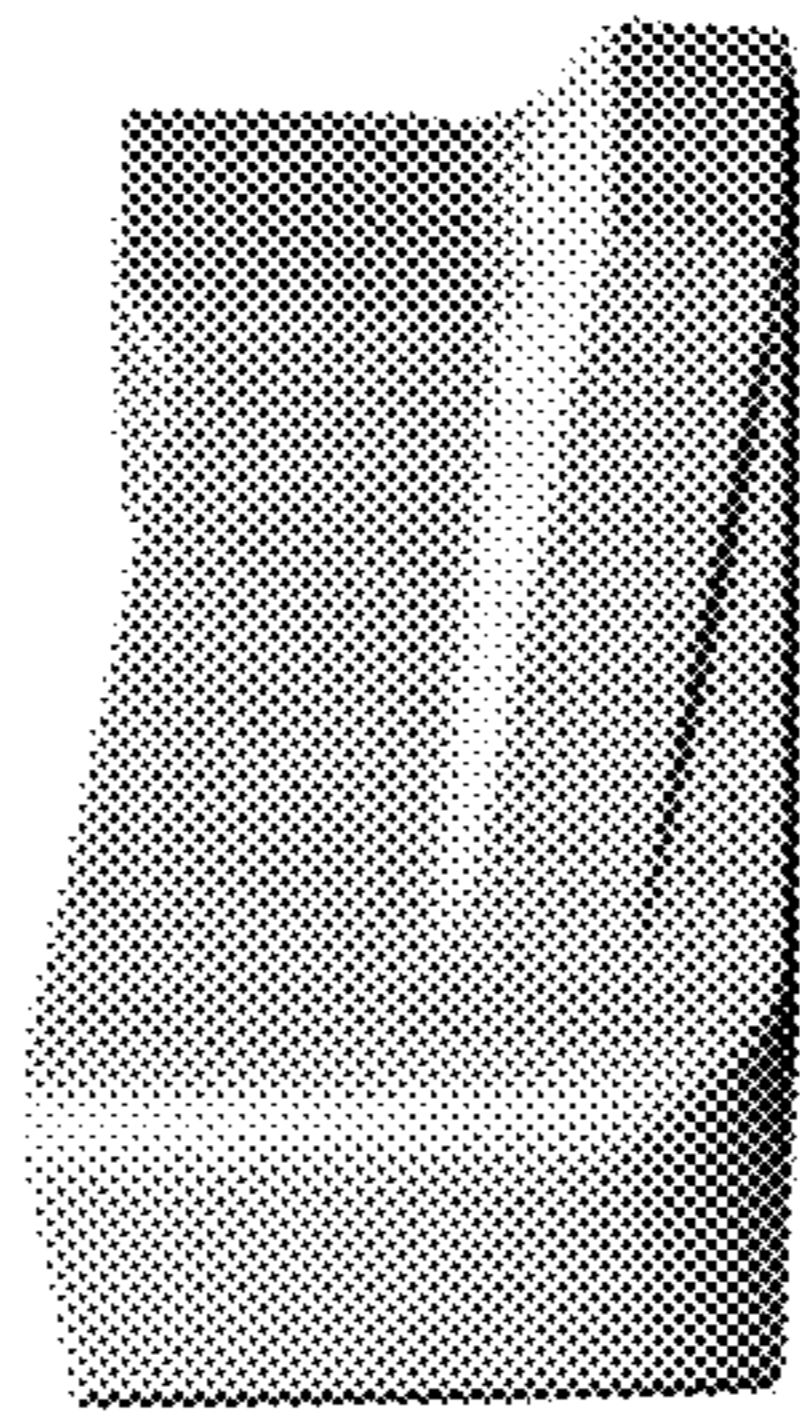

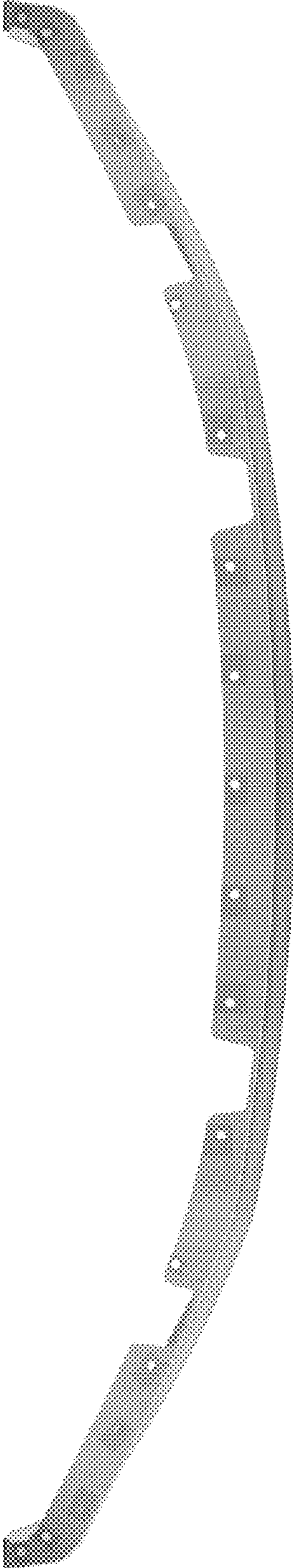
